(57) **CLAIM**

We claim the ornamental design for a portable AED (auto-
mated external defibrillator), as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of portable AED (auto-
mated external defibrillator) showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right-side view thereof;

FIG. 6 is a top plan view thereof;

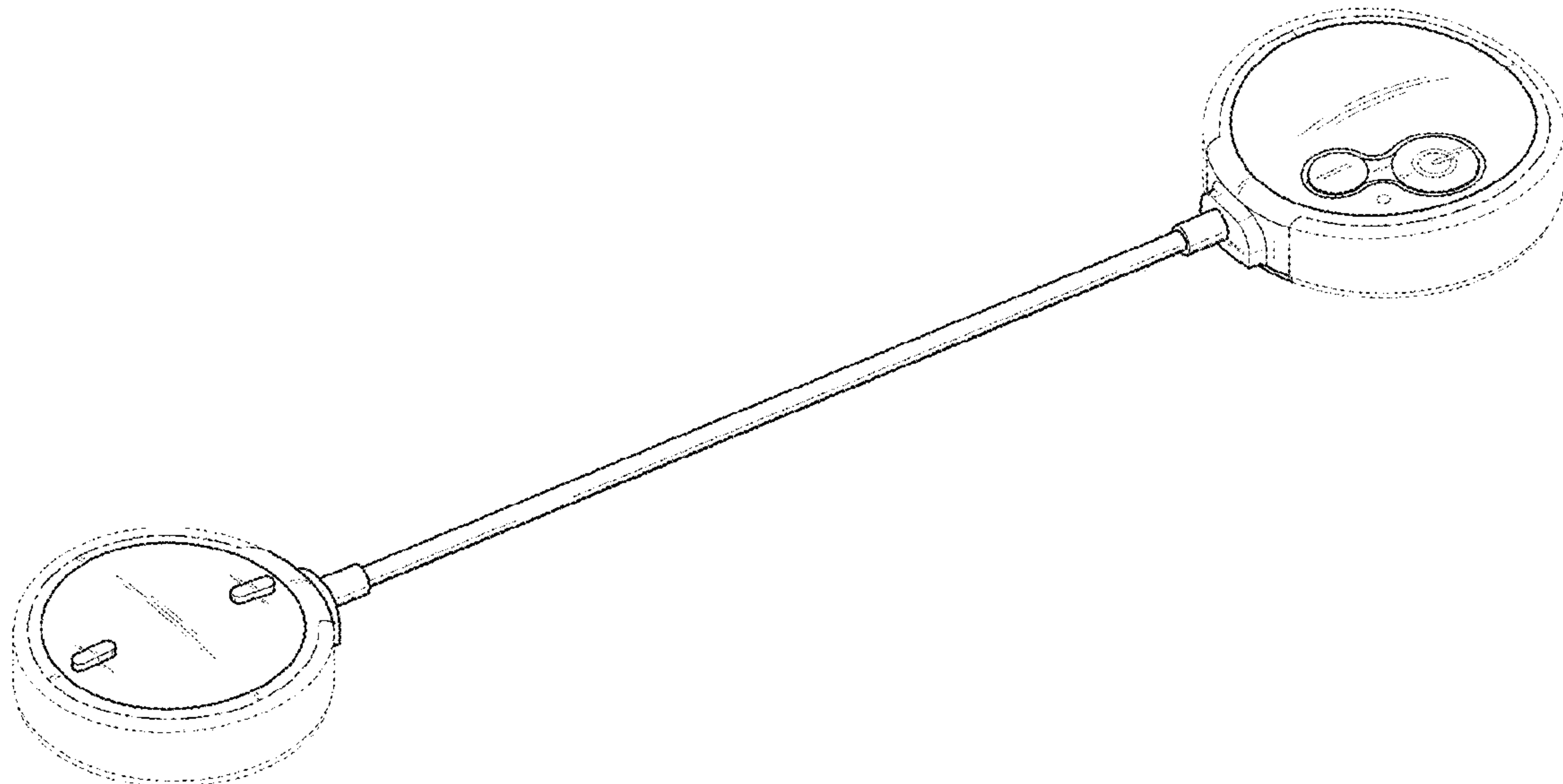

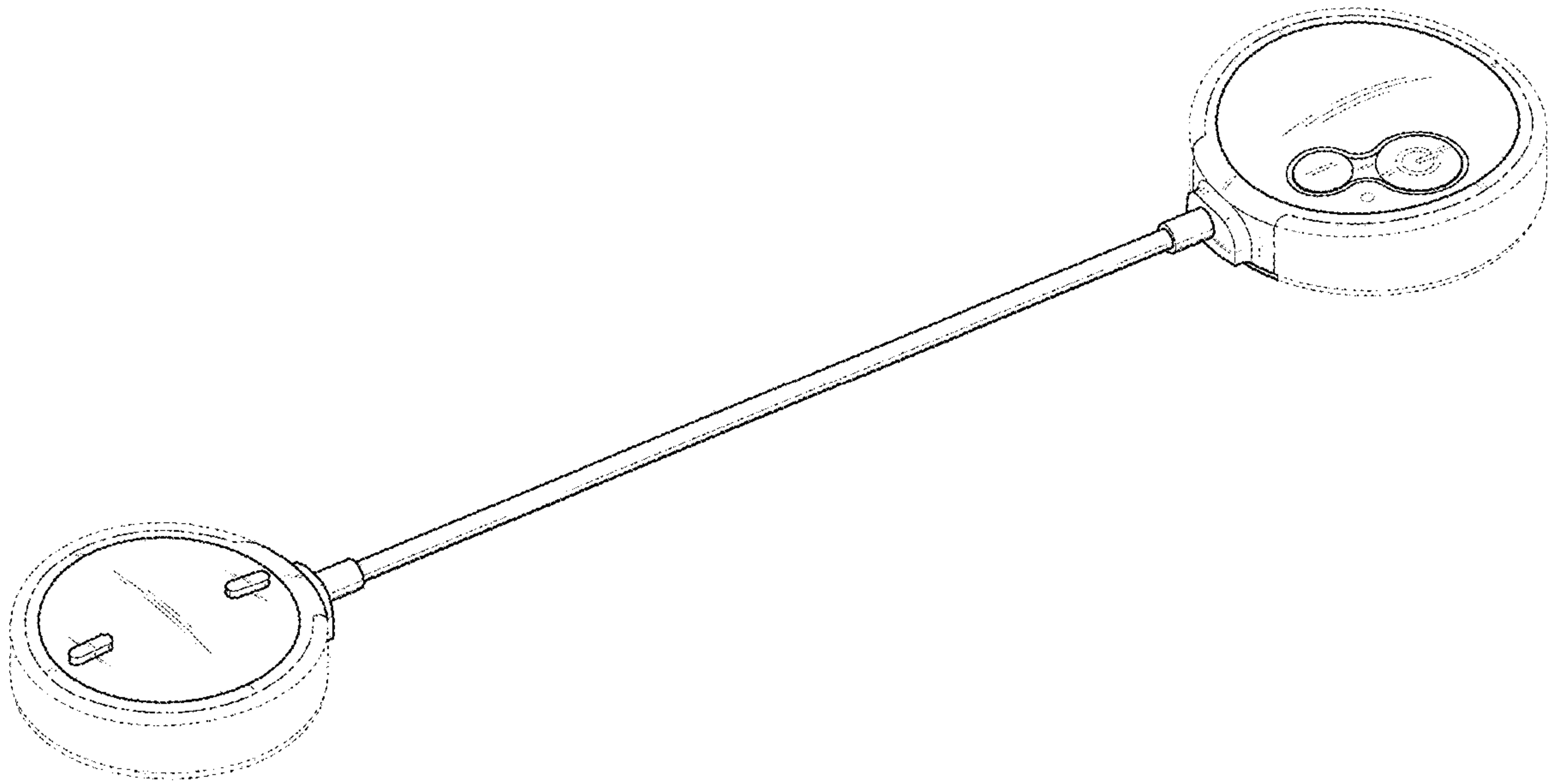

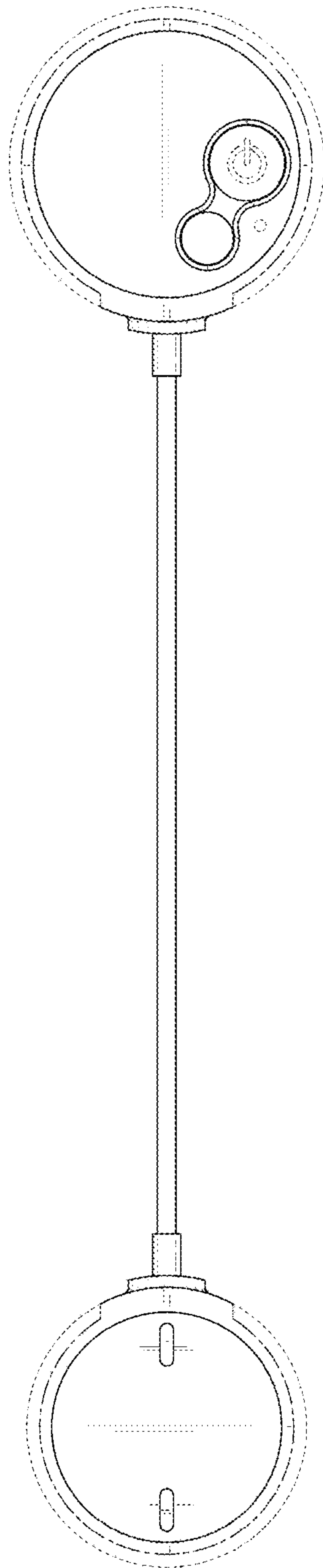

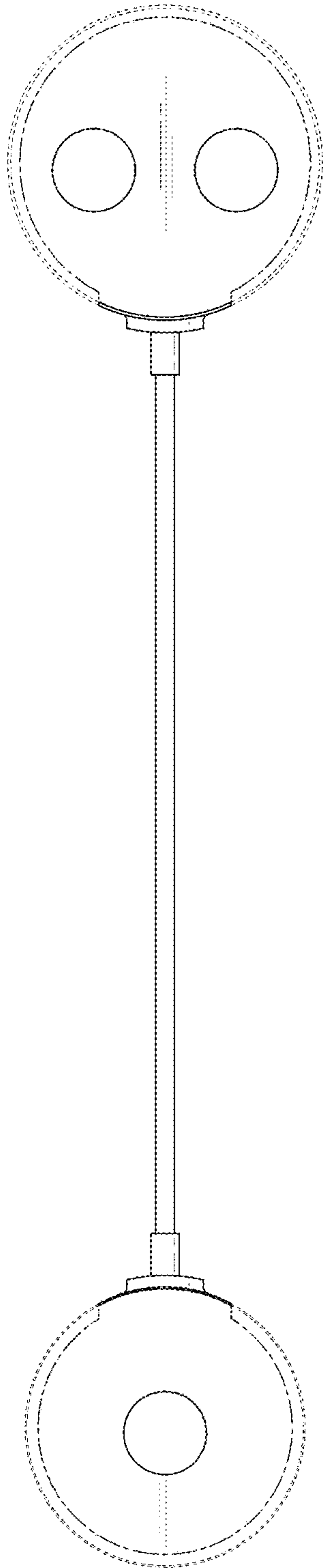

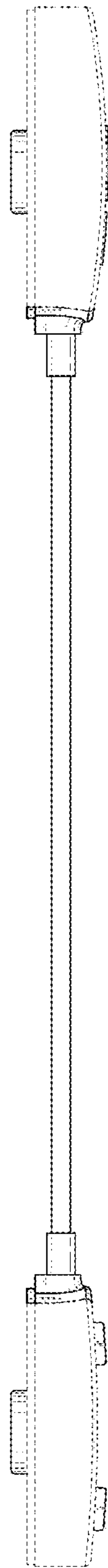

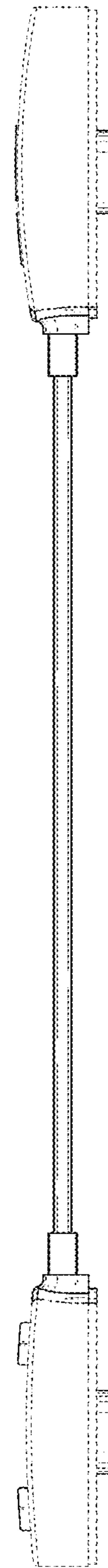

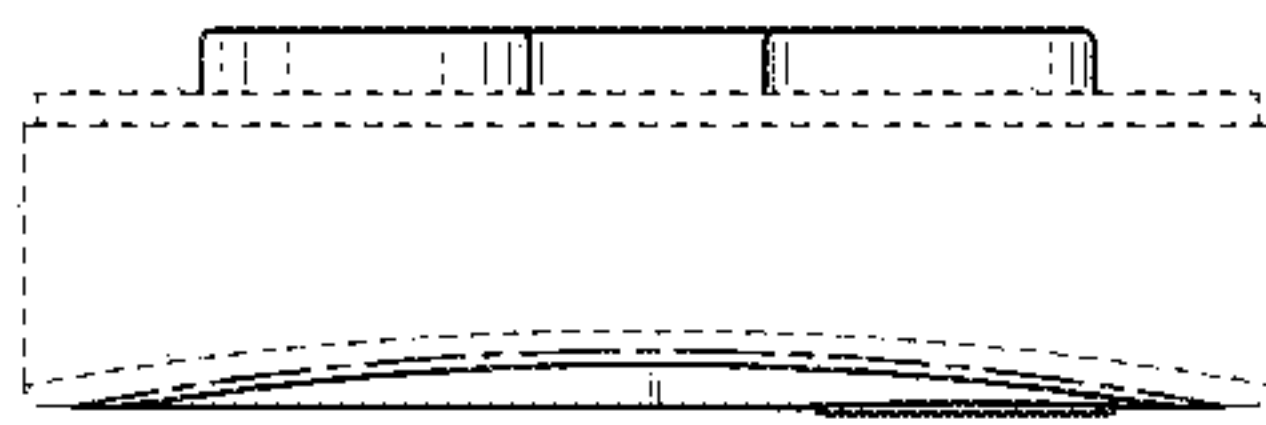

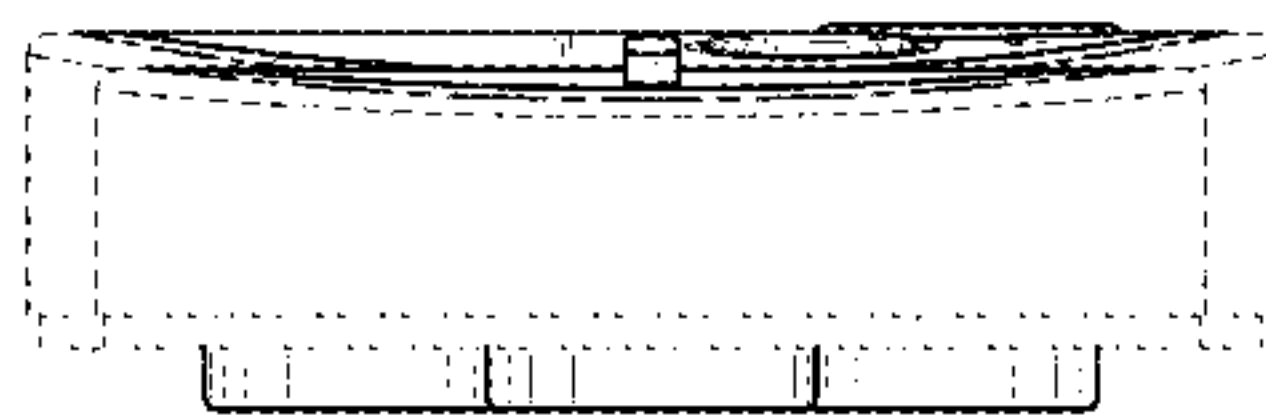

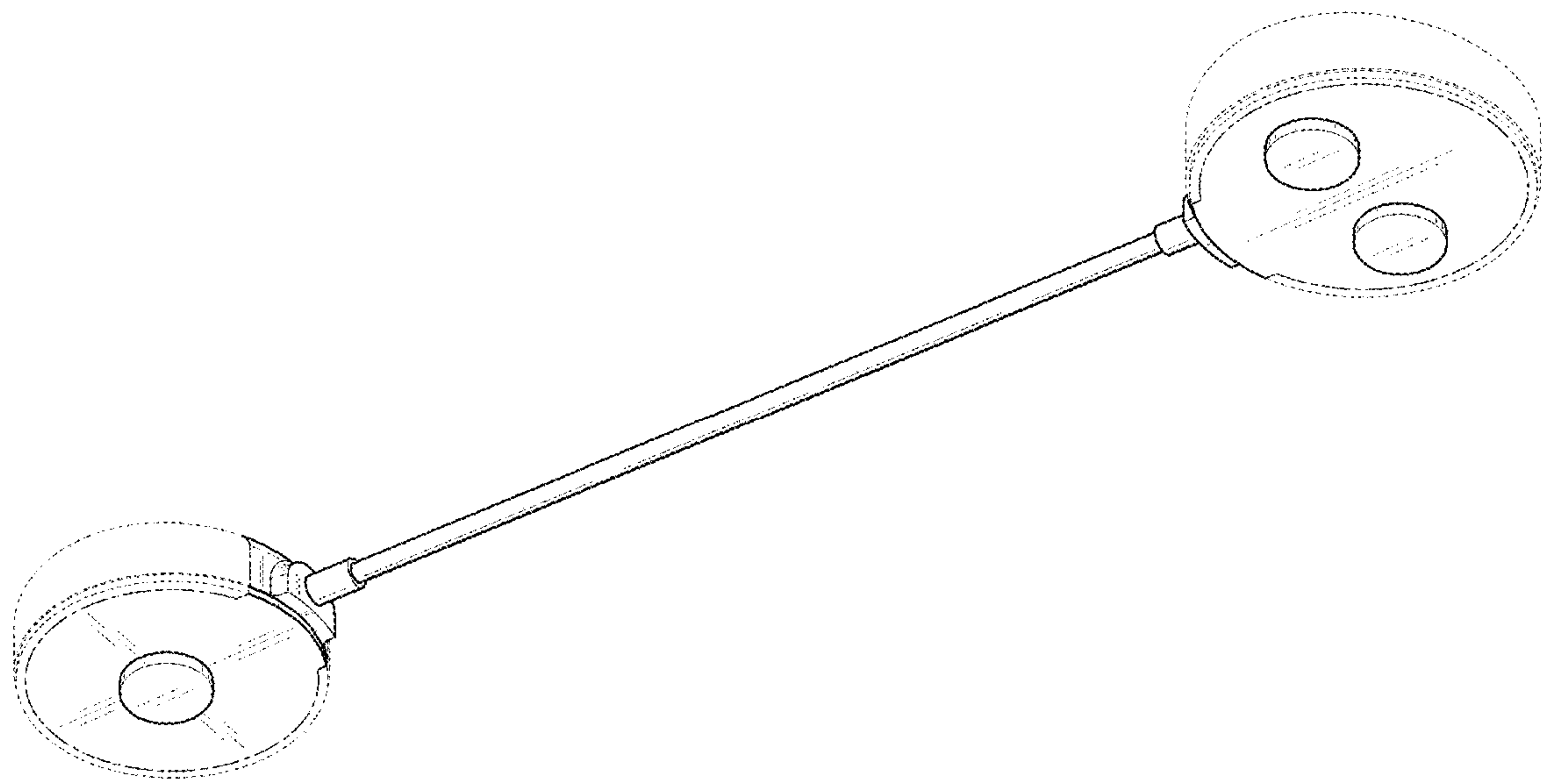
