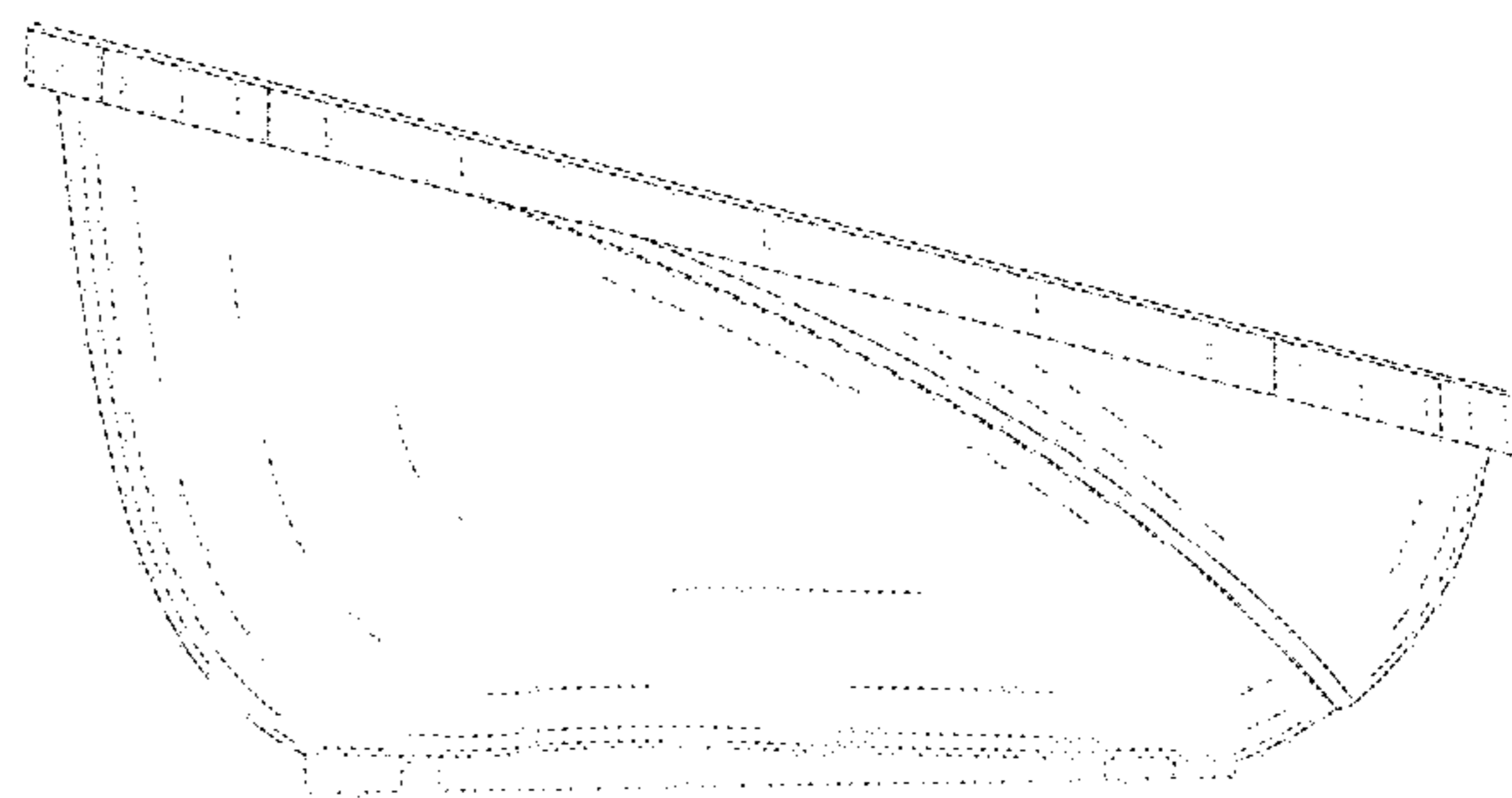
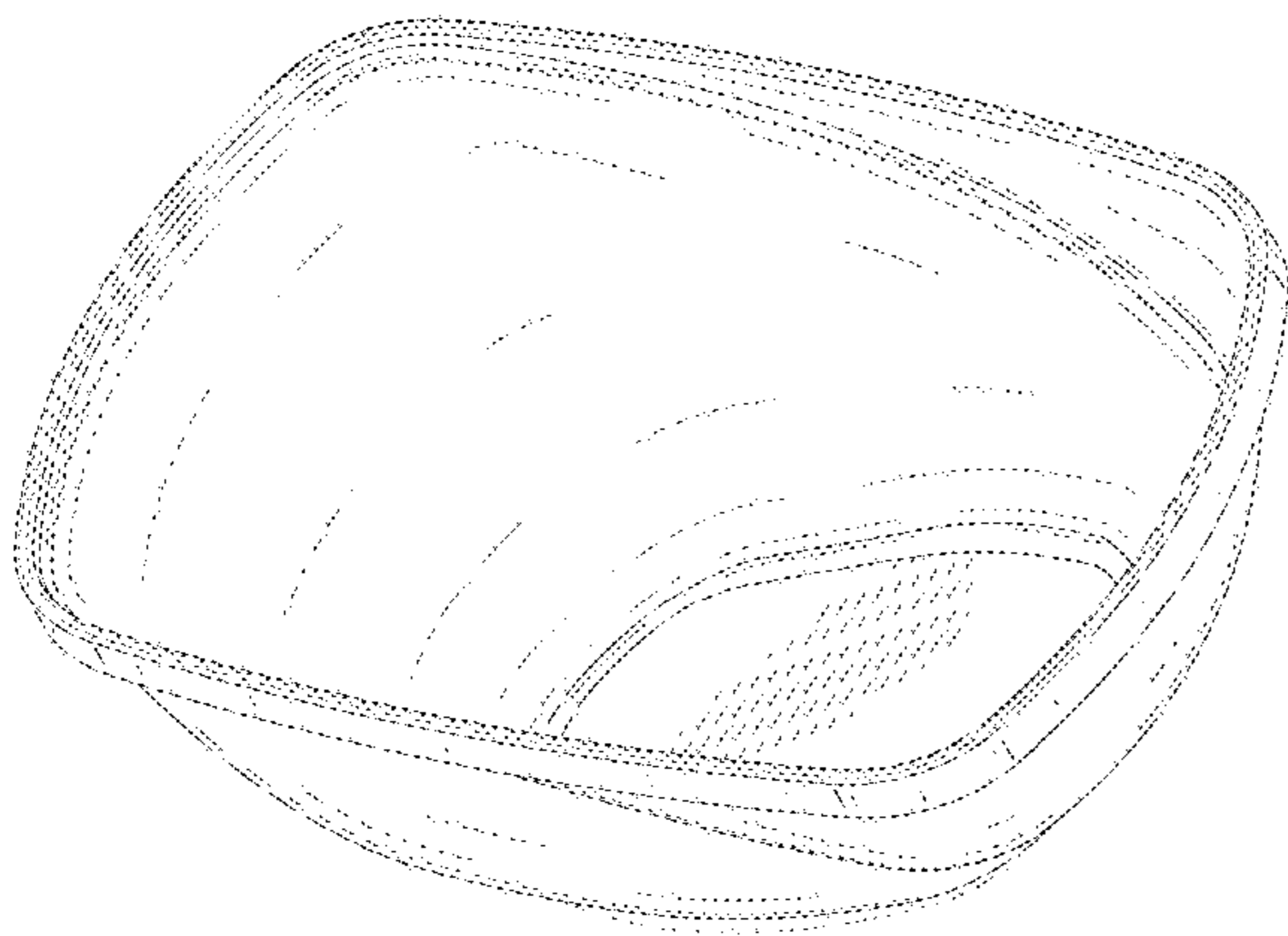
The ornamental design for a litter container, as shown and described.

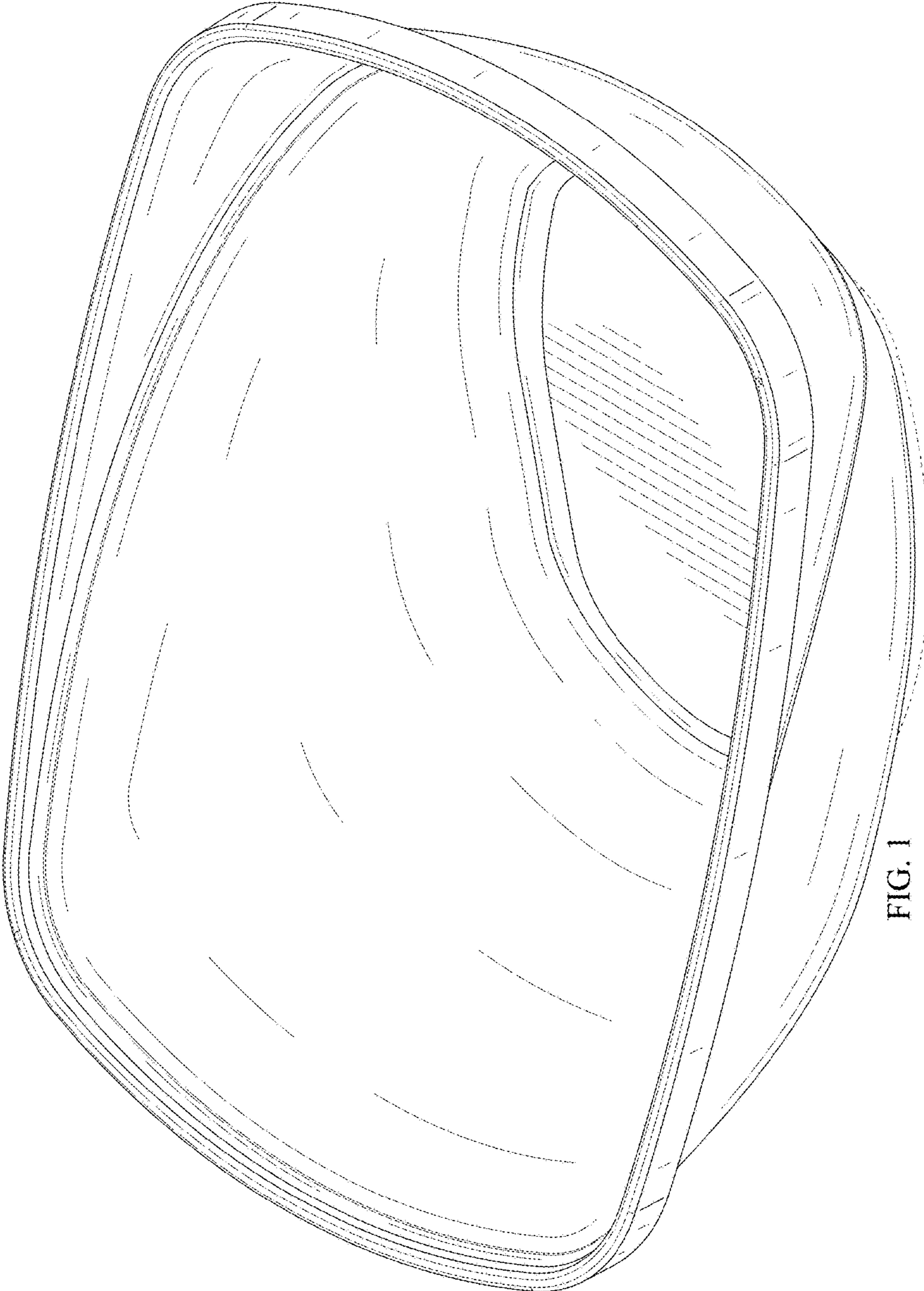

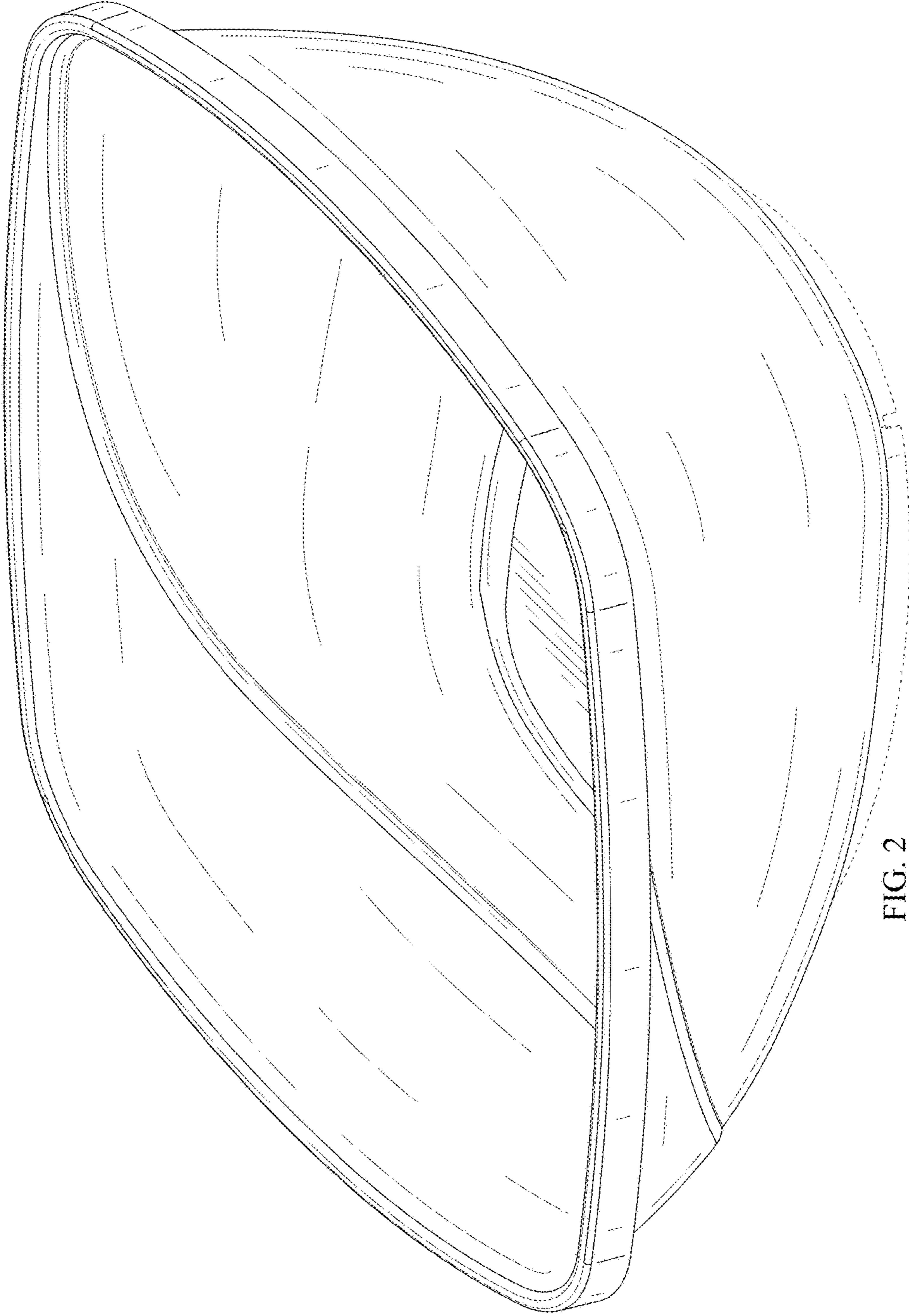

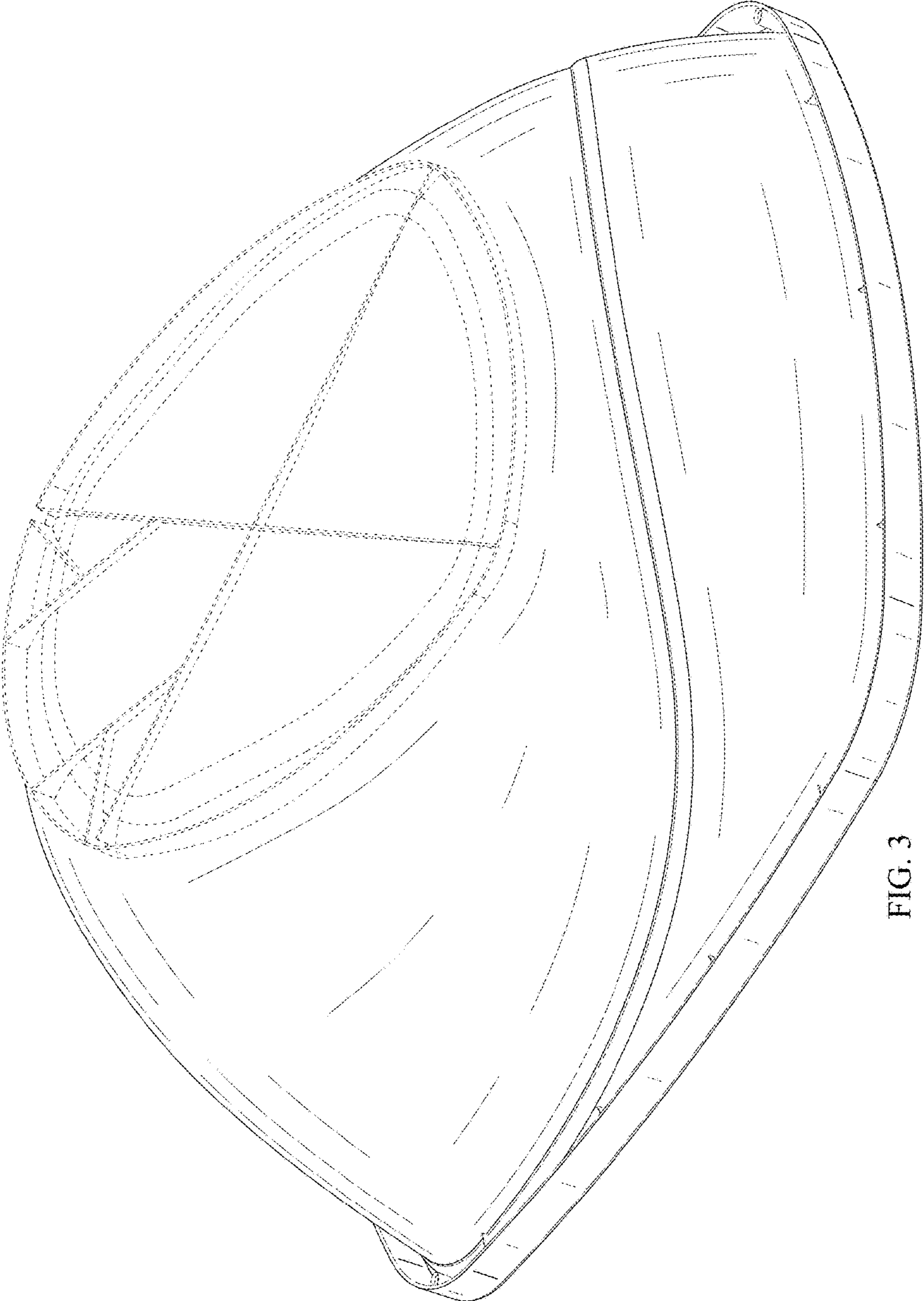

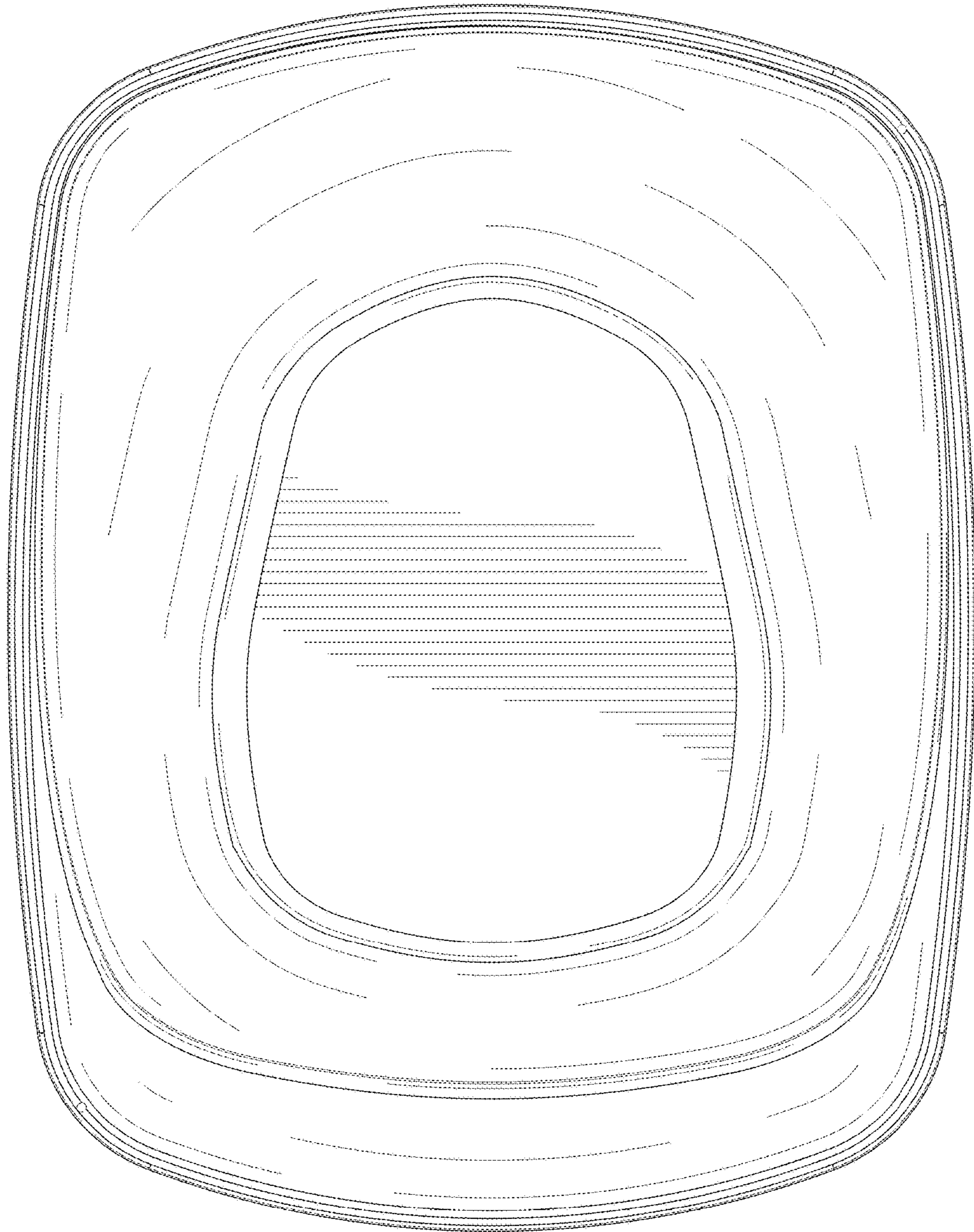

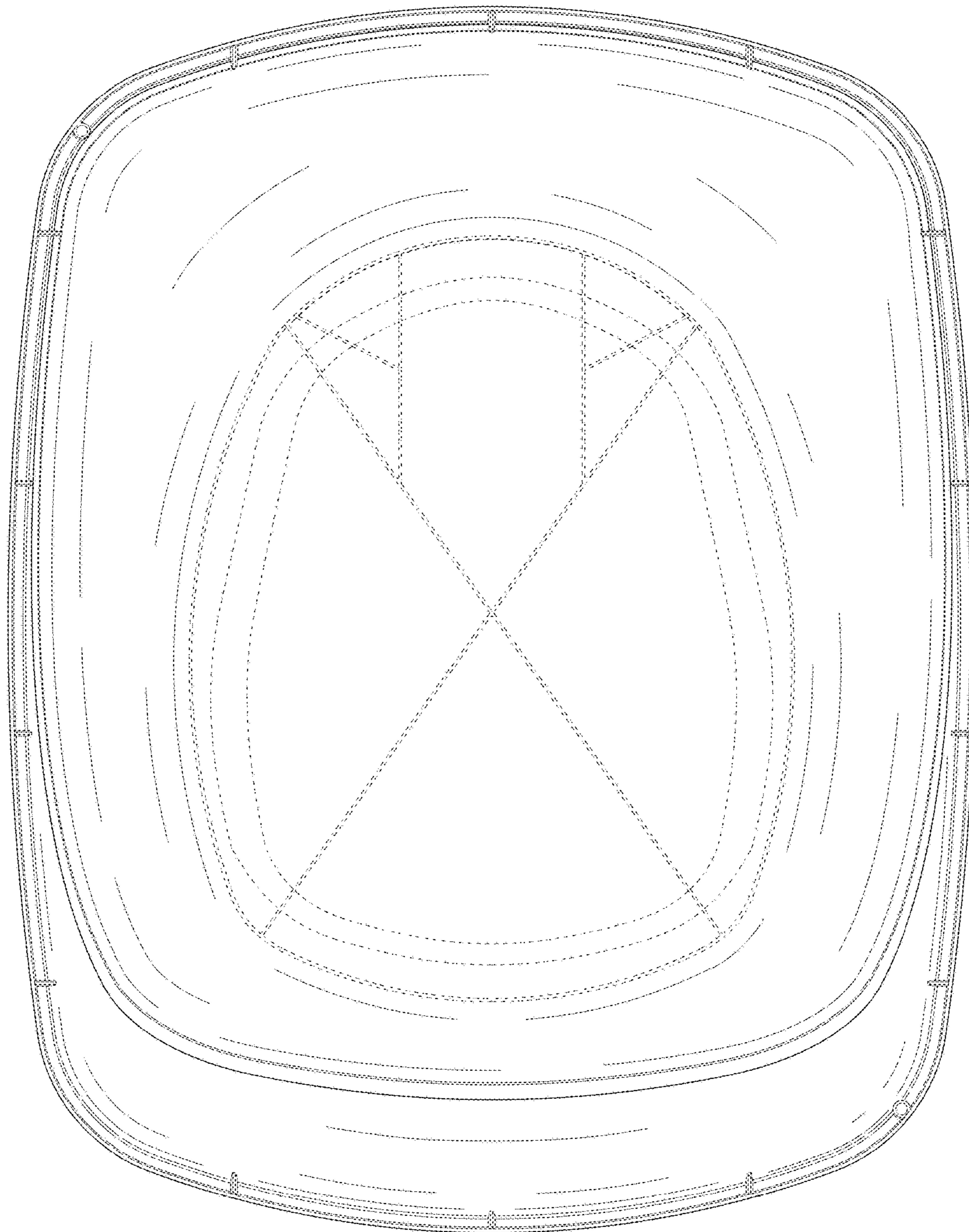

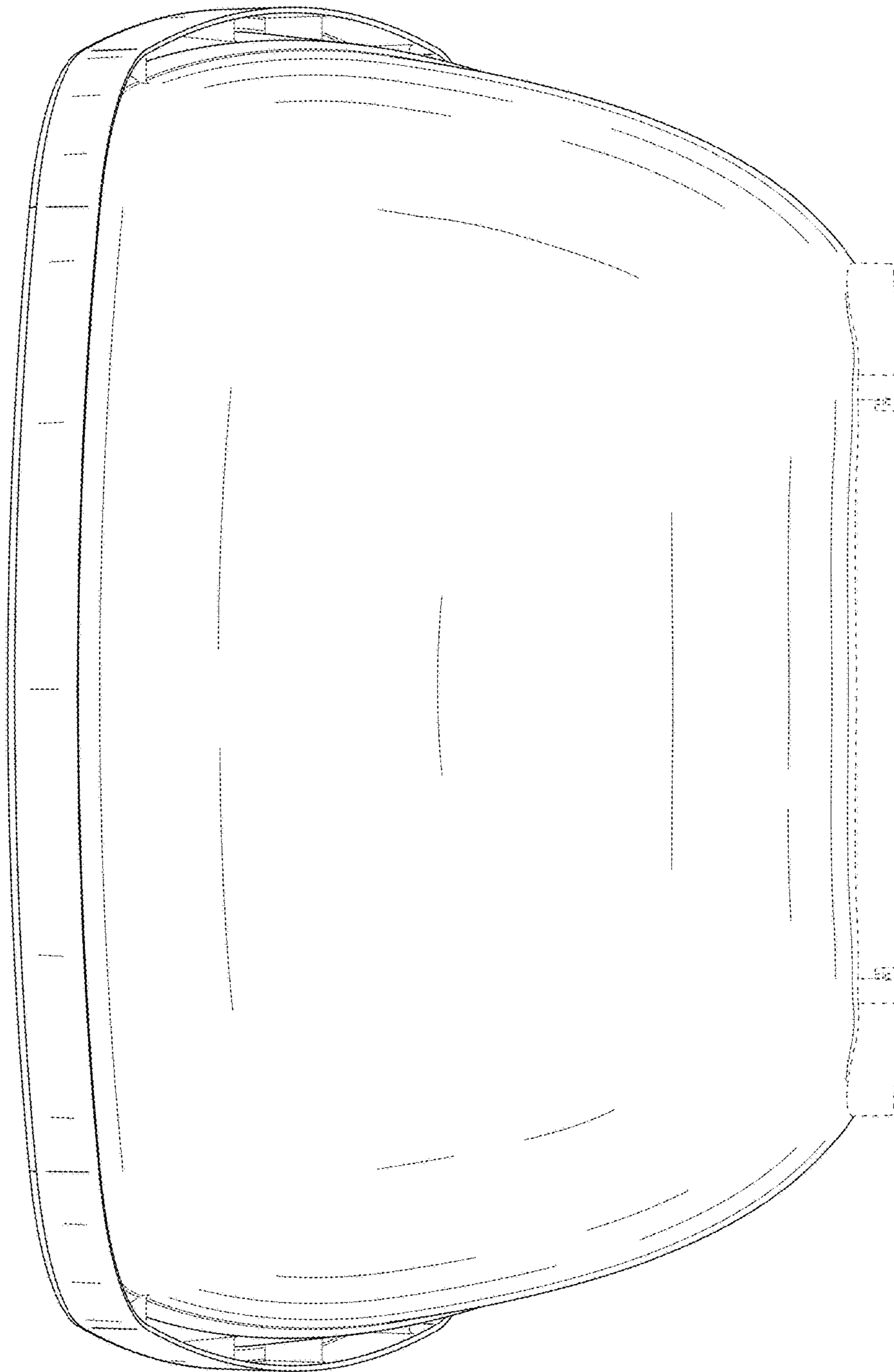
