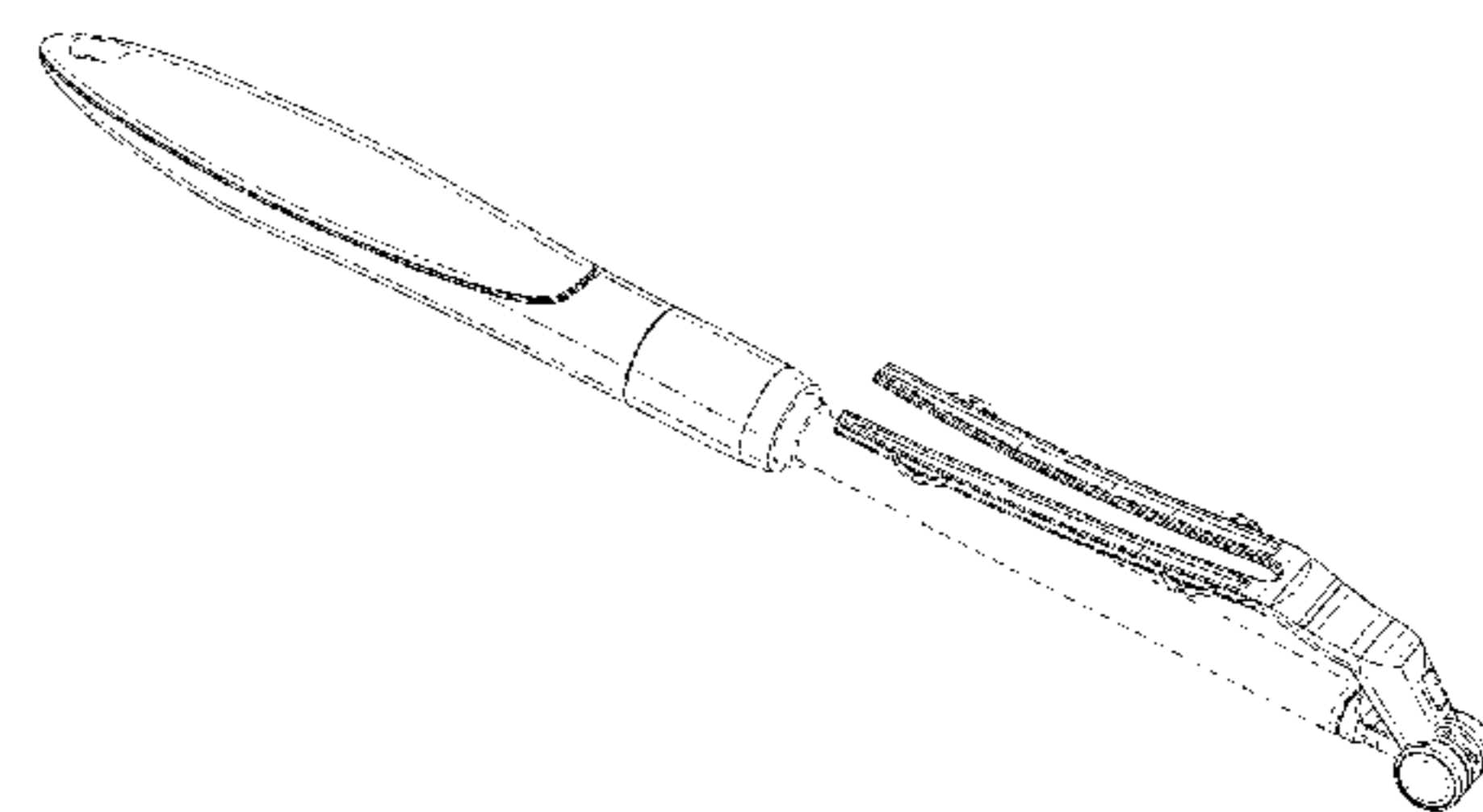
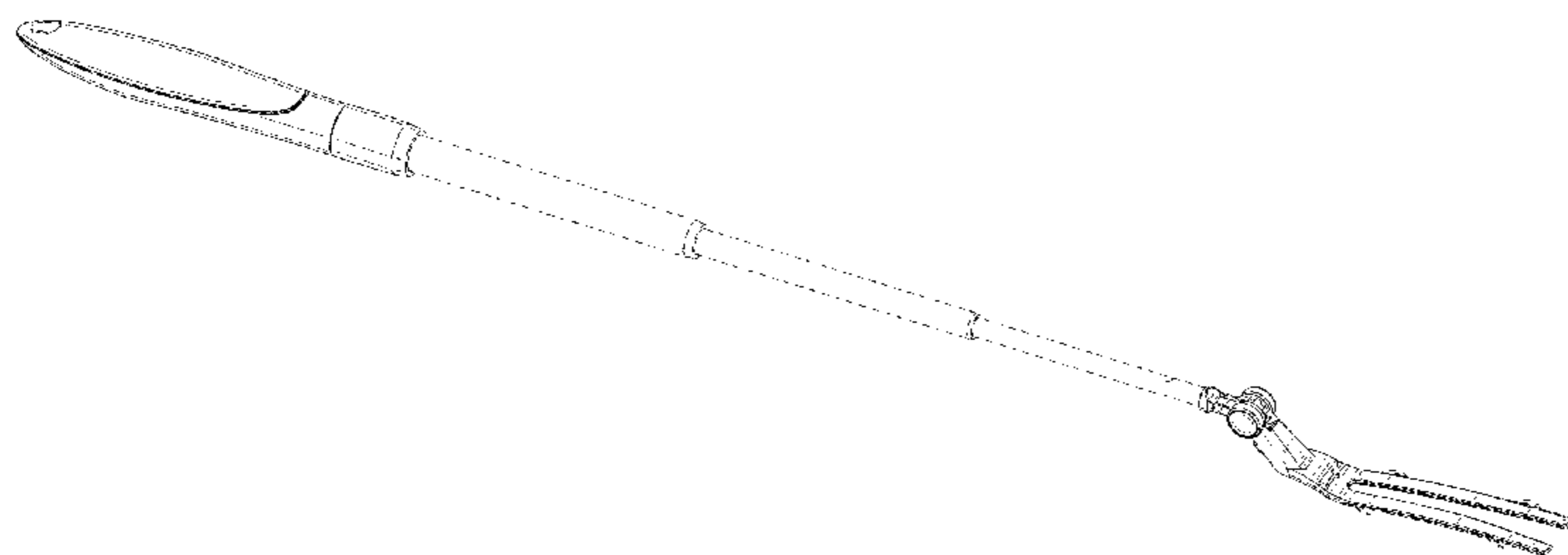
The ornamental design for cleaning device, as shown and described.

**DESCRIPTION**

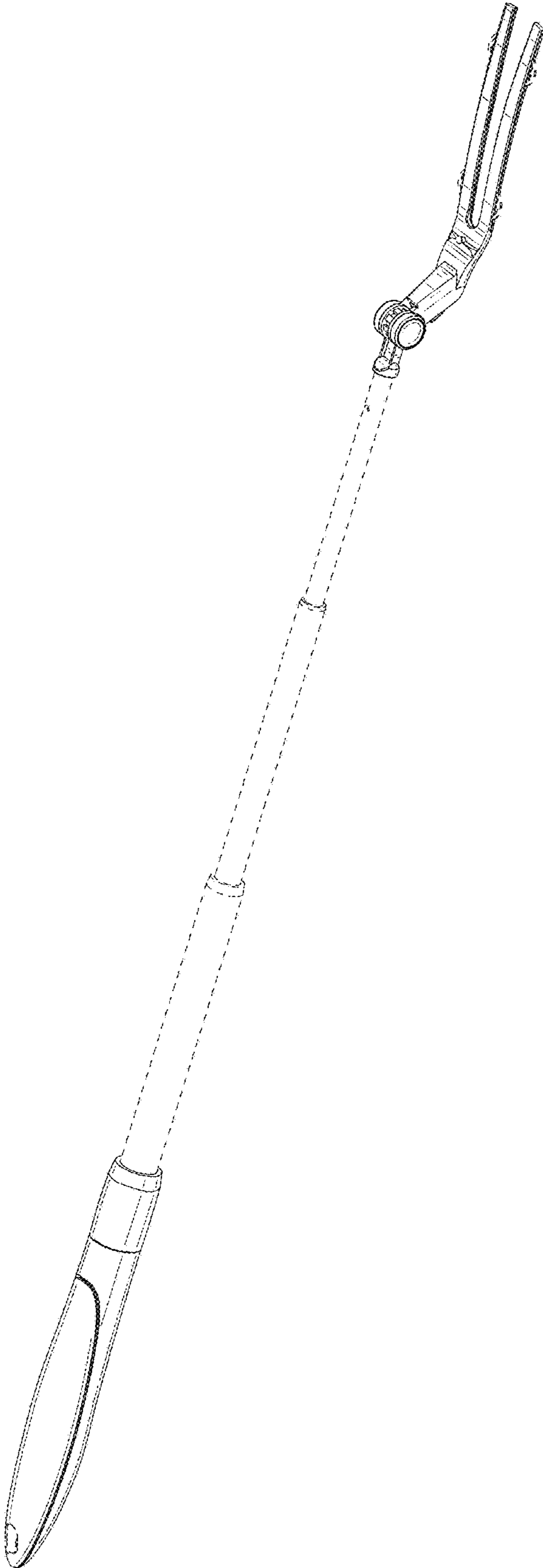

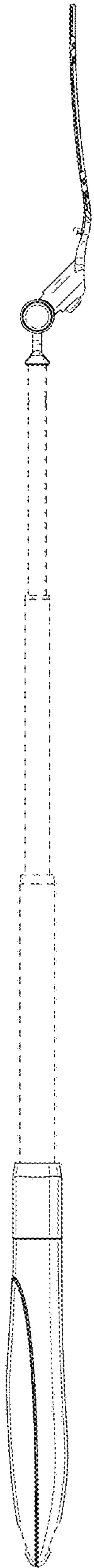

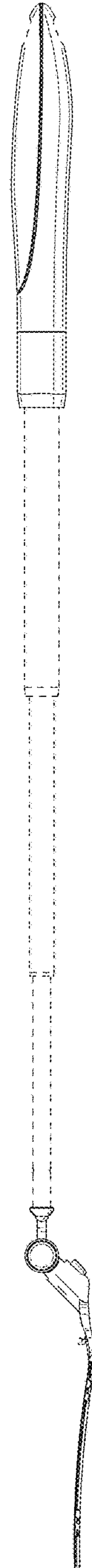

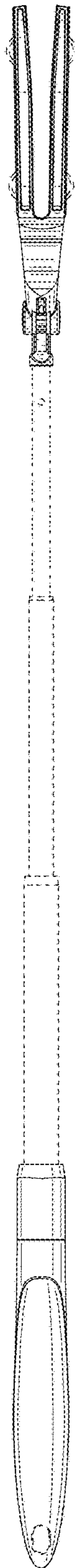

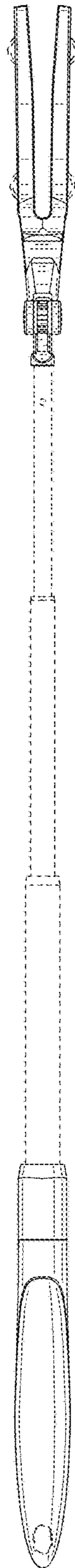

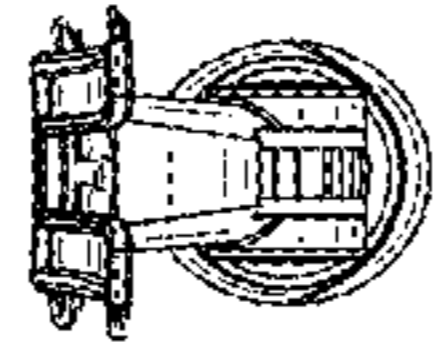

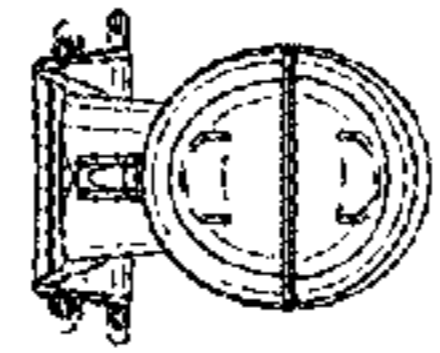

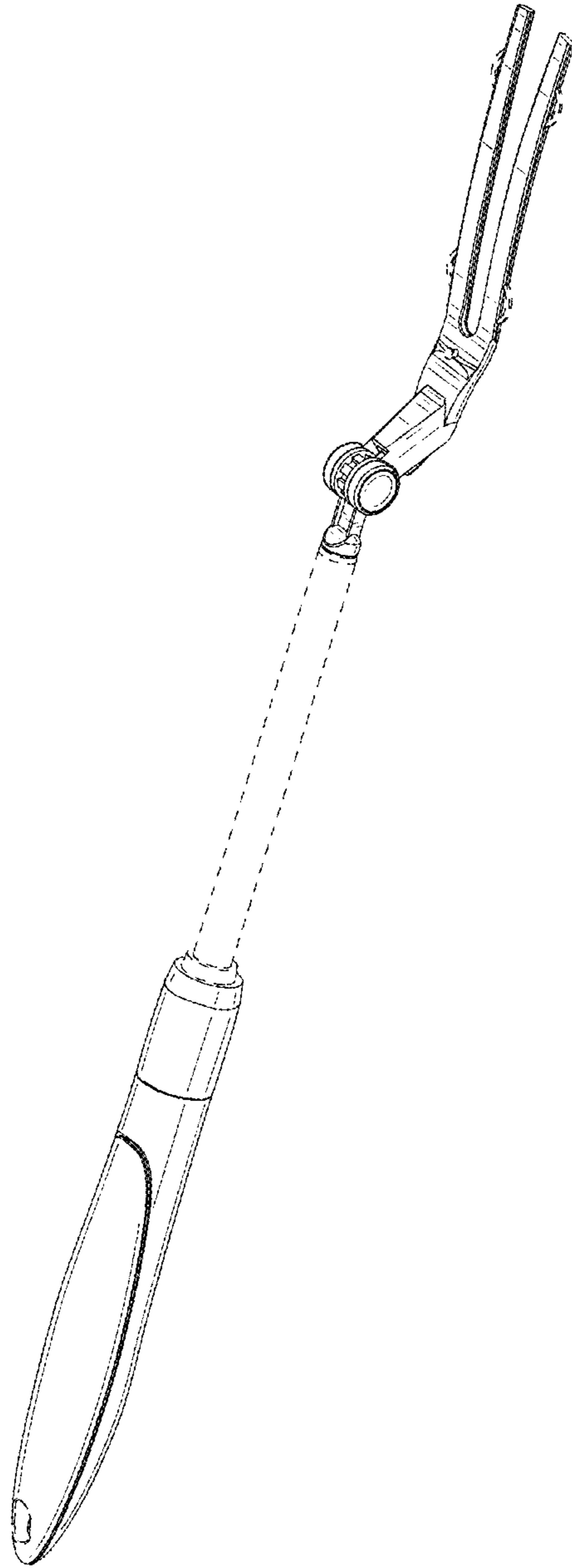

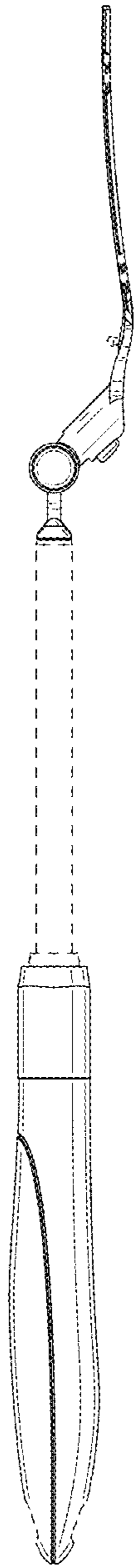

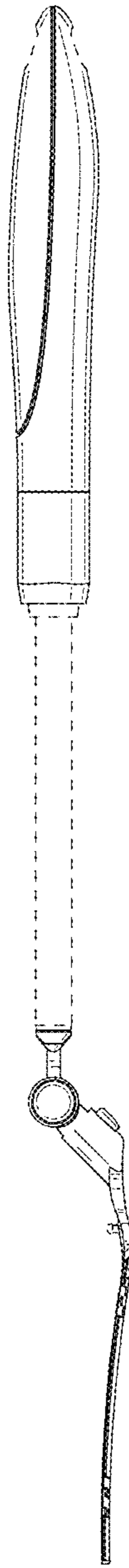

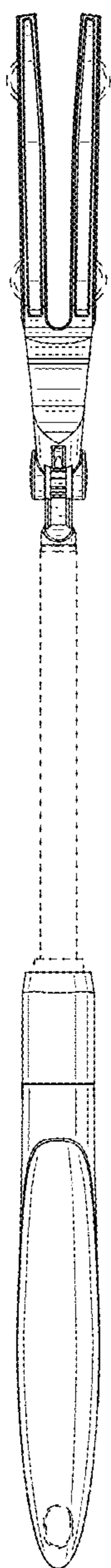

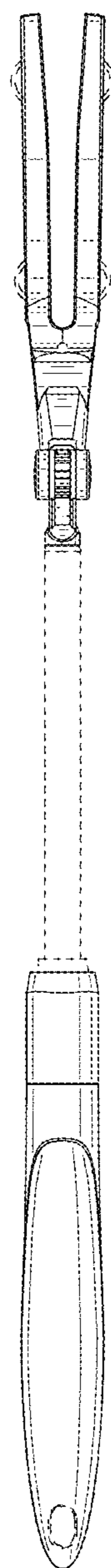

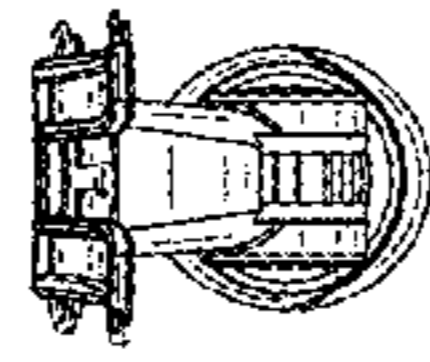

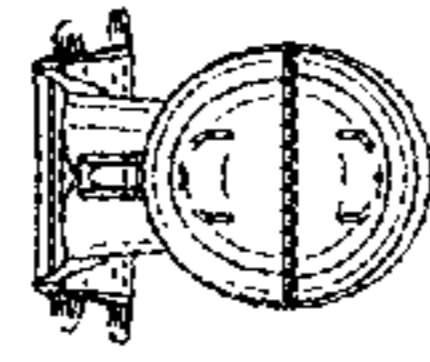

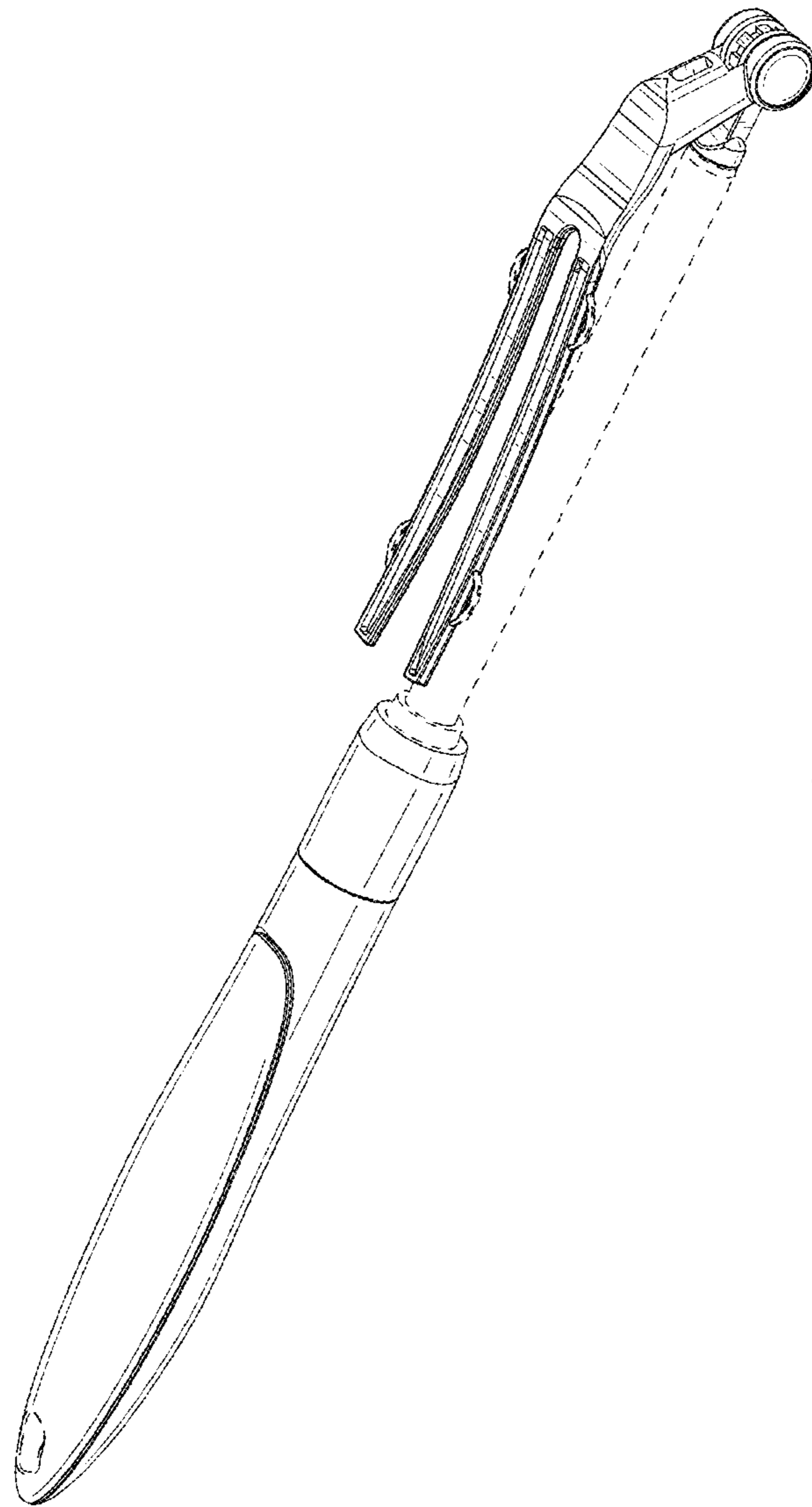

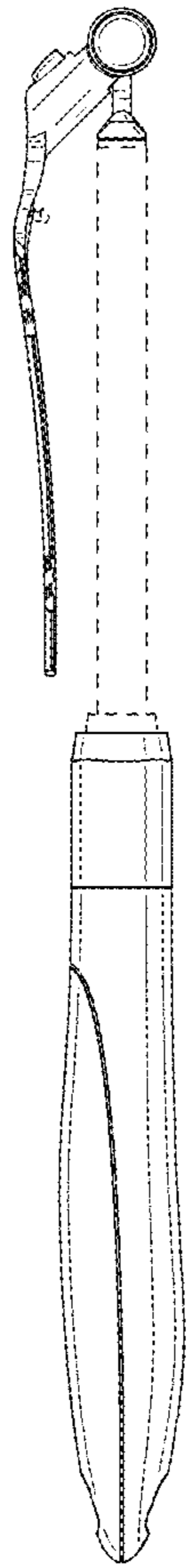

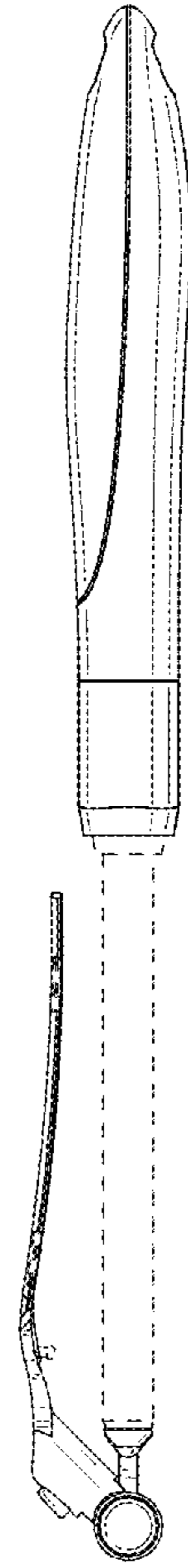

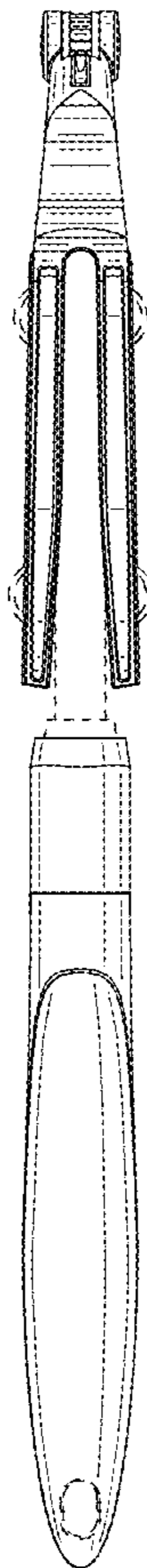

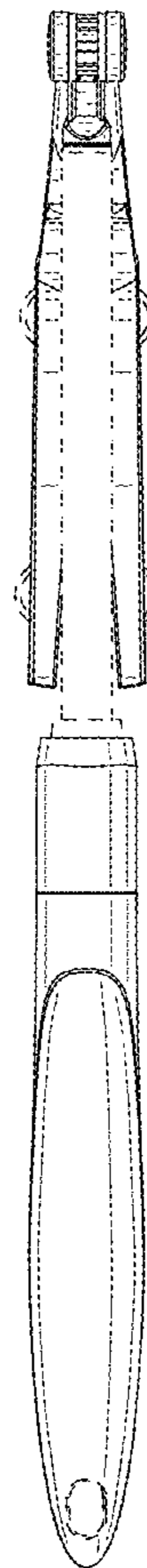

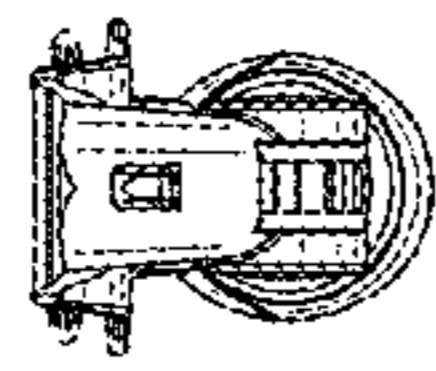

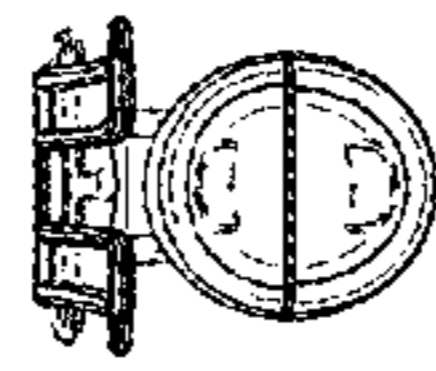
