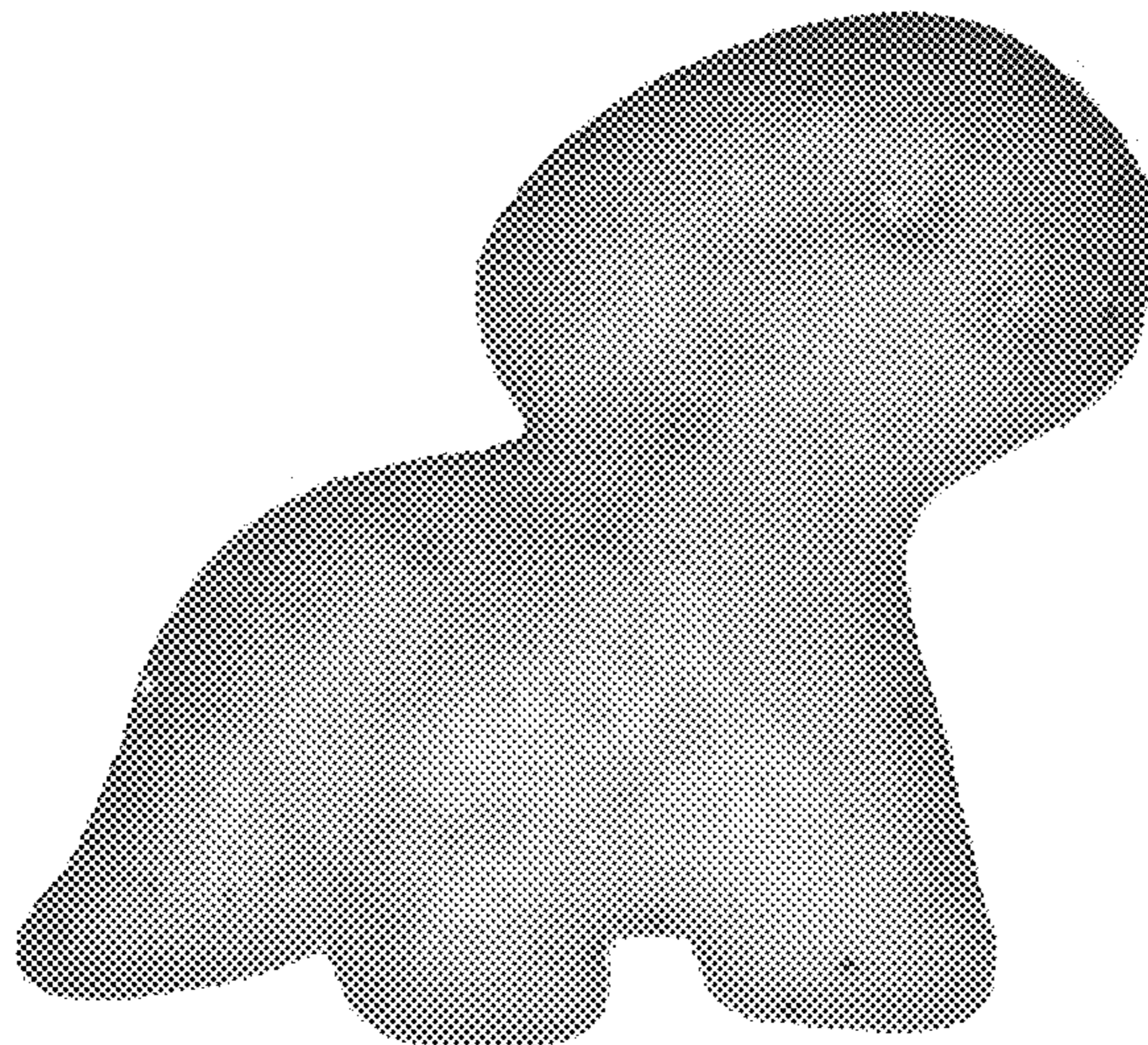
(57) **CLAIM**

The ornamental design for a dinosaur-shaped cracker, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a dinosaur-shaped cracker; FIG. 2 is a top perspective view of the dinosaur-shaped cracker as taken from the front left side. FIG. 3 is a top perspective view of the dinosaur-shaped cracker as taken from the back right side. FIG. 4 is a bottom plan view of the dinosaur-shaped cracker. FIG. 5 is a bottom perspective view of the dinosaur-shaped cracker as taken from the front right side; and, FIG. 6 is a bottom perspective view of the dinosaur-shaped cracker as taken from the back left side.

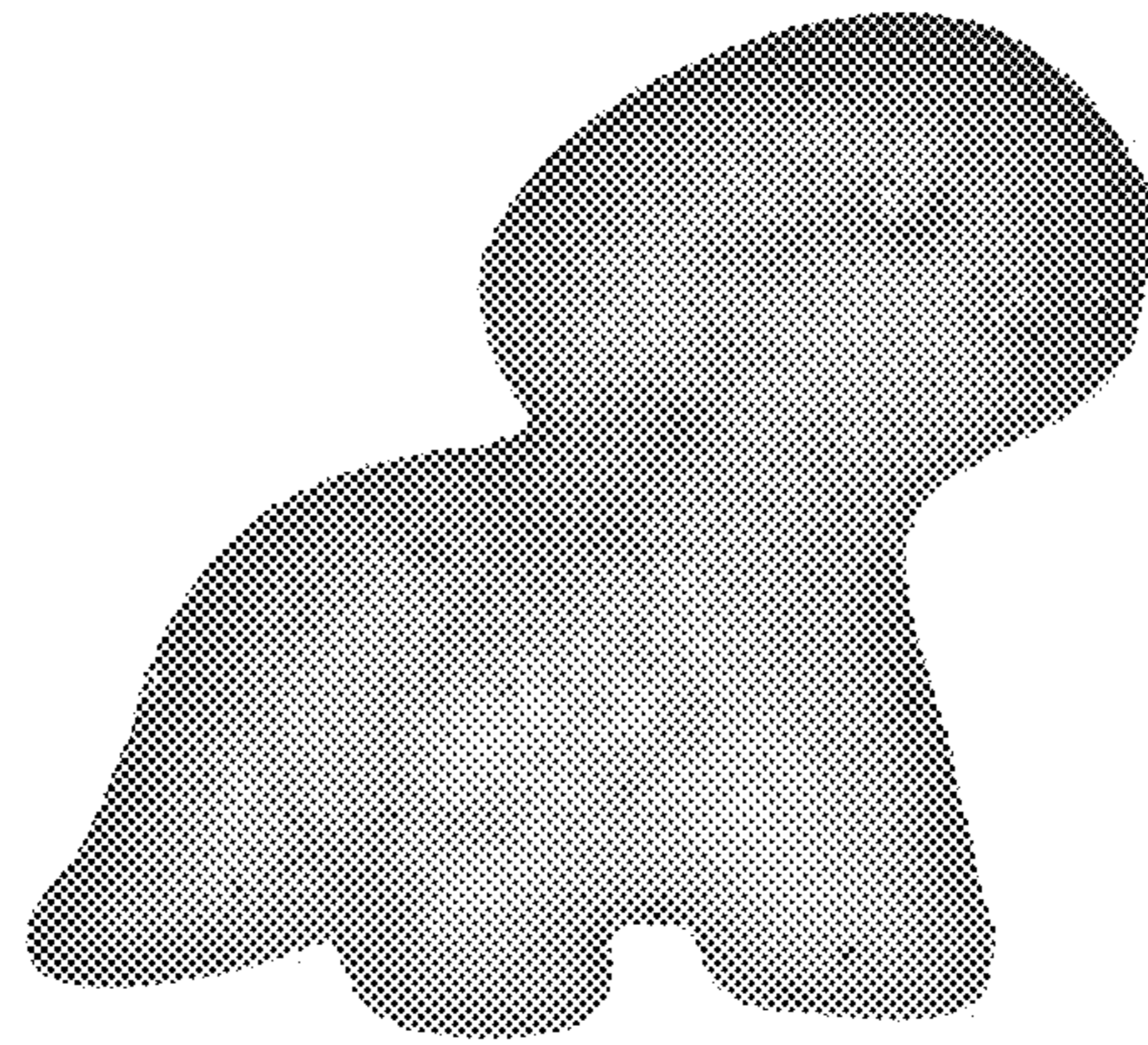

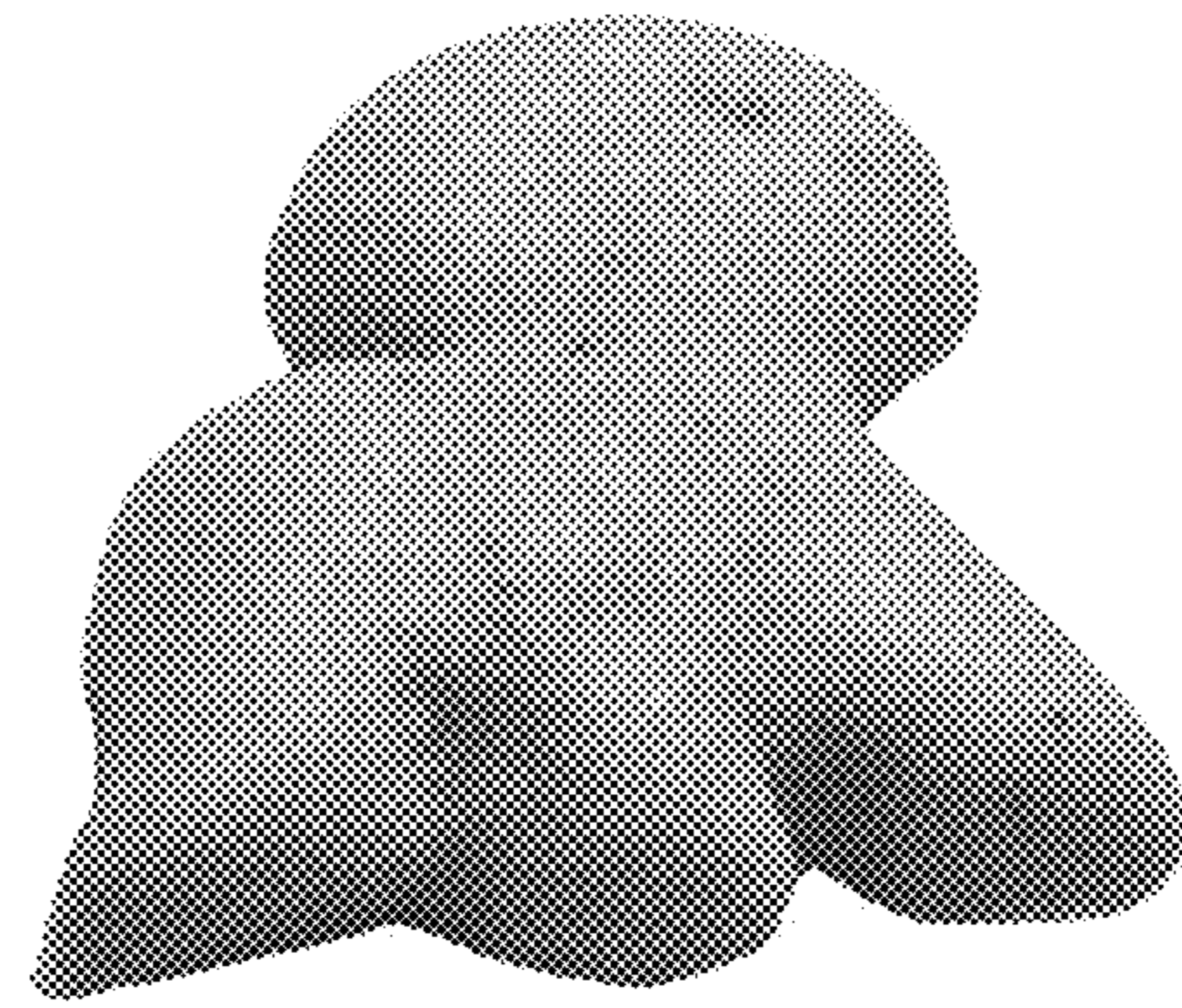

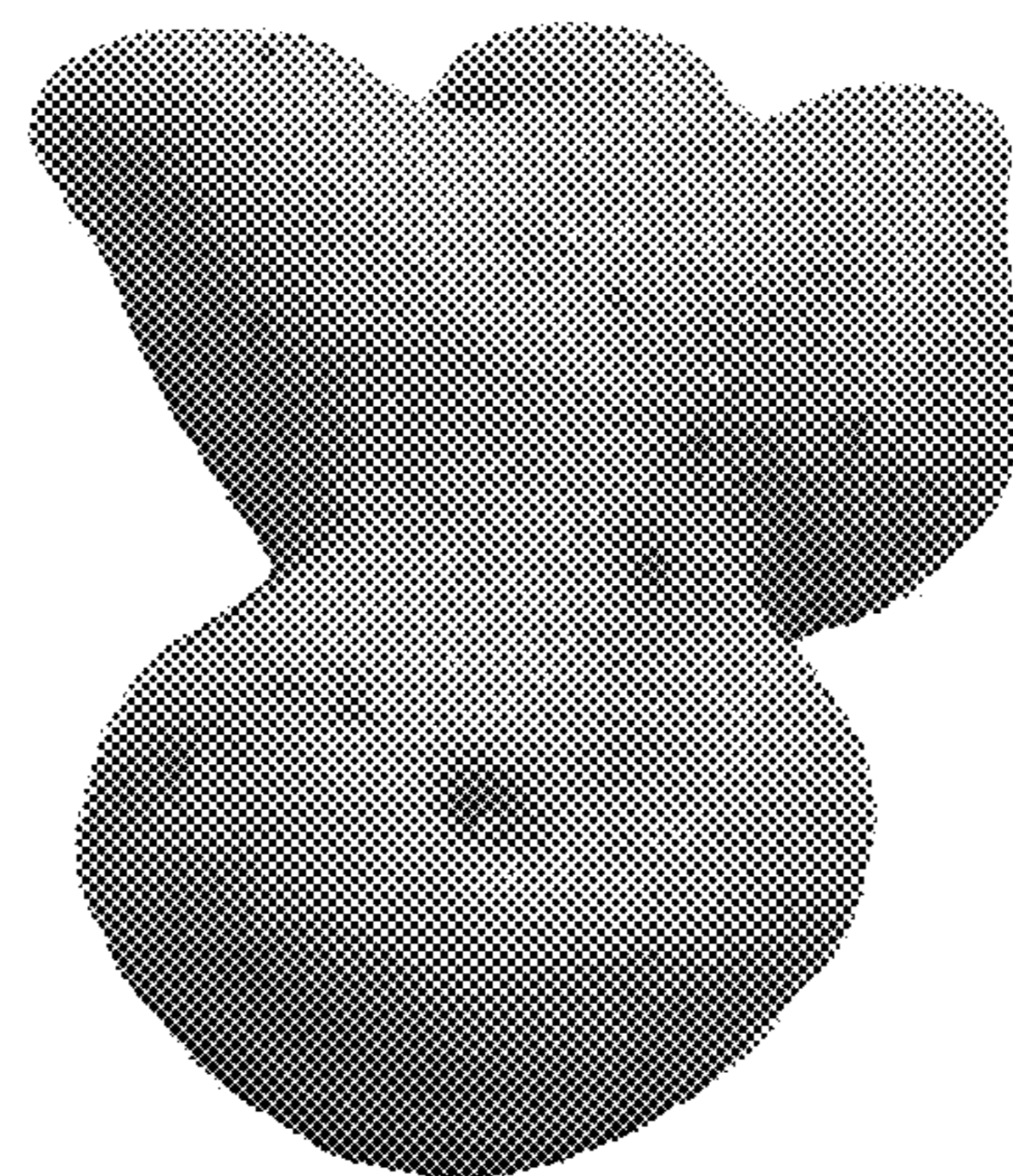

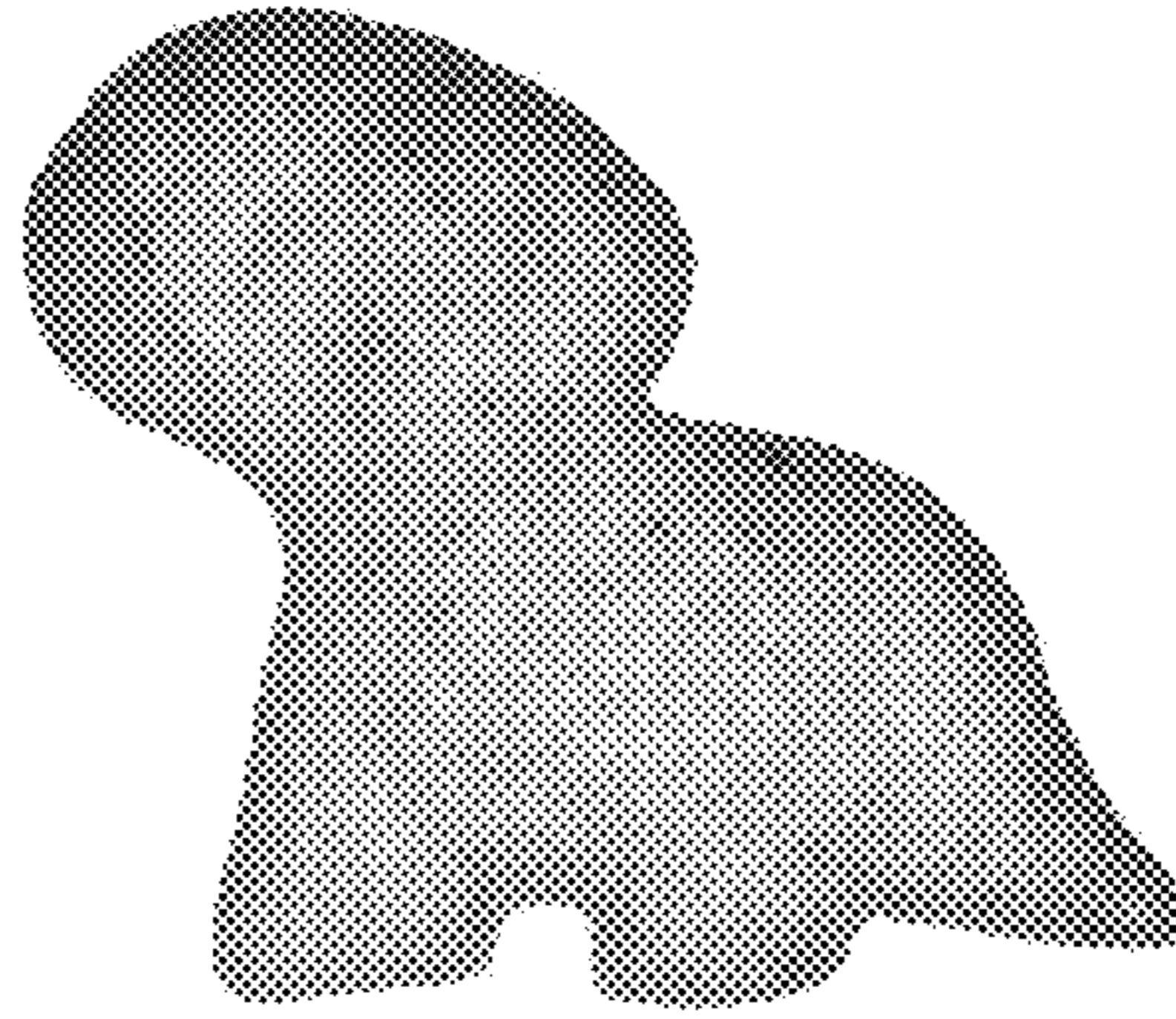

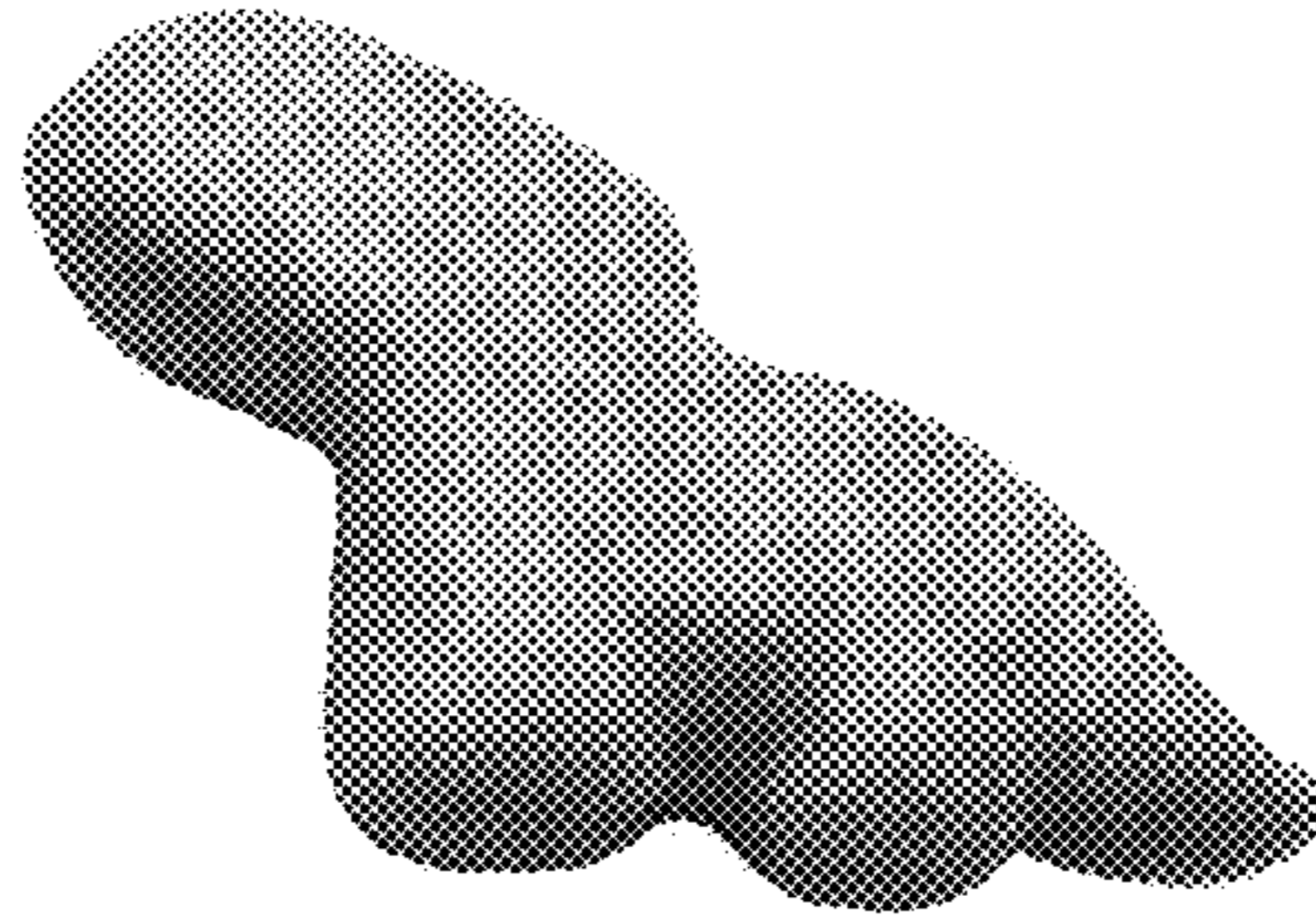

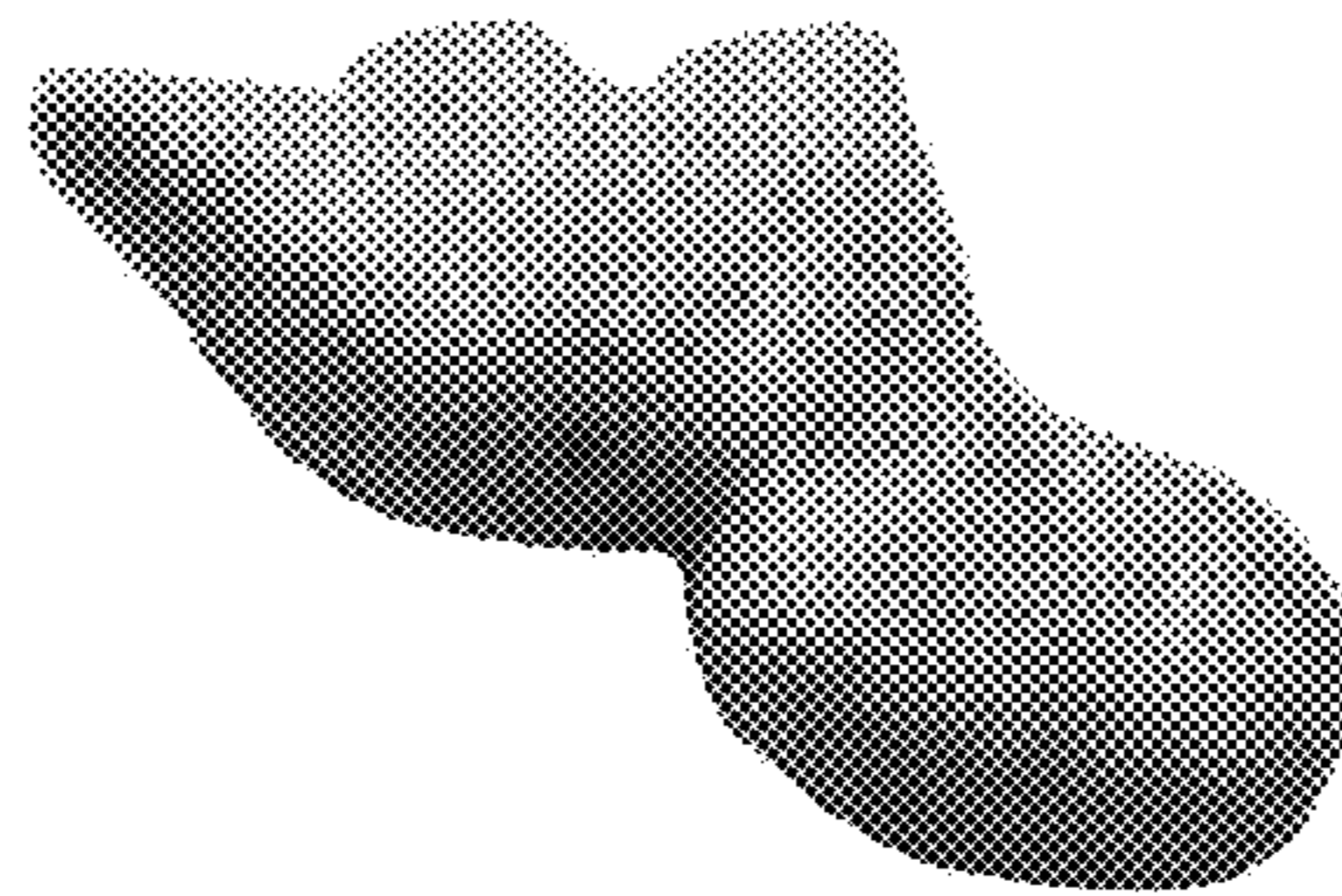
