The ornamental design for a brush handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a brush handle showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is another perspective view thereof, shown in use.  
The broken line showing a brush head is included for the purpose of illustrating use and environment and forms no part of the claimed design.

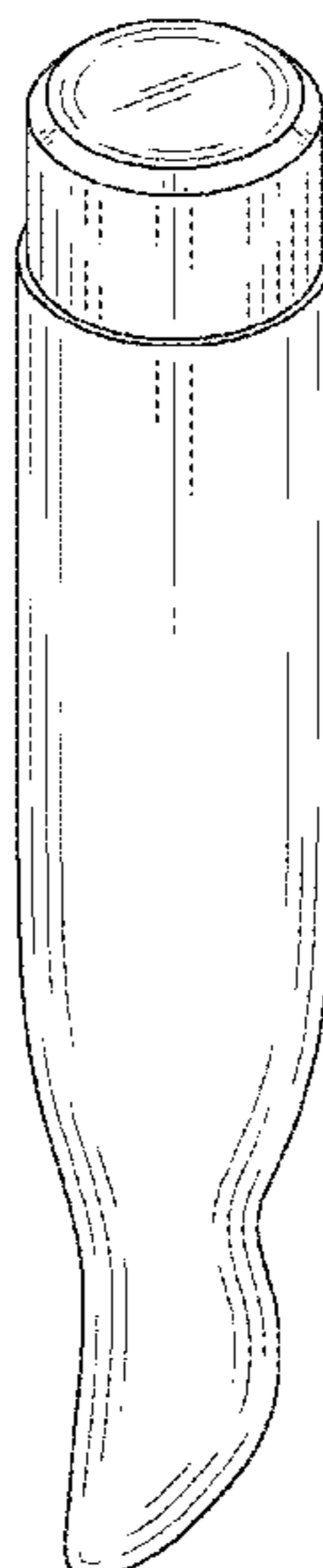

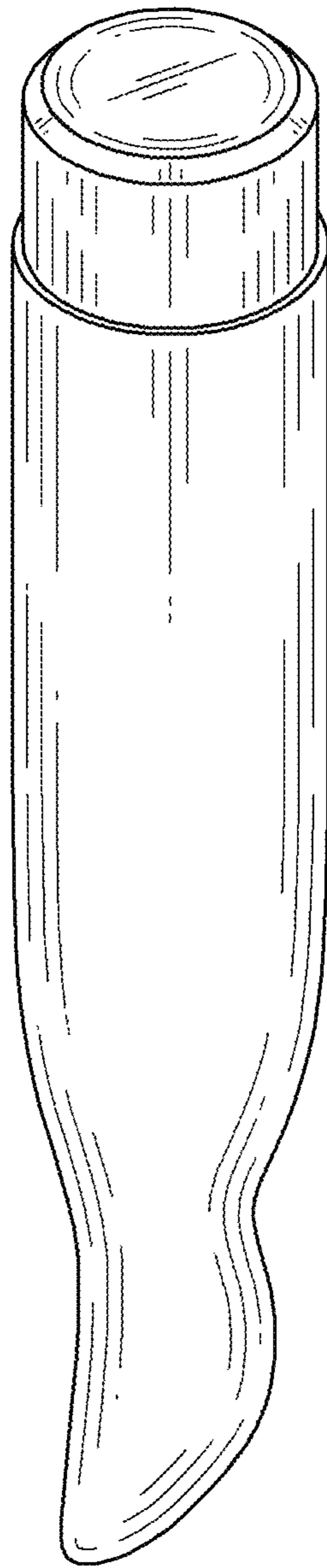

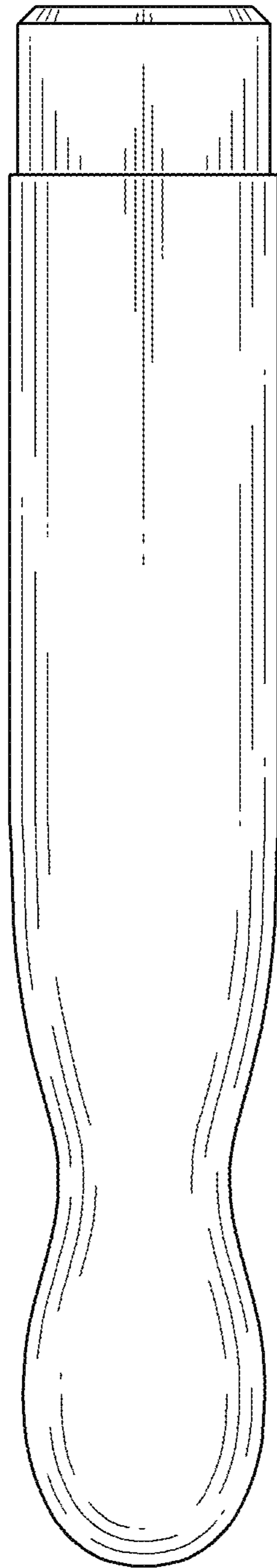

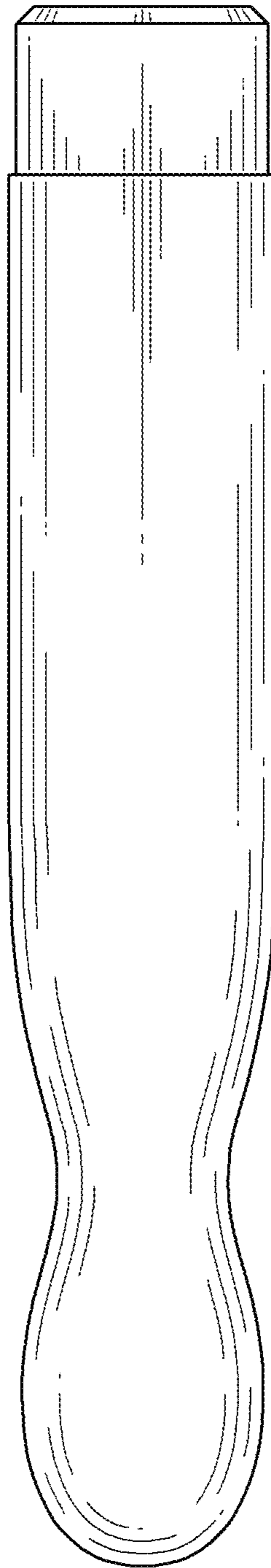

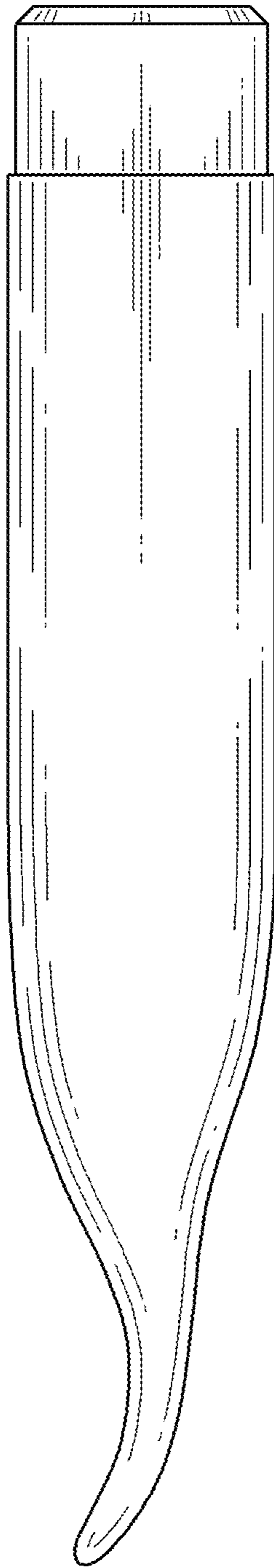

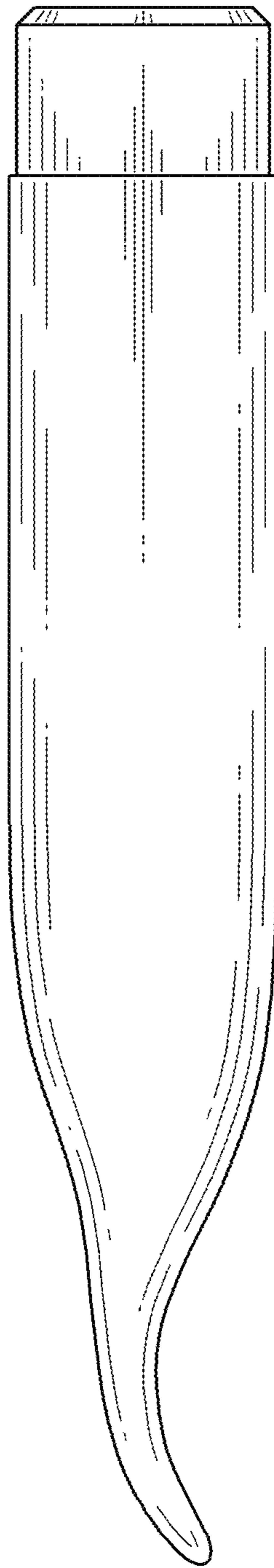

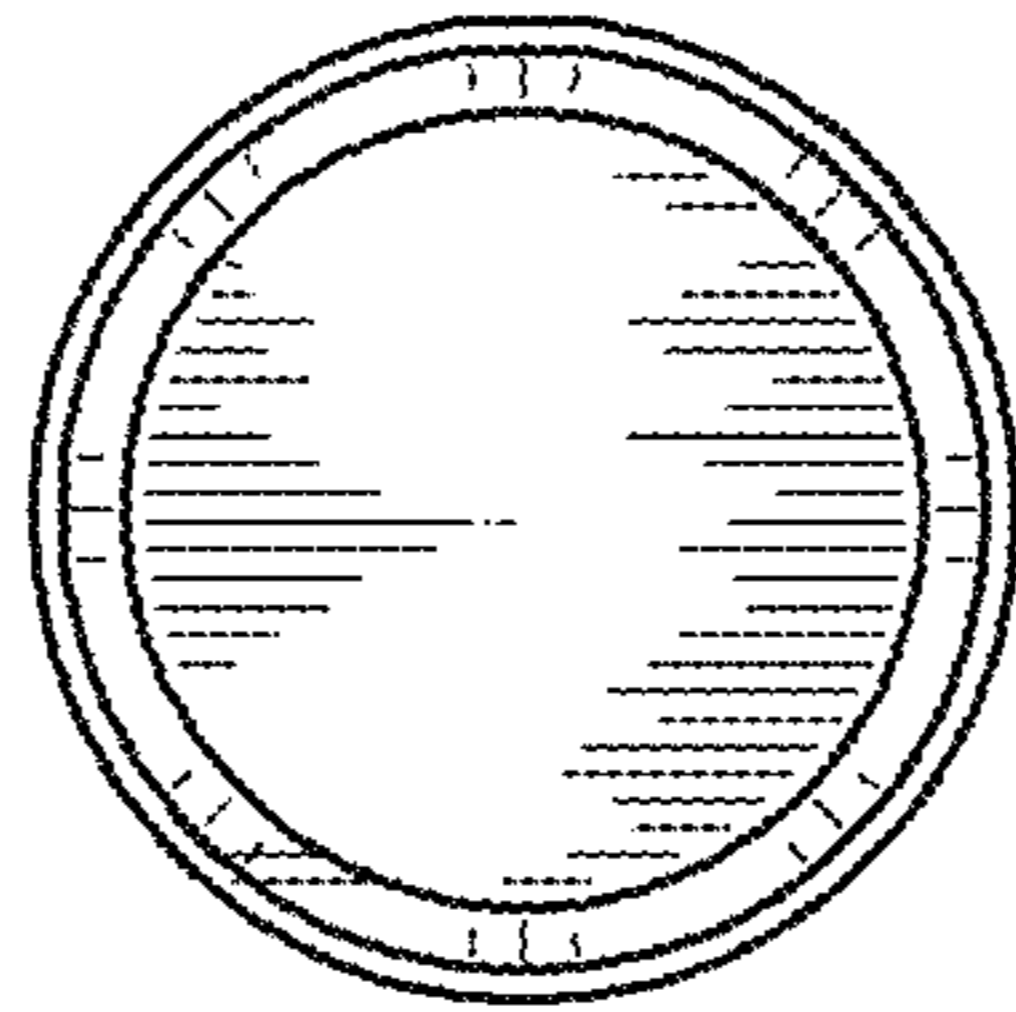

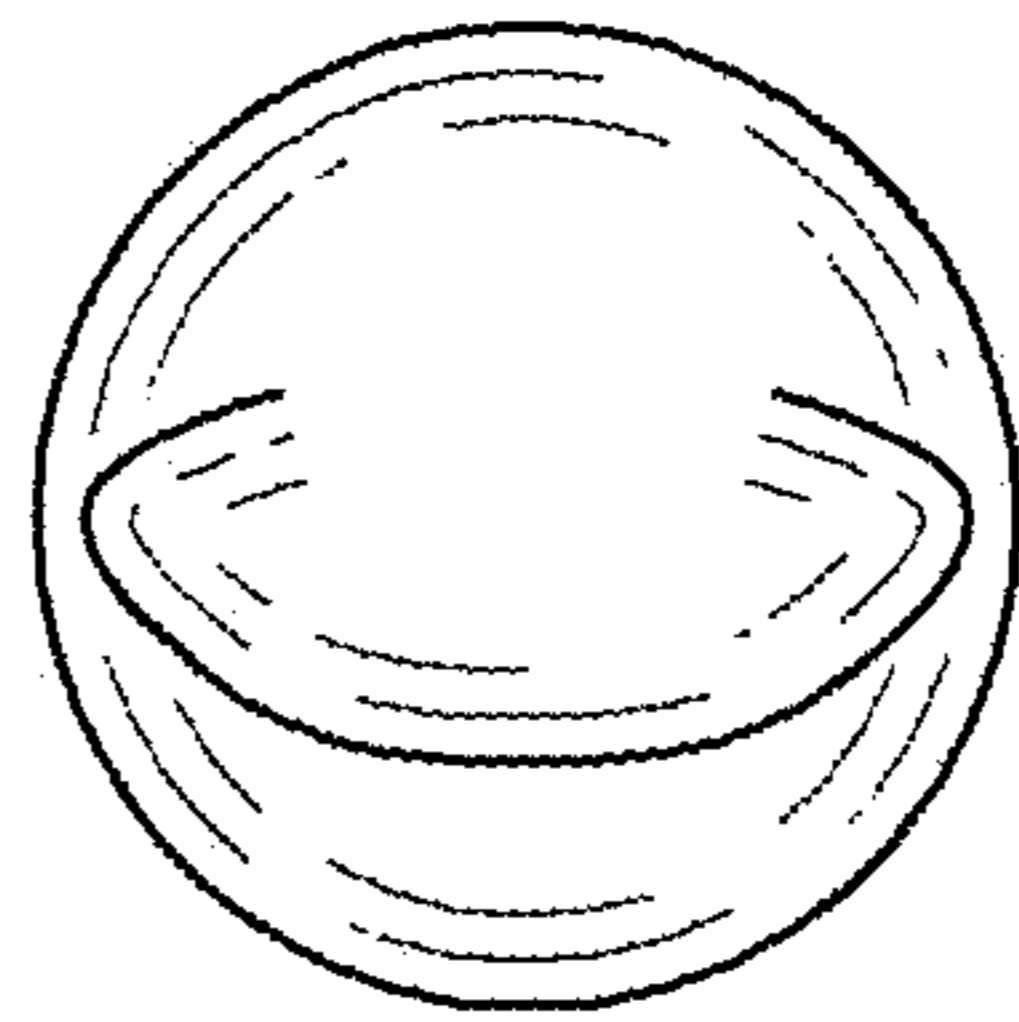
