FIG. 6 is a top view of the cosmetic vessel of FIG. 1; and,

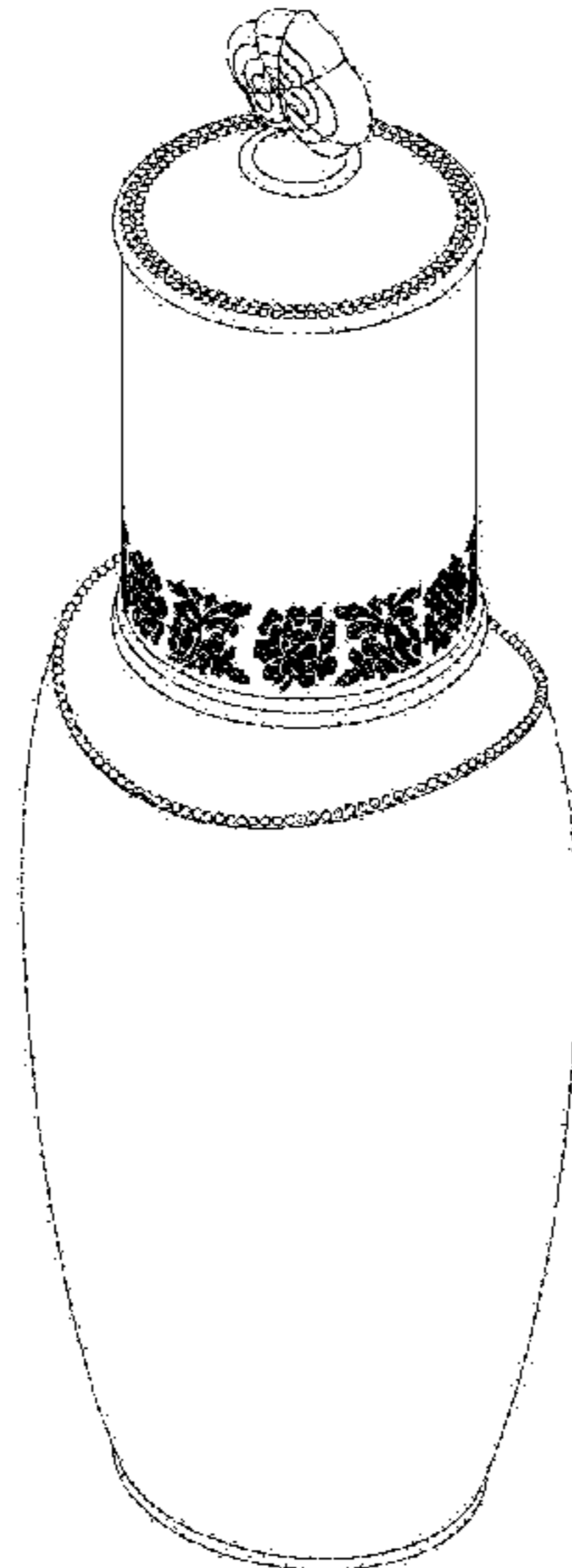
FIG. 7 is a bottom view of the cosmetic vessel of FIG. 1.

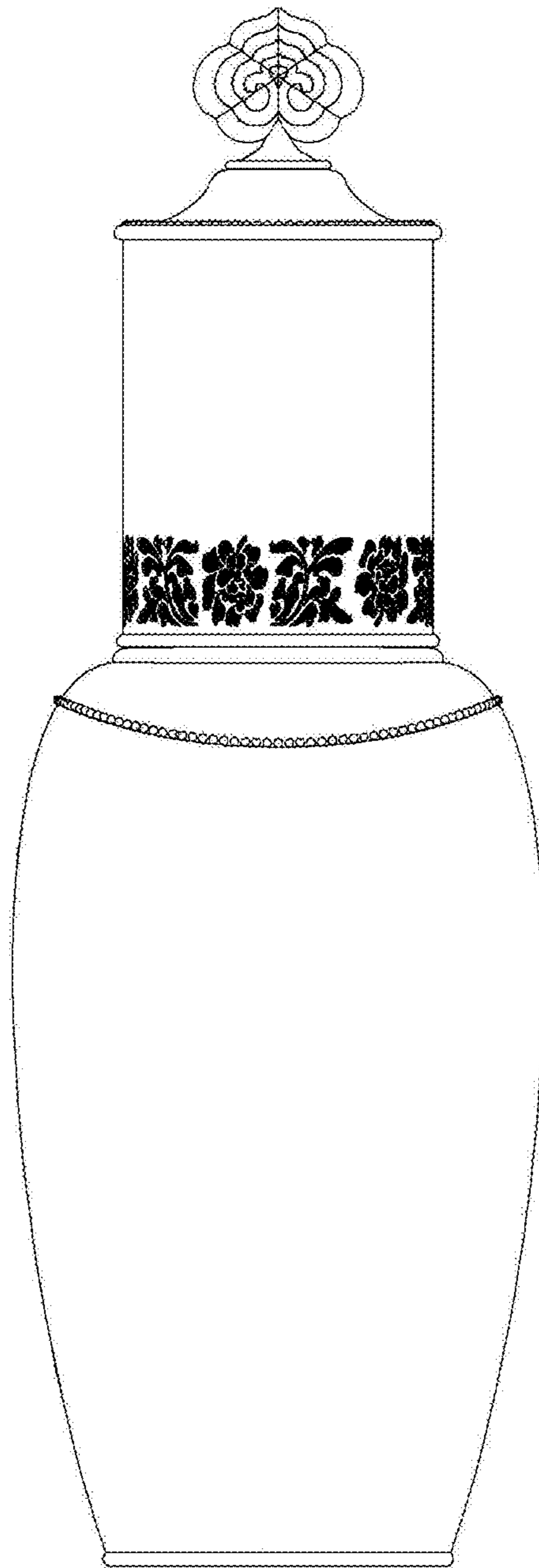

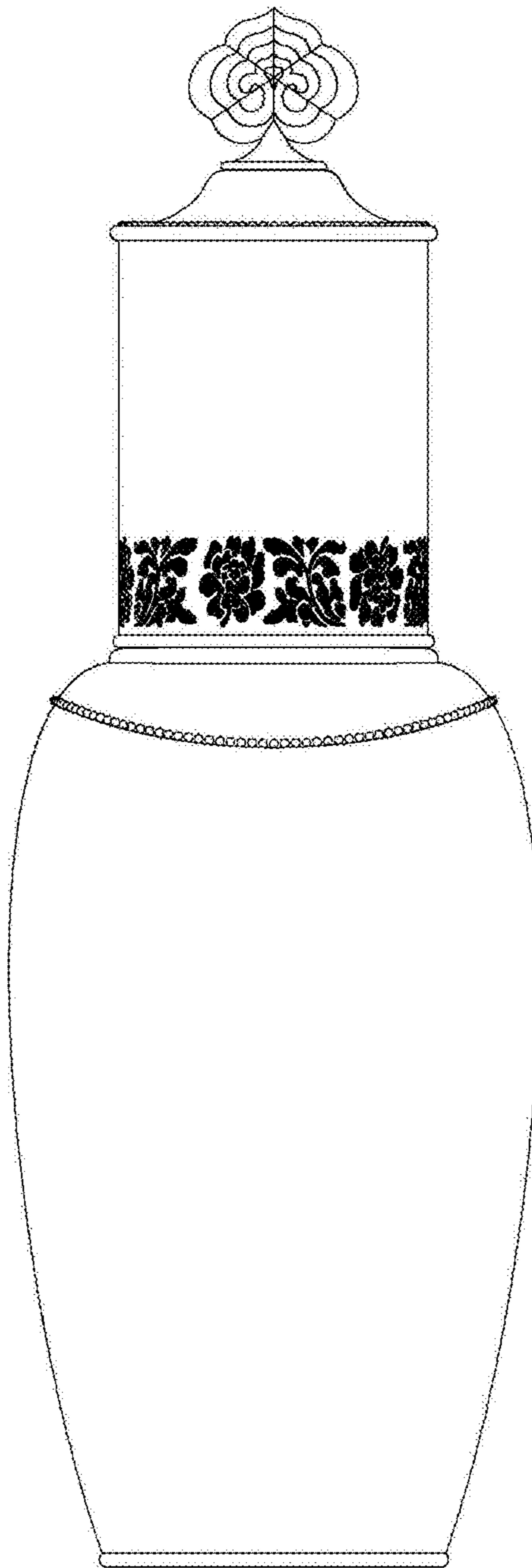

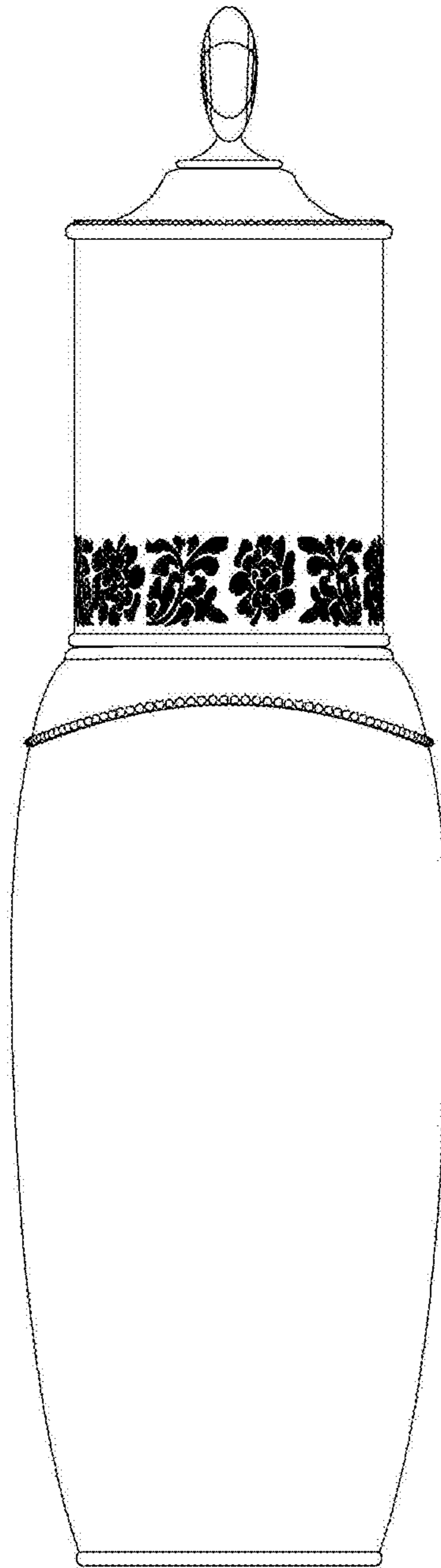

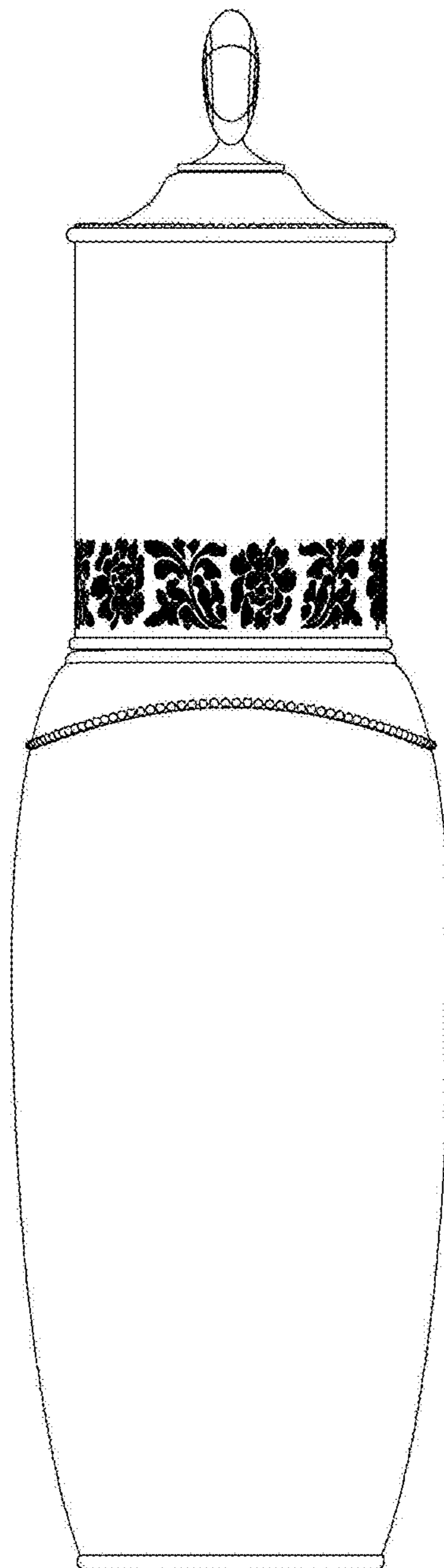

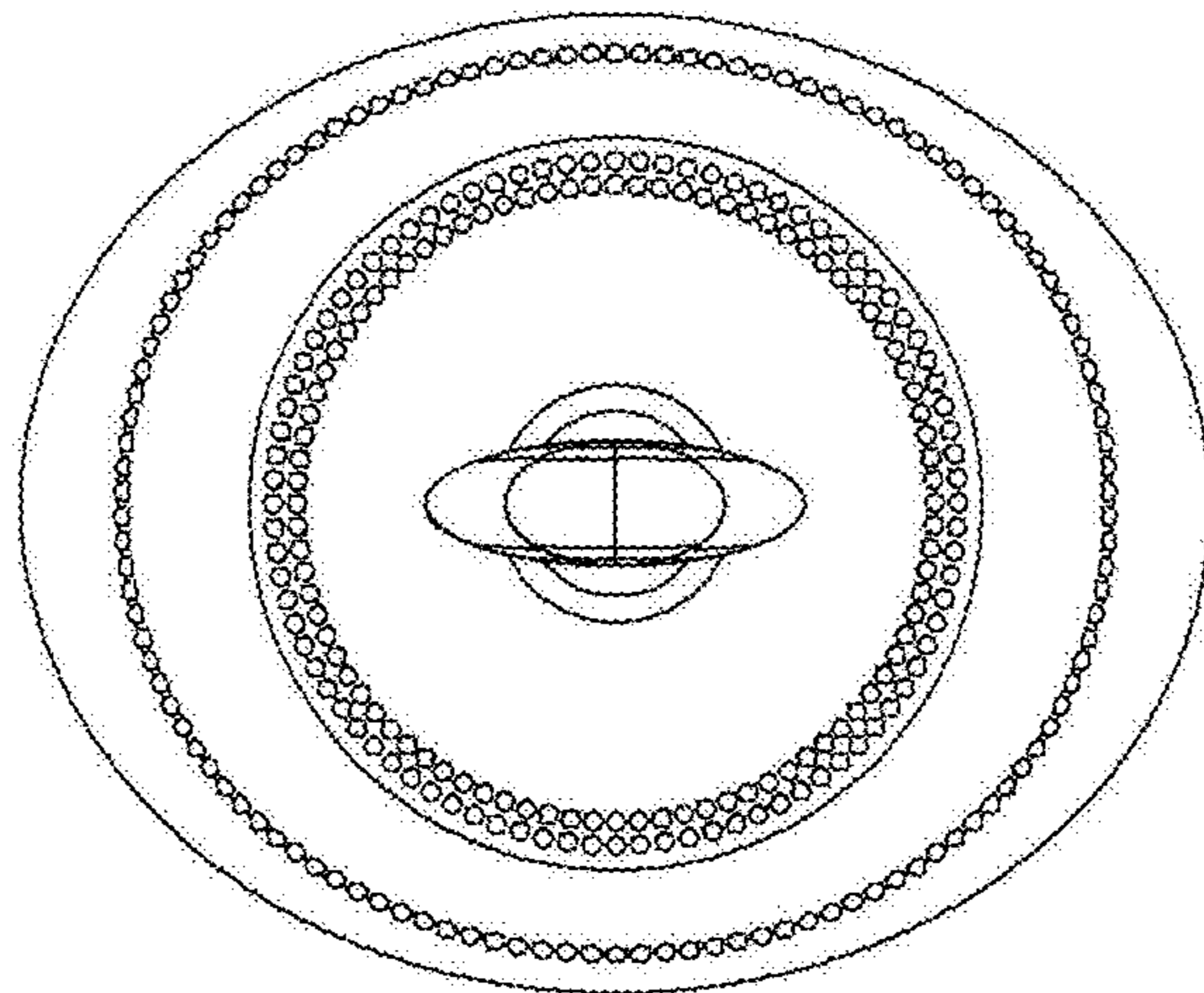
