FIG. 1.3 is a right side view thereof;

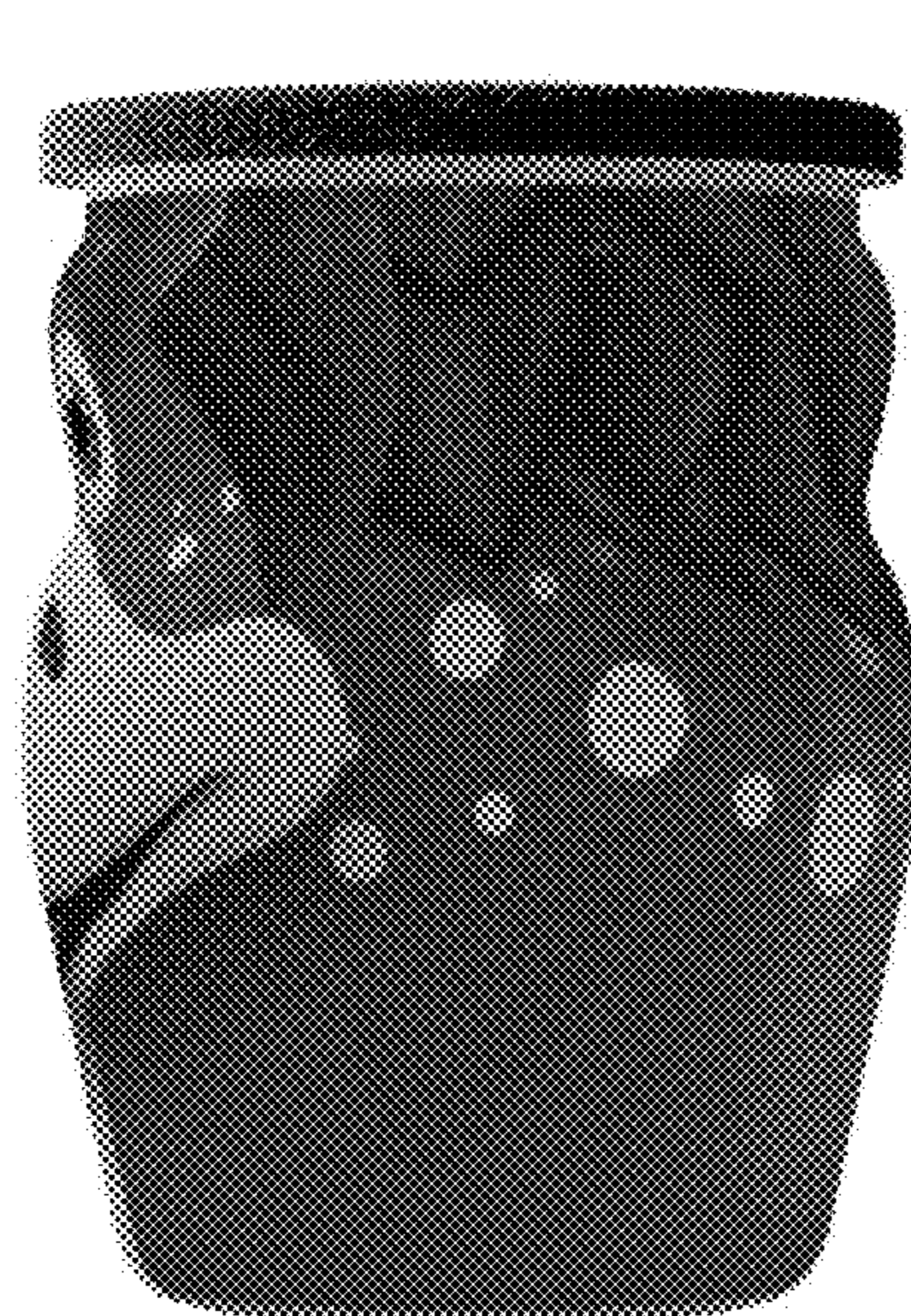
FIG. 1.4 is a rear view thereof;

FIG. 1.7 is a bottom view thereof.

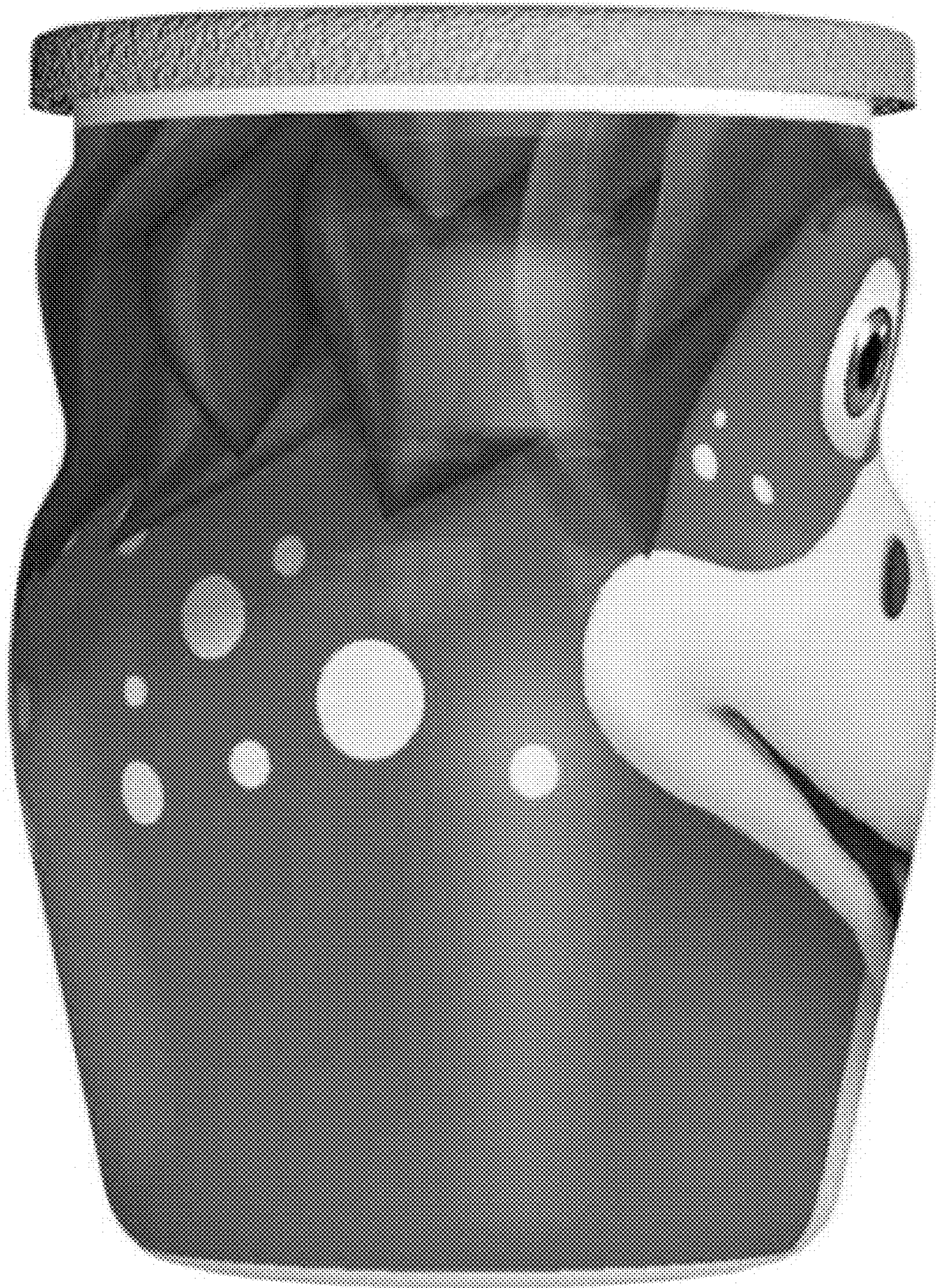

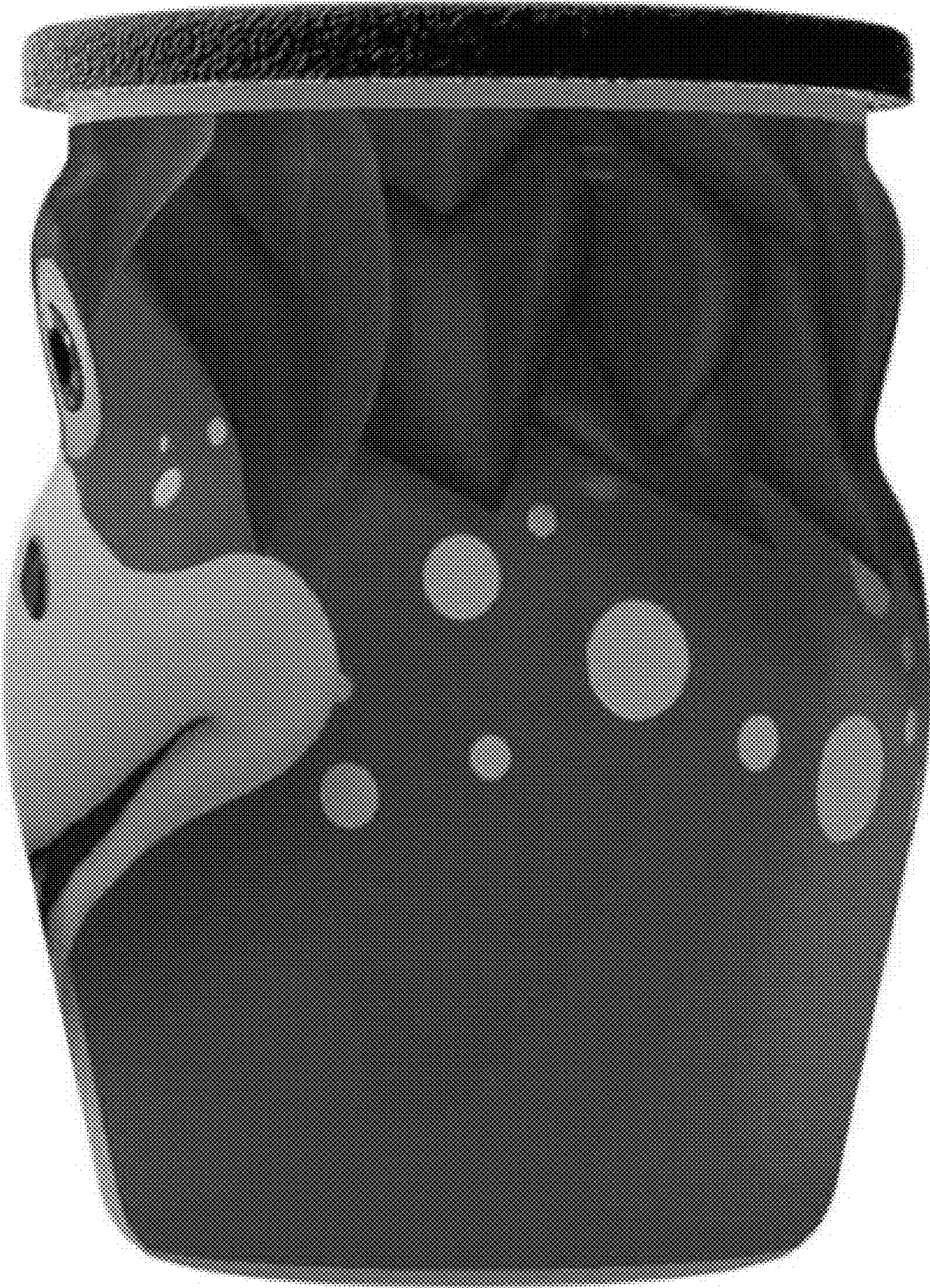
