
(57) **CLAIM**

The ornamental design for a gift card wrap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a gift card wrap having a loop closure;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is an elevation view from the left side thereof rotated by 180 degrees in a clockwise direction;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The stipple shading represents an elasticized fabric material. The broken line showing of the gift card wrap is for the purpose of illustrating portions of the gift card wrap and forms no part of the claimed design.




