(57) **CLAIM**

The ornamental design for a tyre, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side perspective view of a tyre showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side view thereof, the right side view being the mirror image thereof;

FIG. 4 is a partial front elevational view taken from FIG. 2 and shown in an enlarged scale;

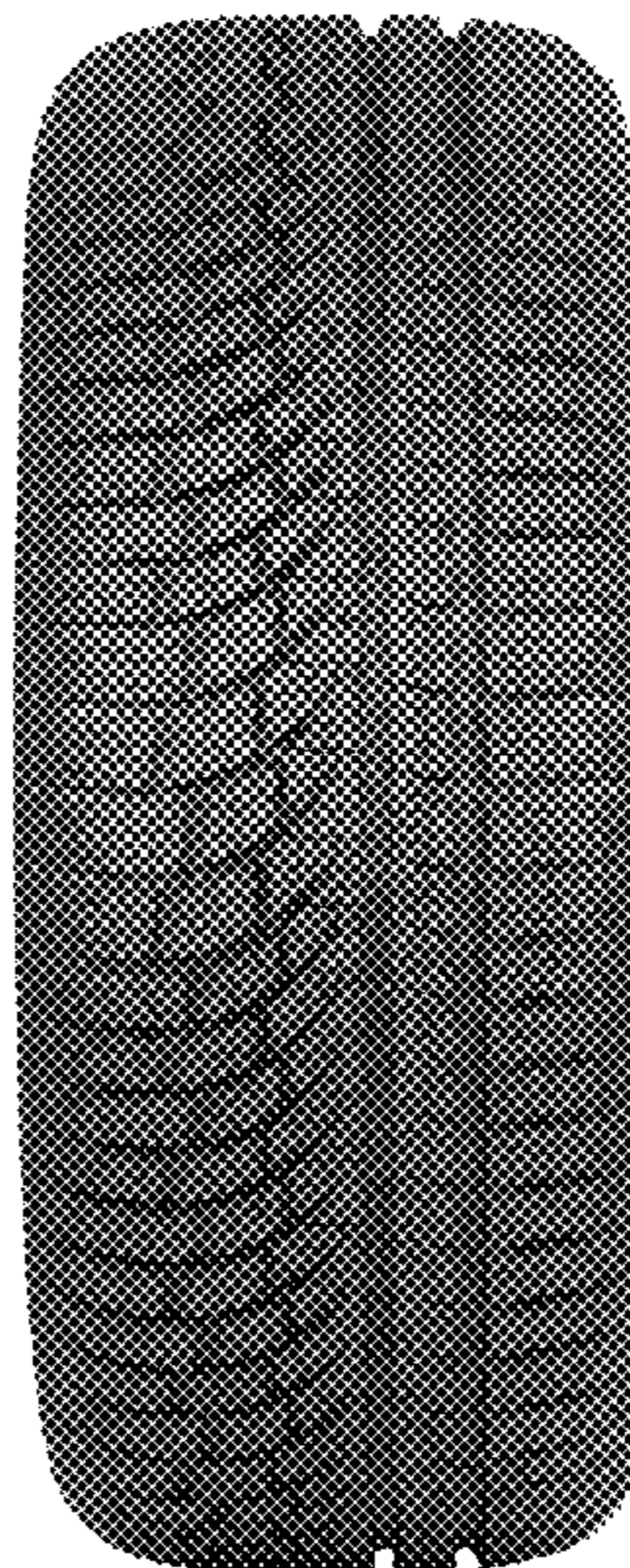
FIG. 5 is an enlarged fragmentary front view showing a central circumferential tread band;

FIG. 6 is an enlarged fragmentary front view showing a right lateral edge cleat with adjacent cleat elements disposed laterally inboard;

FIG. 7 is an enlarged fragmentary front view showing an individual cleat located on the left lateral edge of the tread; and,

FIG. 8 is an enlarged fragmentary front view showing a channel that is disposed between radially adjacent cleats located on the left lateral edge of the tread.

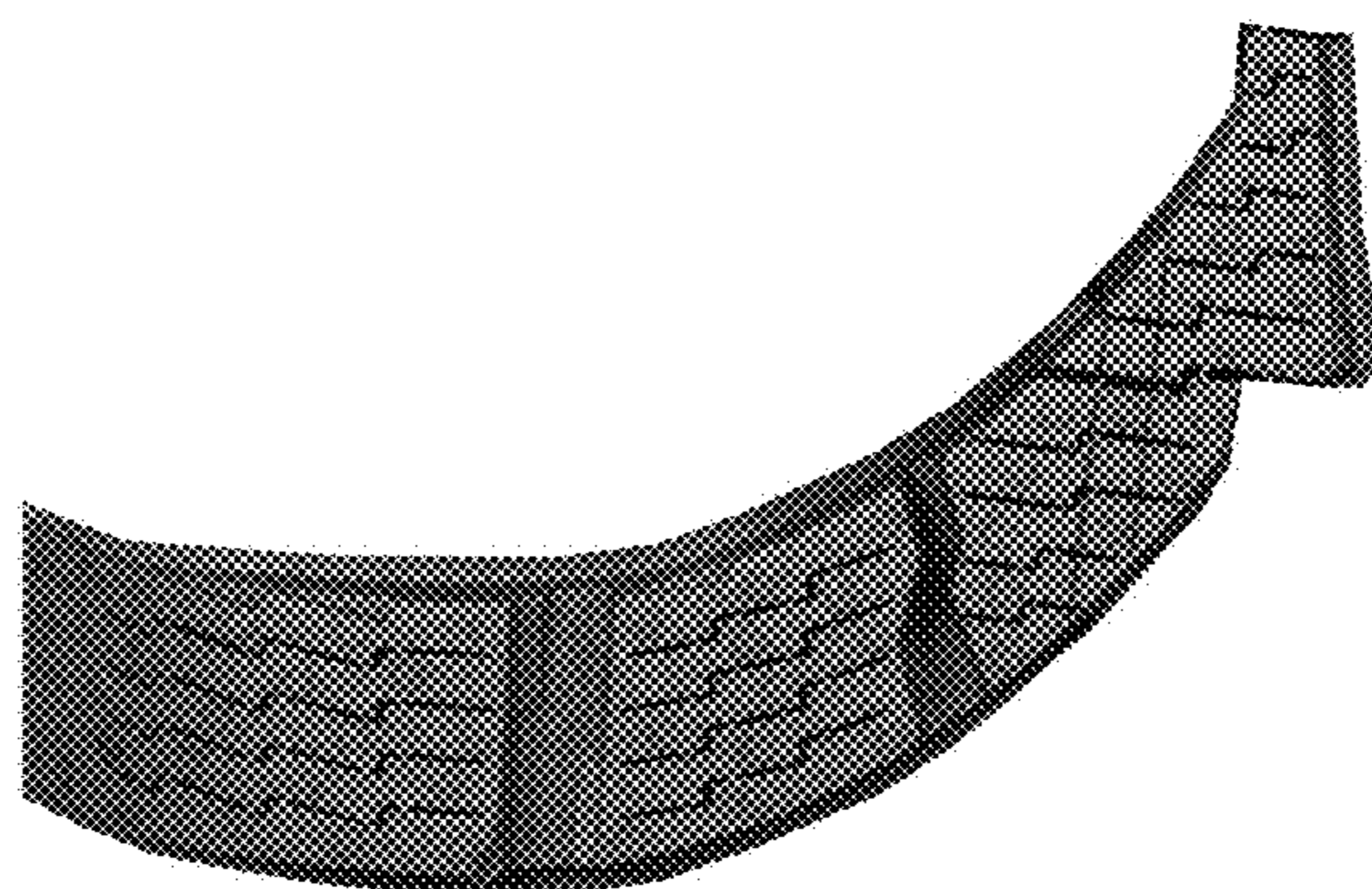

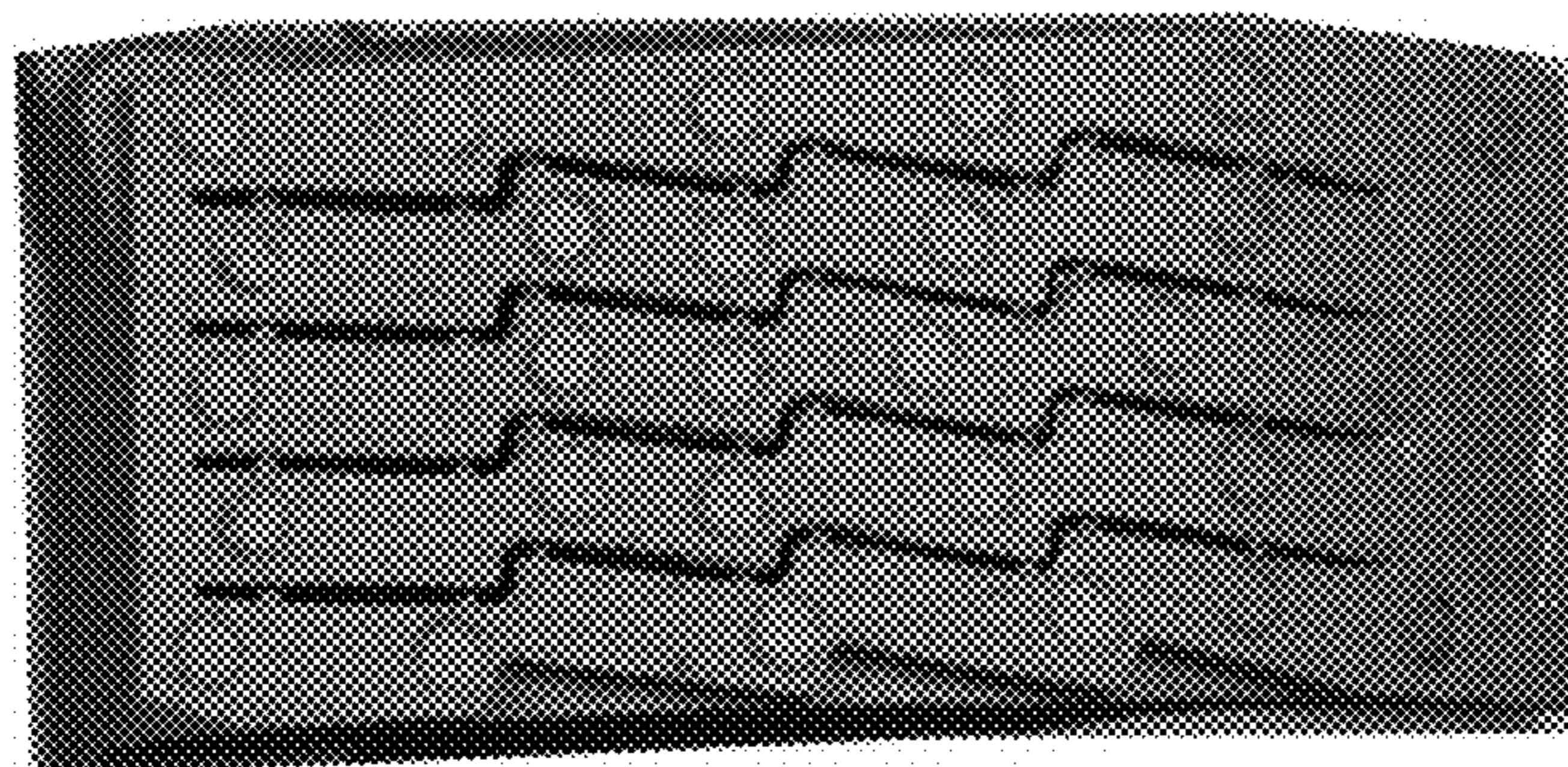
