FIG. 8 is a bottom view thereof.

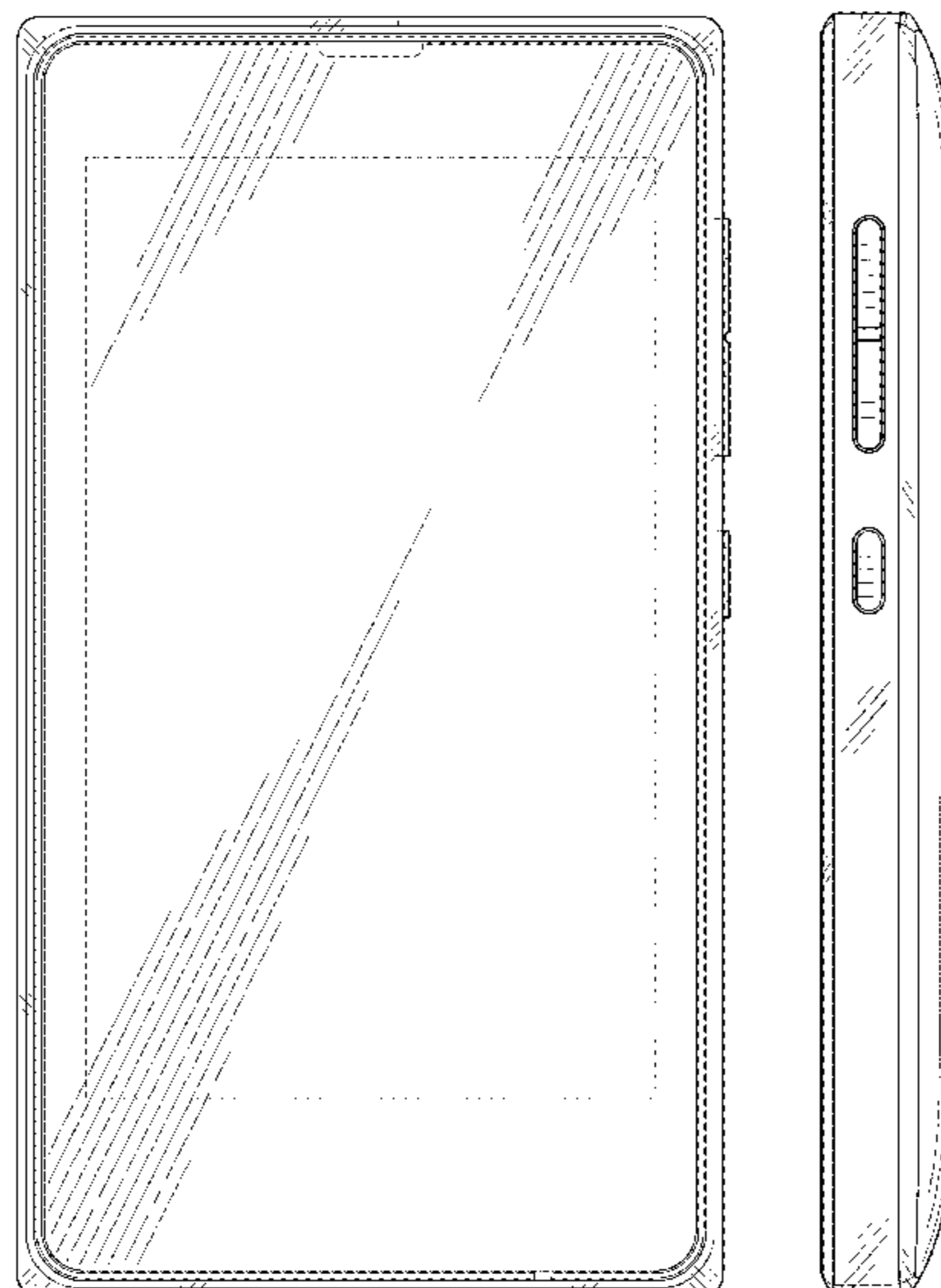

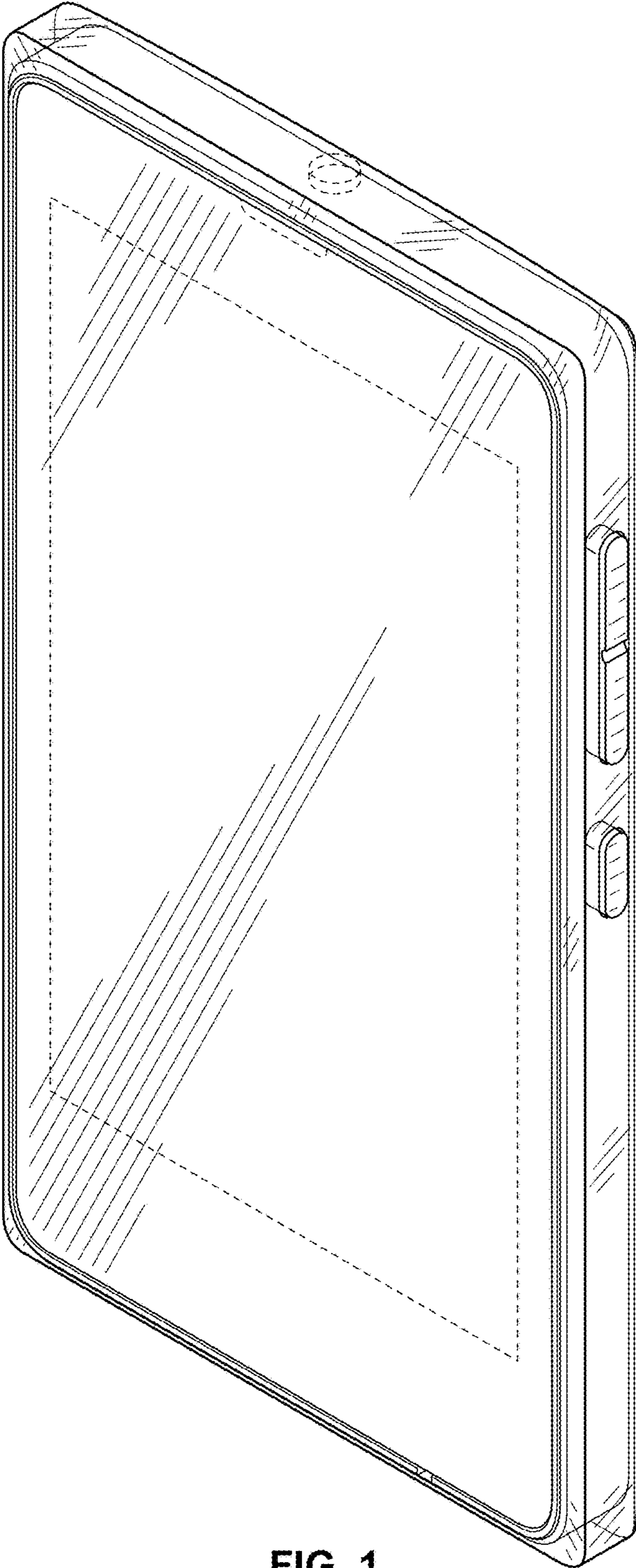

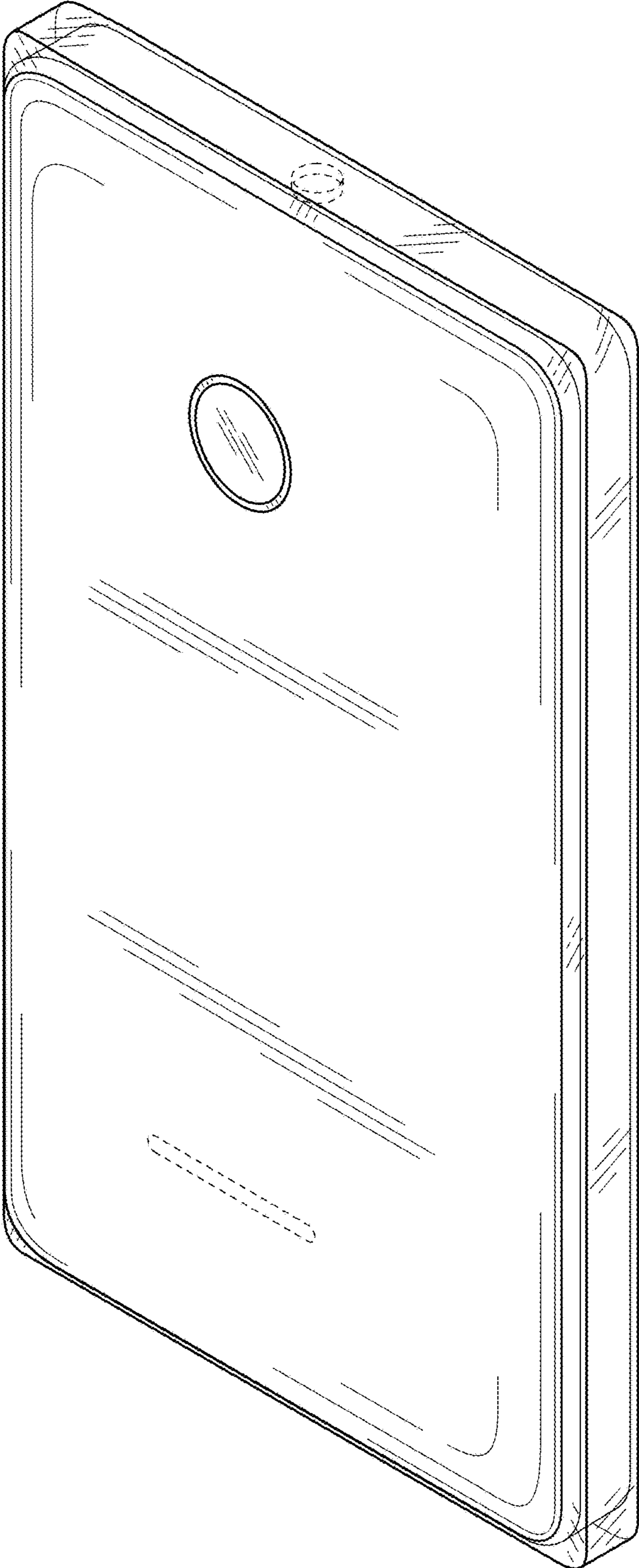

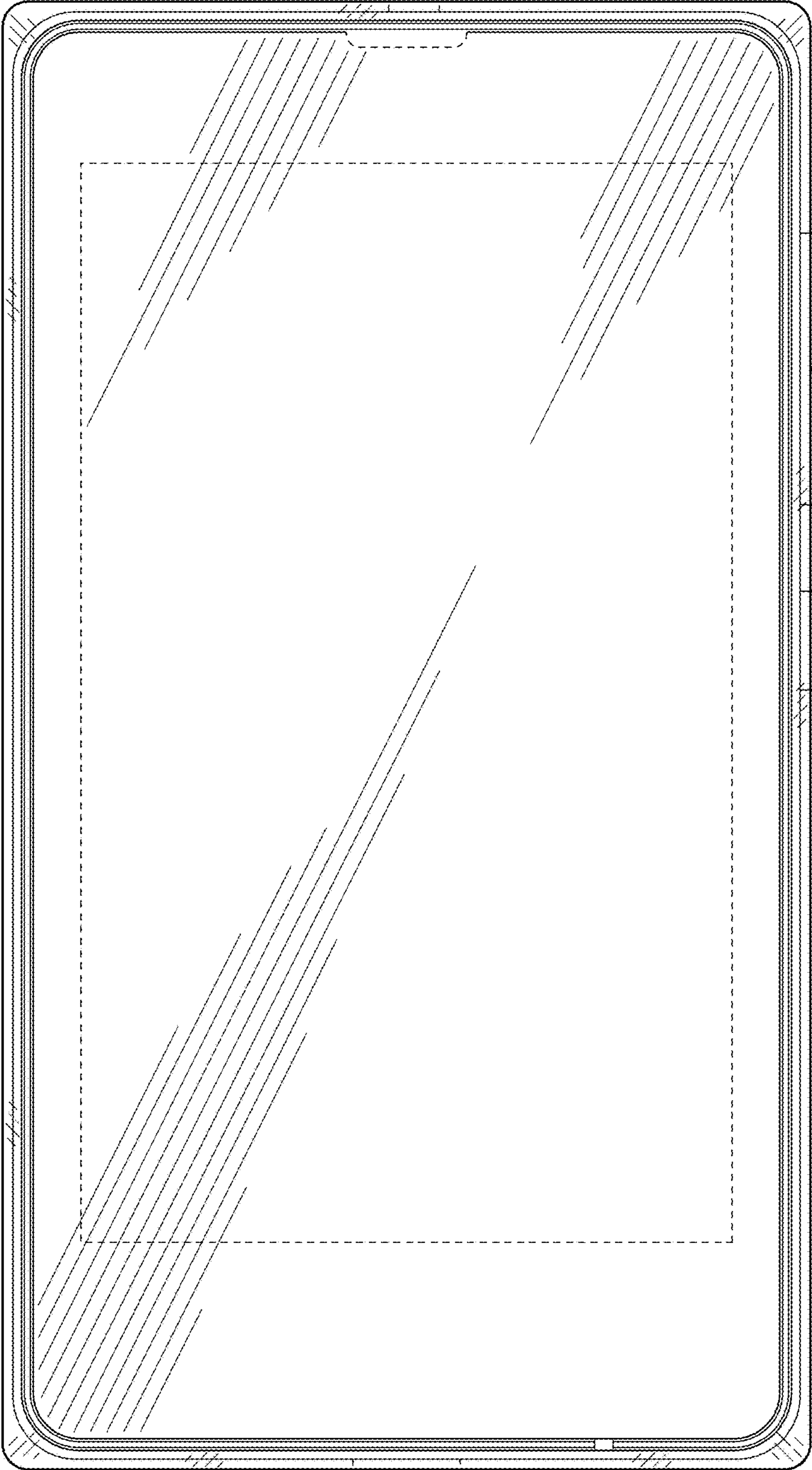

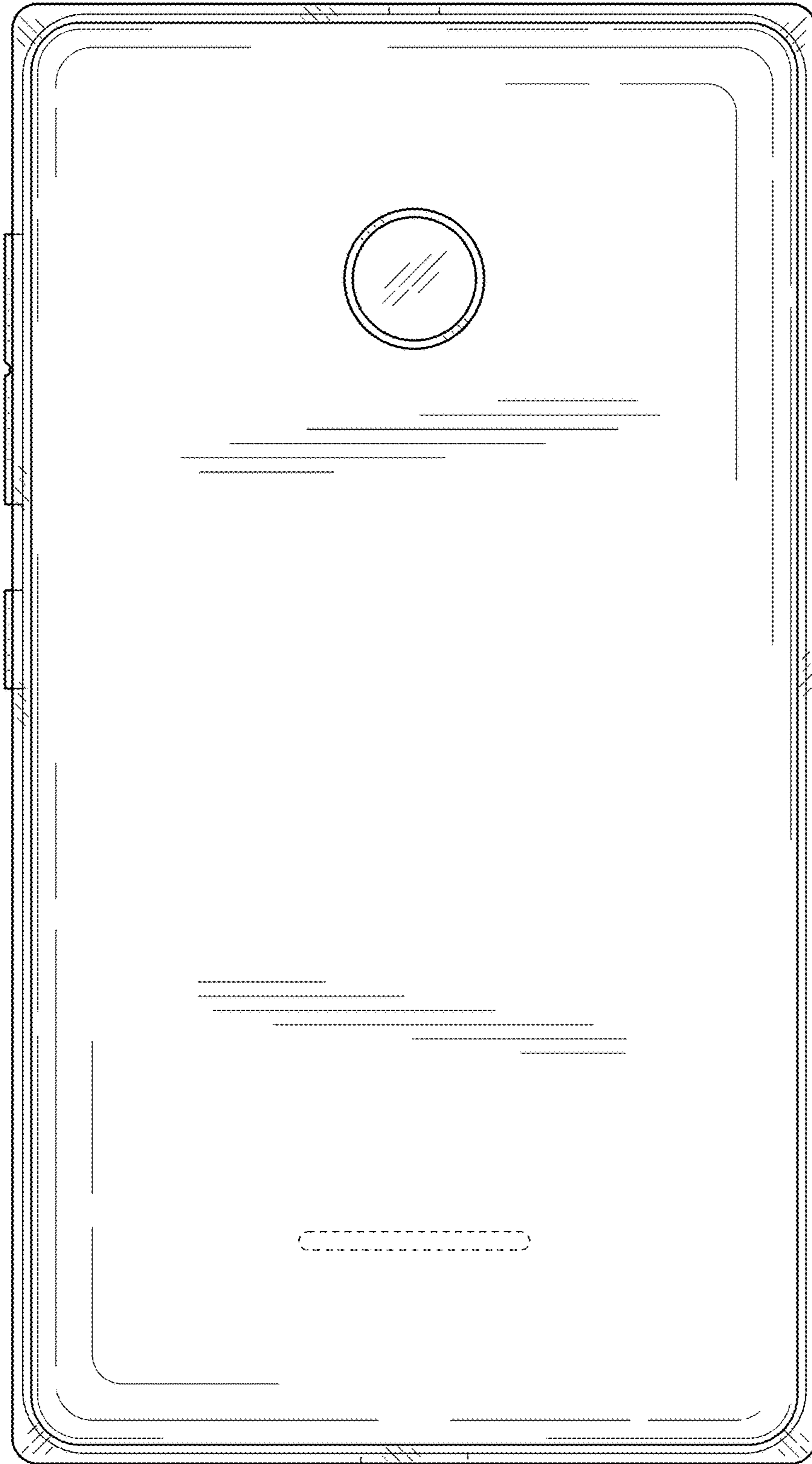

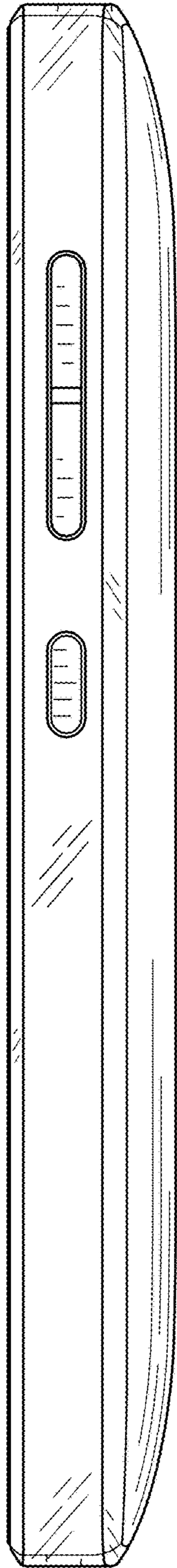

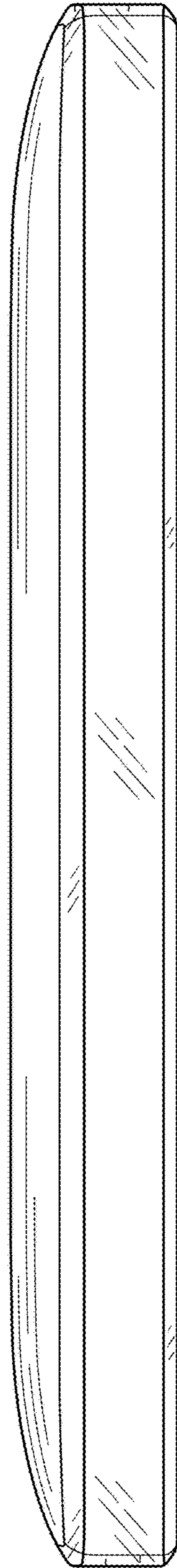

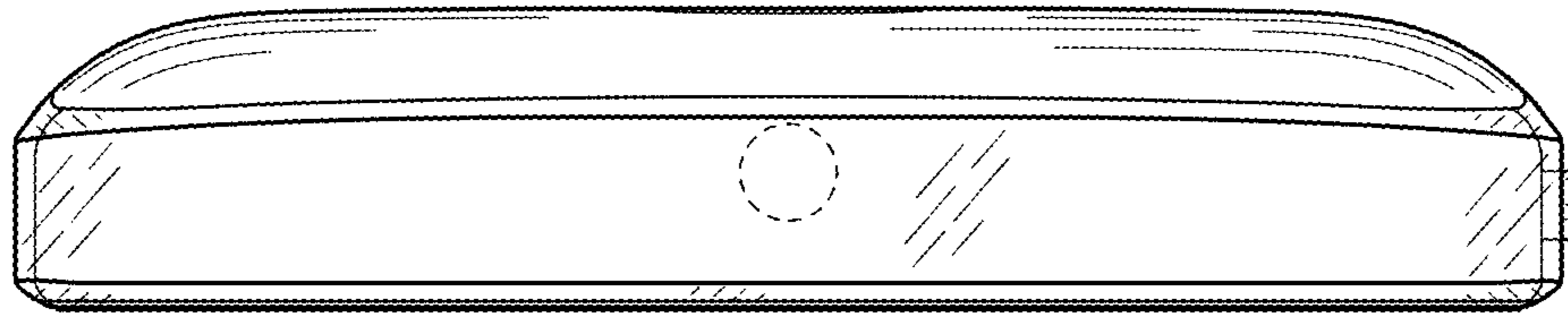

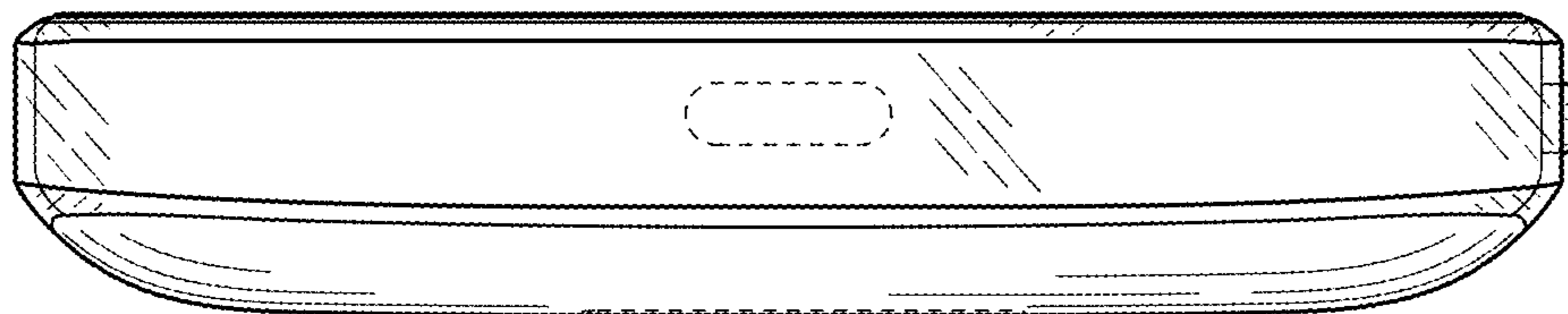
