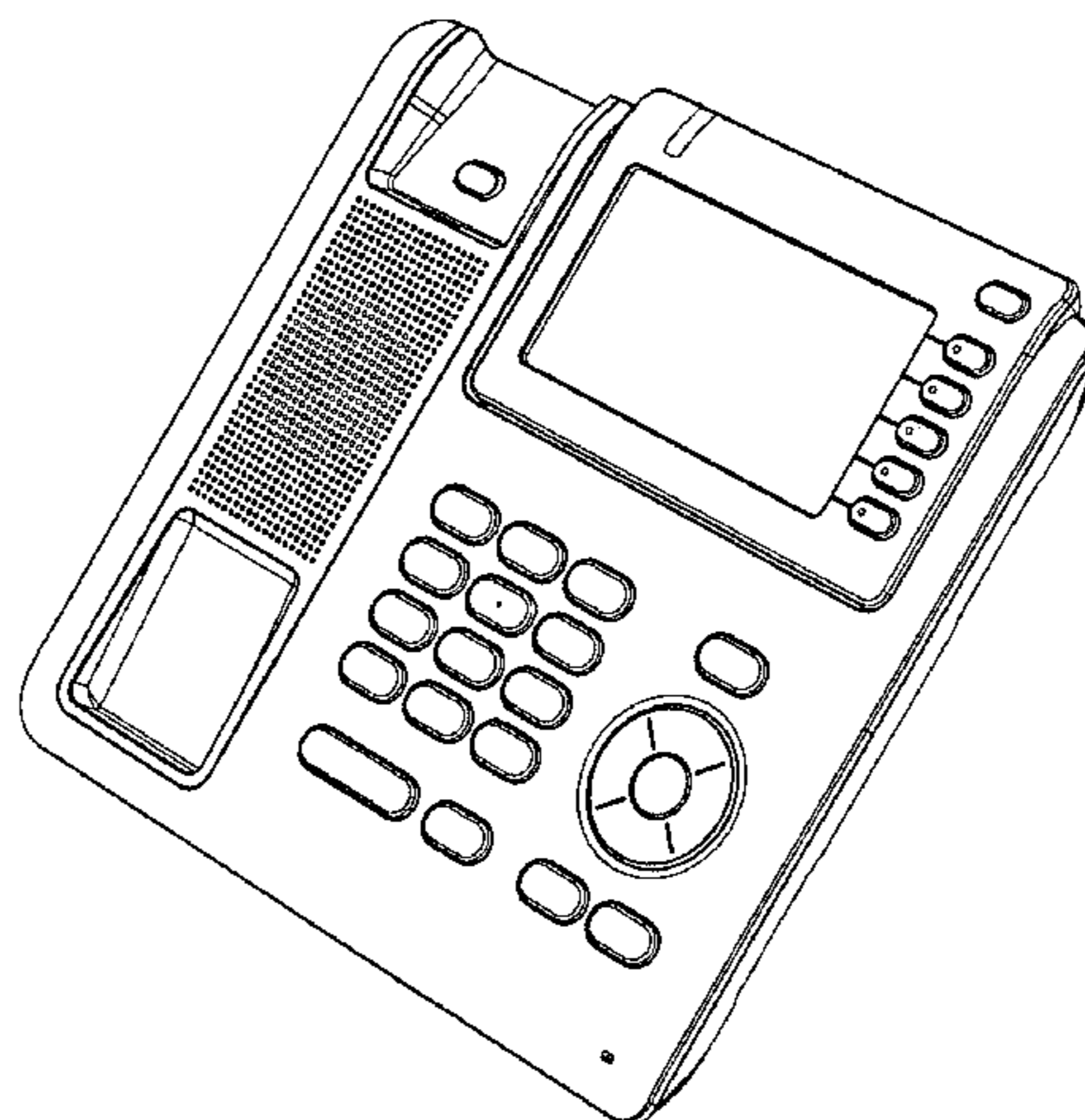
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of our telephone;  
FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof; and,

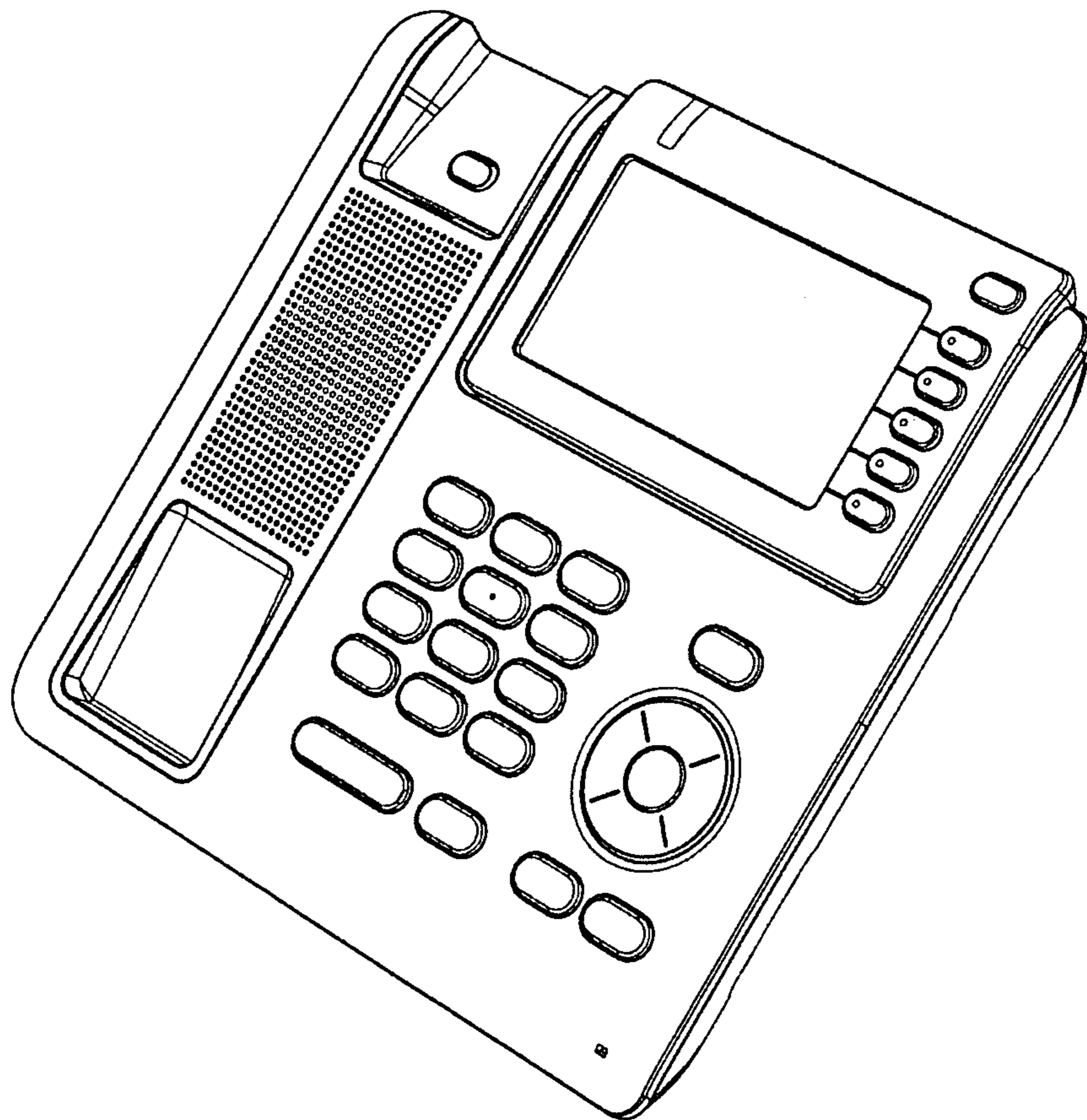

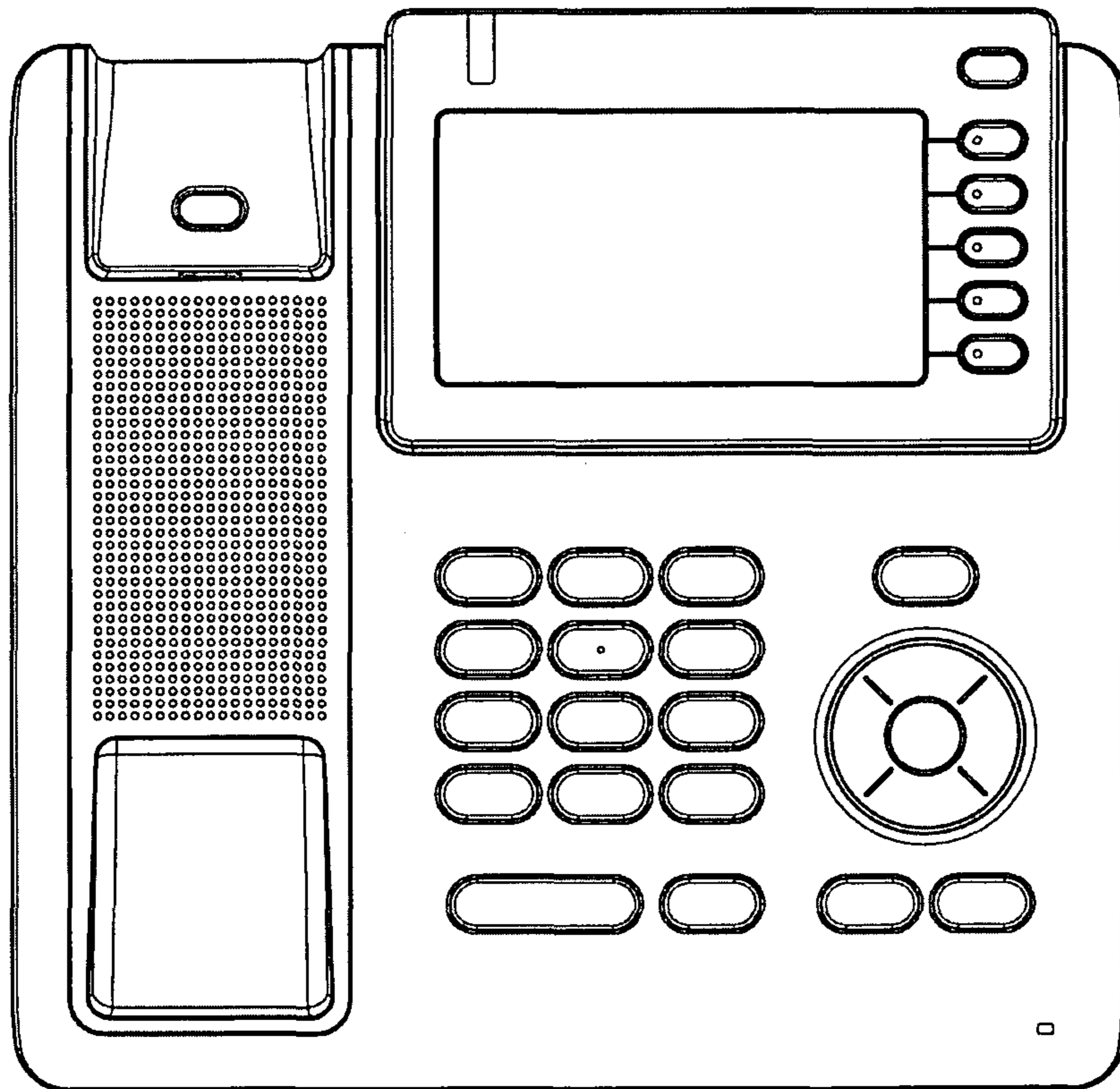
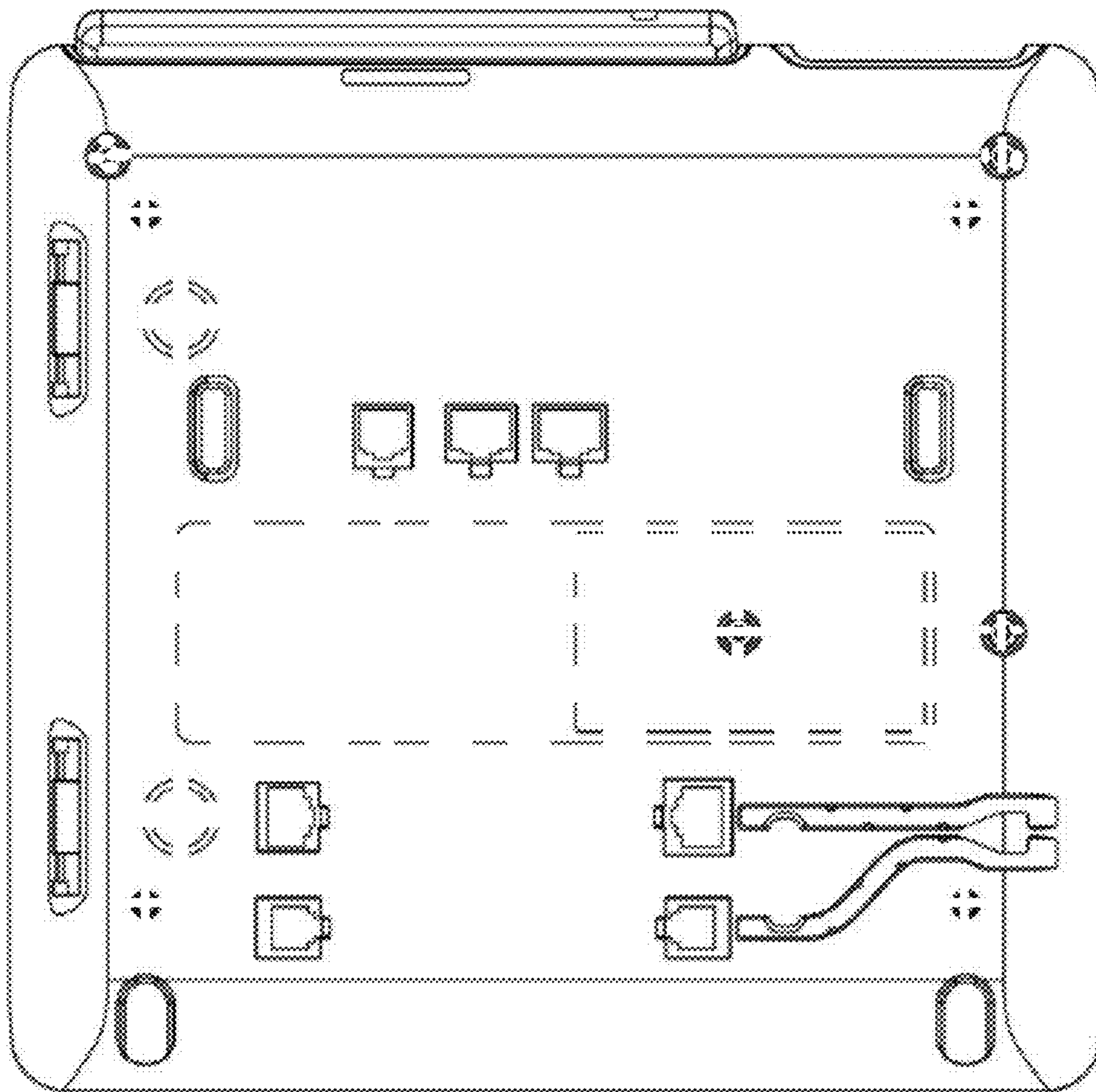
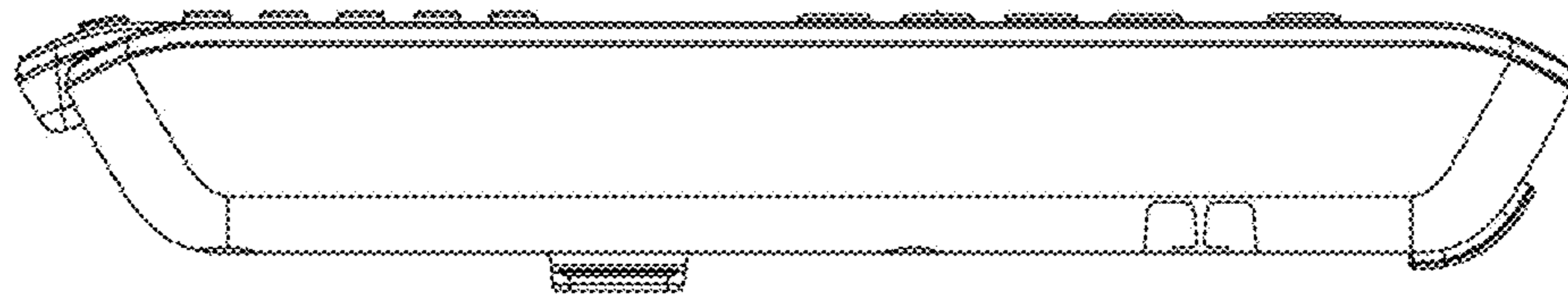

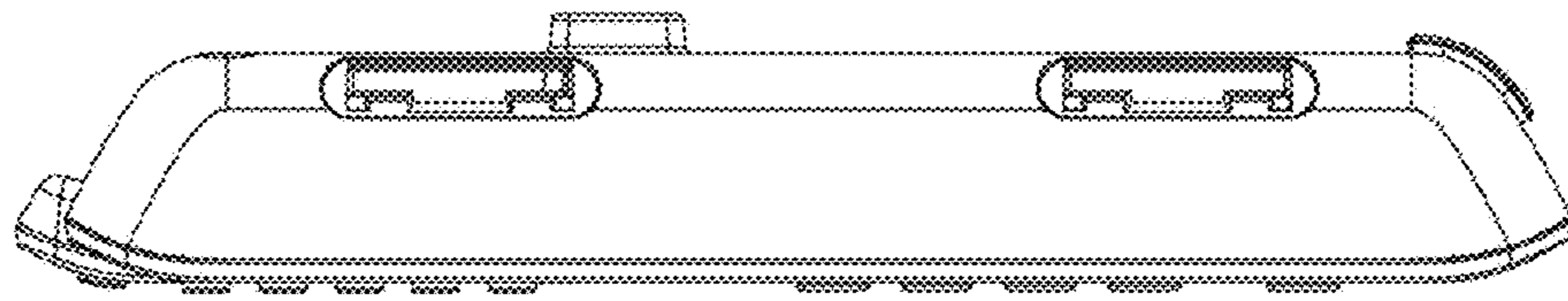
INTEGRATED PHONE | PHONE | LEFT VIEW

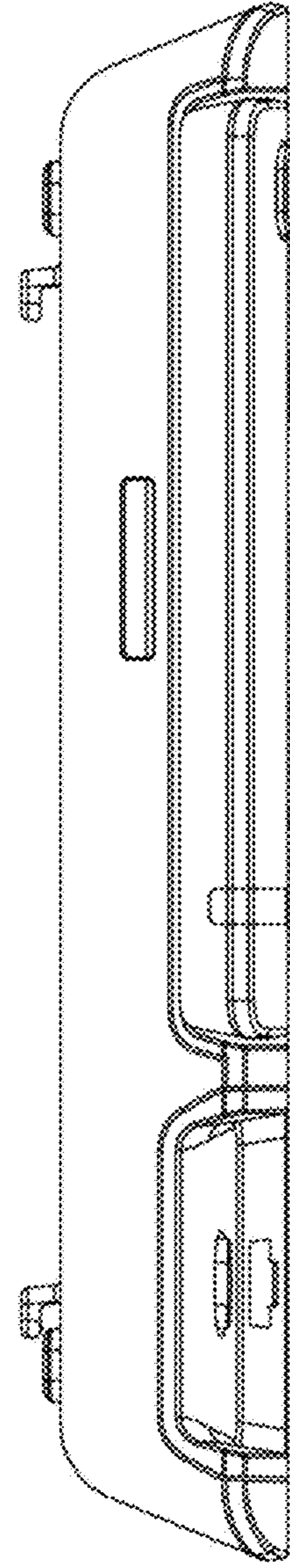
INTEGRATED PHONE | PHONE | RIGHT VIEW
