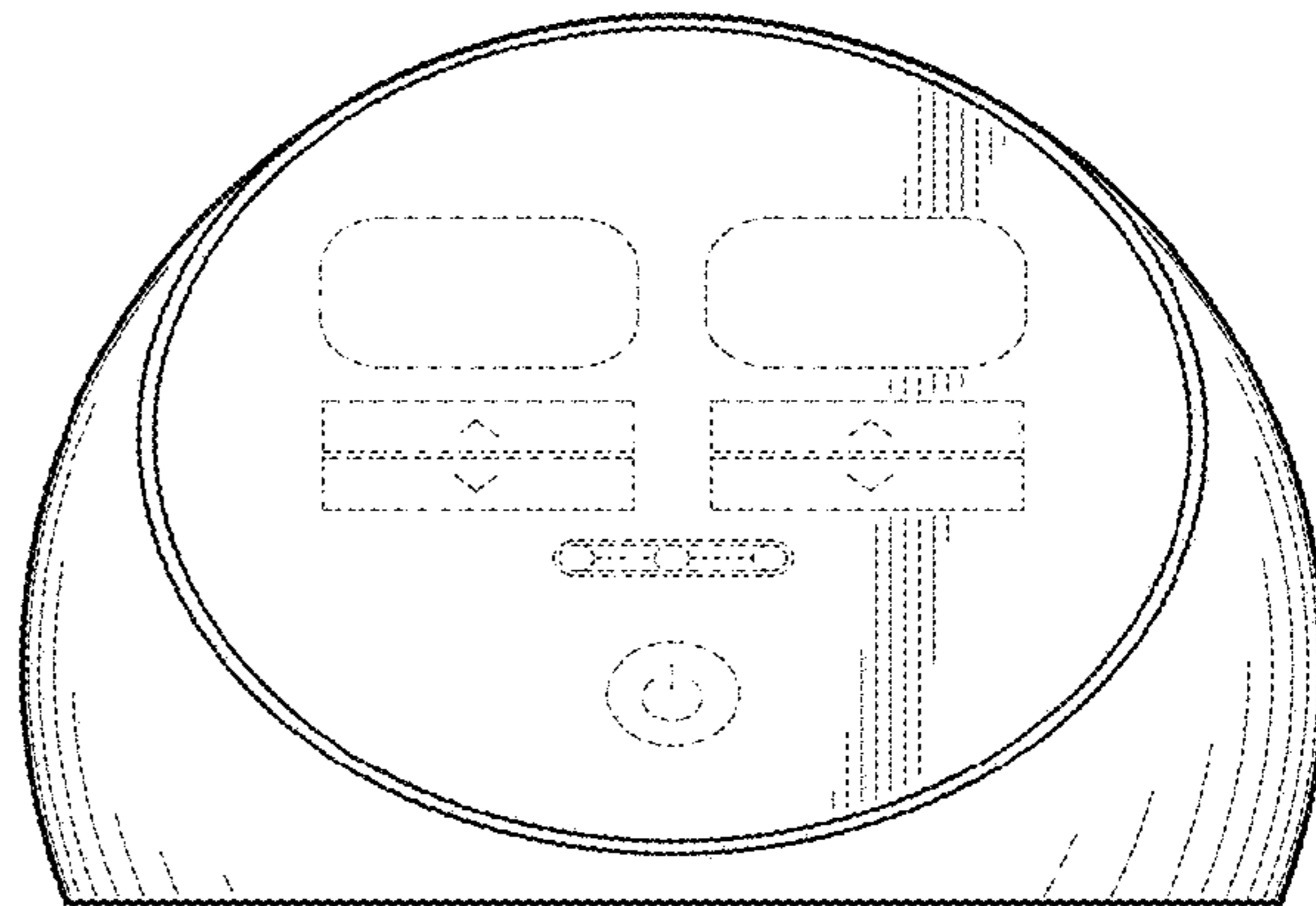
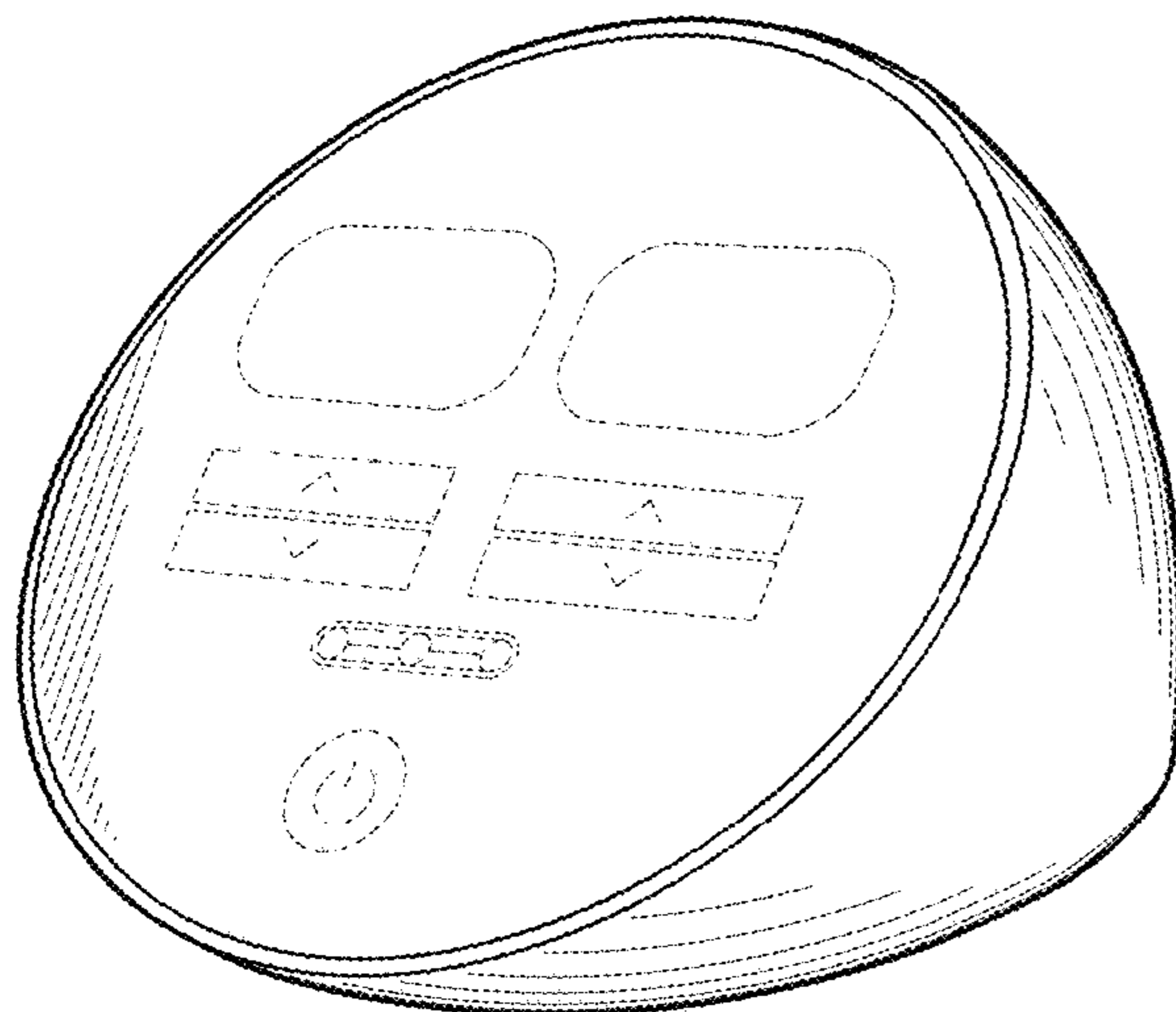
(57) **CLAIM**

The ornamental design for a sauna control unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sauna control unit, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof; the left side elevation view being a mirror image thereof;

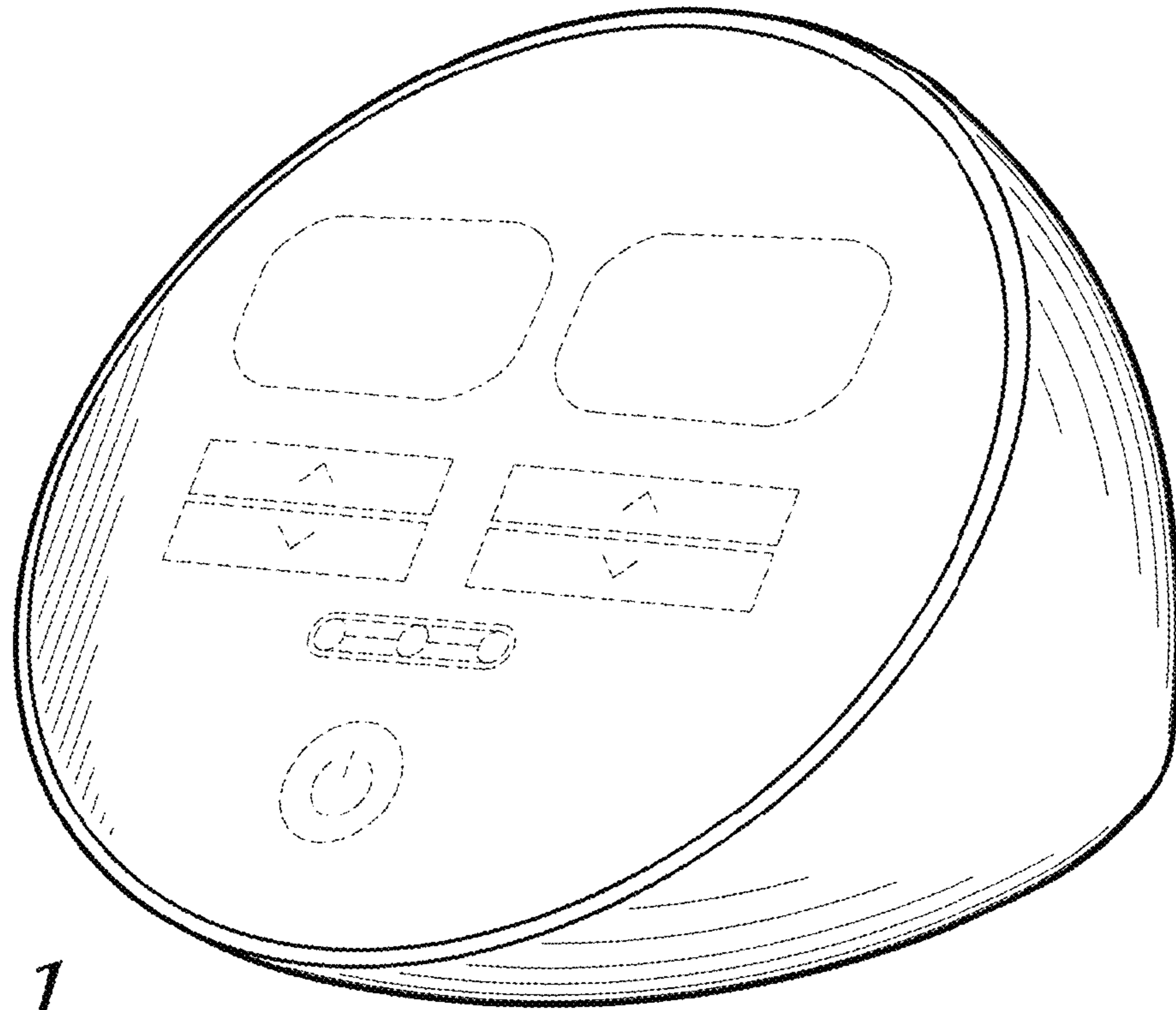

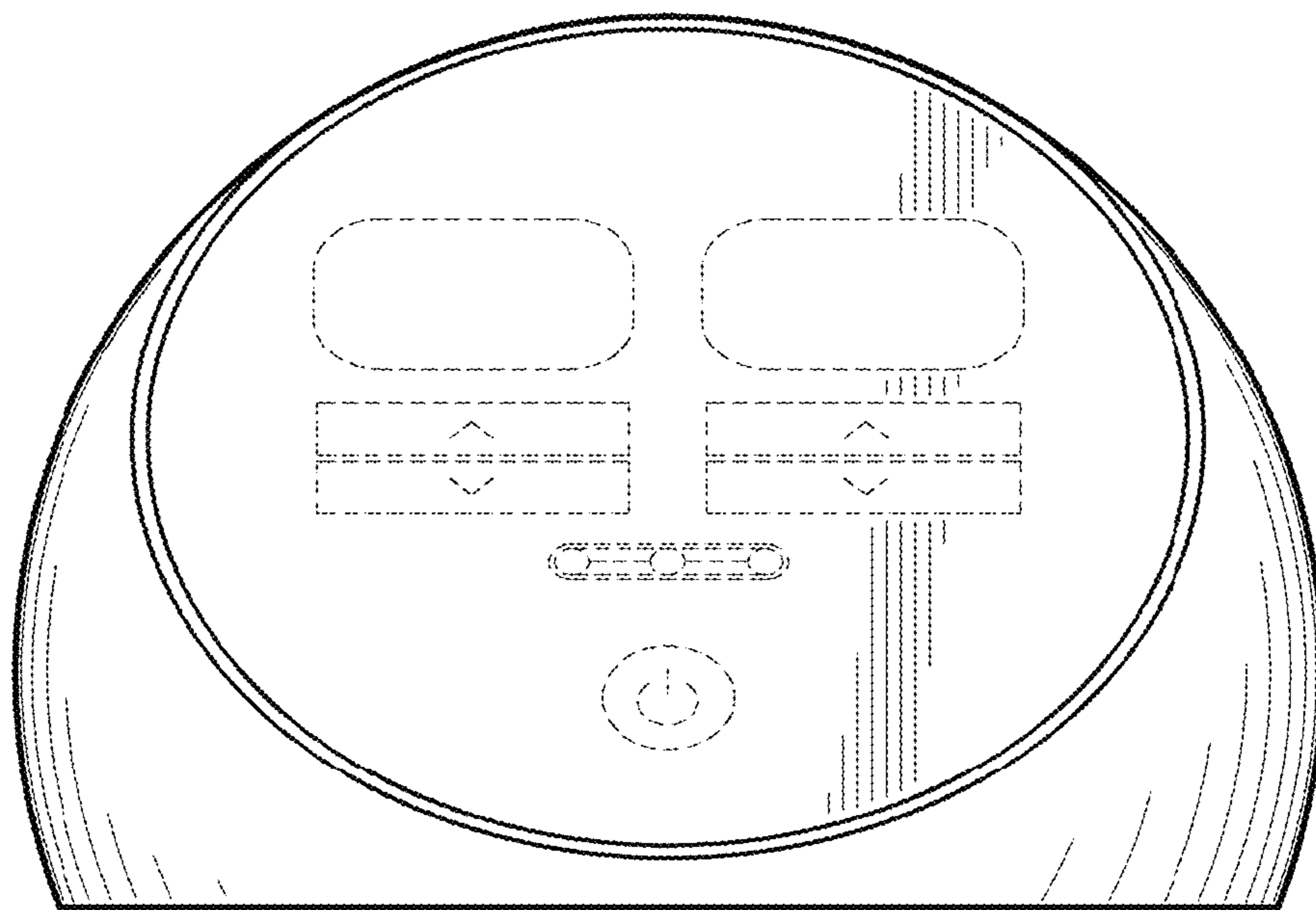

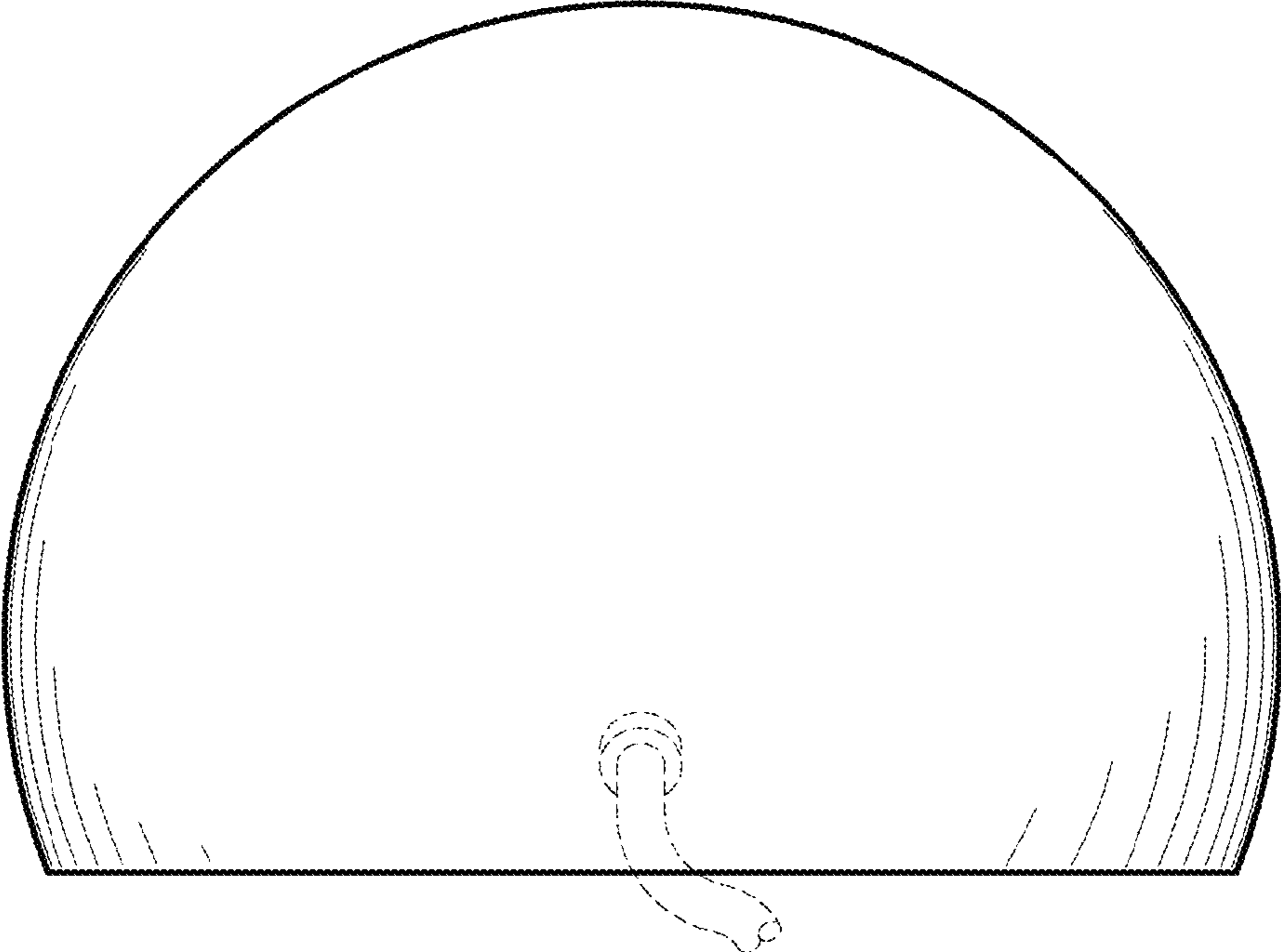

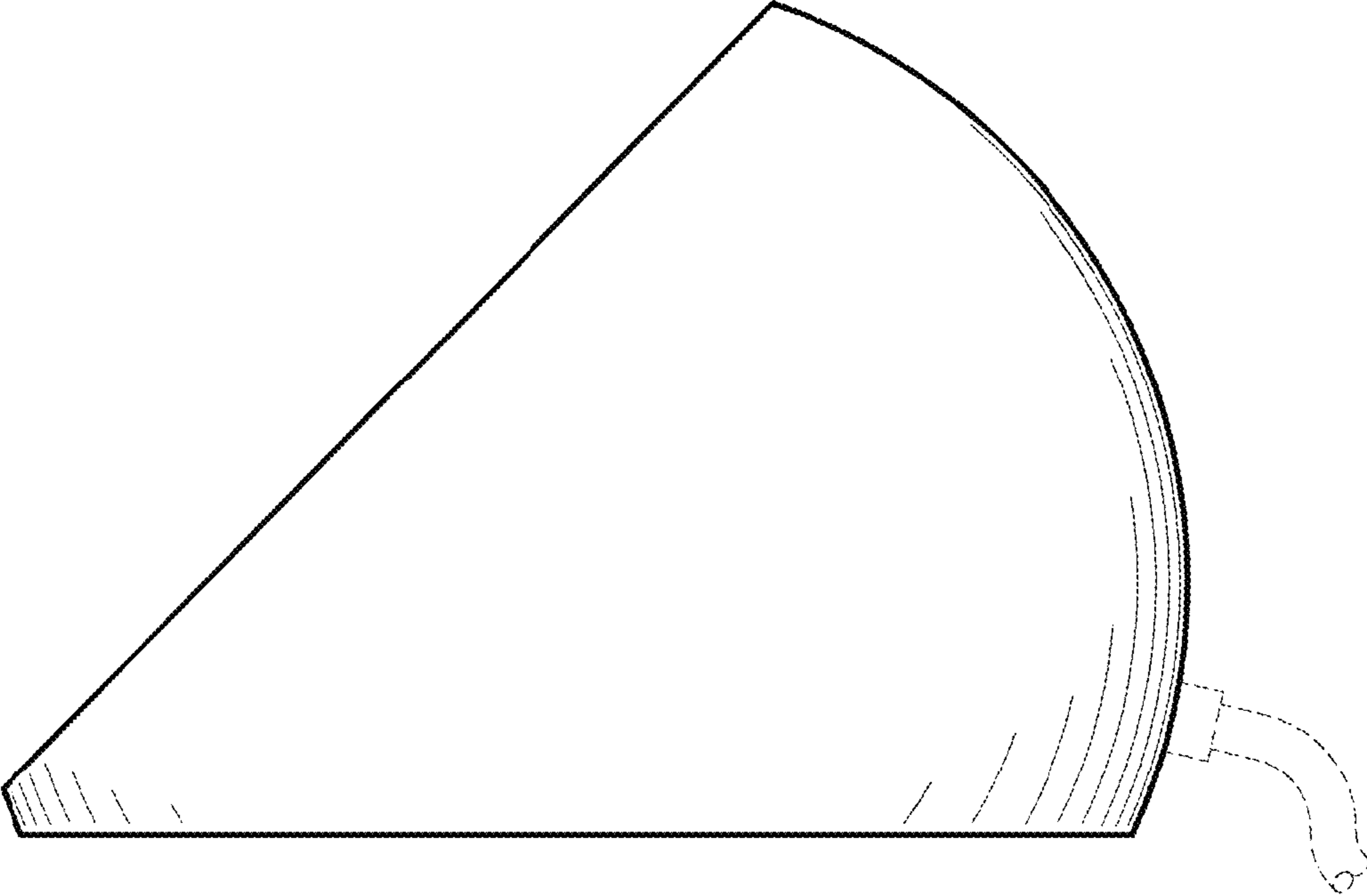

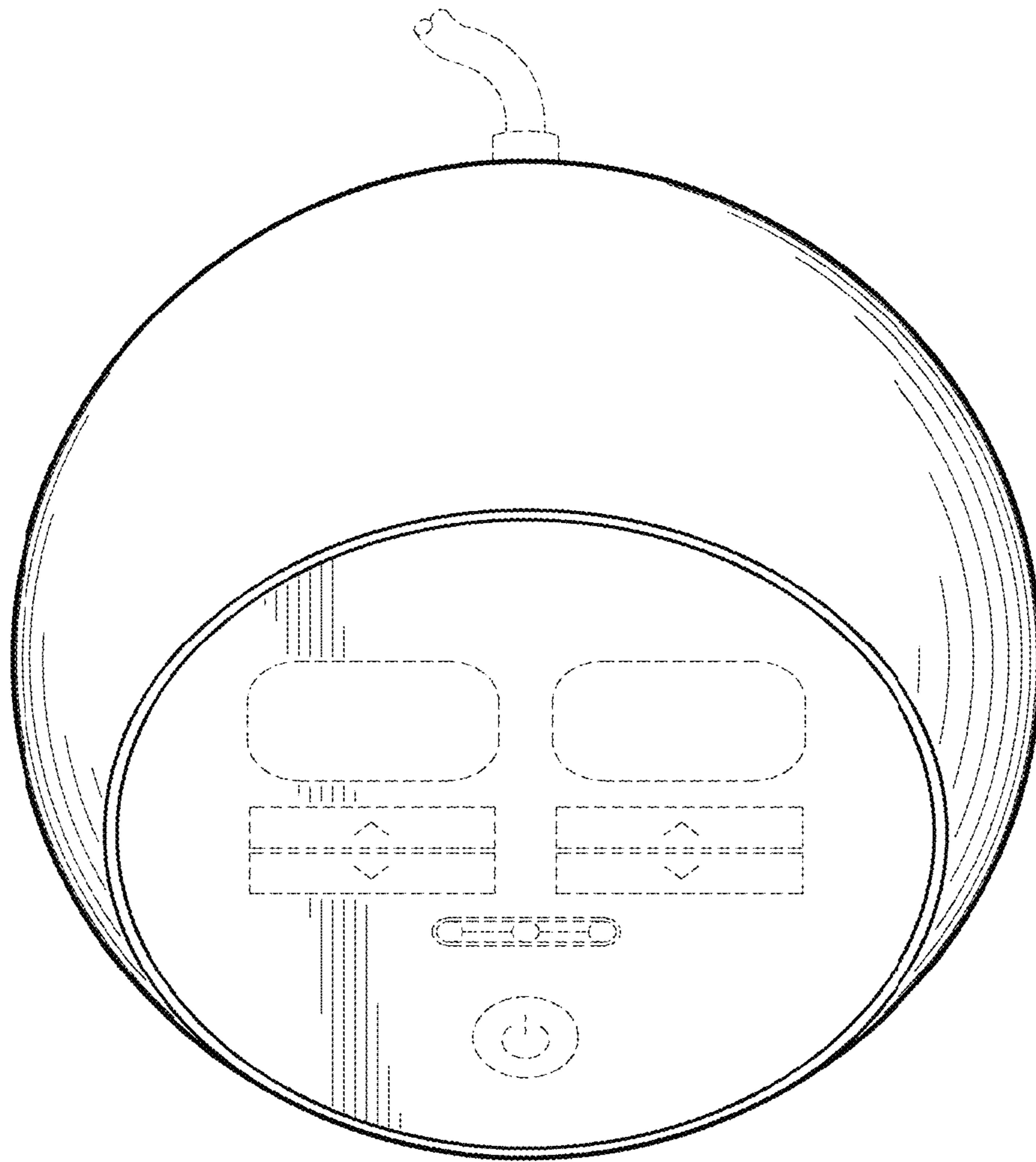

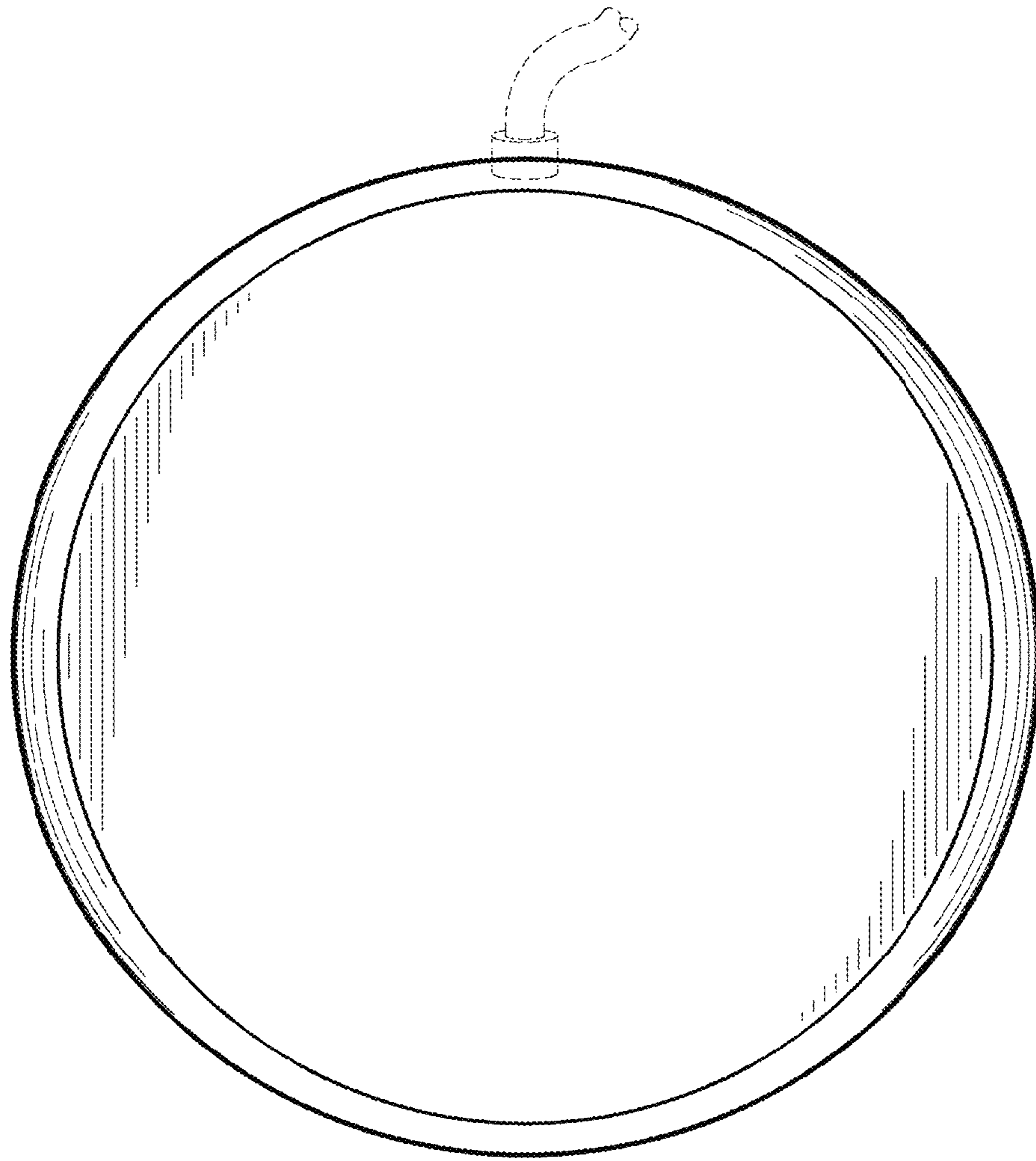
