The ornamental design for a display screen with graphical user interface including a sustainability dashboard for an enterprise, as shown and described.

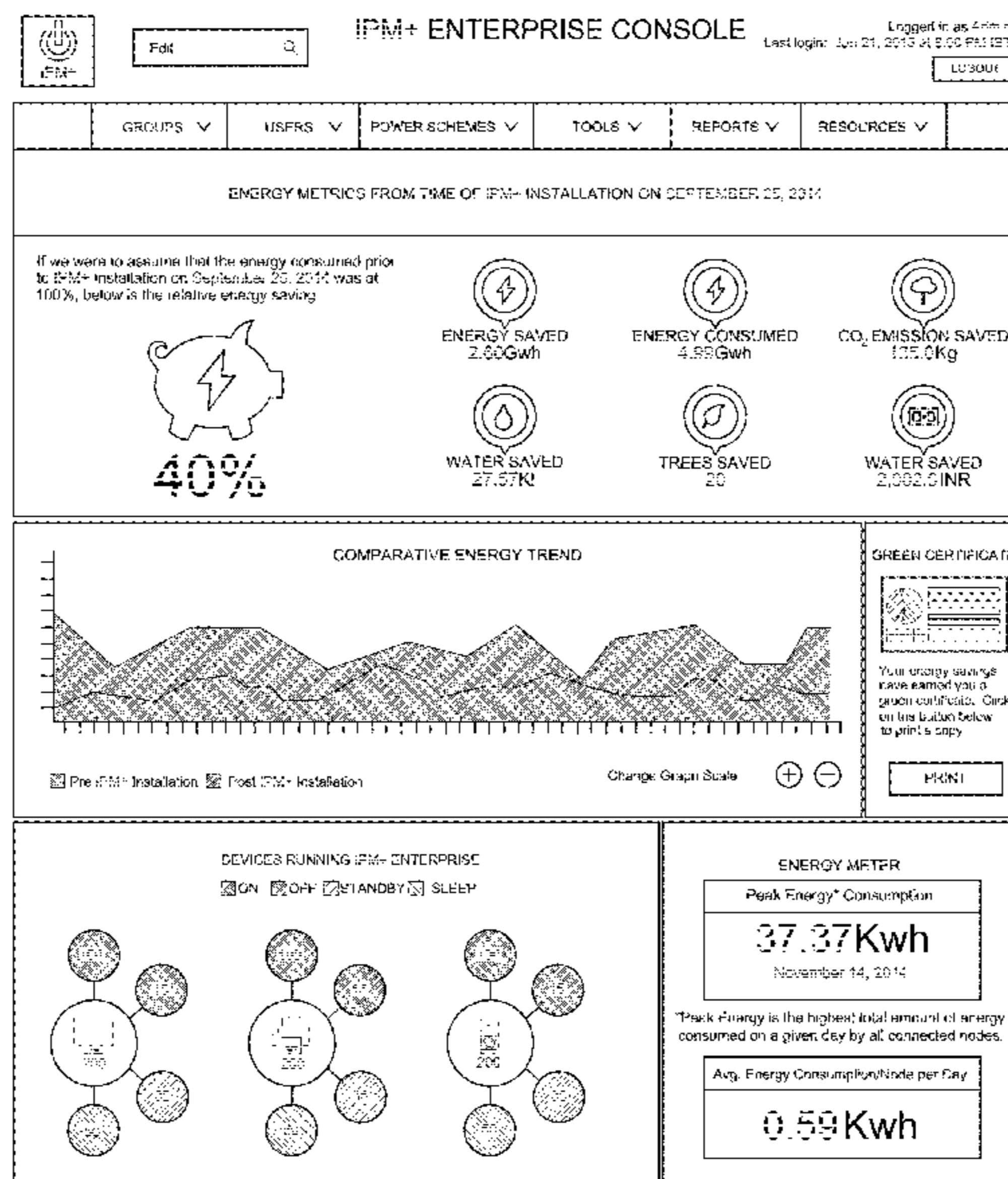
DESCRIPTION

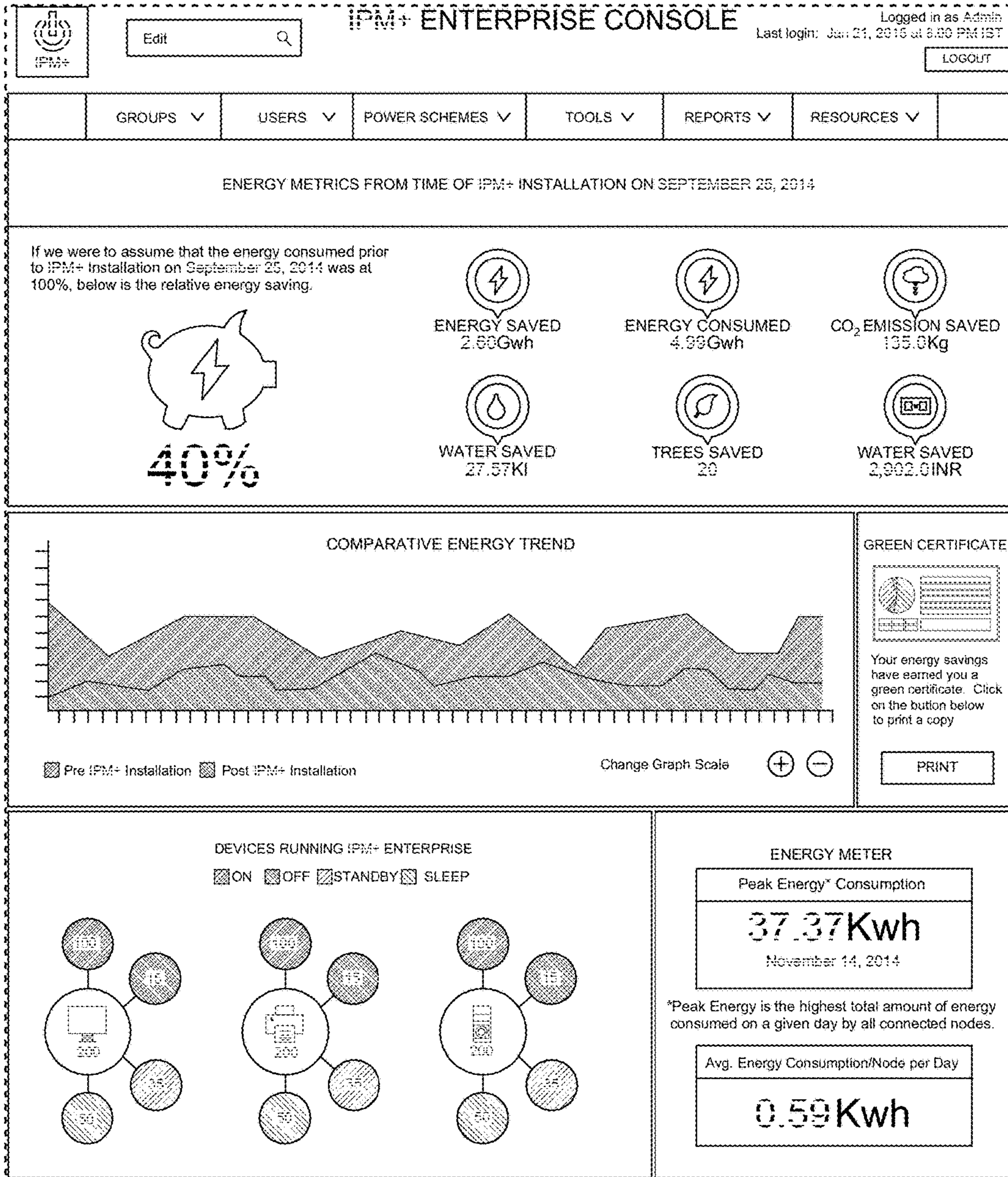
