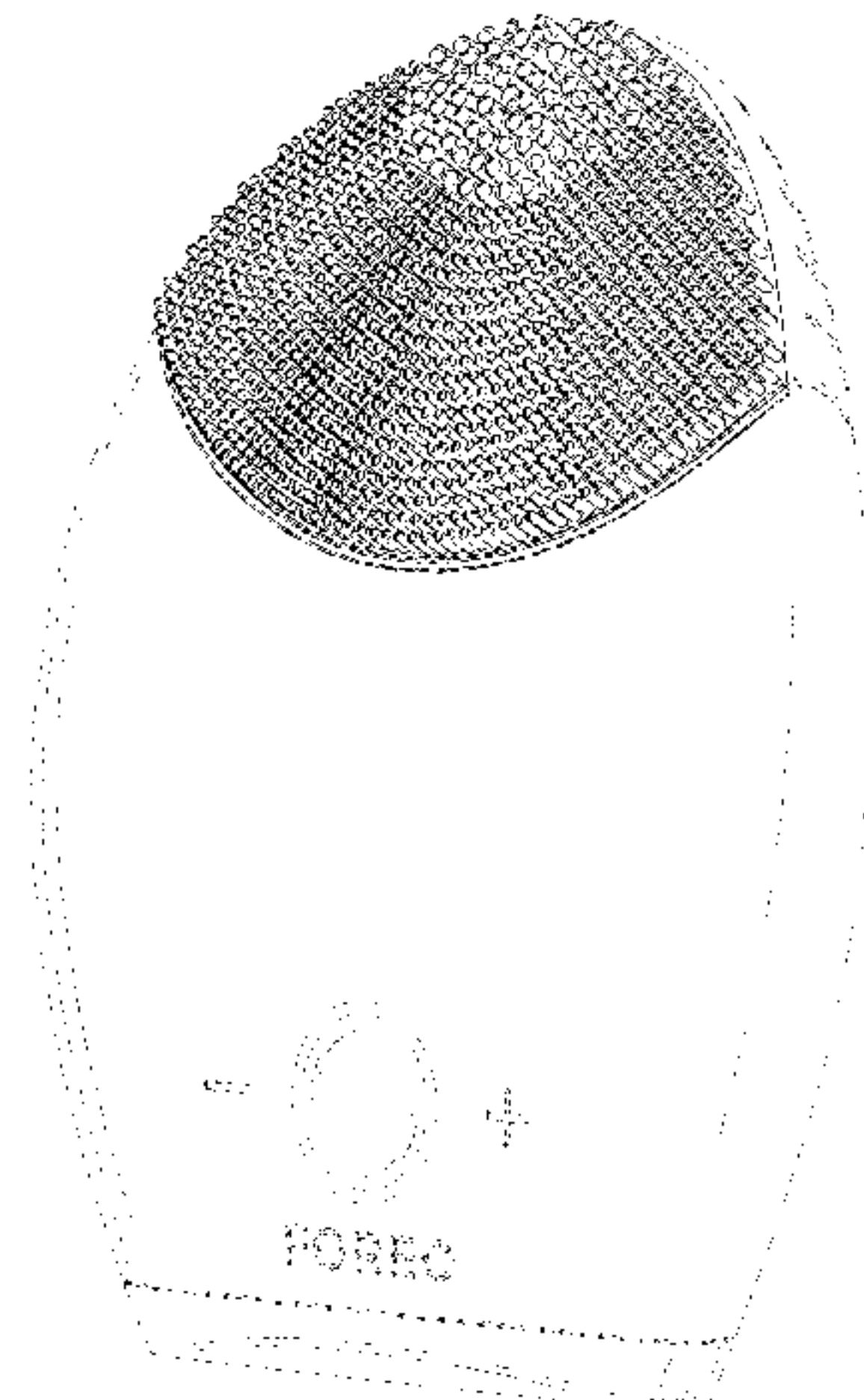


FIG. 26 is a right side view of the fourth embodiment of the skin cleanser.

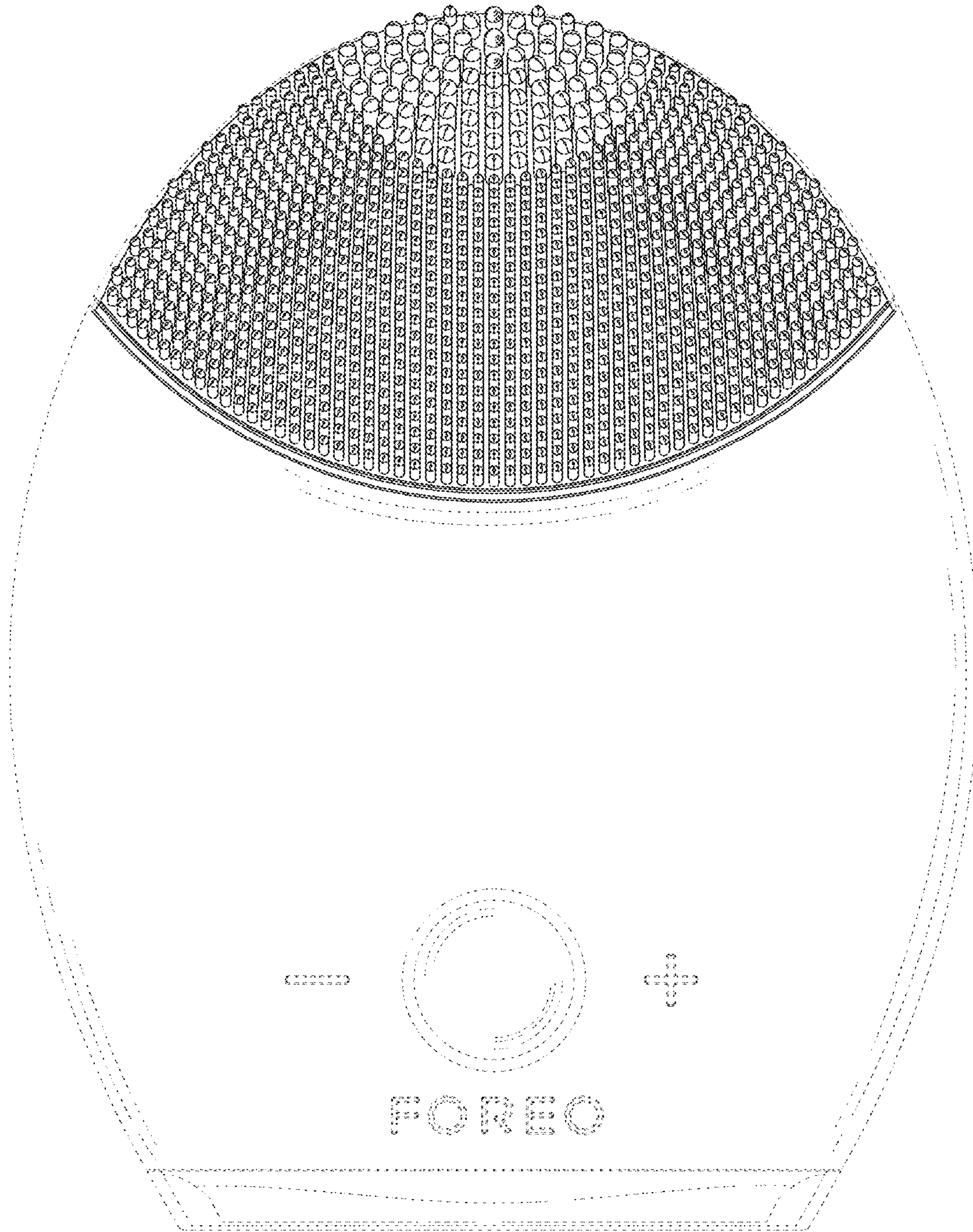

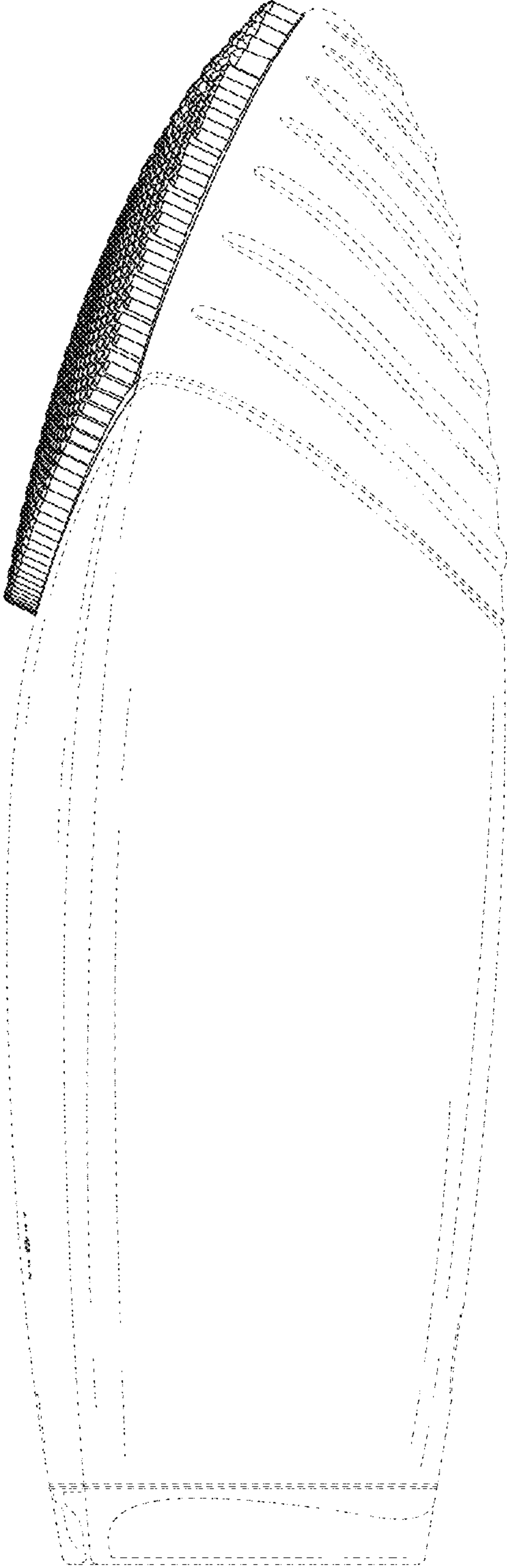

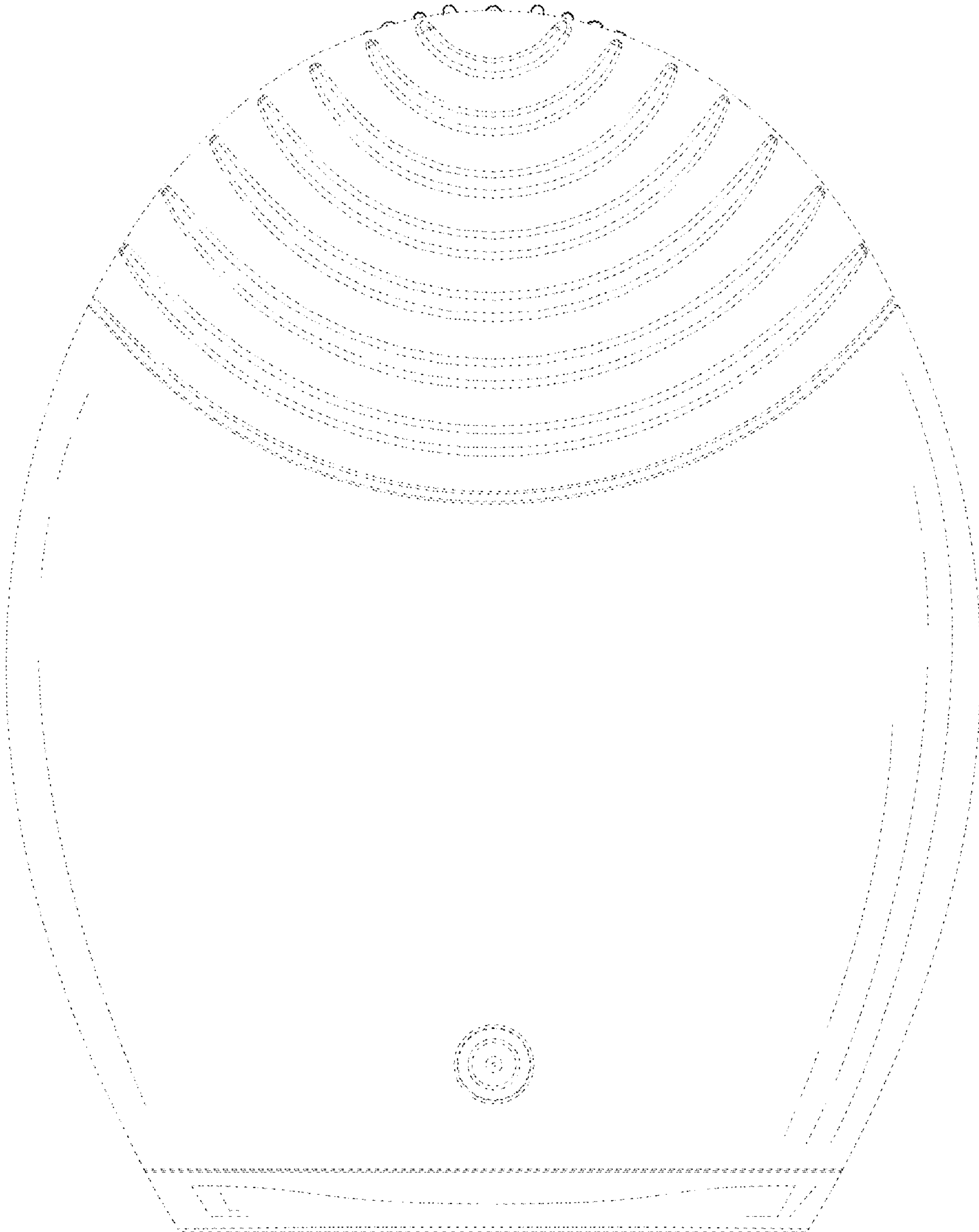

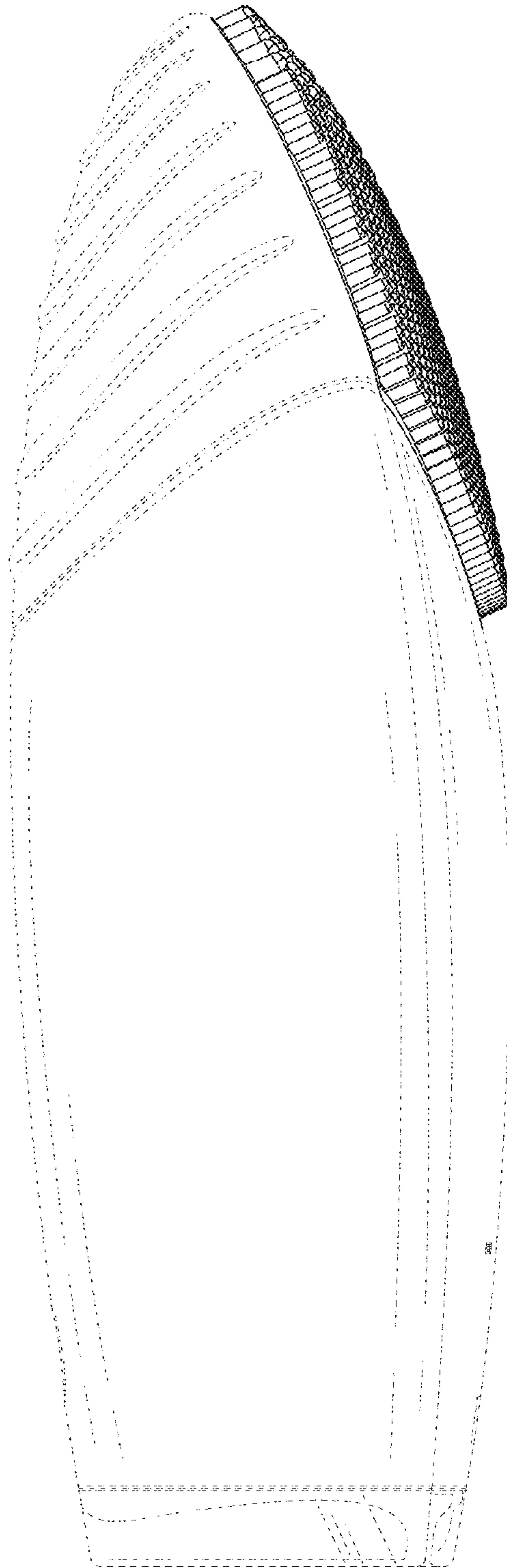

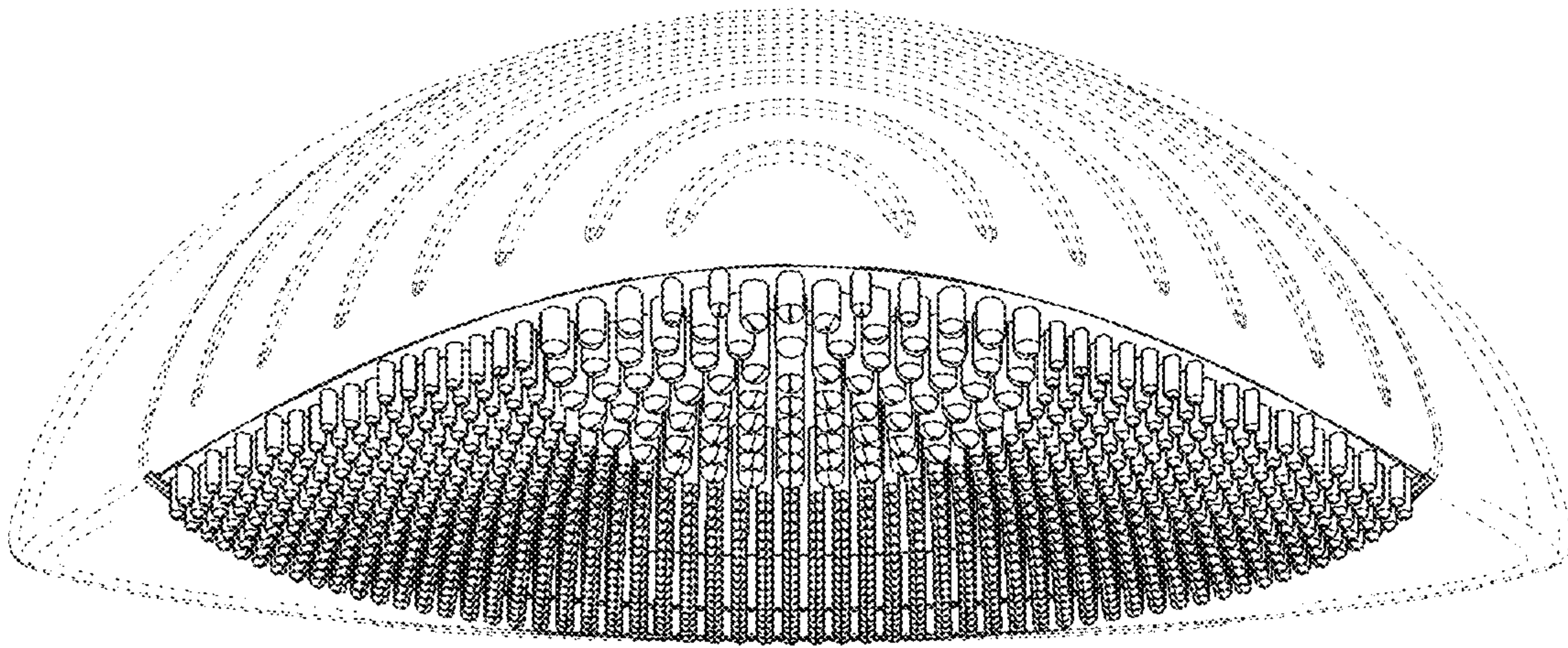

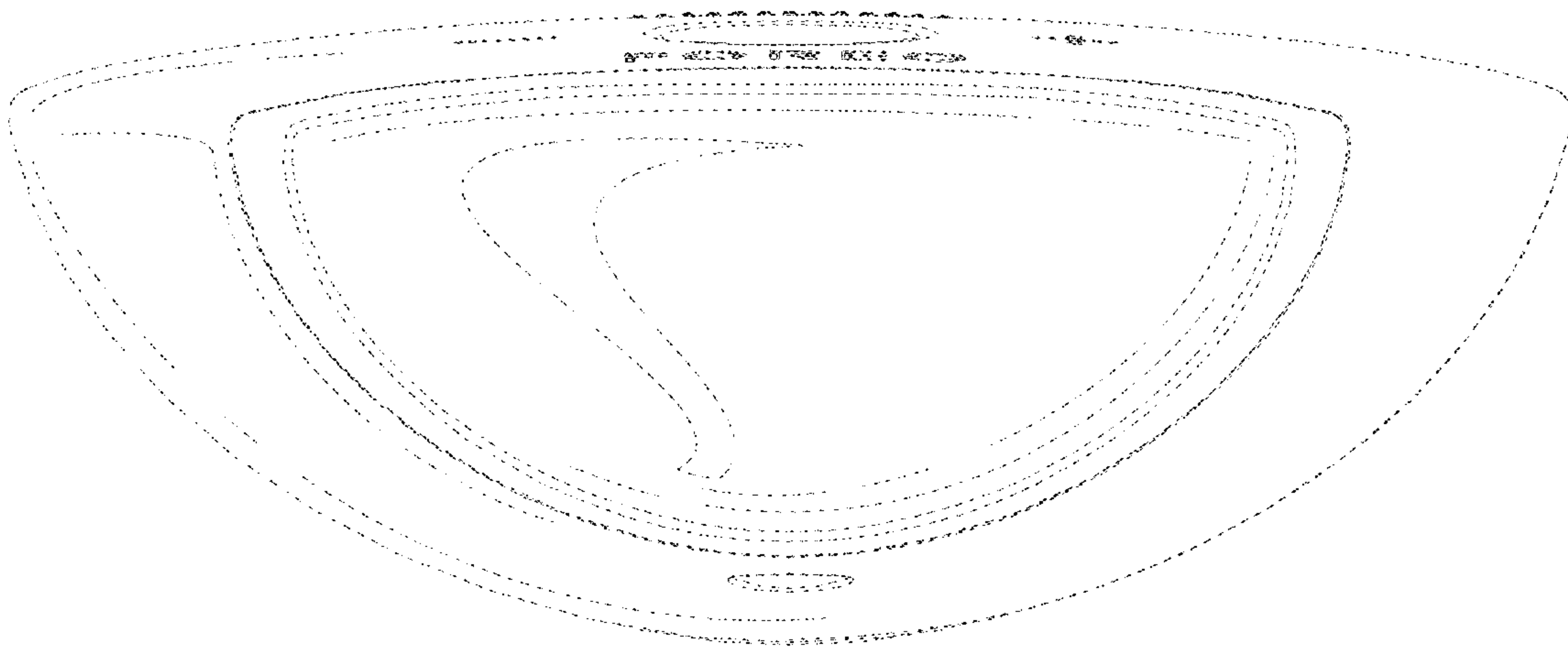

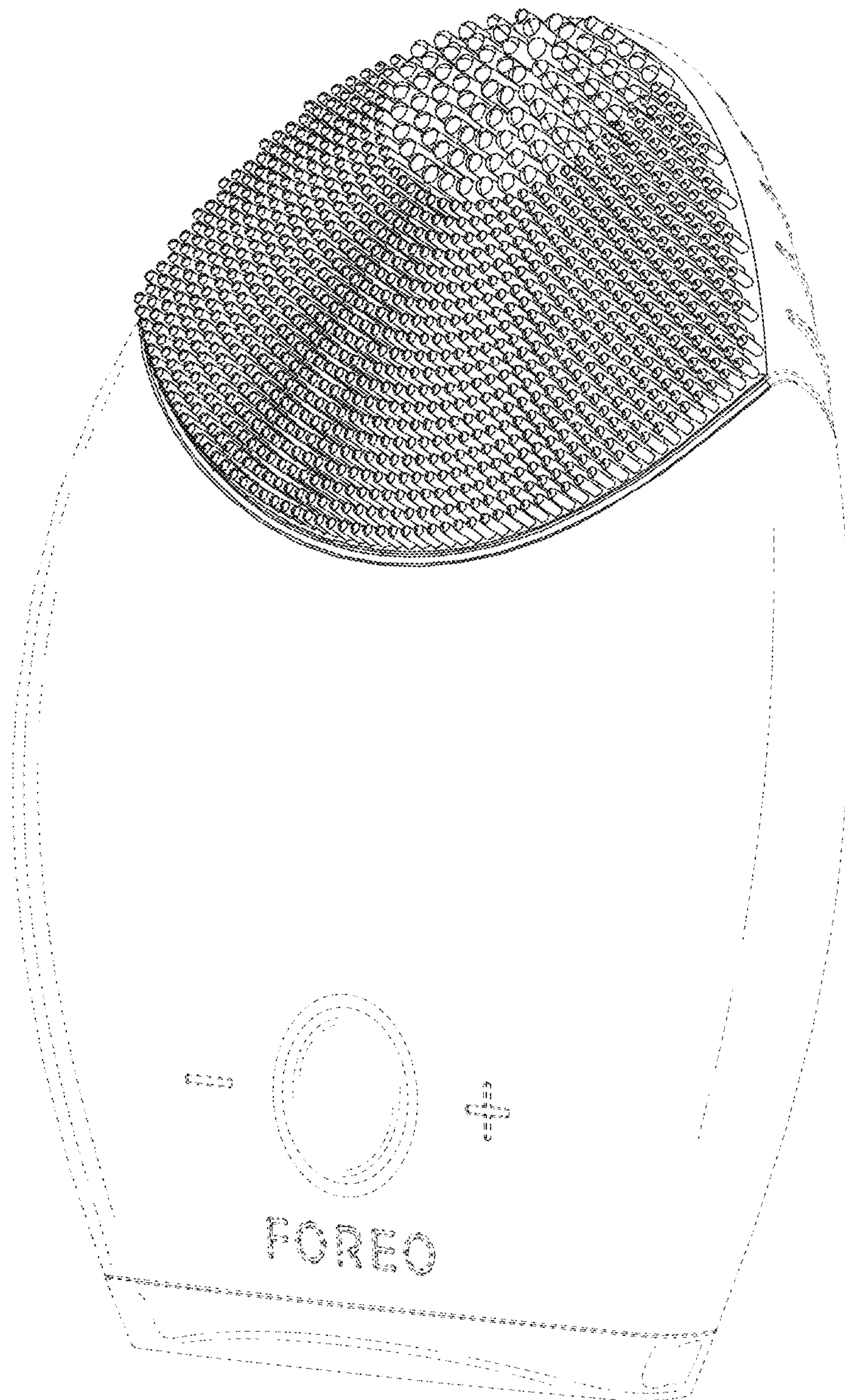

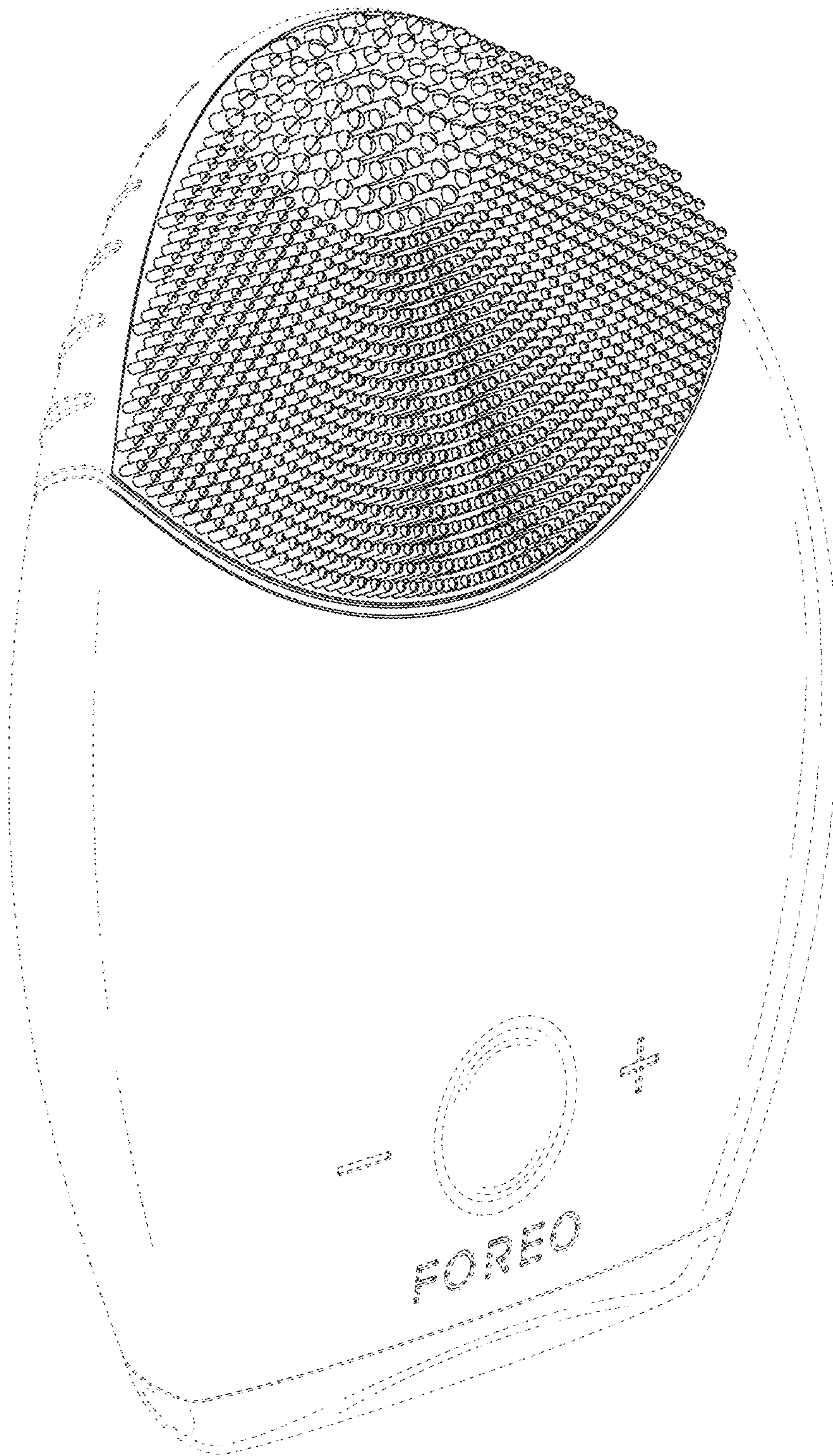

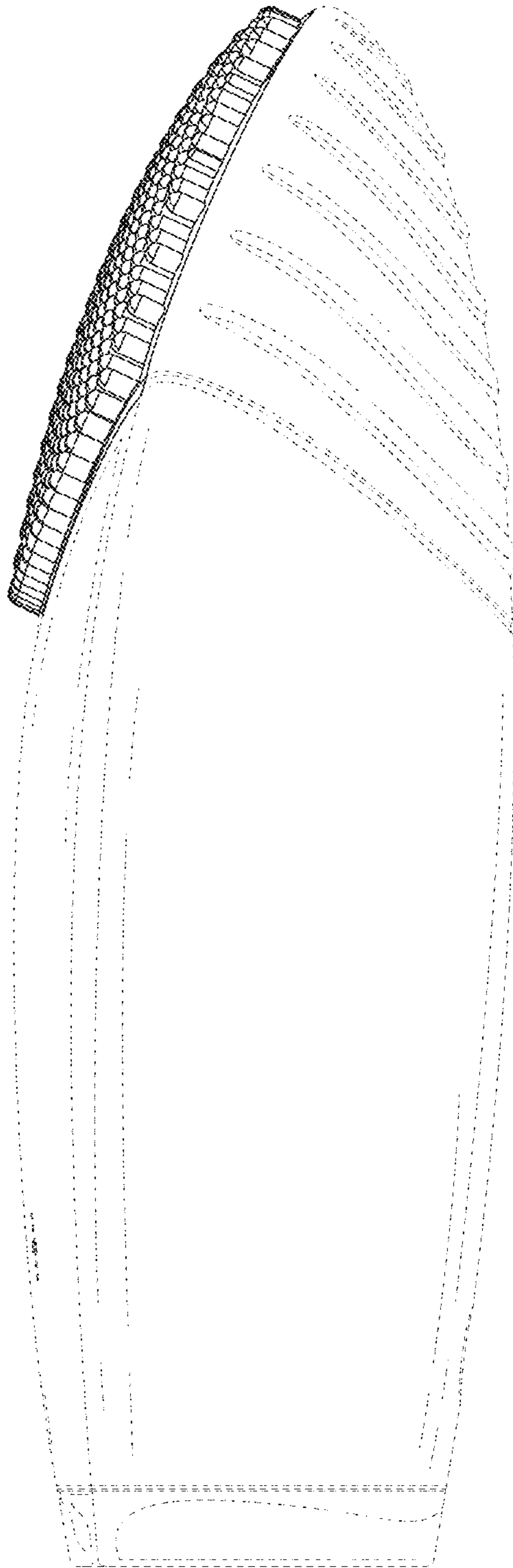

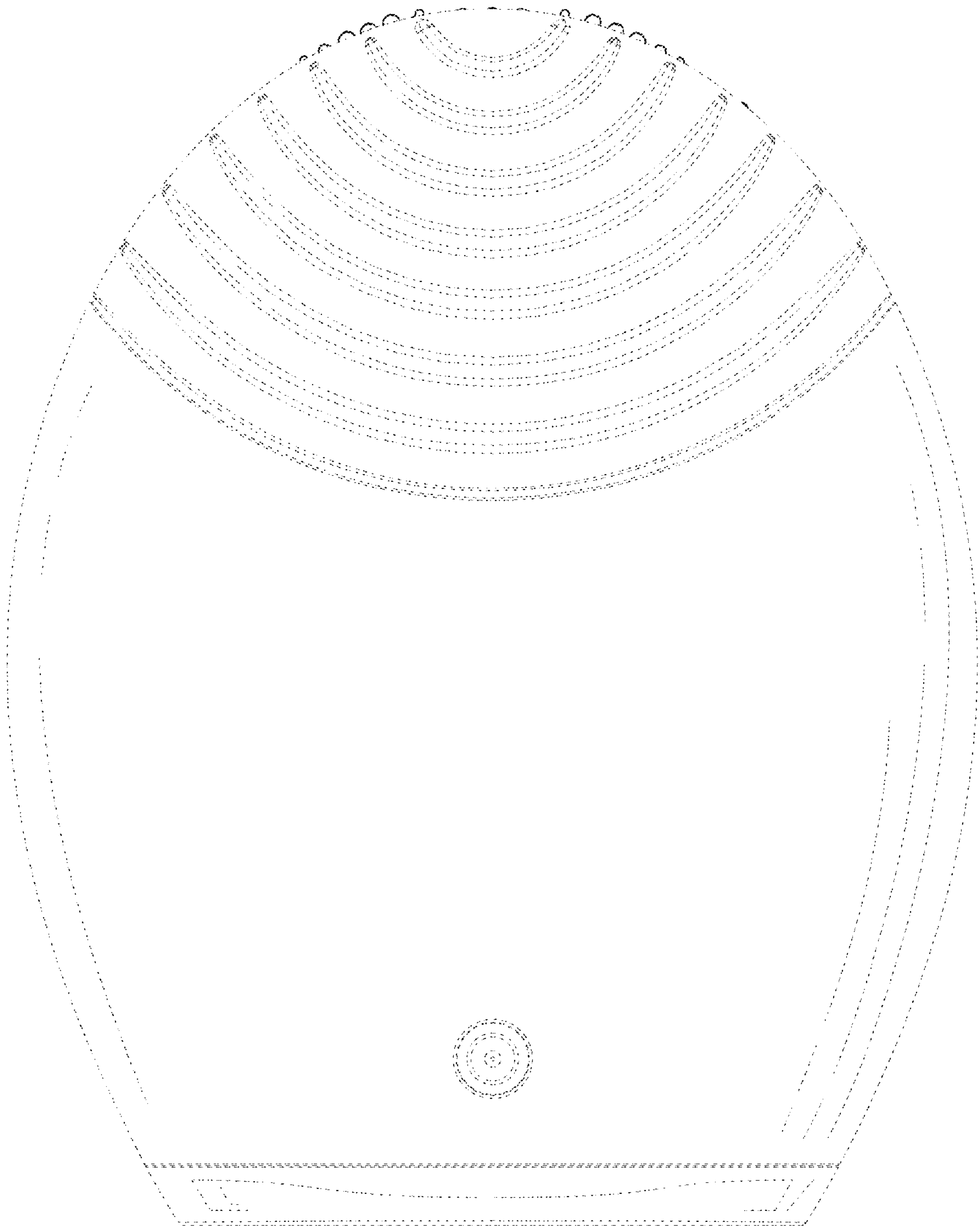

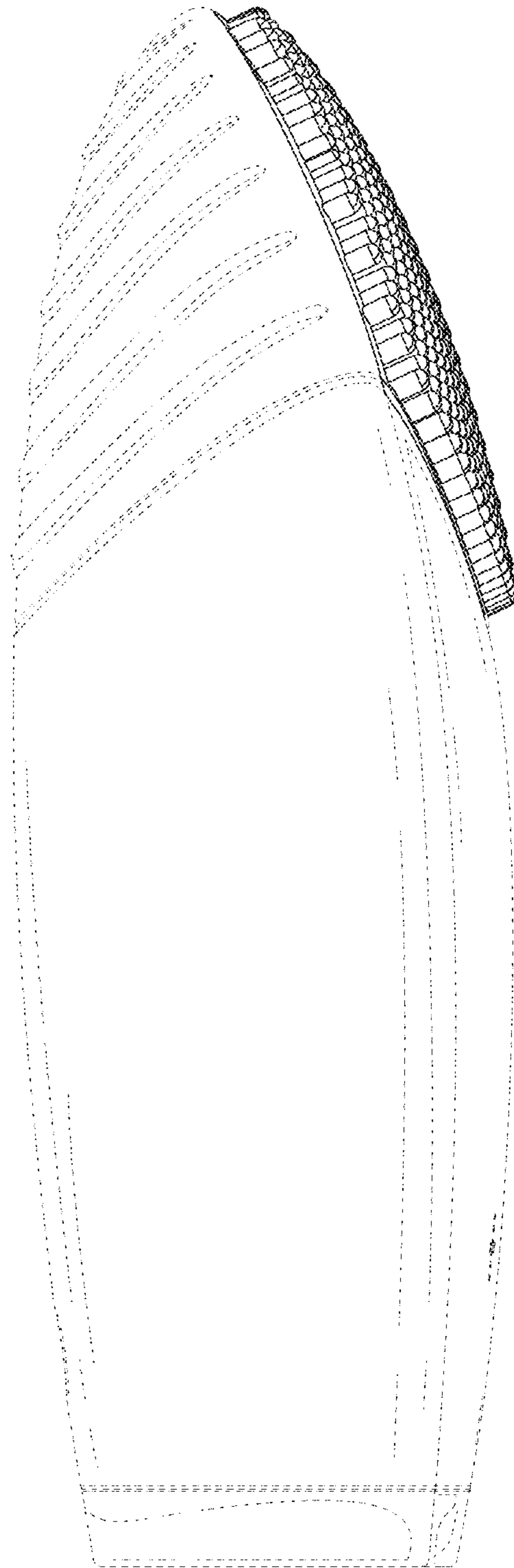

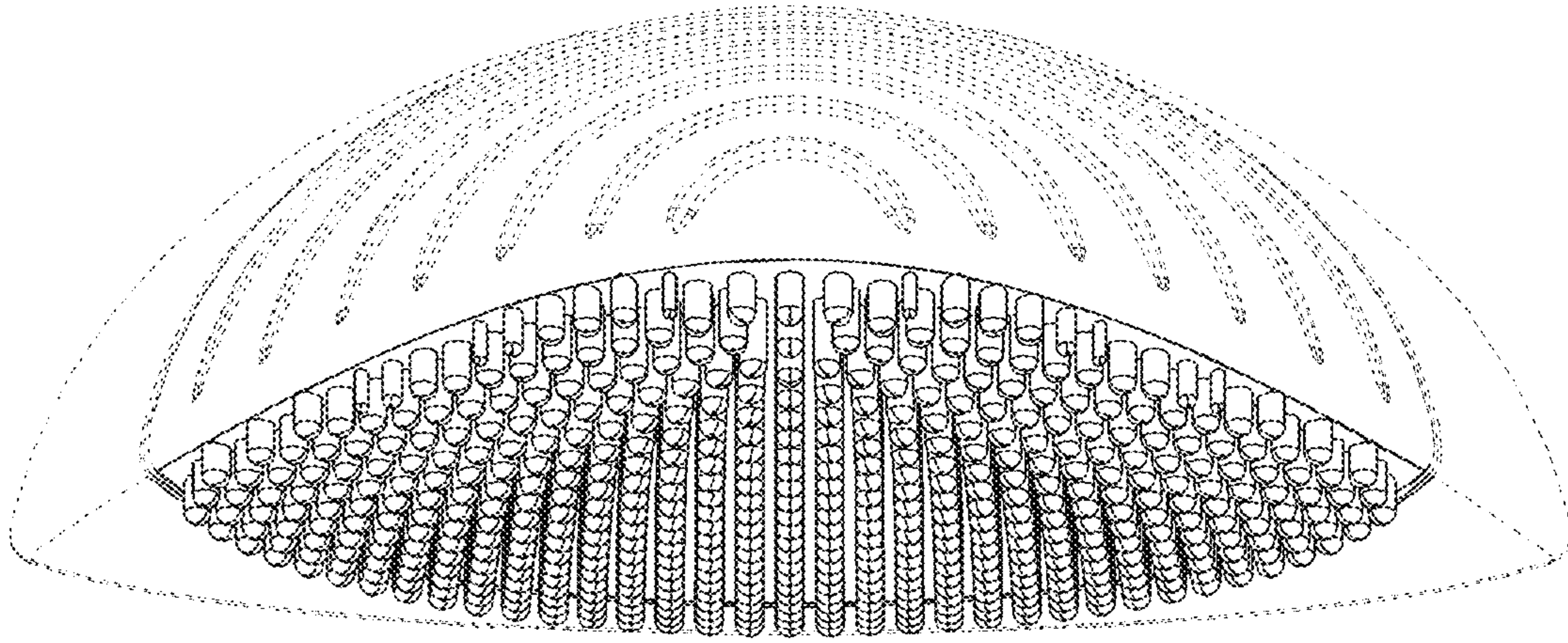

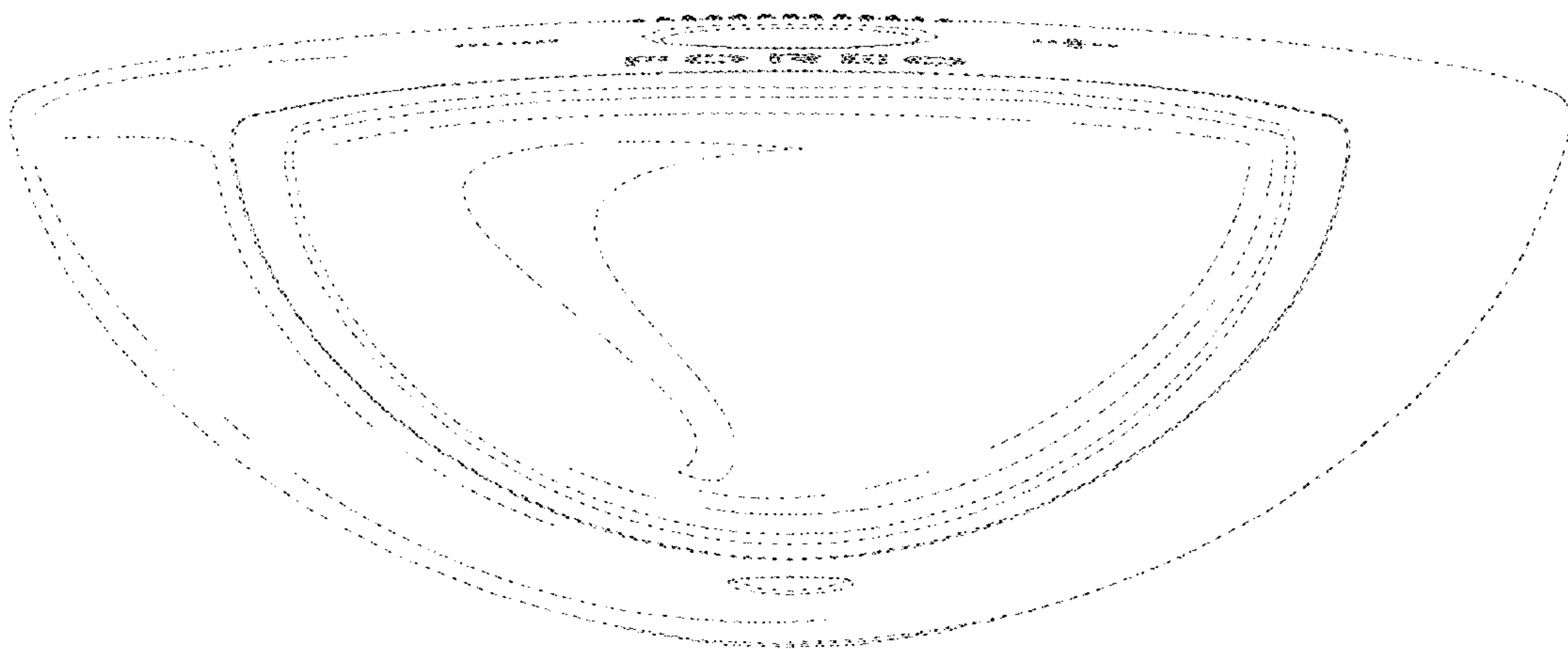

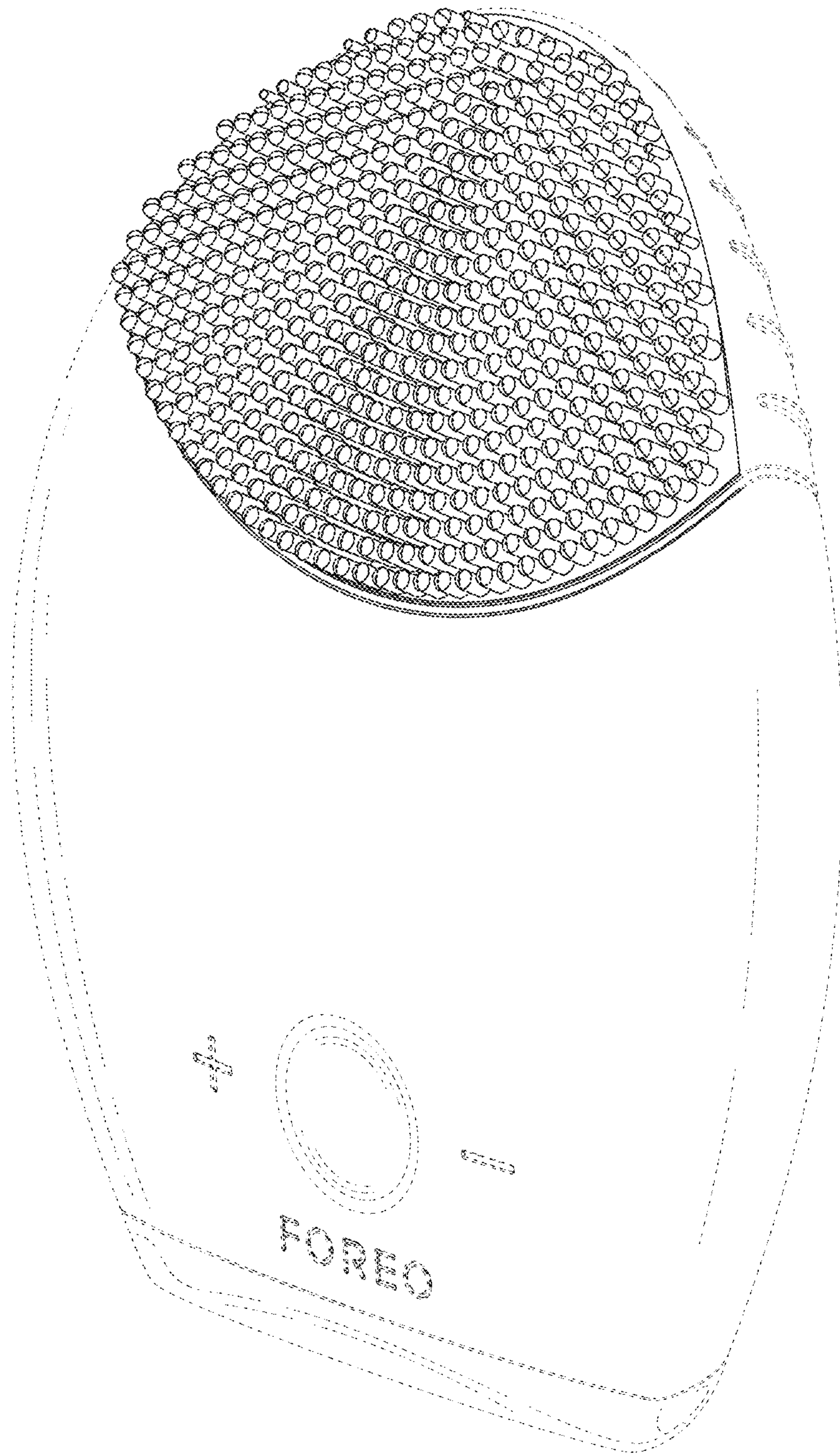

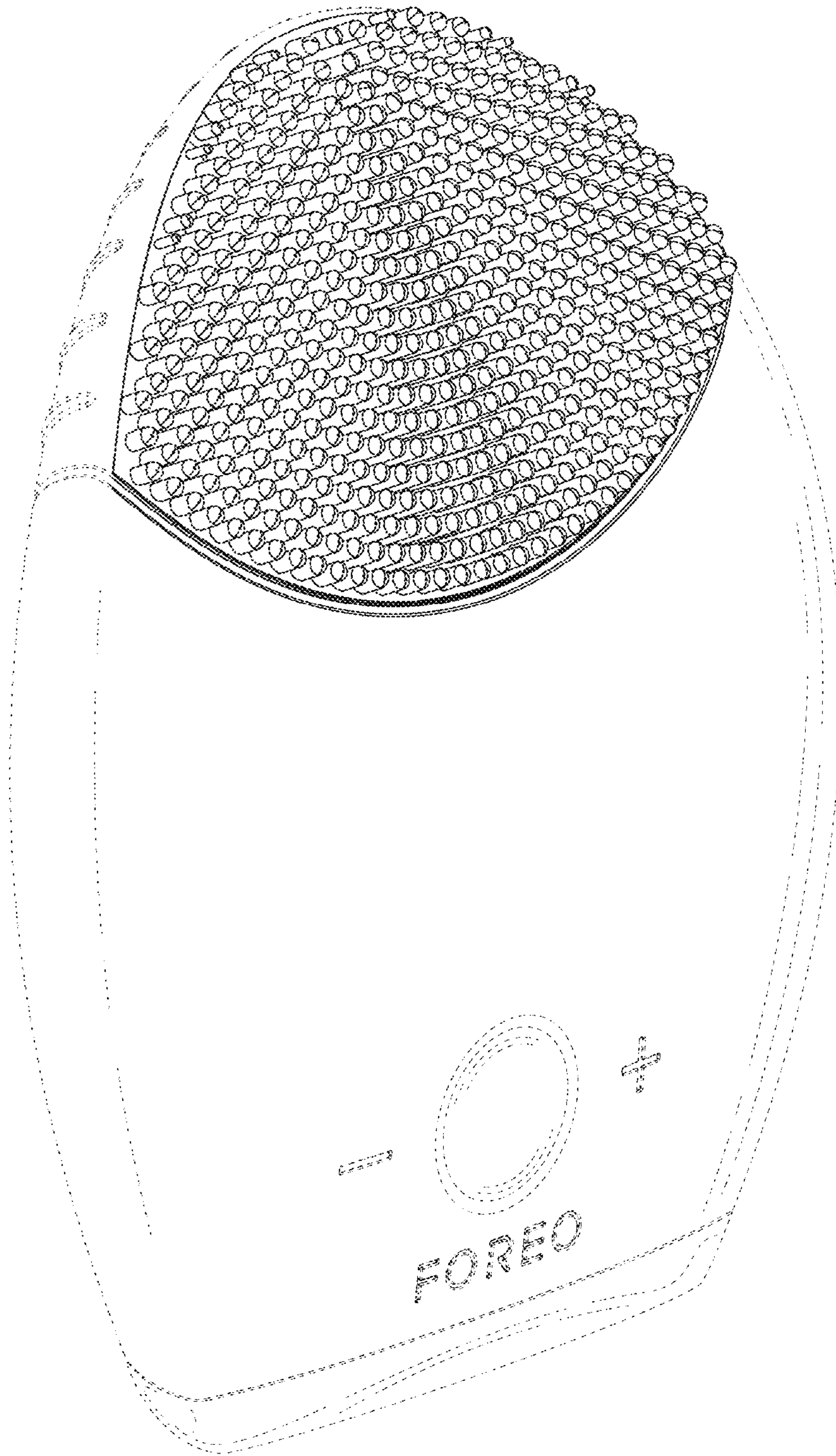

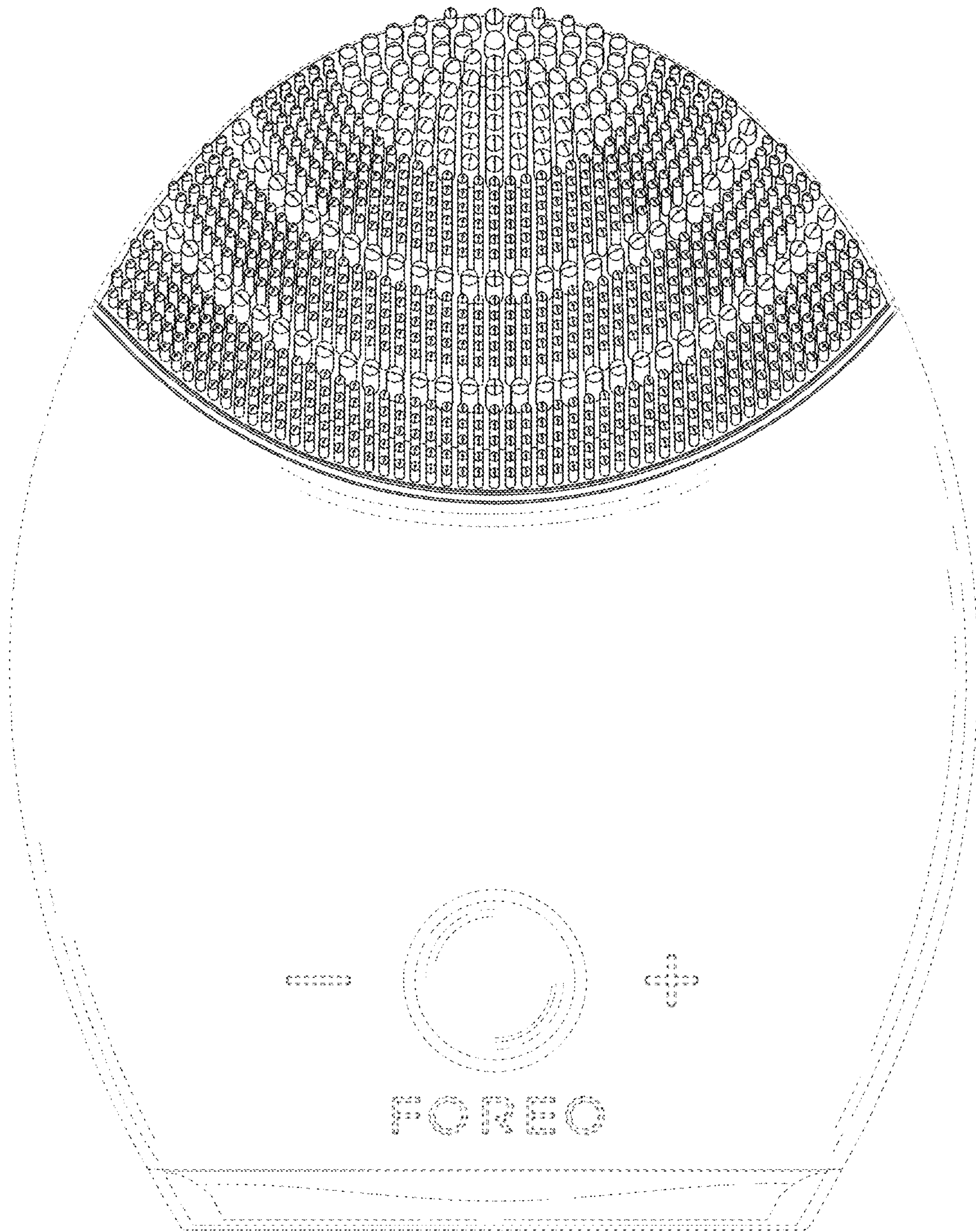

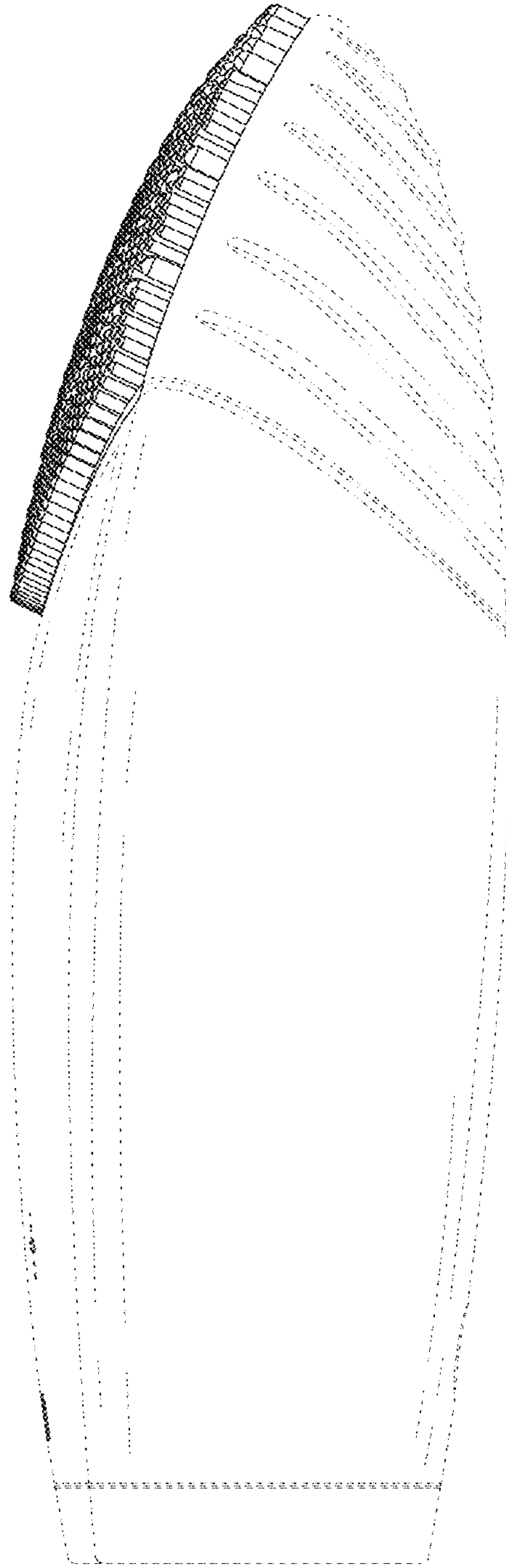

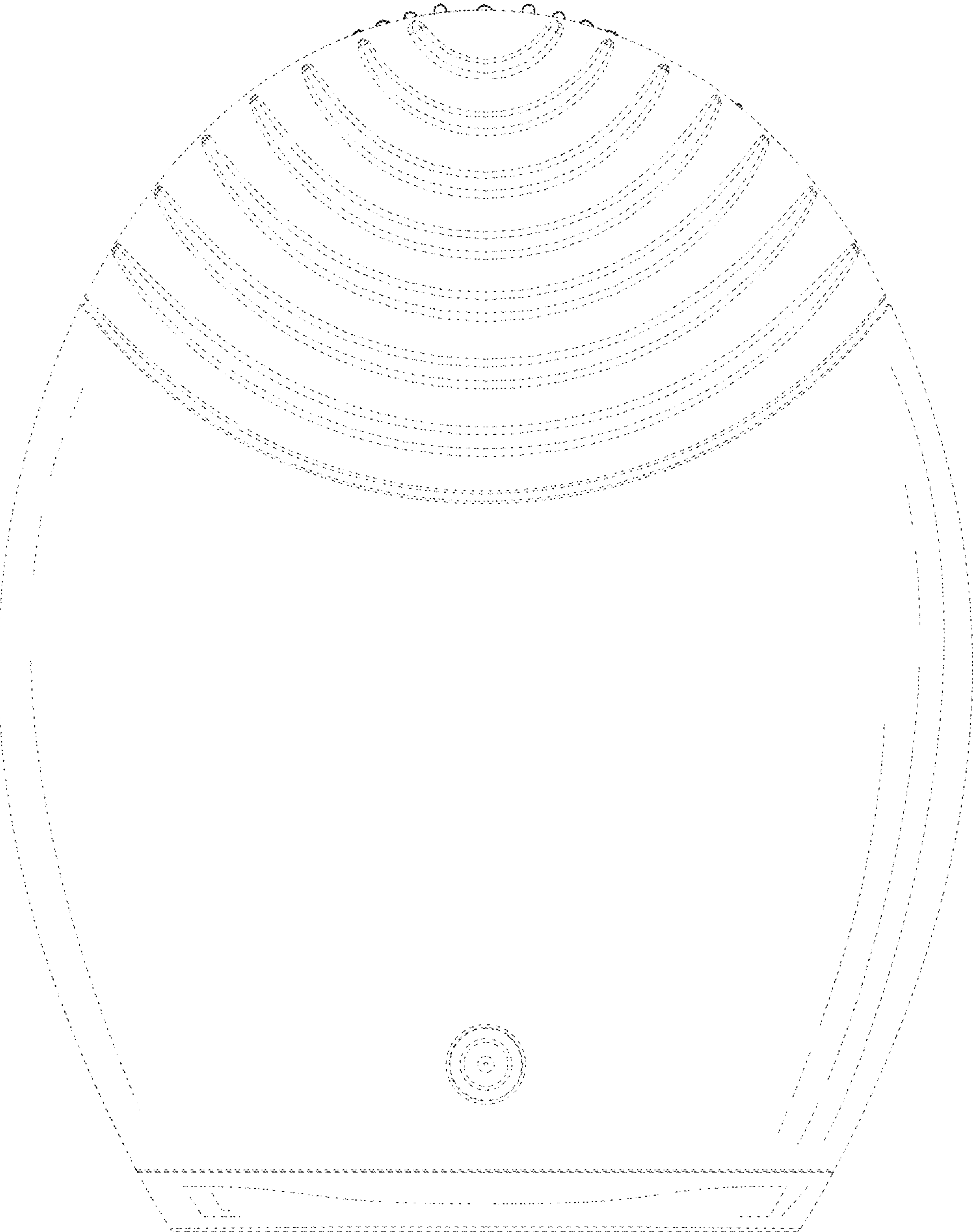

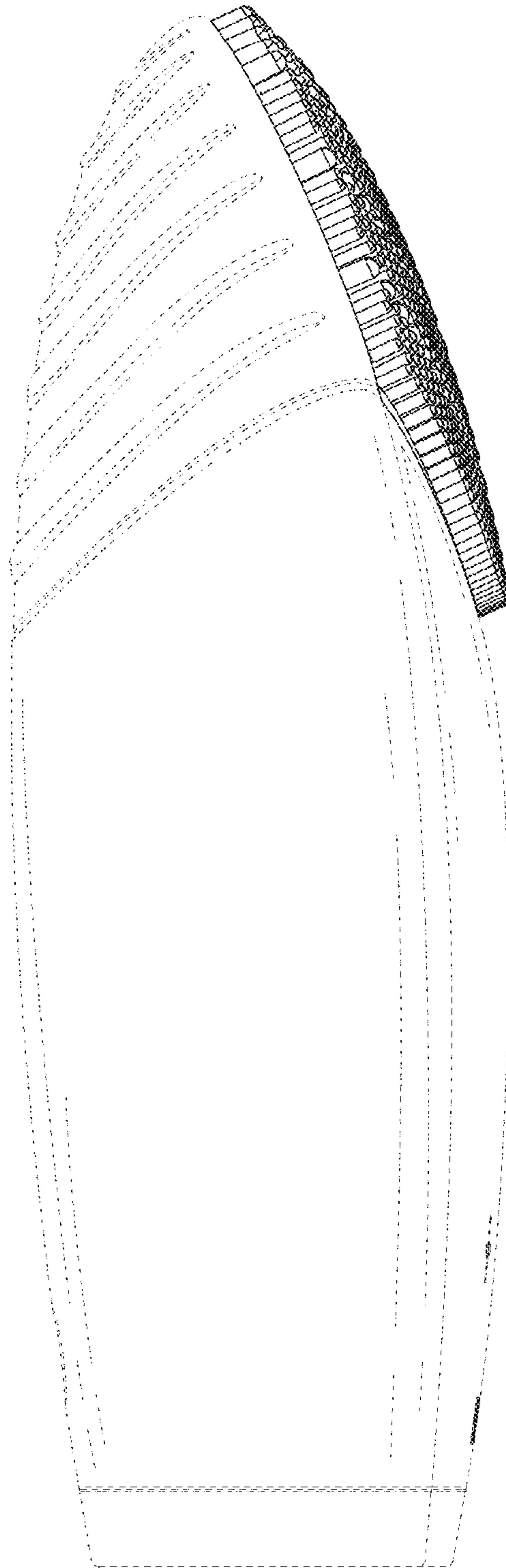

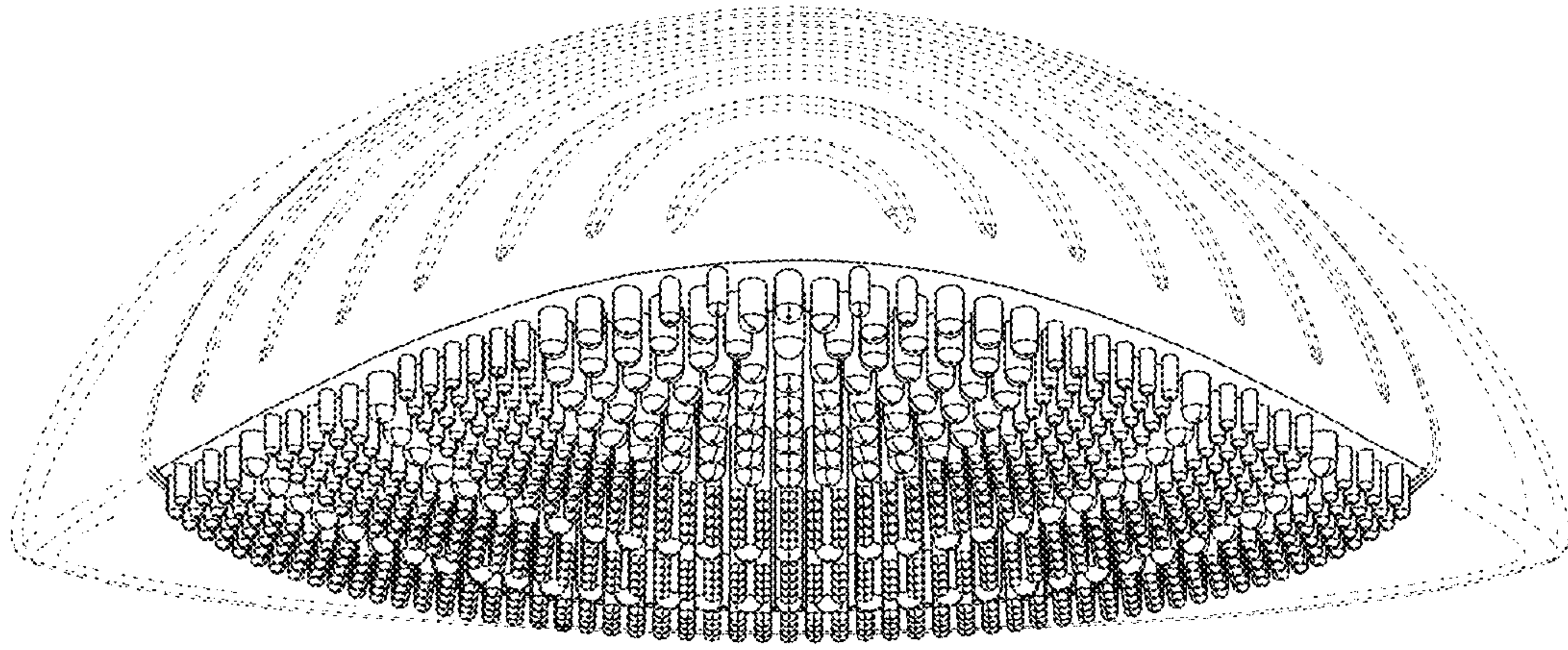

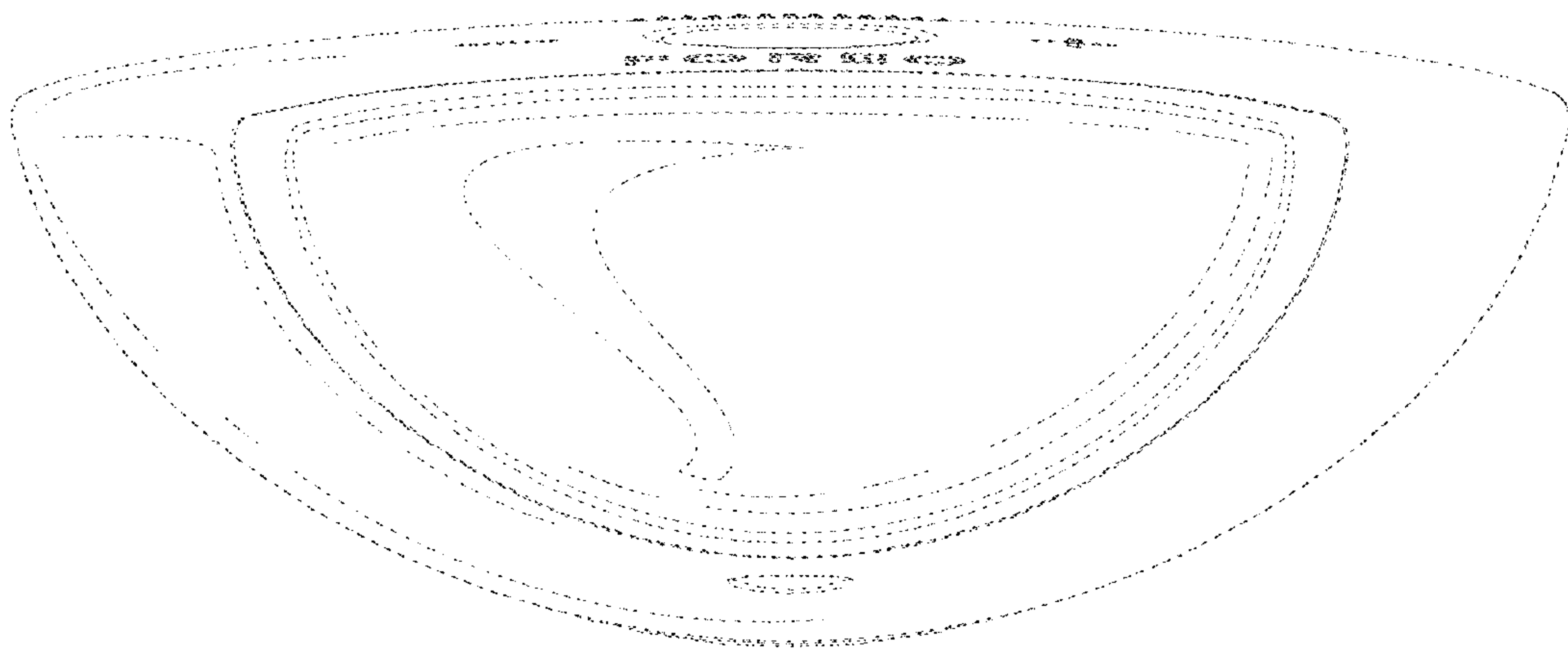

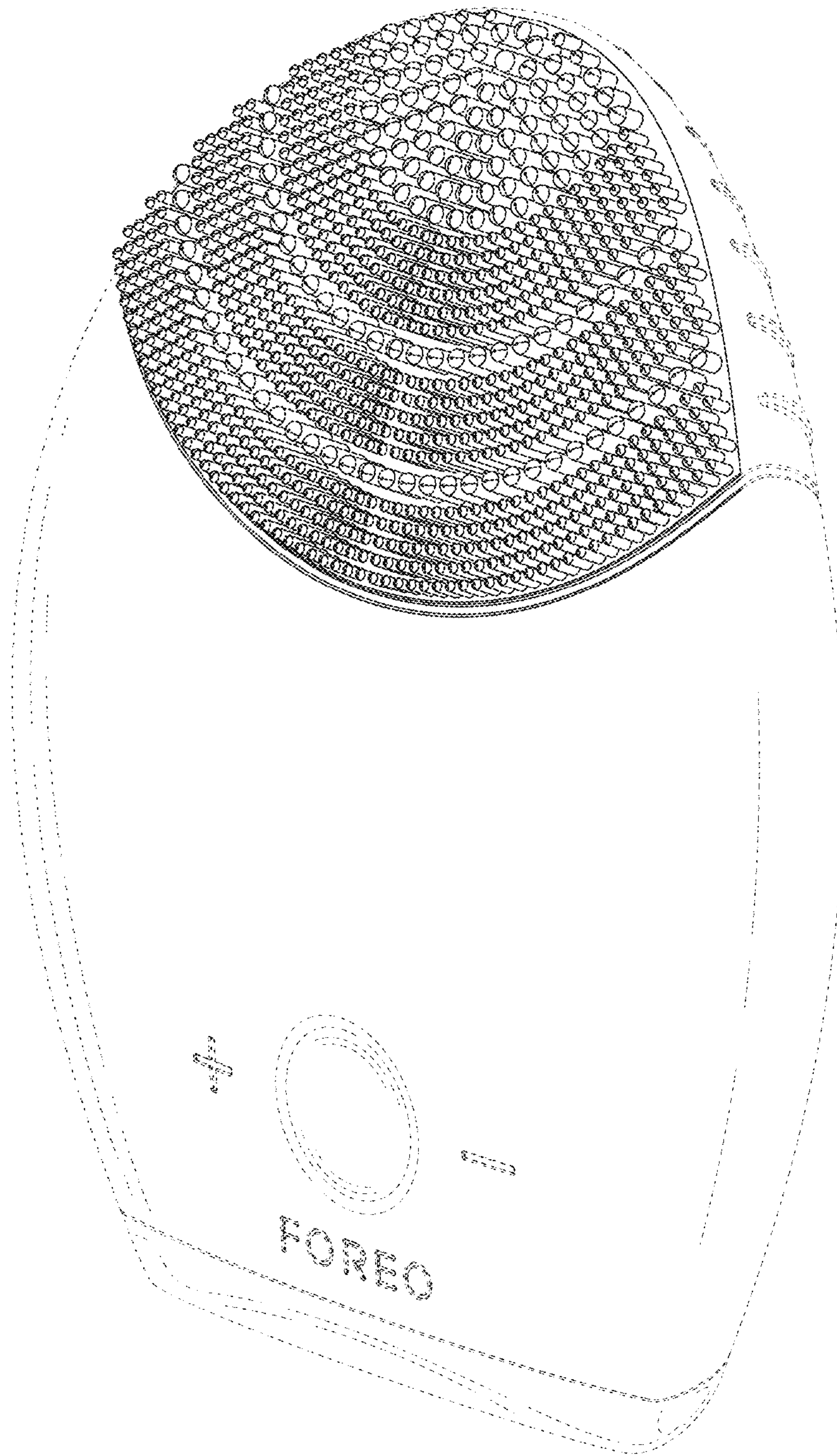

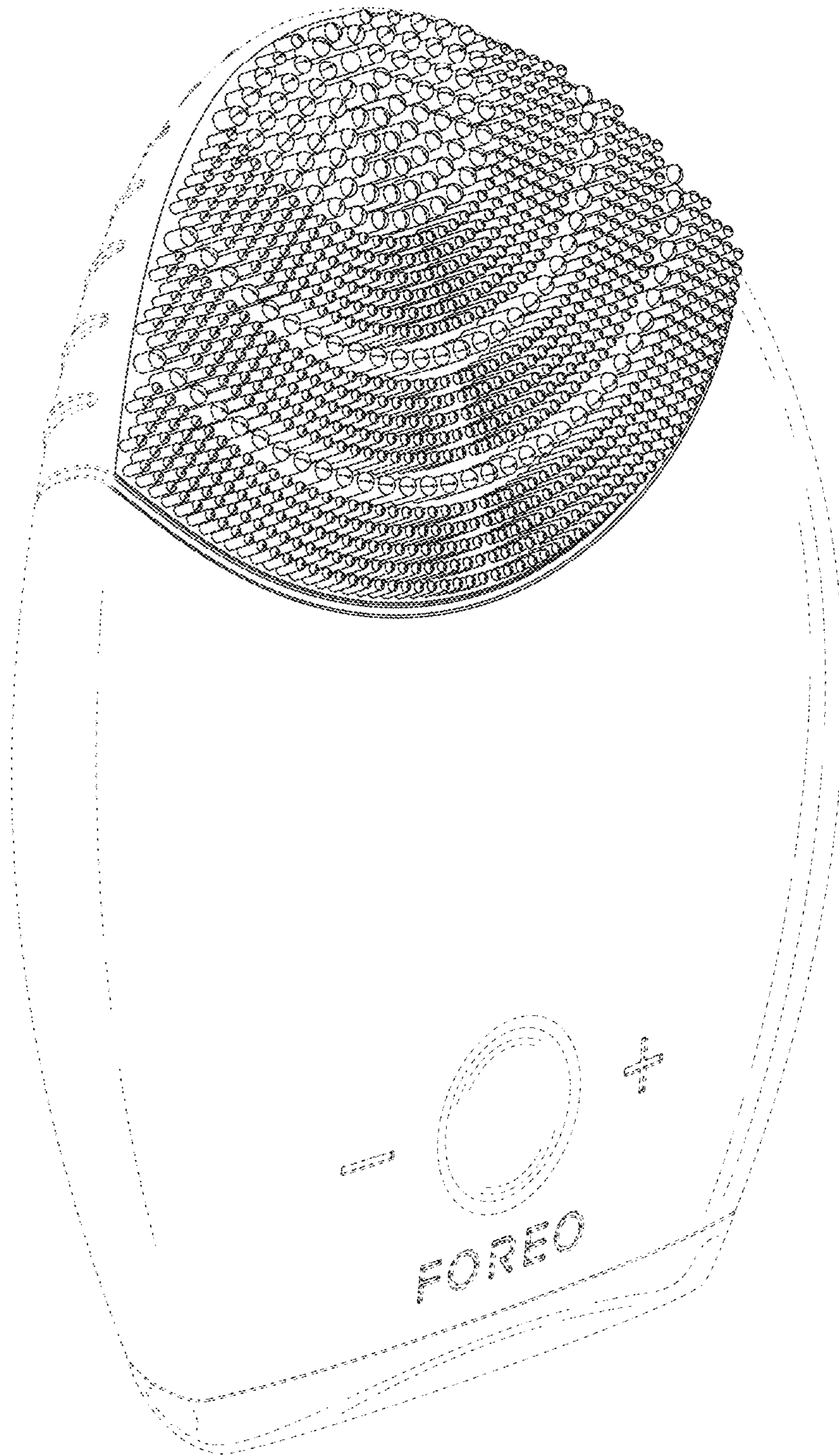

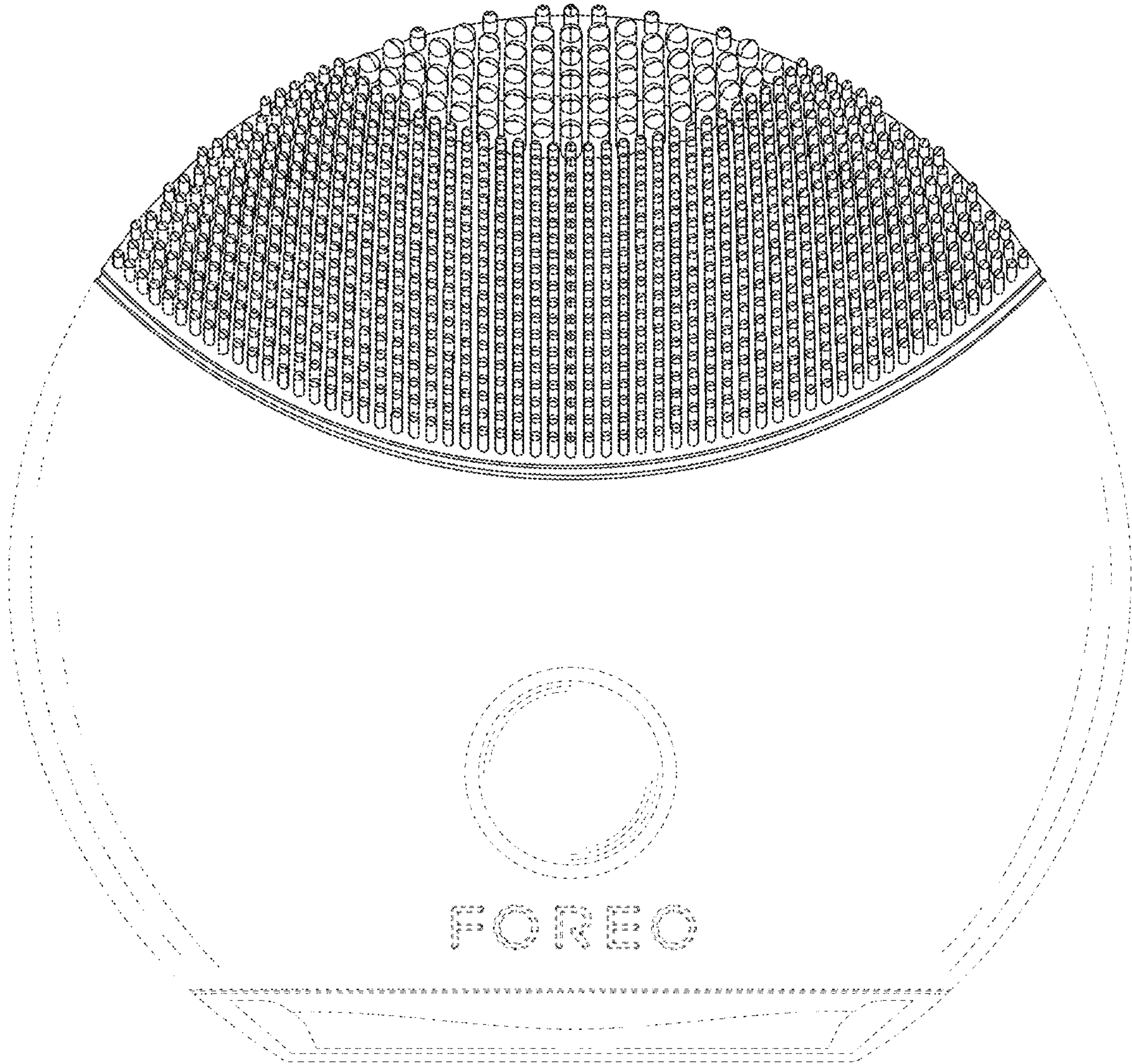

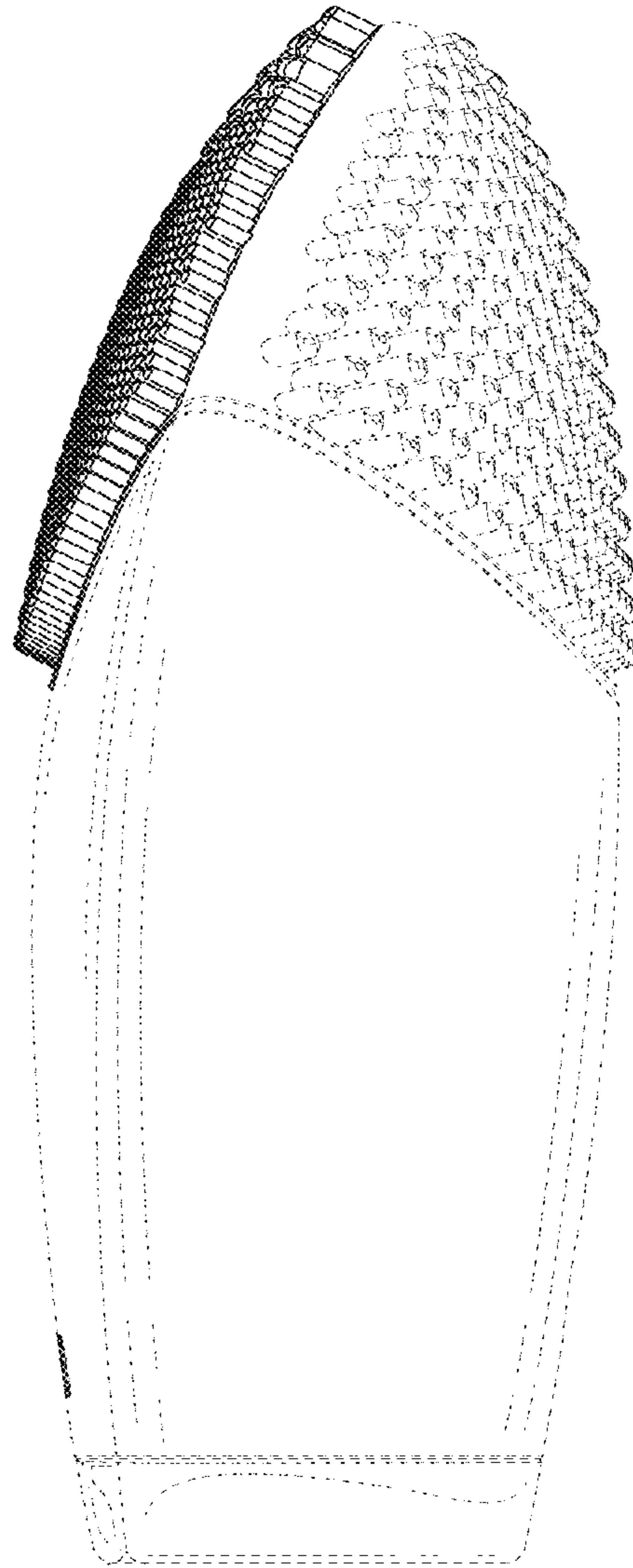

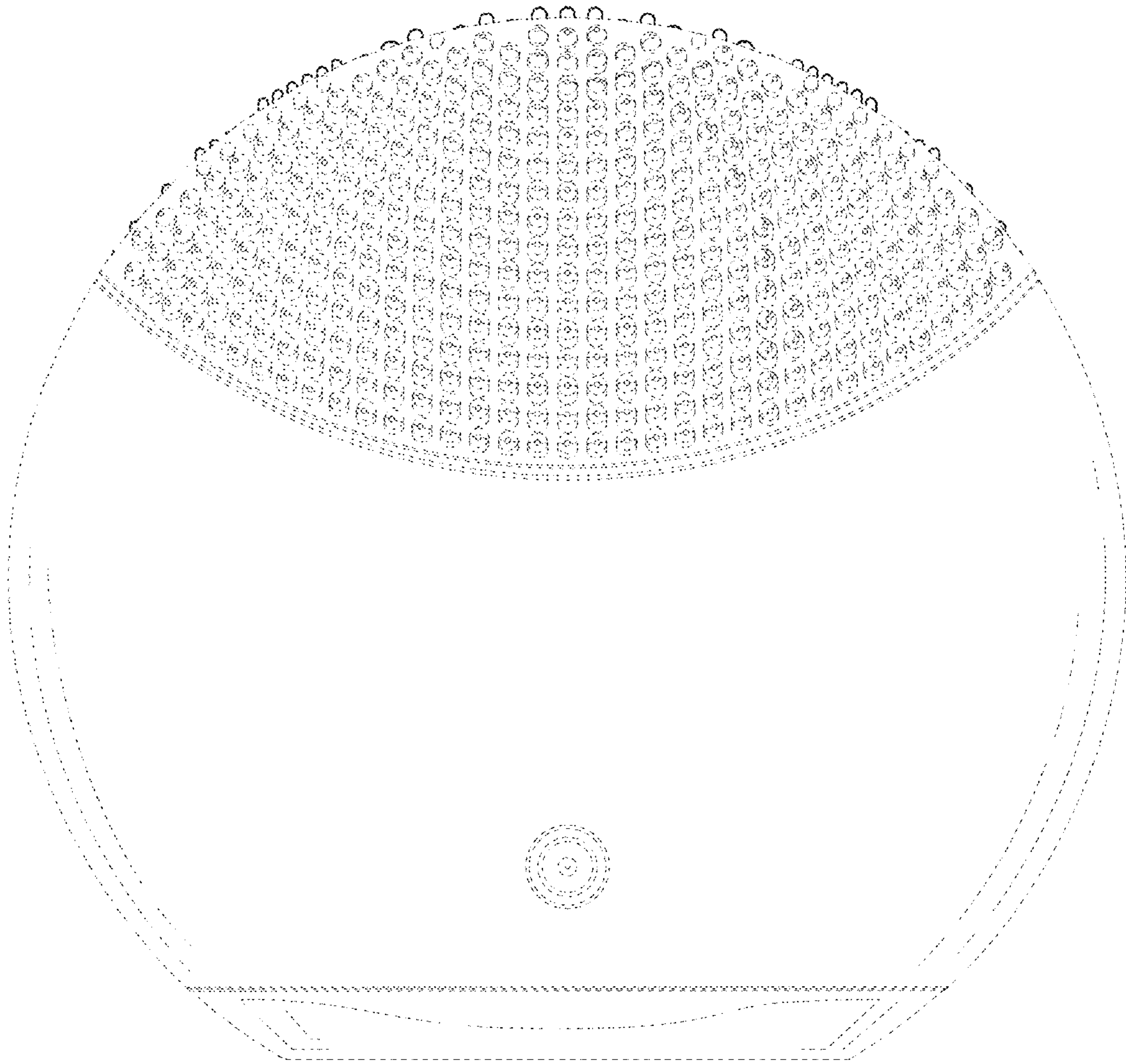

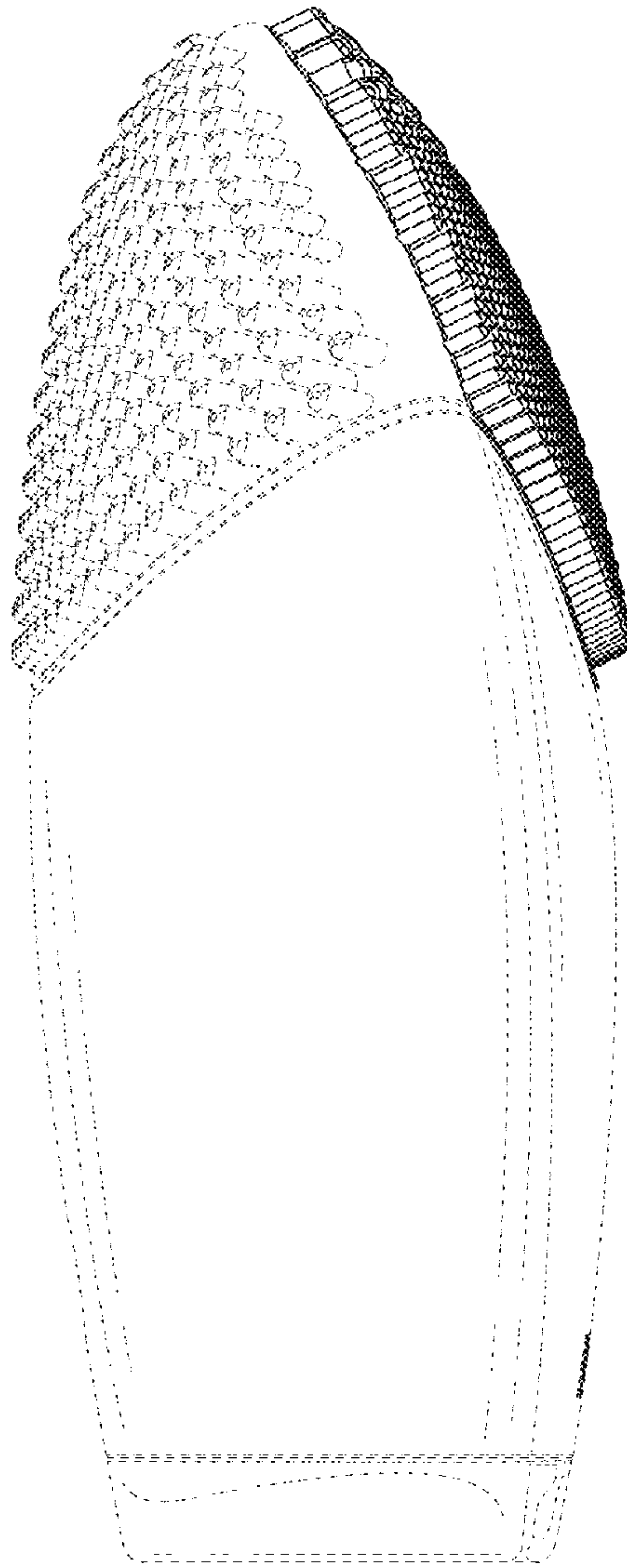

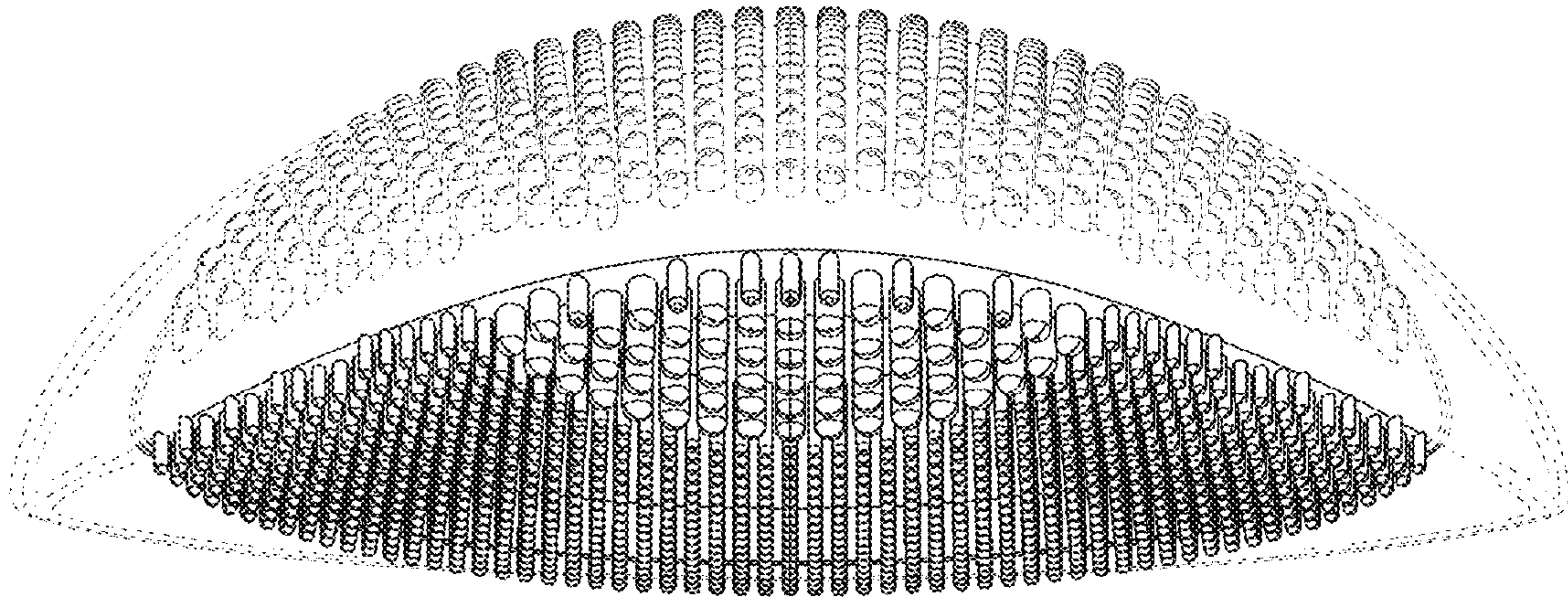

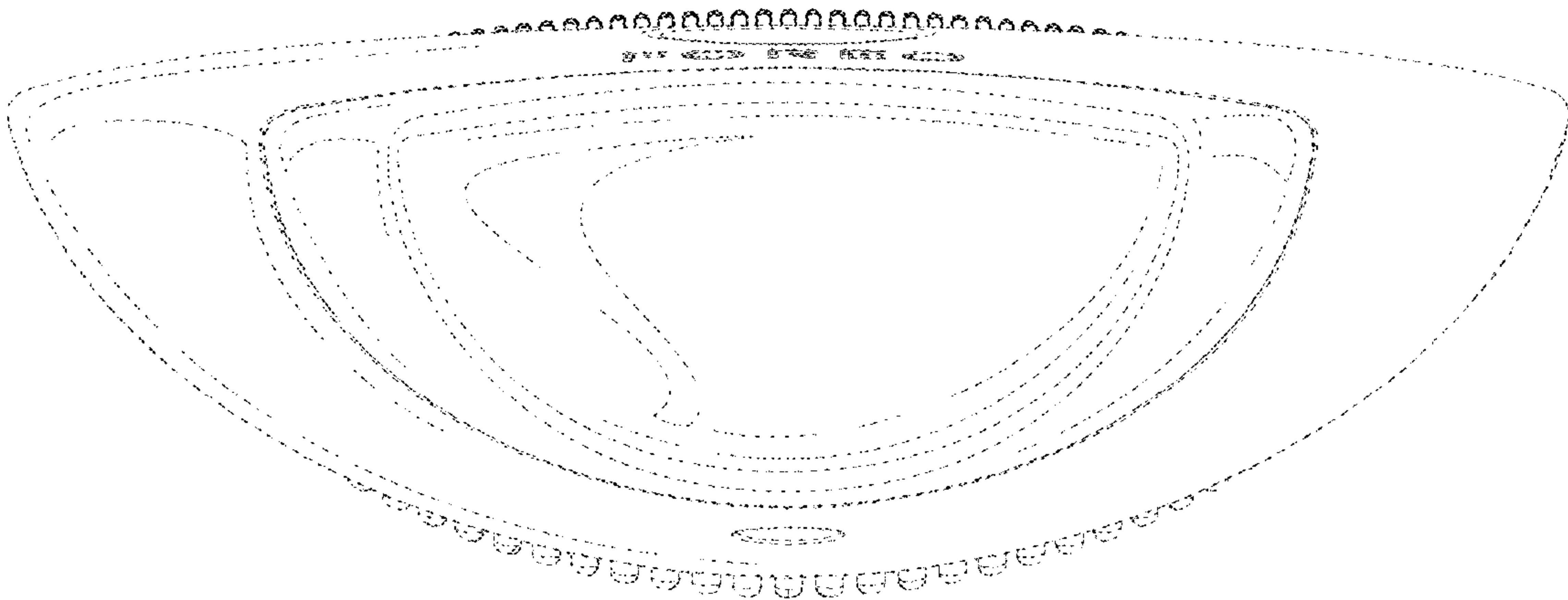

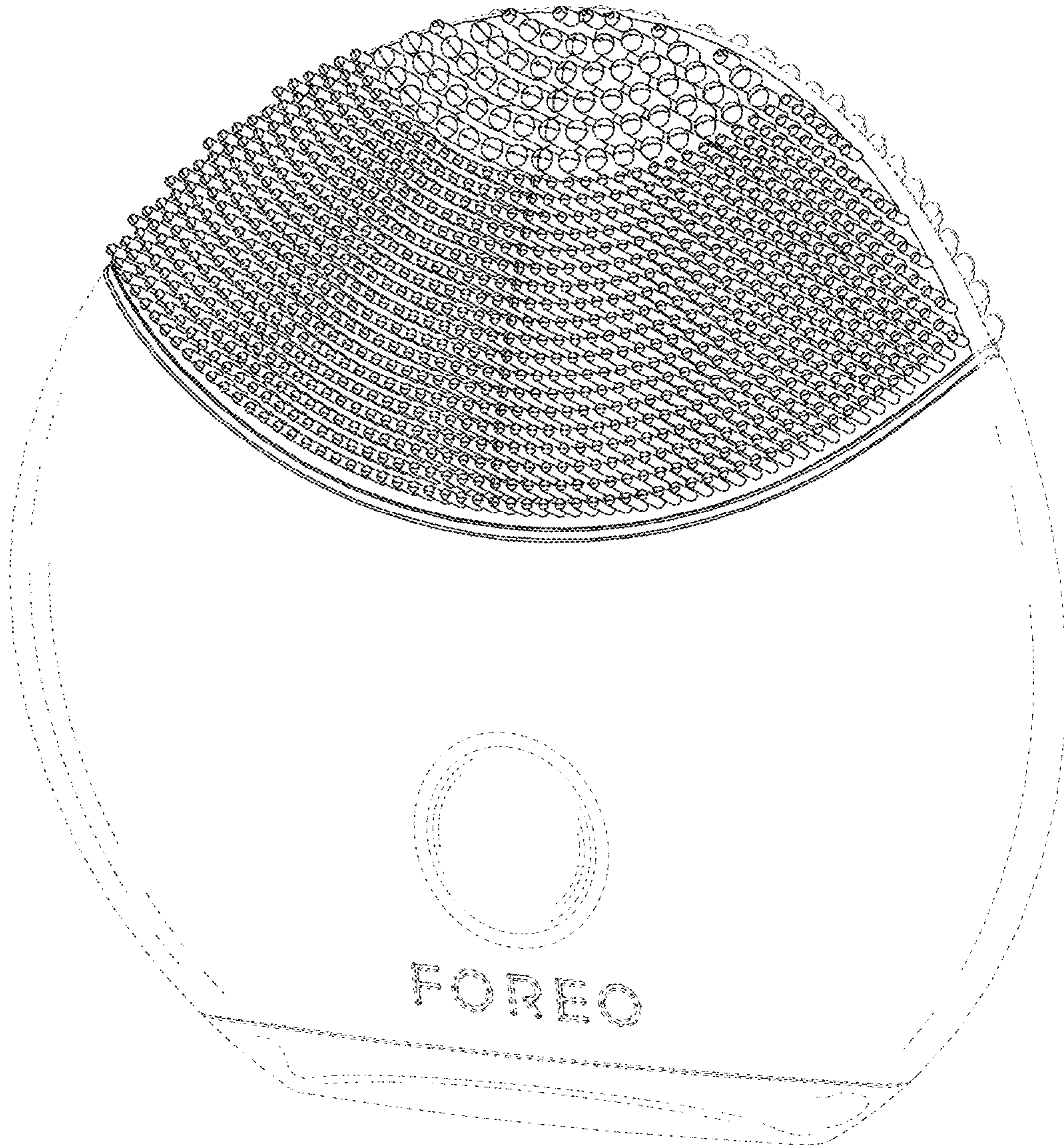

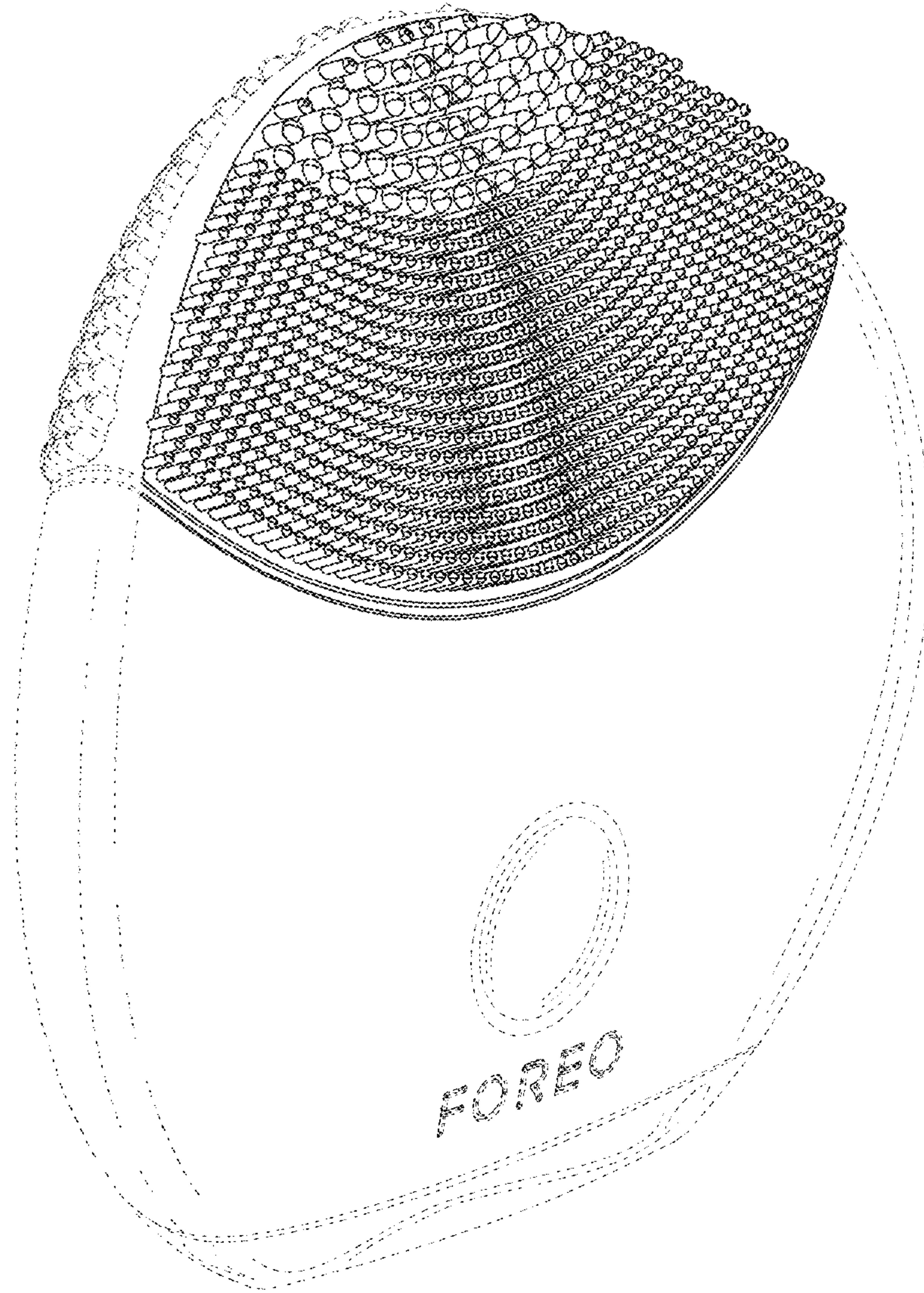

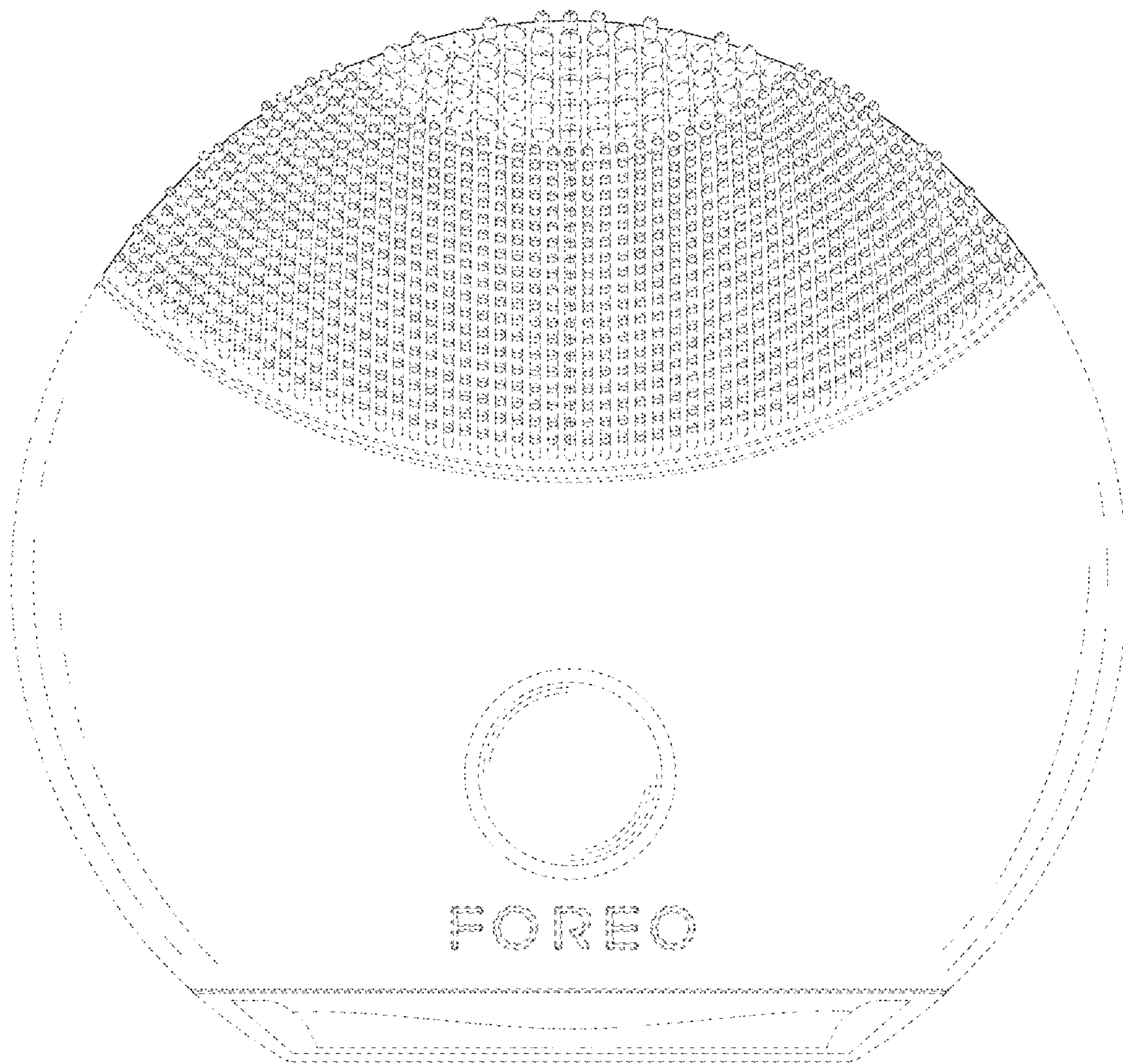

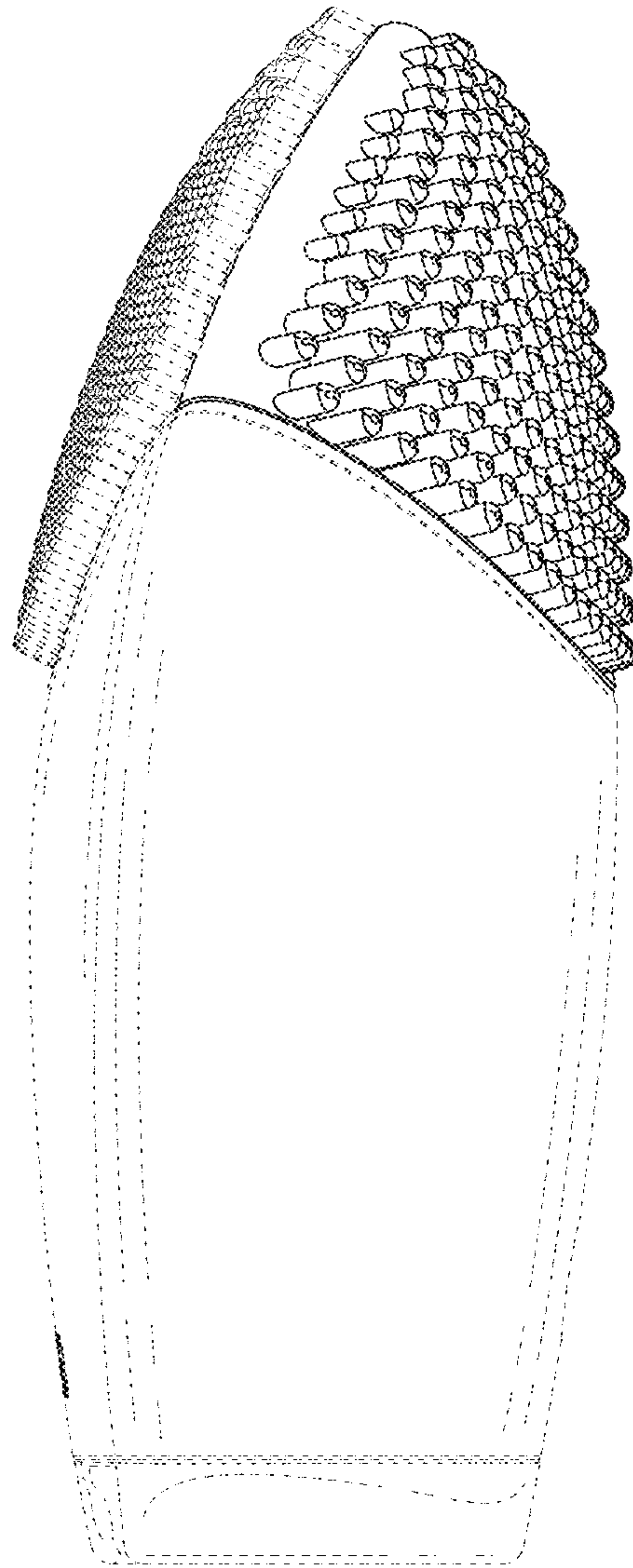

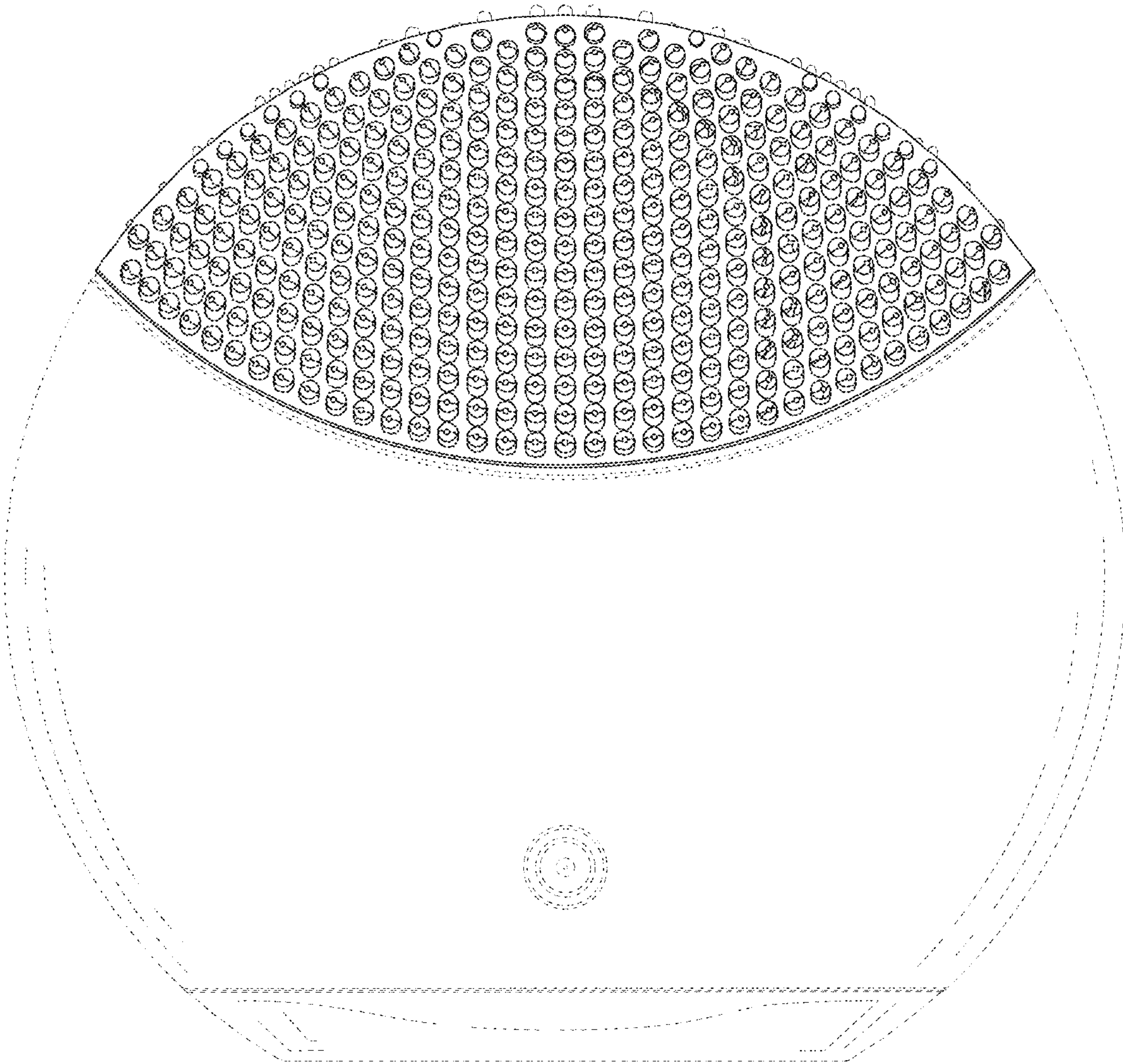

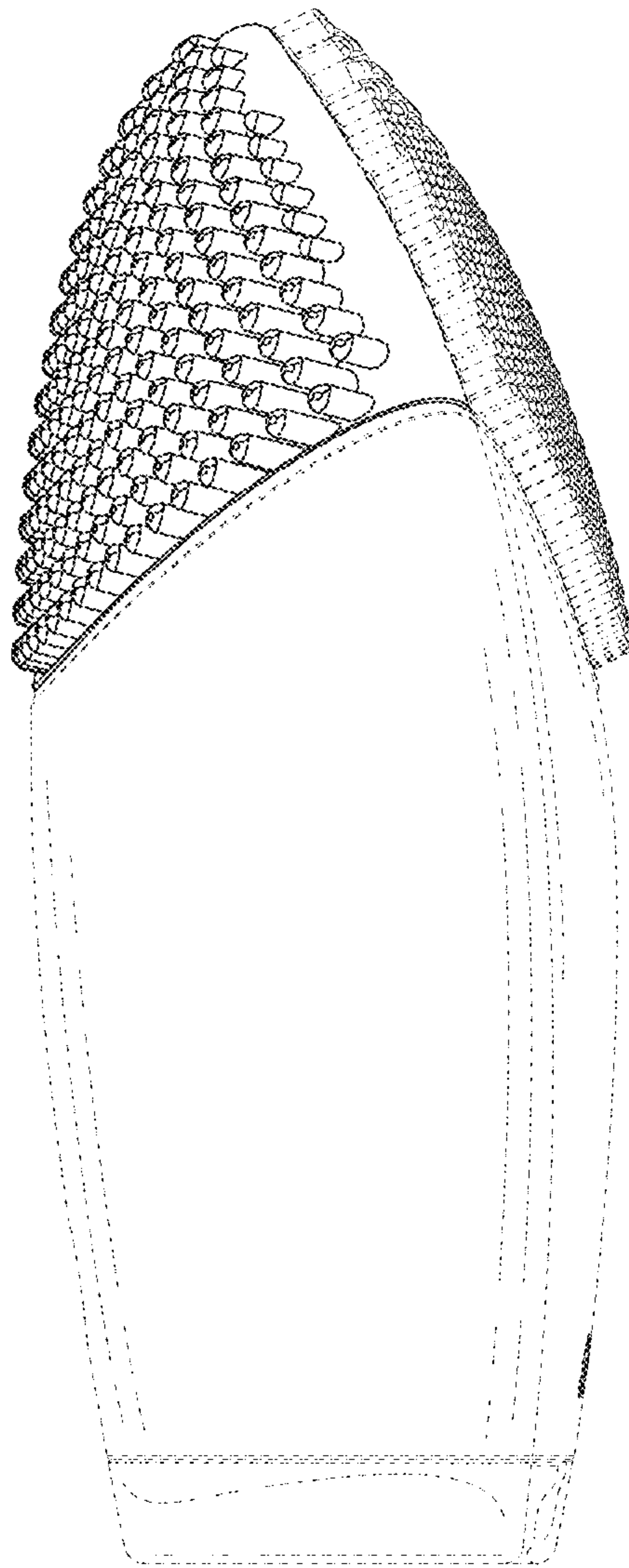

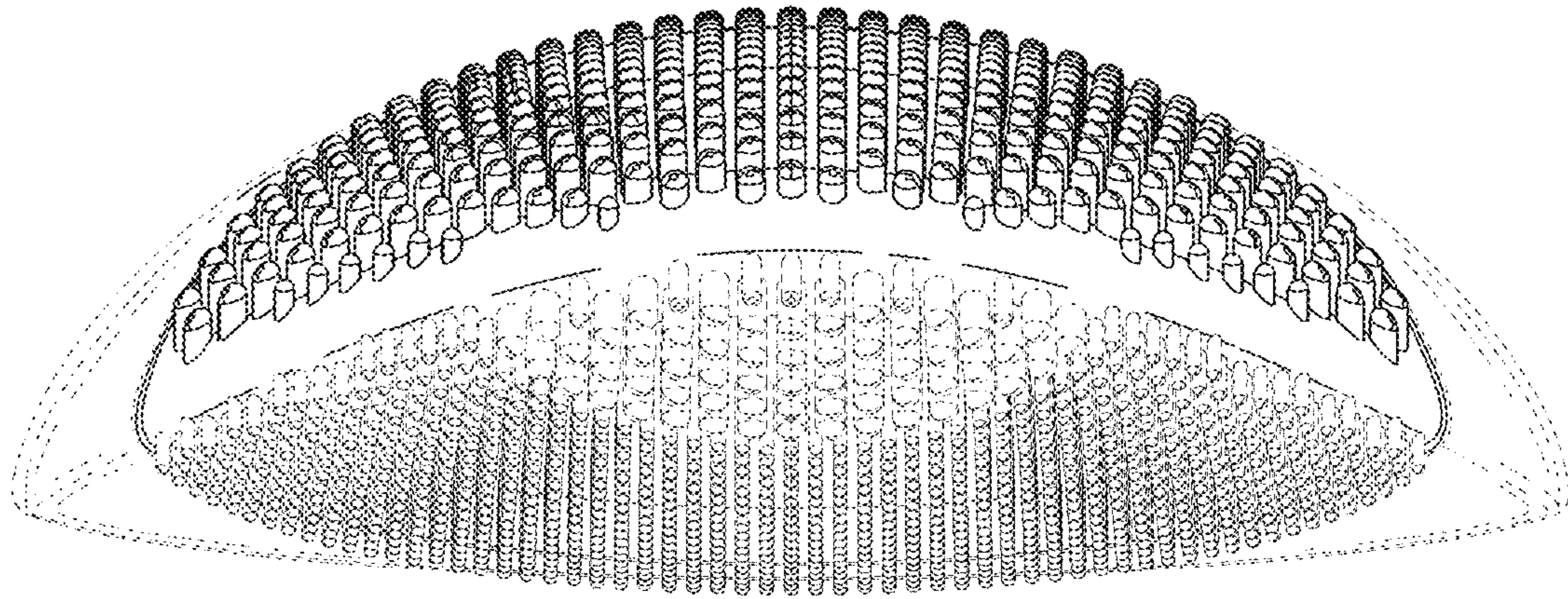

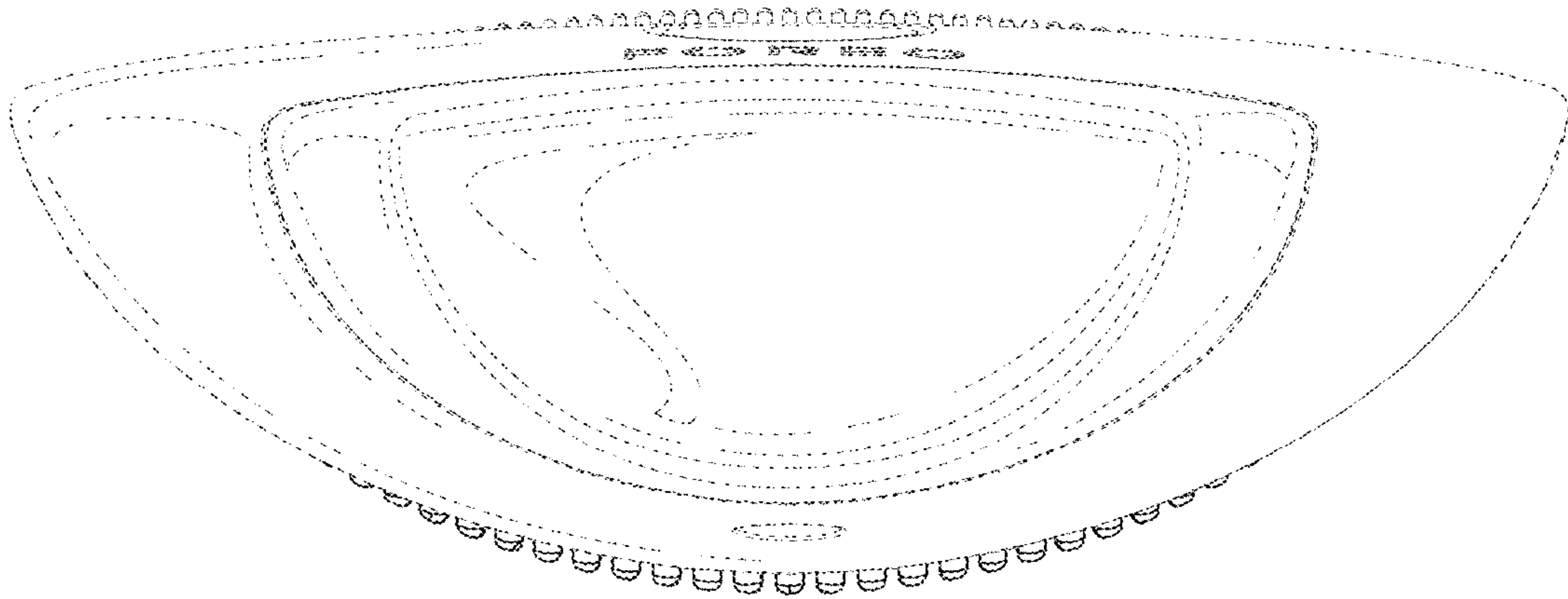

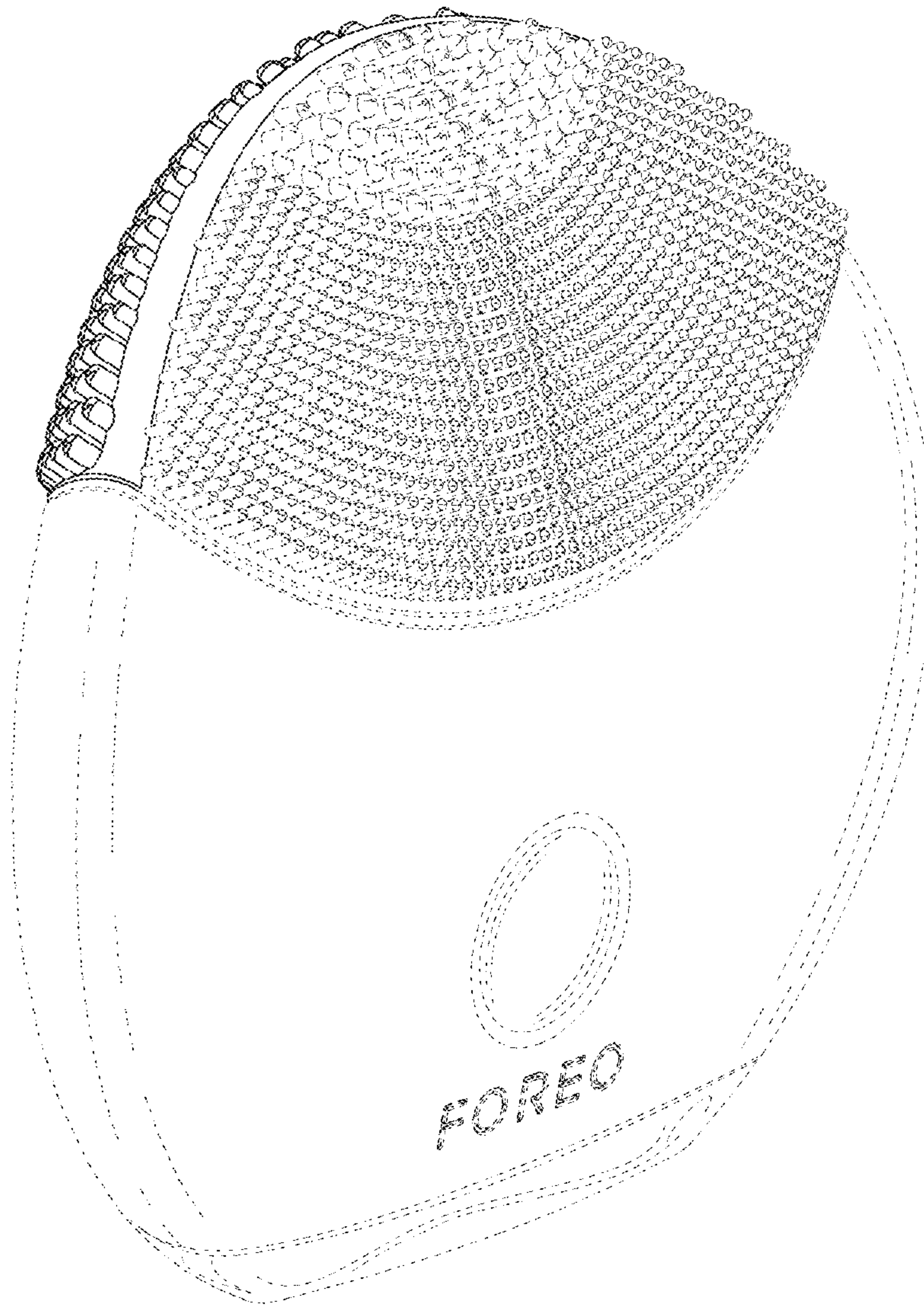
