DESCRIPTION

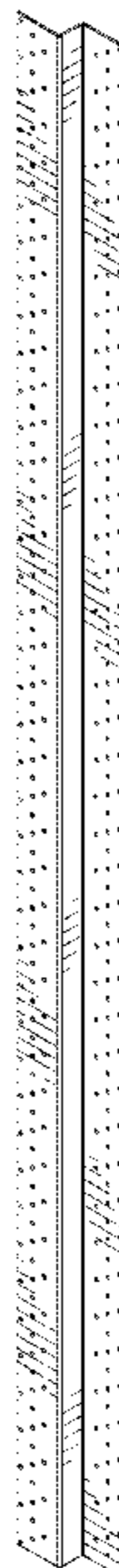
FIG. 1 is a perspective view of a fence post showing our new design.

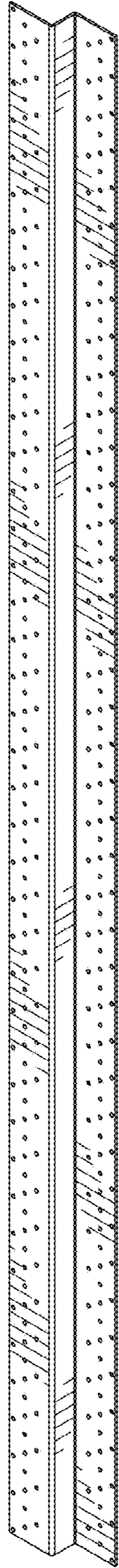

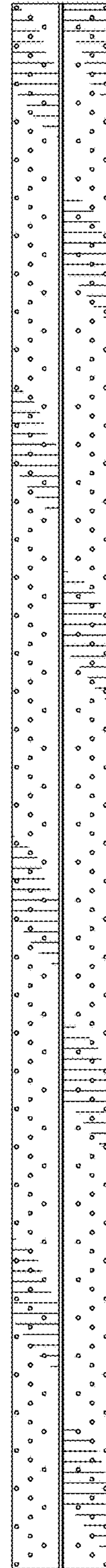

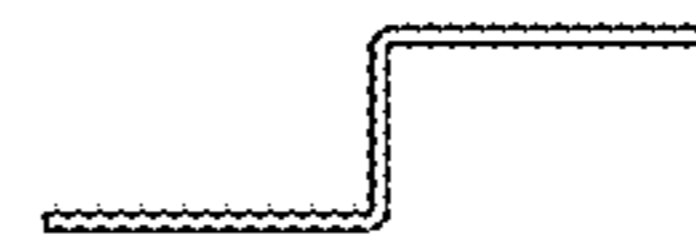
