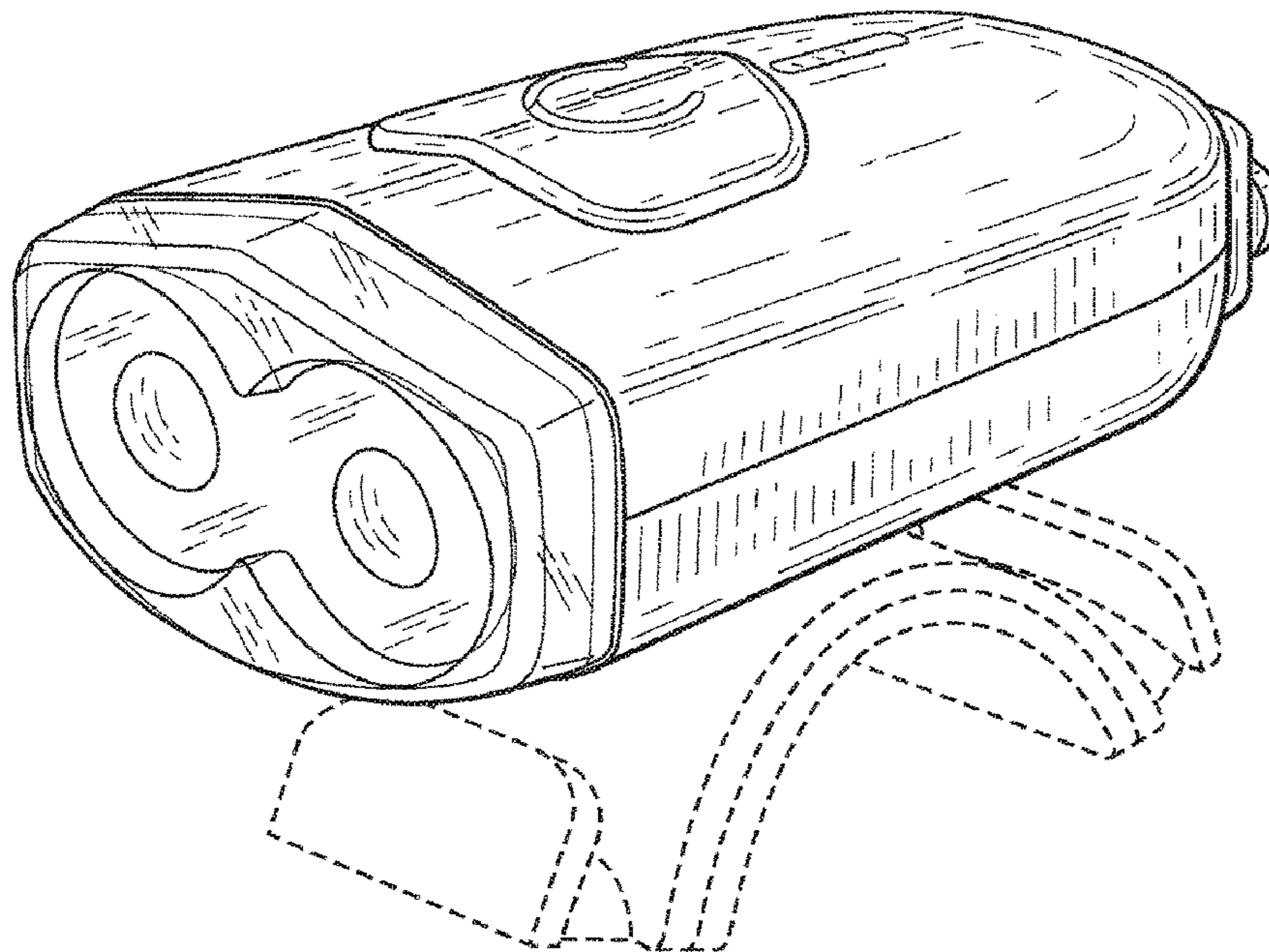
(57) **CLAIM**

The ornamental design for a bicycle headlight, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a light in accordance with the new design;  
FIG. 2 is front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan elevational view thereof;  
FIG. 7 is a bottom plan elevational view thereof; and,  
FIG. 8 is a rear elevational view as shown in FIG. 3, showing an opened access port, which is shown closed in FIG. 3.

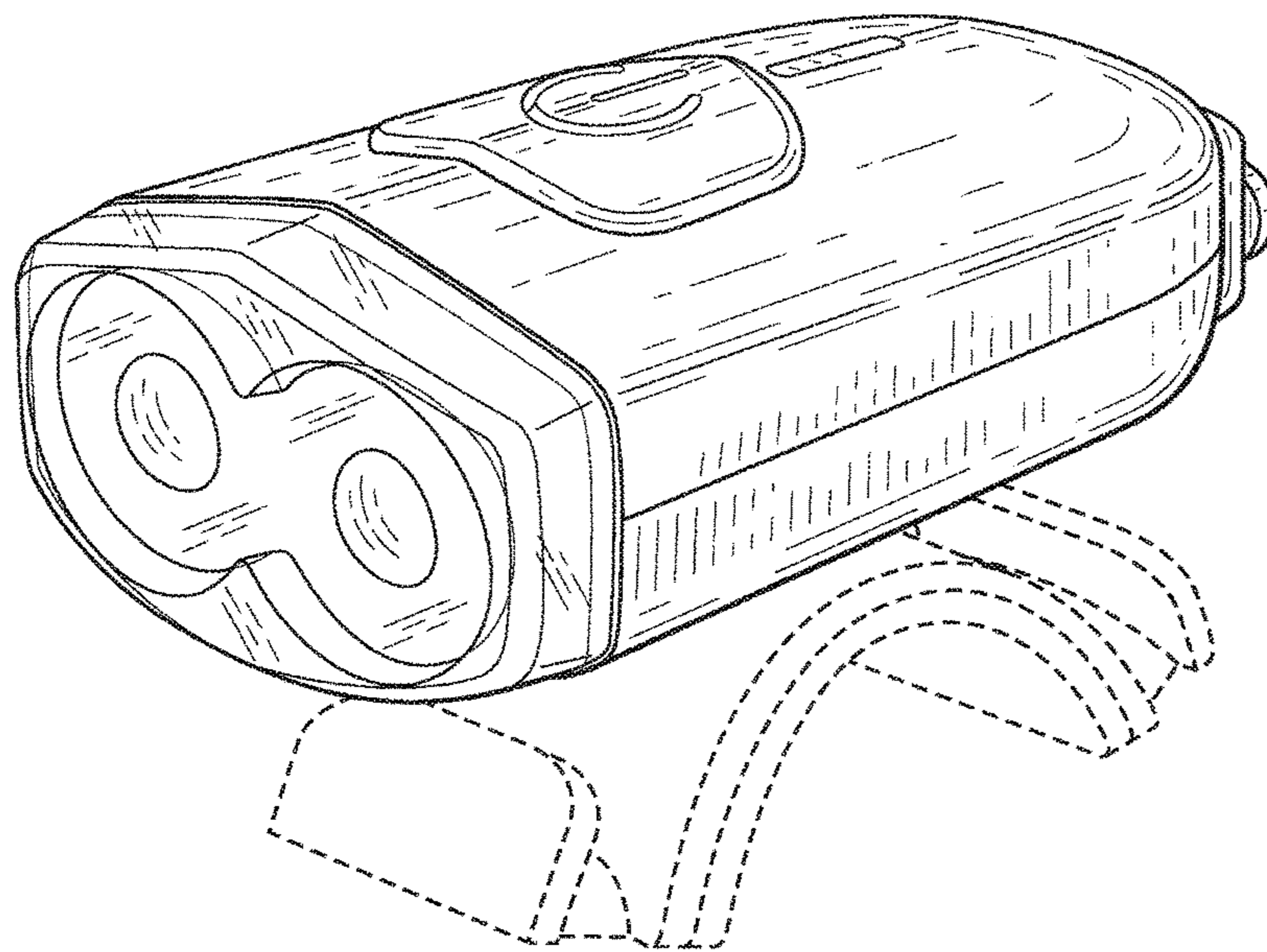

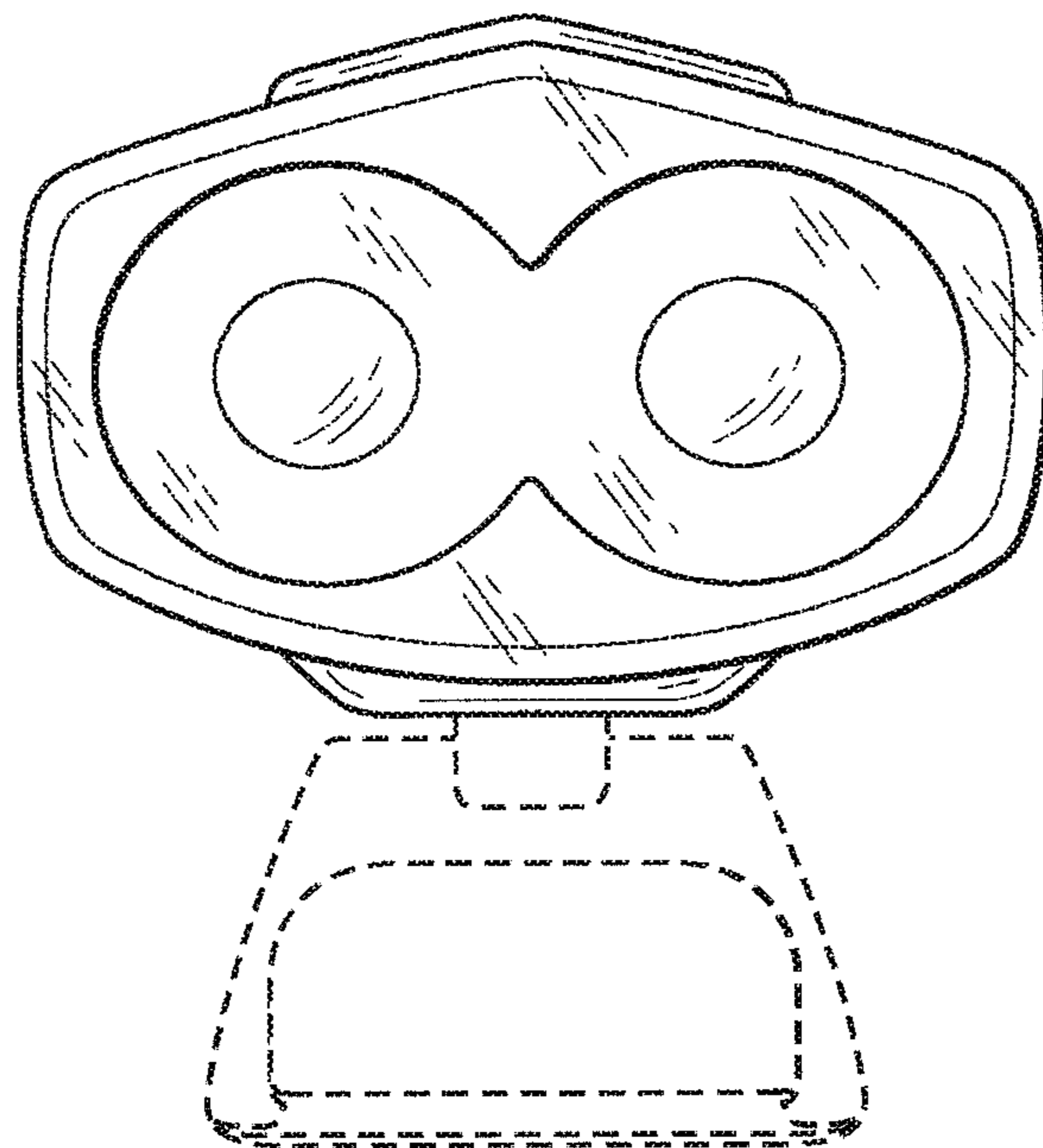

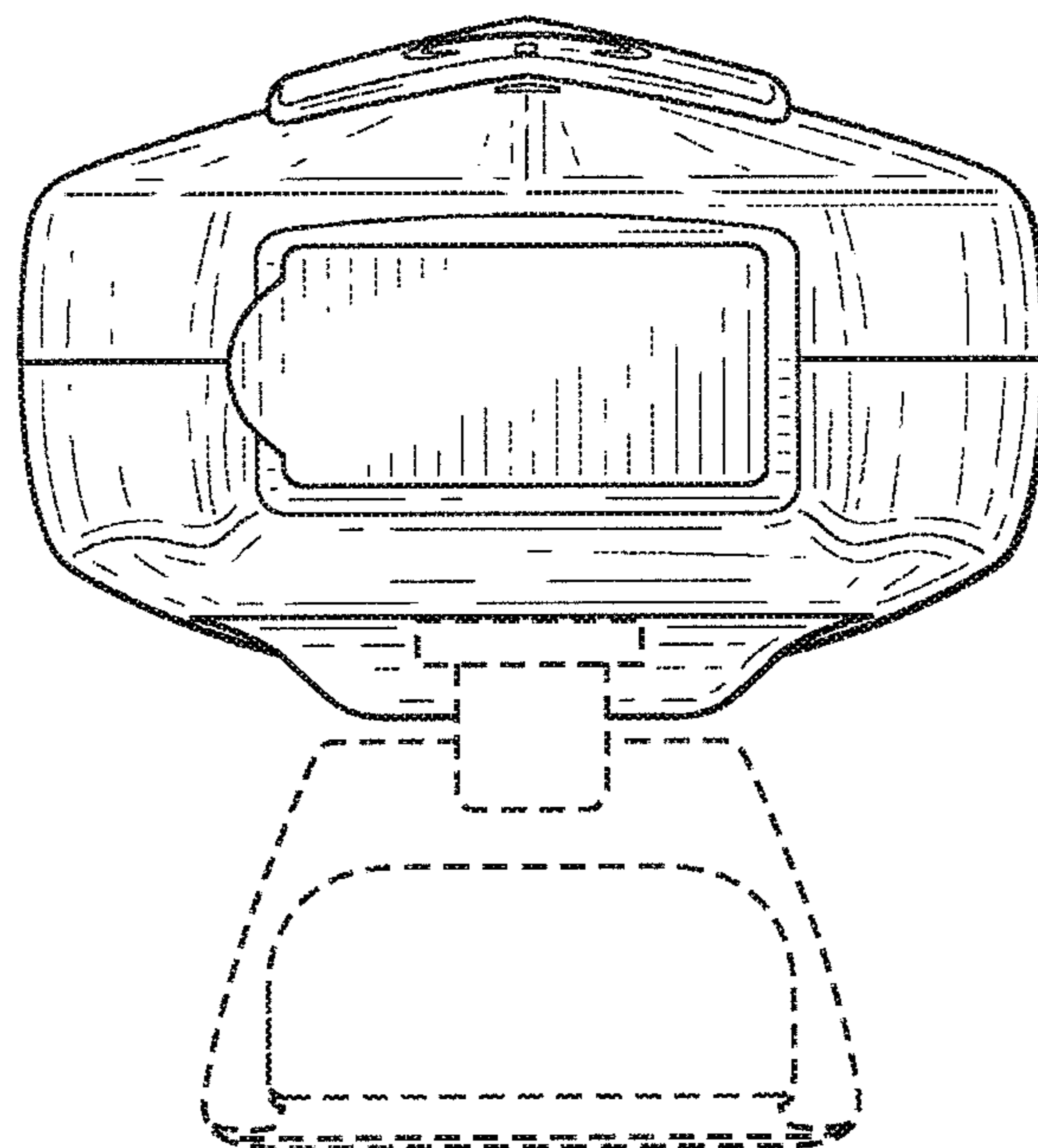

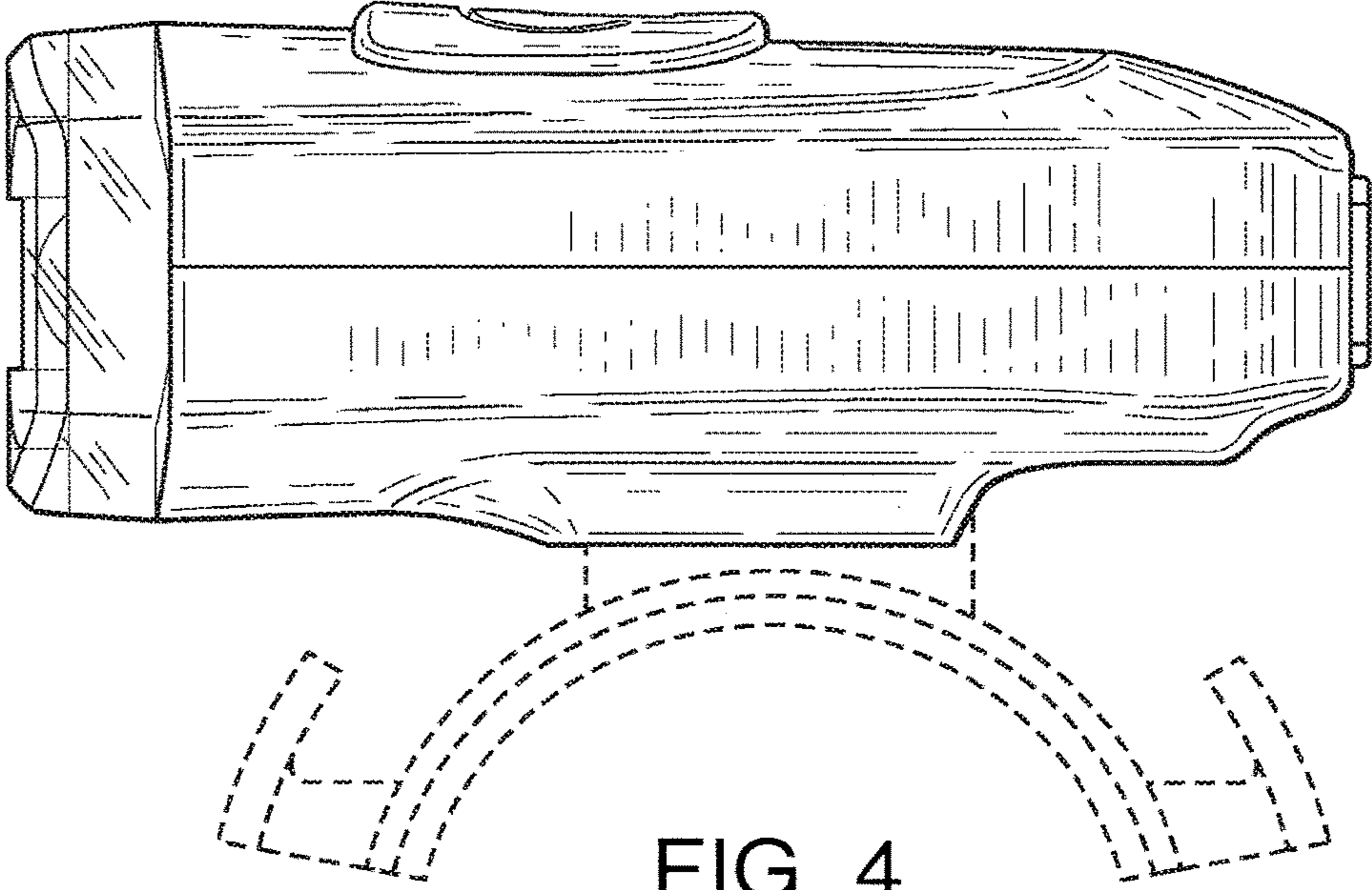

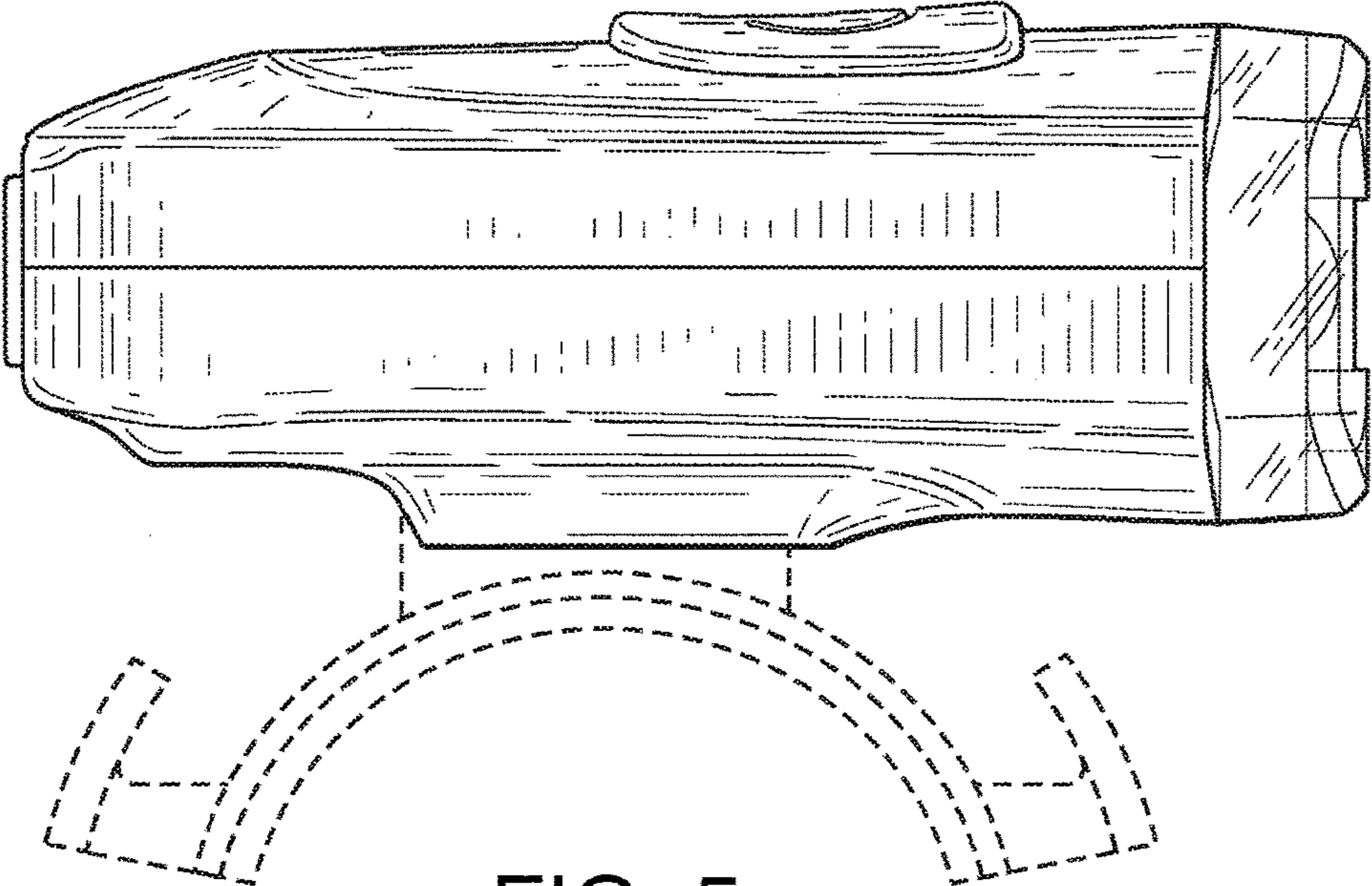

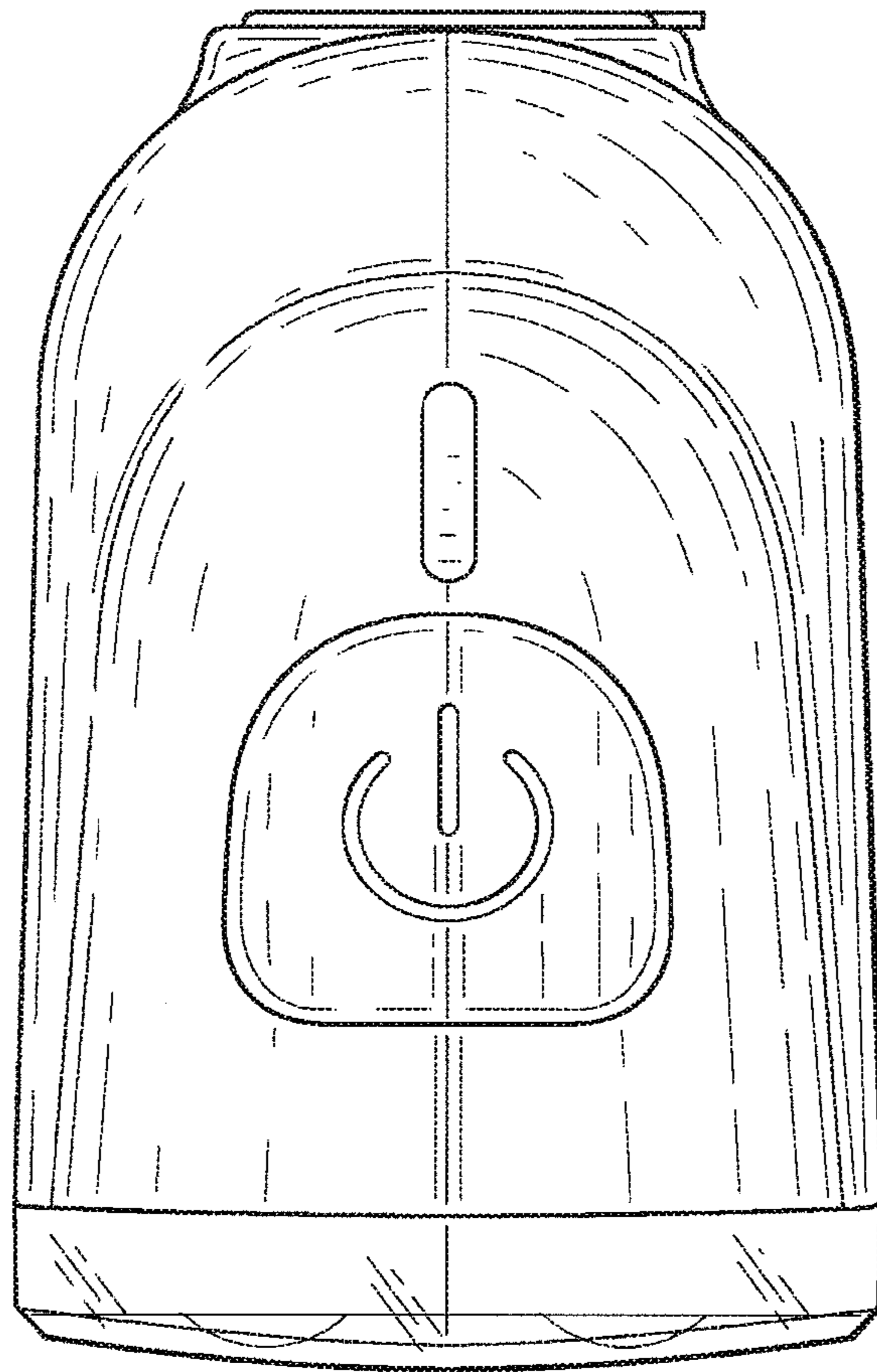

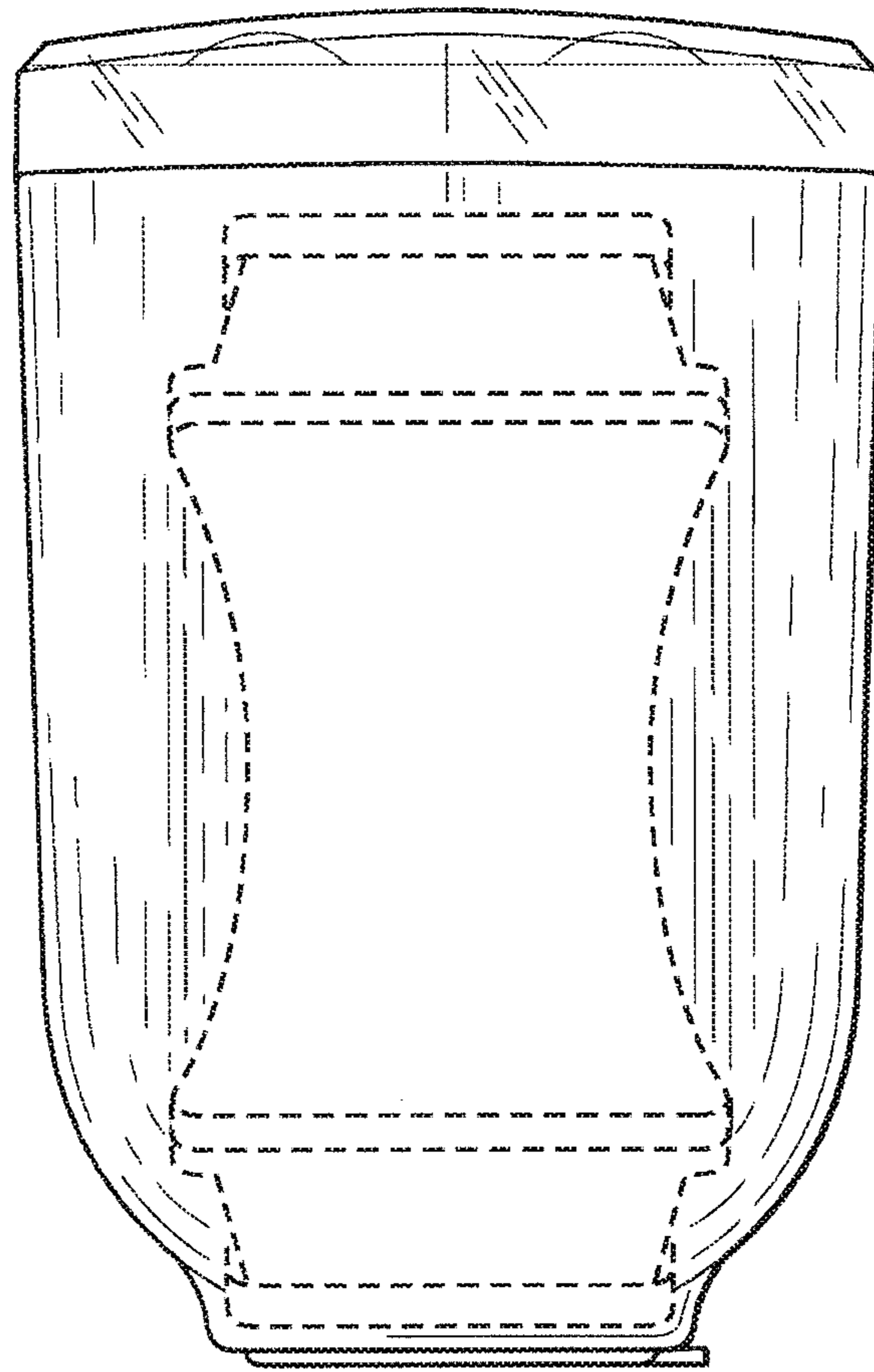

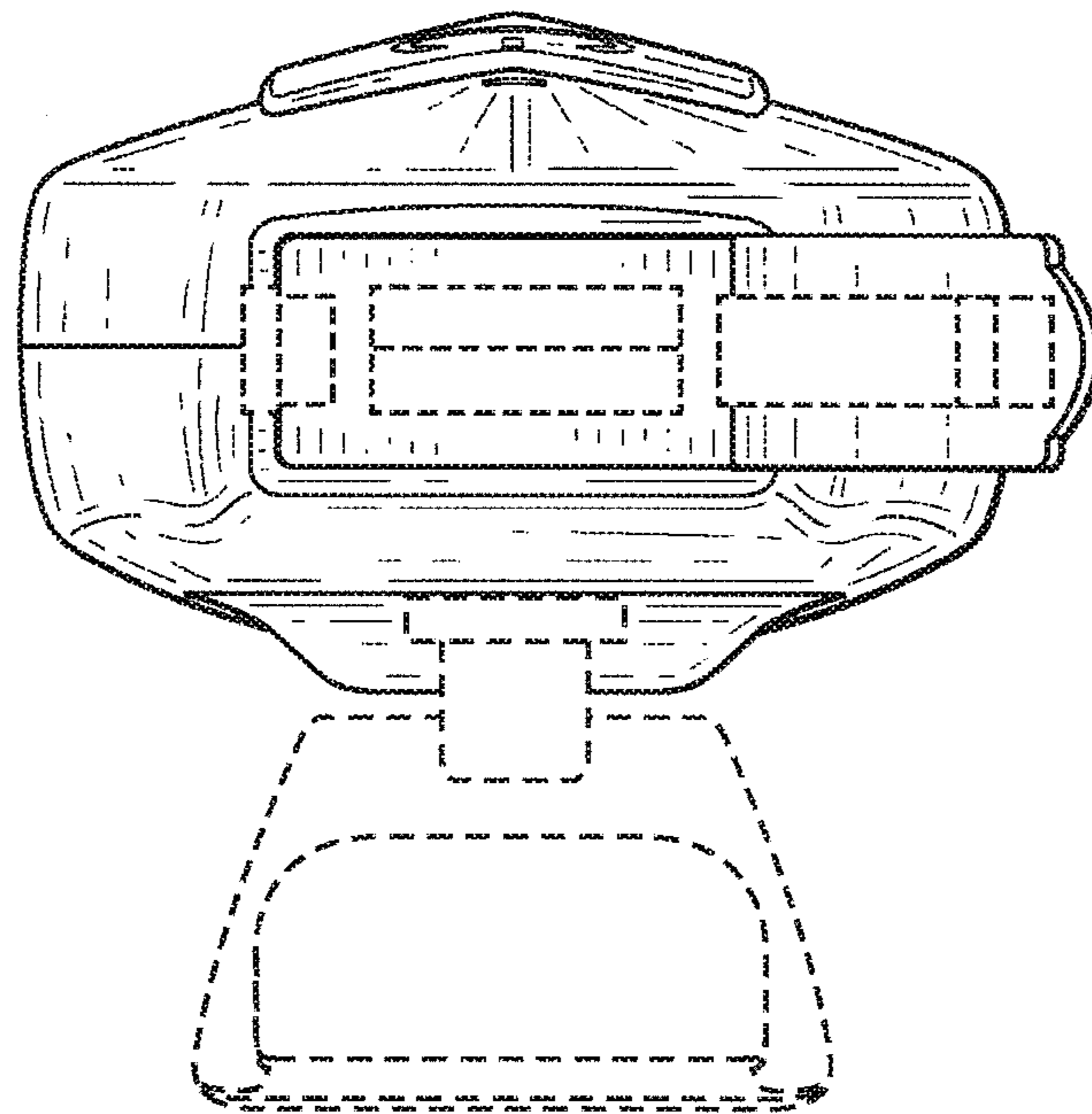
