(57) **CLAIM**

I claim the ornamental design for a front combination lamp for an automobile thereof, as shown and described.

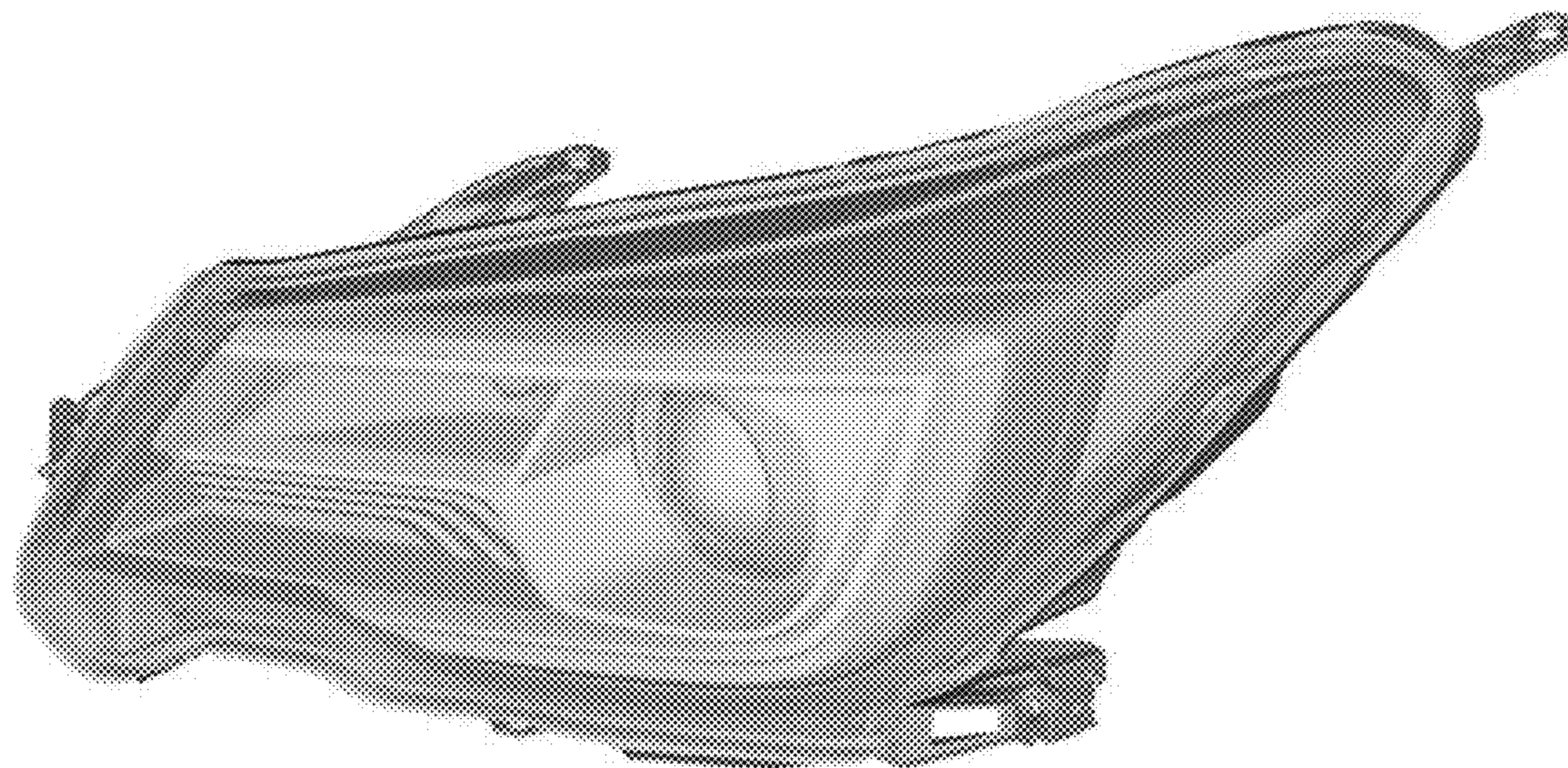

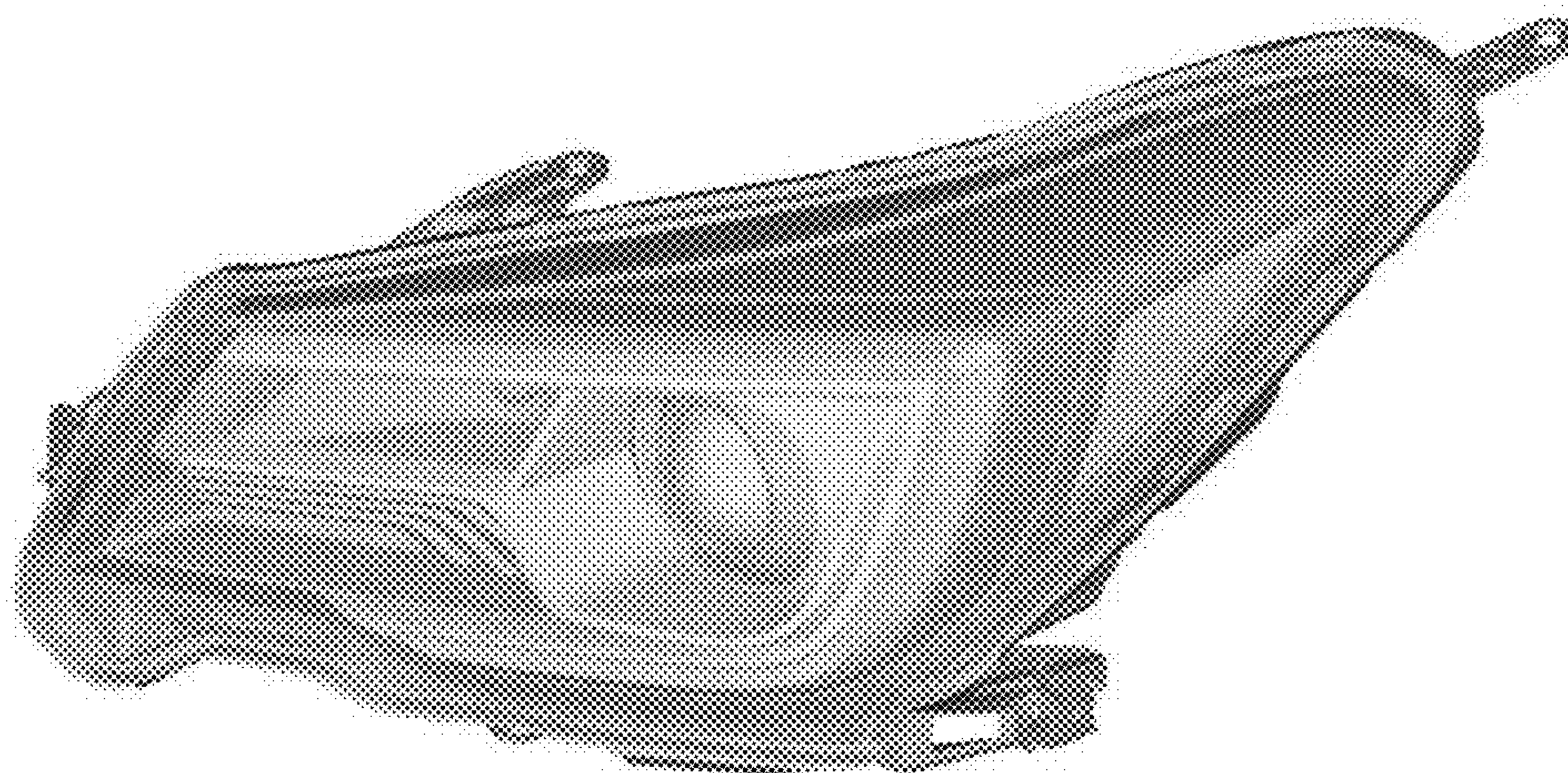

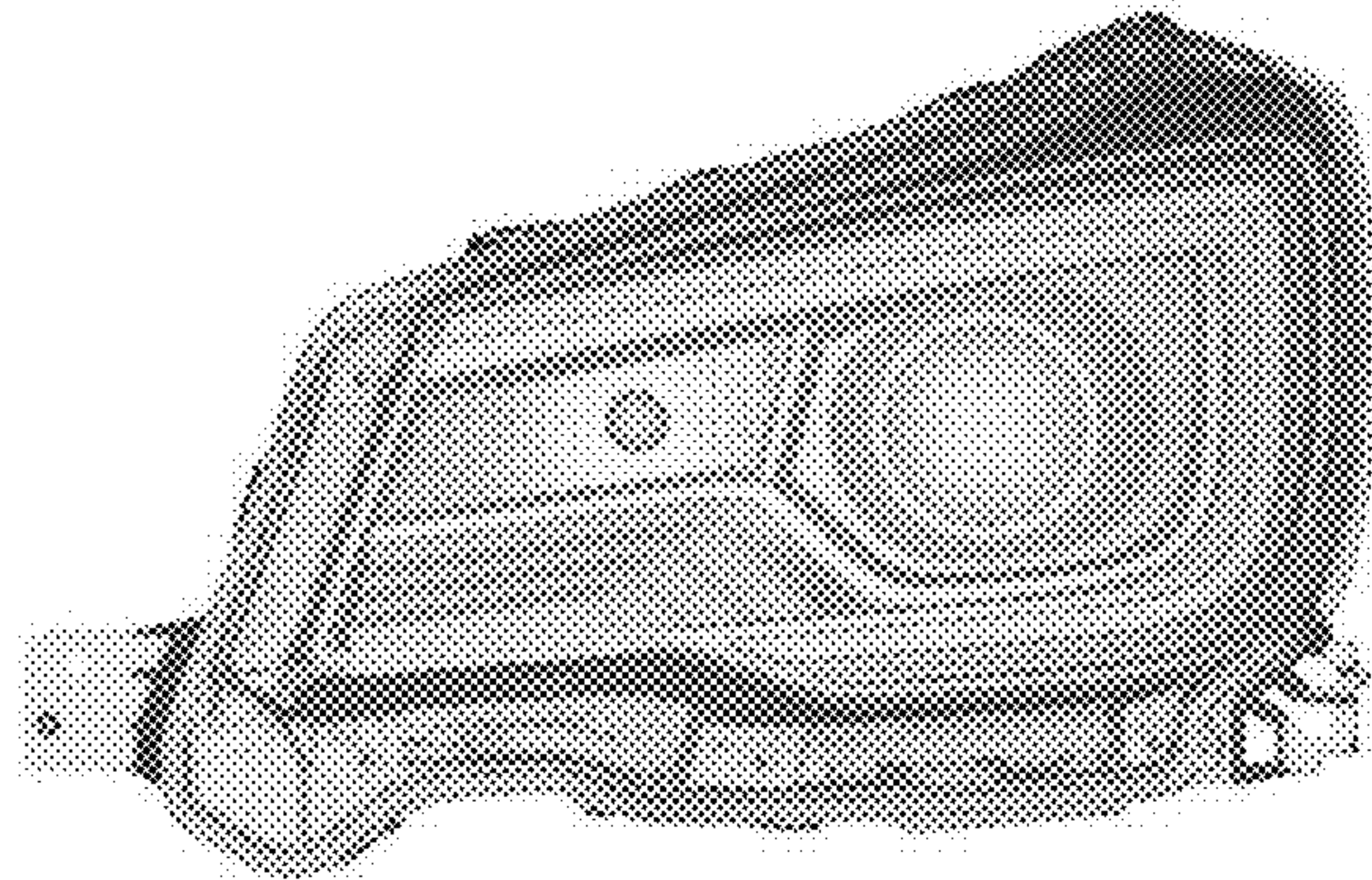

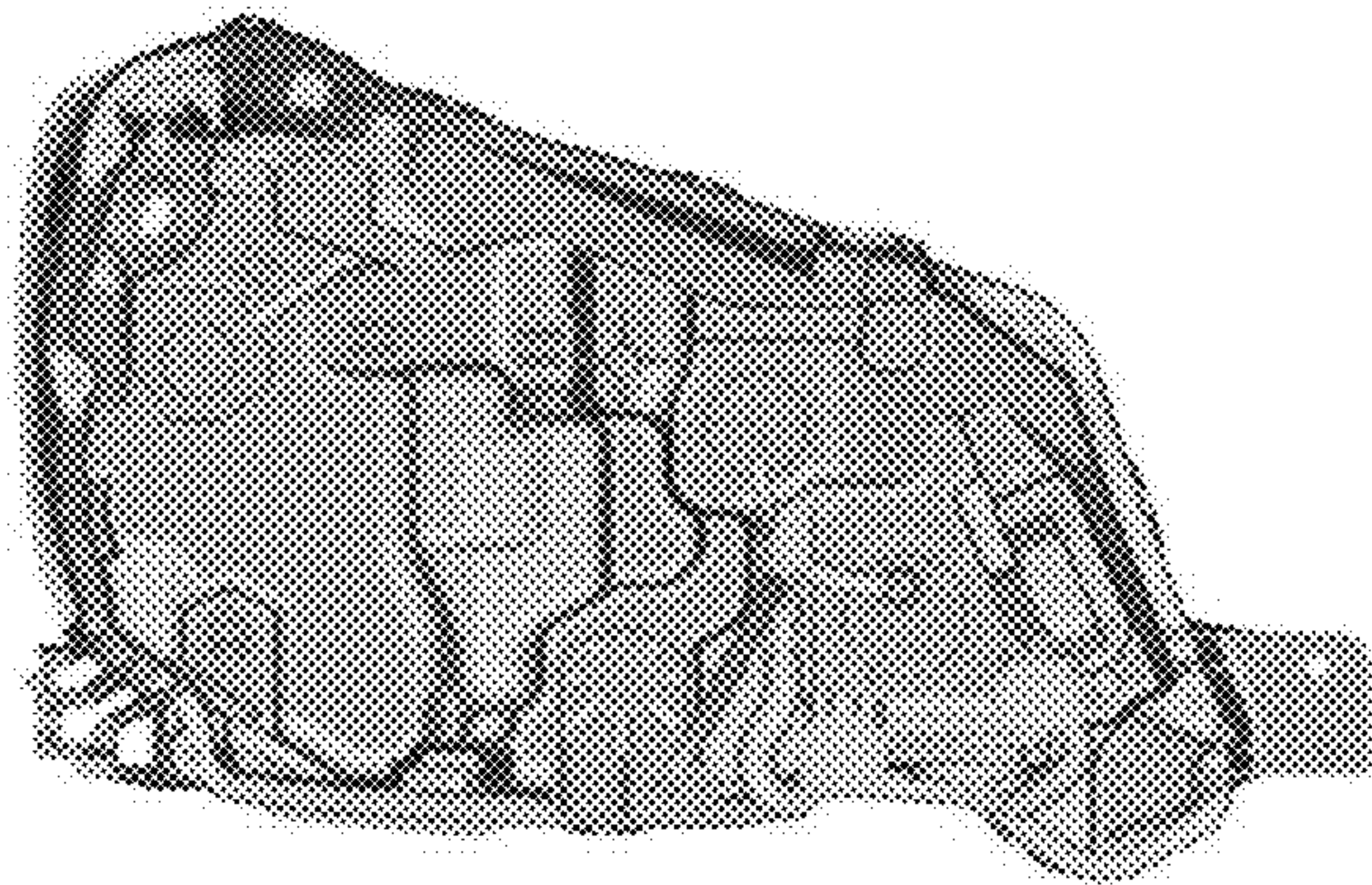

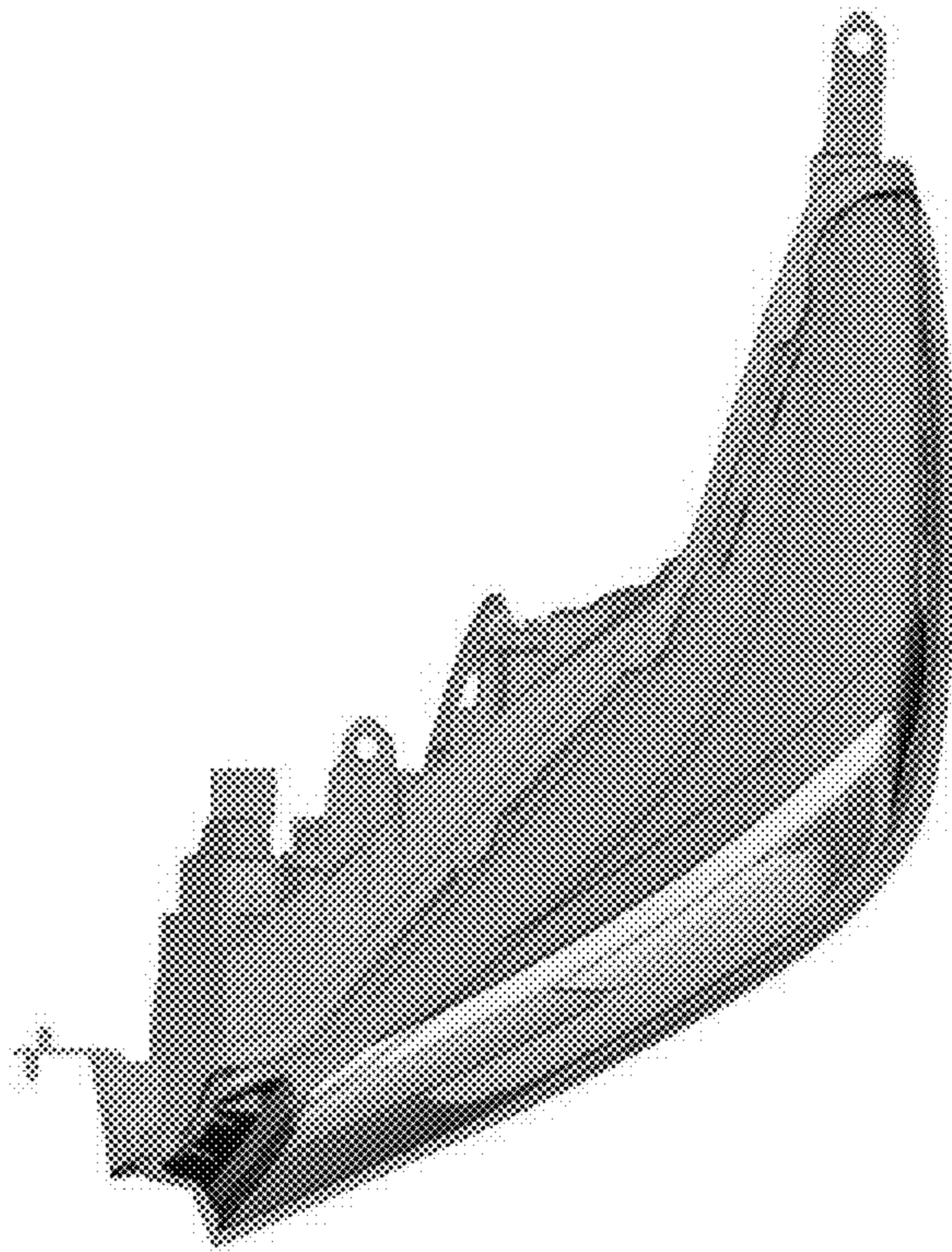

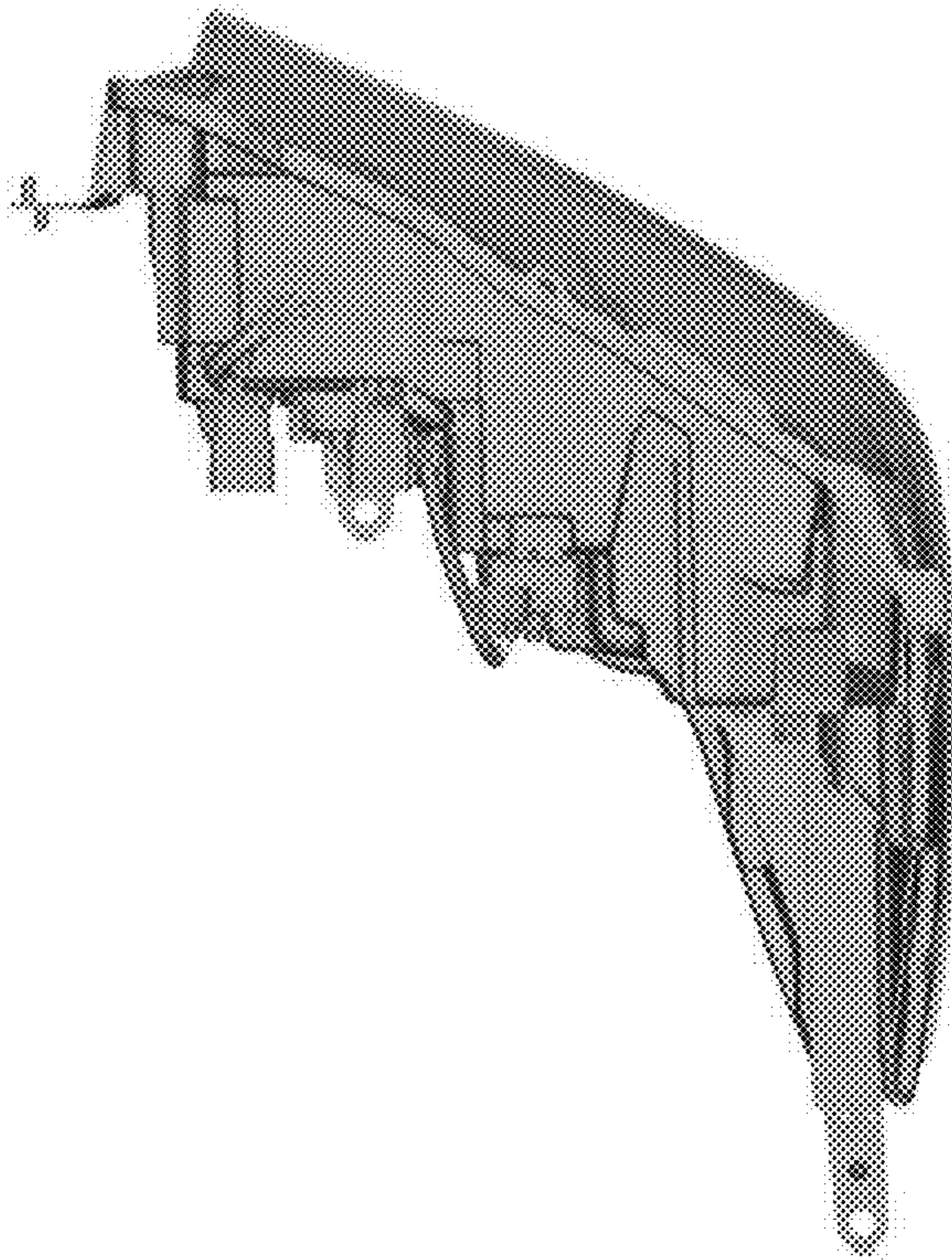

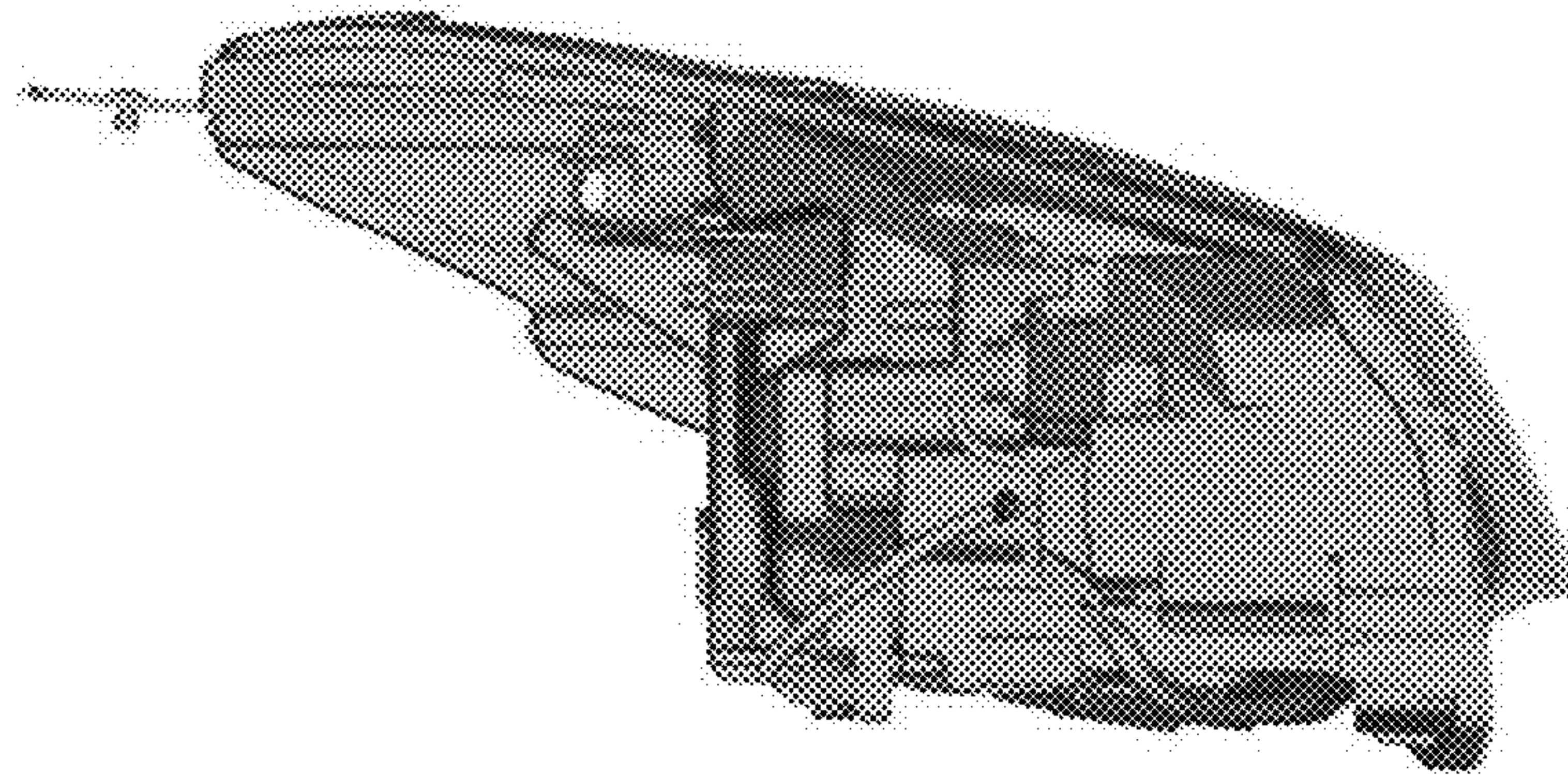

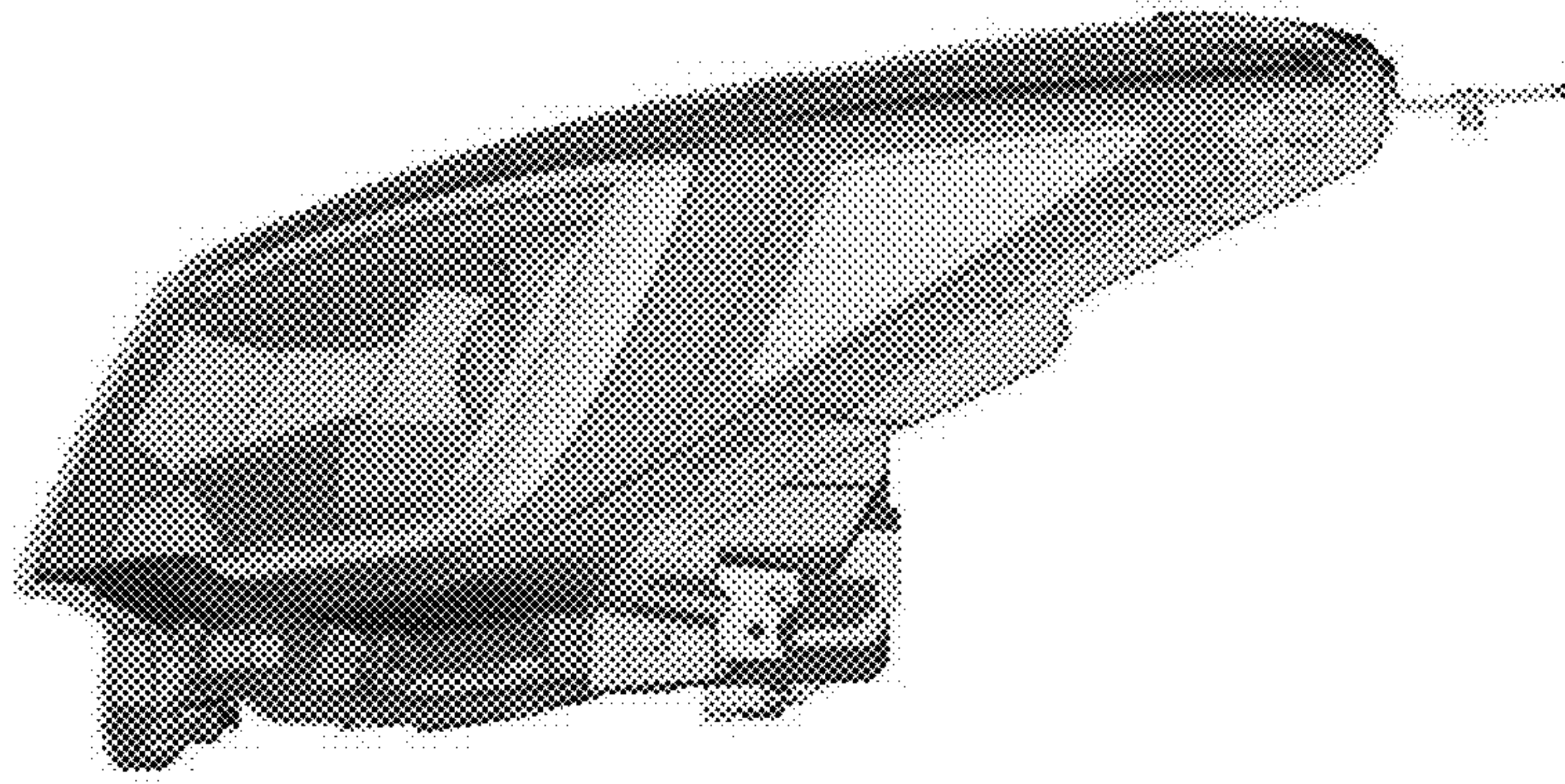
