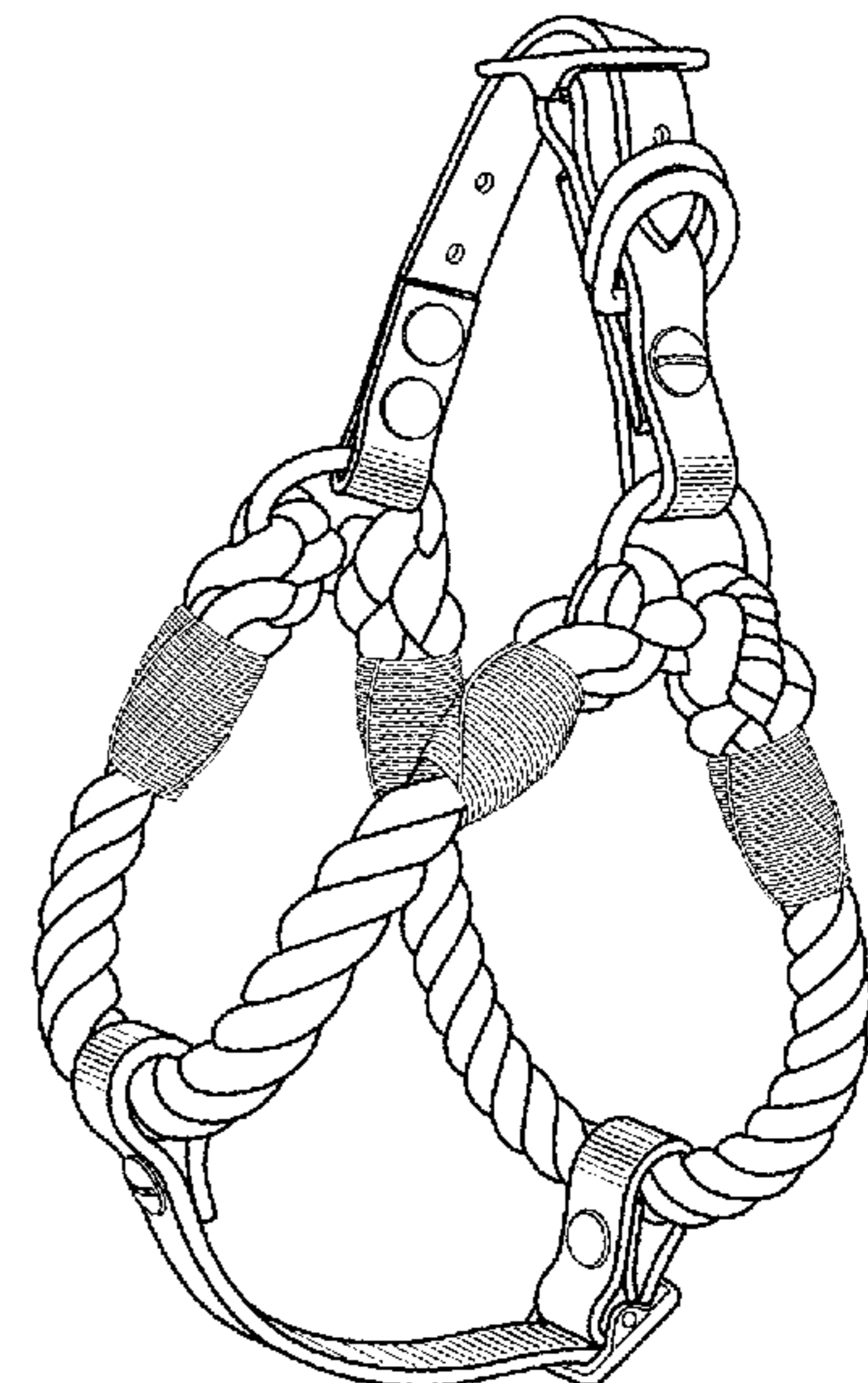
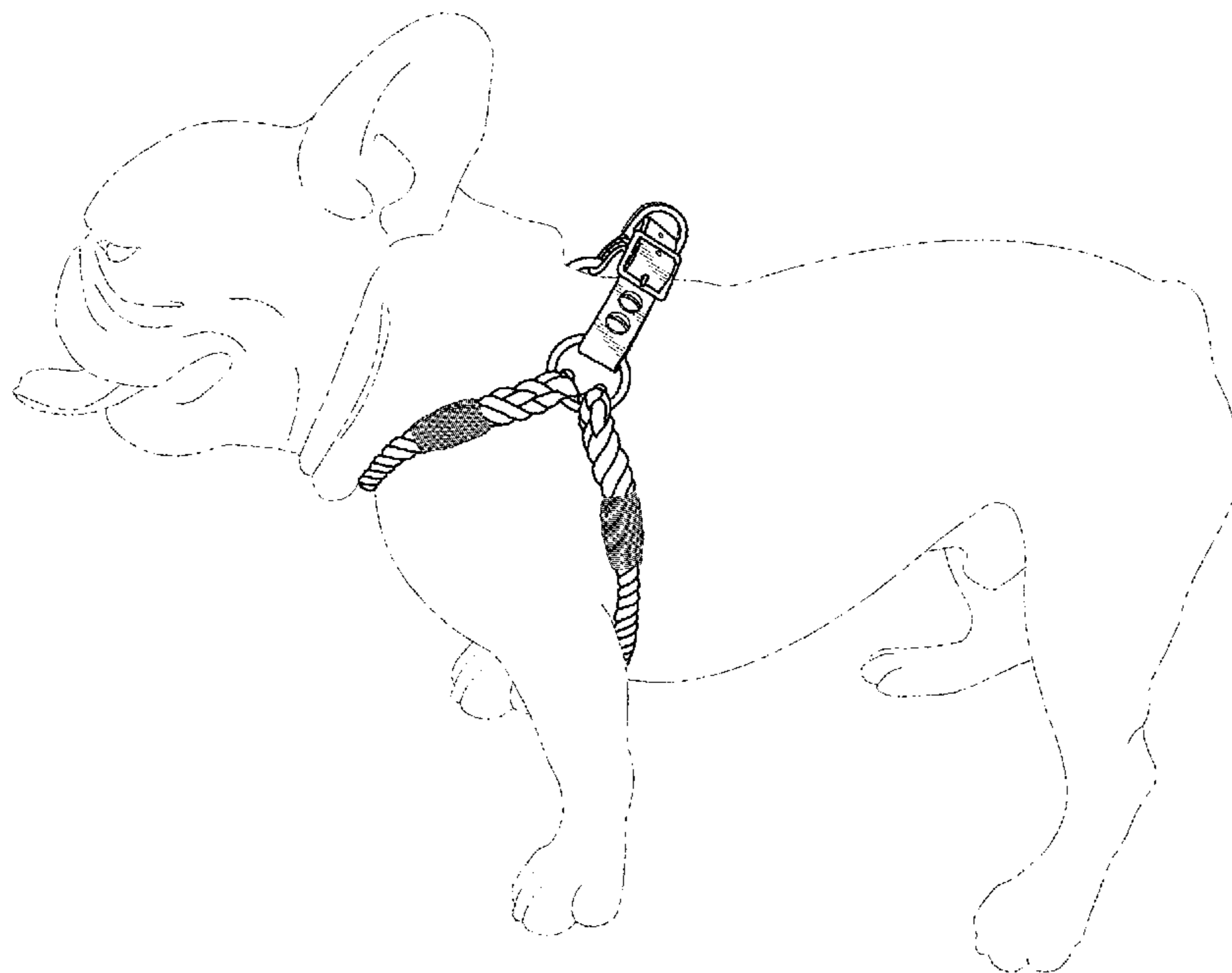
(57) **CLAIM**

The ornamental design for a pet harness, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a pet harness showing our new design in use on a pet; FIG. 2 is a top plan view of the pet harness of FIG. 1; FIG. 3 is a bottom view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a front-left perspective view thereof; and, FIG. 7 is a top-right perspective view thereof. The broken lines showing a pet in FIG. 1 are included for the purpose of illustrating environment and form no part of the claimed design.

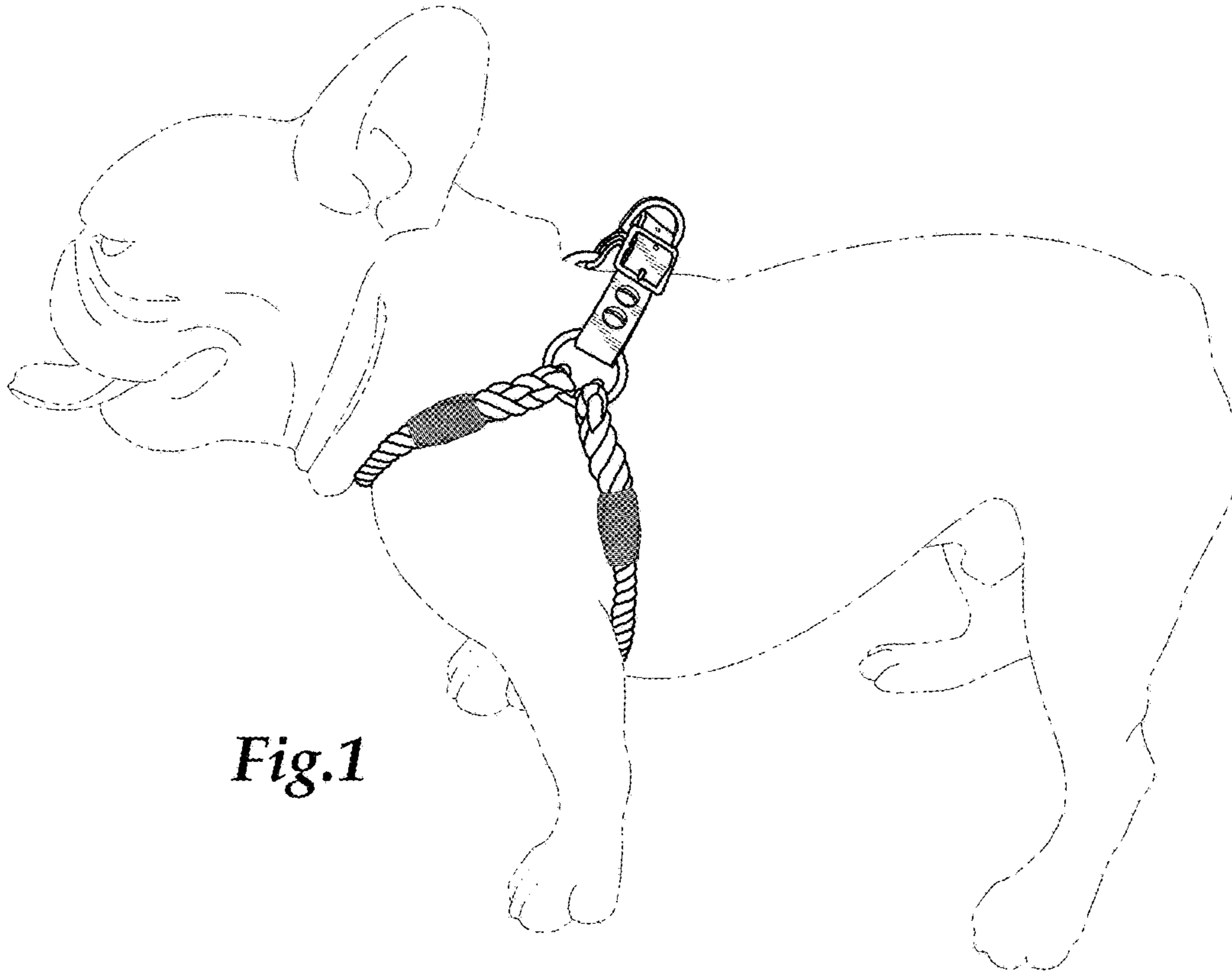

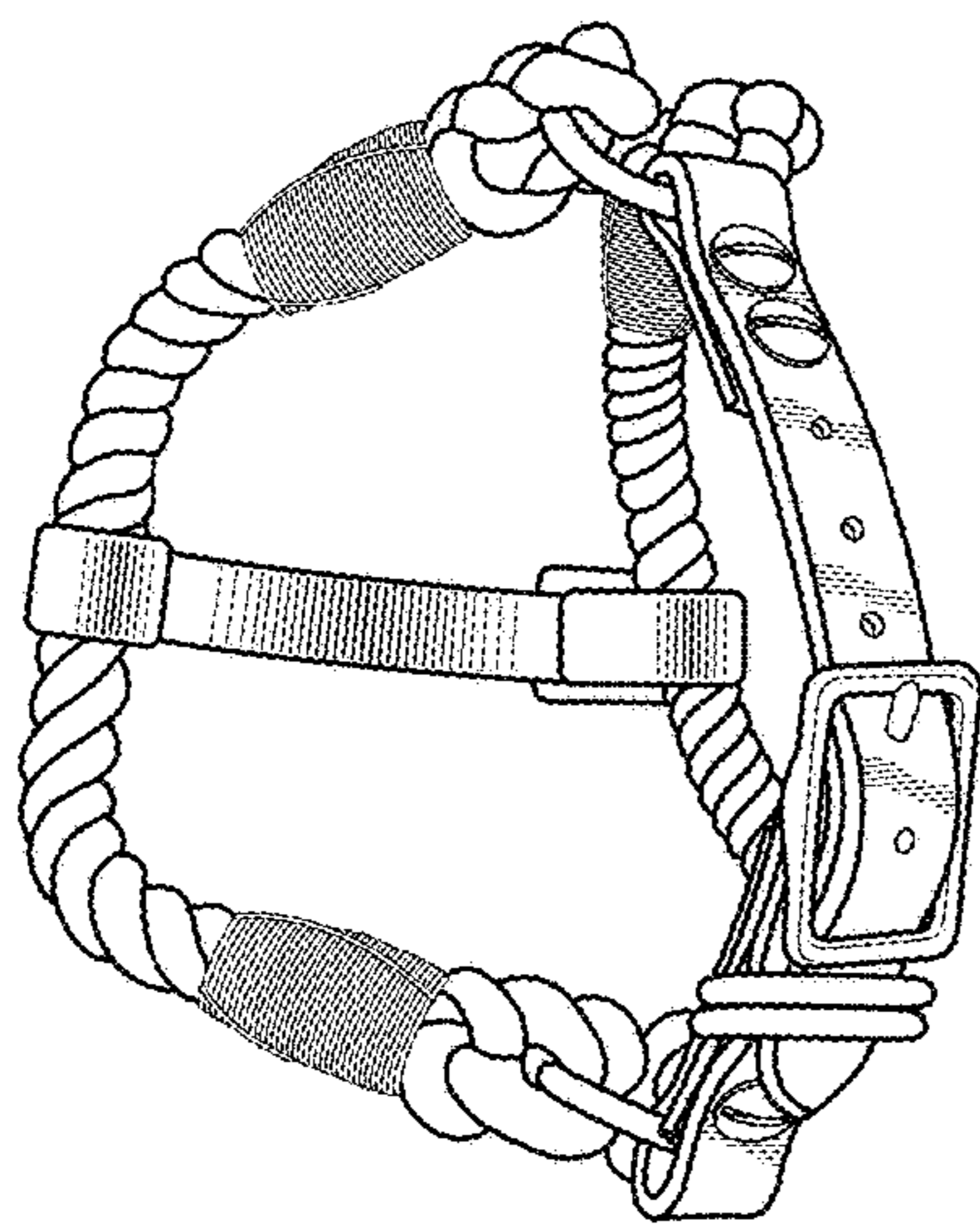

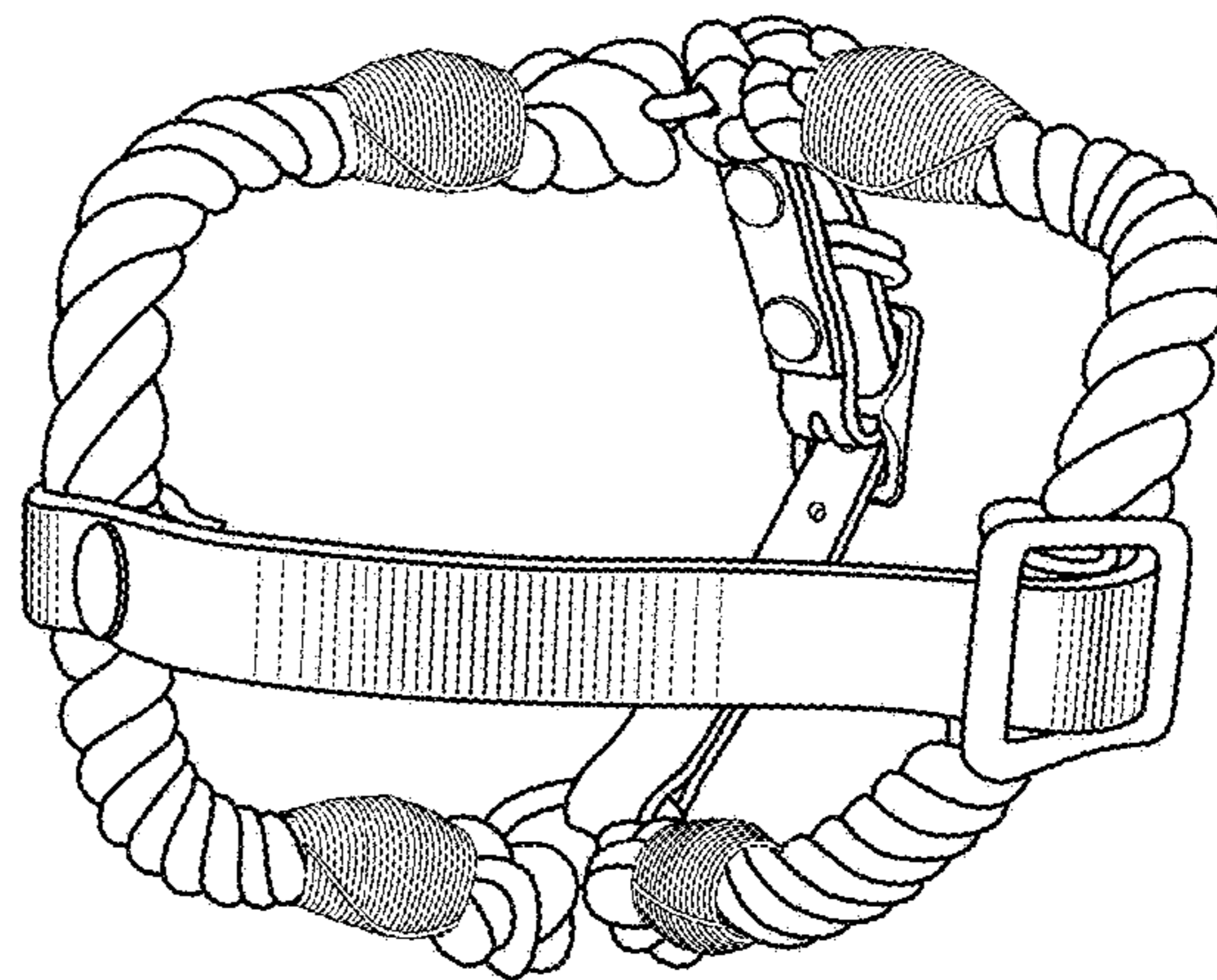

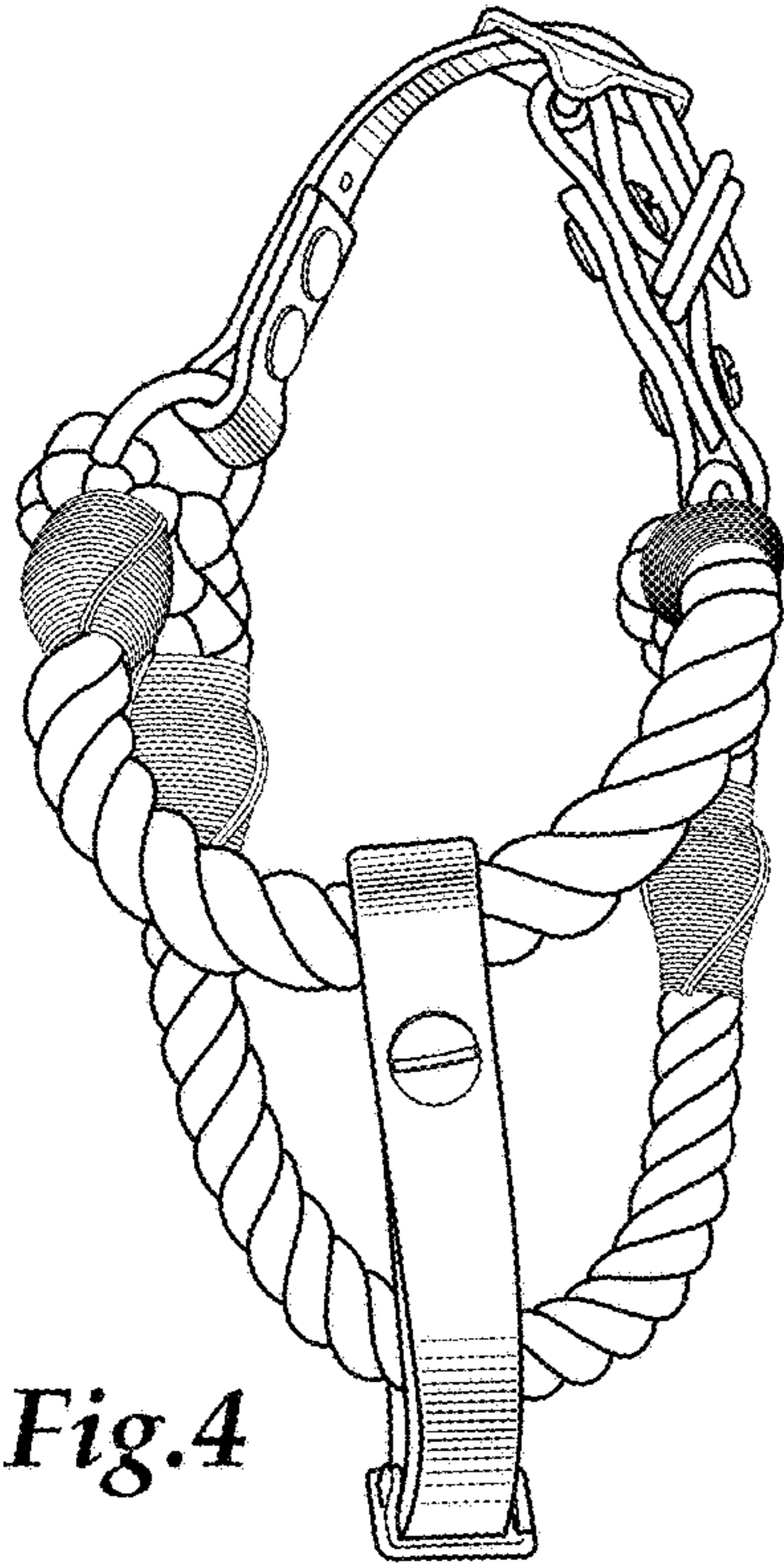

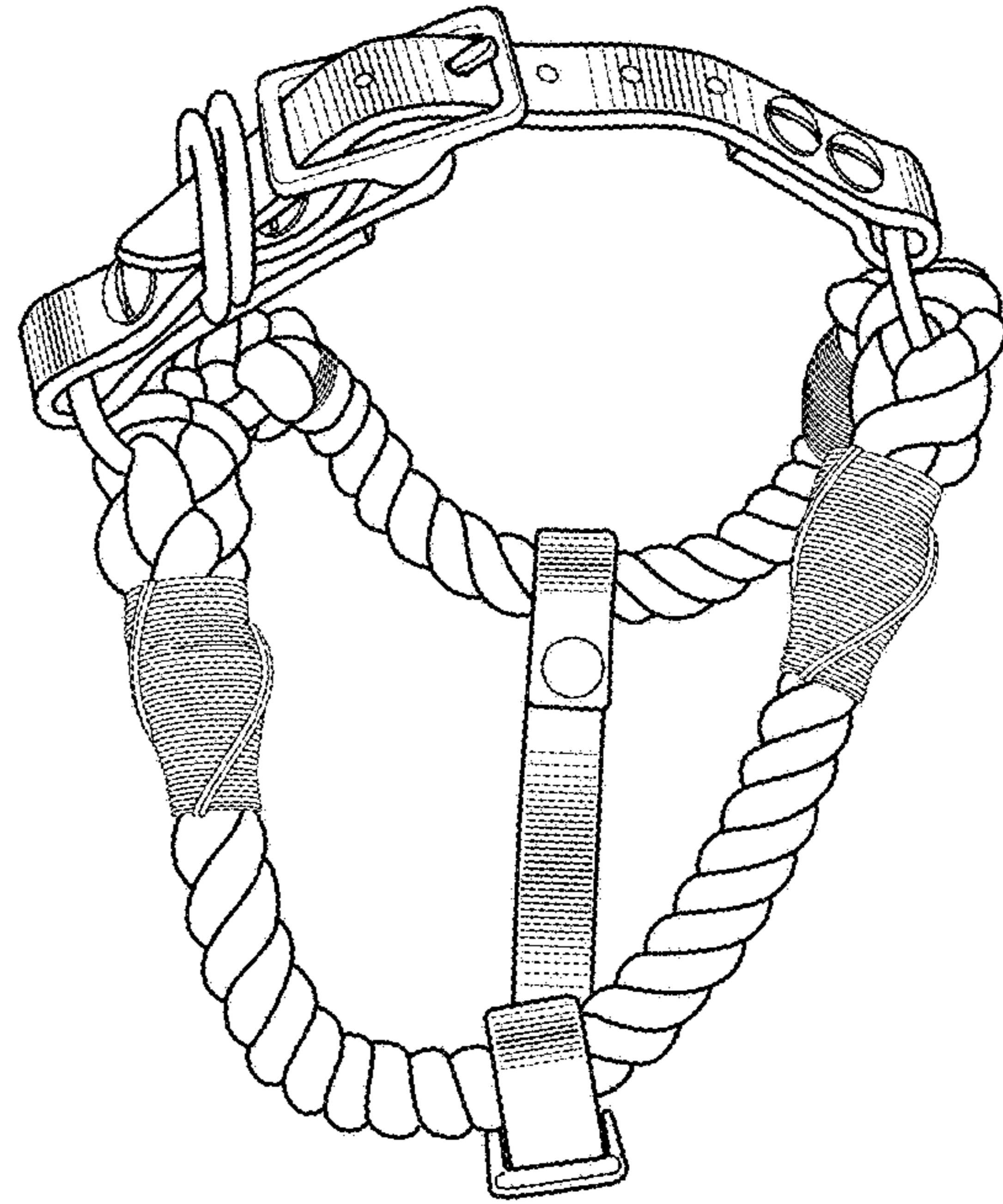

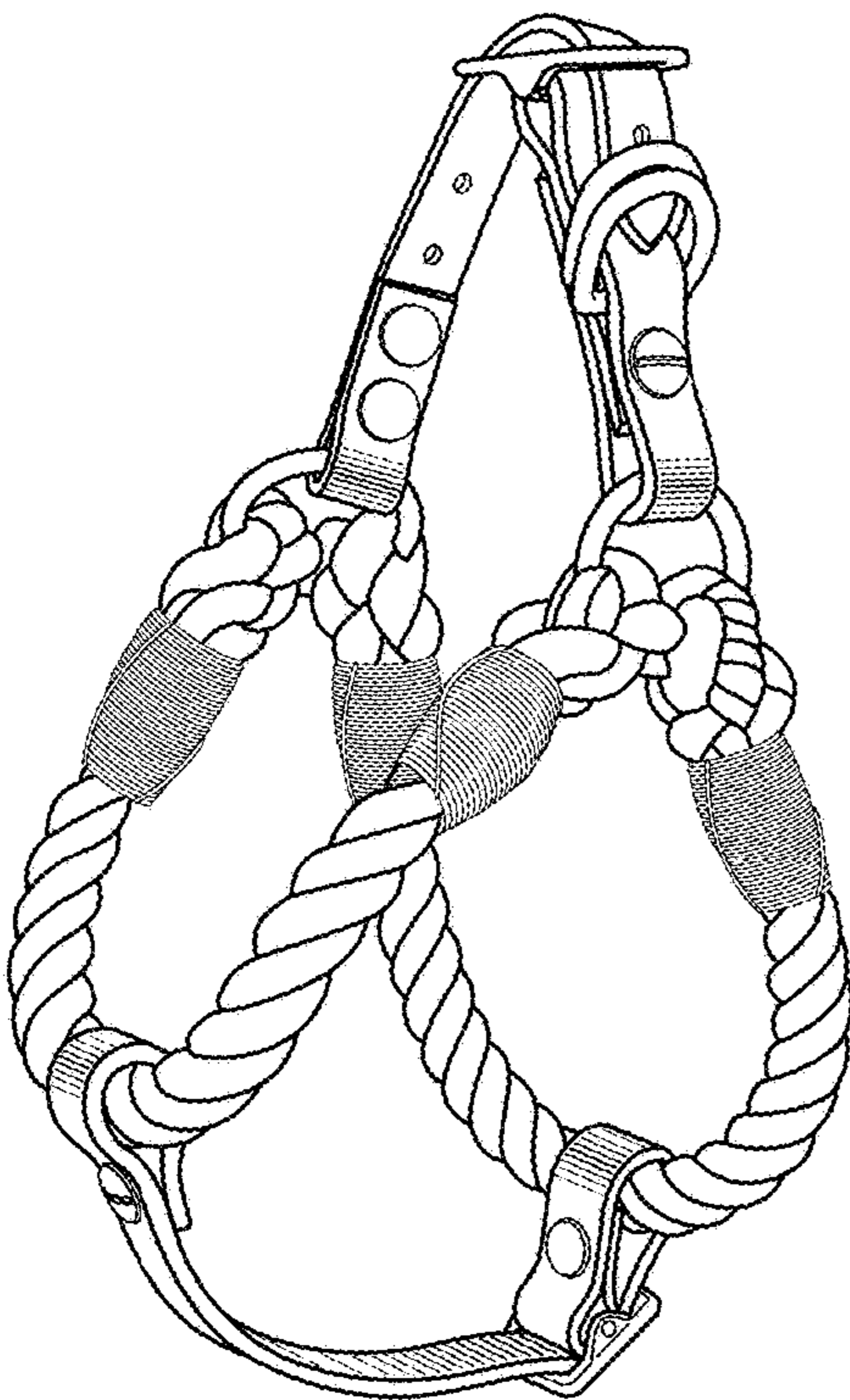

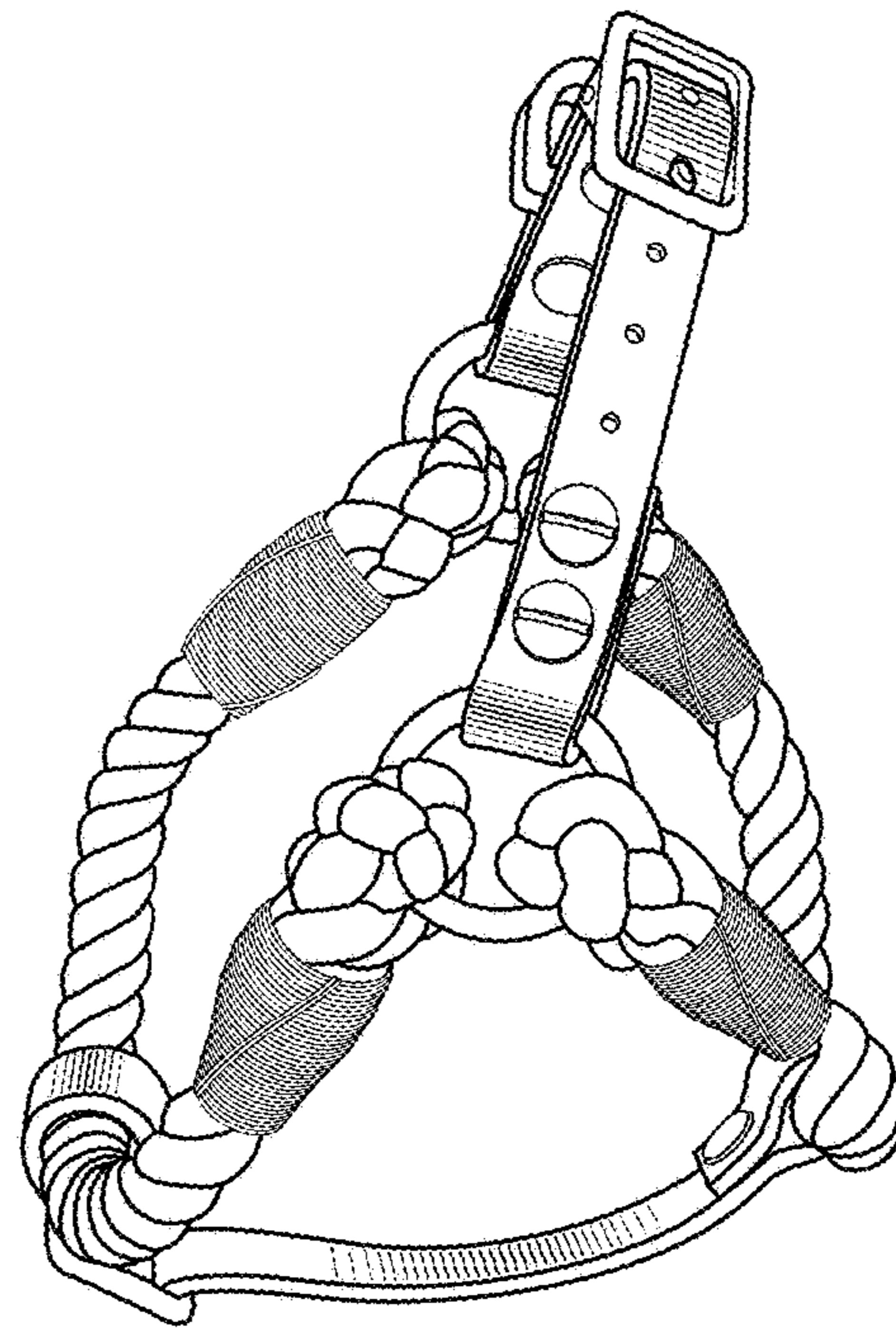
