(57) **CLAIM**

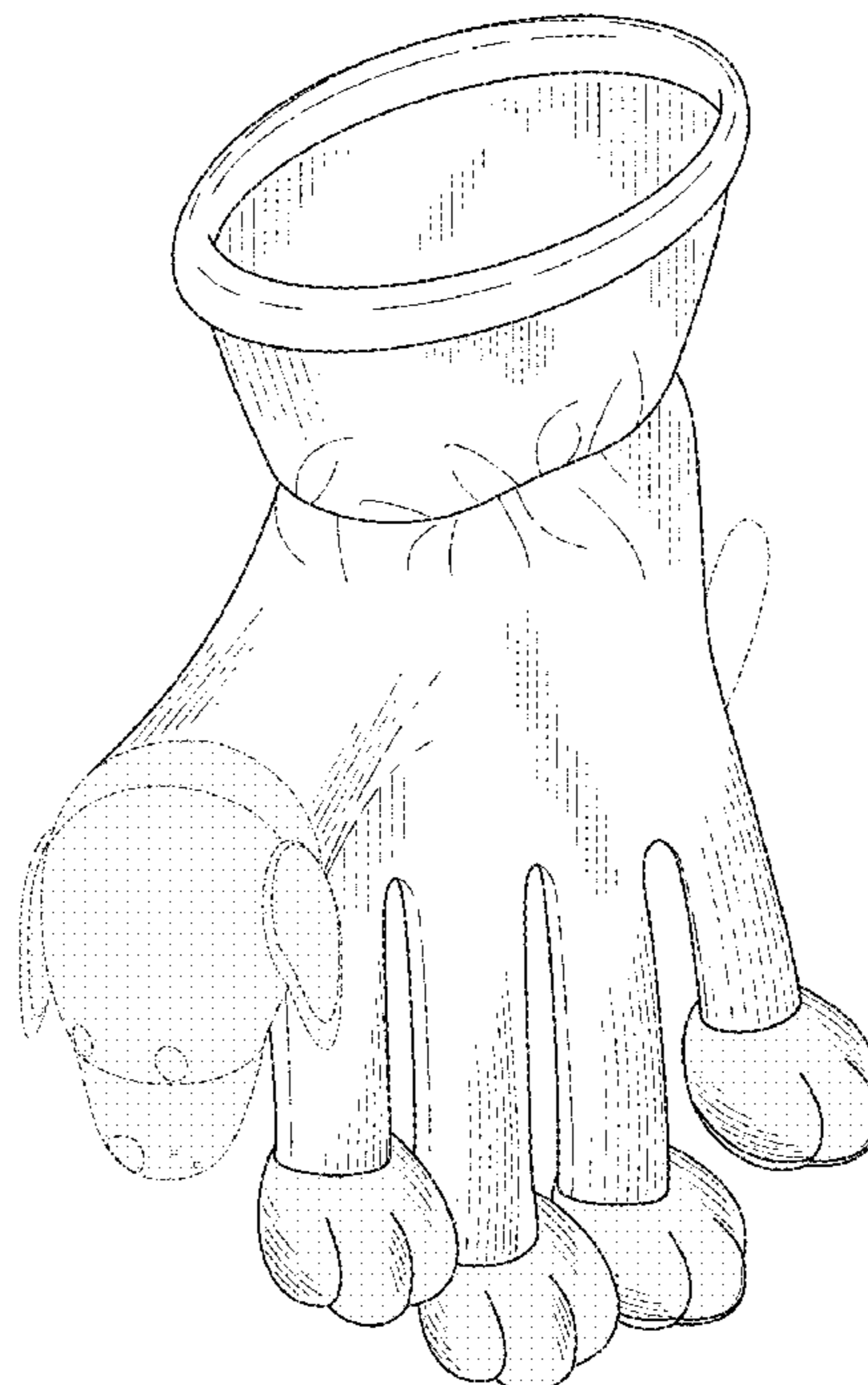
I claim the ornamental design for a glove with paws, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a glove with paws, showing my new design;
FIG. 2 is a right-side elevational view thereof;
FIG. 3 is a left-side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The dot-dash broken lines showing a plush animal head and tail in the figures depict portions of the glove that form no part of the claimed design. The remaining broken lines on FIGS. 3, 4 and 7 represent stitching, and are part of the claimed design.

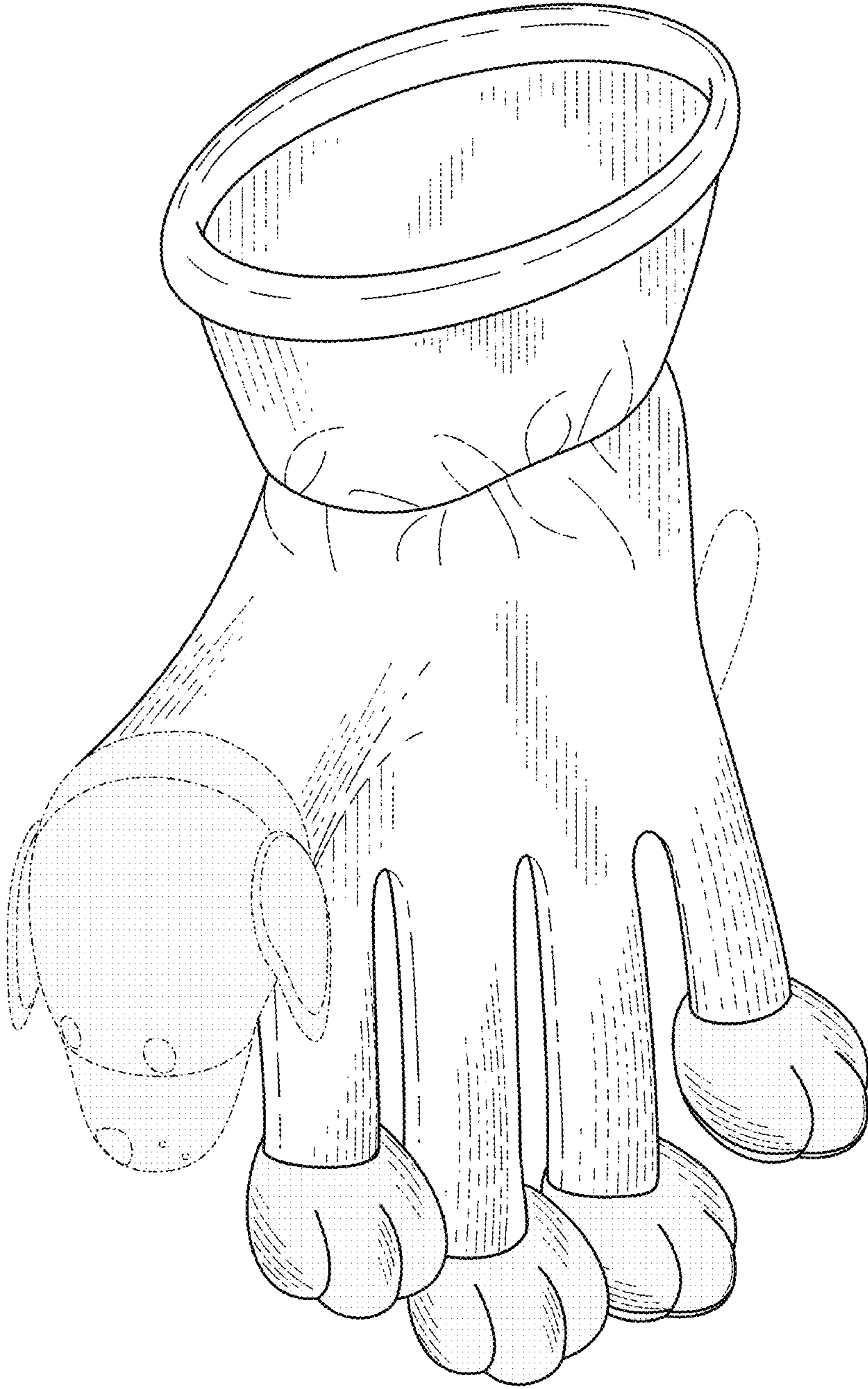

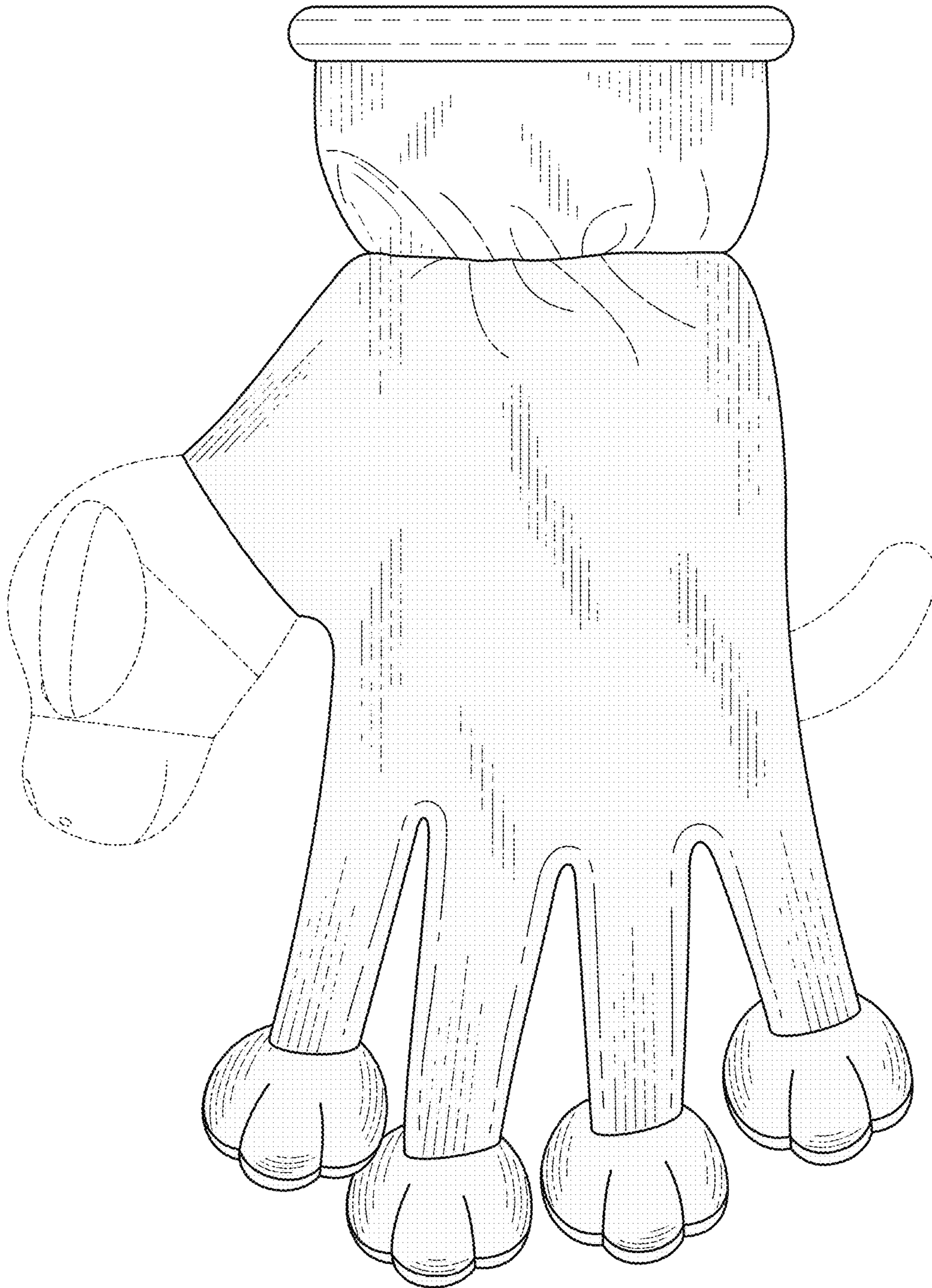

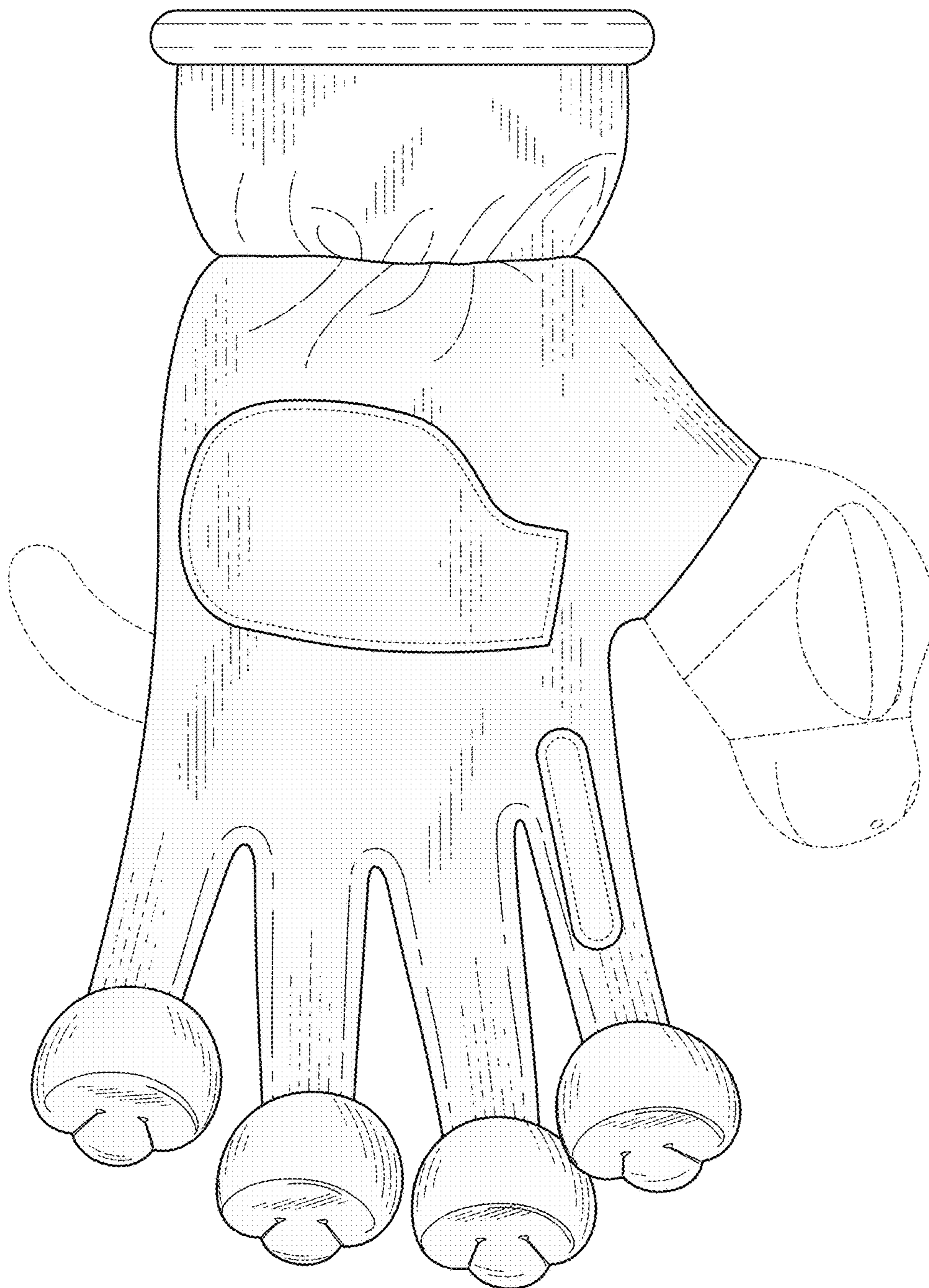

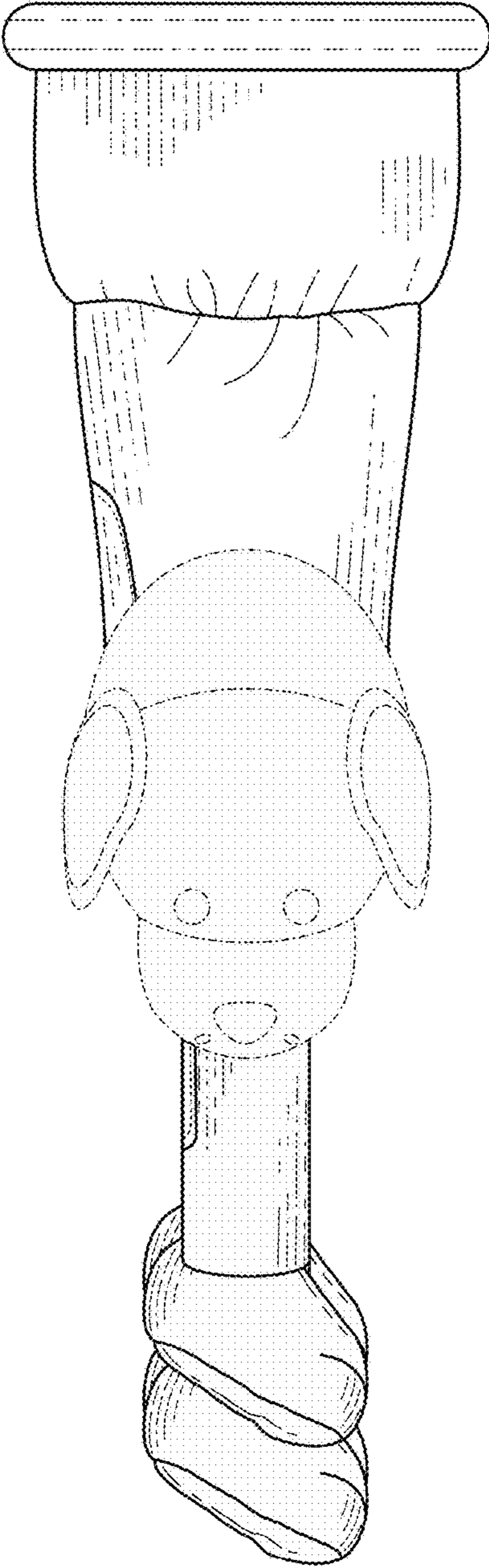

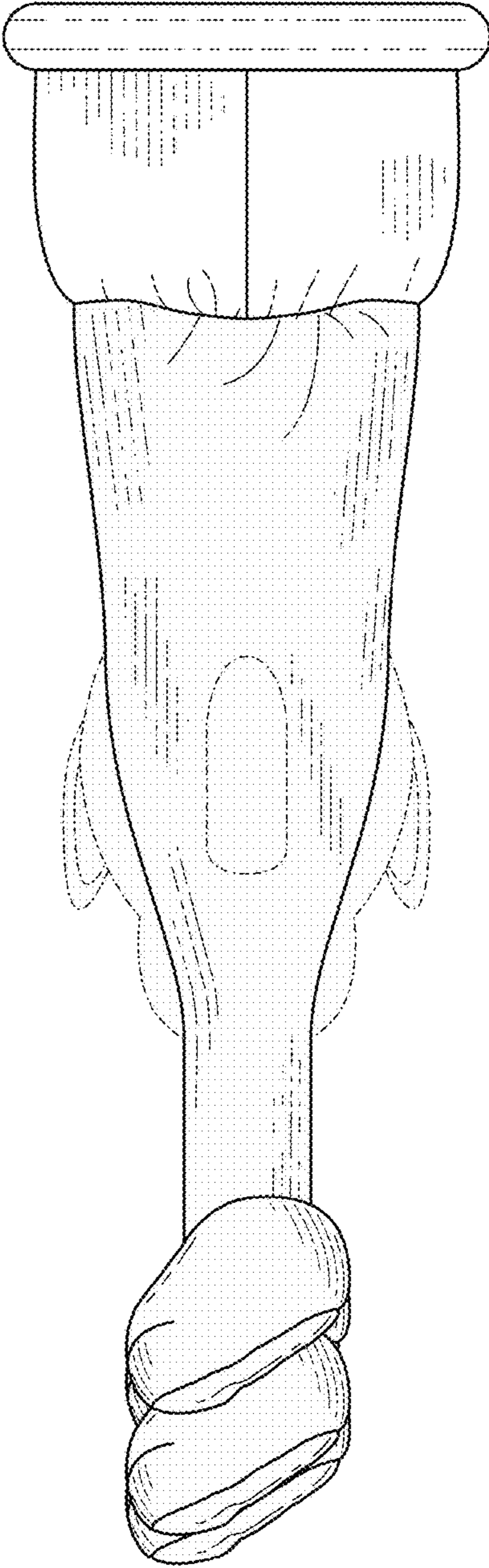

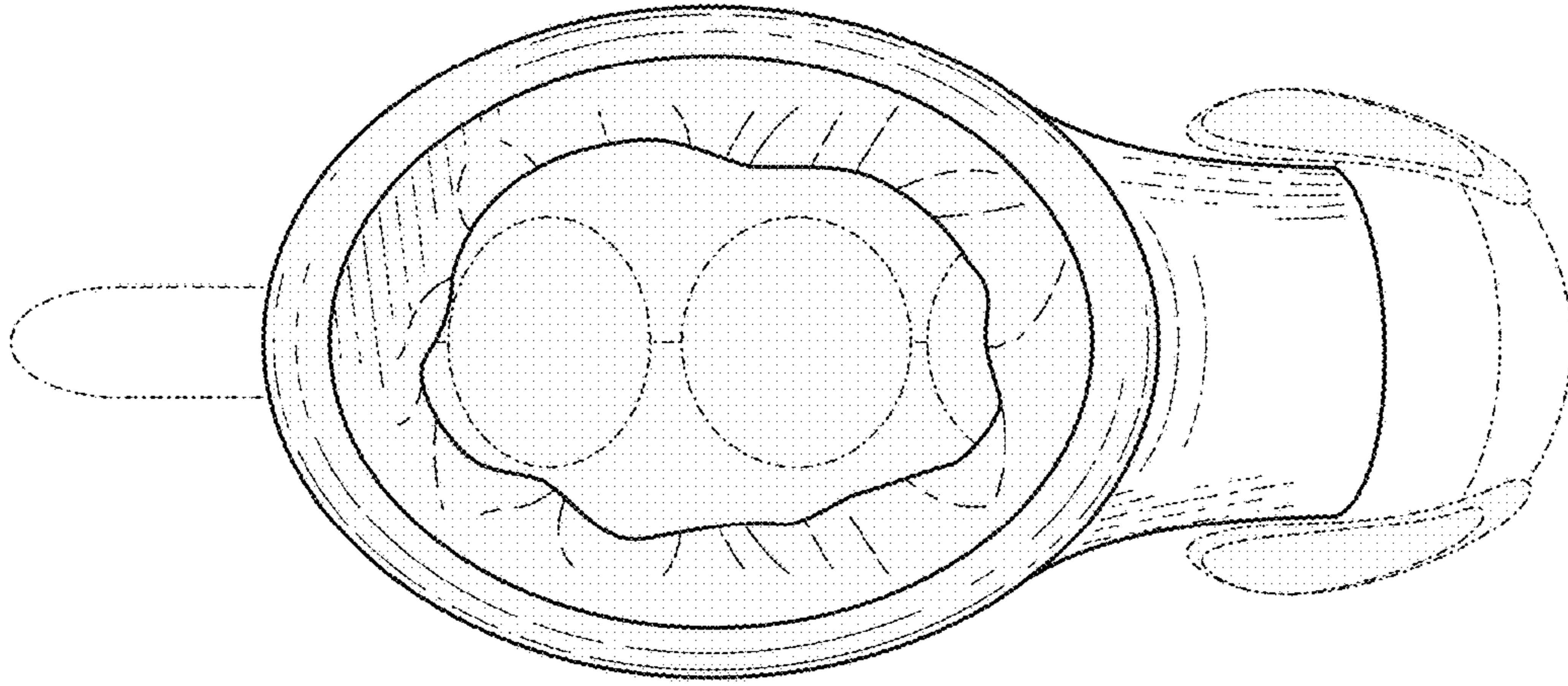

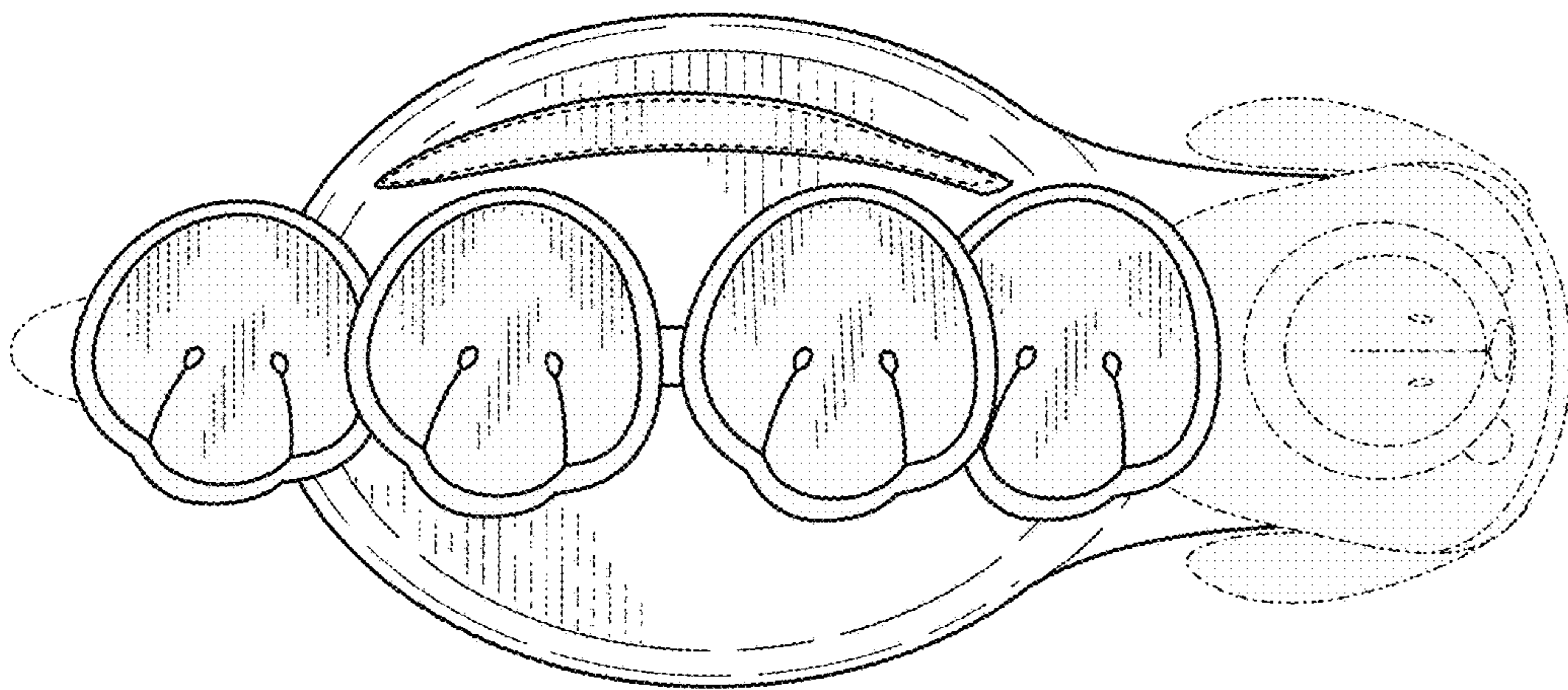
