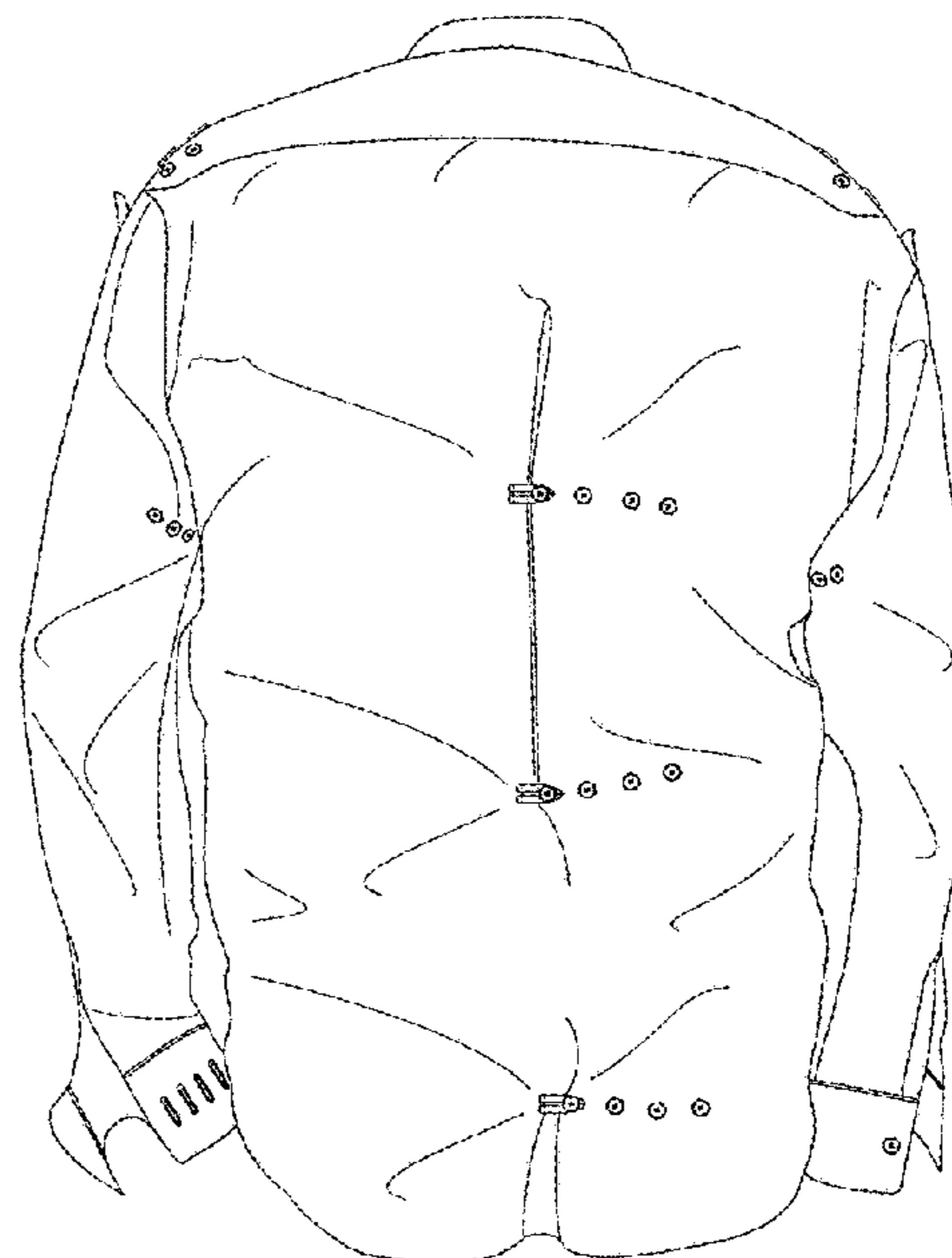
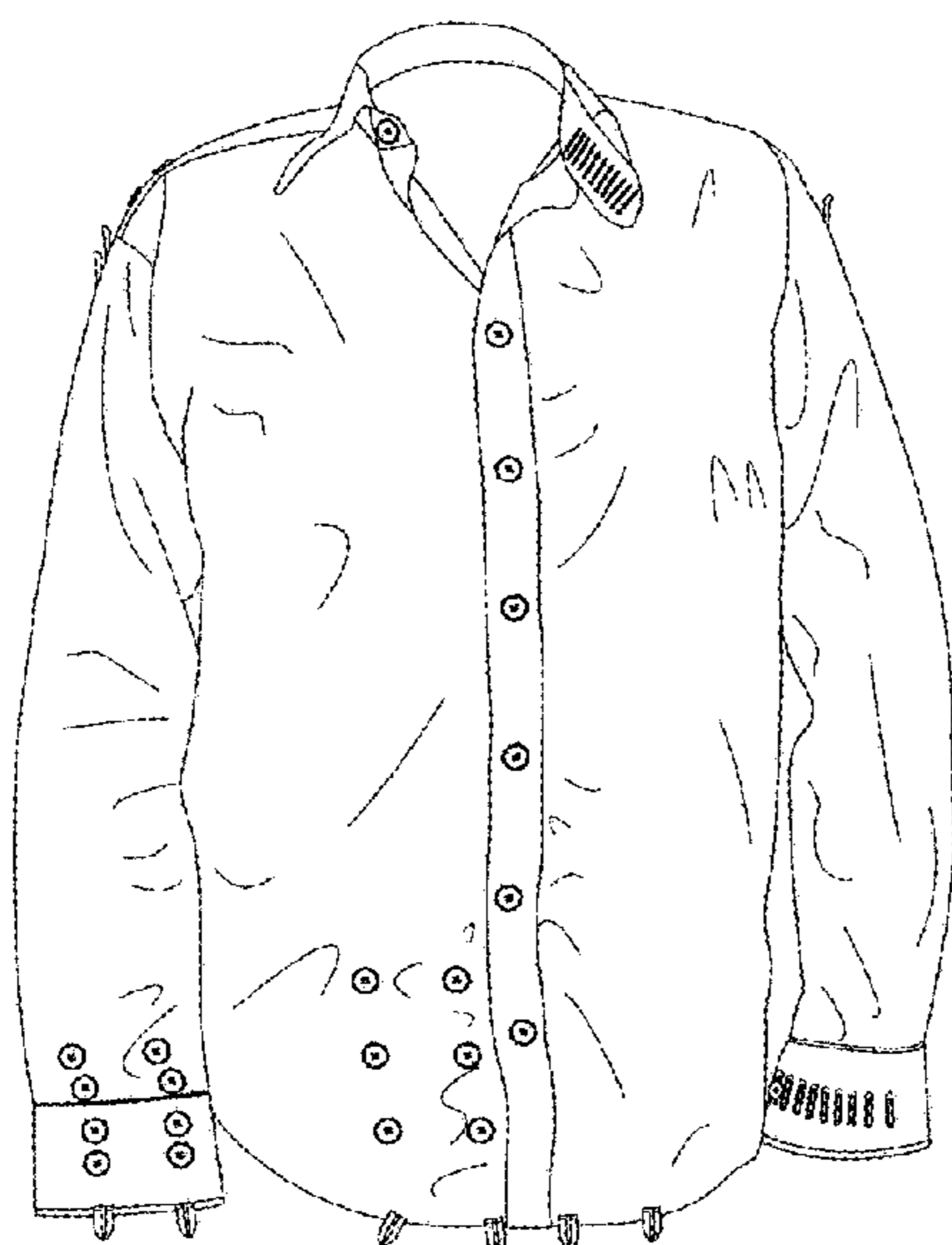
(57) **CLAIM**

We claim the ornamental design for a tailor shirt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the tailor shirt with sleeves down embodying the inventive design;  
FIG. 2 is a front view of the tailor shirt with the sleeves raised thereof;  
FIG. 3 is a right side view with sleeves down thereof;  
FIG. 4 is a right side perspective view with sleeve raised thereof;  
FIG. 5 is a left side perspective view with the sleeve lowered thereof;  
FIG. 6 is a left side view with the sleeve raised thereof;  
FIG. 7 is a back view with the sleeves down thereof;  
FIG. 8 is a back view with the sleeves raised thereof;  
FIG. 9 is an enlarged partial view of the right sleeve shown in FIG. 4 raised in a closed position;  
FIG. 10 is an enlarged partial top view of the right sleeve cuff shown in FIG. 3 in an open position;  
FIG. 11 is an enlarged partial top view of the right sleeve cuff shown in FIG. 3 in a closed position;  
FIG. 12 is an enlarged partial front view of the collar shown in FIG. 2 in closed position; and,  
FIG. 13 is an enlarged partial top view of the left side sleeve cuff shown in FIG. 2 in closed position.  
The broken lines represent enlargement reference boundaries that form no part of the claimed design.

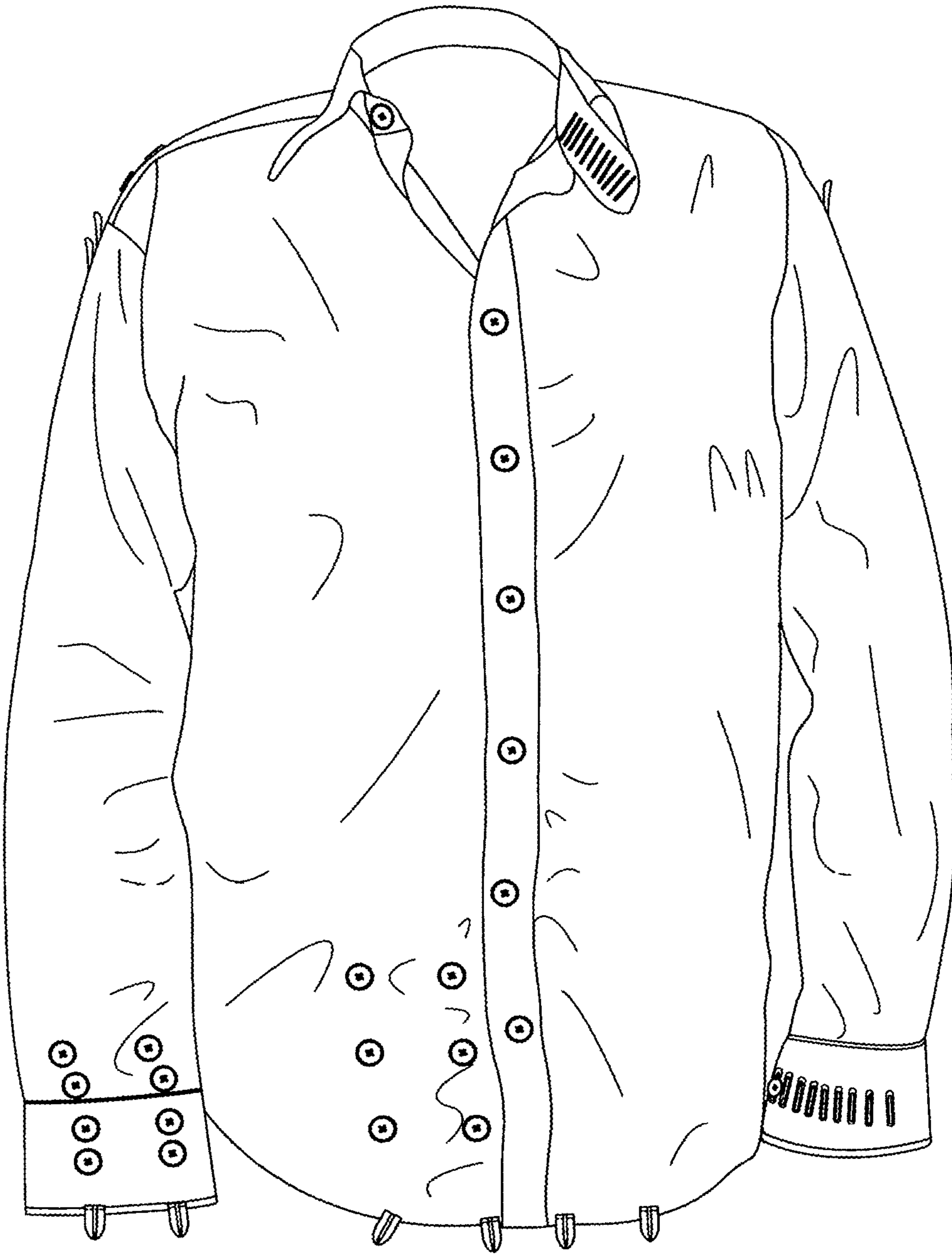

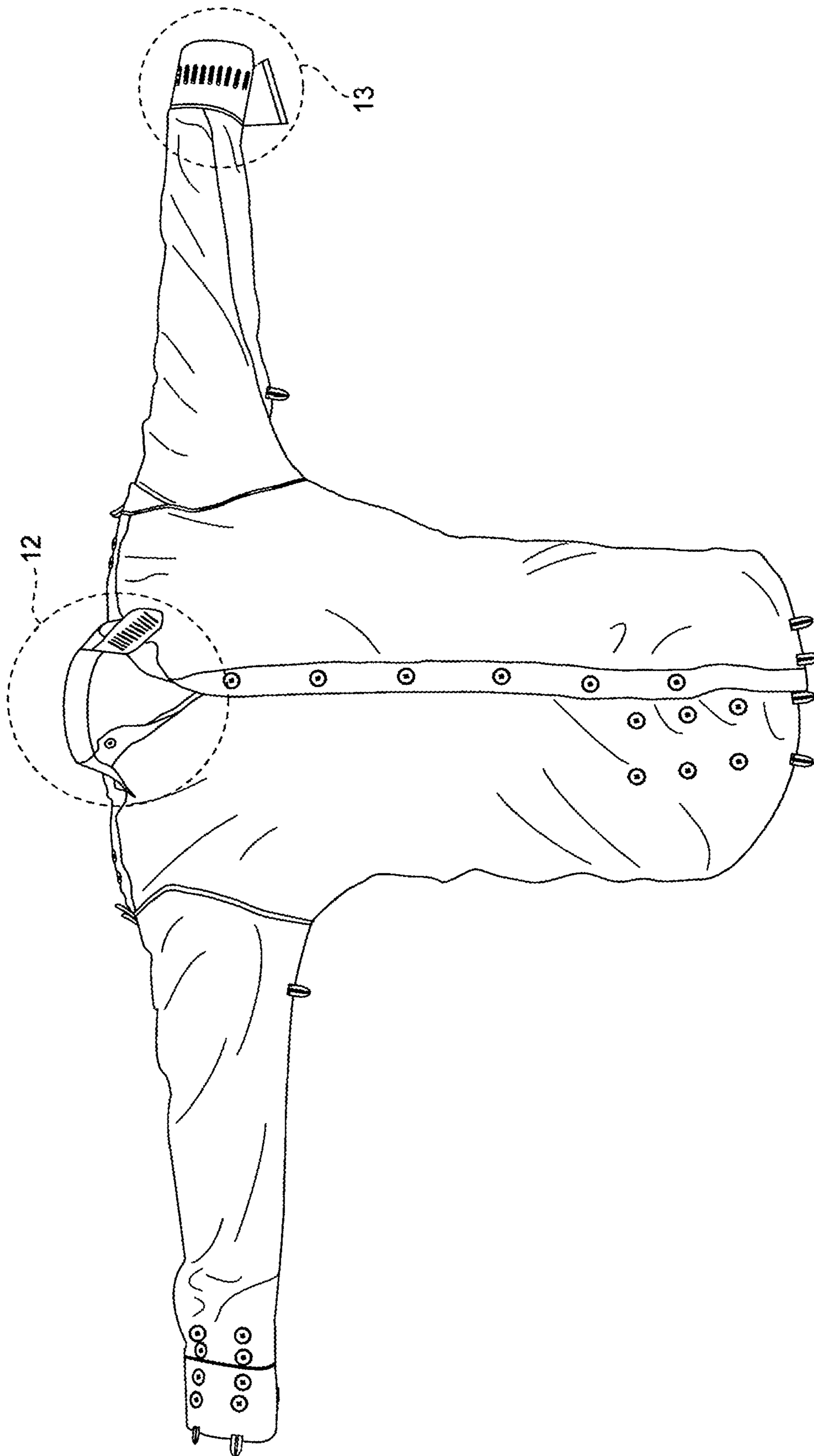

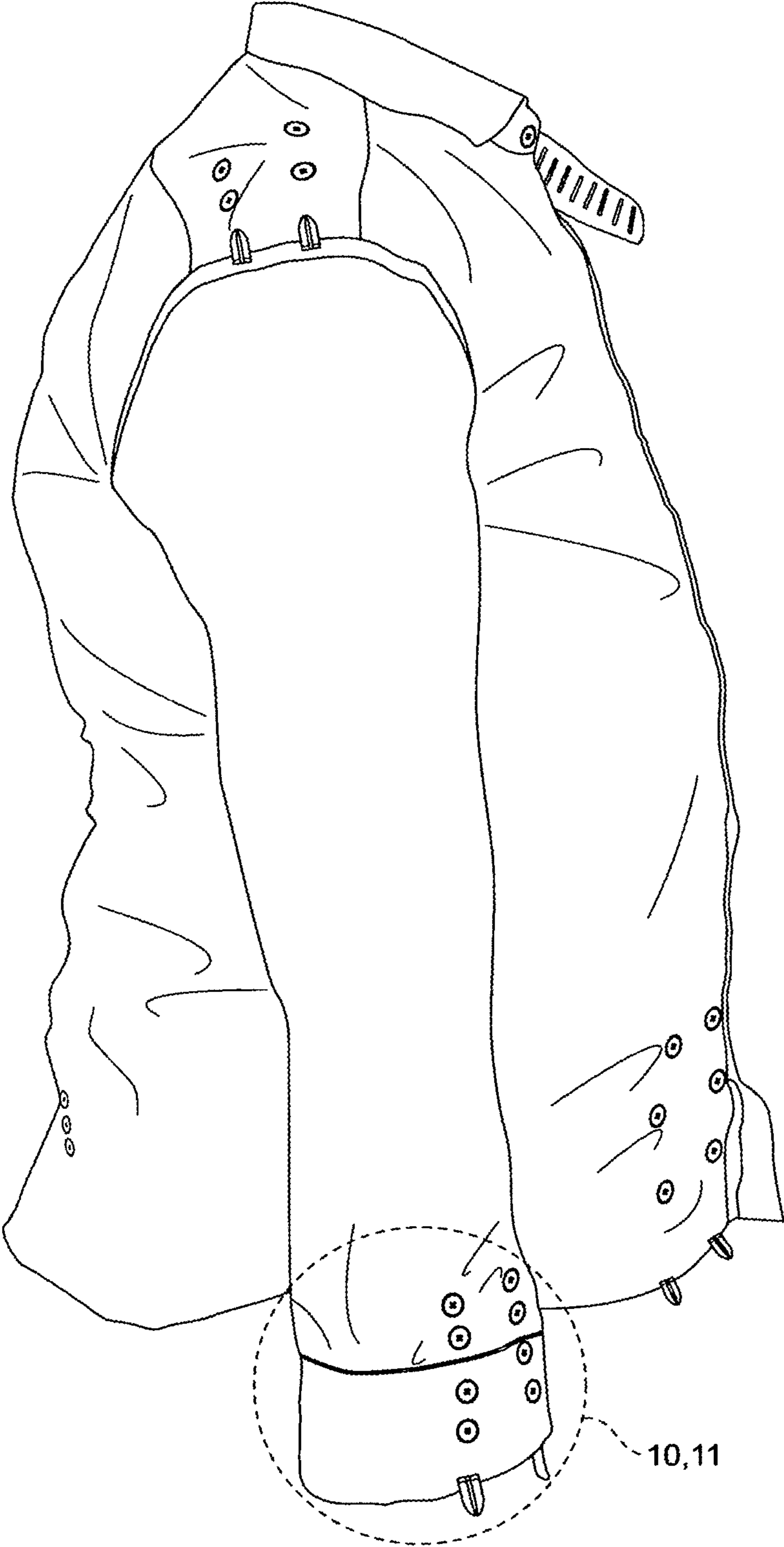

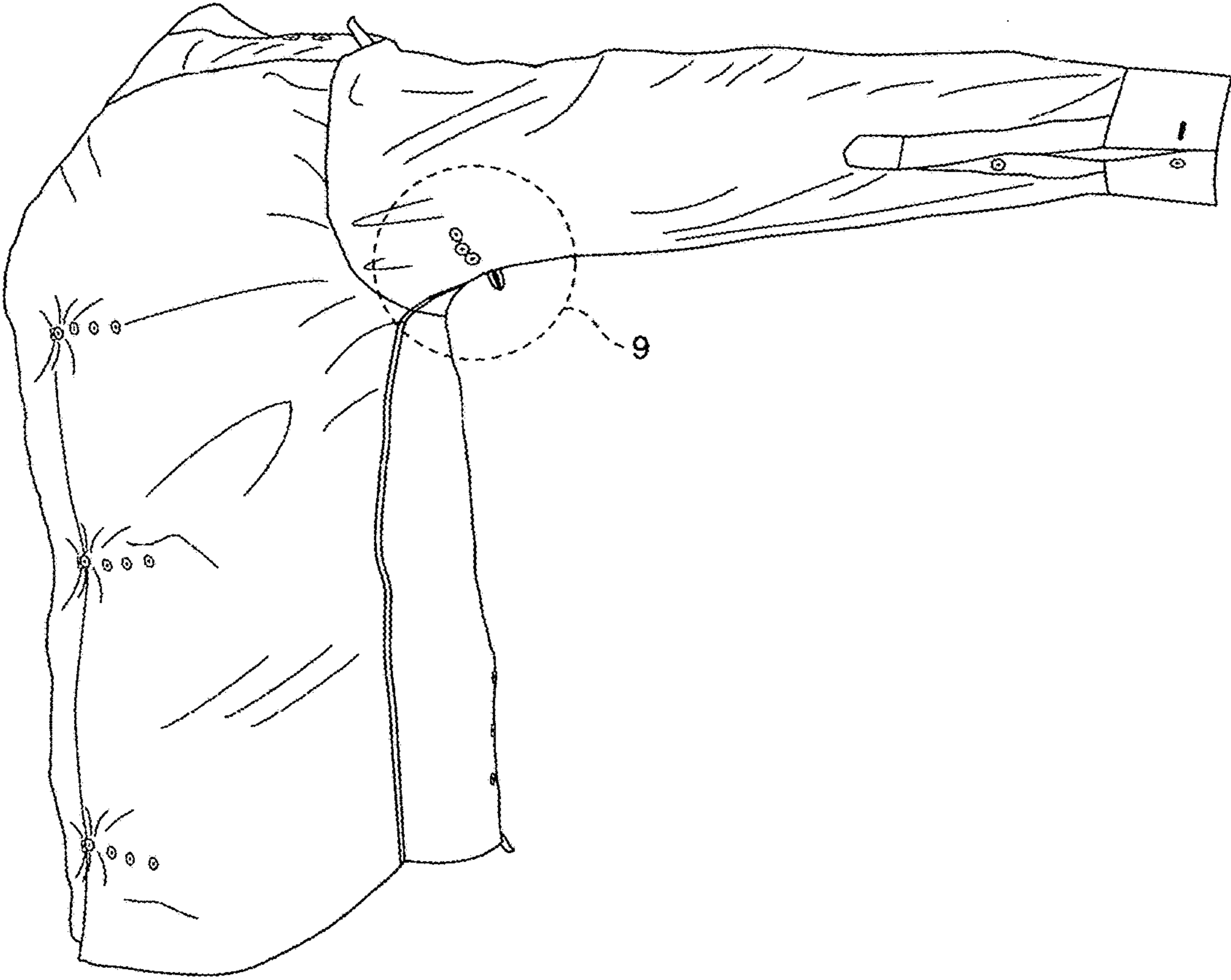

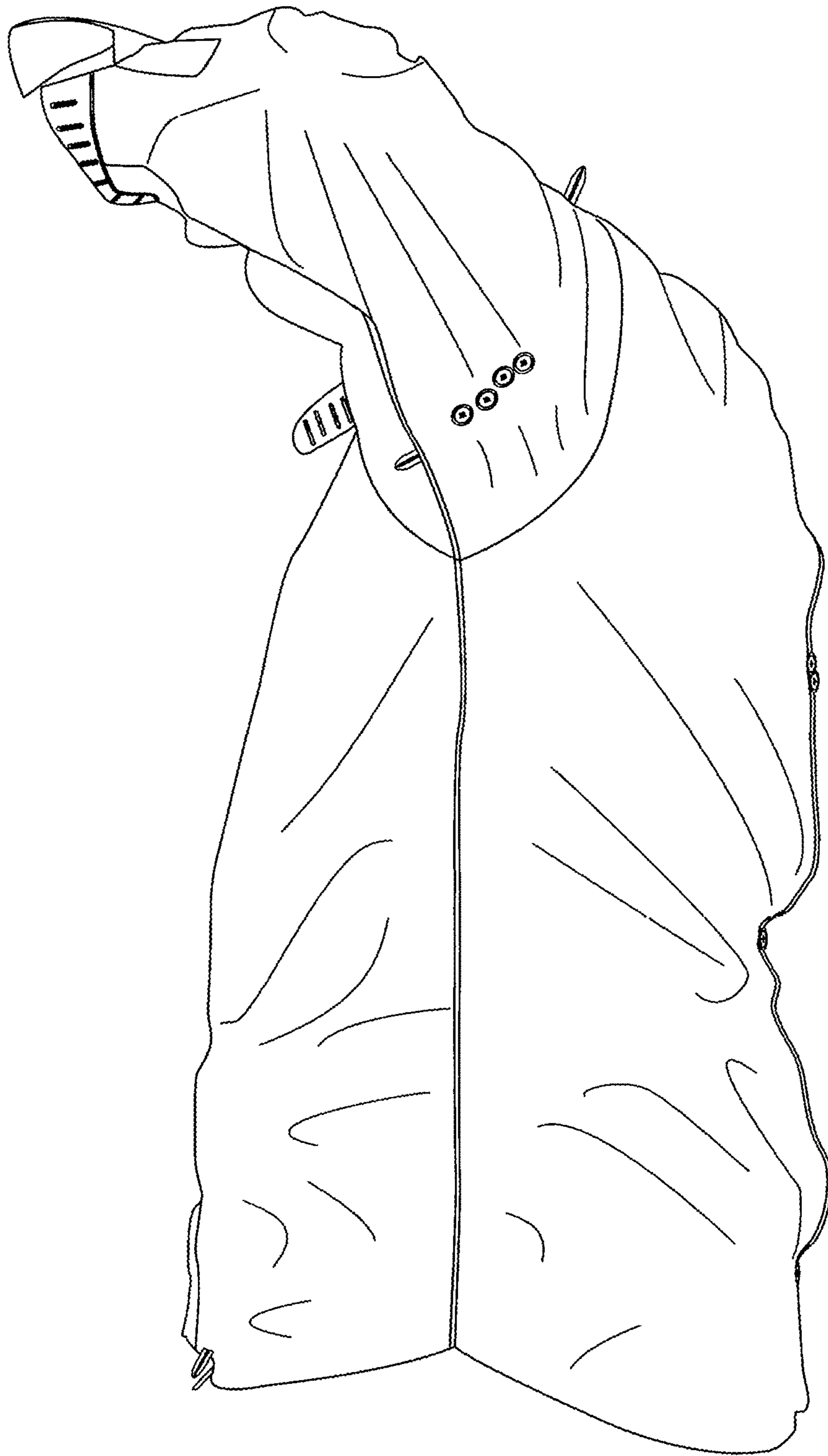

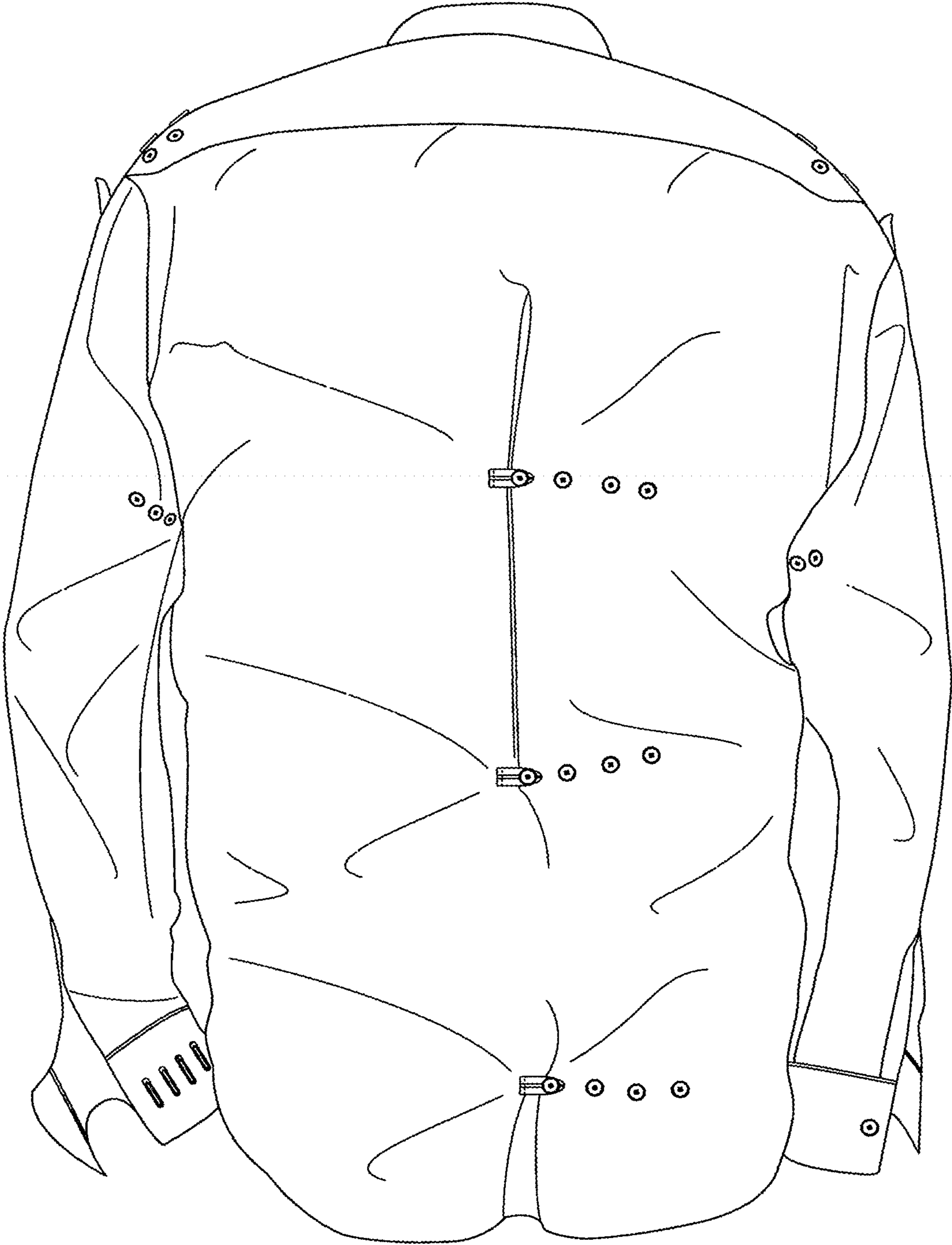

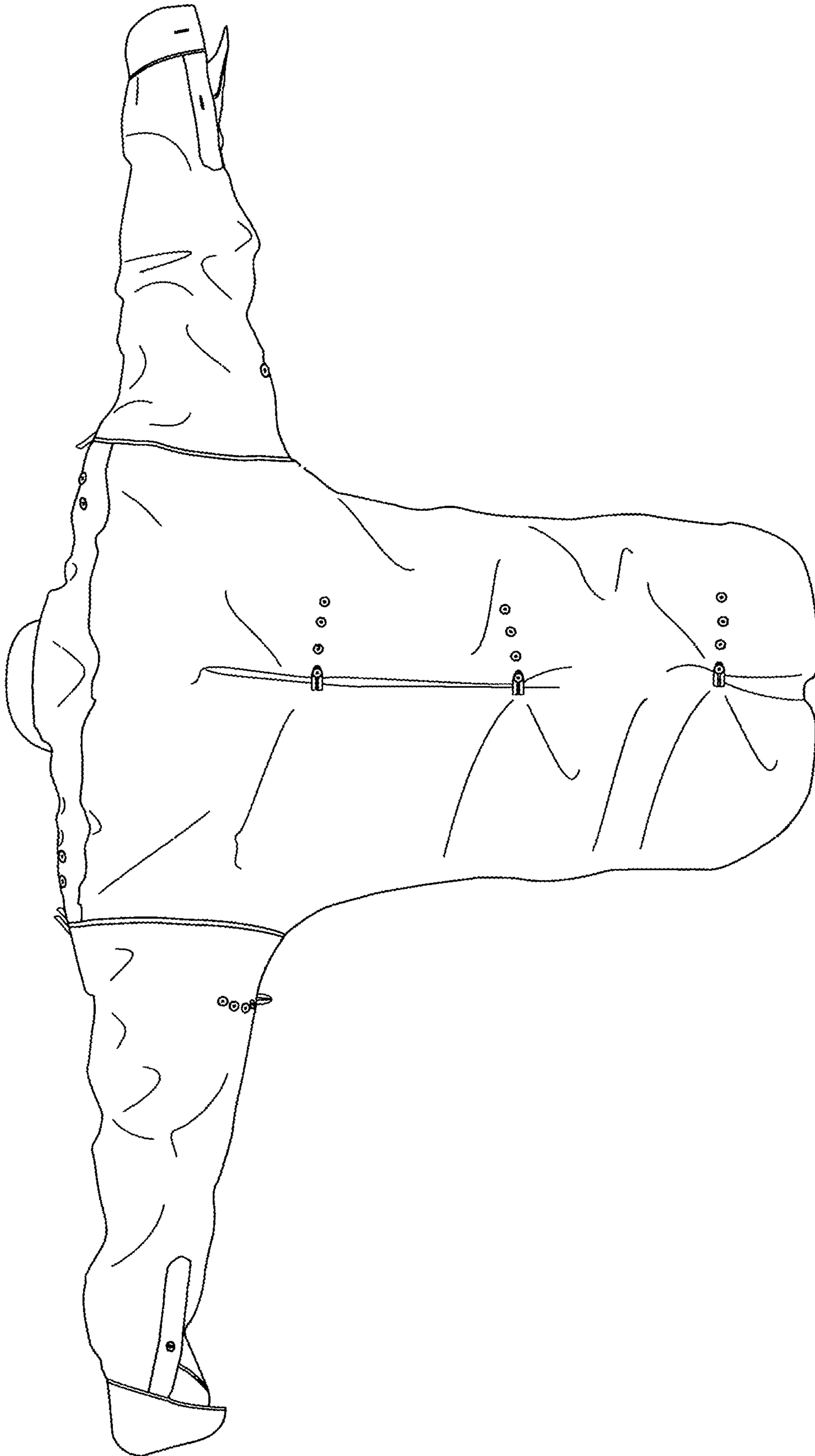

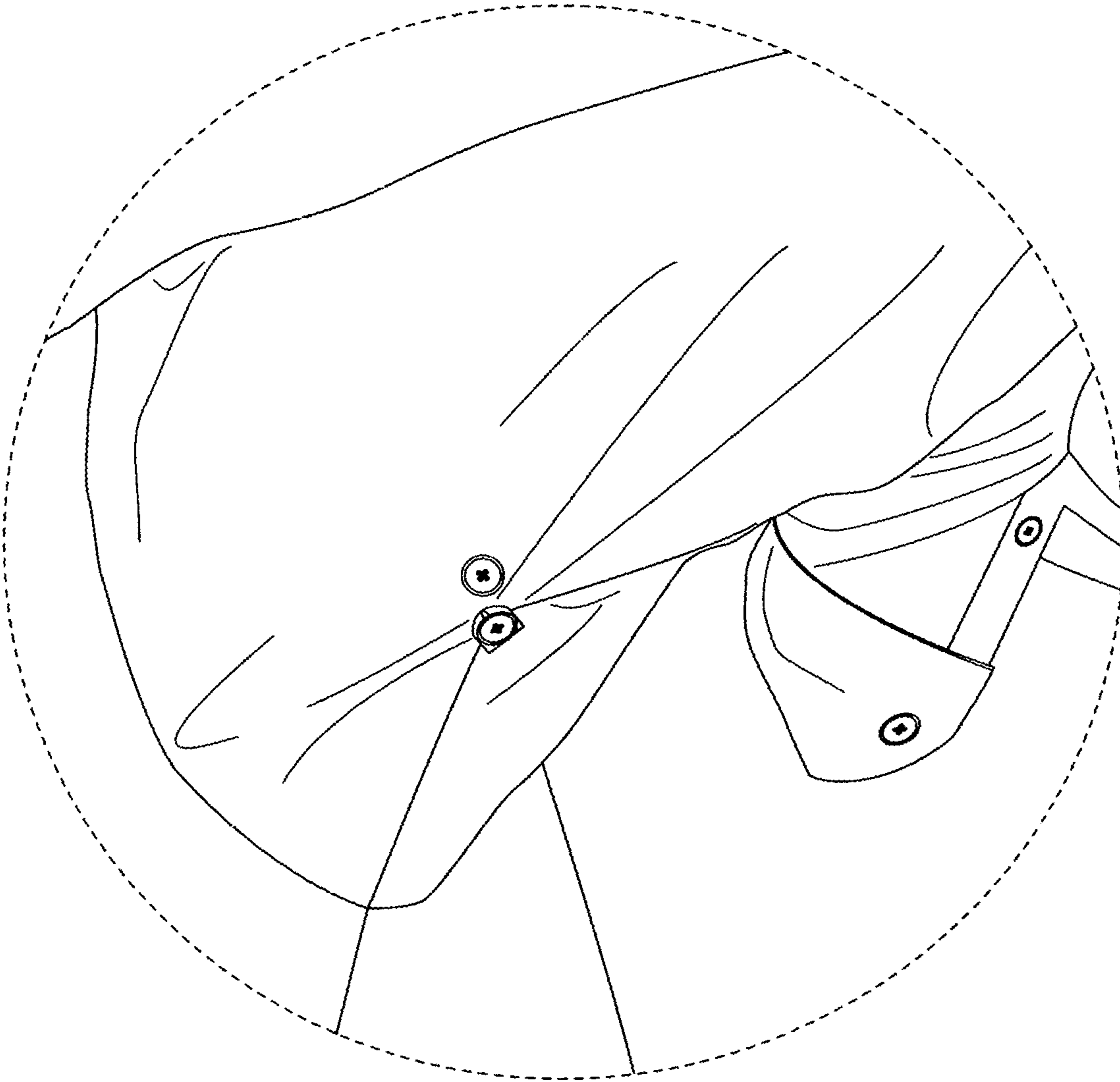

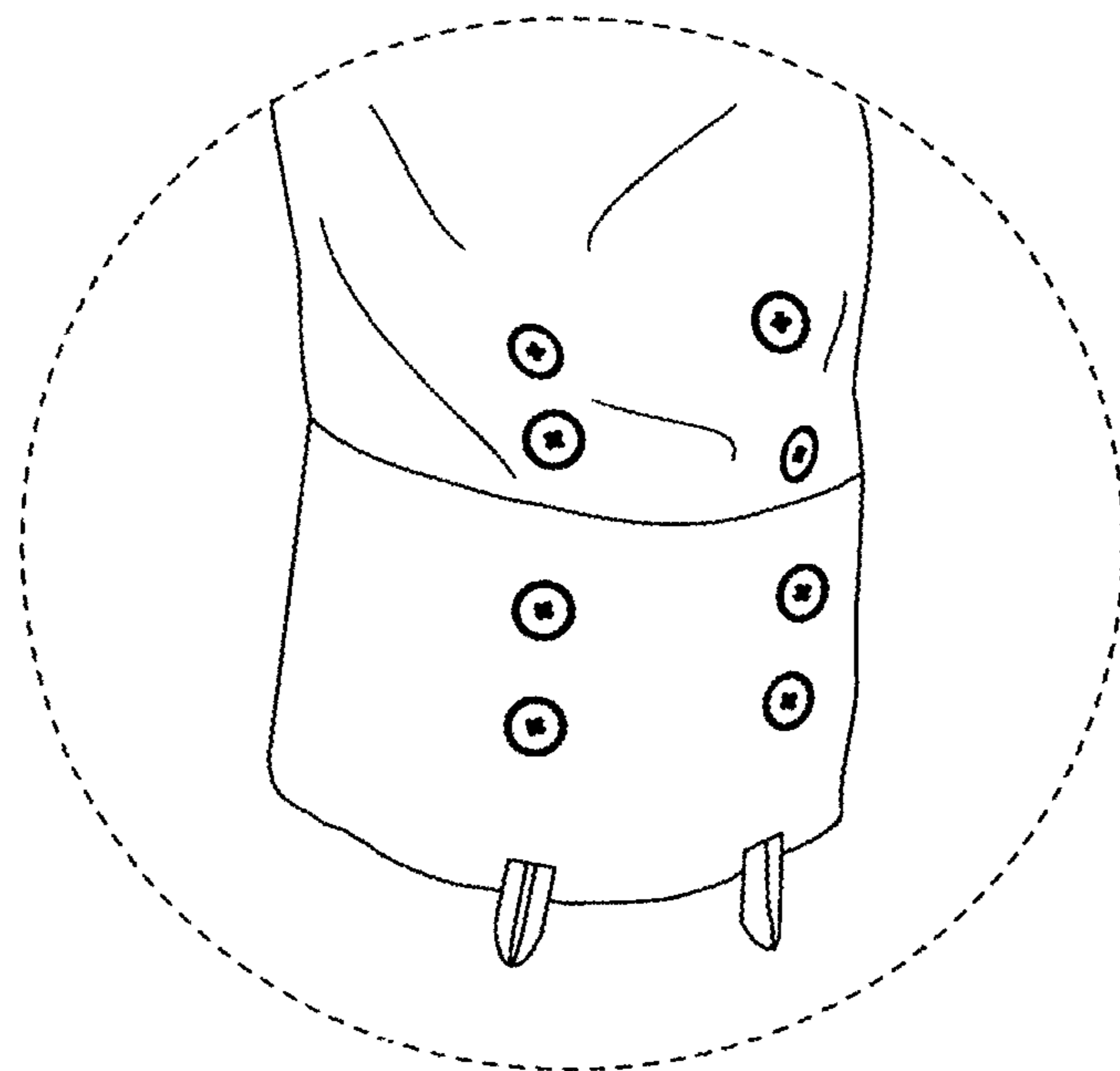

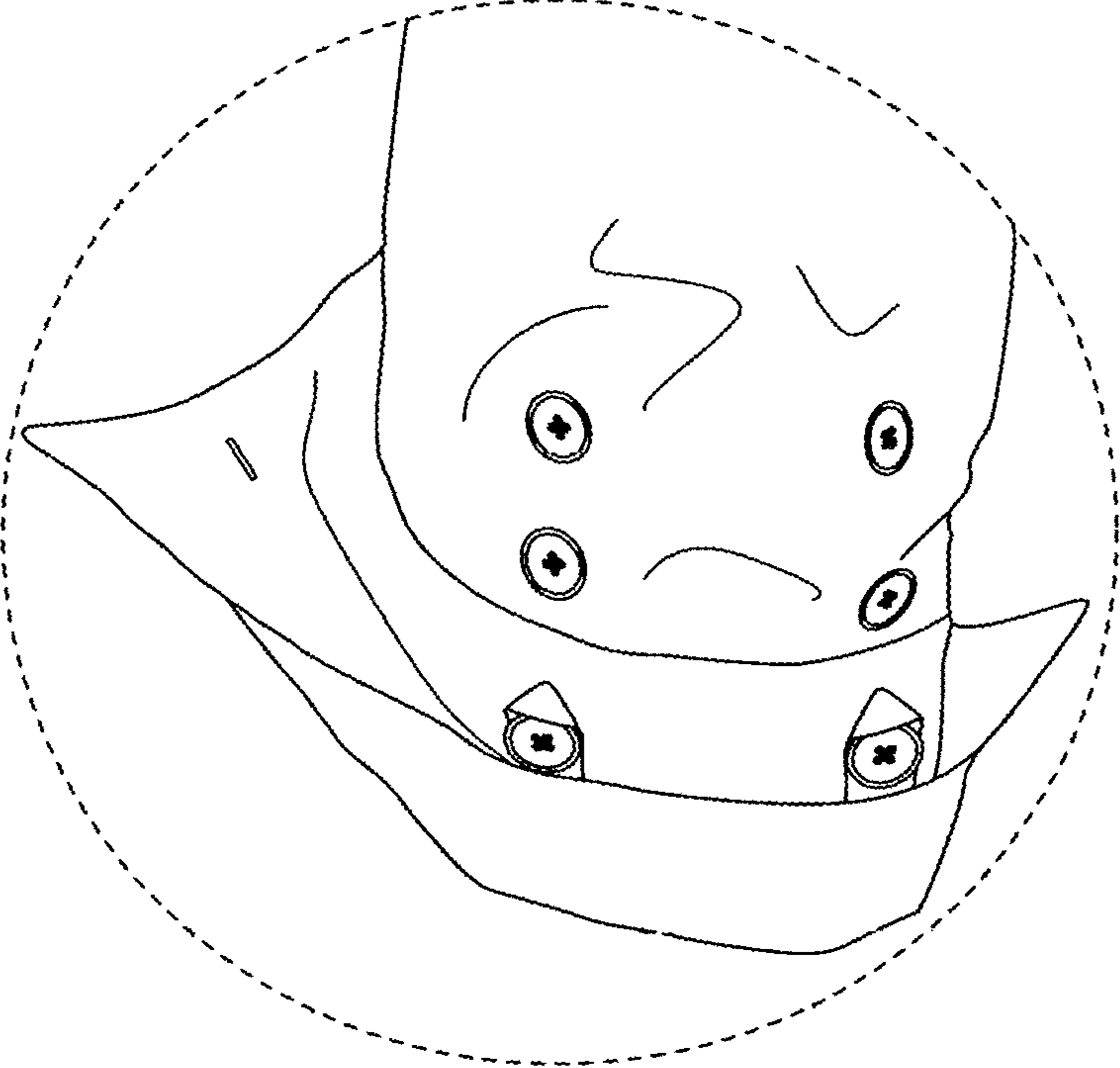

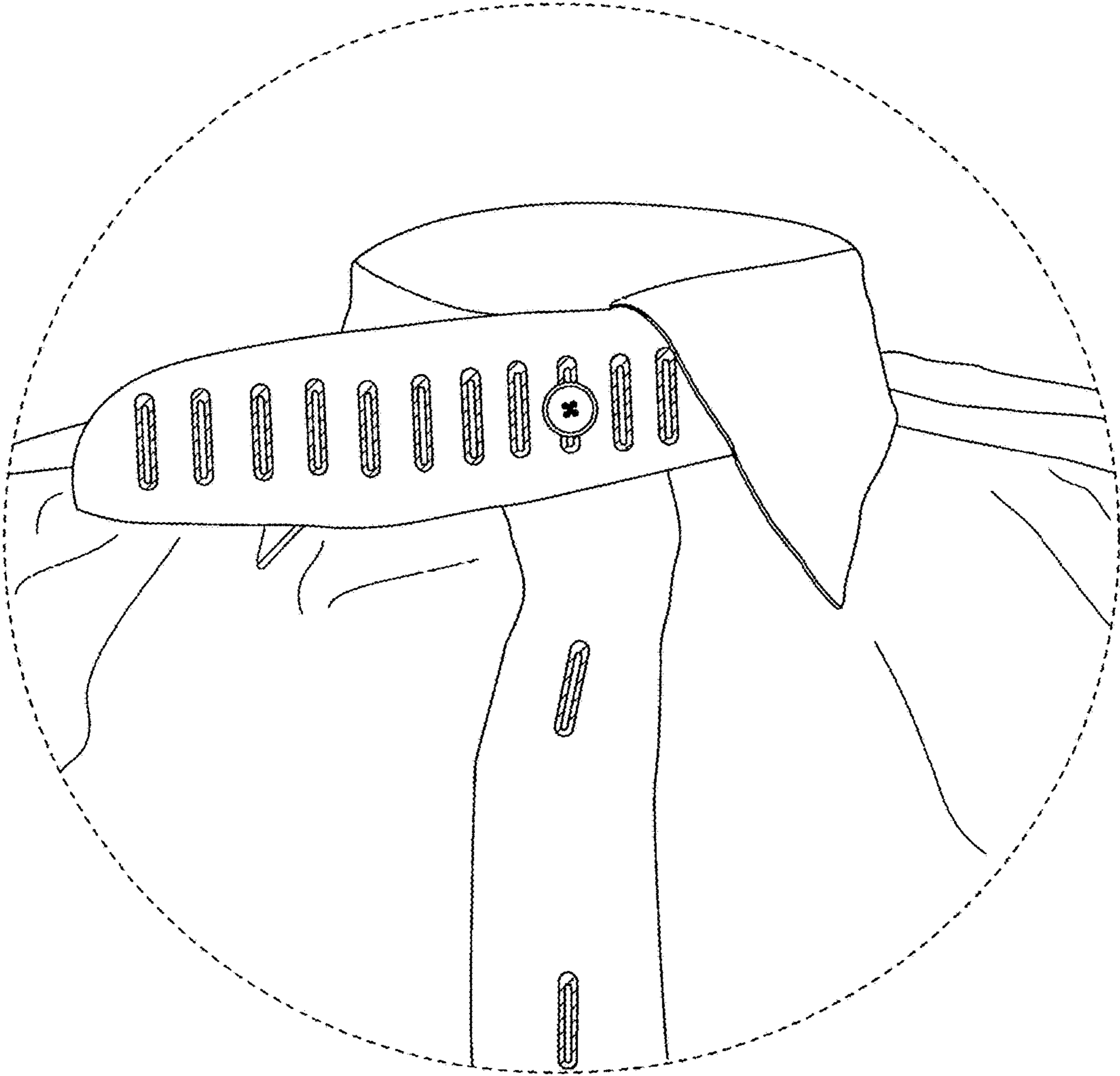

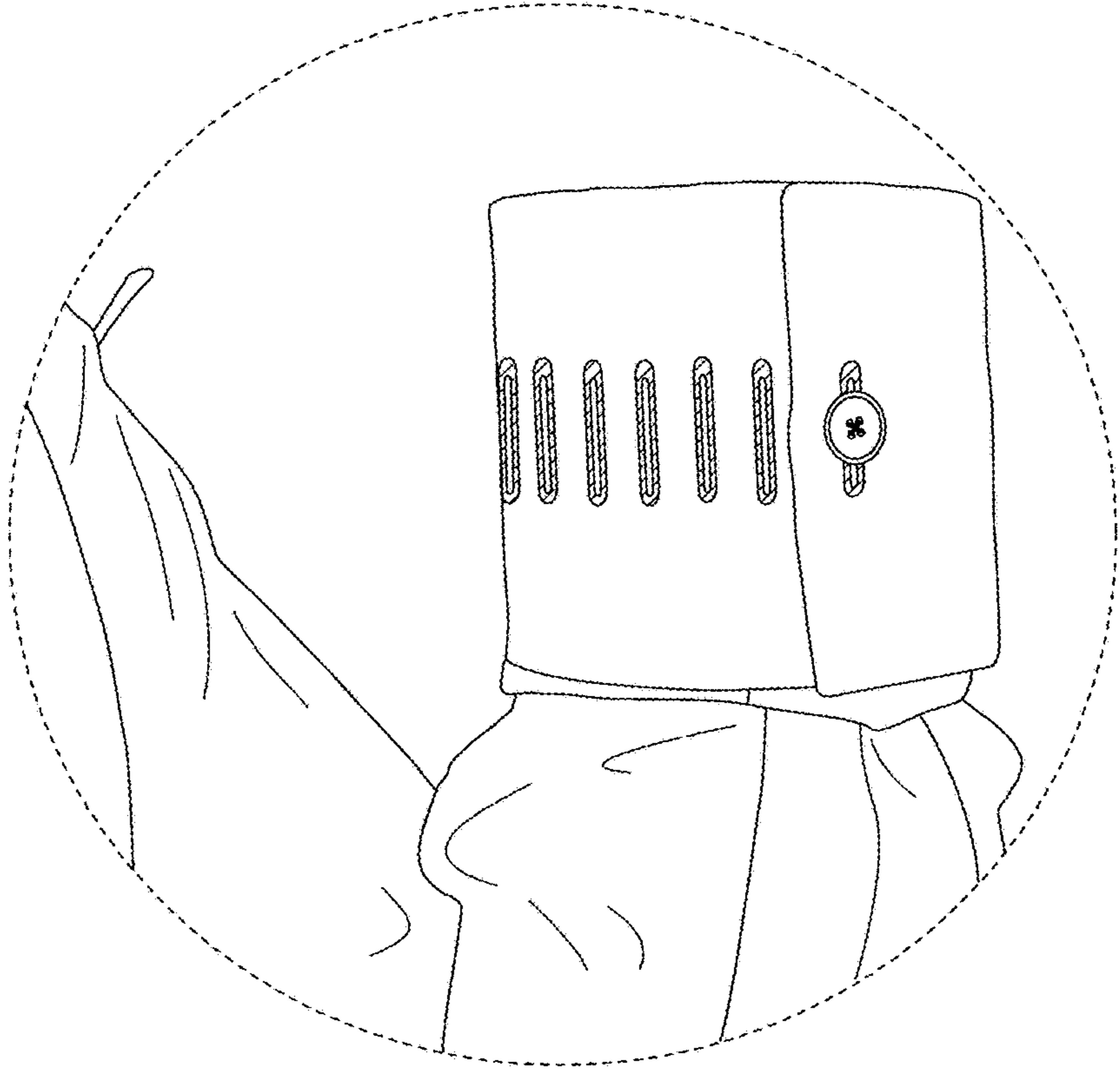
