**DESCRIPTION**

FIG. 1 is an isometric view of a boot showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 5 is a left-side elevational view thereof.

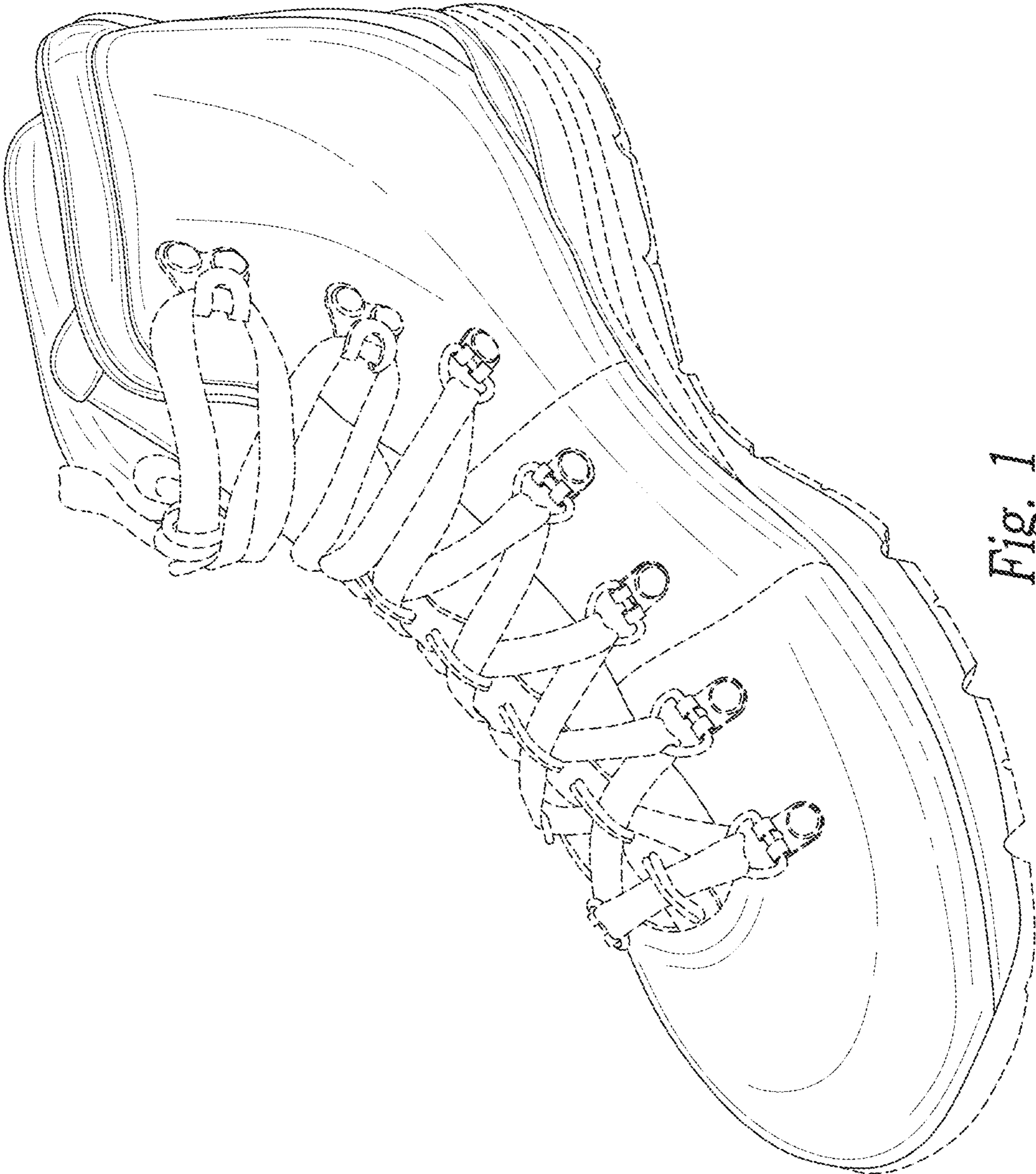

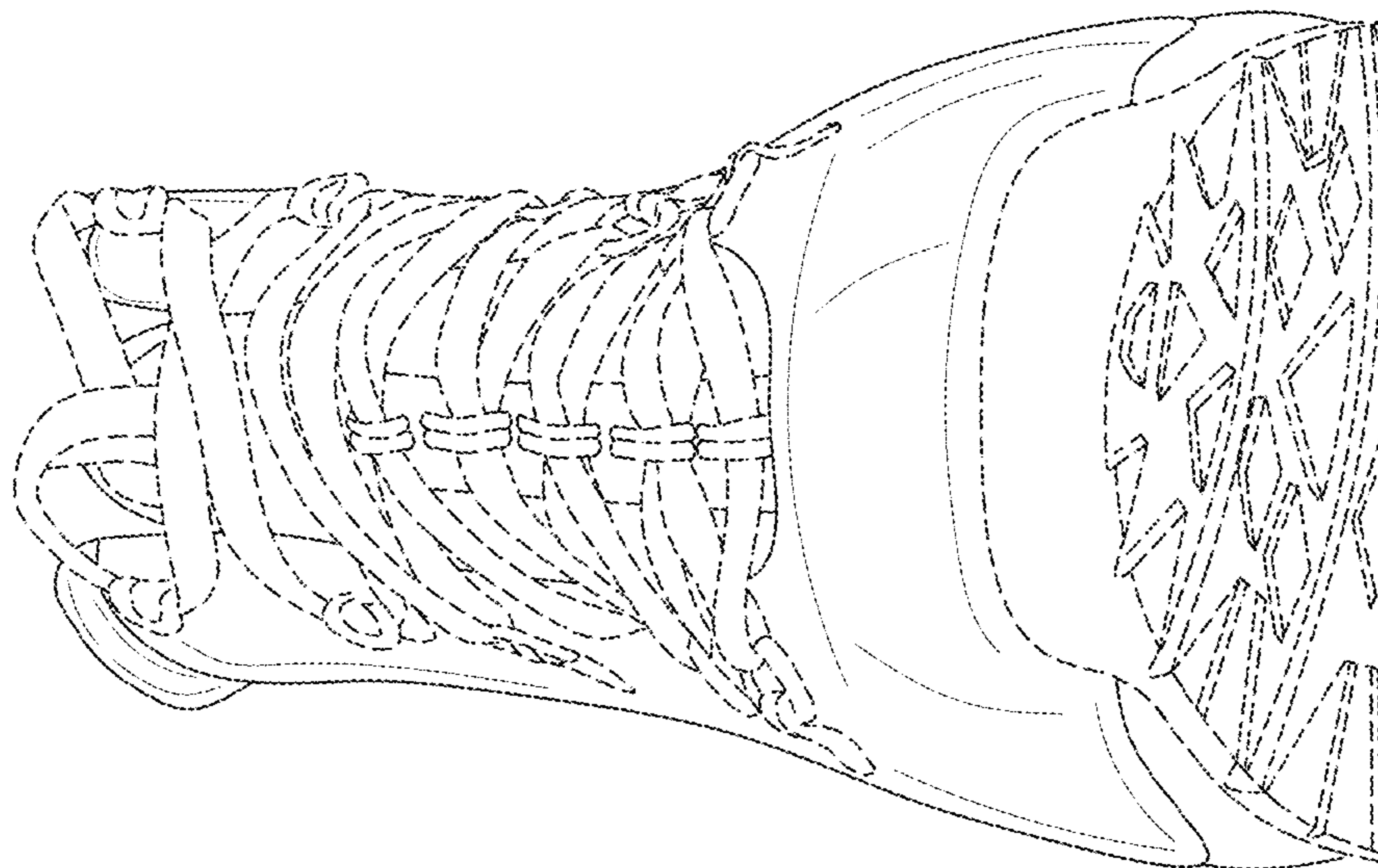

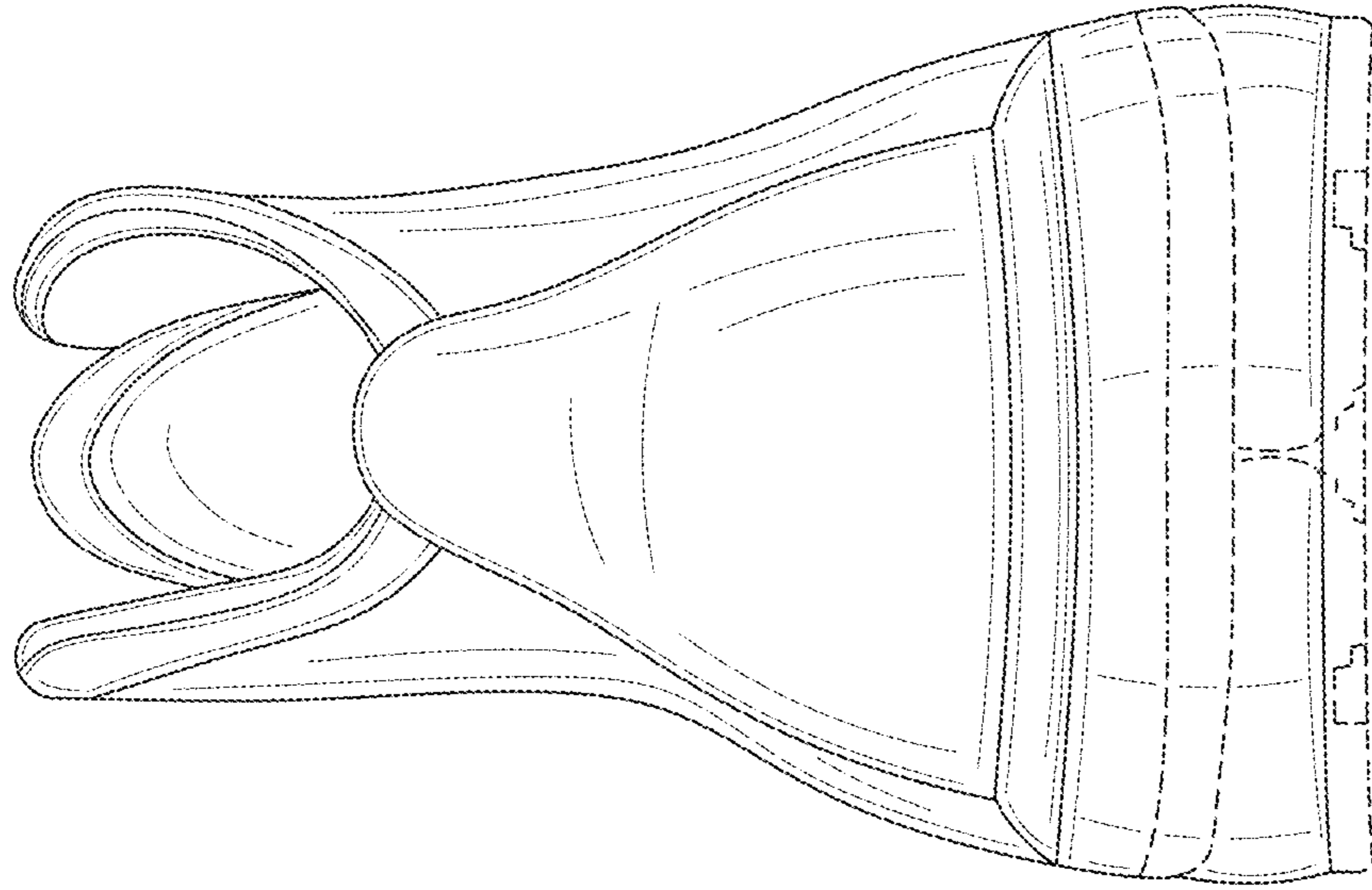

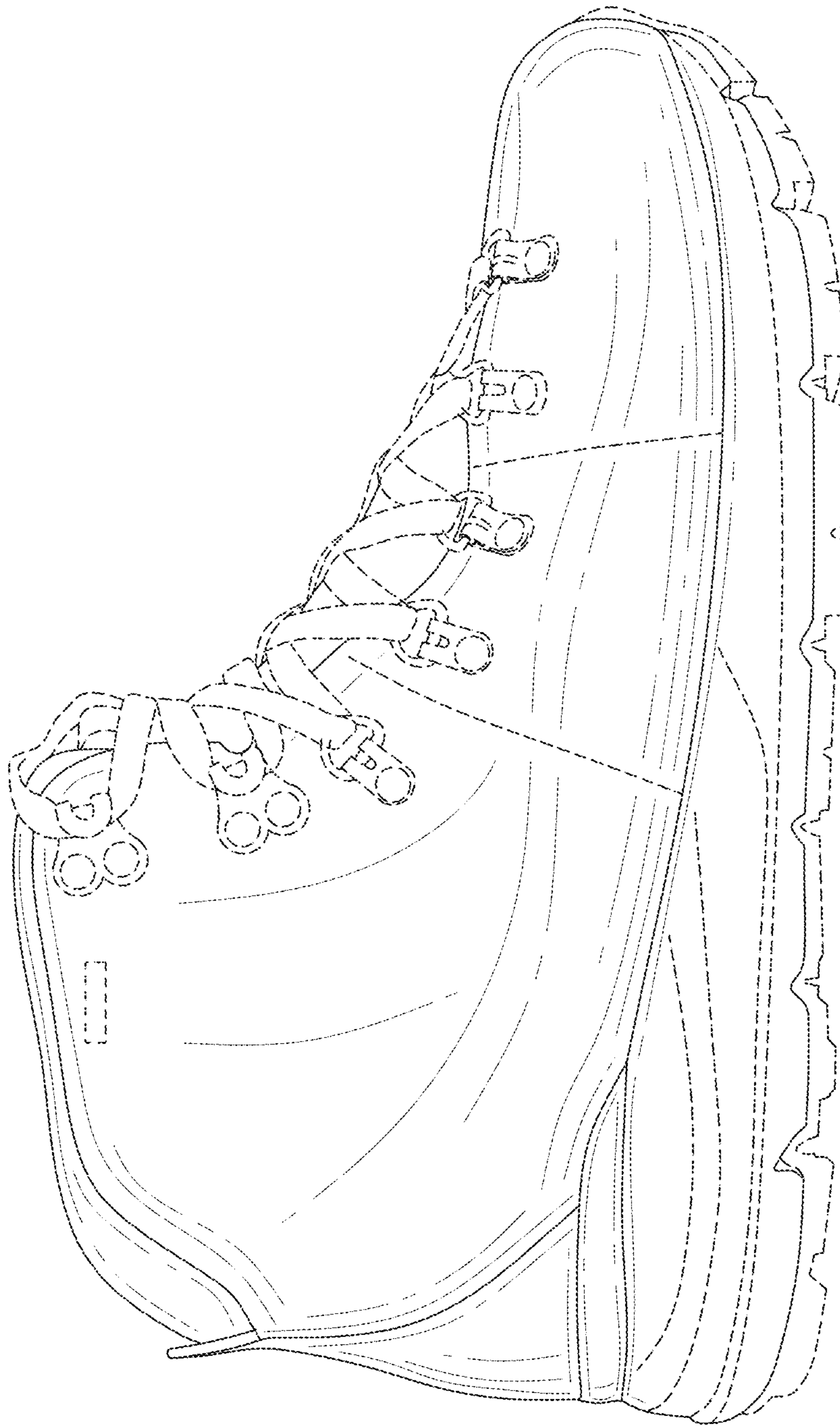
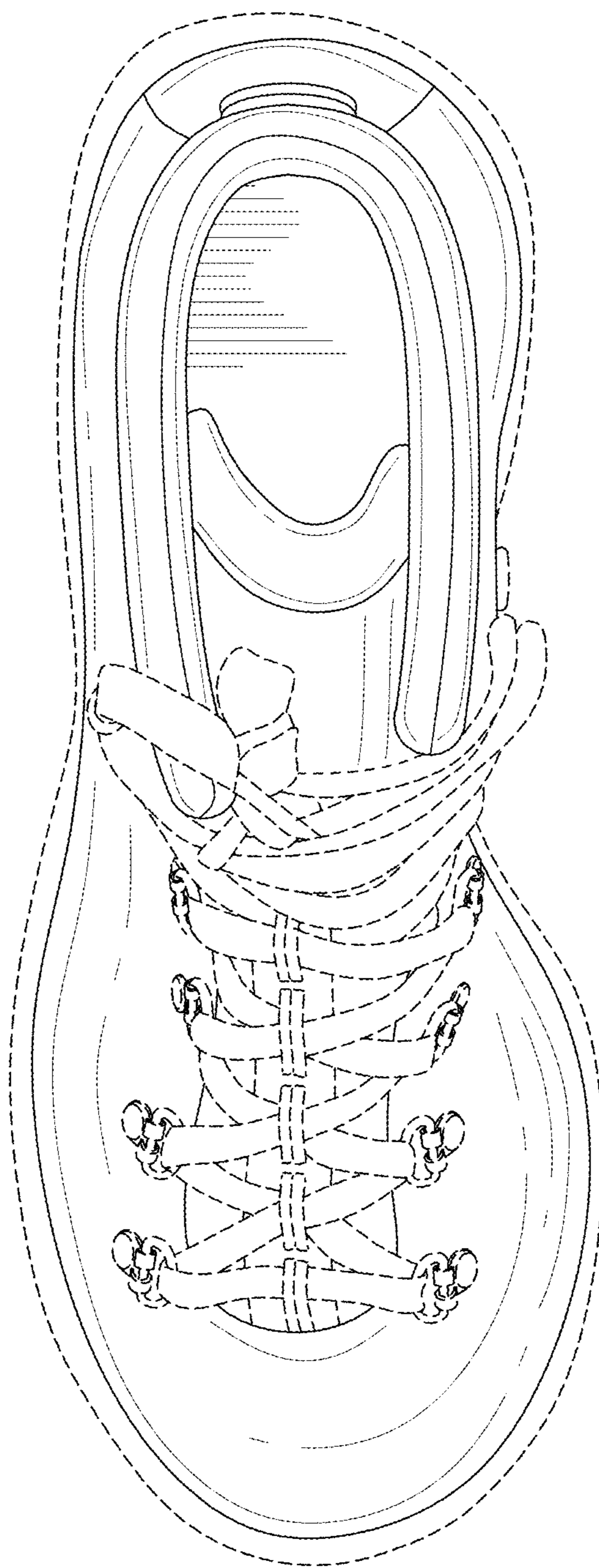
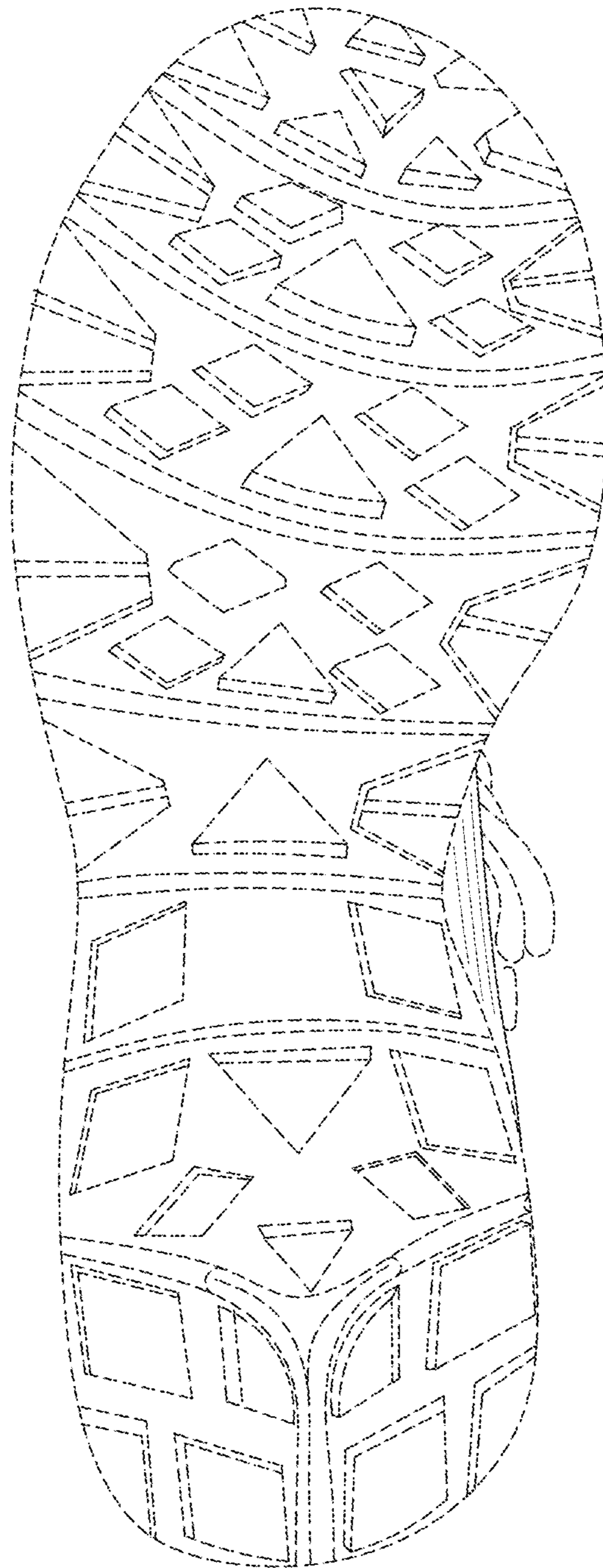
