(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing my new design;

FIG. 2 is a side view thereof;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is an enlarged view of FIG. 1 with unclaimed subject matter omitted;

FIG. 5 is a front perspective view of a shoe upper showing an alternative embodiment of my new design;

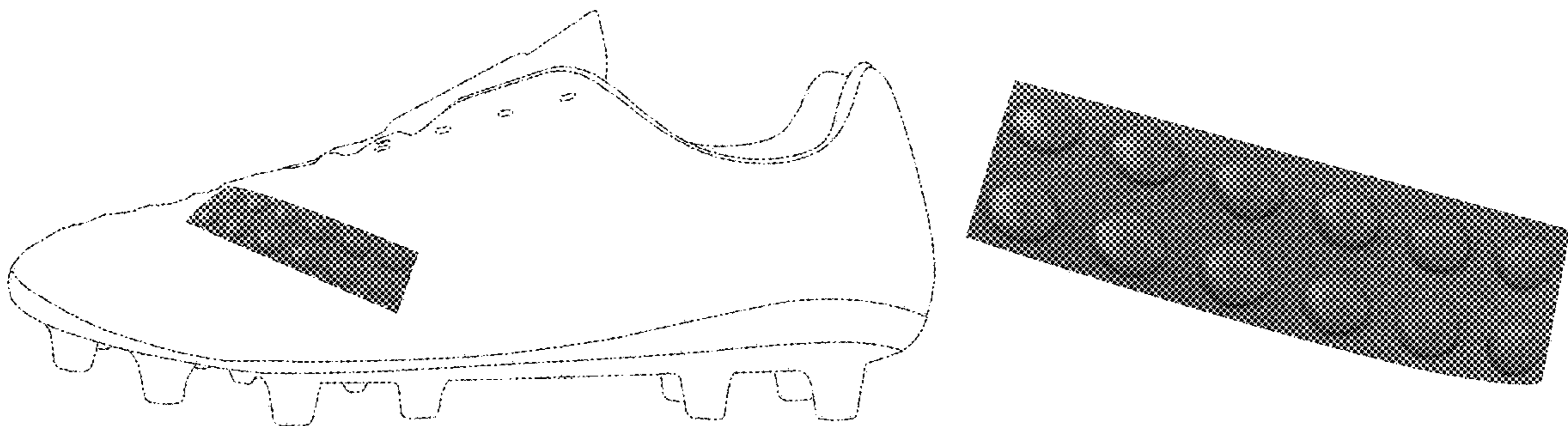
FIG. 6 is a side view thereof;

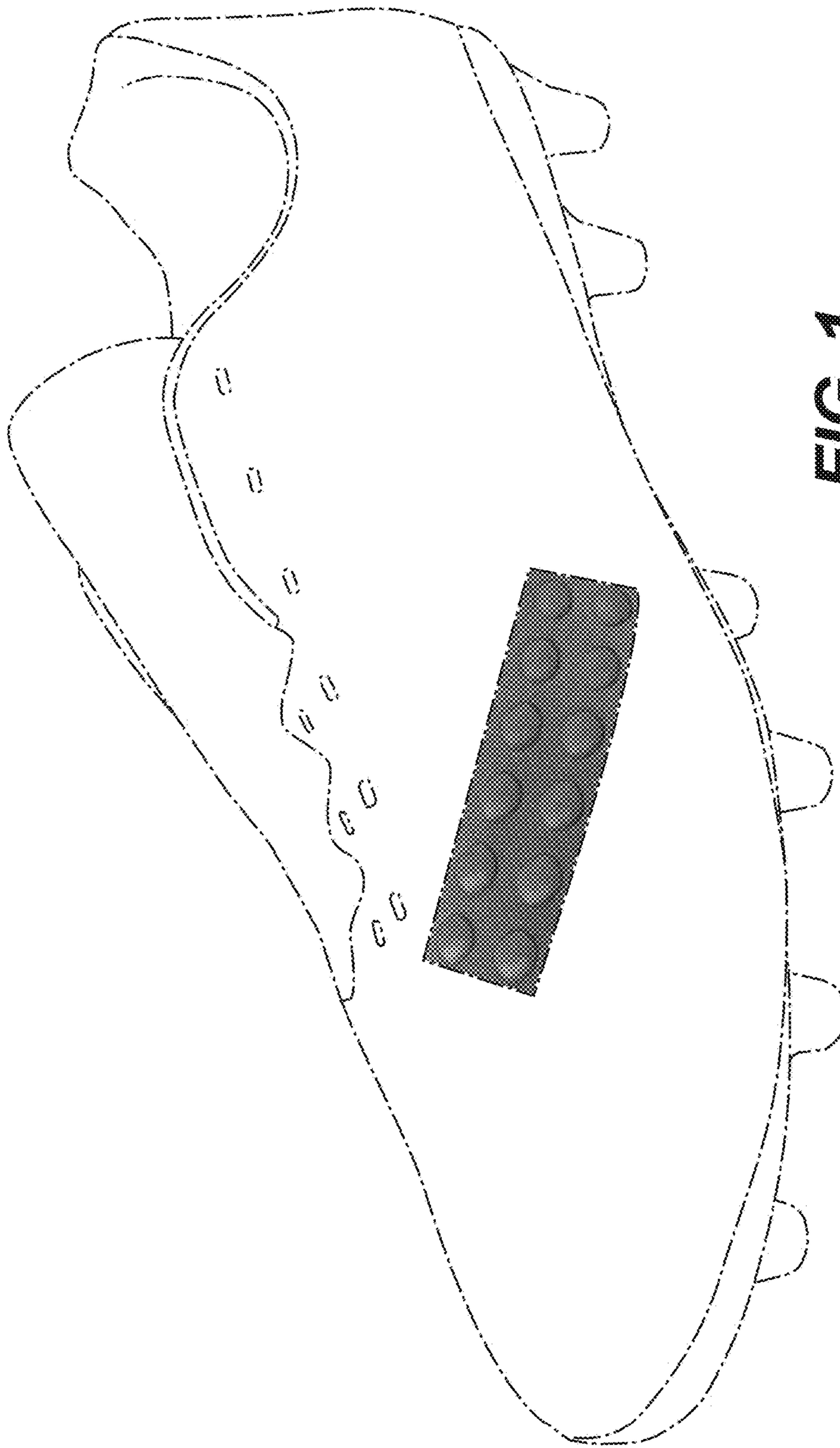

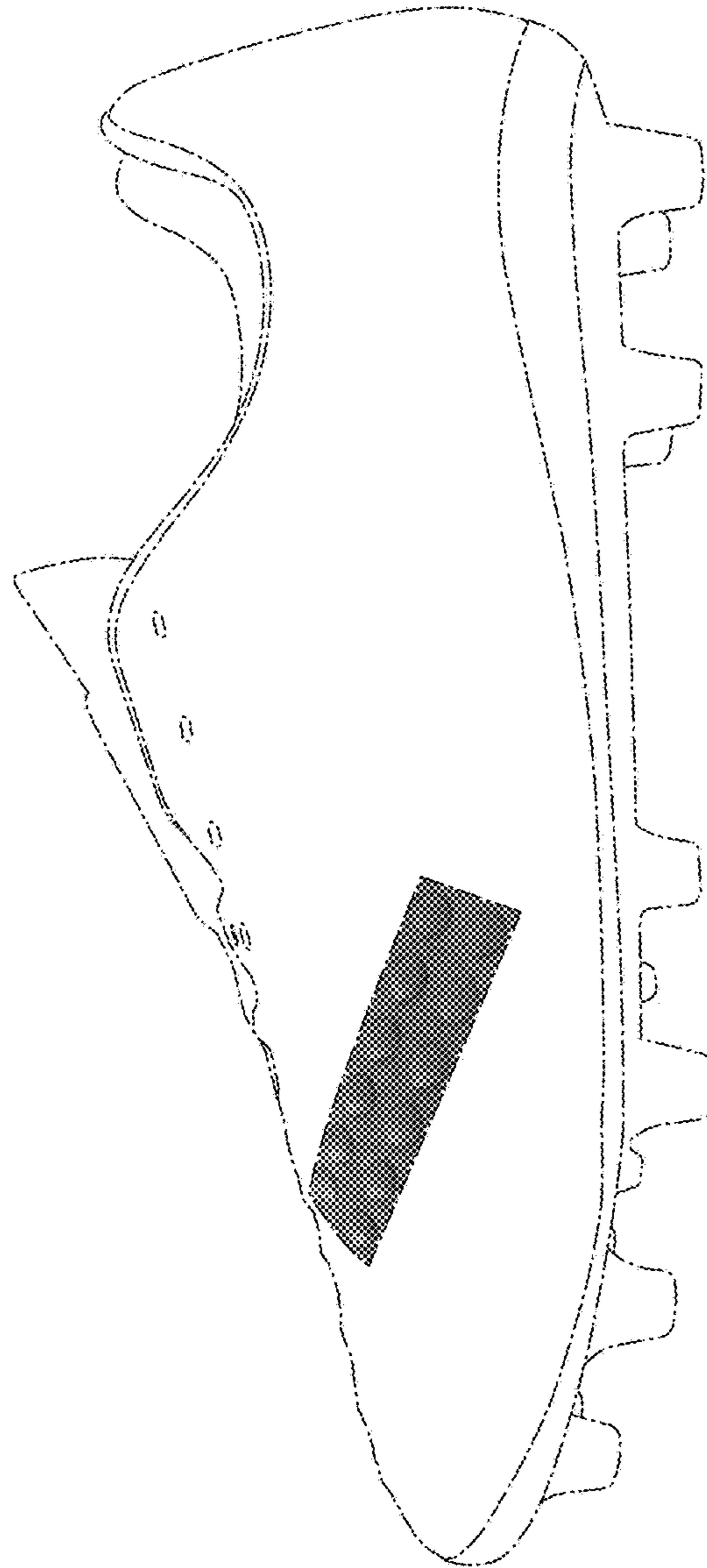
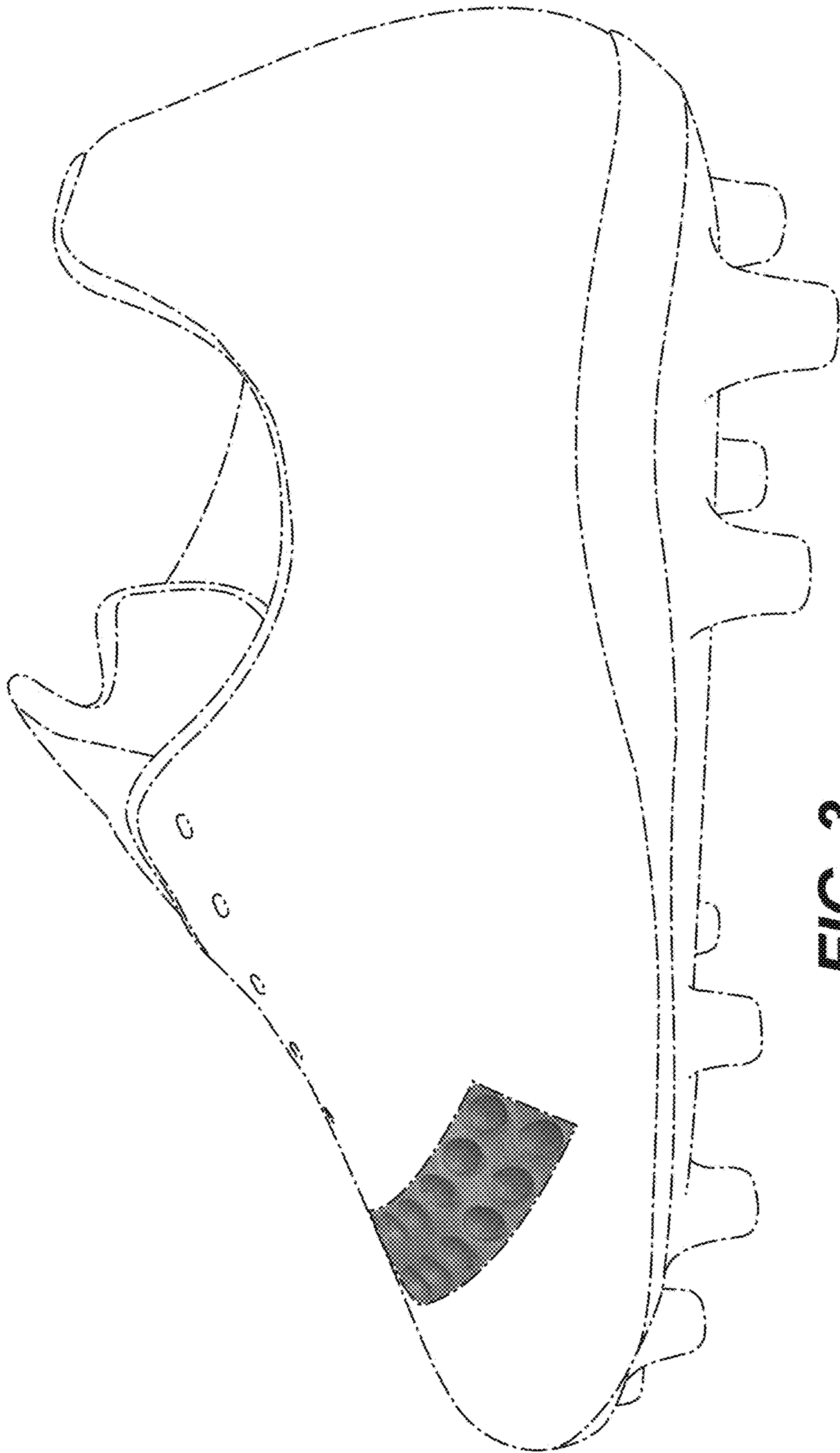

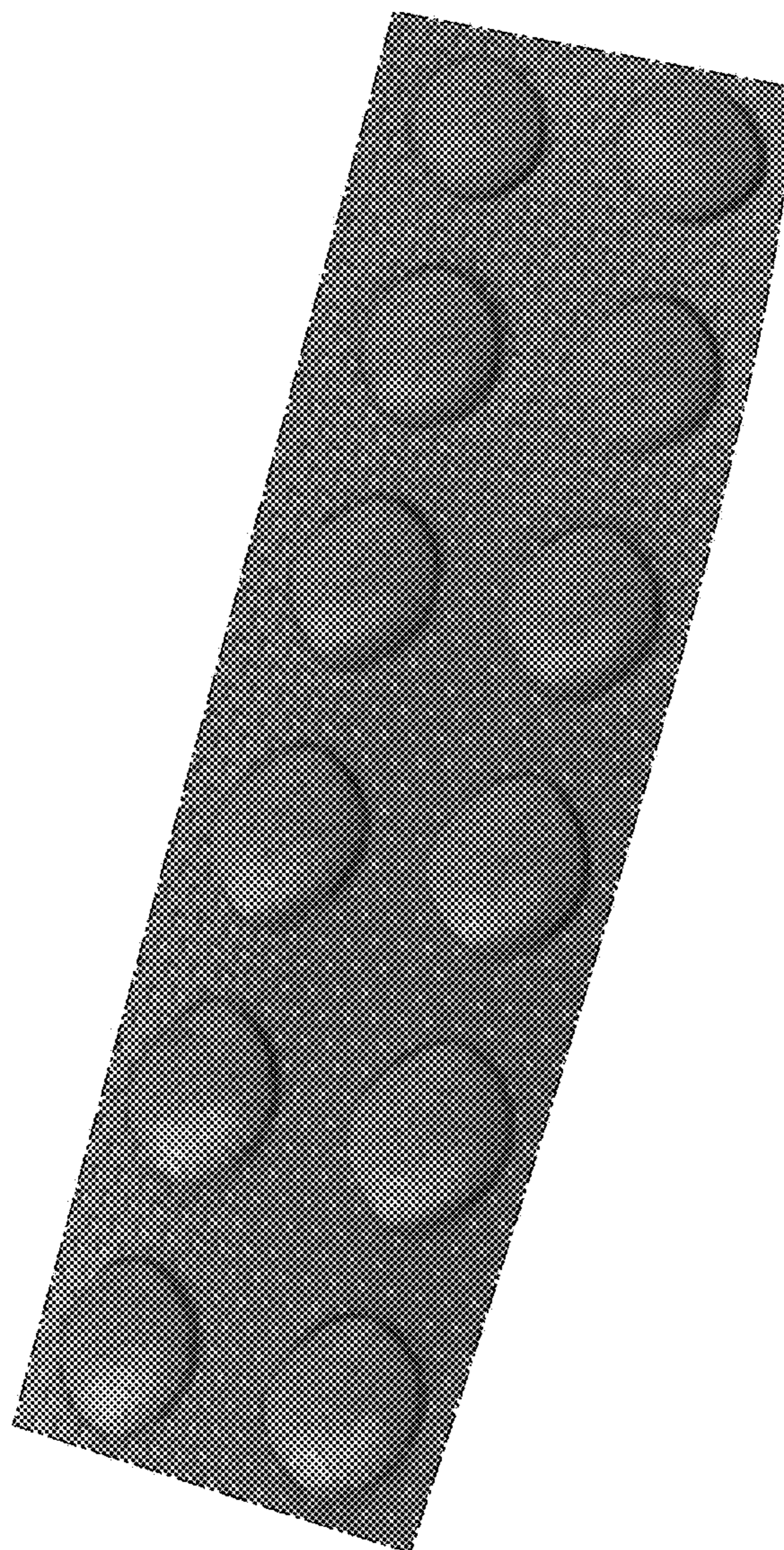
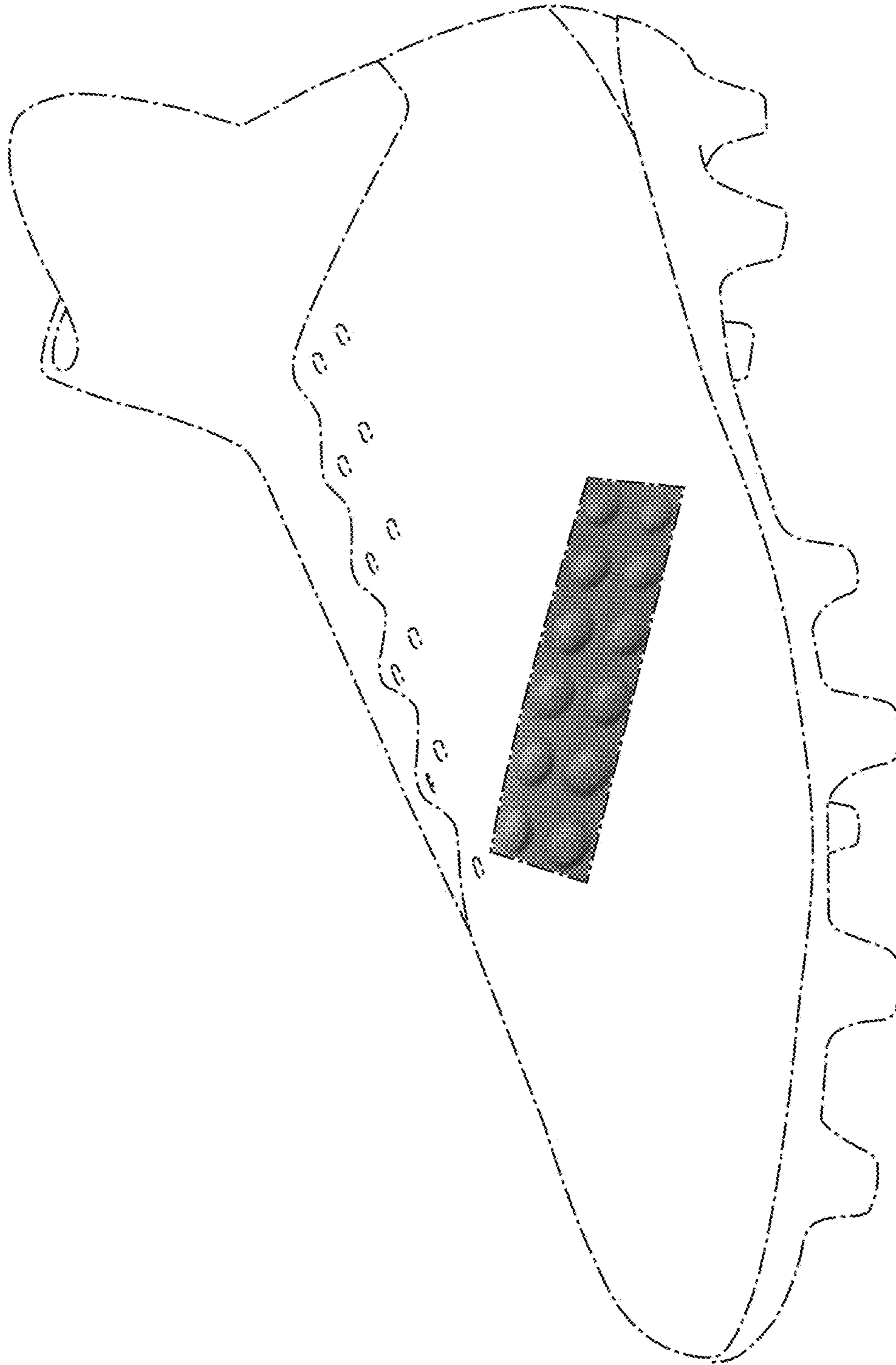
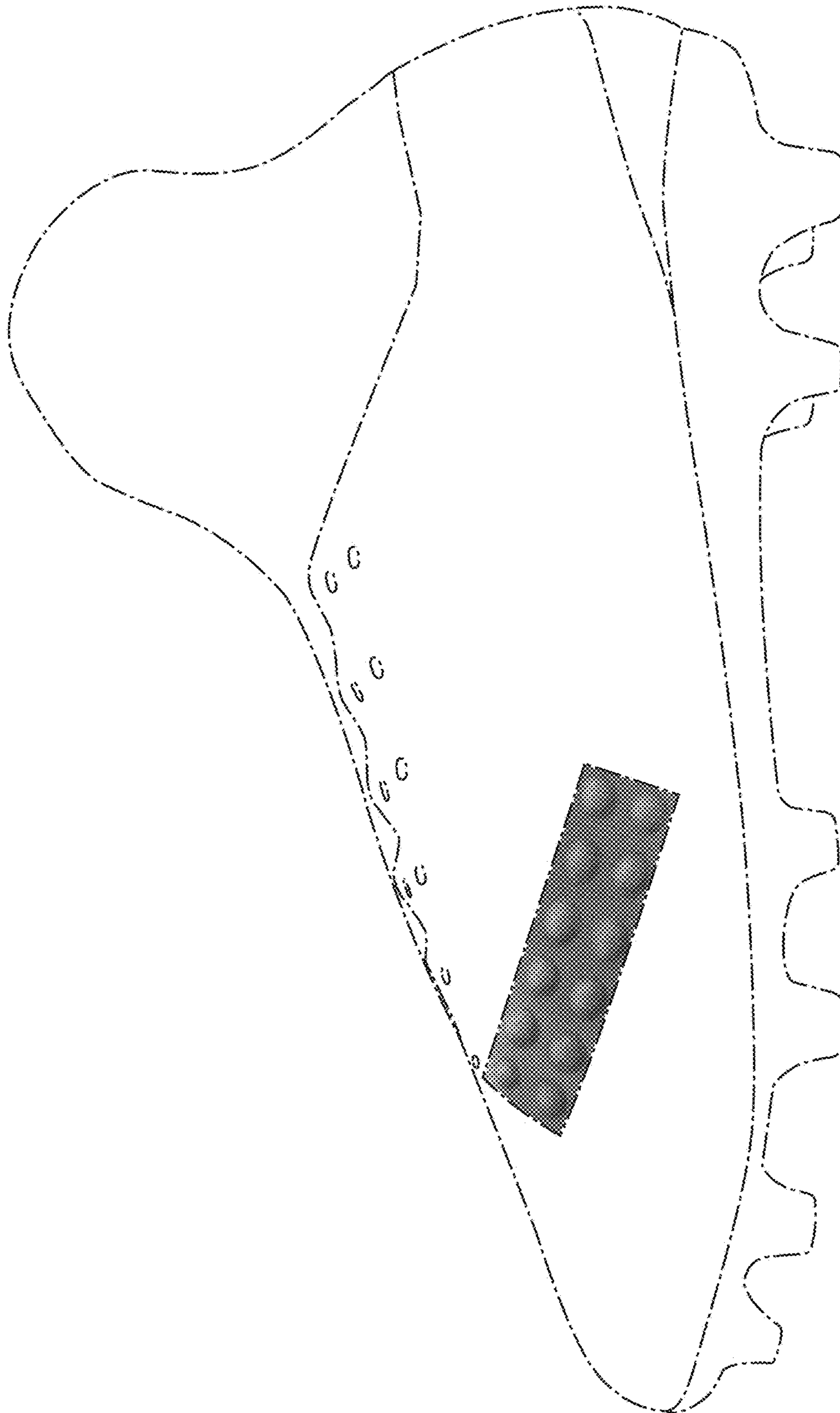

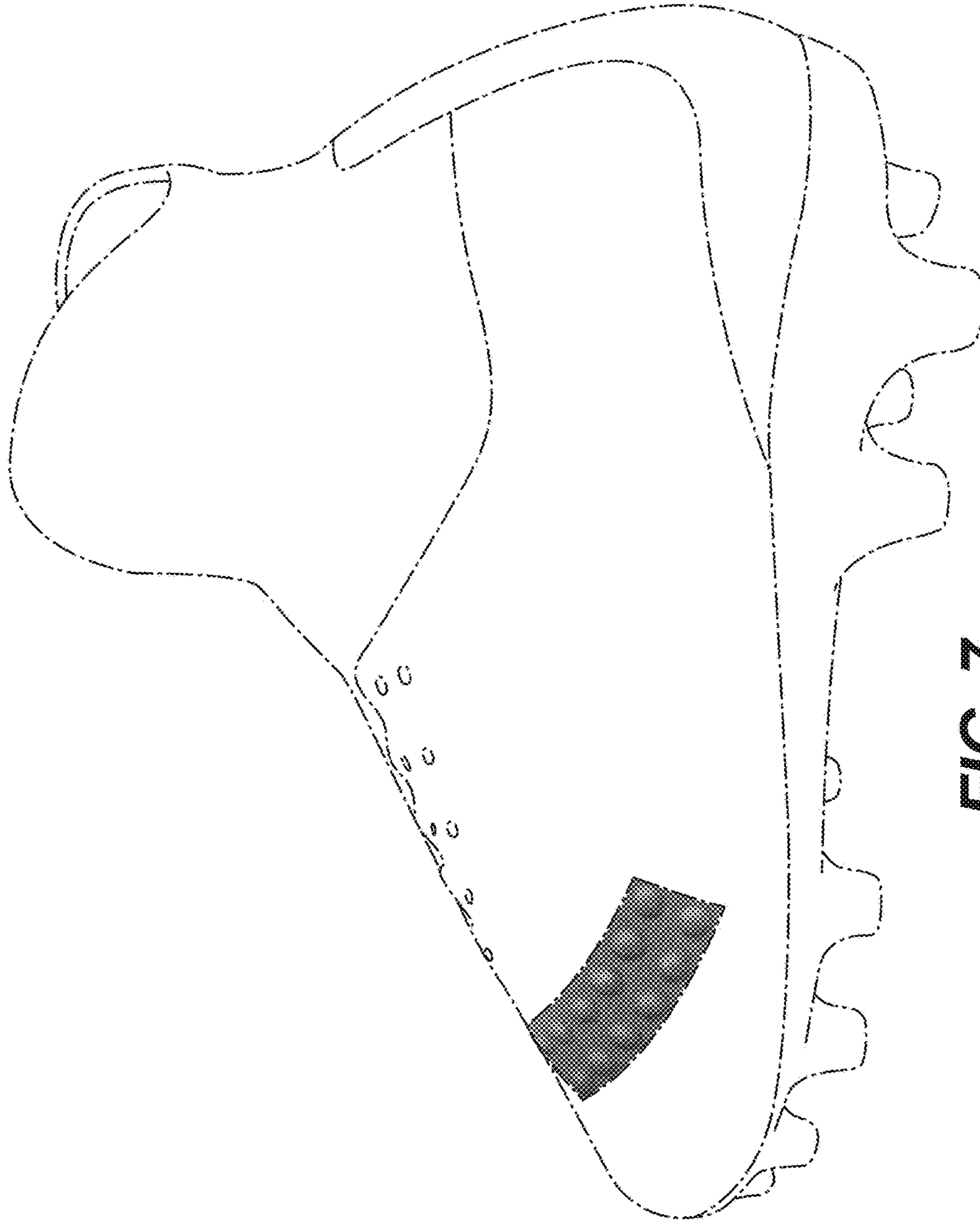

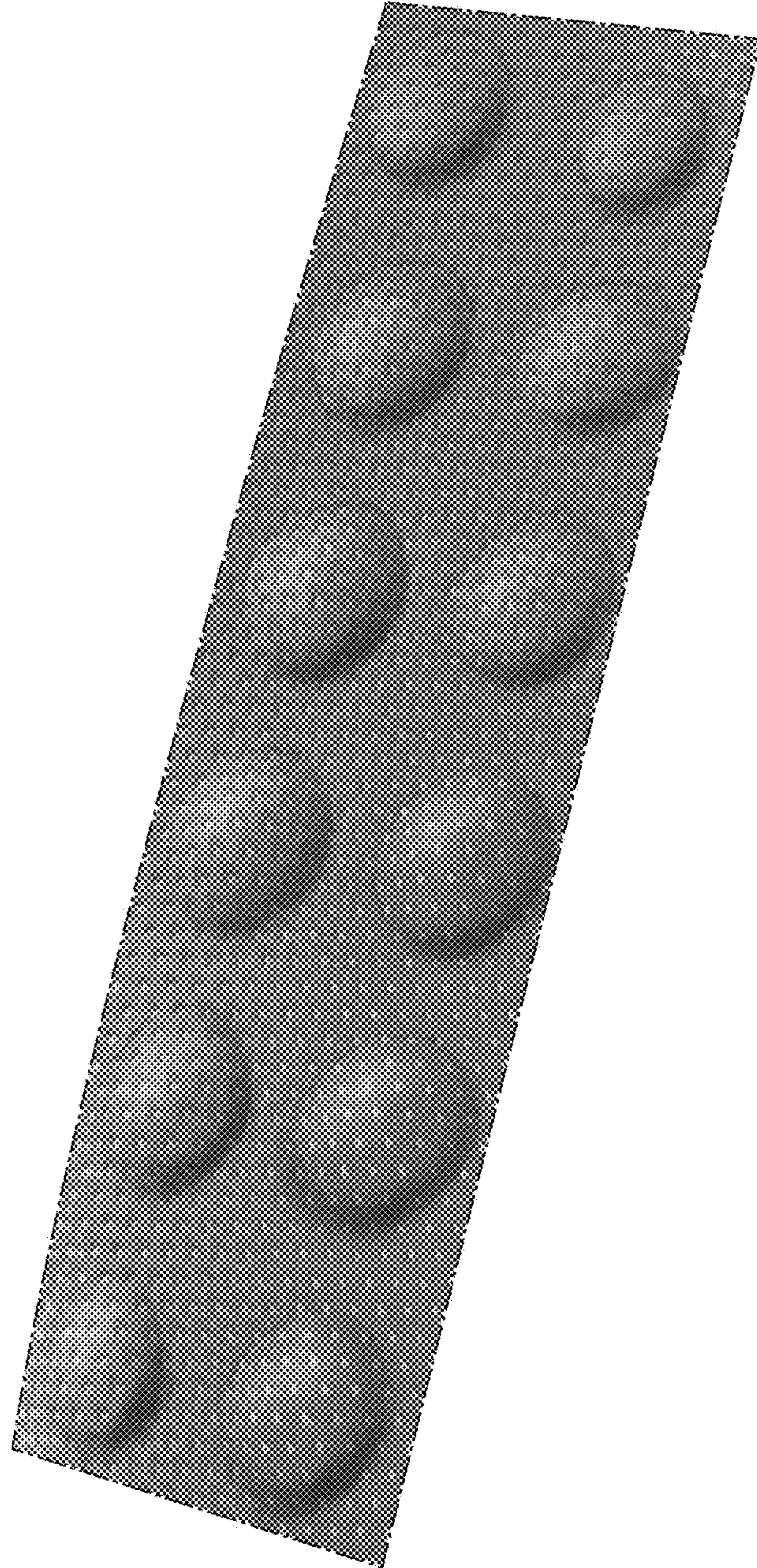
