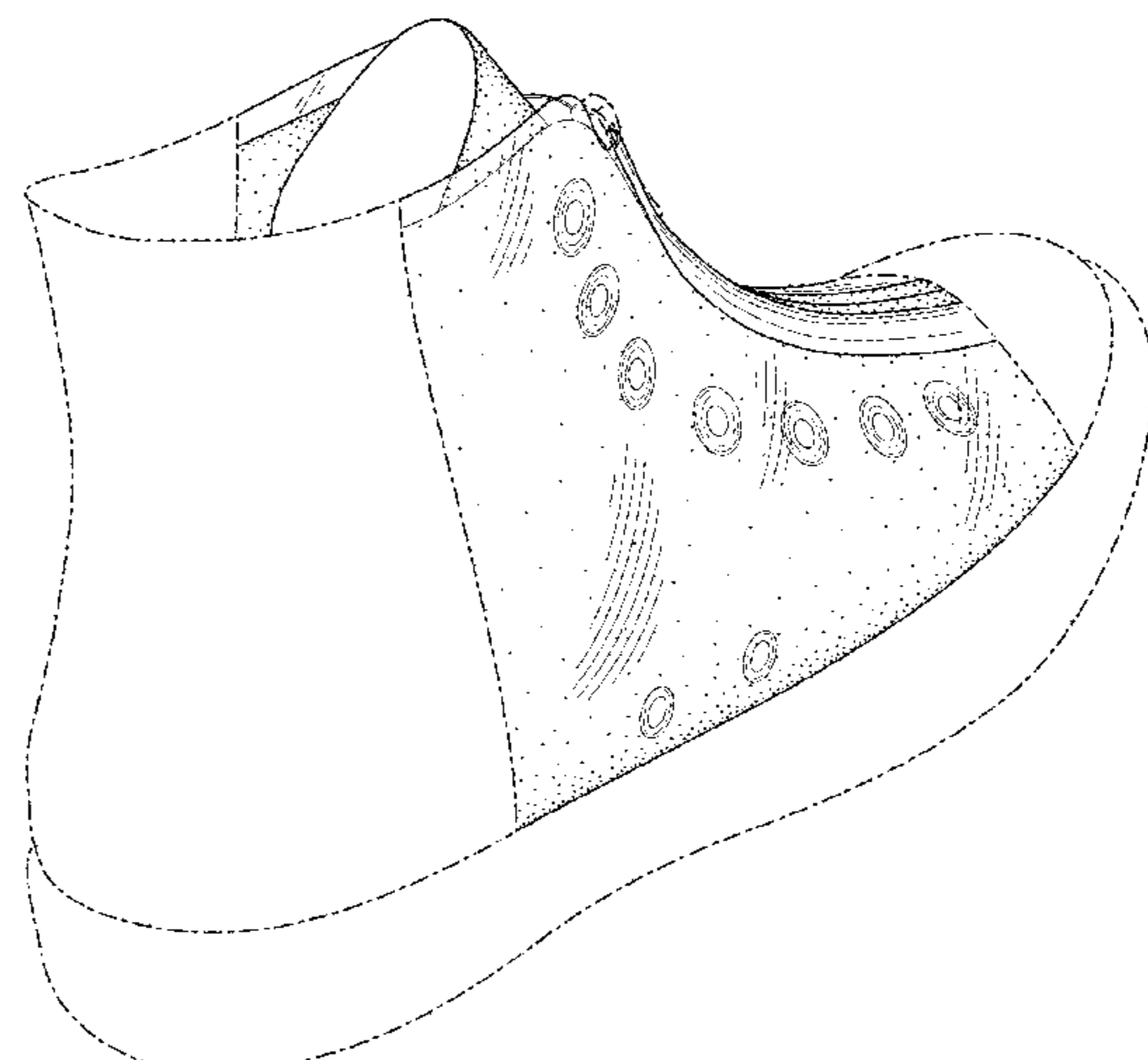
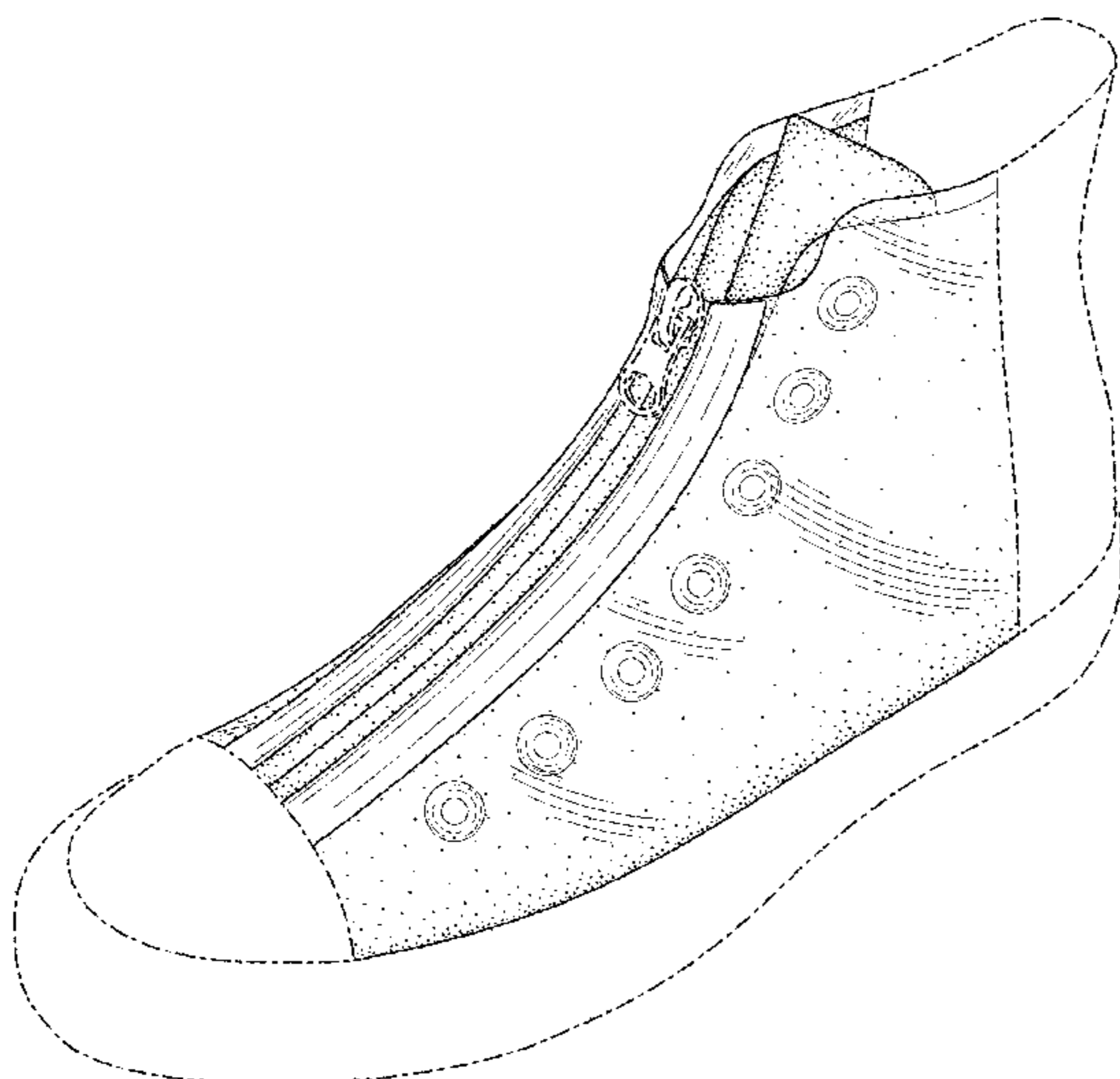
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper with a transparent overlay showing my new design;  
FIG. 2 is a medial view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a second front perspective view thereof;  
FIG. 6 is a lateral view thereof; and,  
FIG. 7 is a rear perspective view thereof.

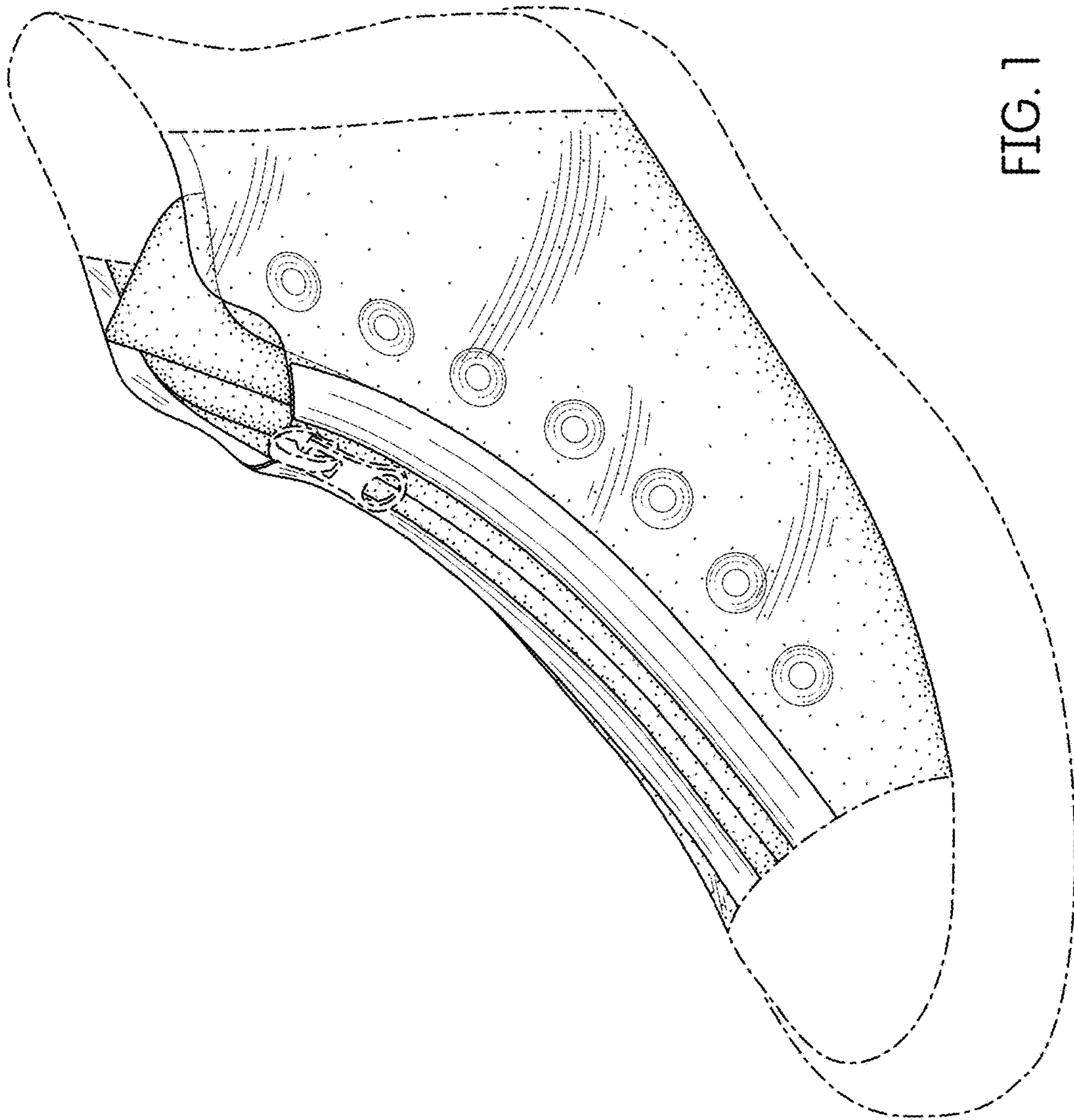

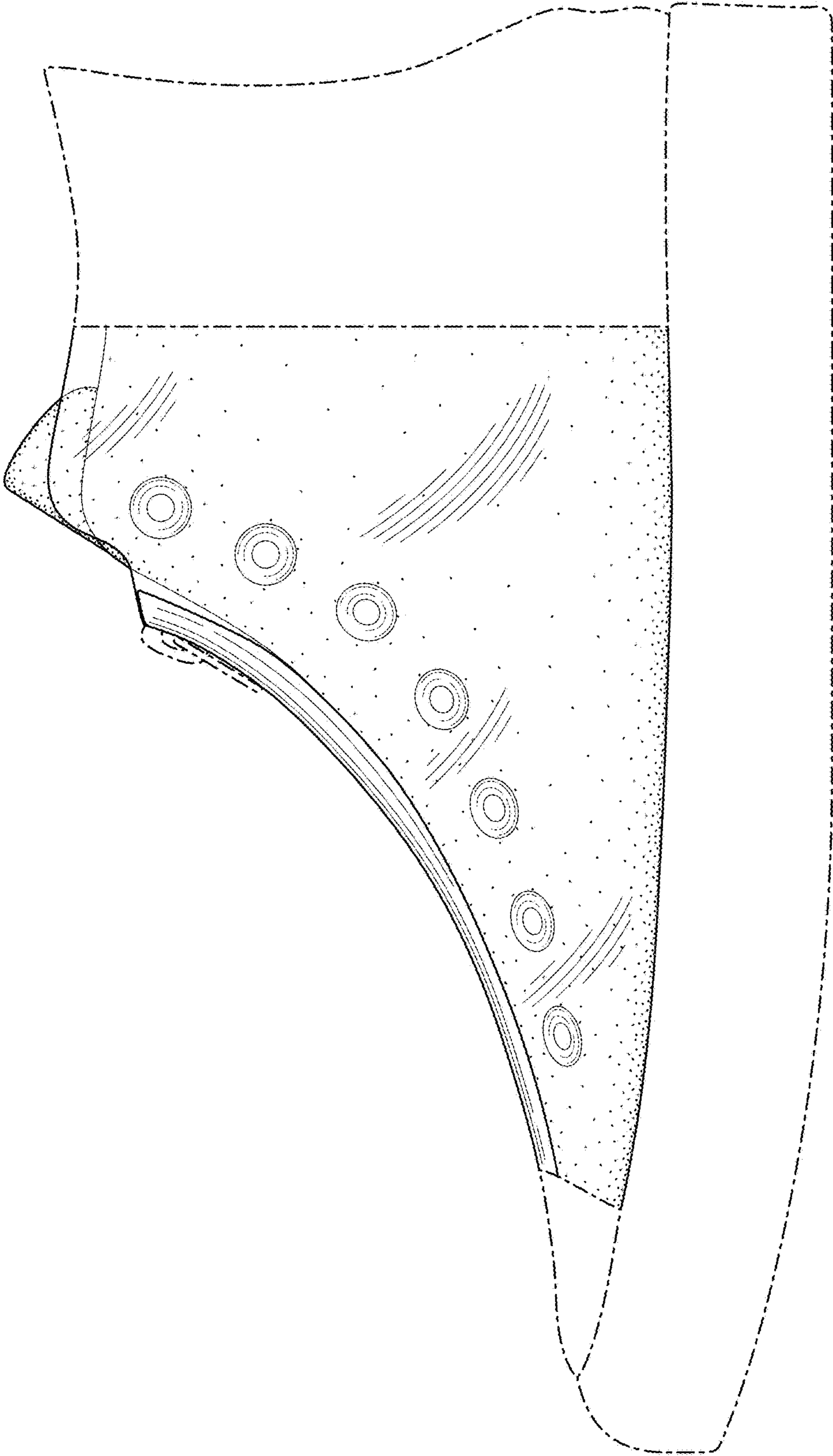

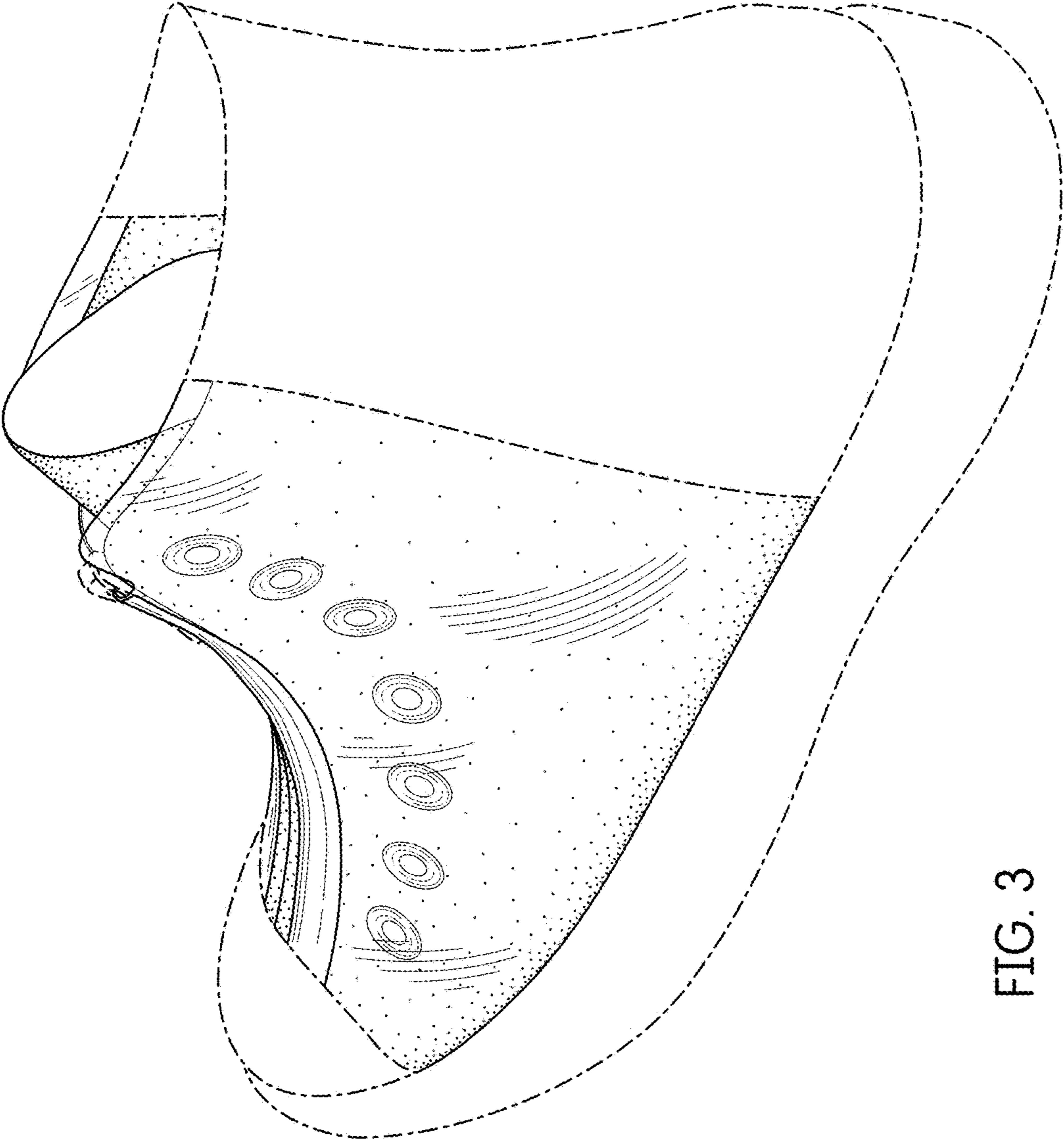

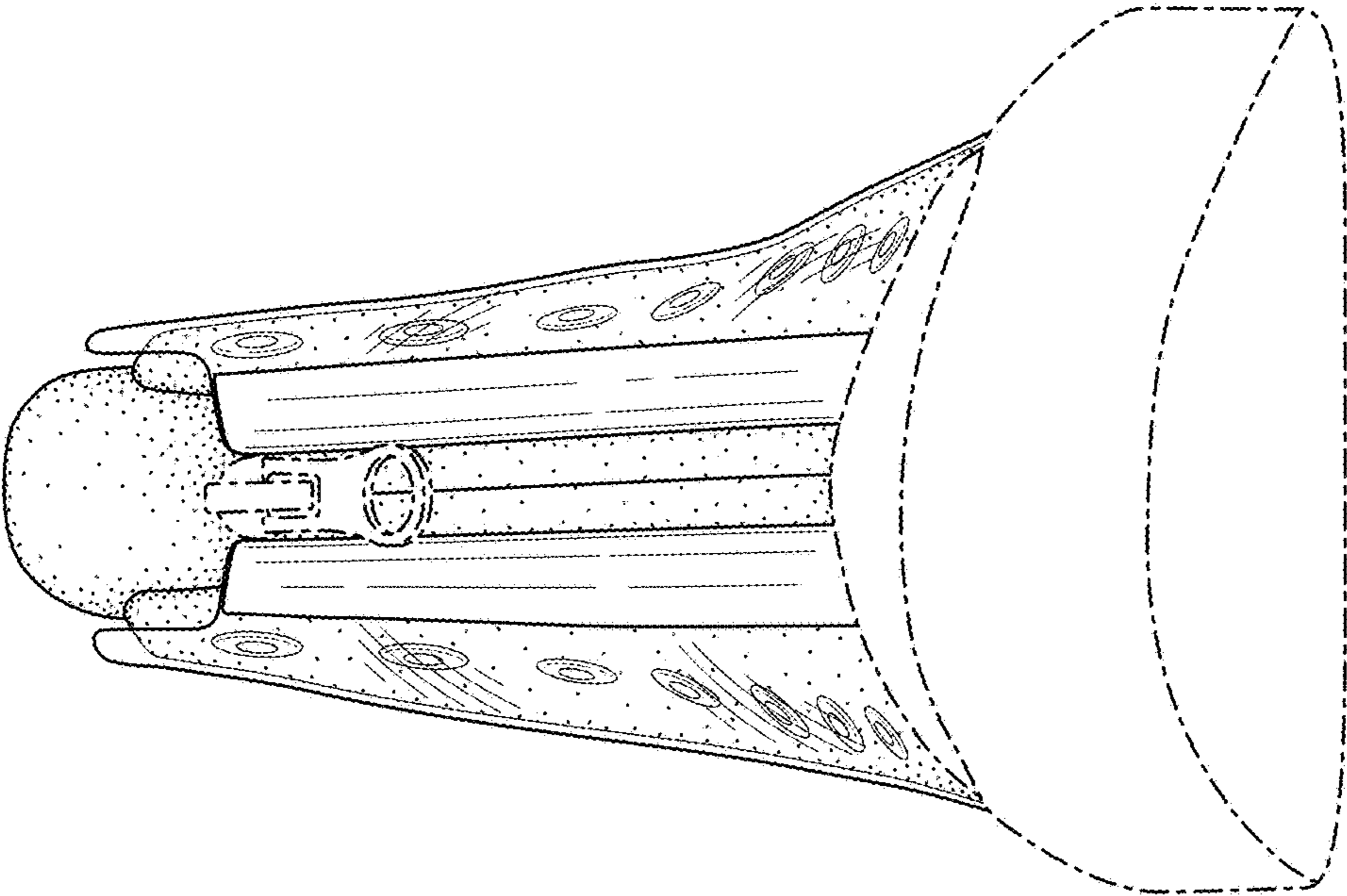

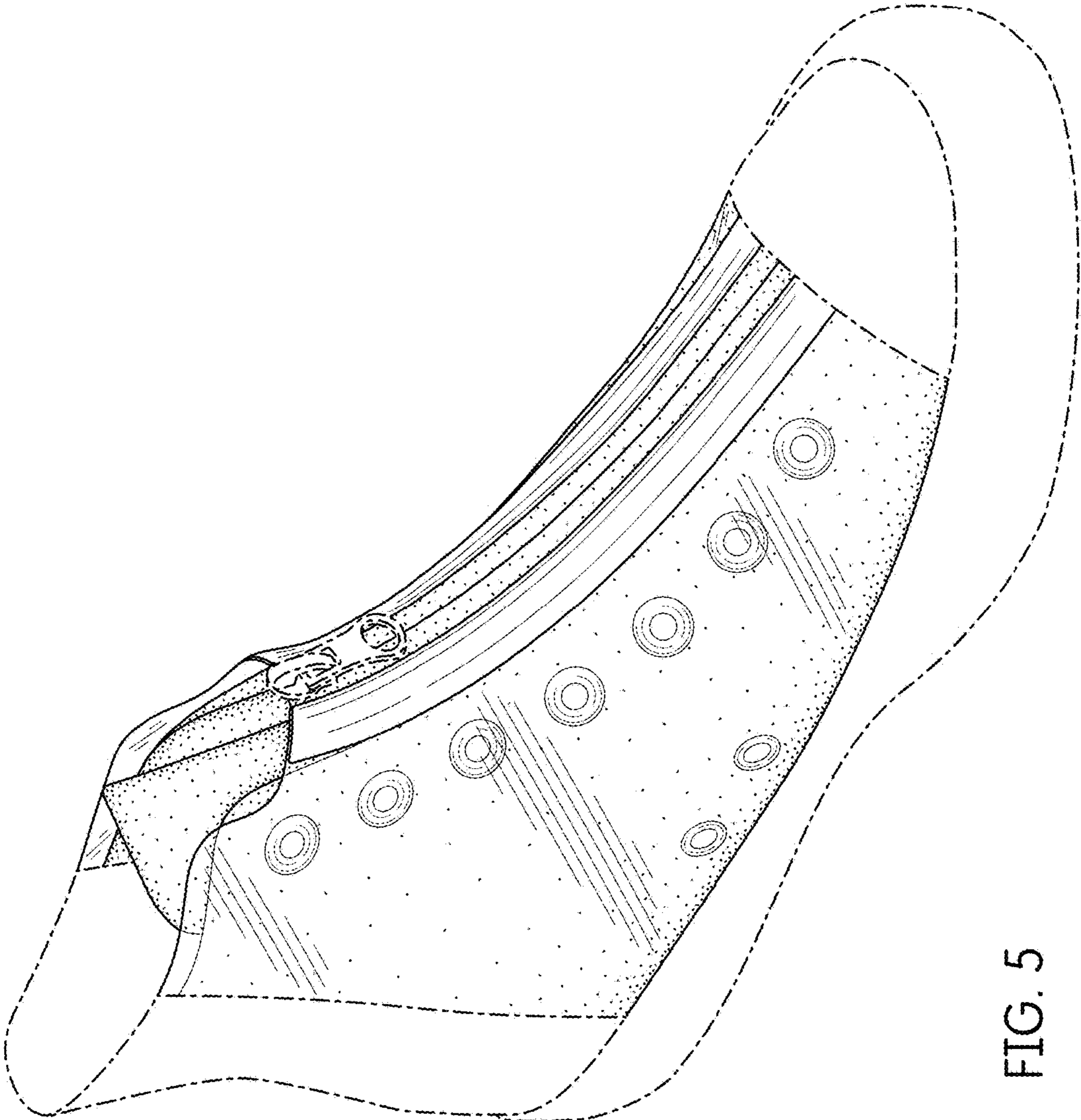

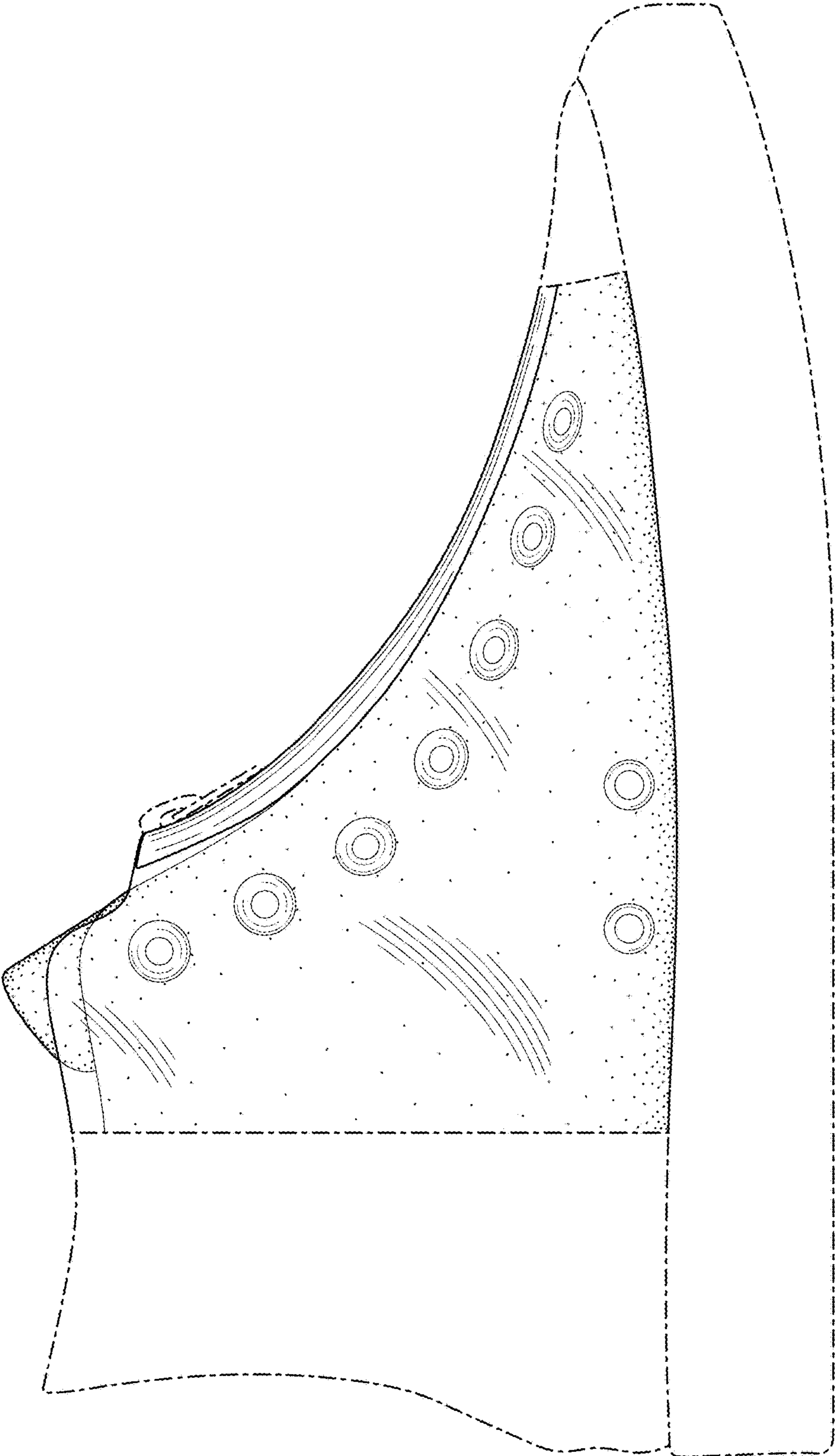

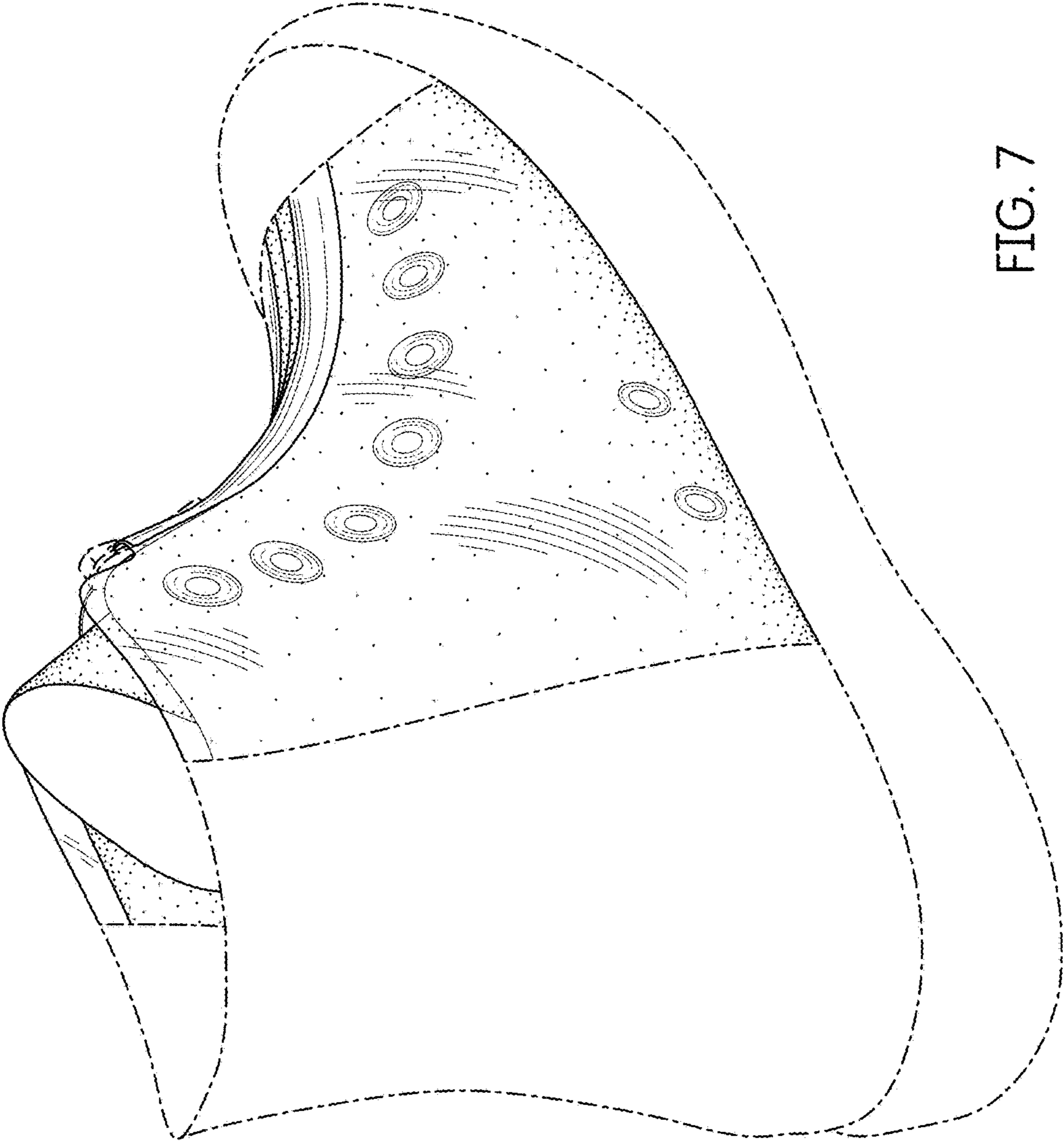
