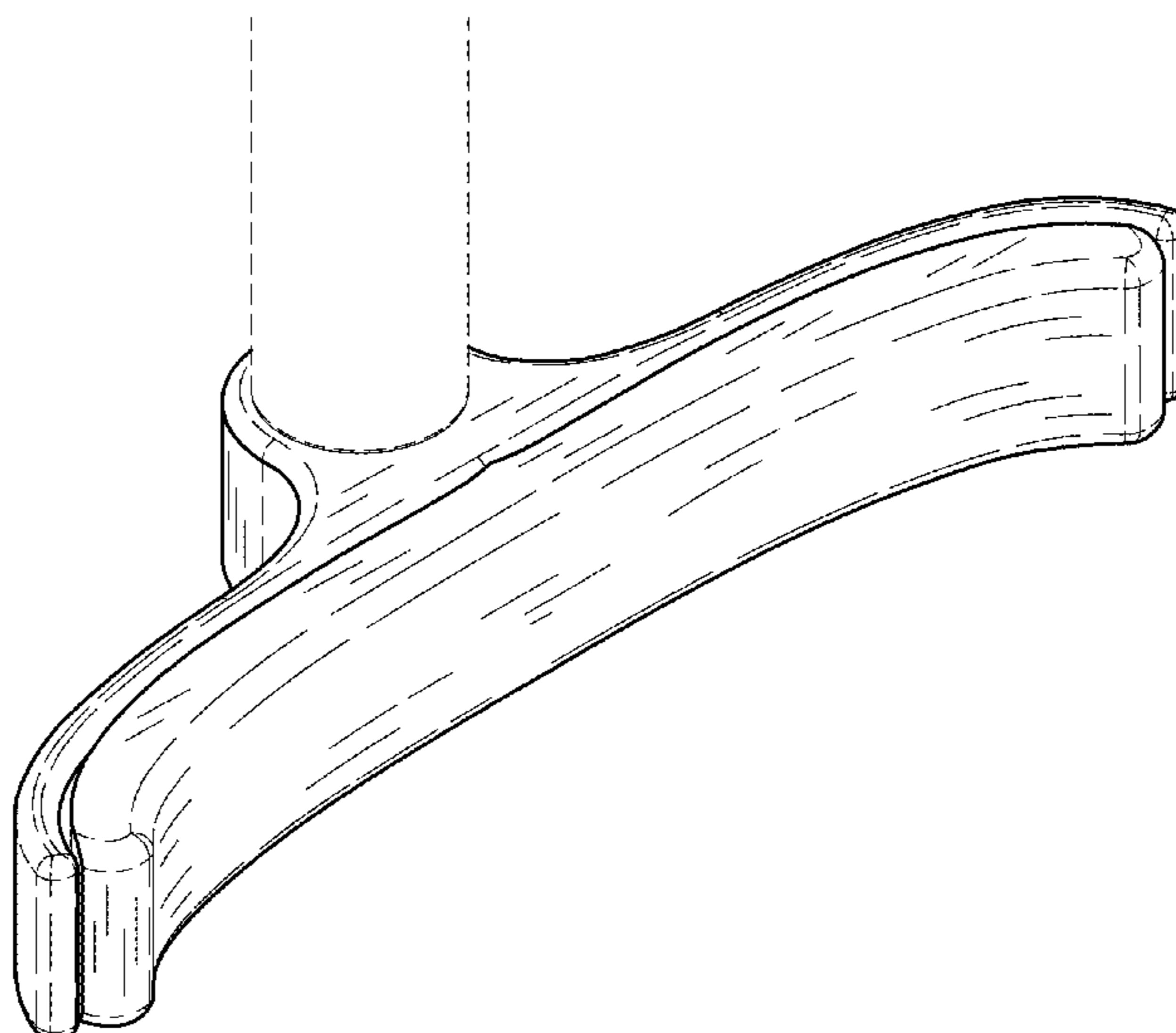
(57) **CLAIM**

The ornamental design for a crutch support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a crutch support showing the new design;
FIG. 2 is a bottom view of the crutch support;
FIG. 3 is a top view of the crutch support;
FIG. 4 is a left side view of the crutch support, the right side being a mirror image thereof;
FIG. 5 is a back view of the crutch support; and,
FIG. 6 is a front view of the crutch support.

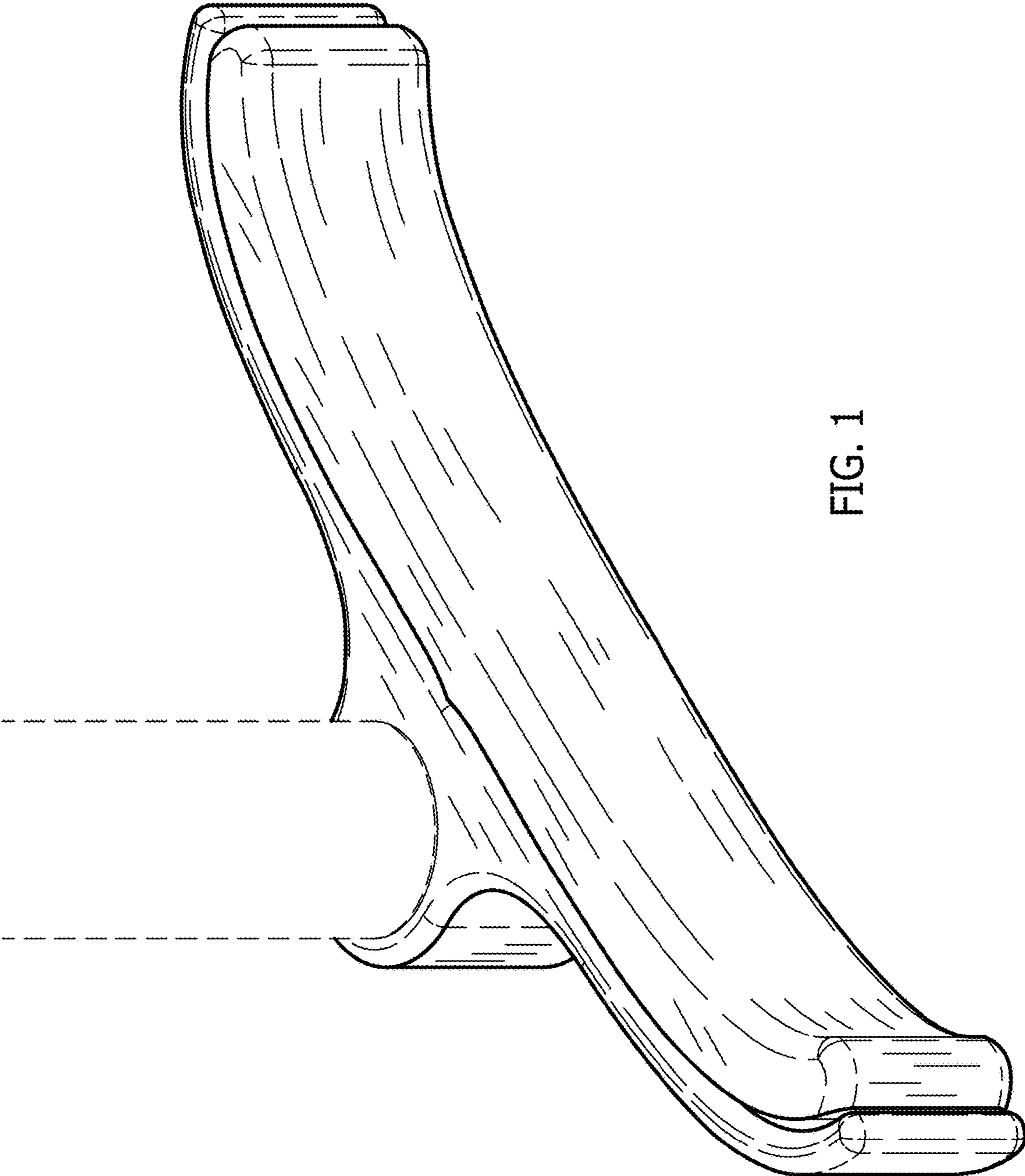

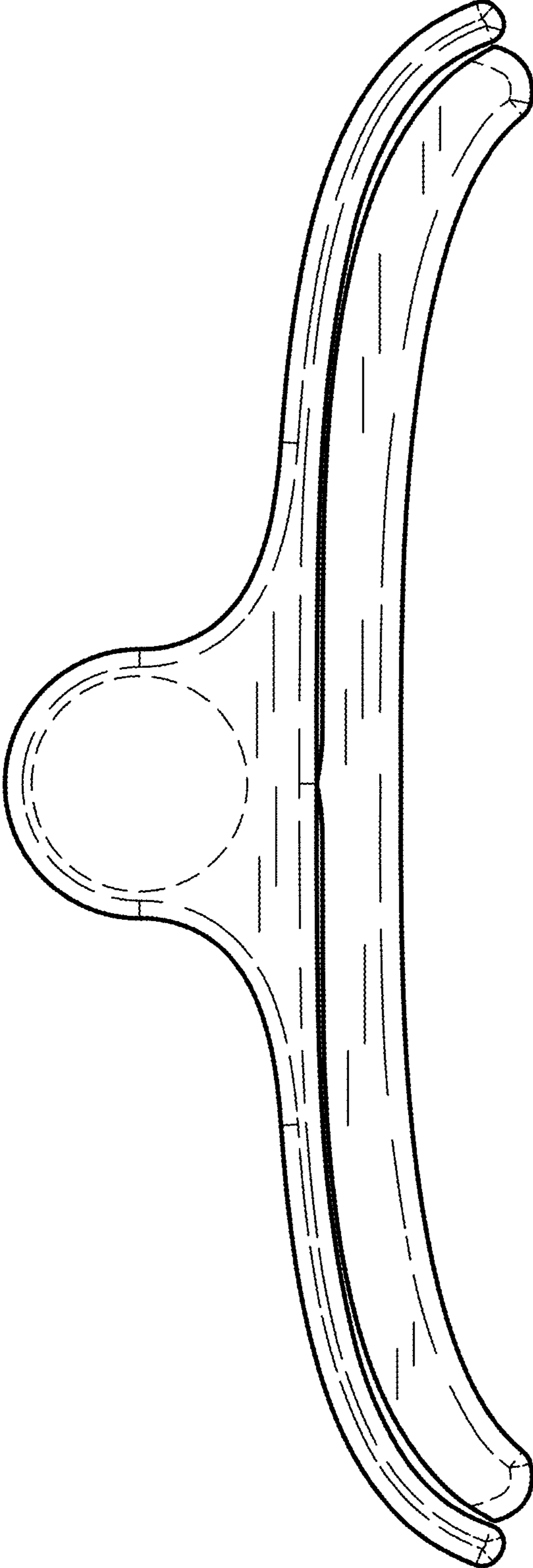

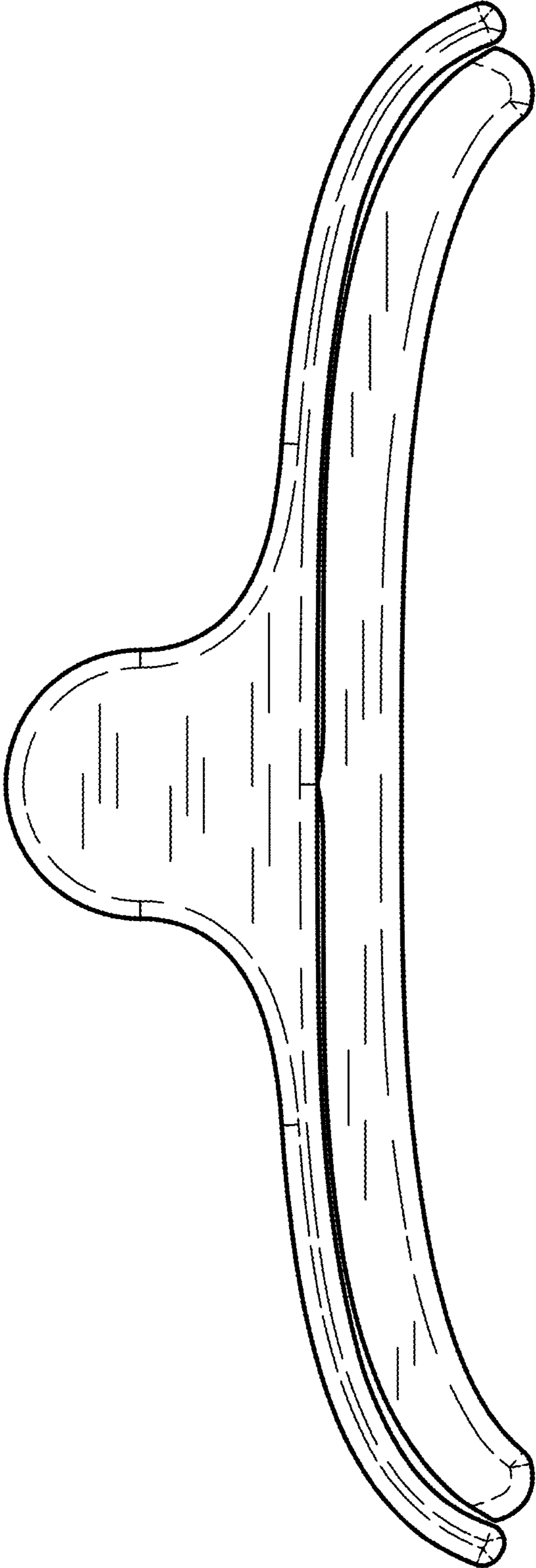

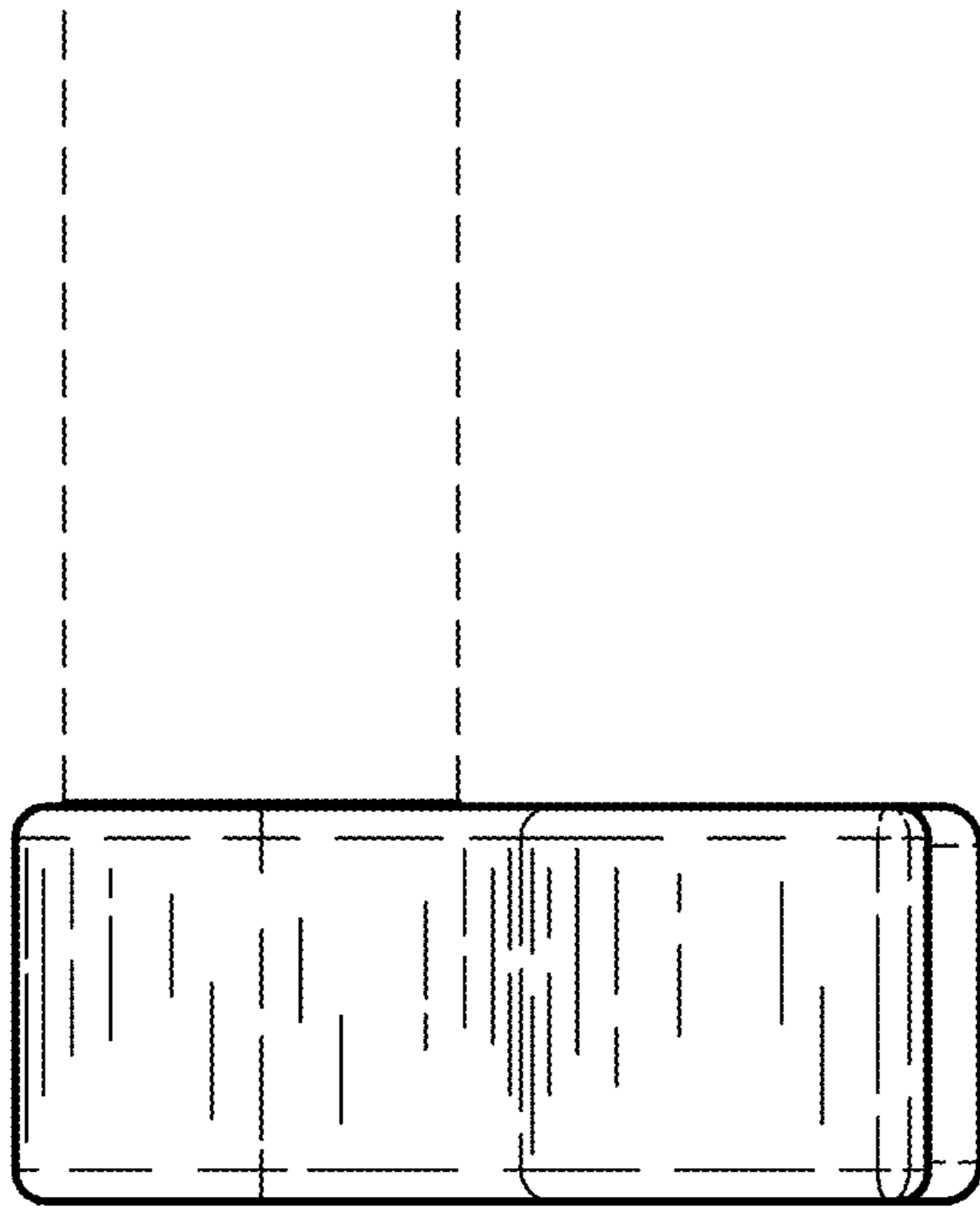

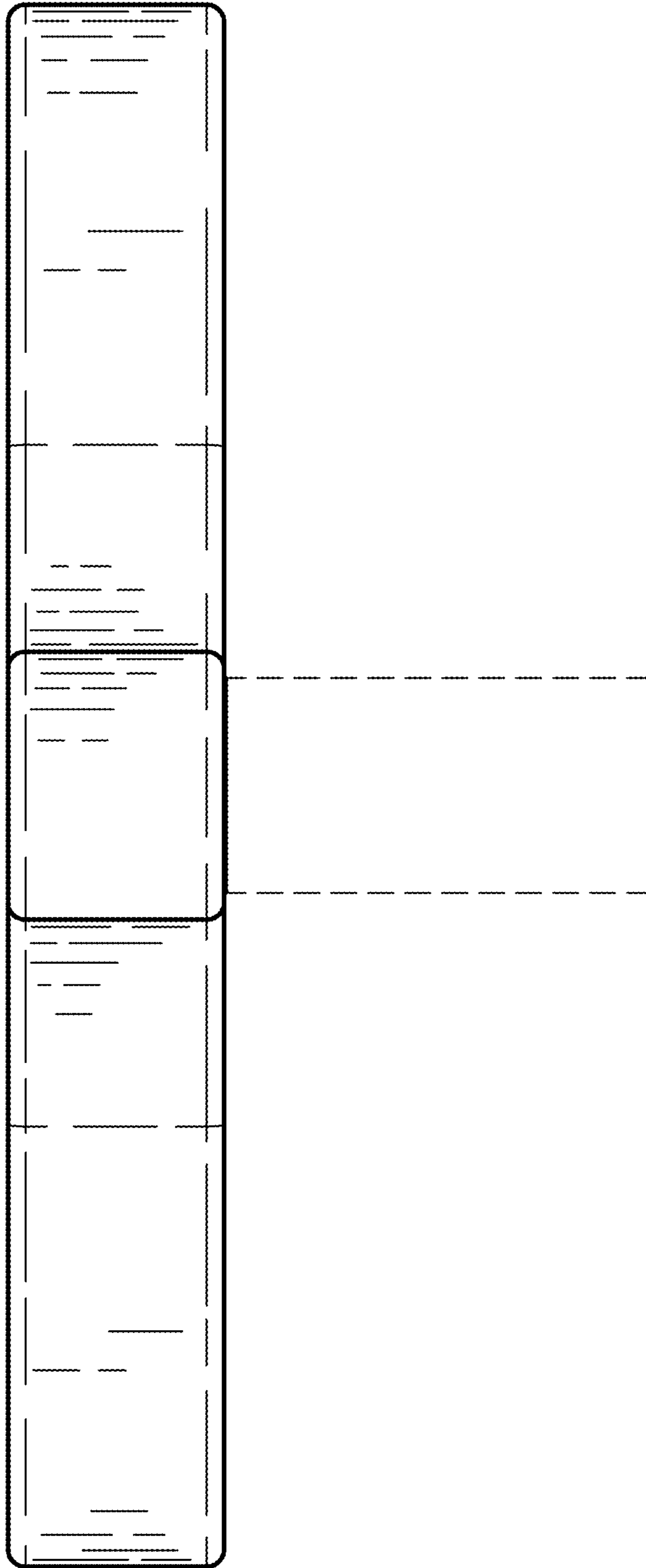

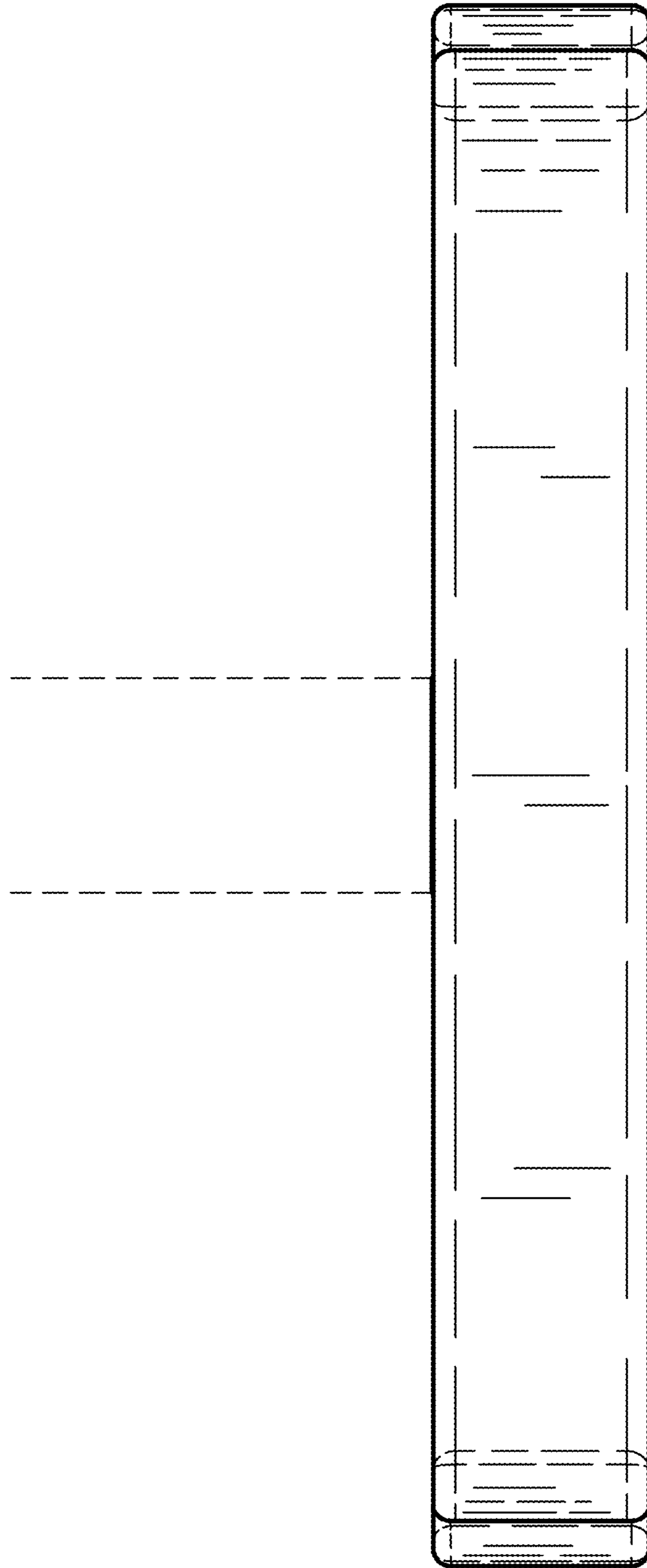
