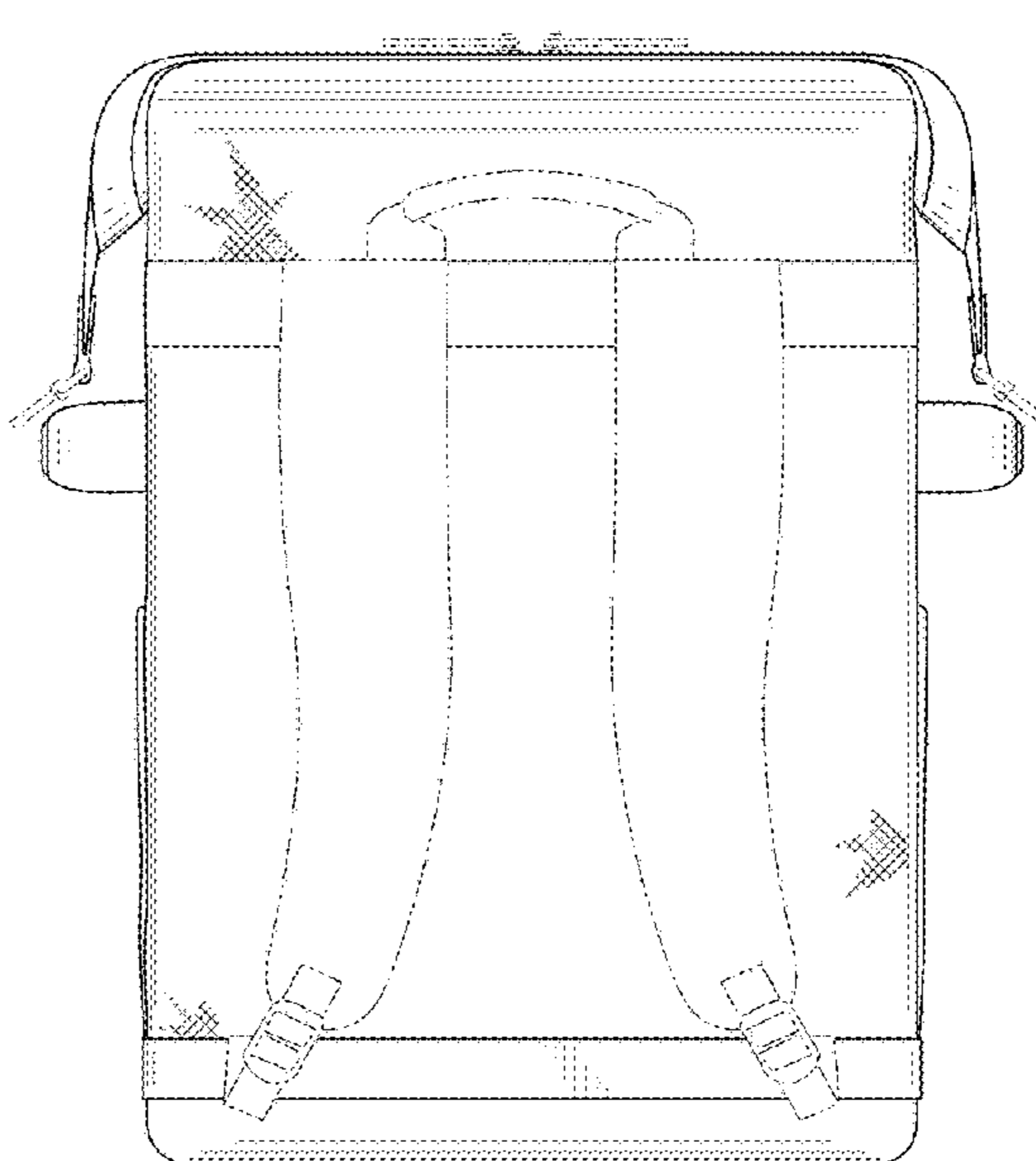
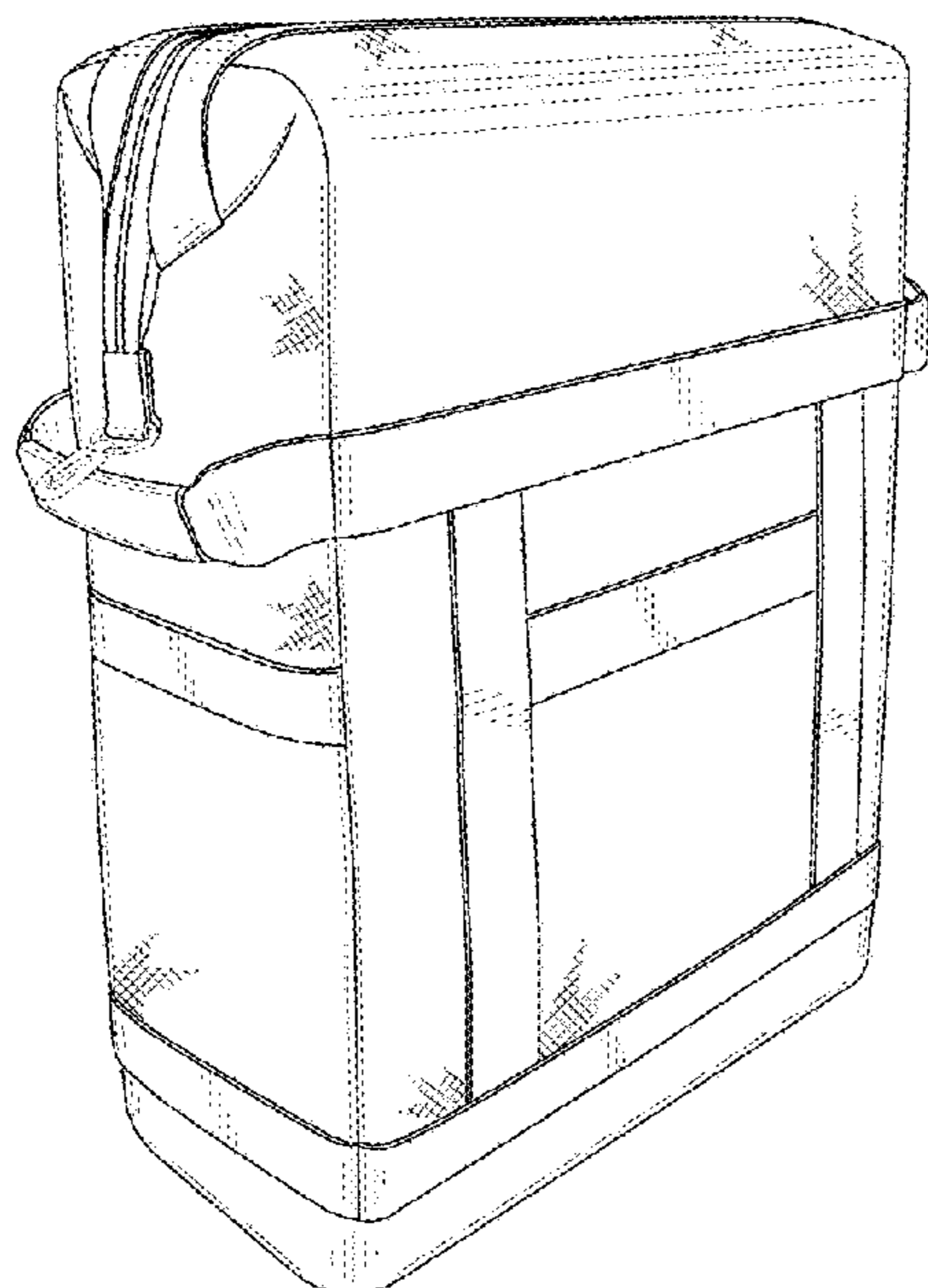
FIG. 1 is a perspective front side view of a backpack of the present invention;

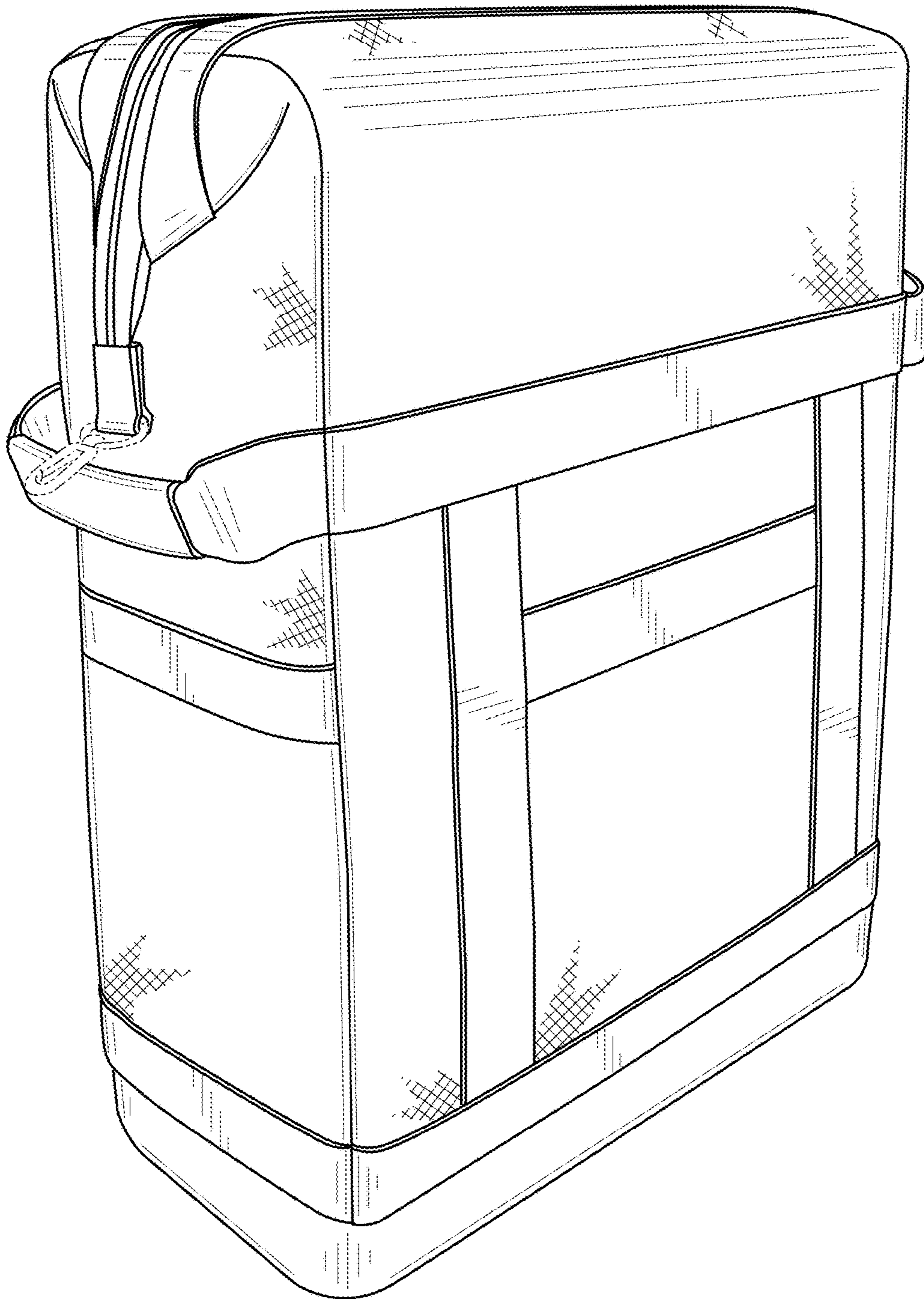

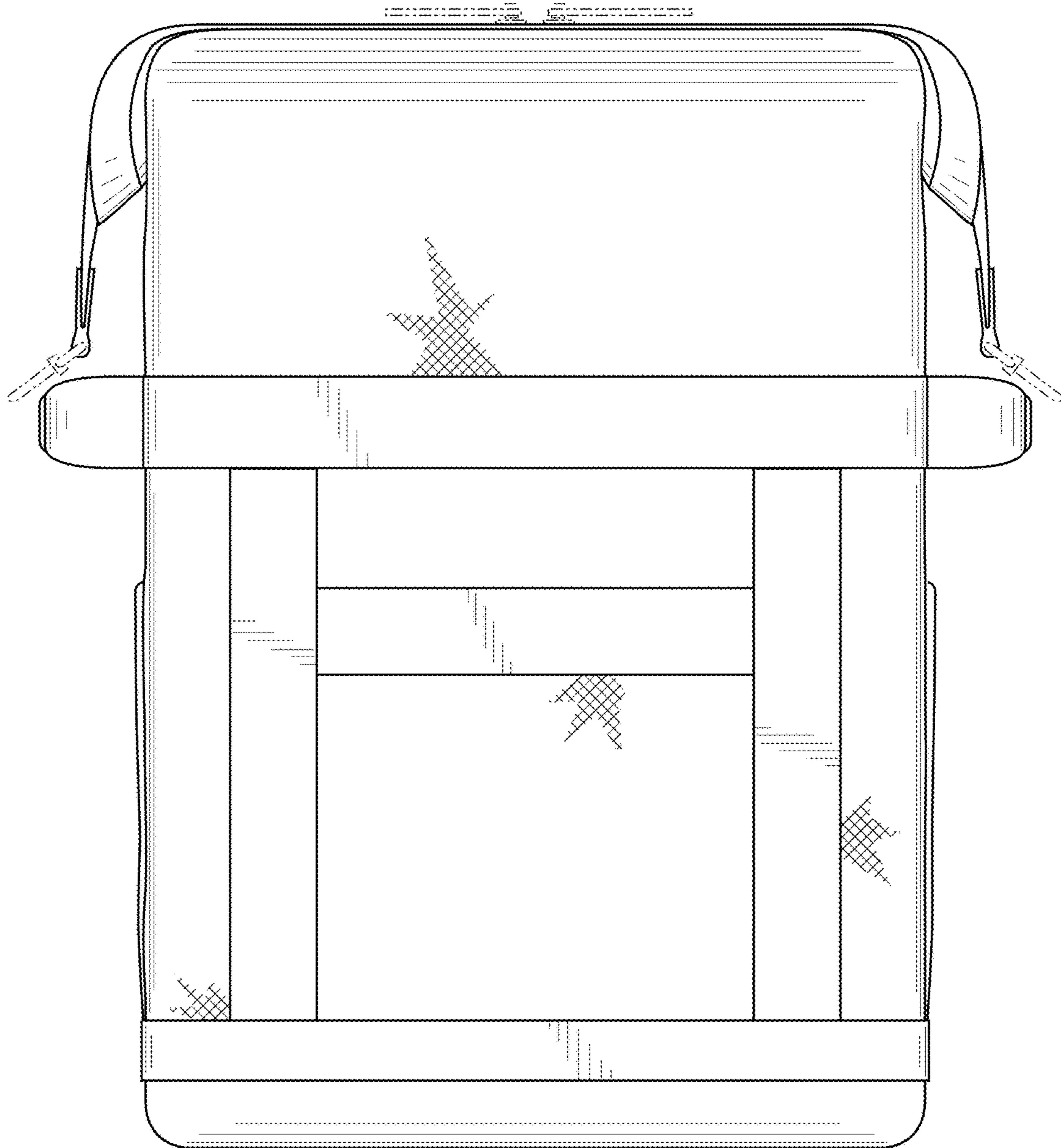

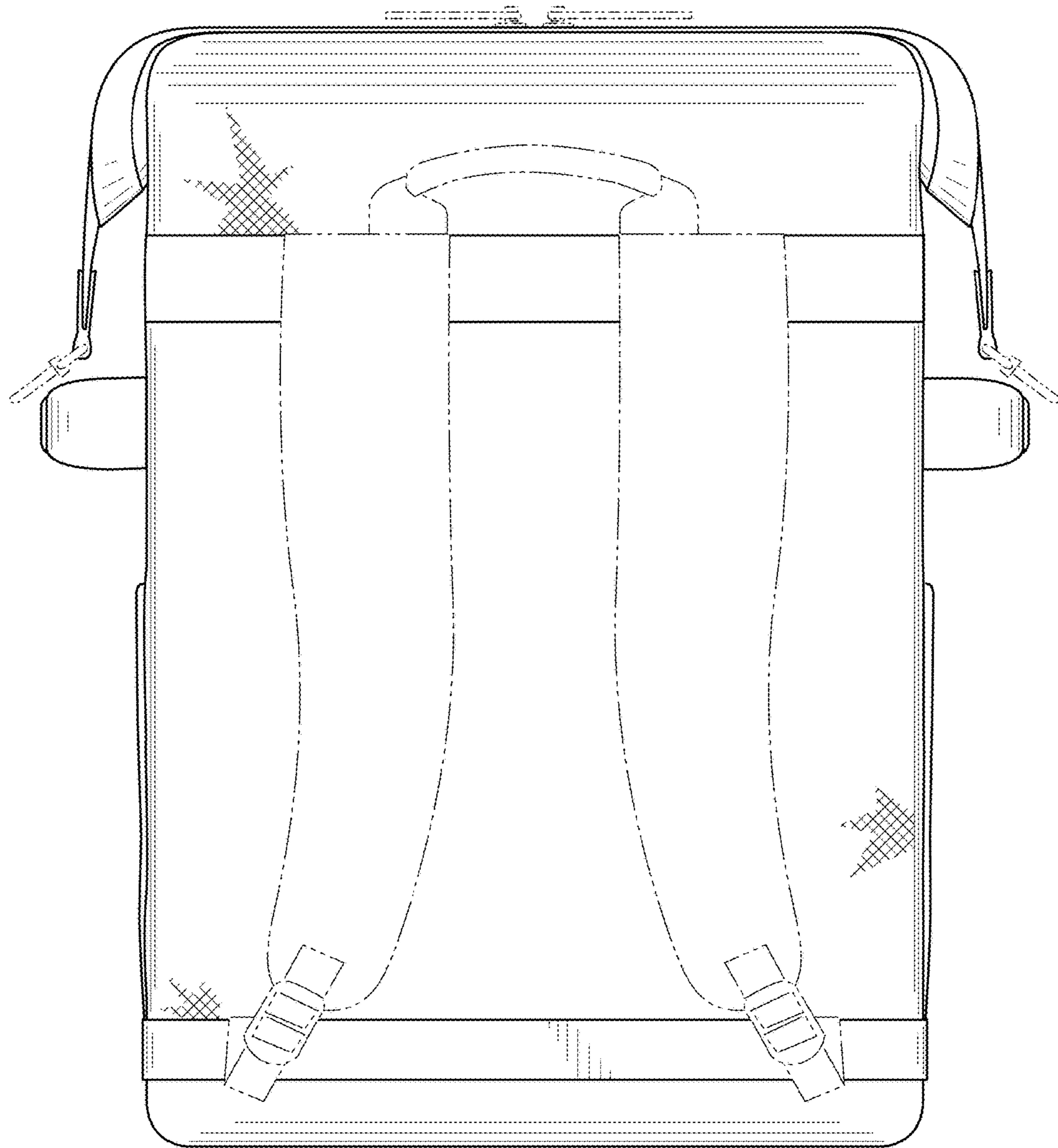

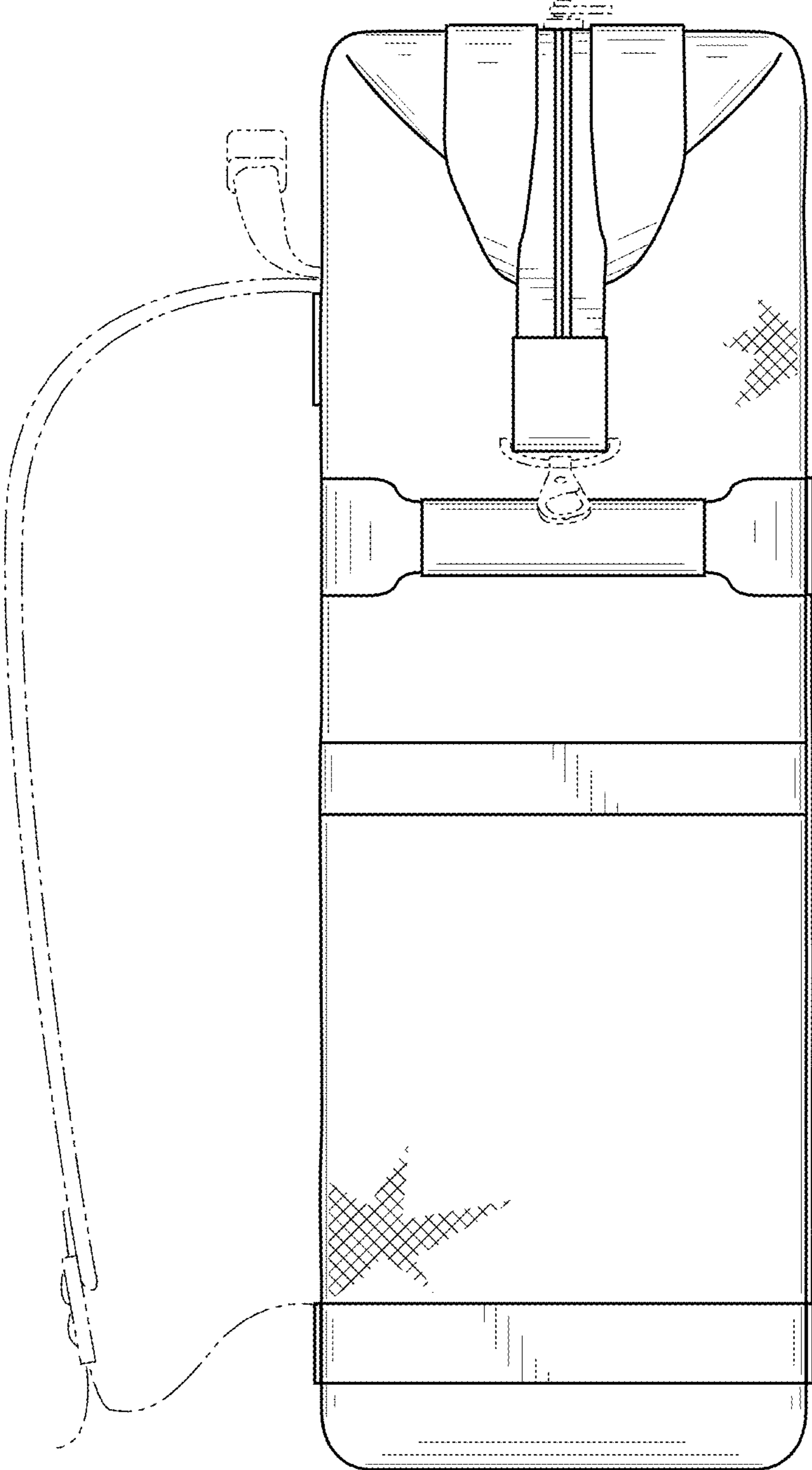

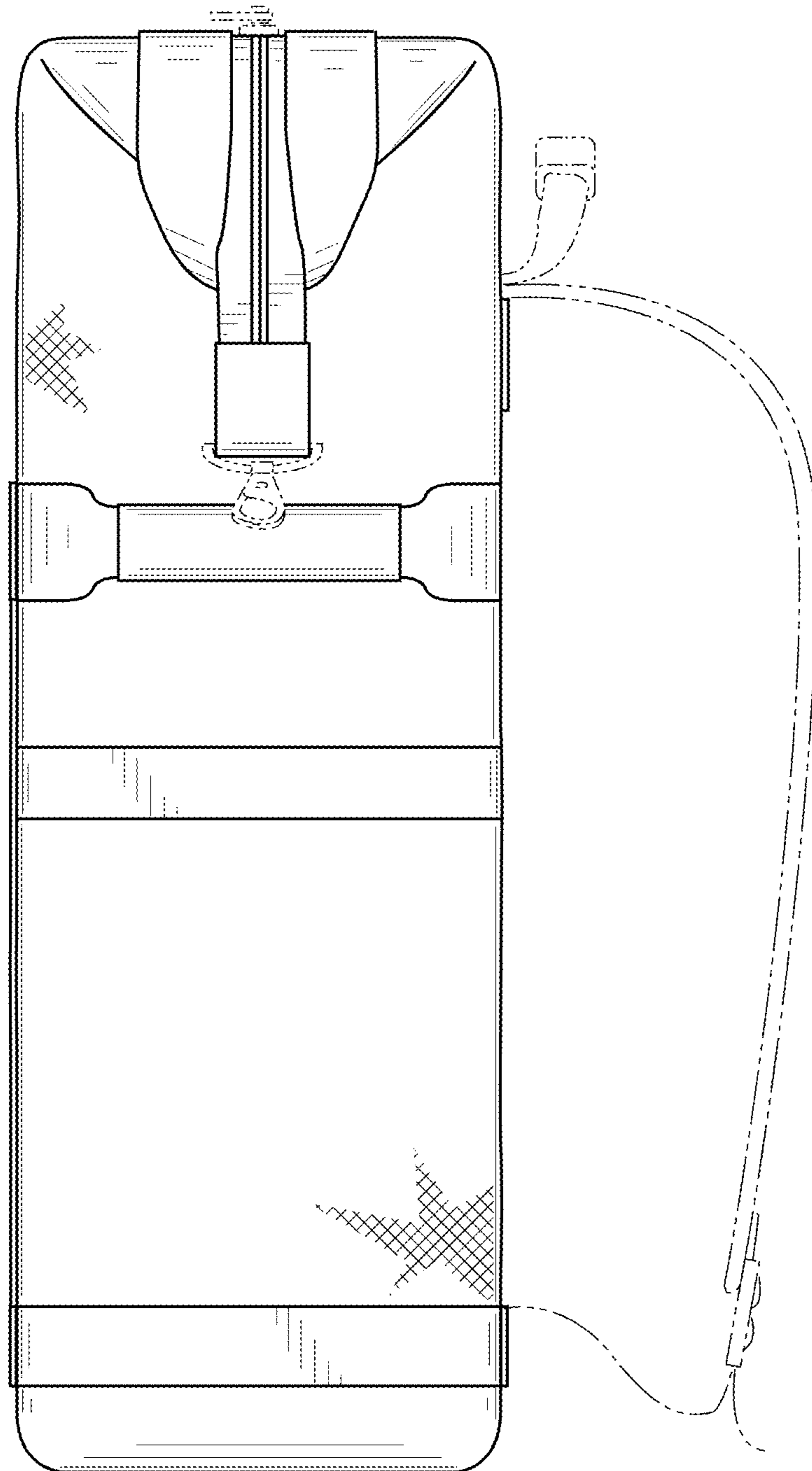

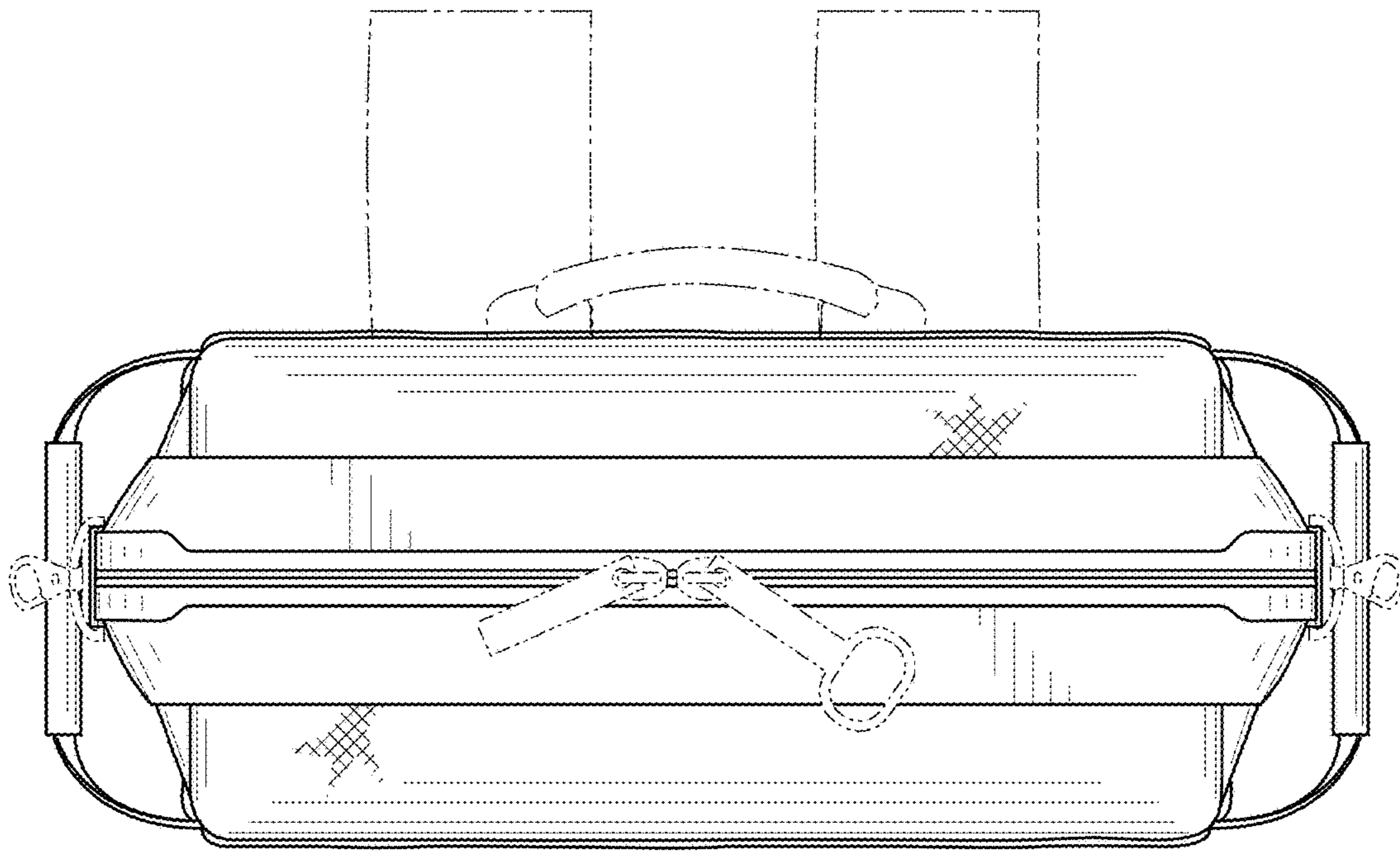

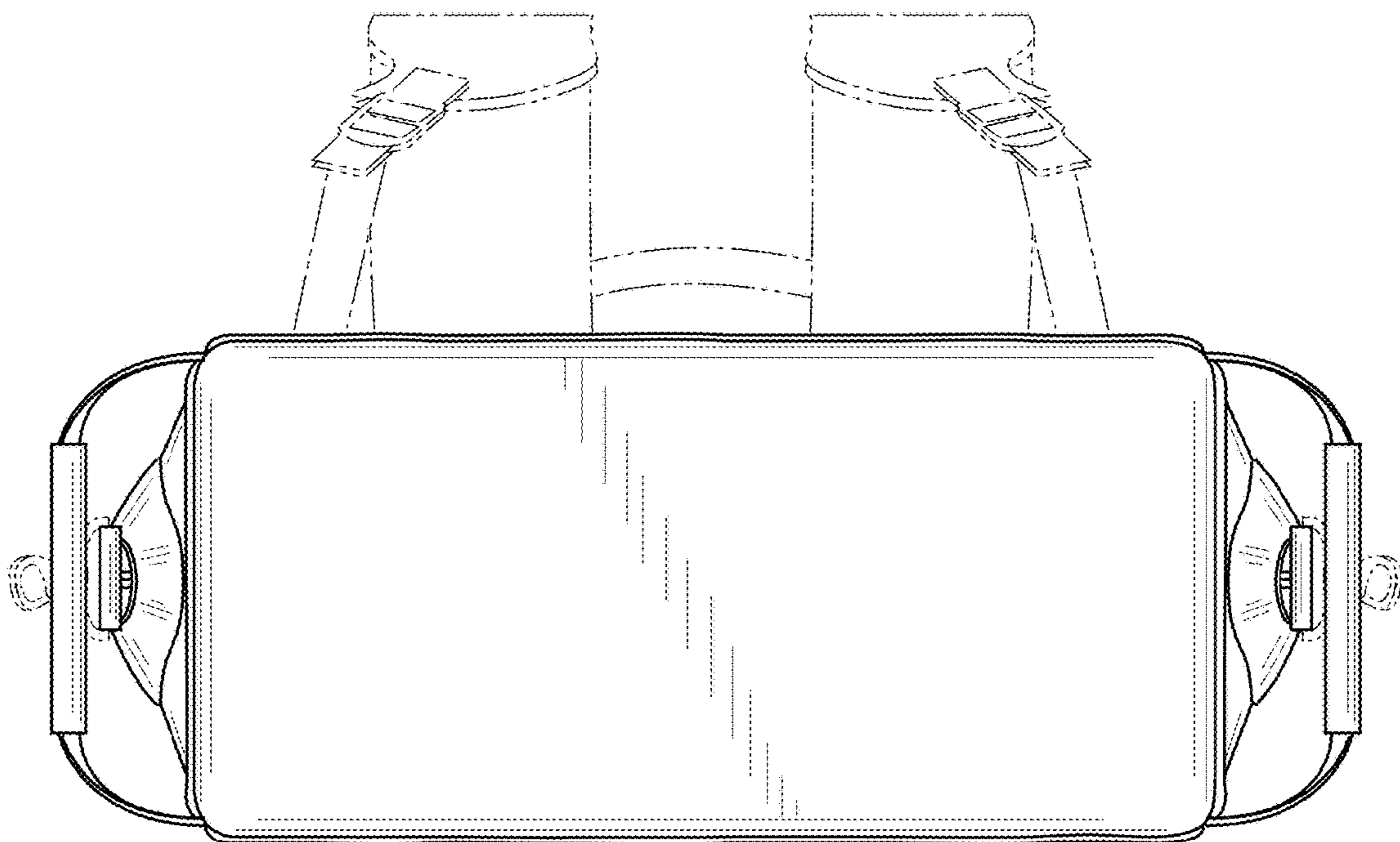
