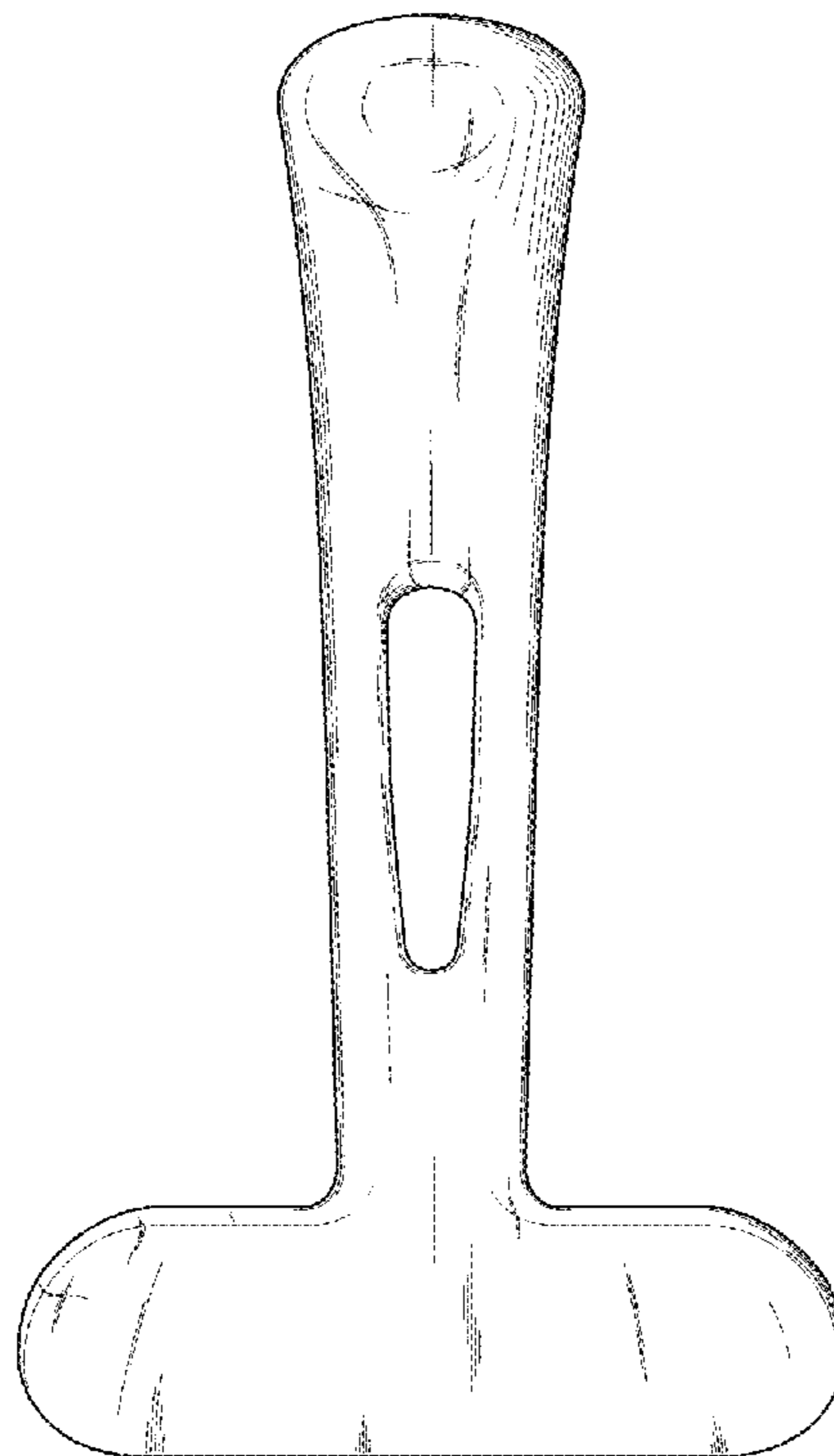
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a kettle handle showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;

FIG. 5 is a top view thereof;

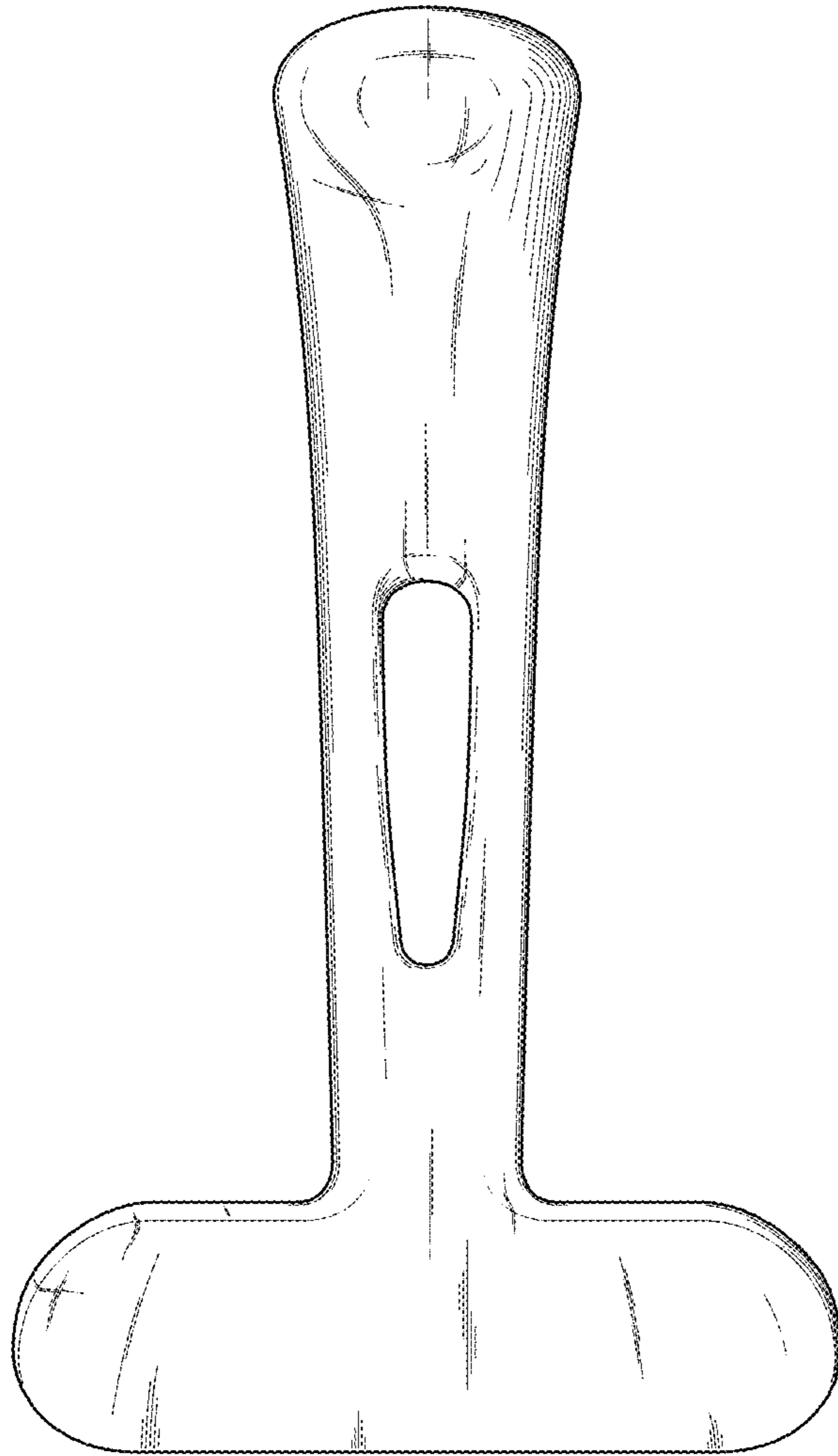

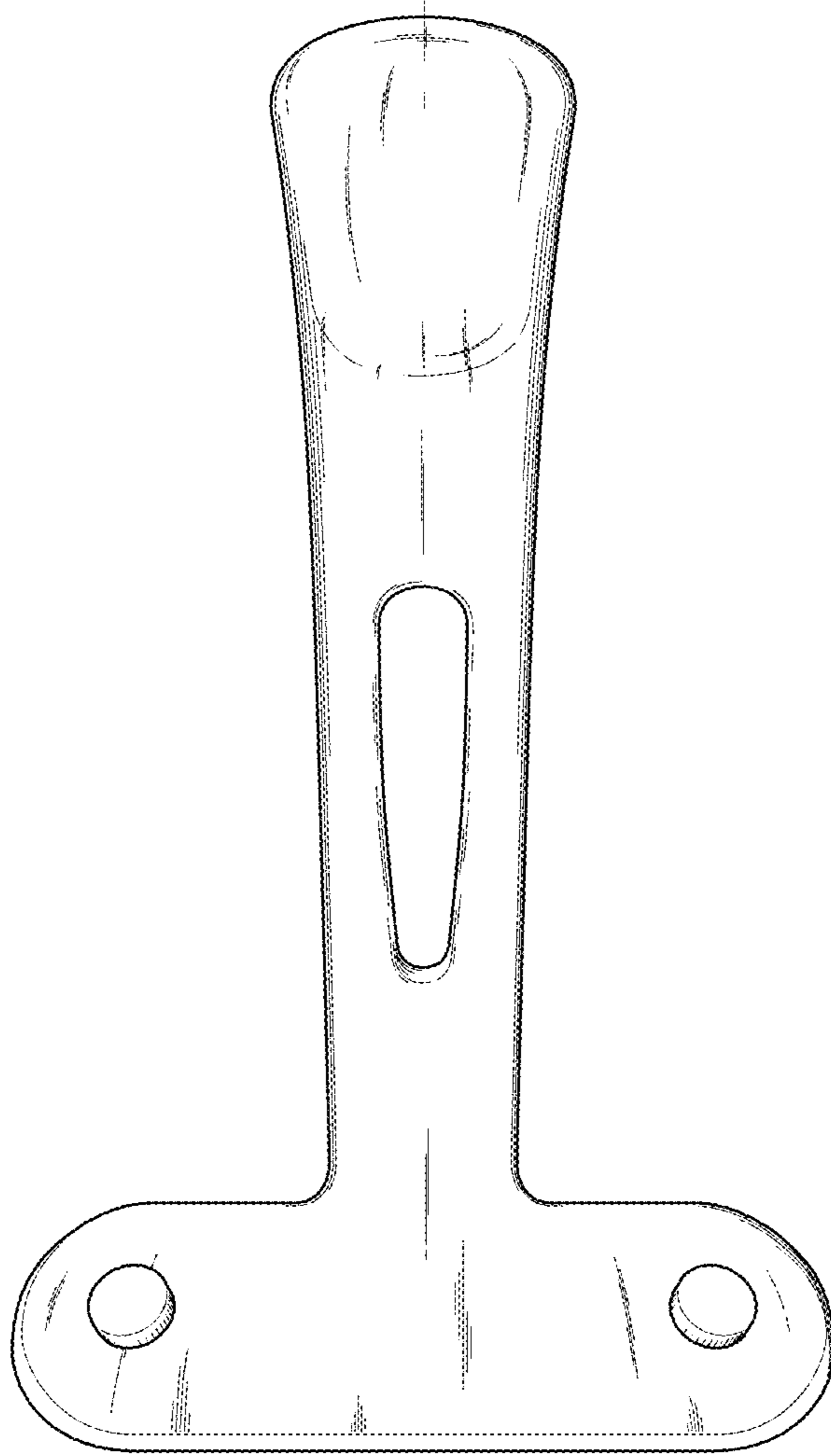

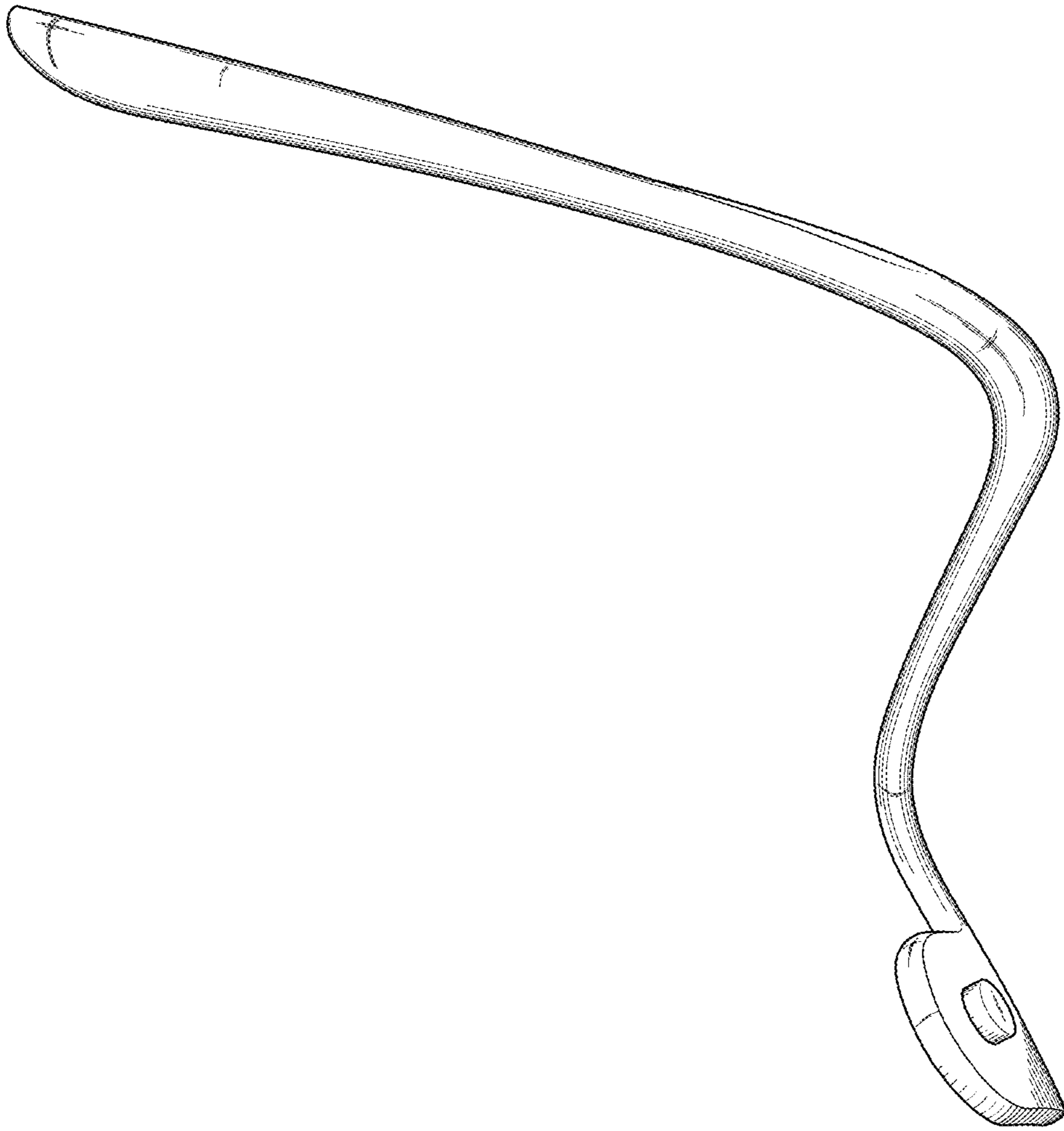

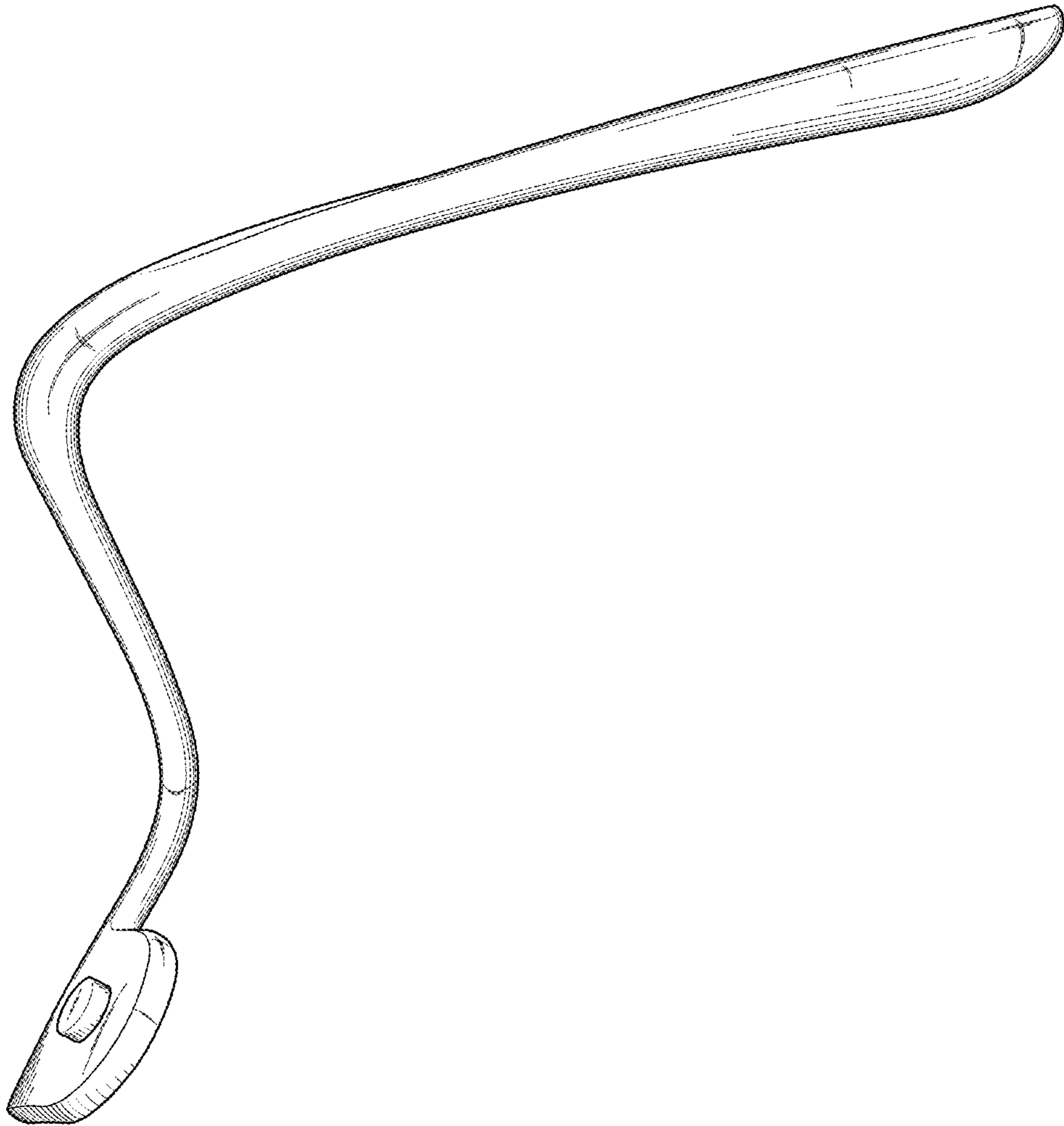

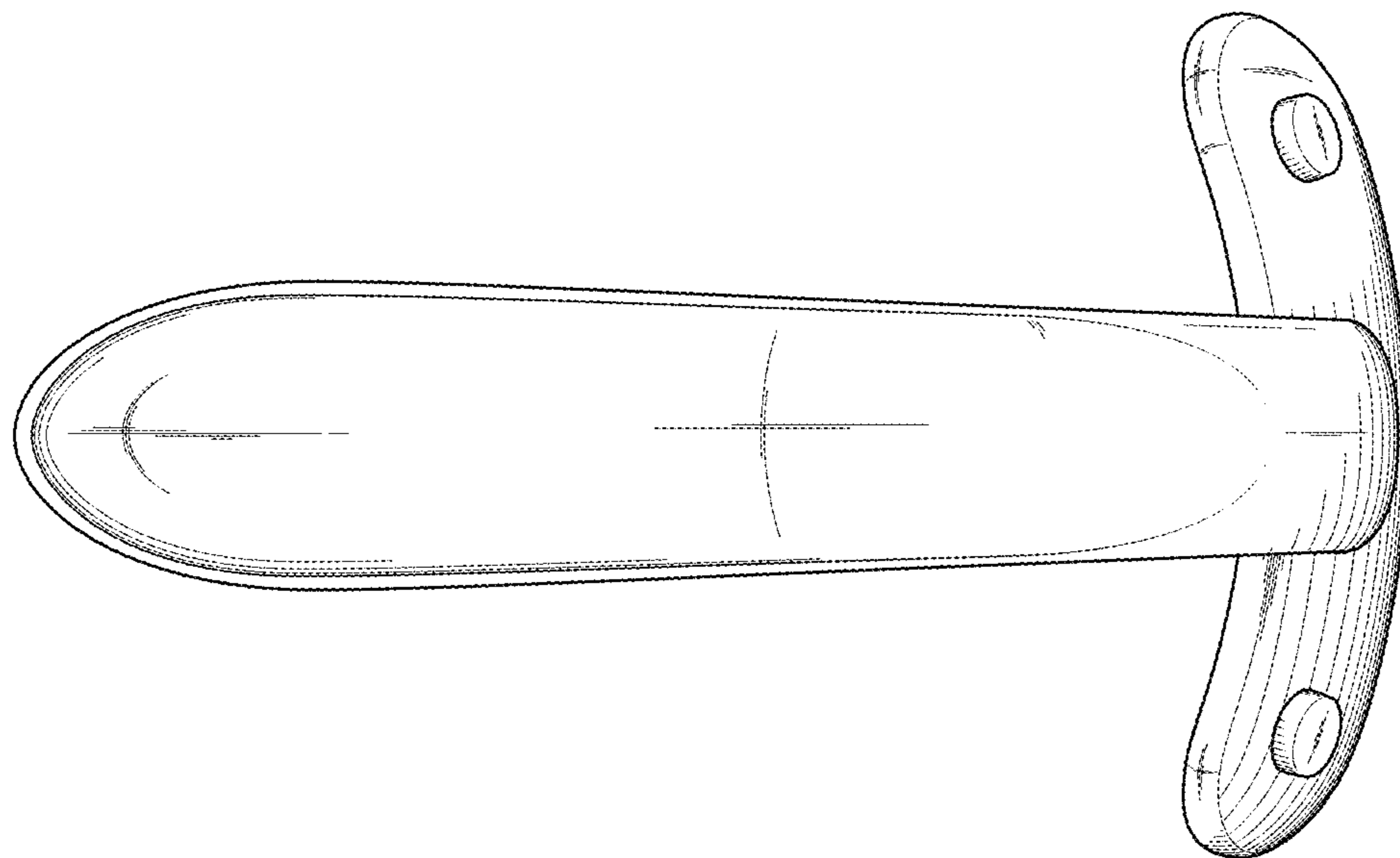

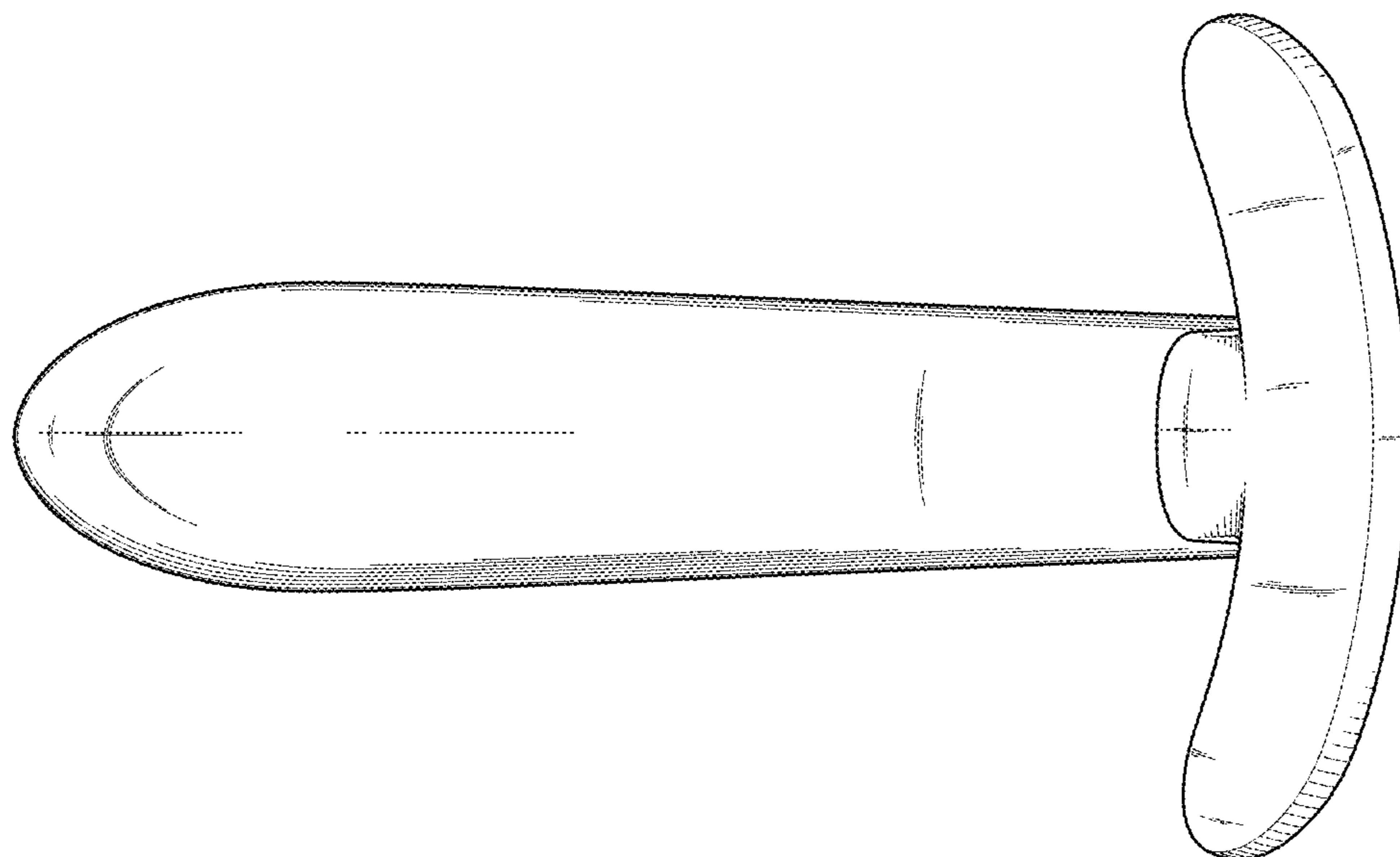

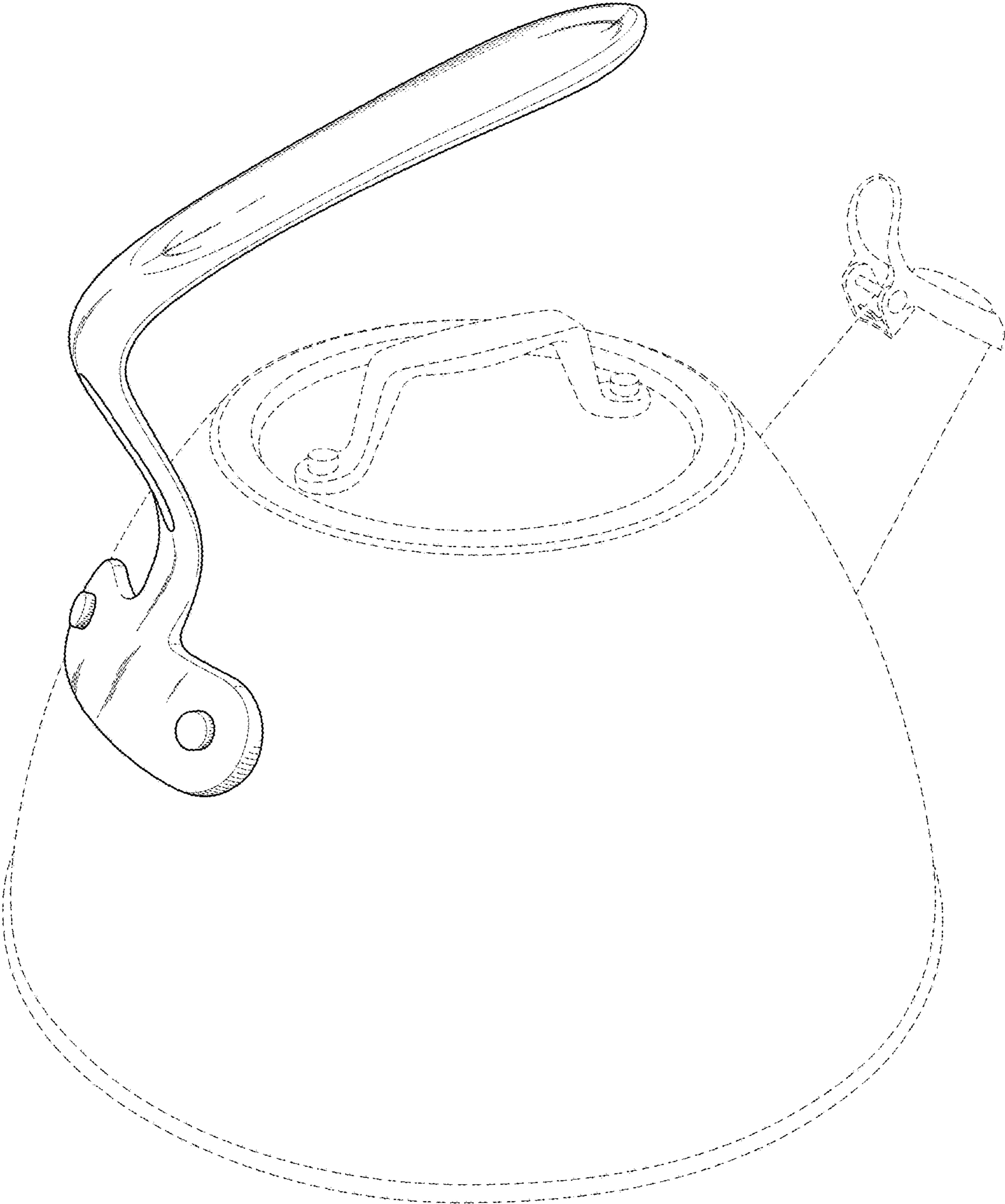

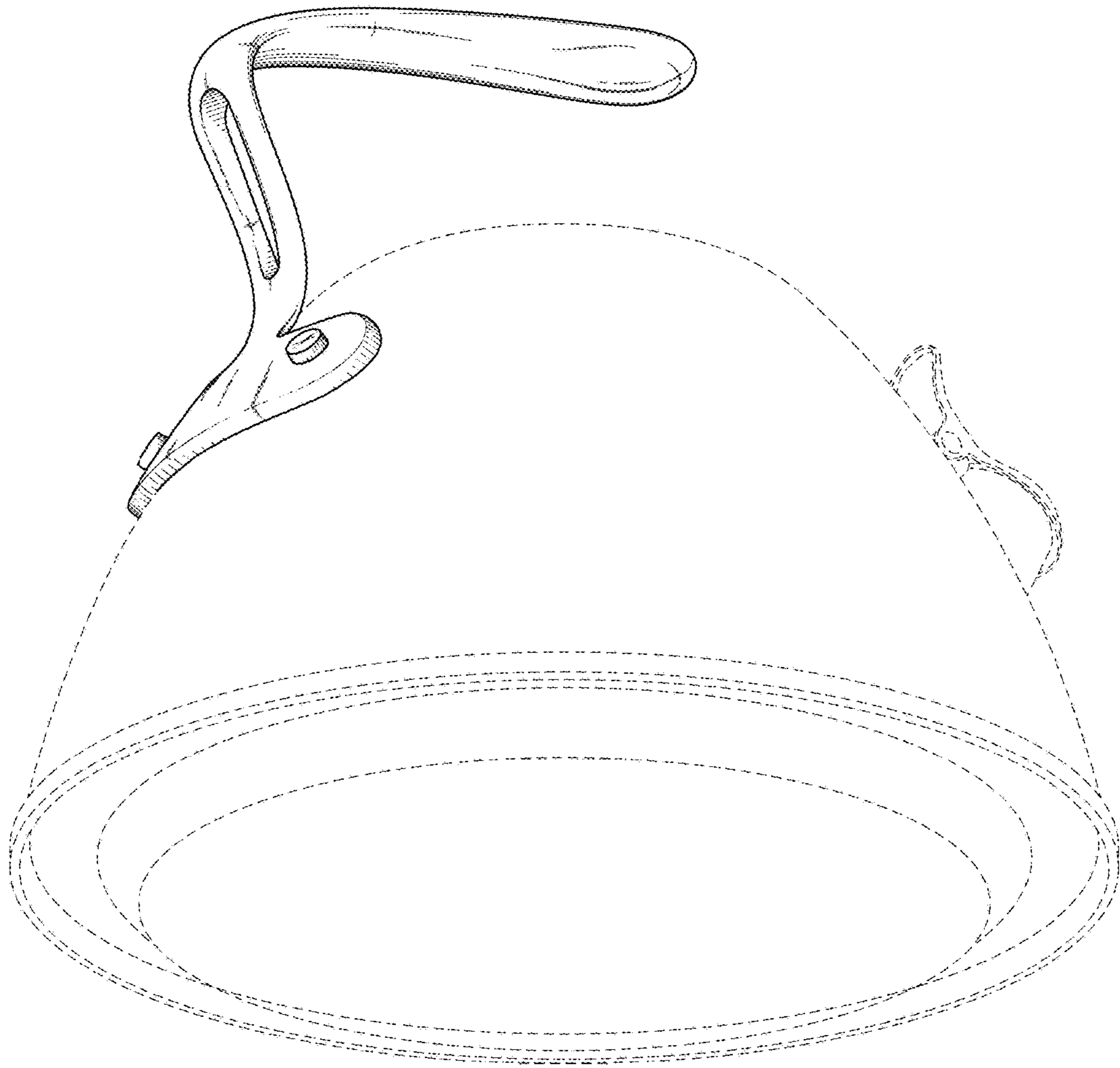
