DESCRIPTION

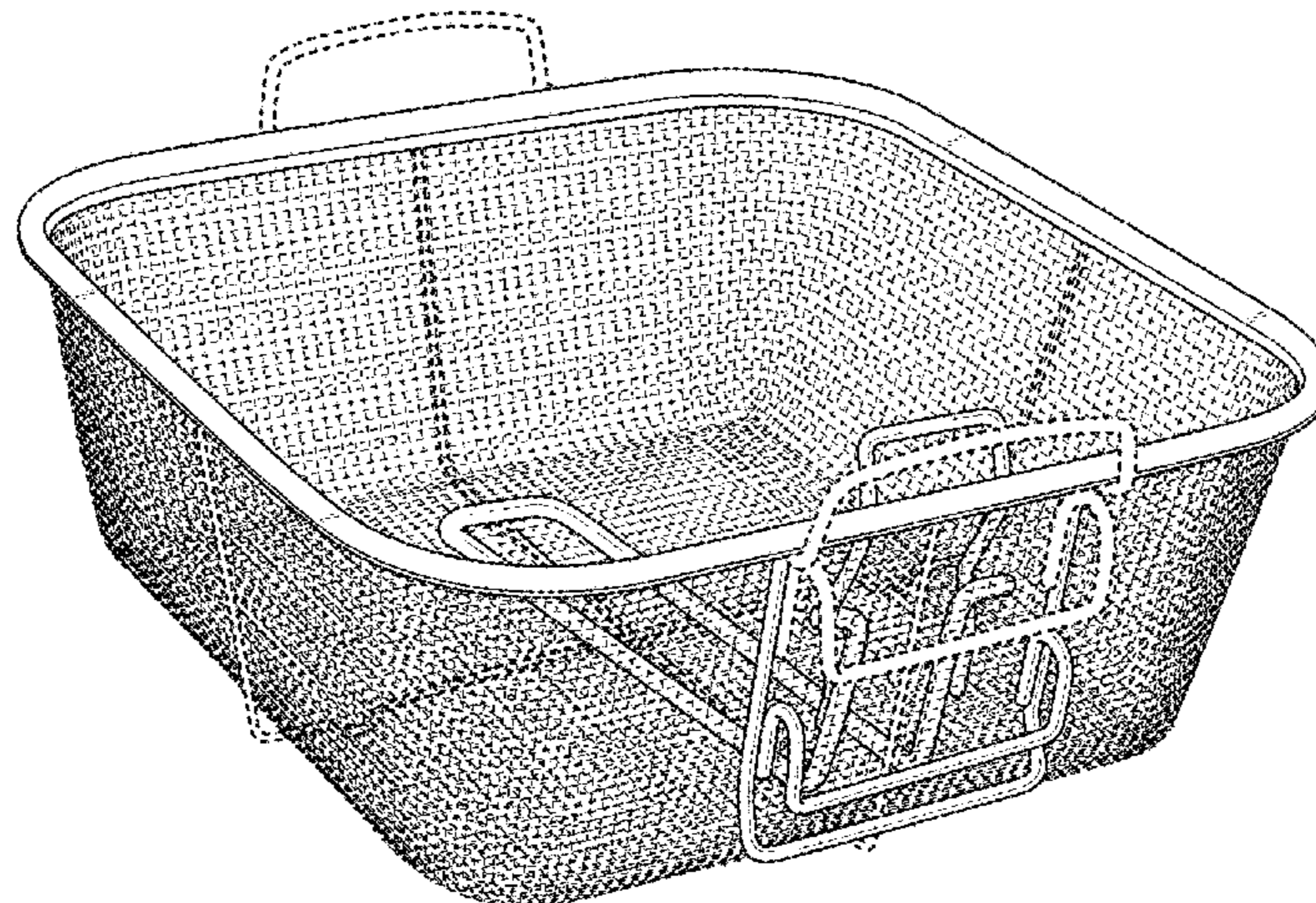
FIG. 1 is a perspective view of a fry basket in accordance with the subject disclosure.

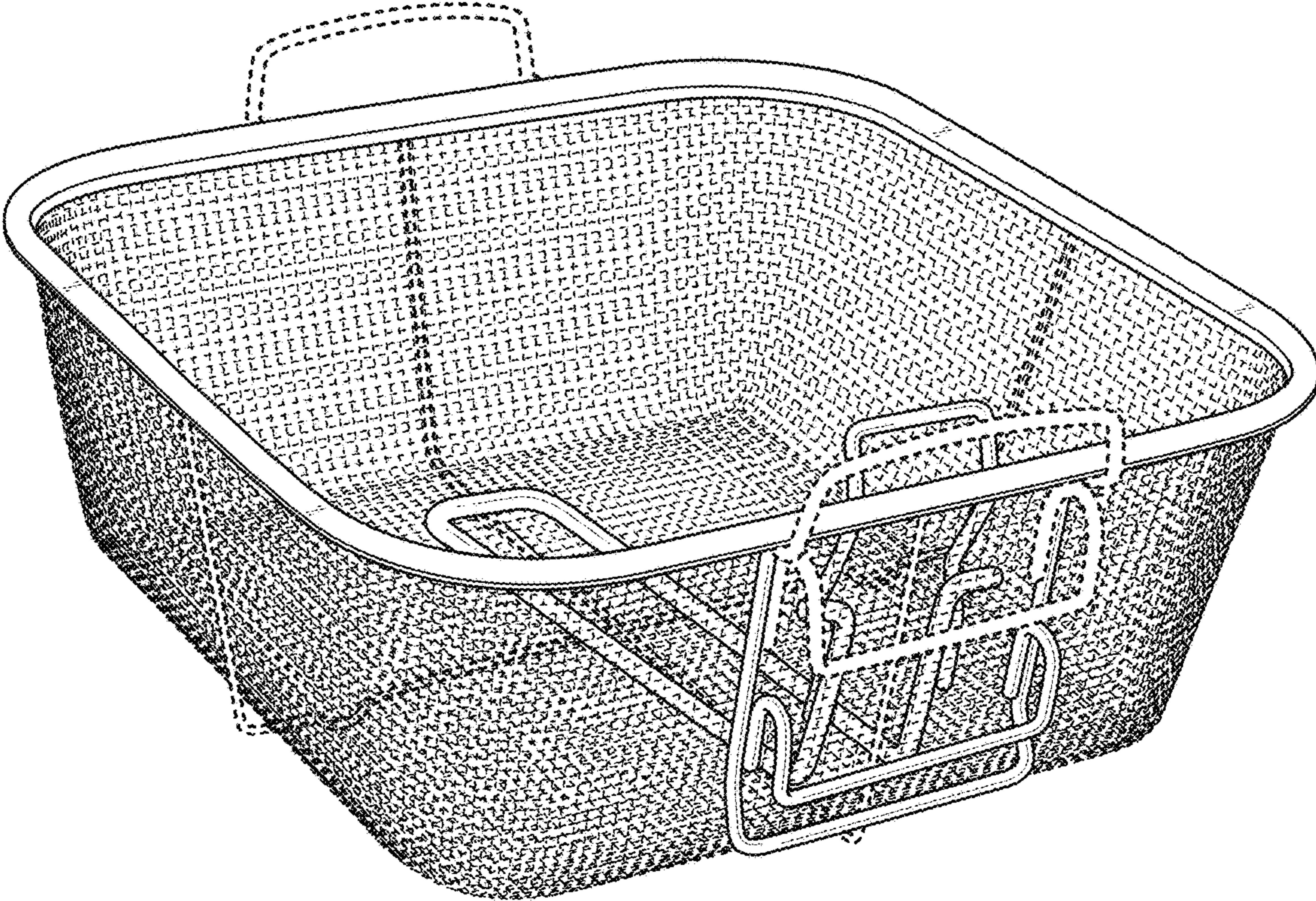

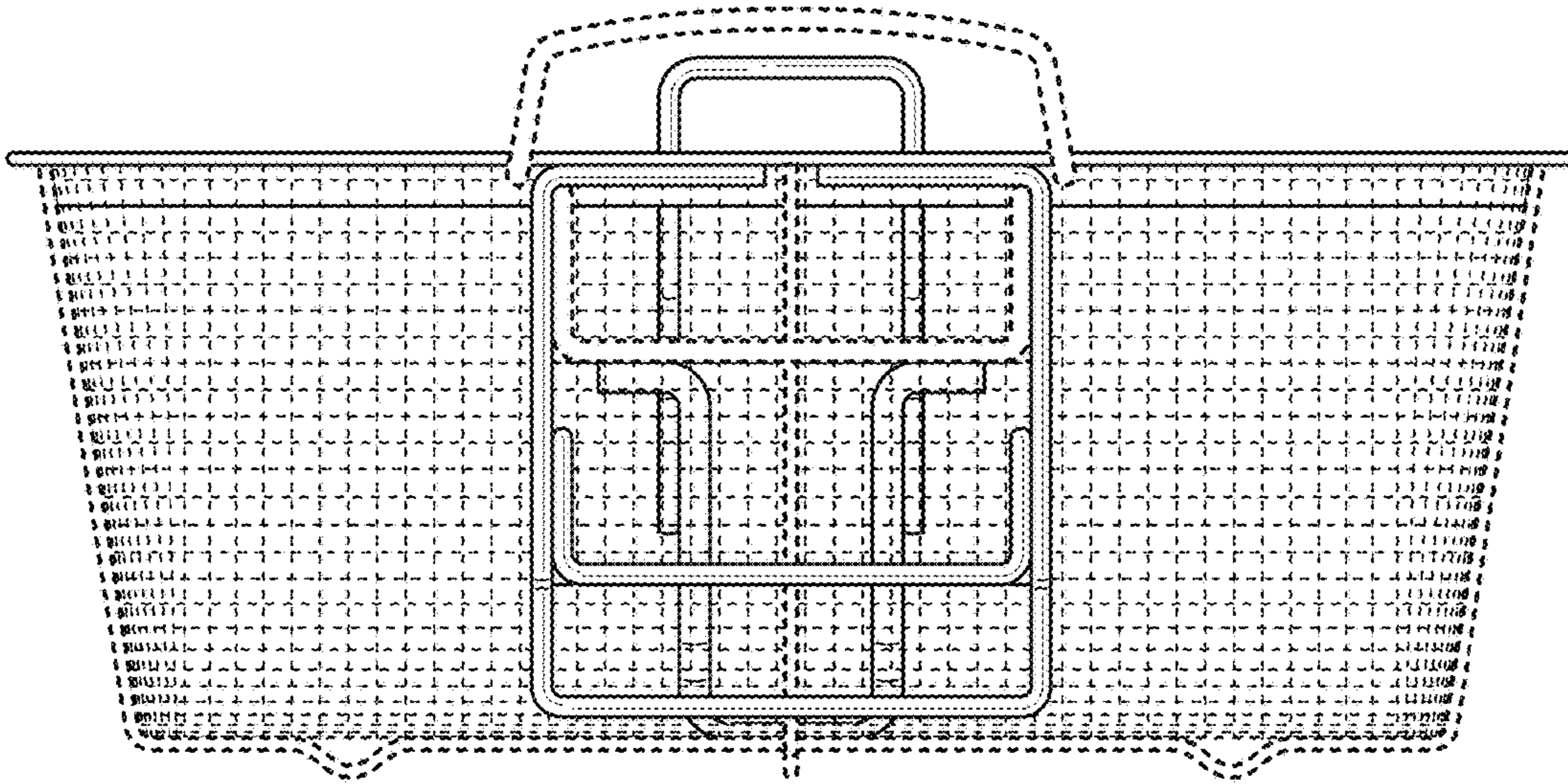

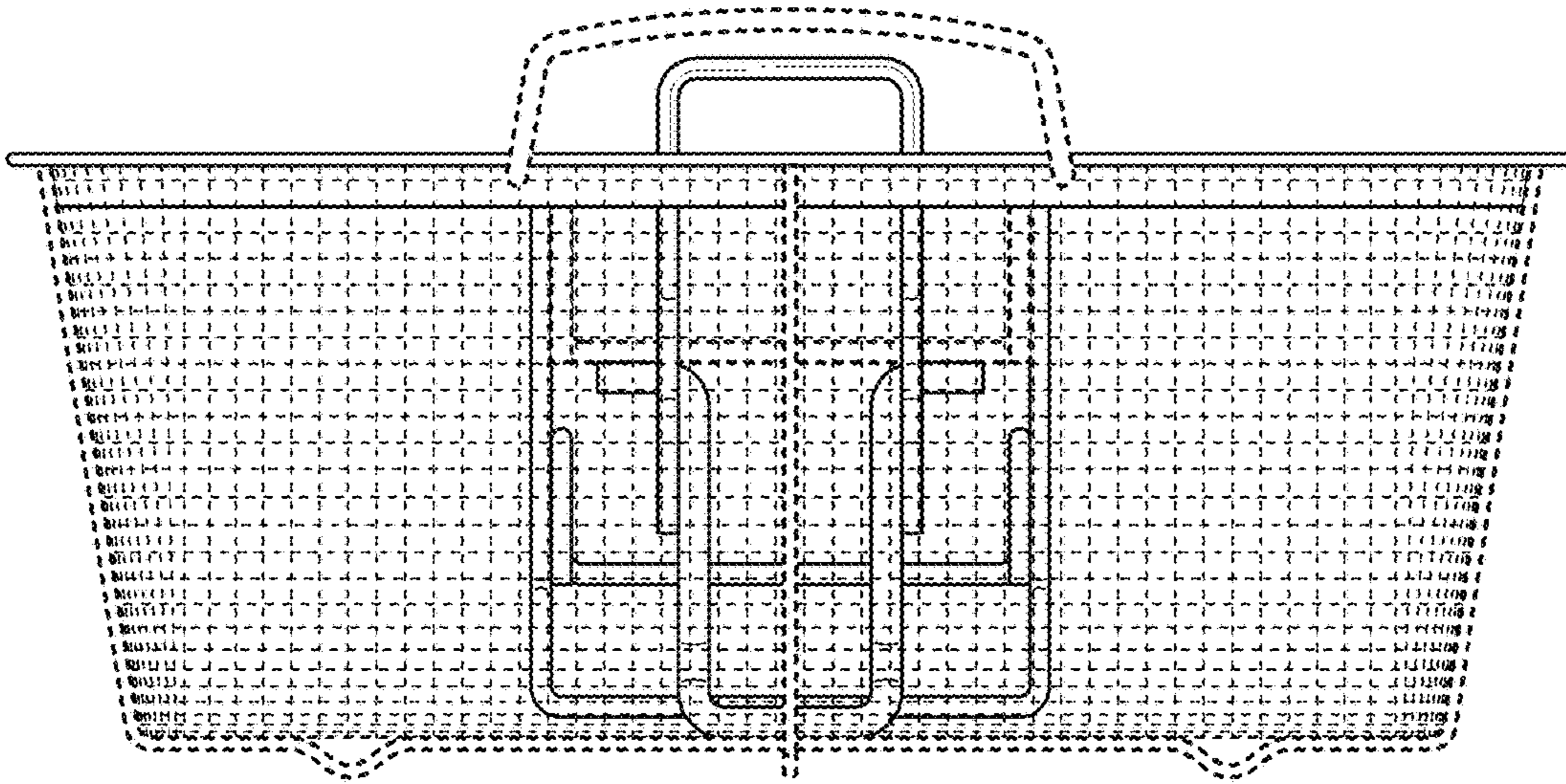

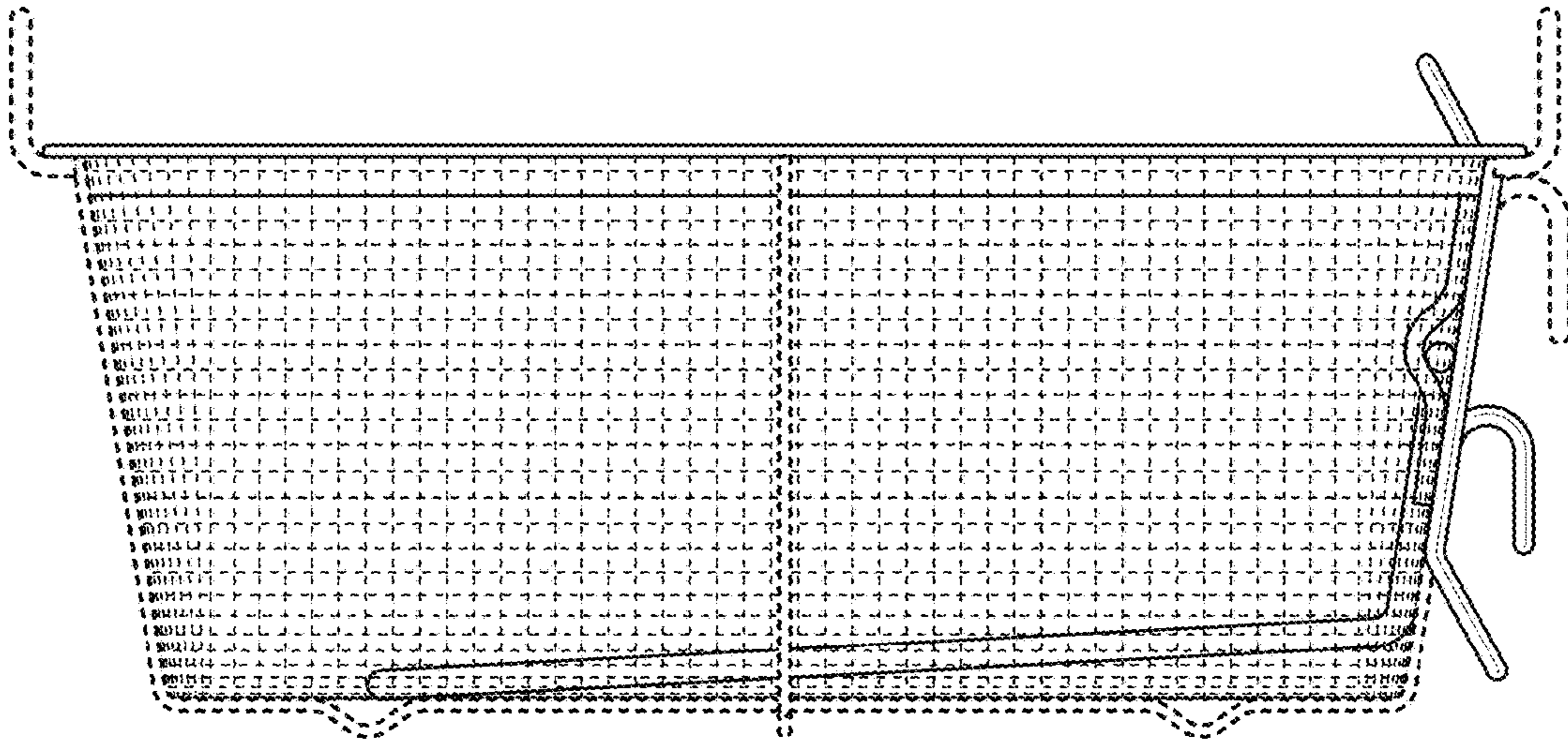

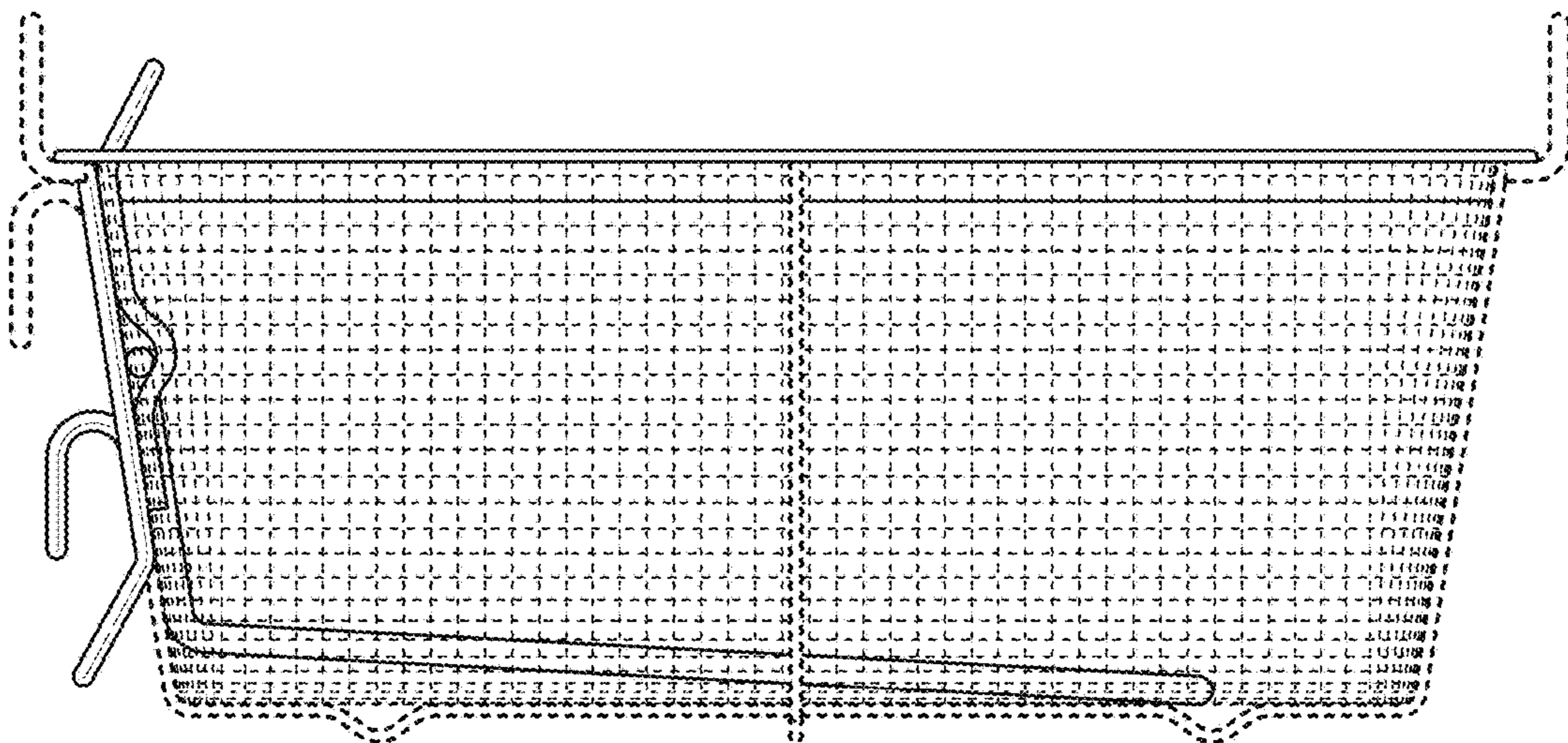

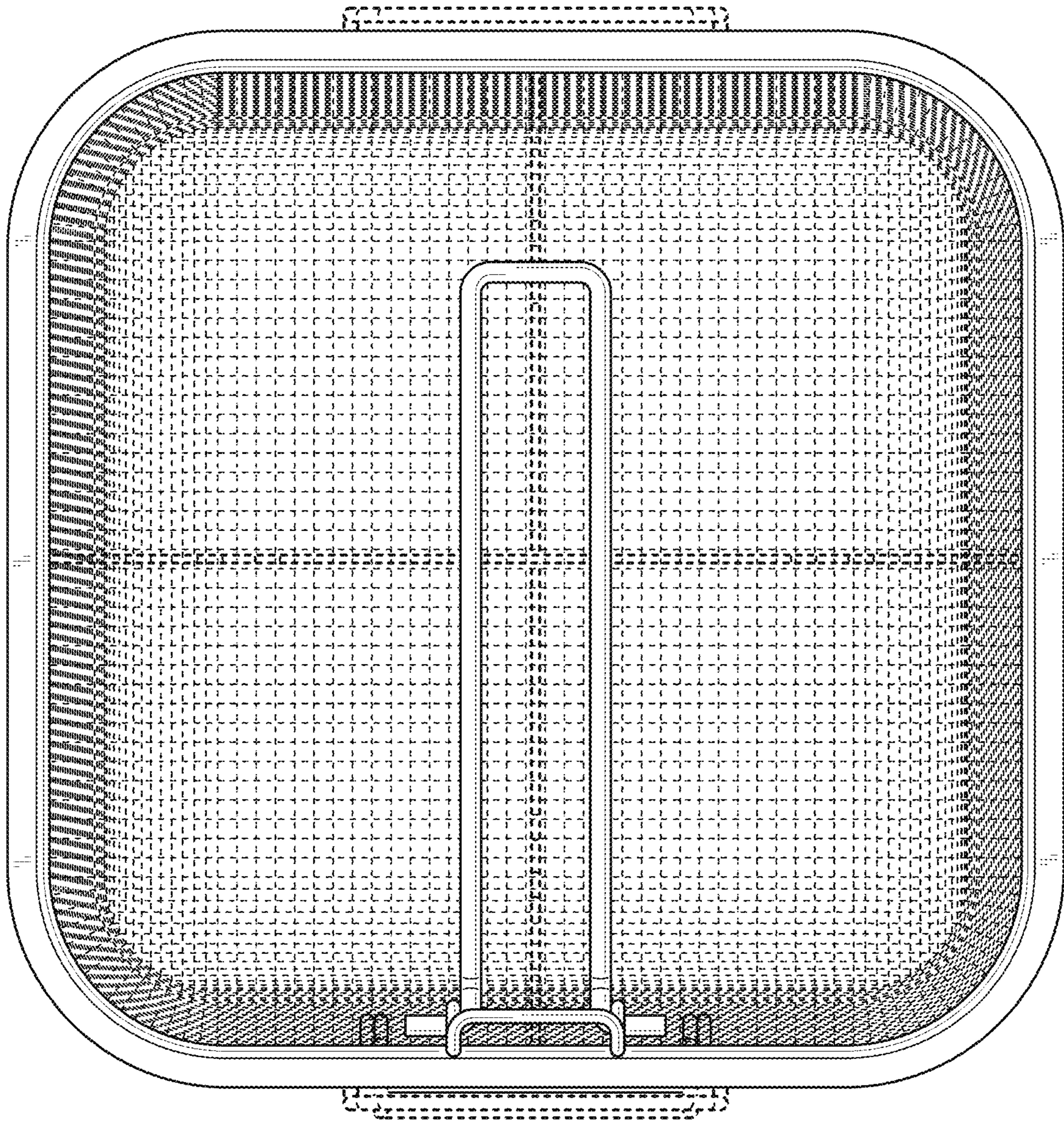

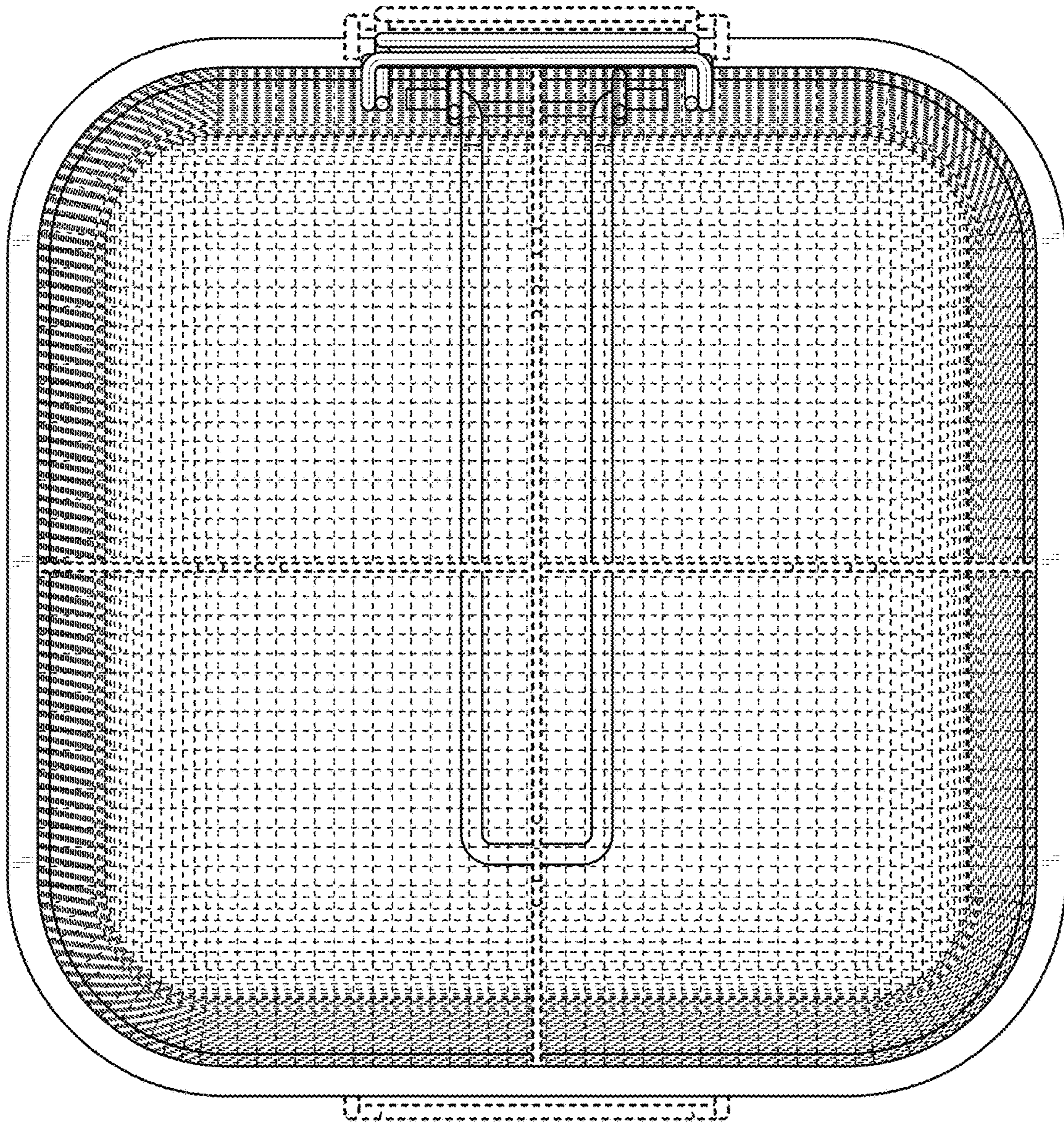
