(57) **CLAIM**

We claim the ornamental design for a beverage glass, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a beverage glass showing our new design;

FIG. 4 is a left side view thereof;

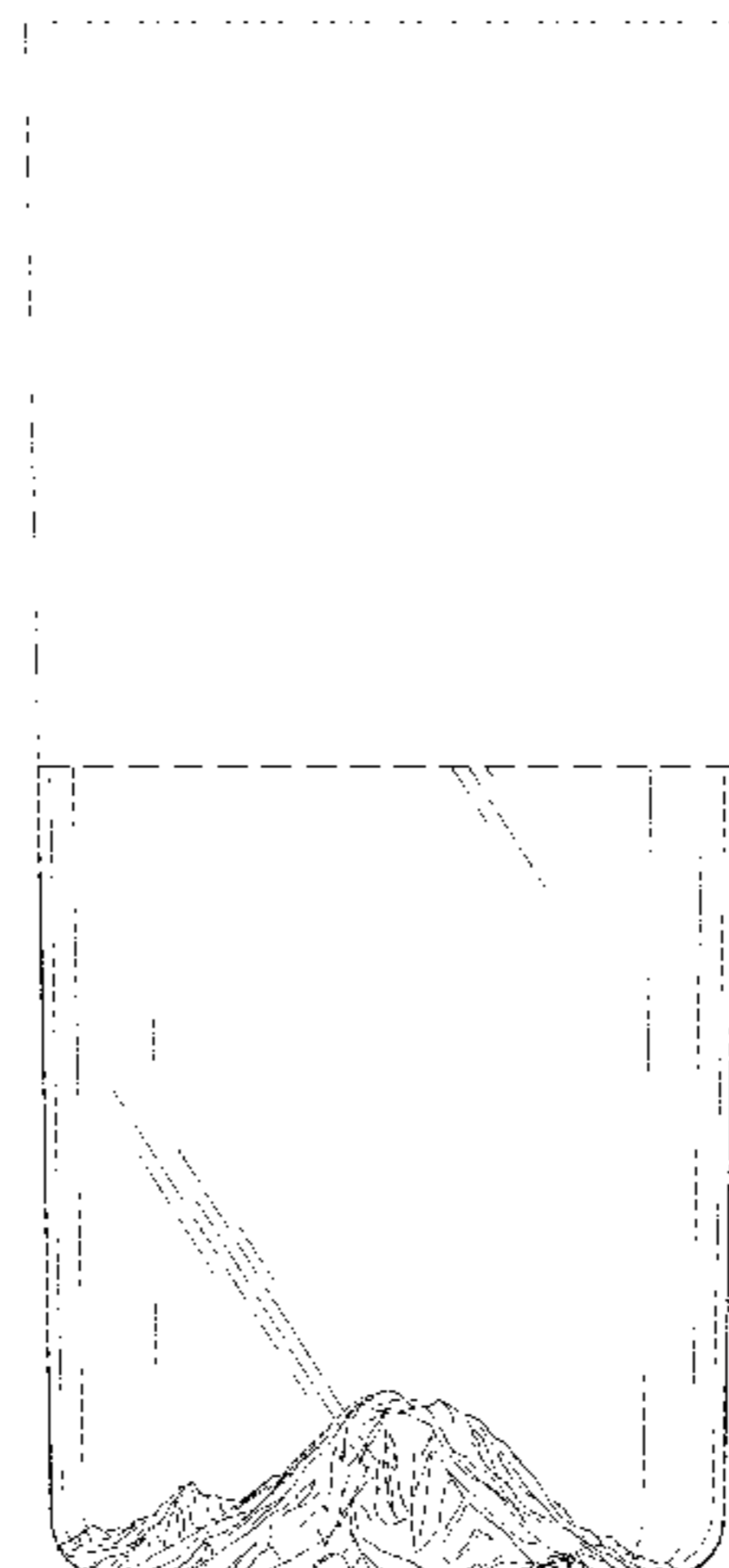
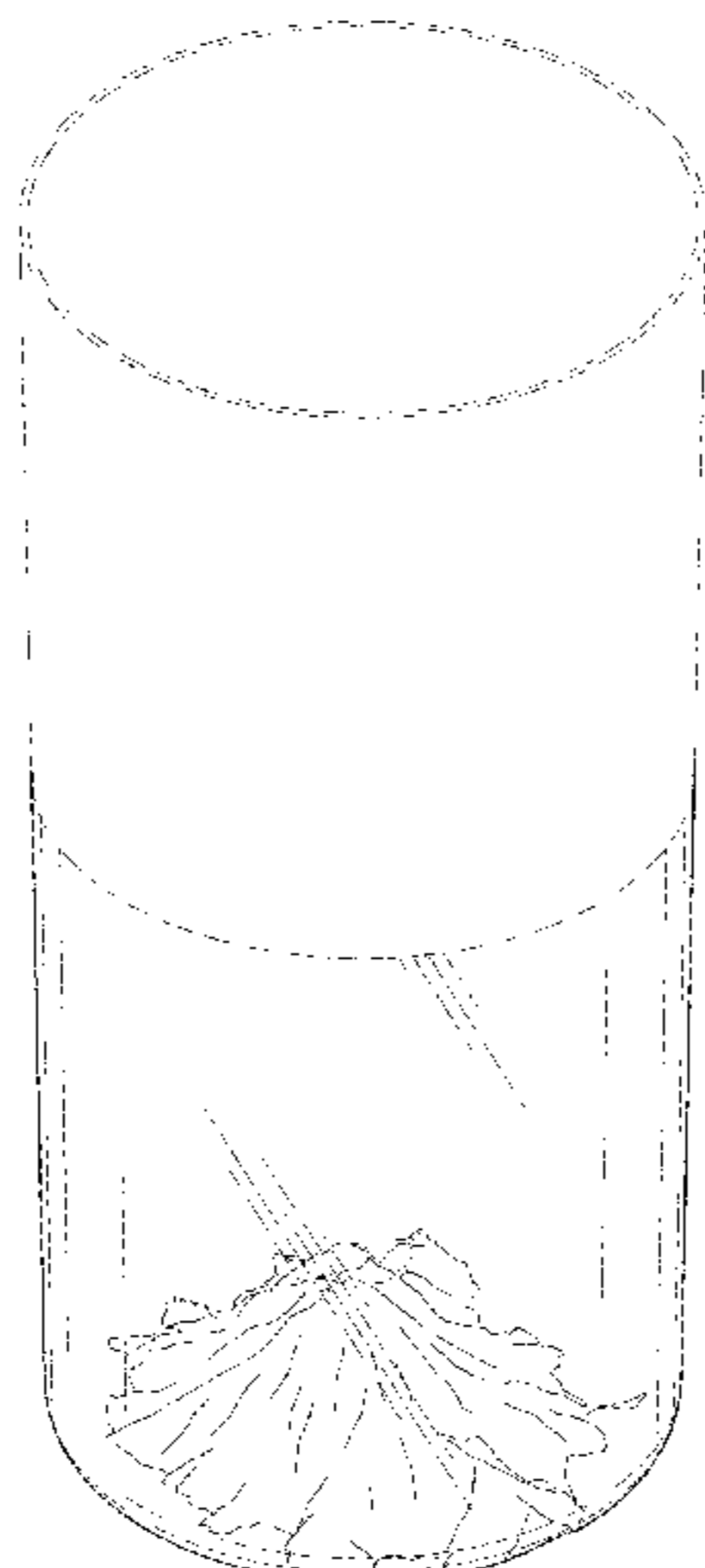
FIG. 5 is a right side view thereof;

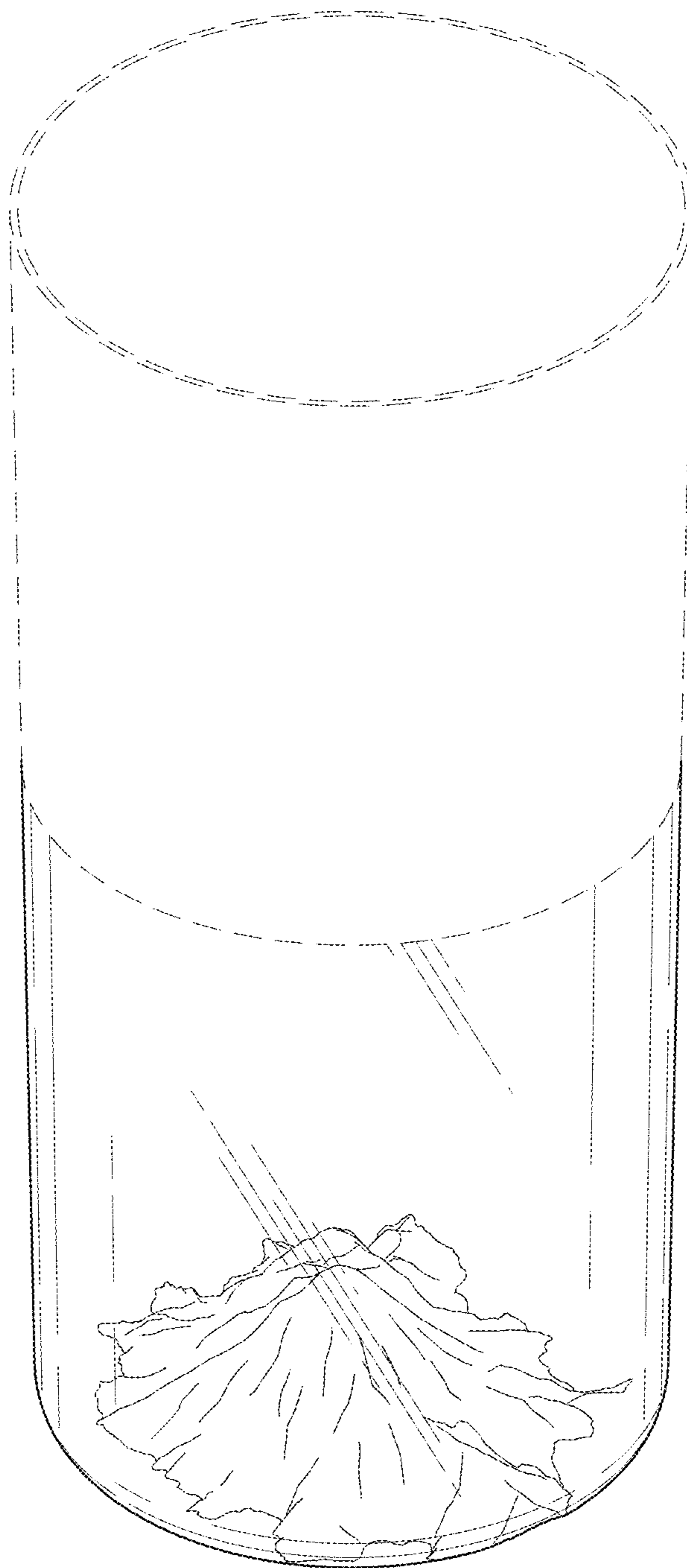

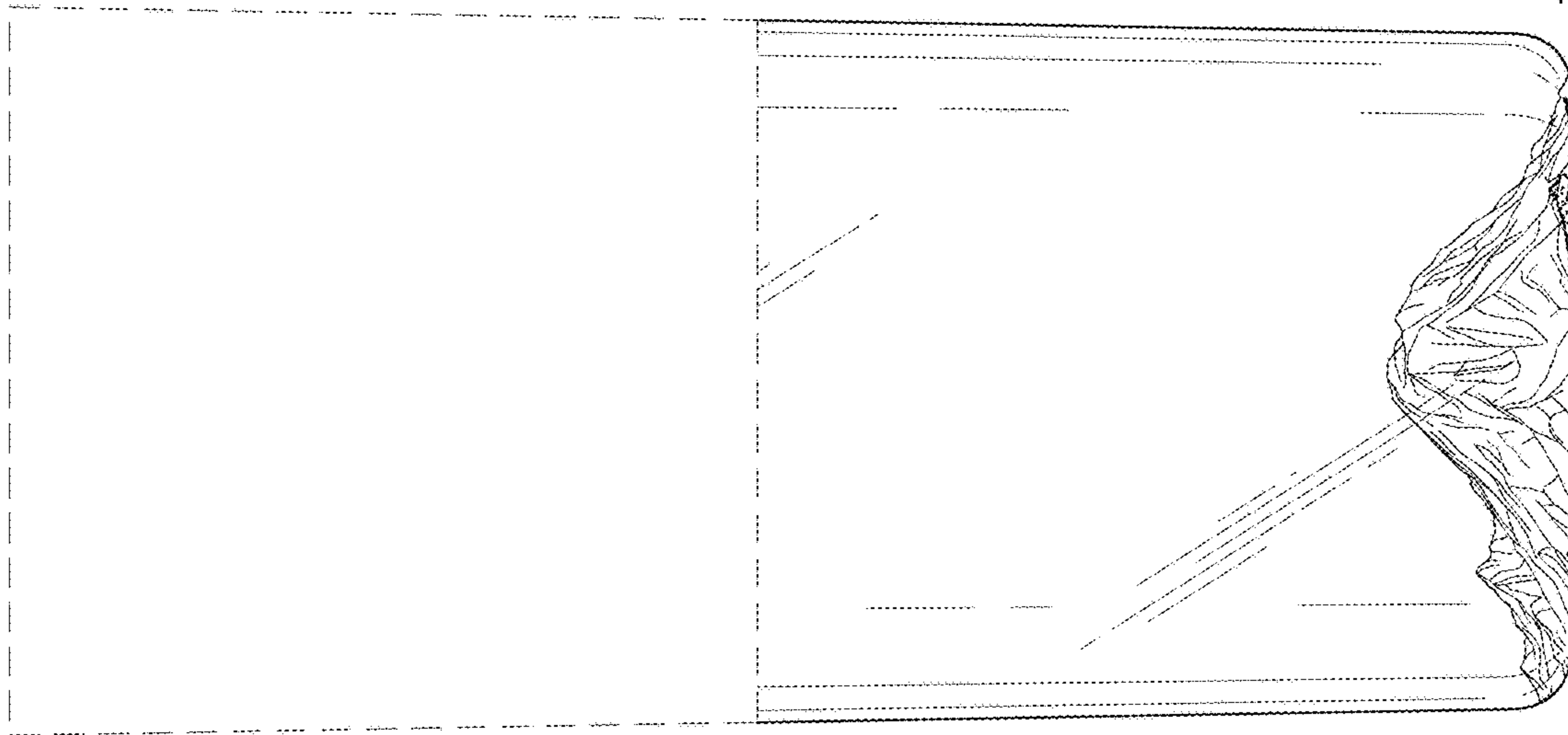

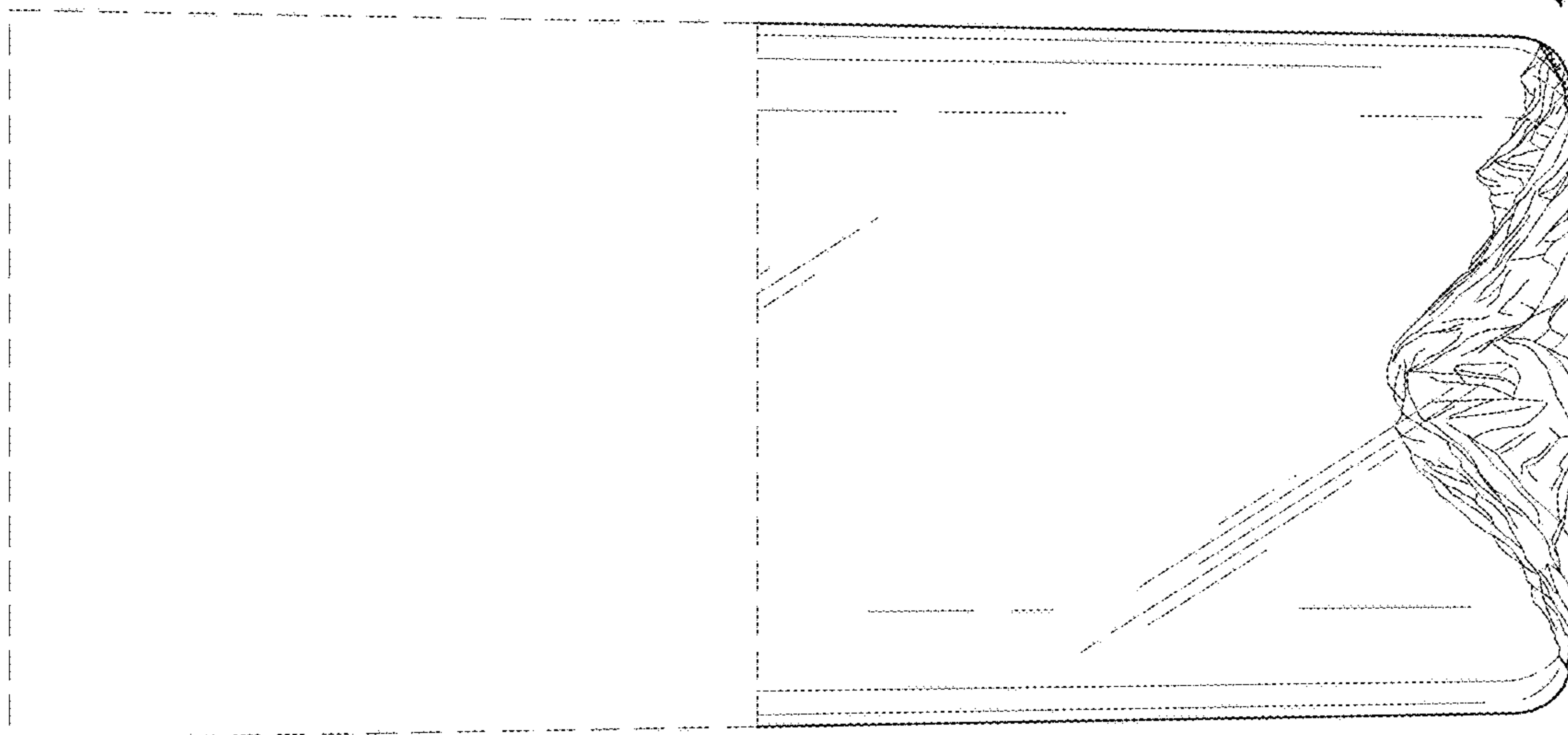

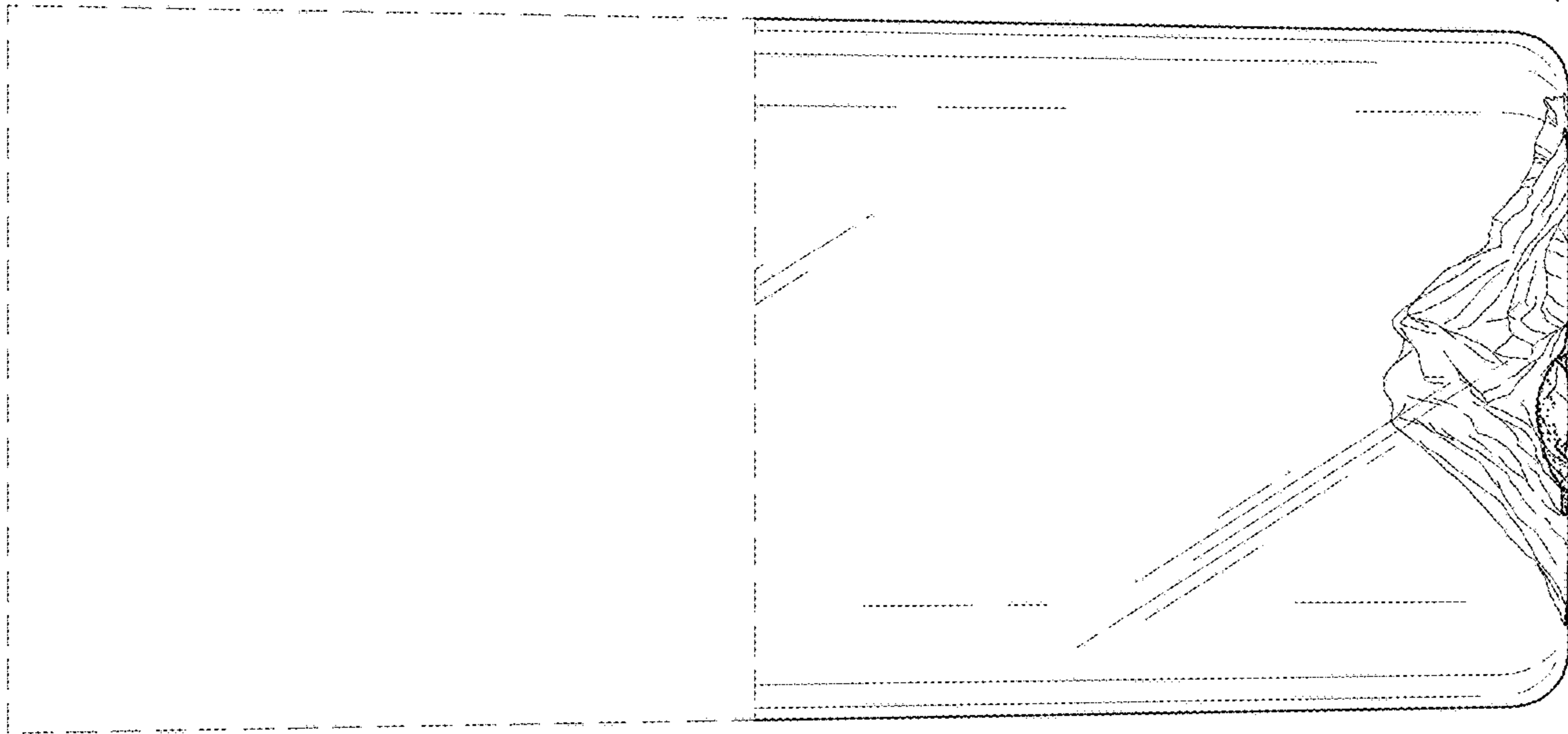

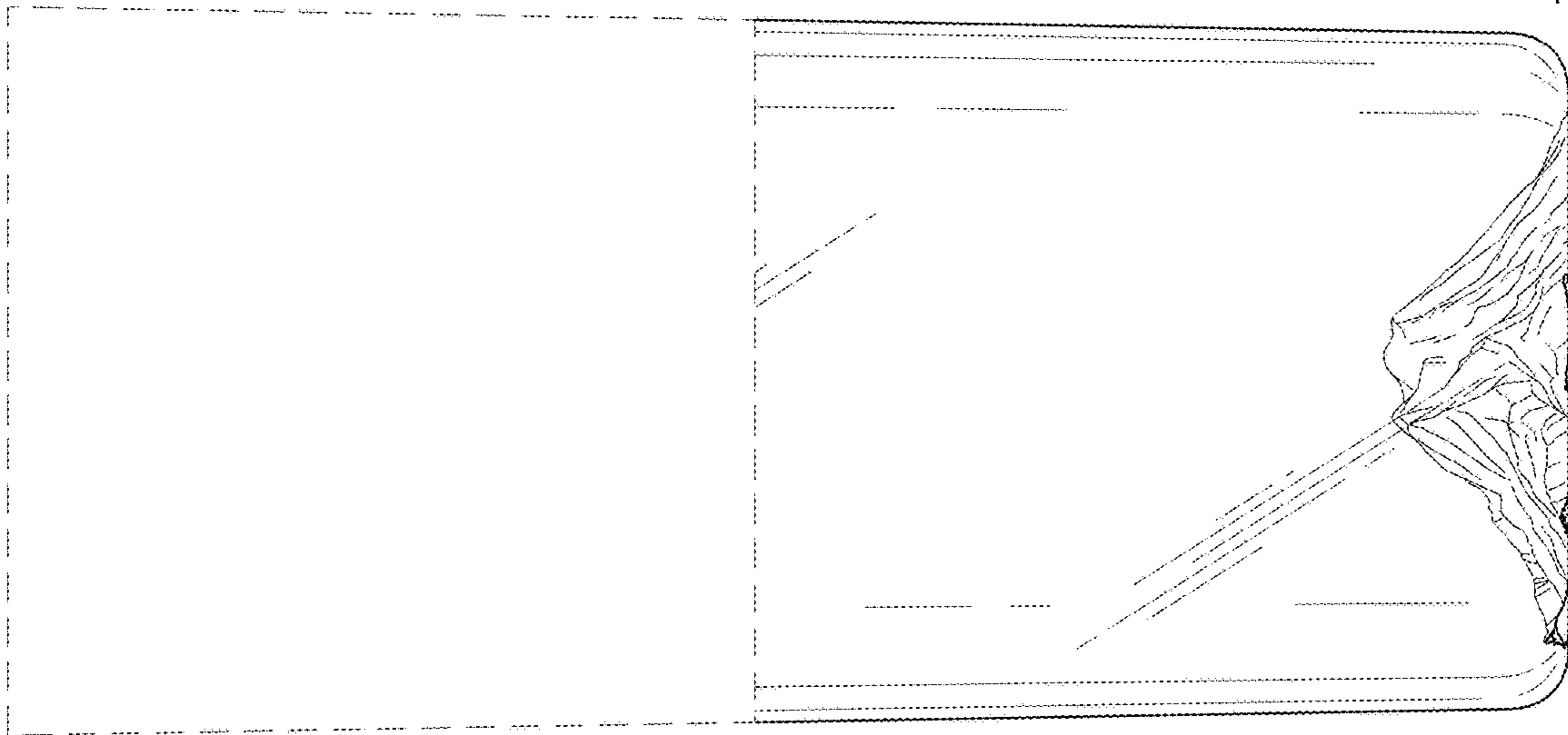

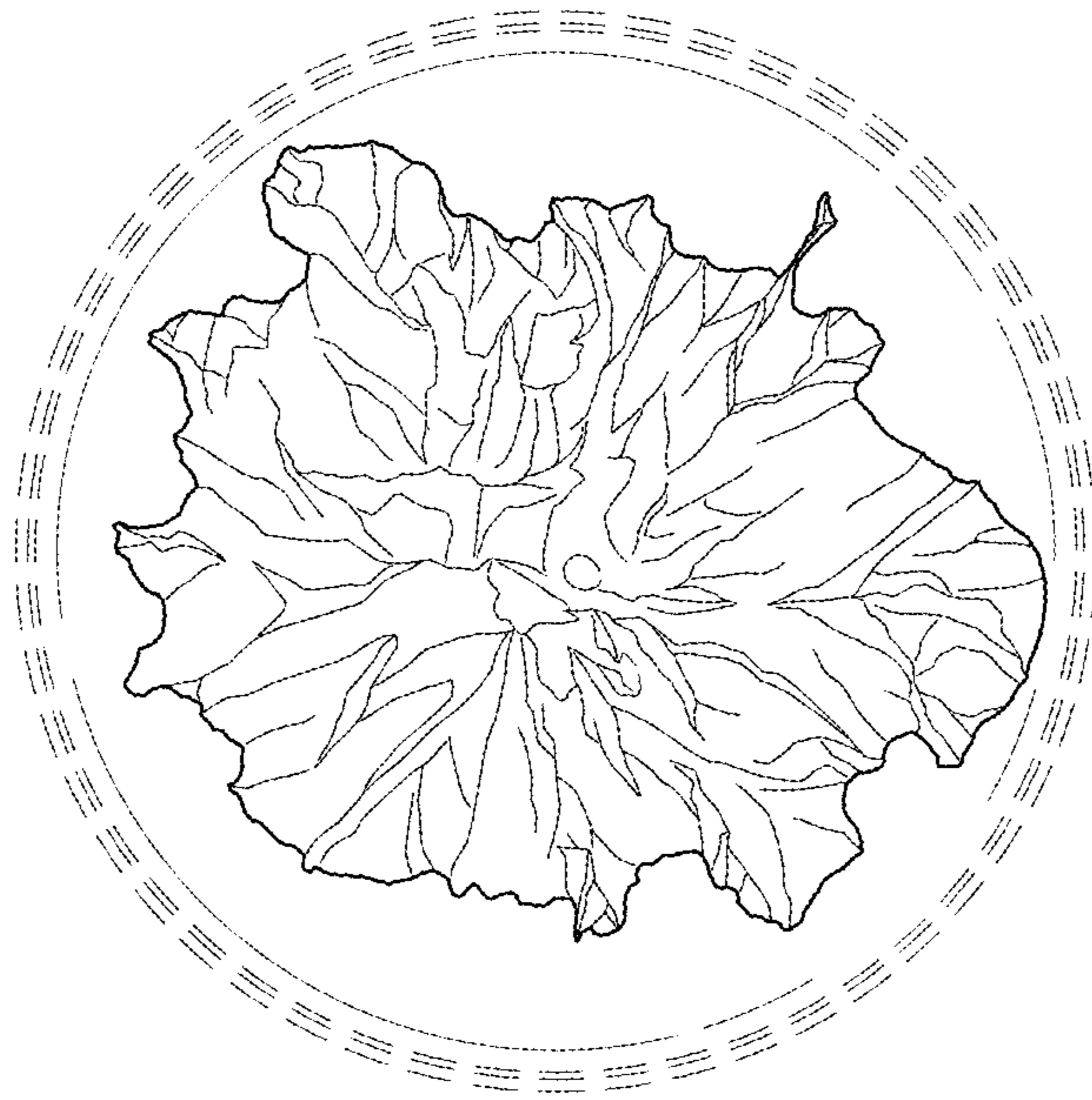

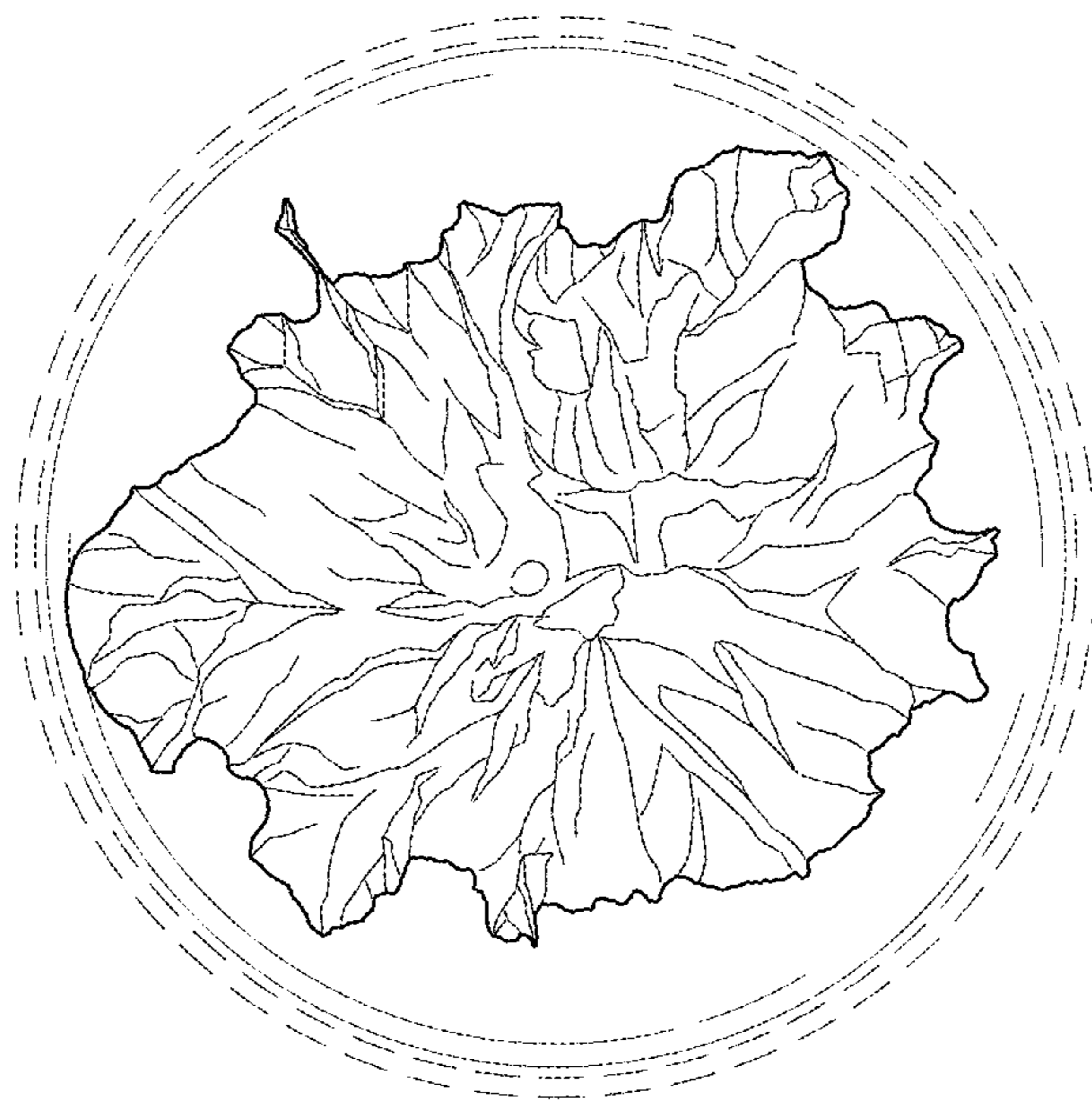
