FIG. 7 is a rear view thereof.

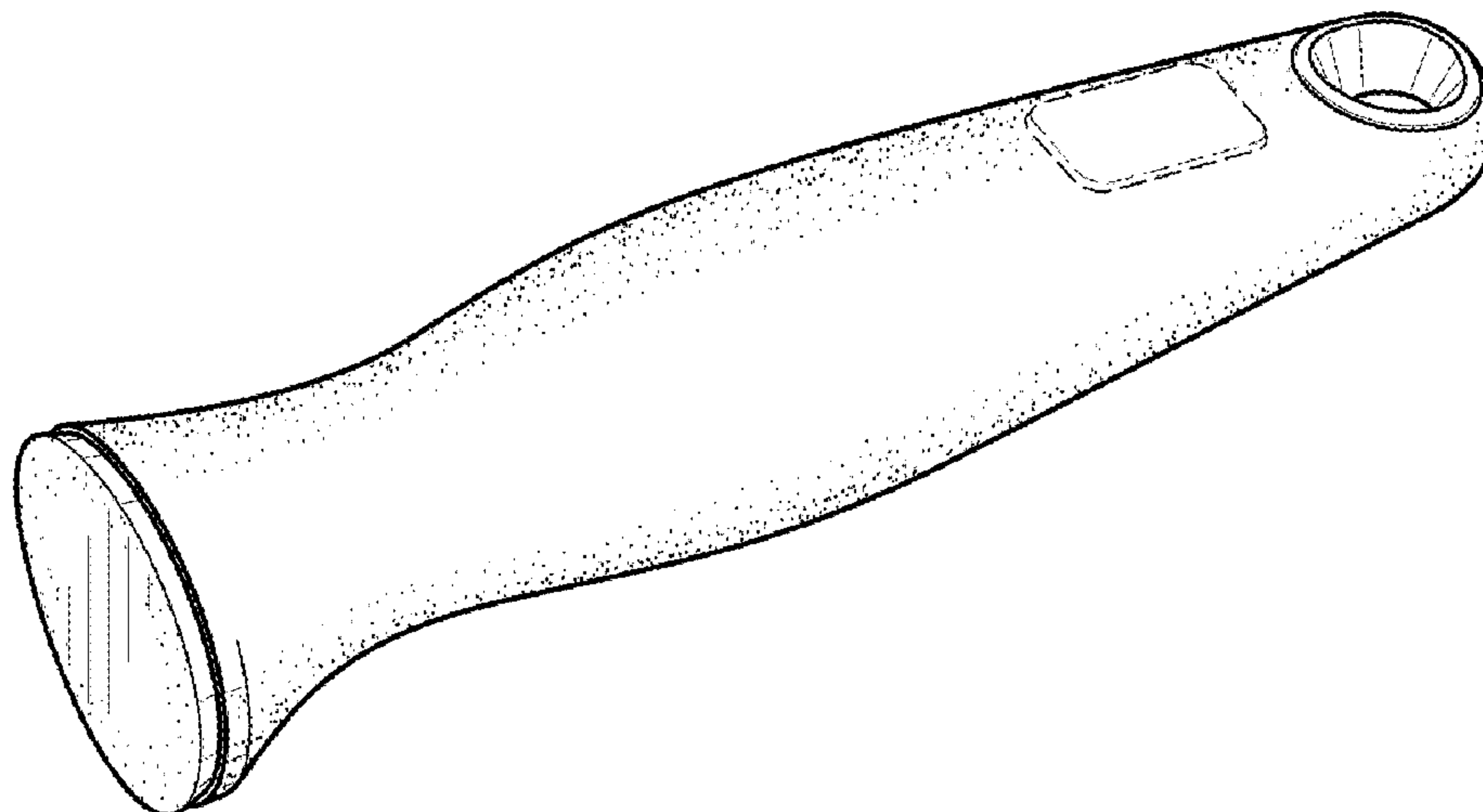
The broken lines in the drawings represent portions of the handle and tool head and forms no part of the claimed design.

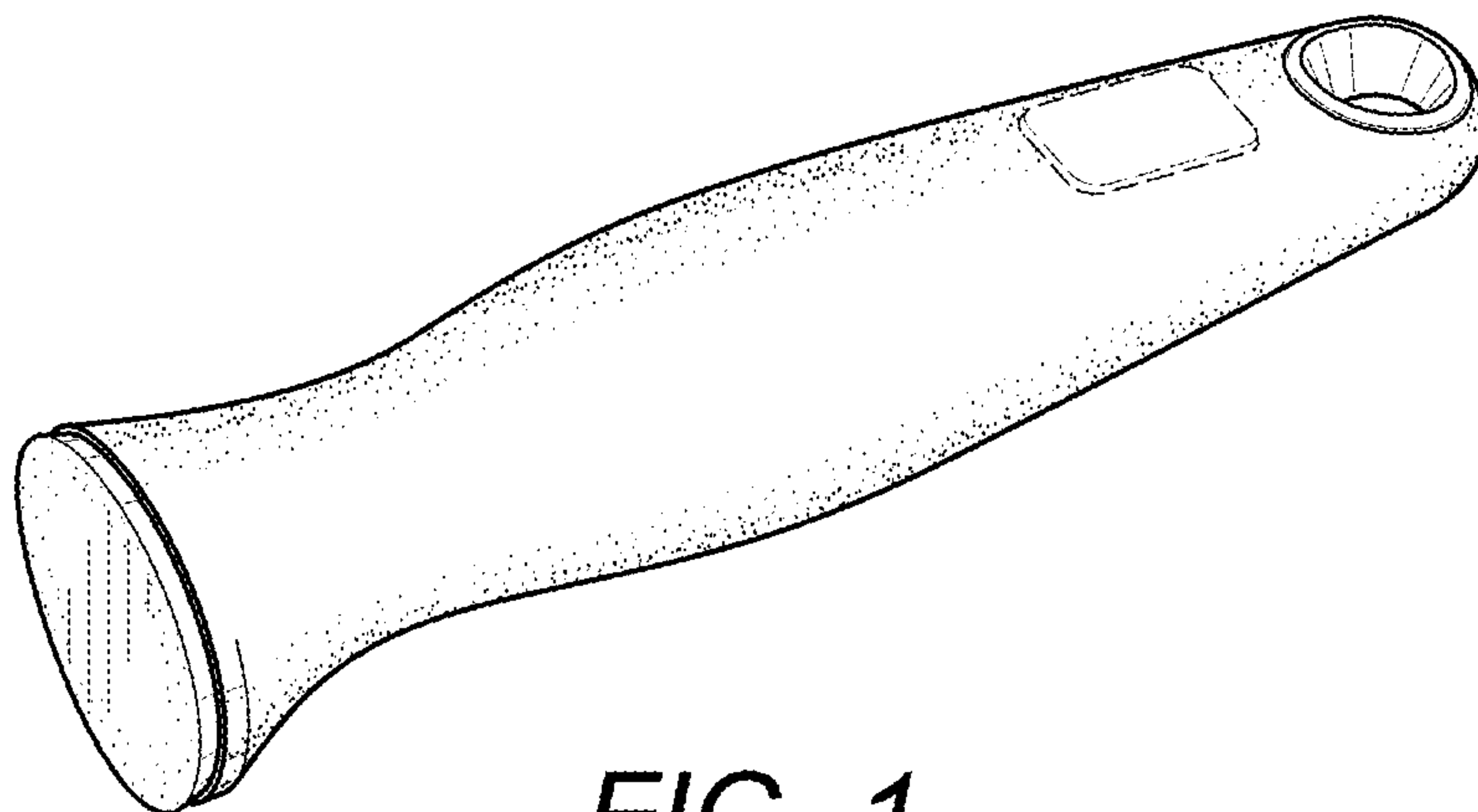

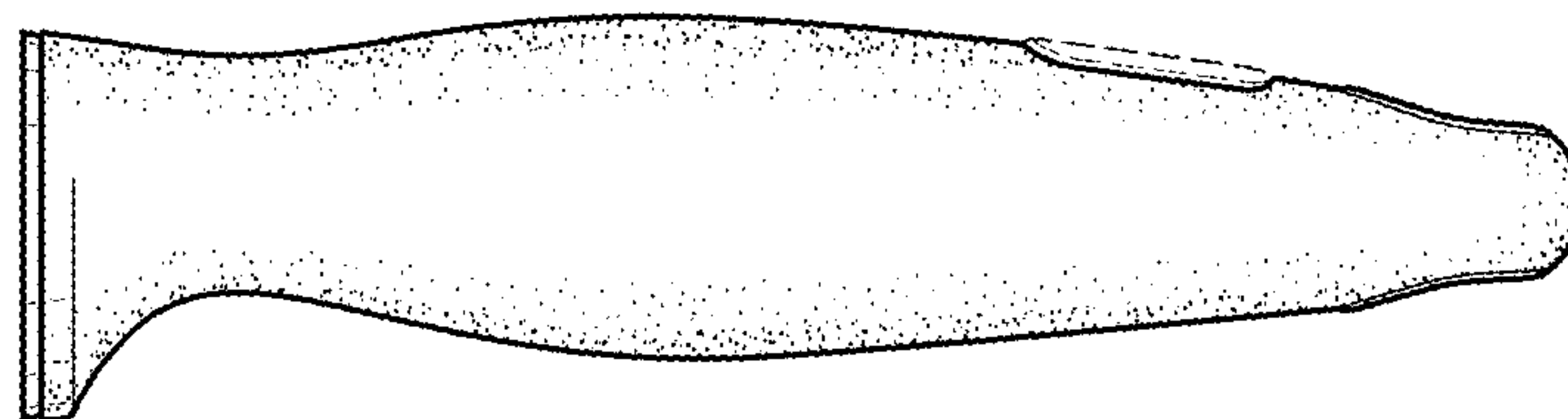

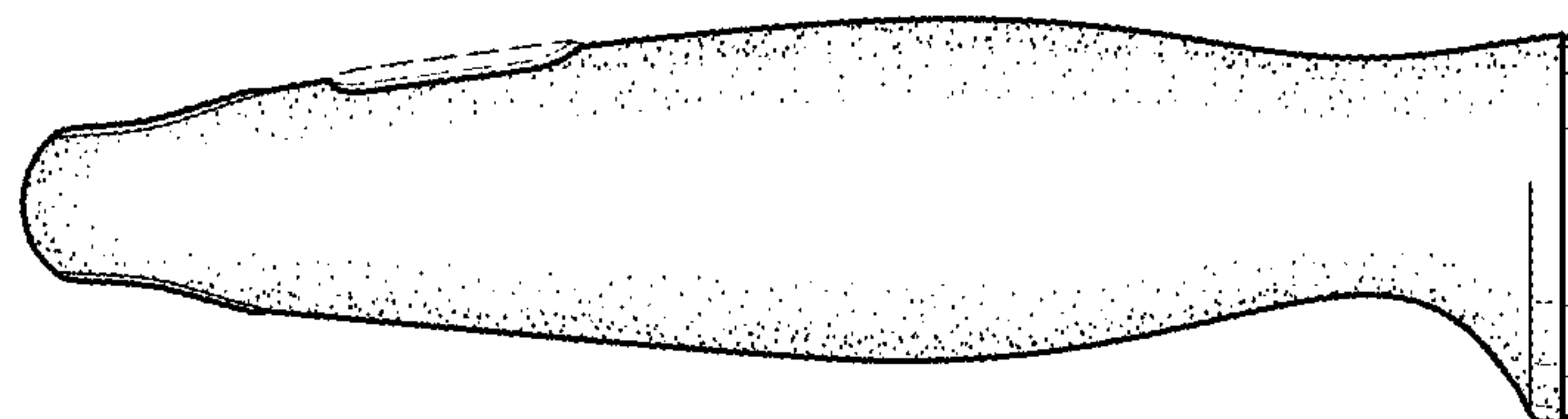

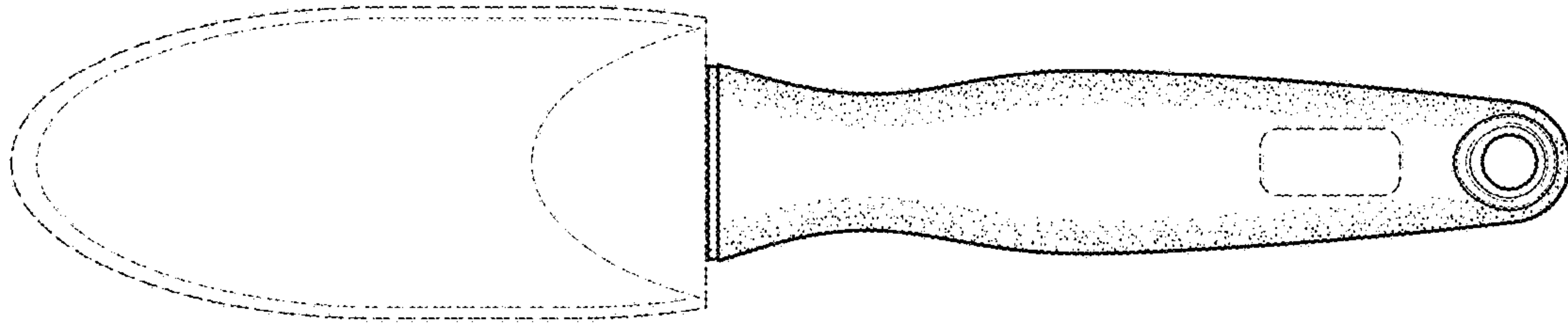

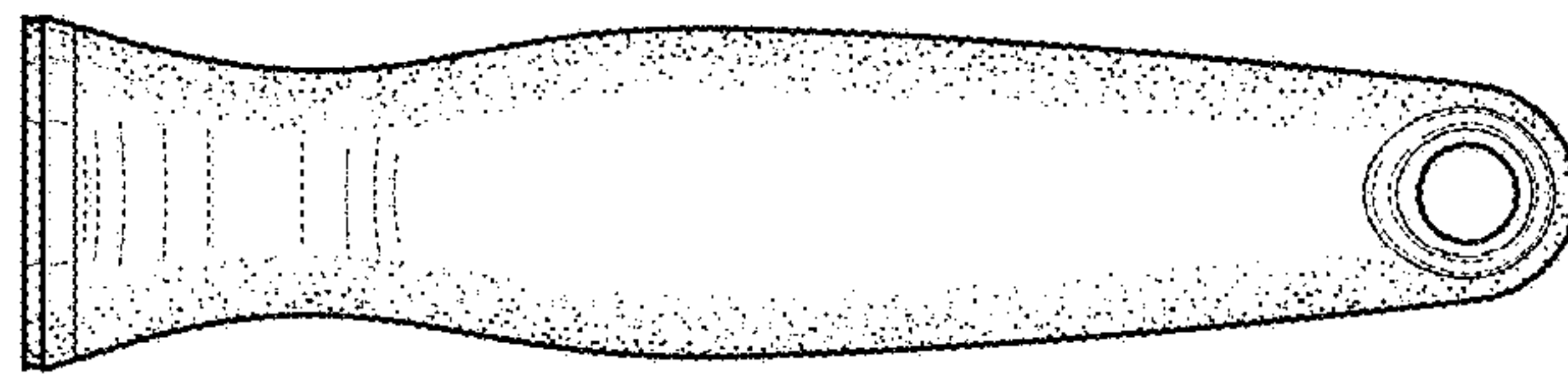

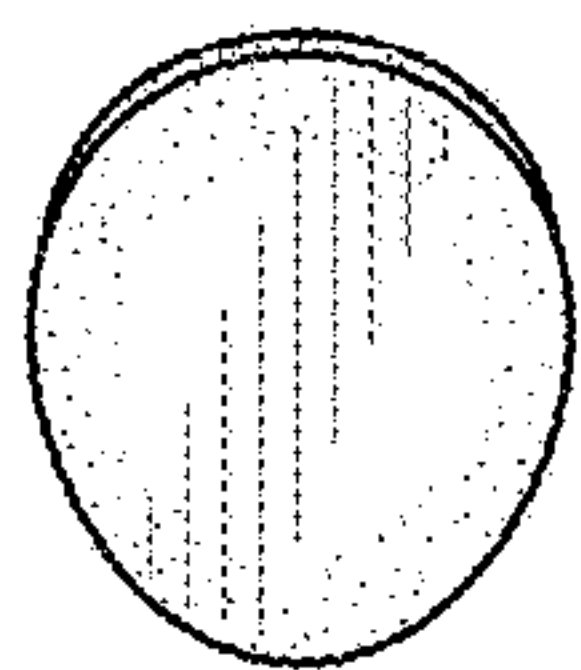

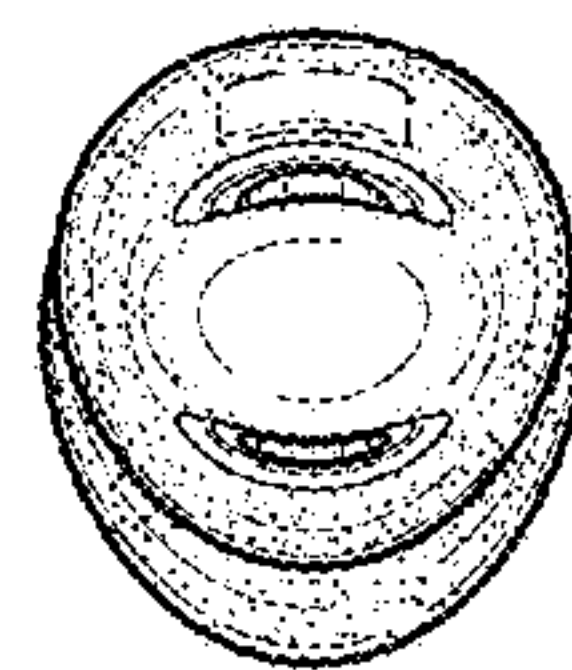
