DESCRIPTION

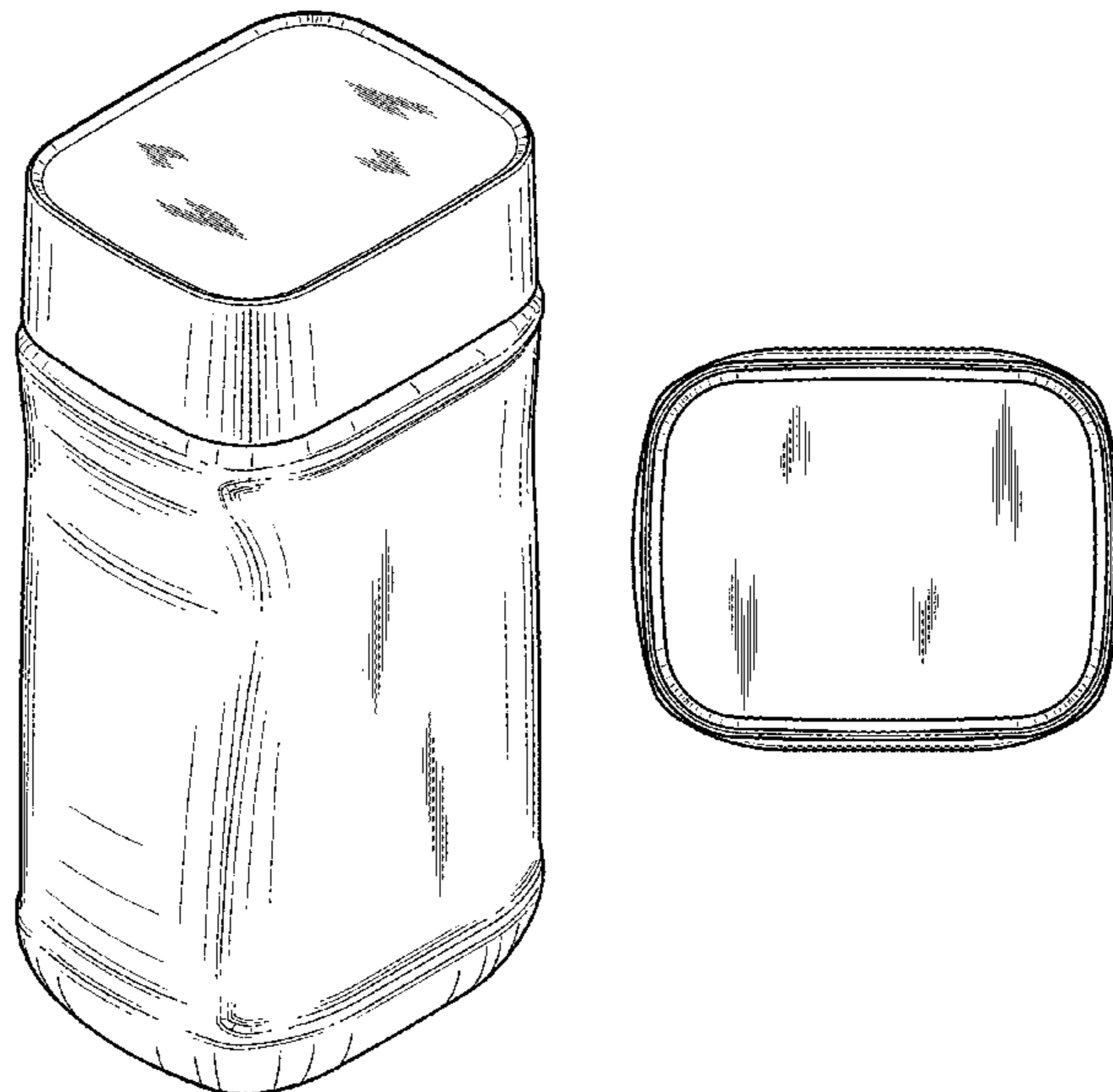
FIG. 1 is a front perspective view of the container showing the new design.

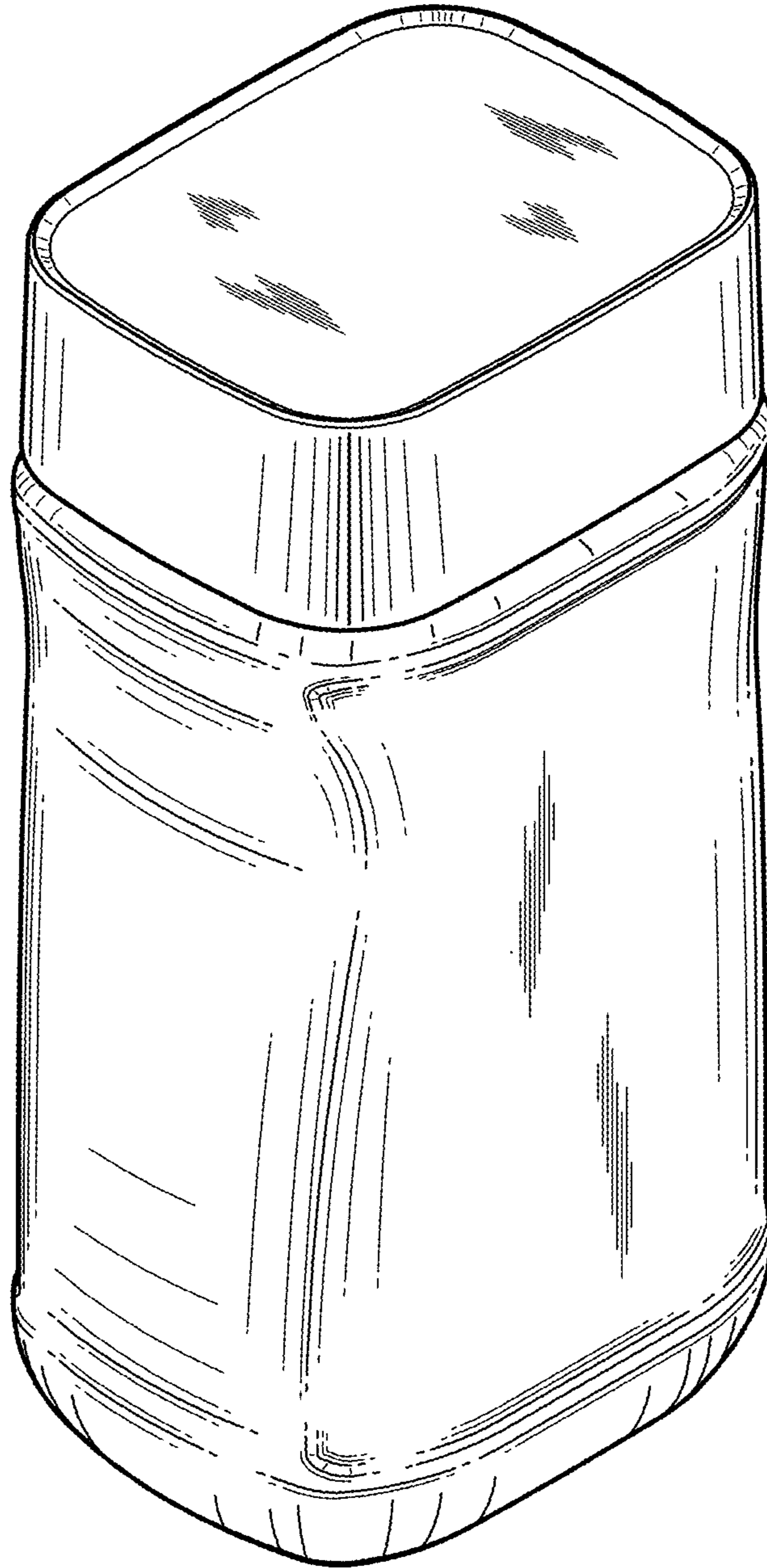

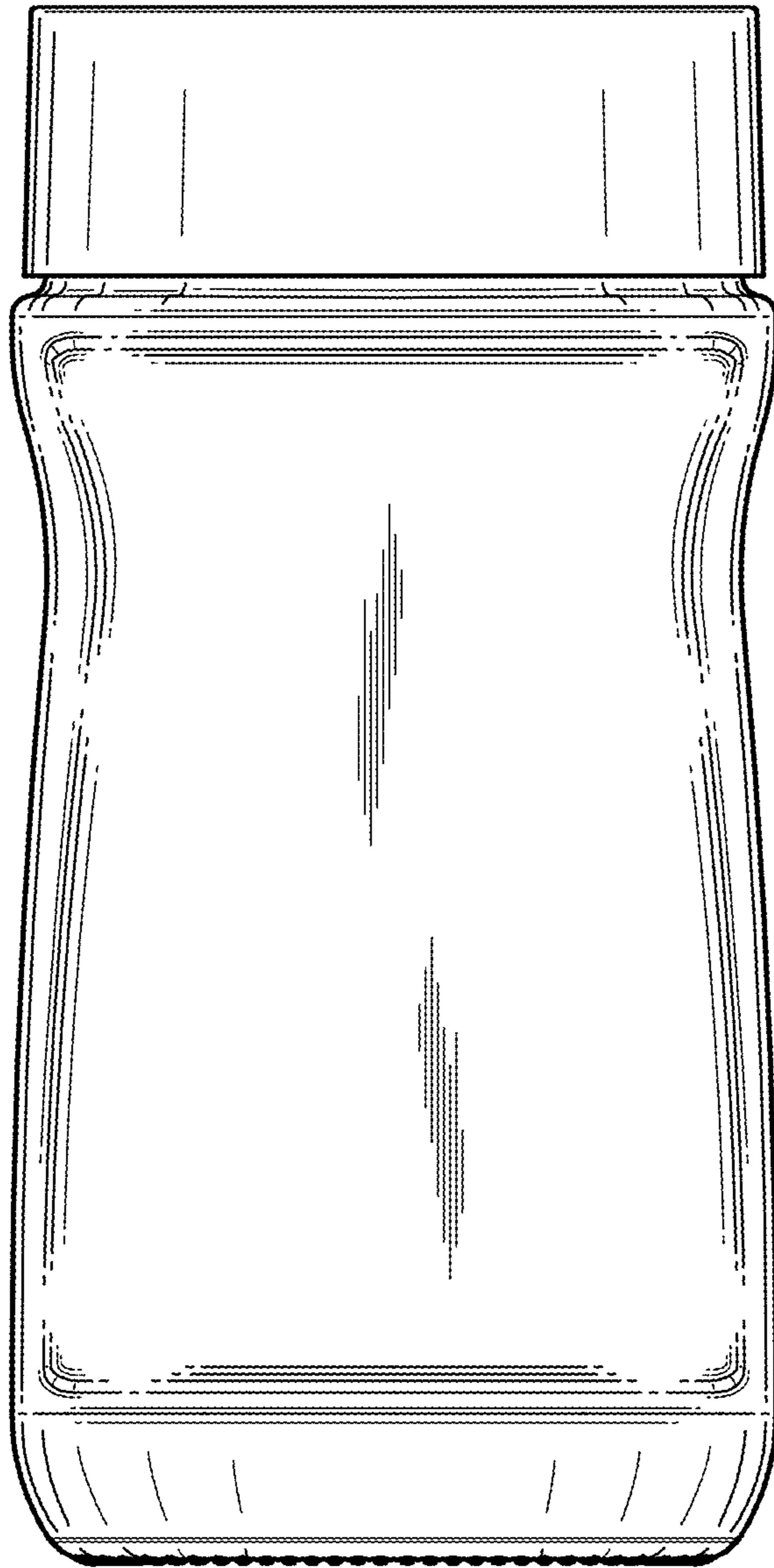

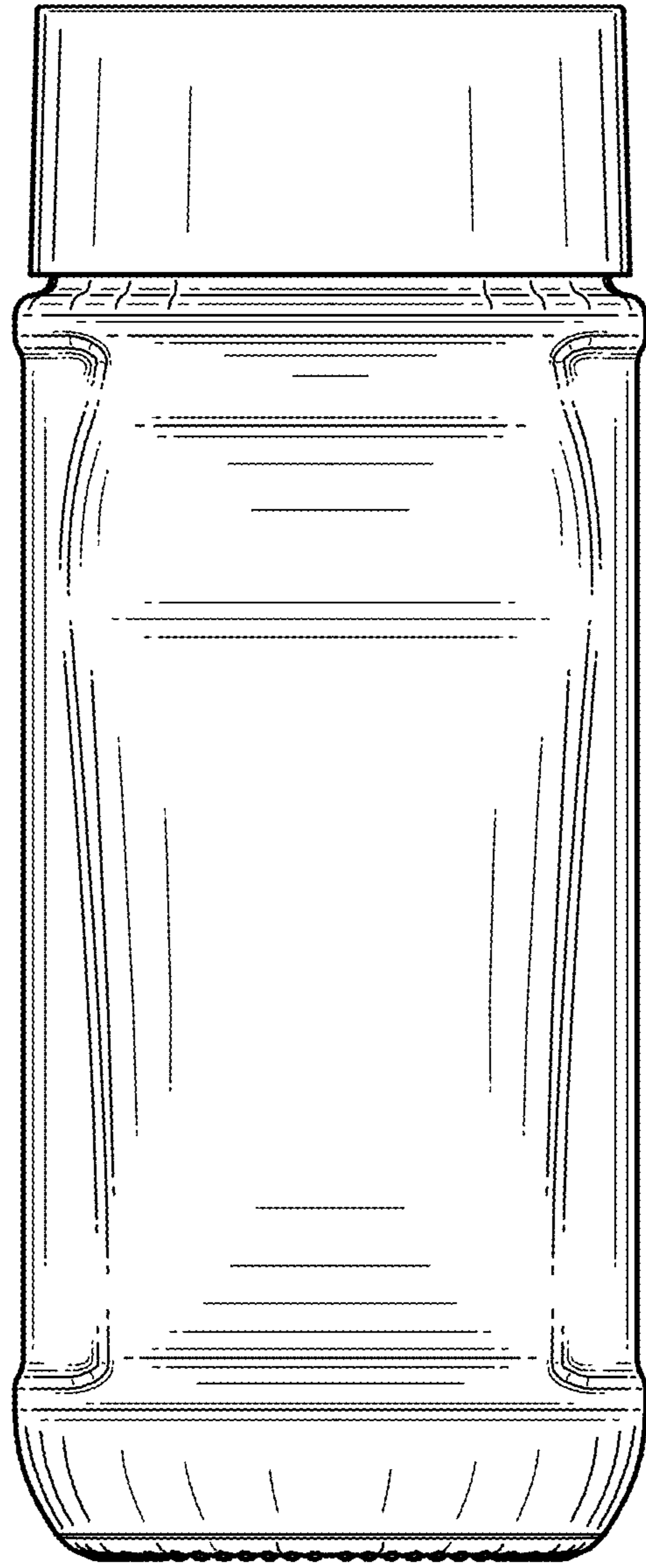

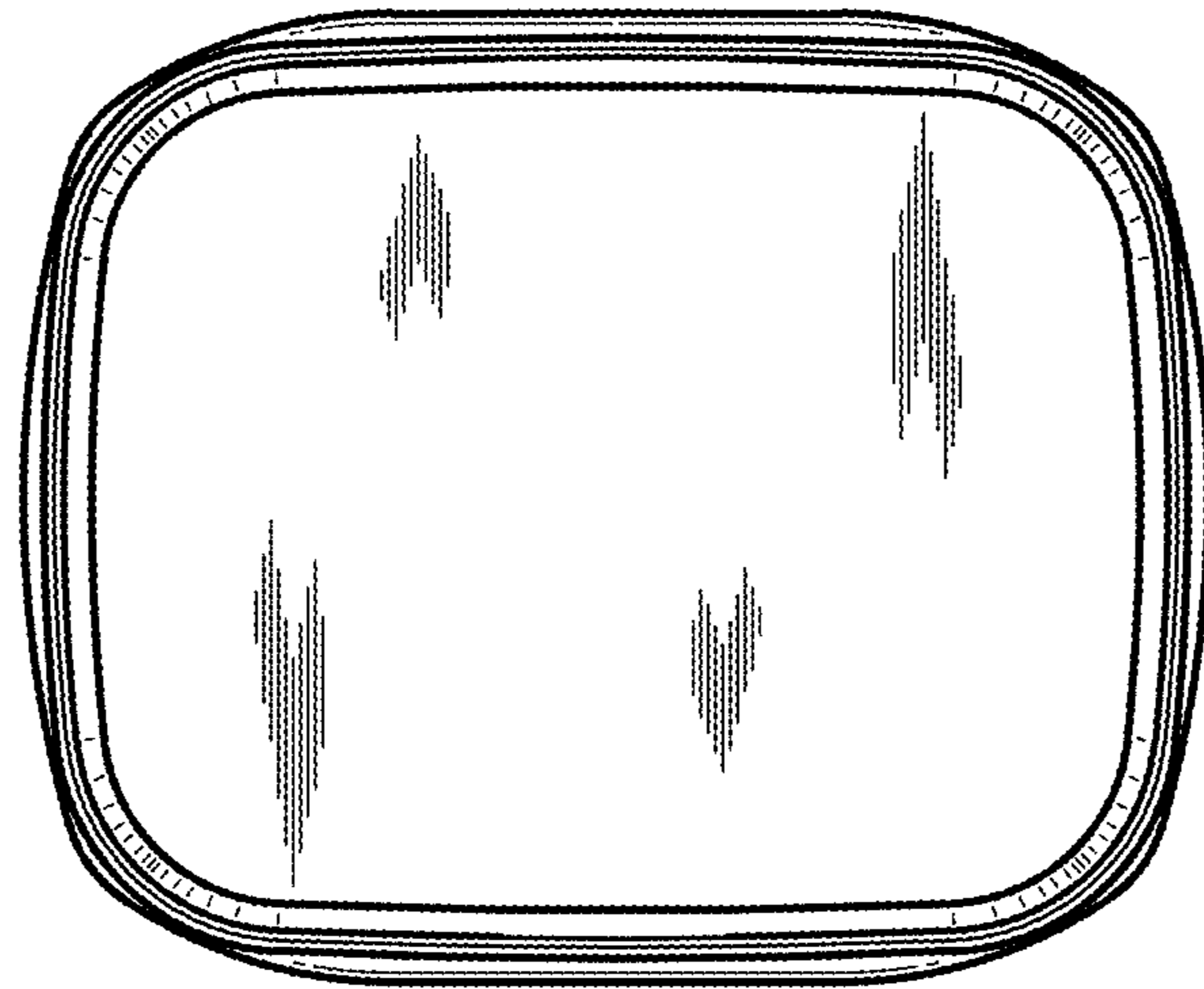
