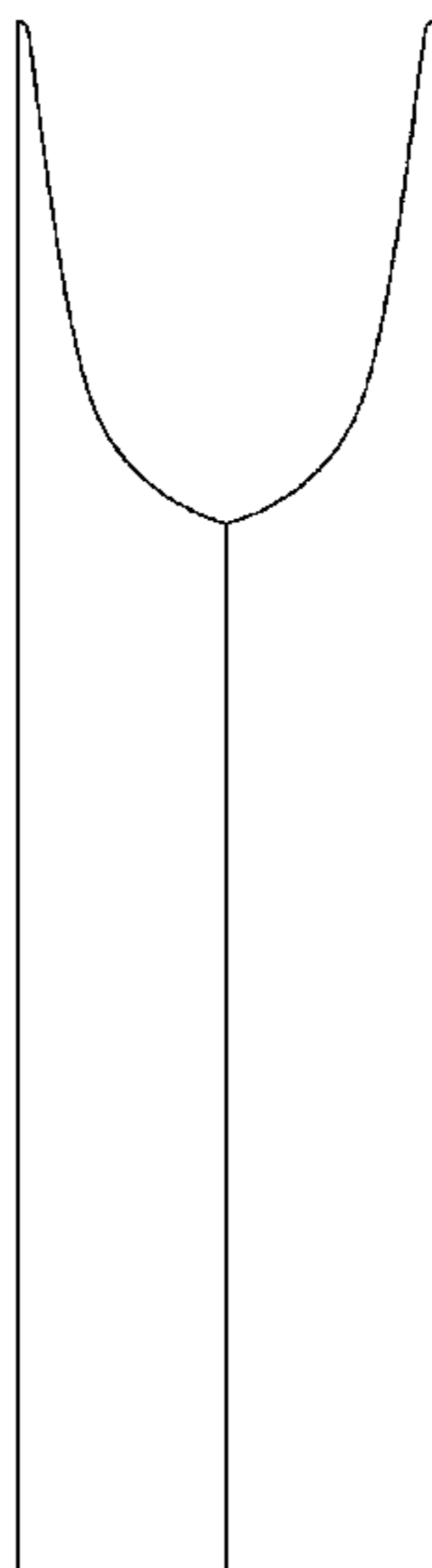
DESCRIPTION

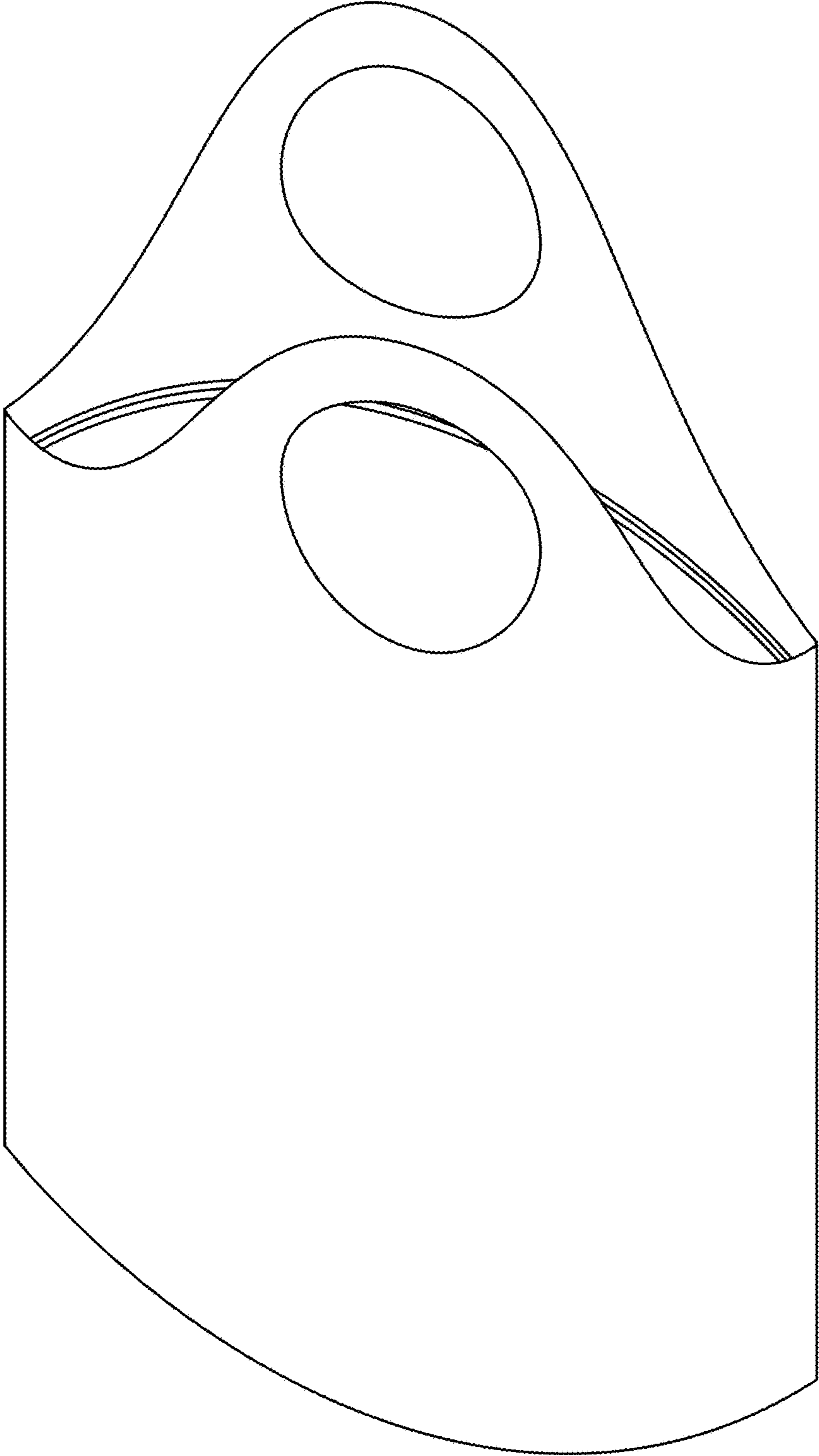

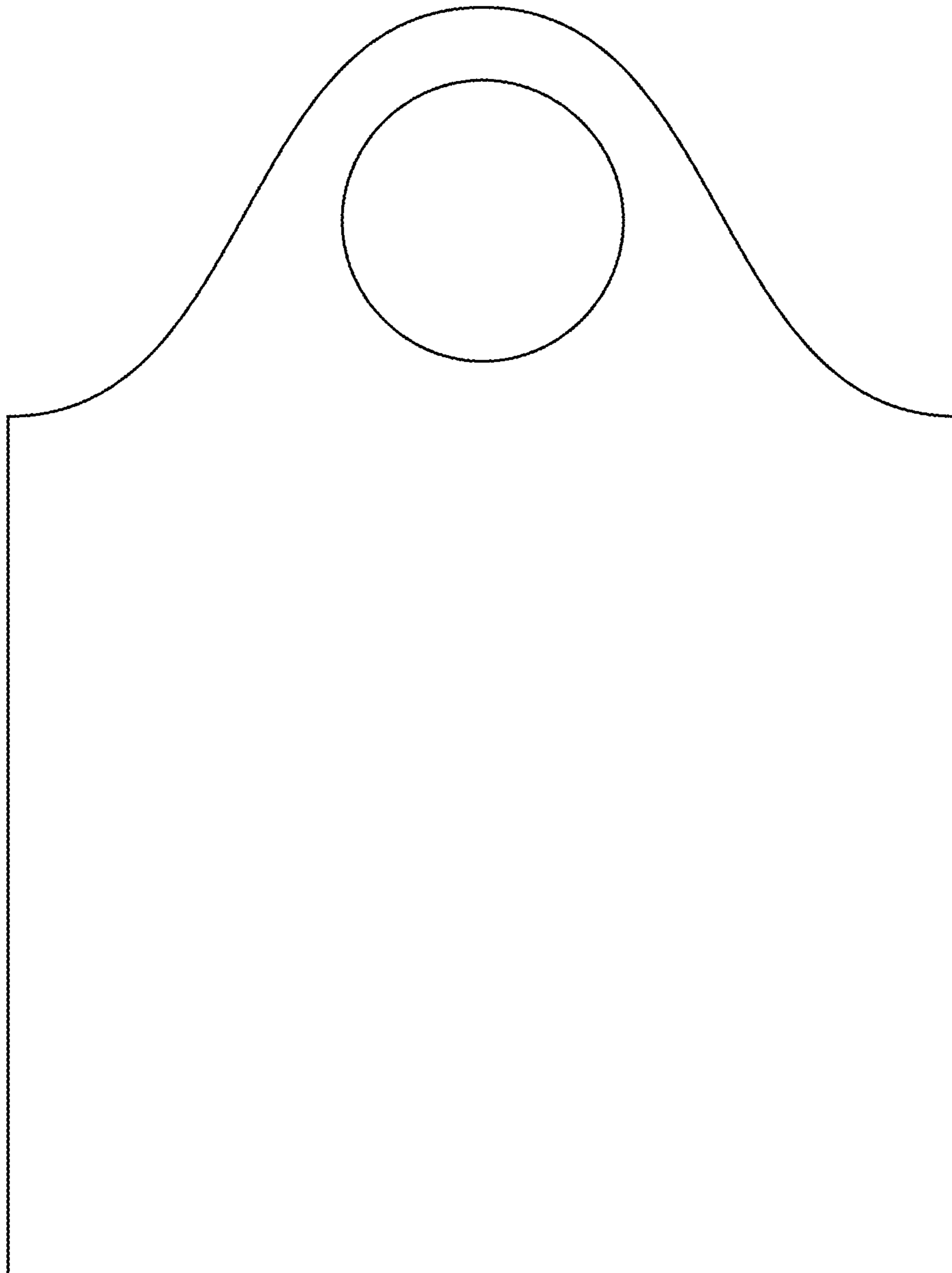

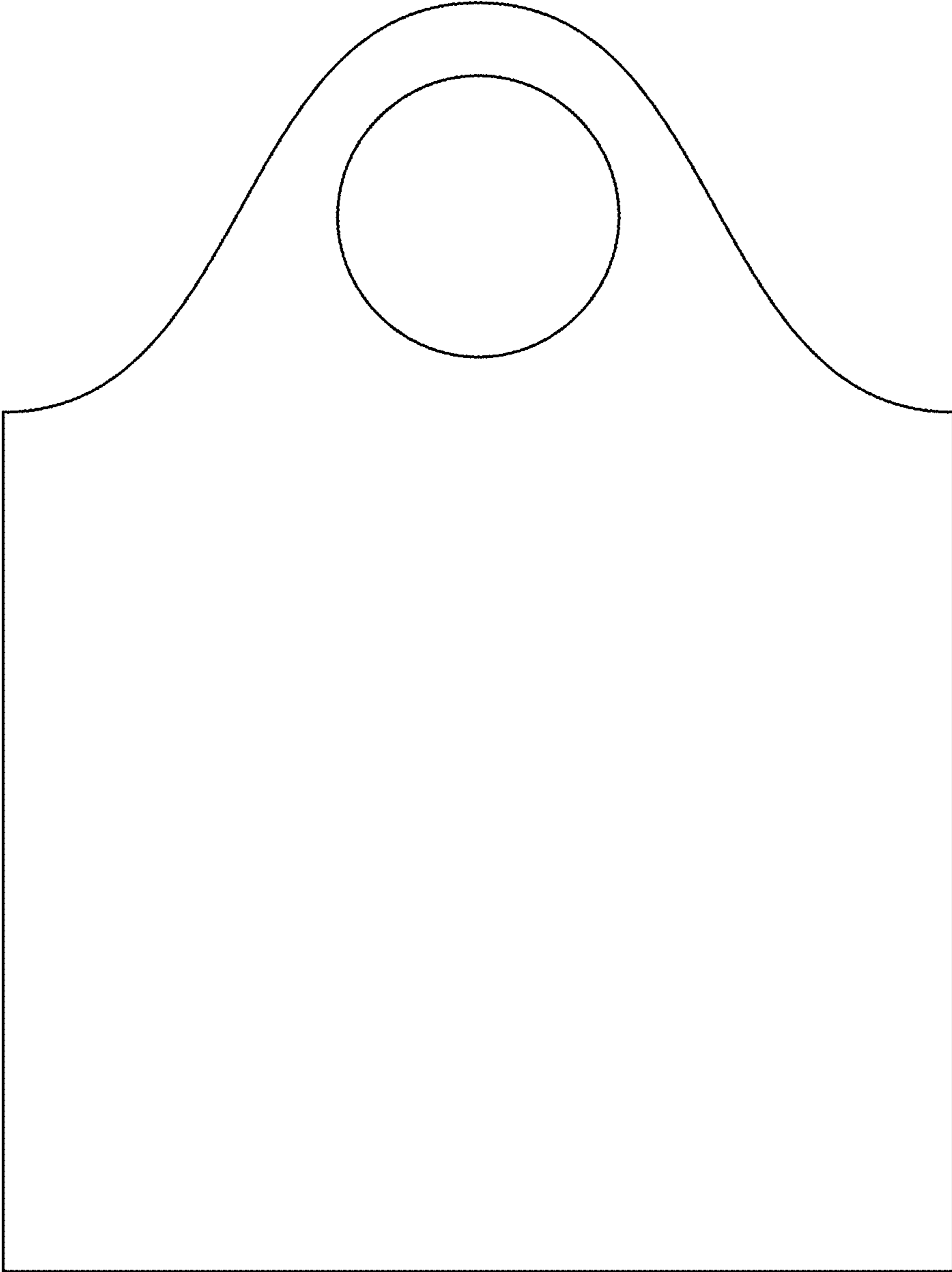

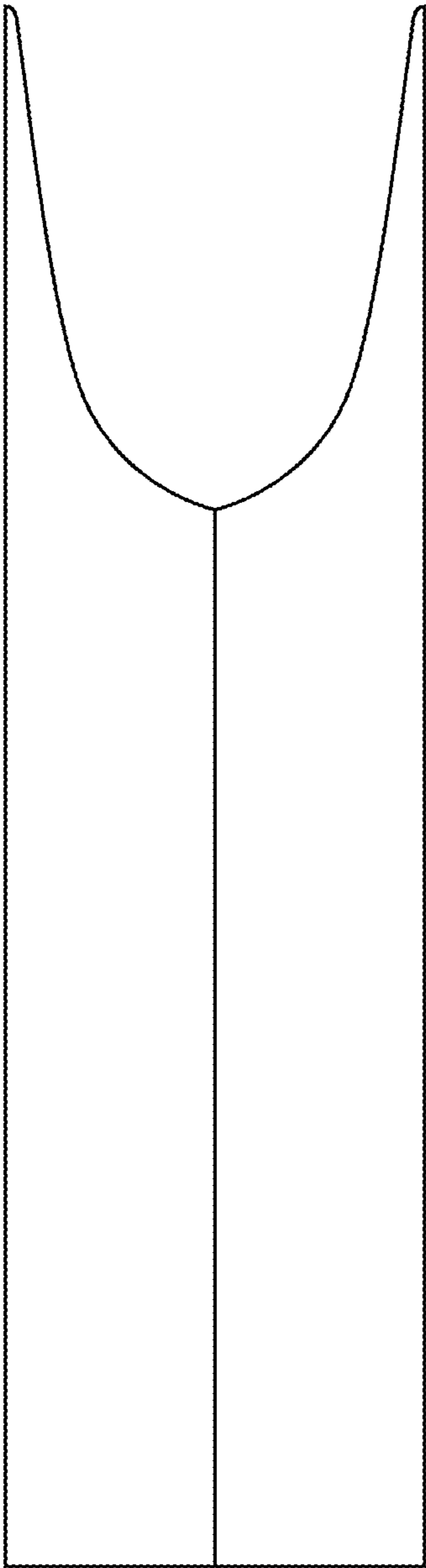

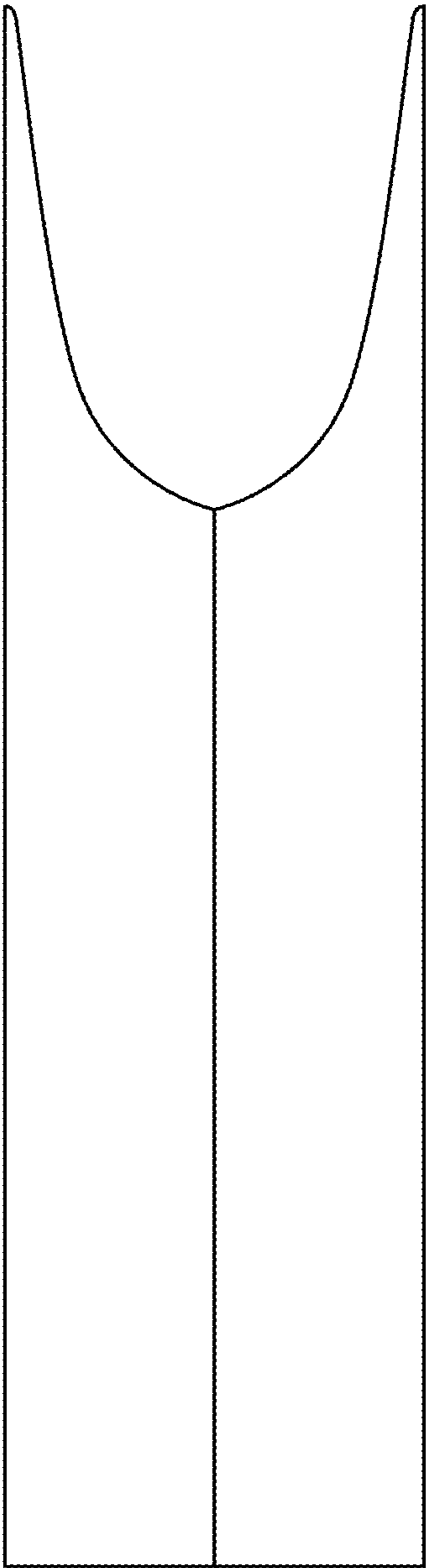

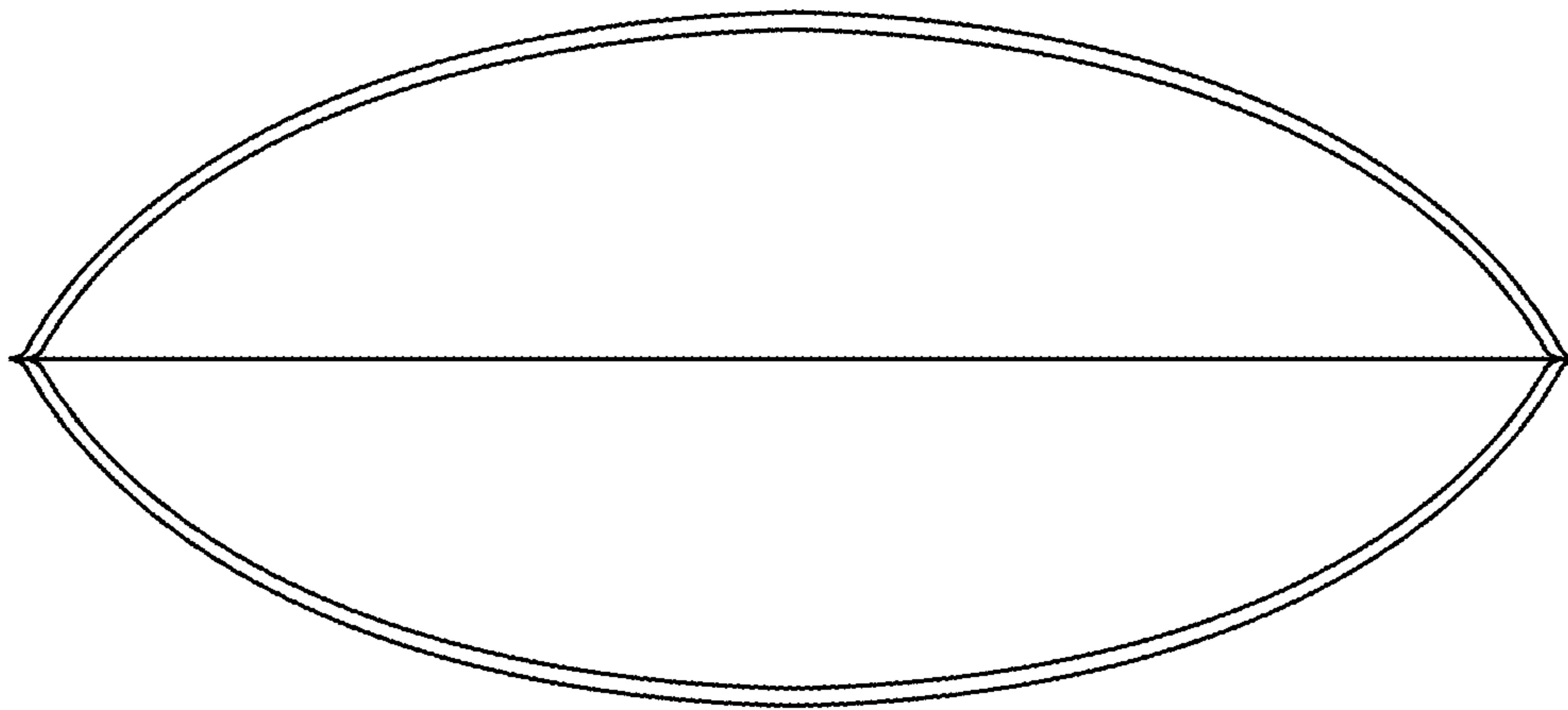
