The ornamental design for the pendant, as shown and described.

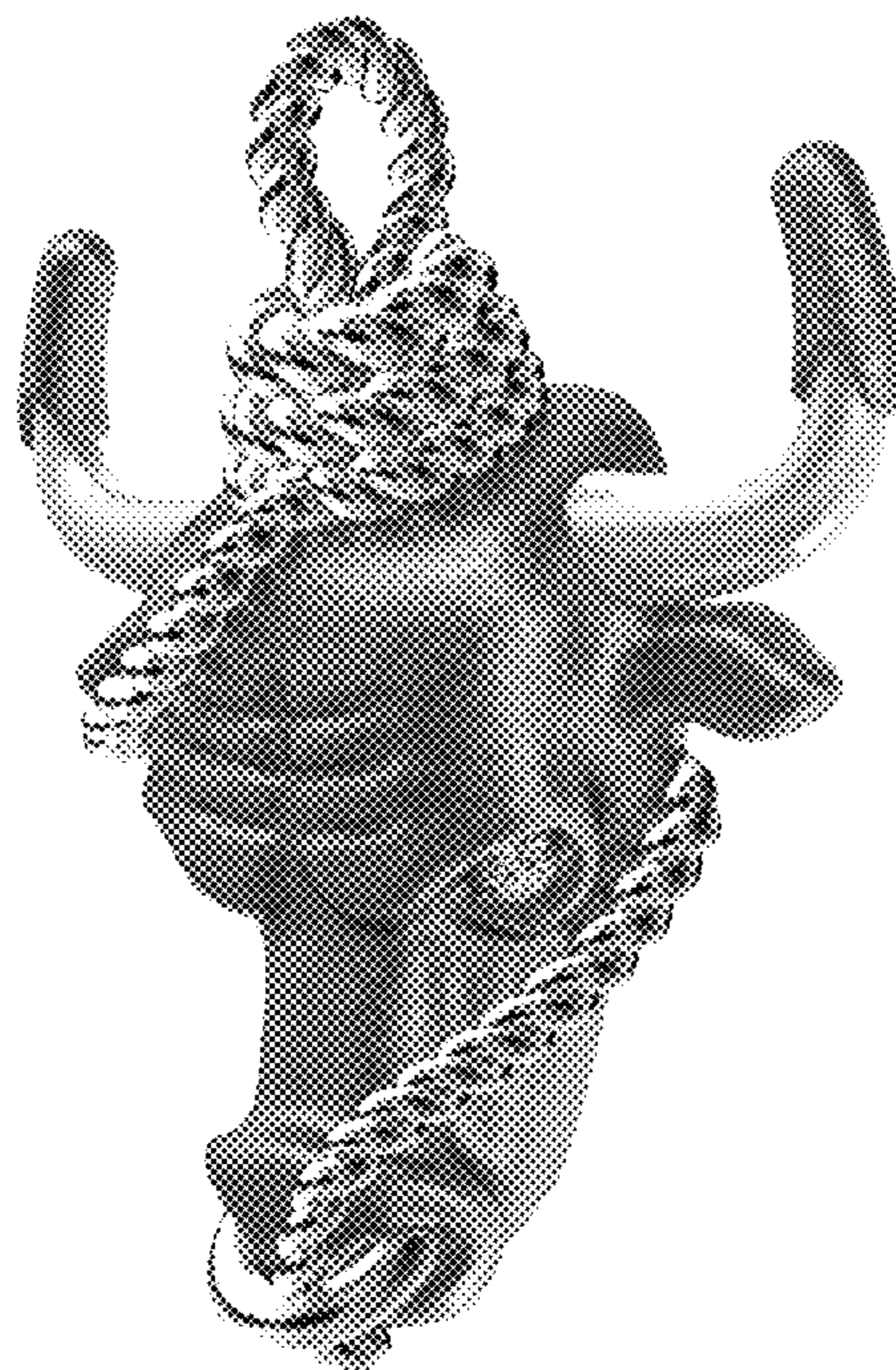
DESCRIPTION

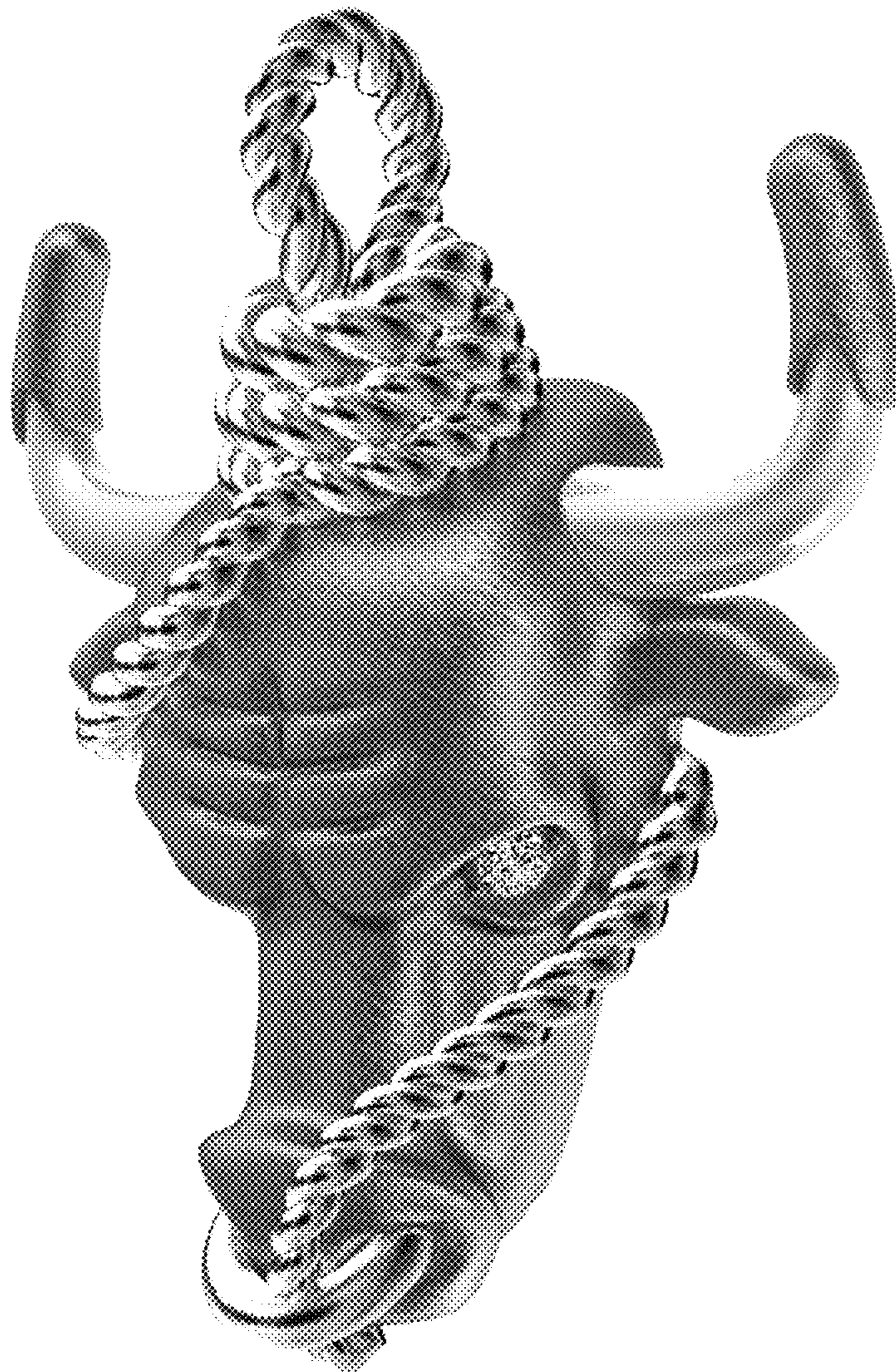

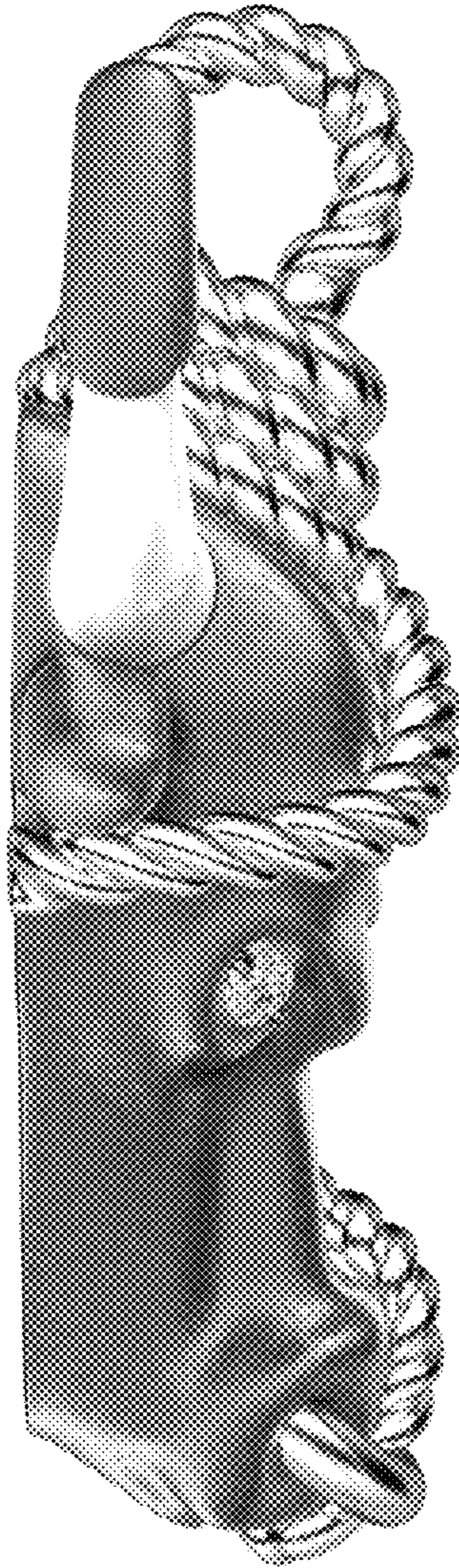

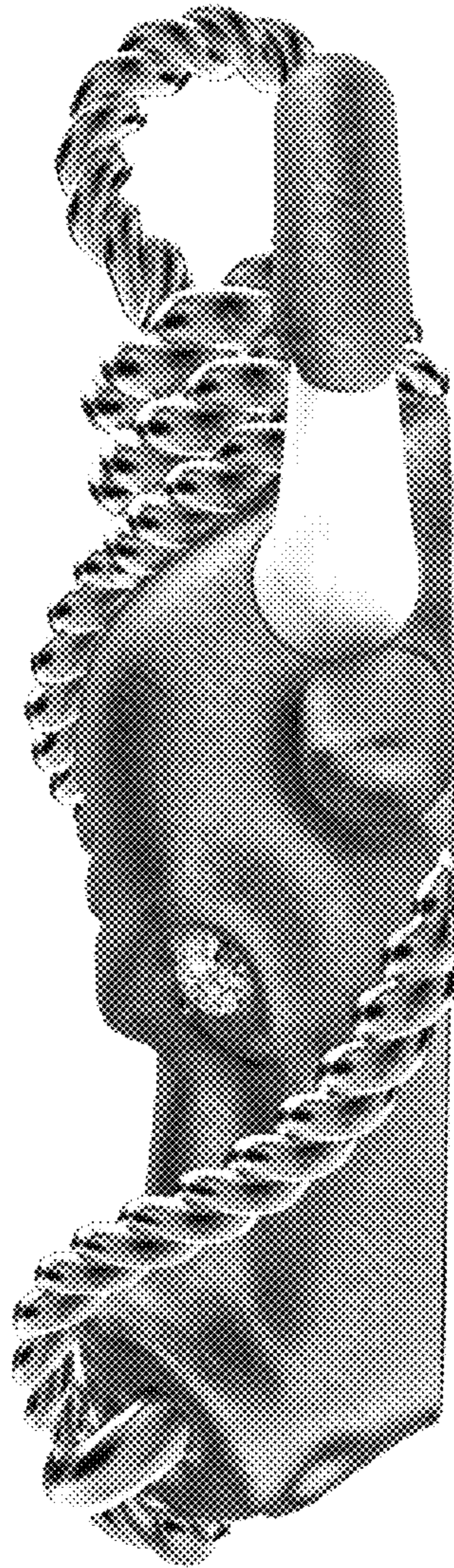

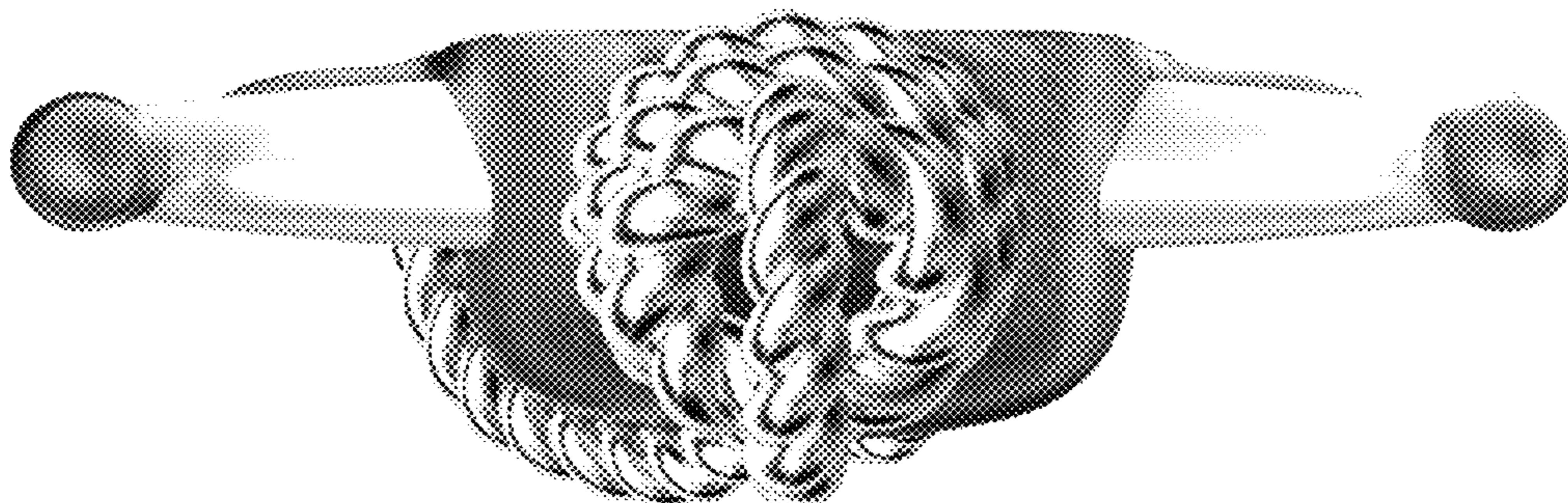

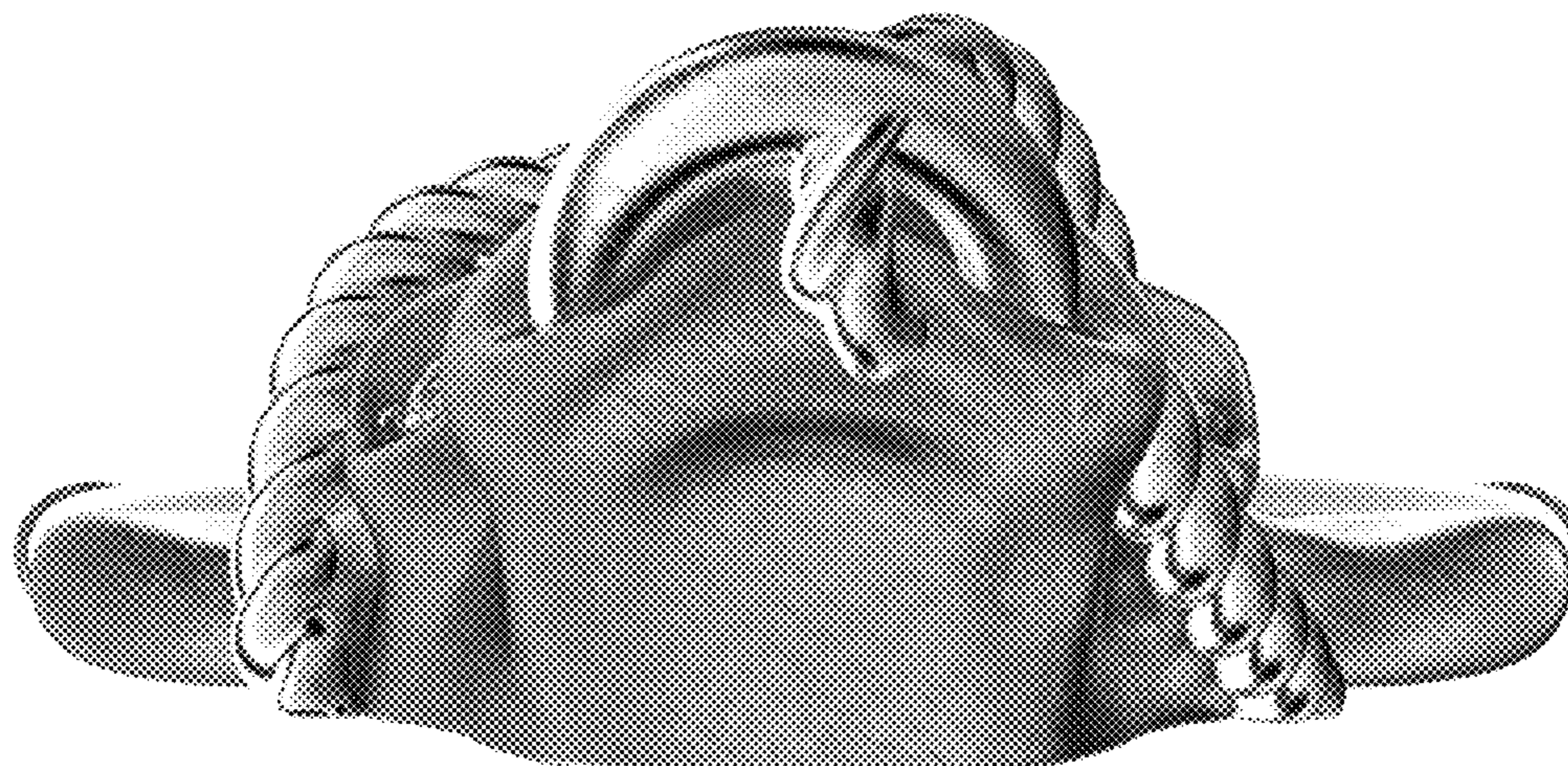
