(57) **CLAIM**

The ornamental design for a pointed face of a sheet element used in construction of hollow shaped bodies, as shown and described.

**DESCRIPTION**

FIG. 5 is a right side elevation view thereof;

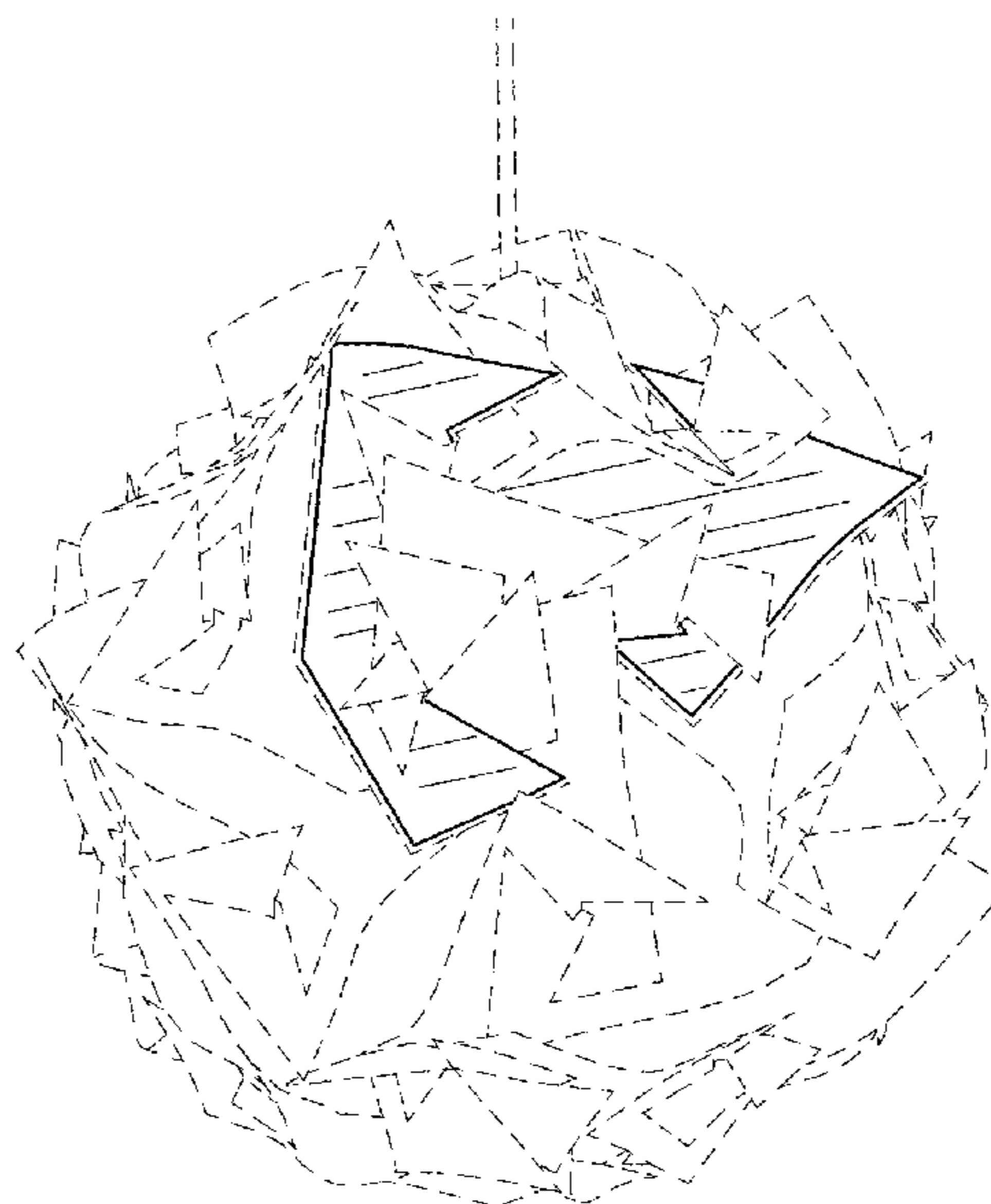
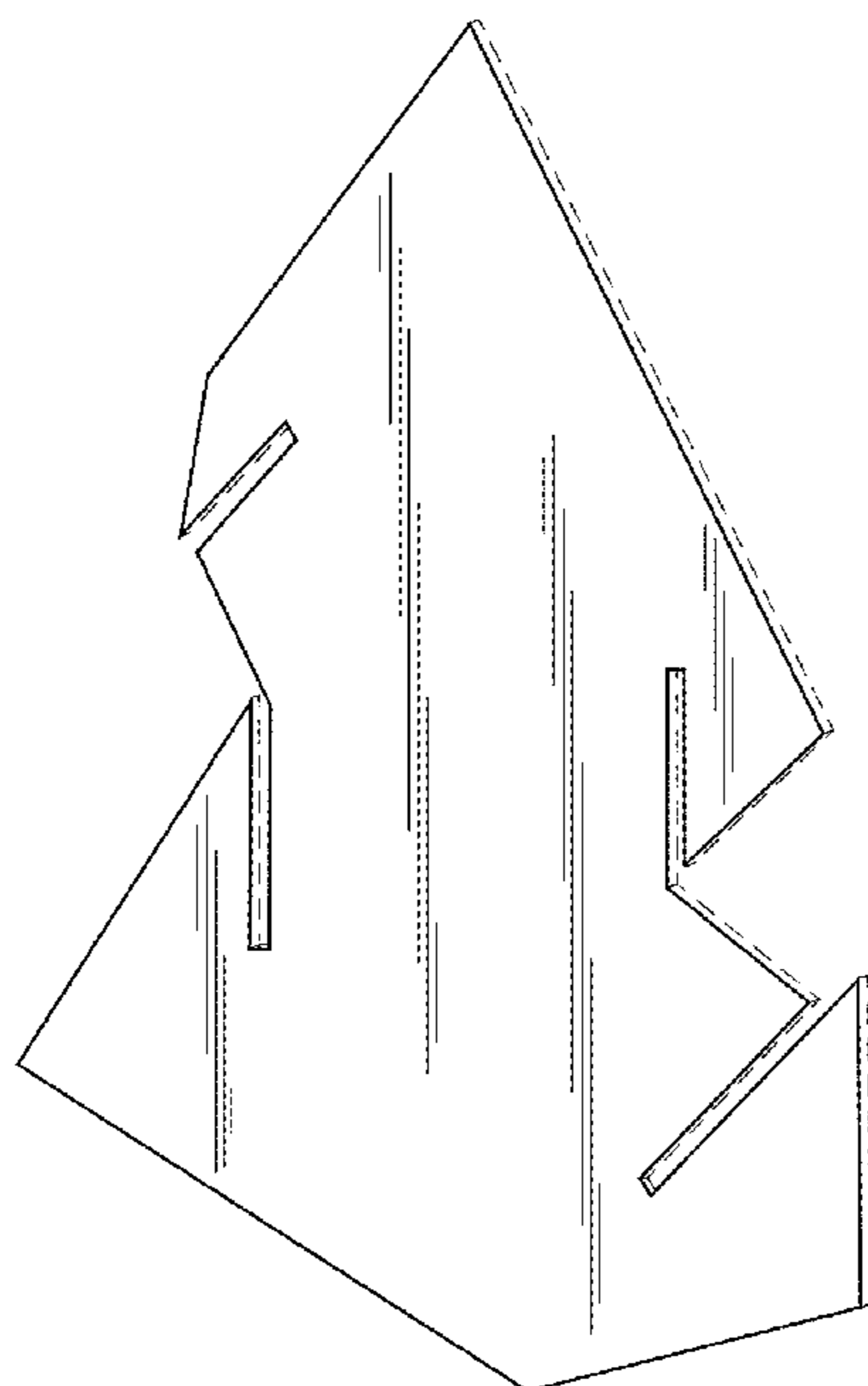
FIG. 6 is a top plan view thereof;

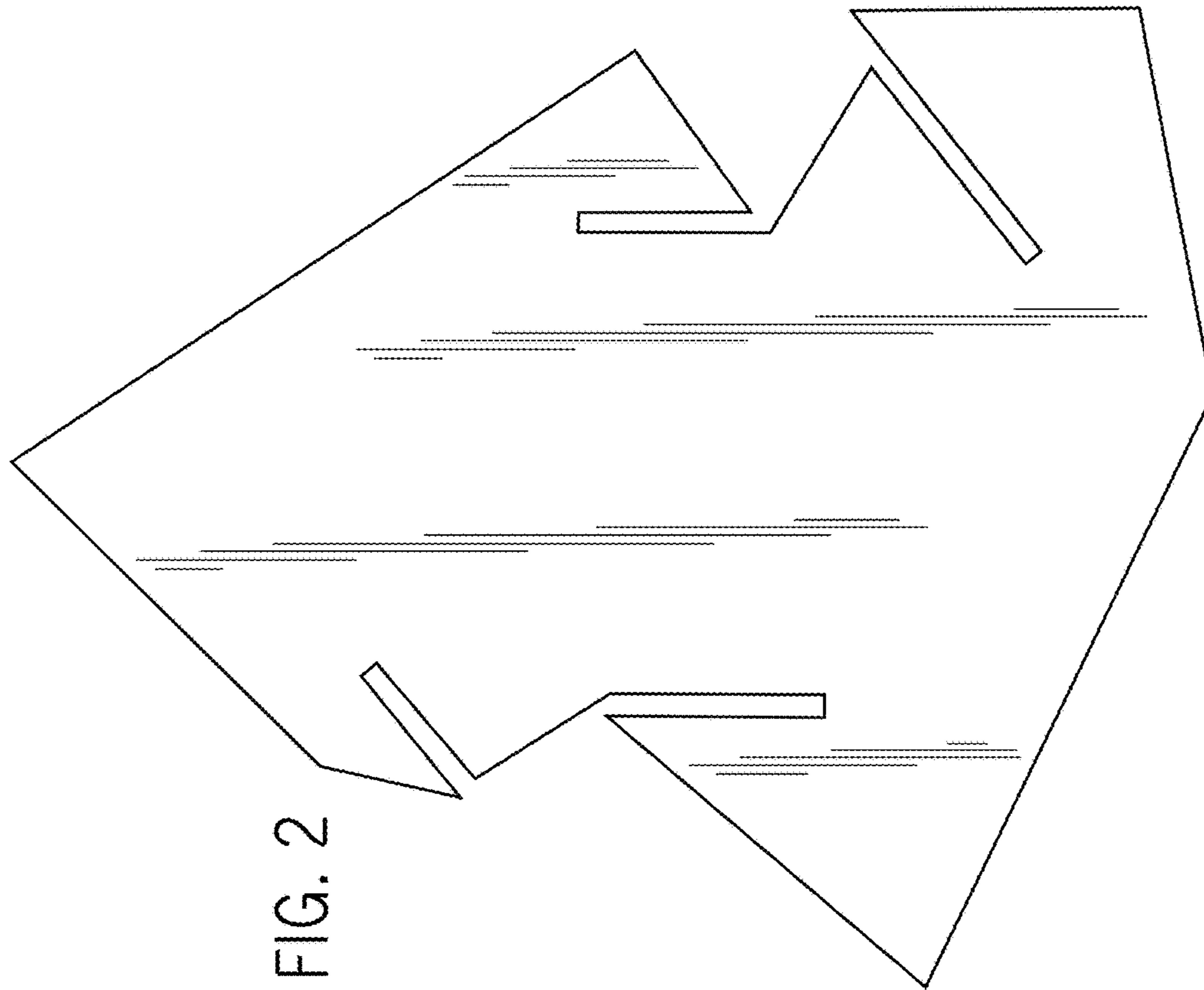

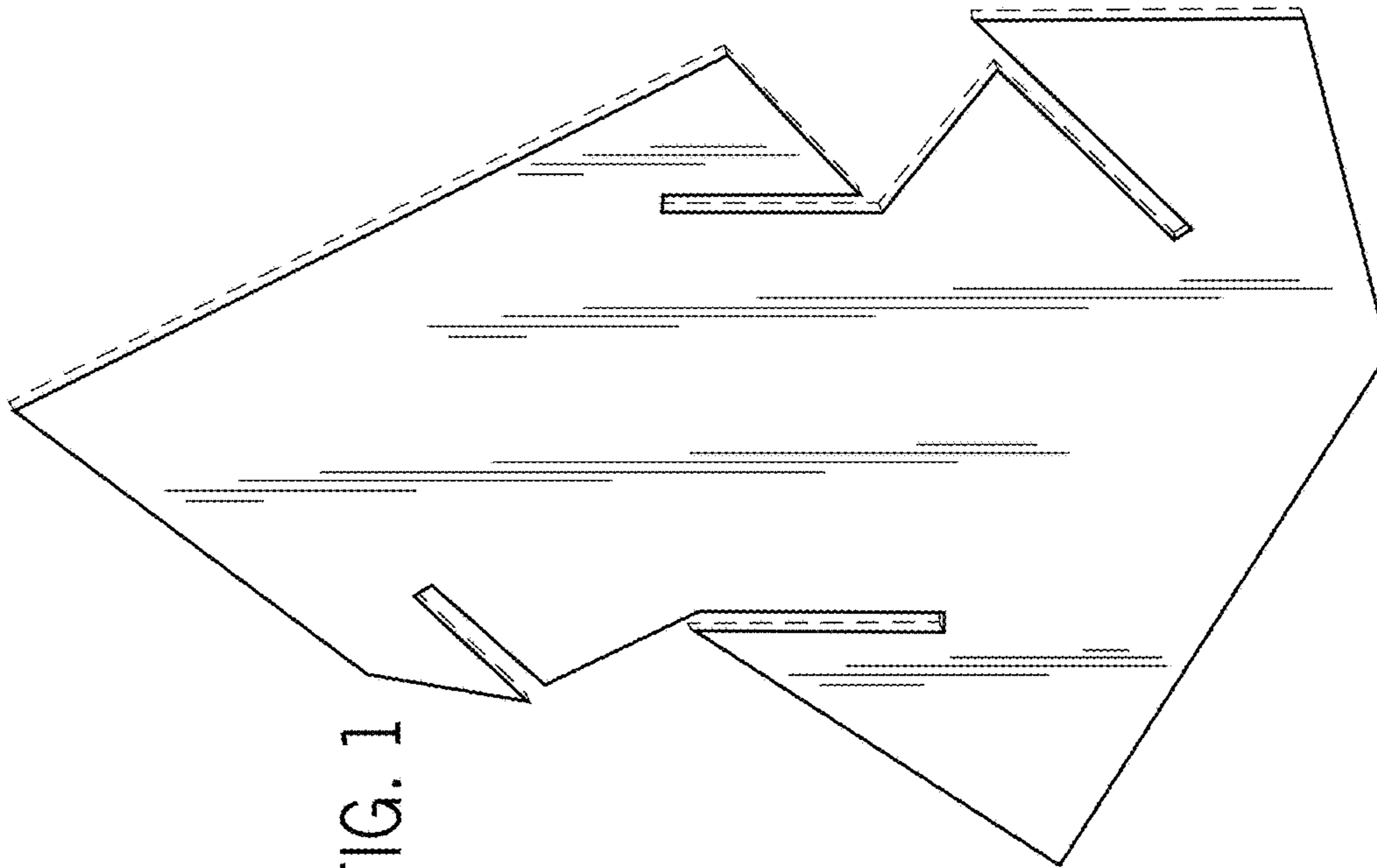

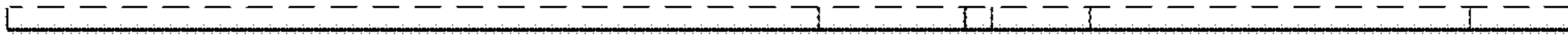

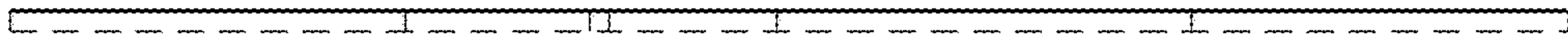

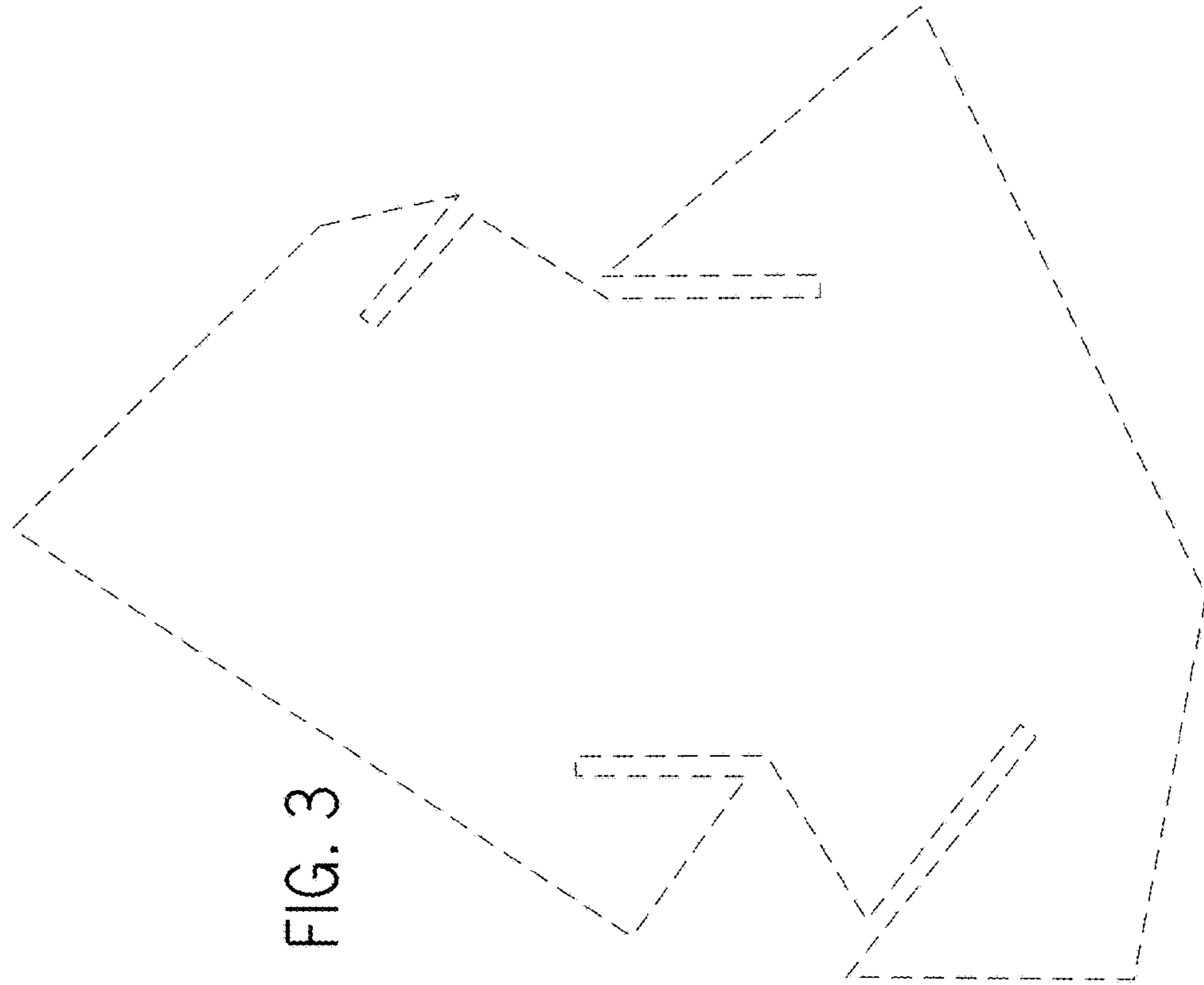

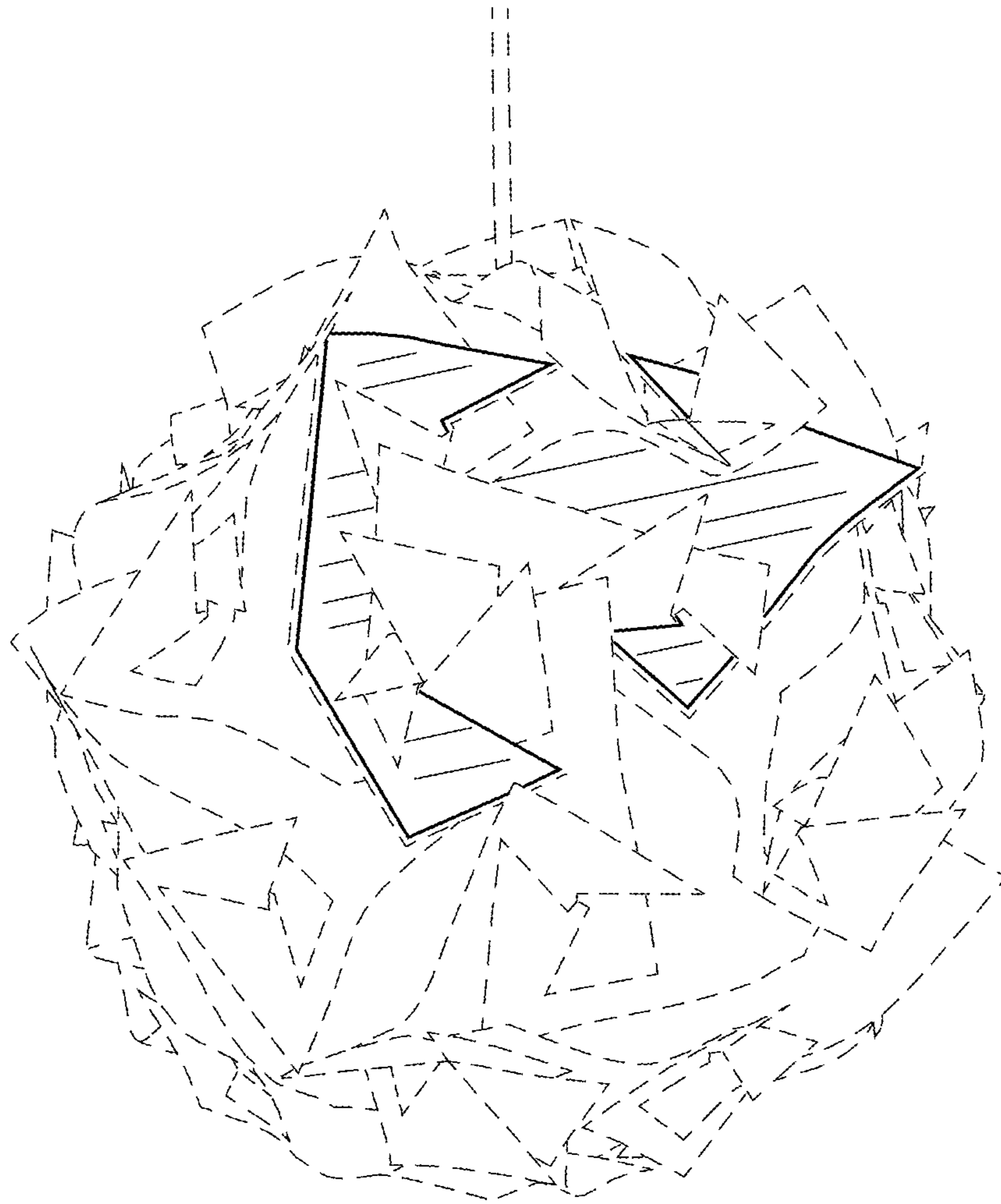
