(57) **CLAIM**

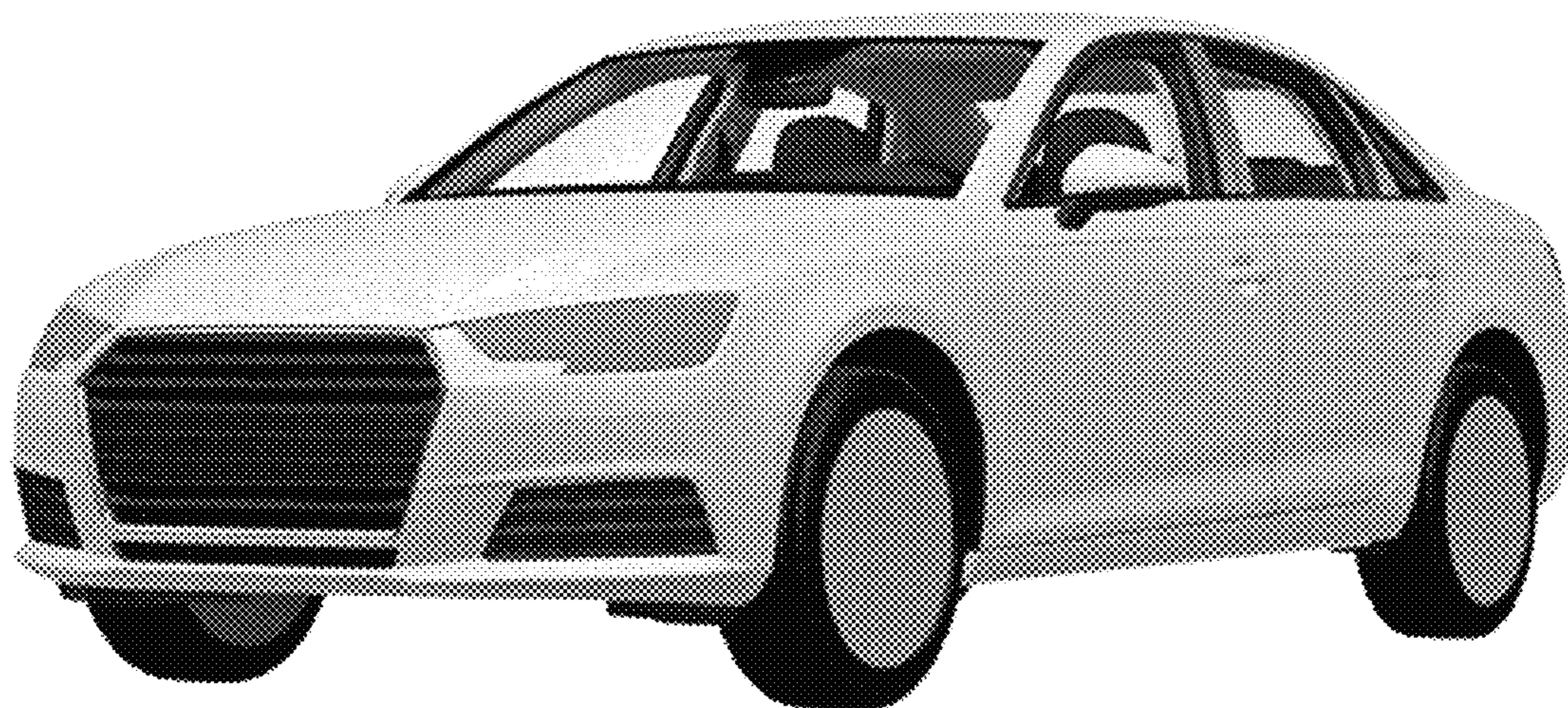
The ornamental design for a motor vehicle, toy and/or replicas thereof, as shown and described.

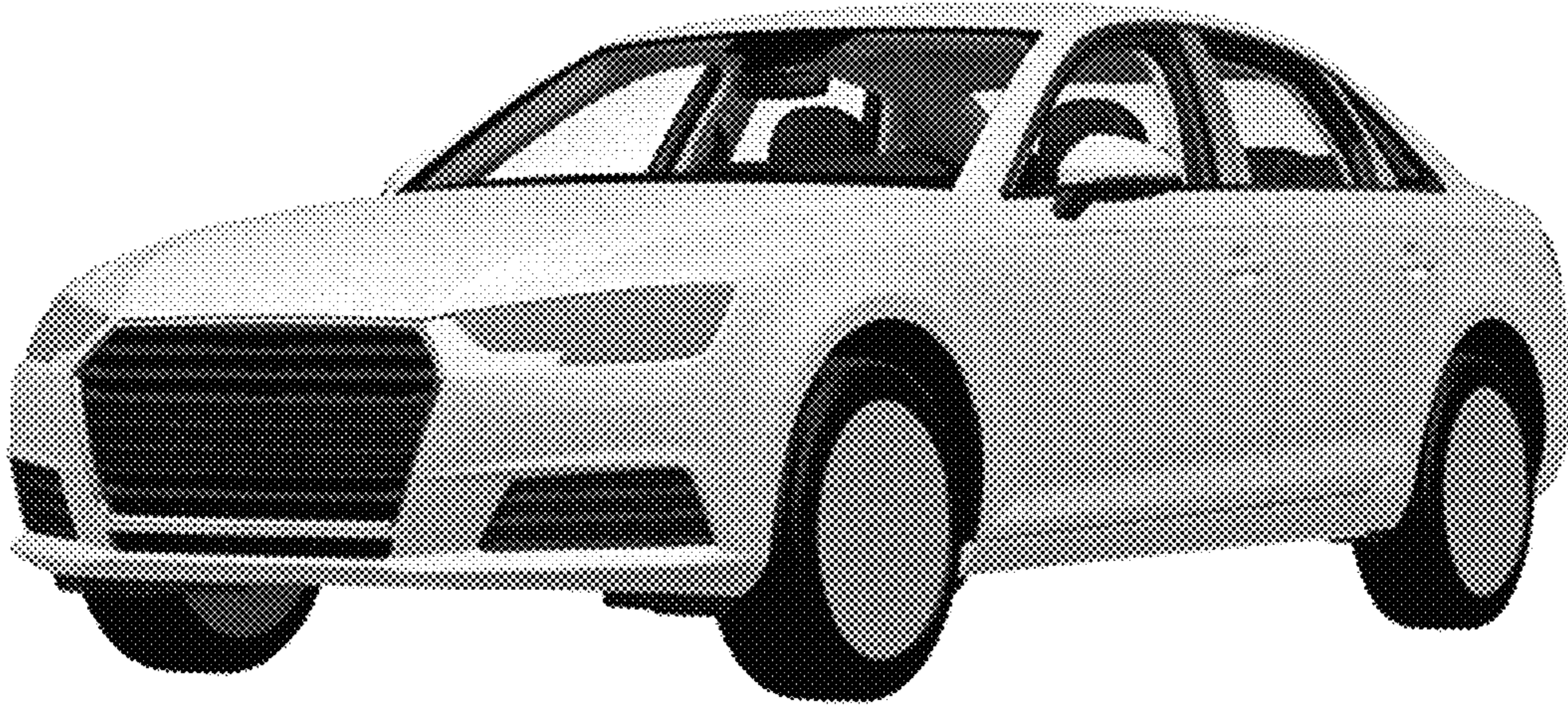

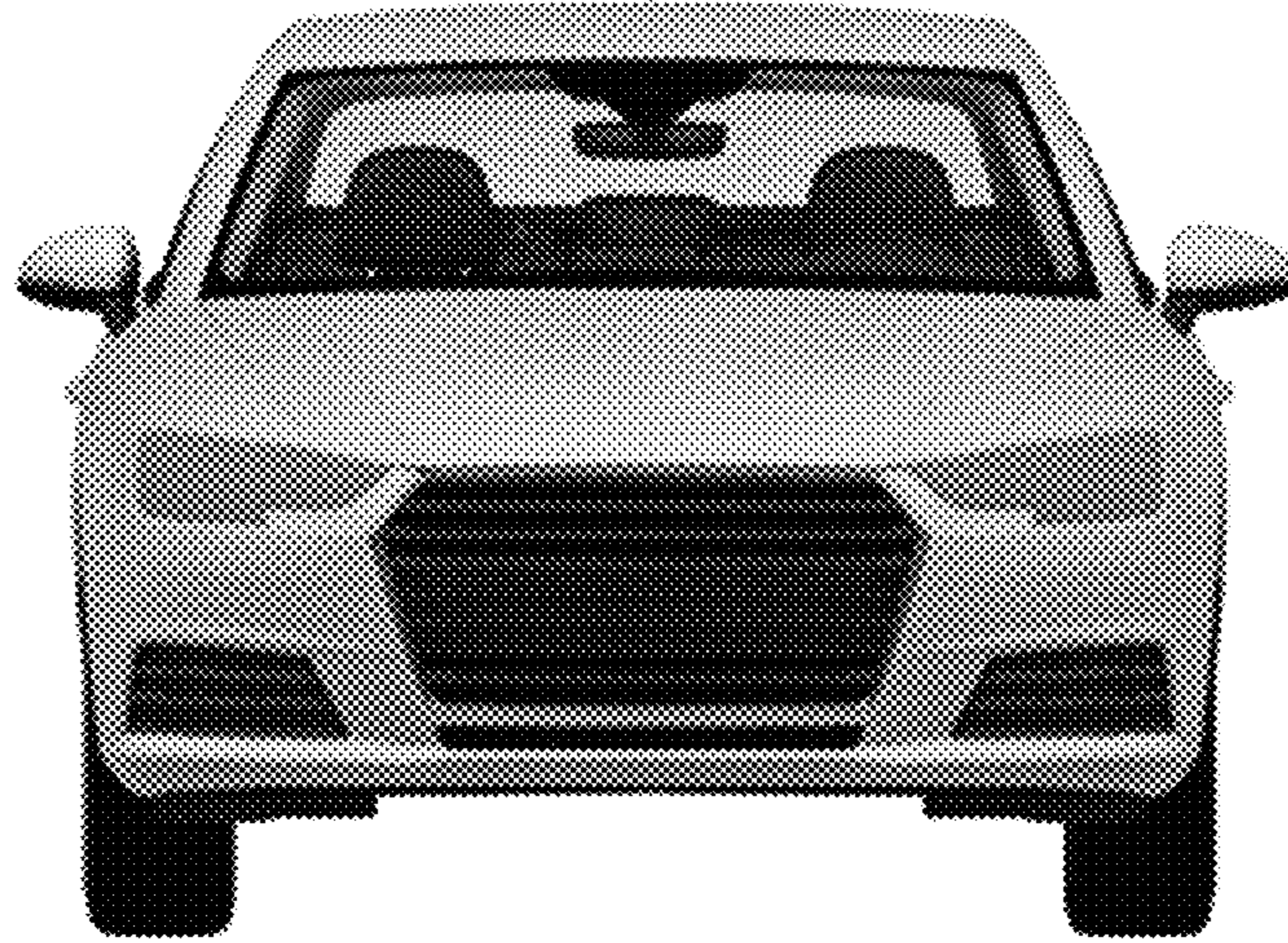

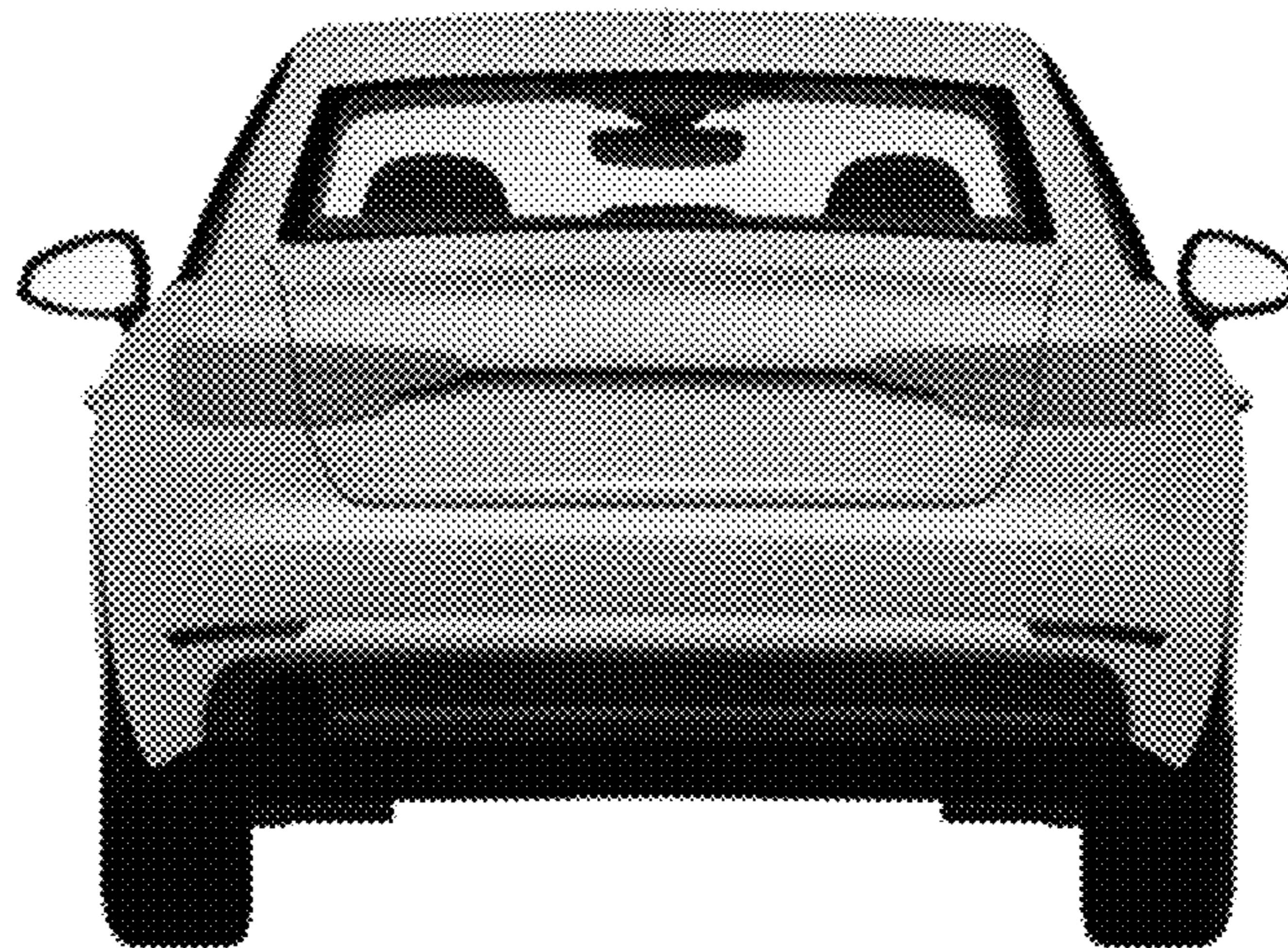

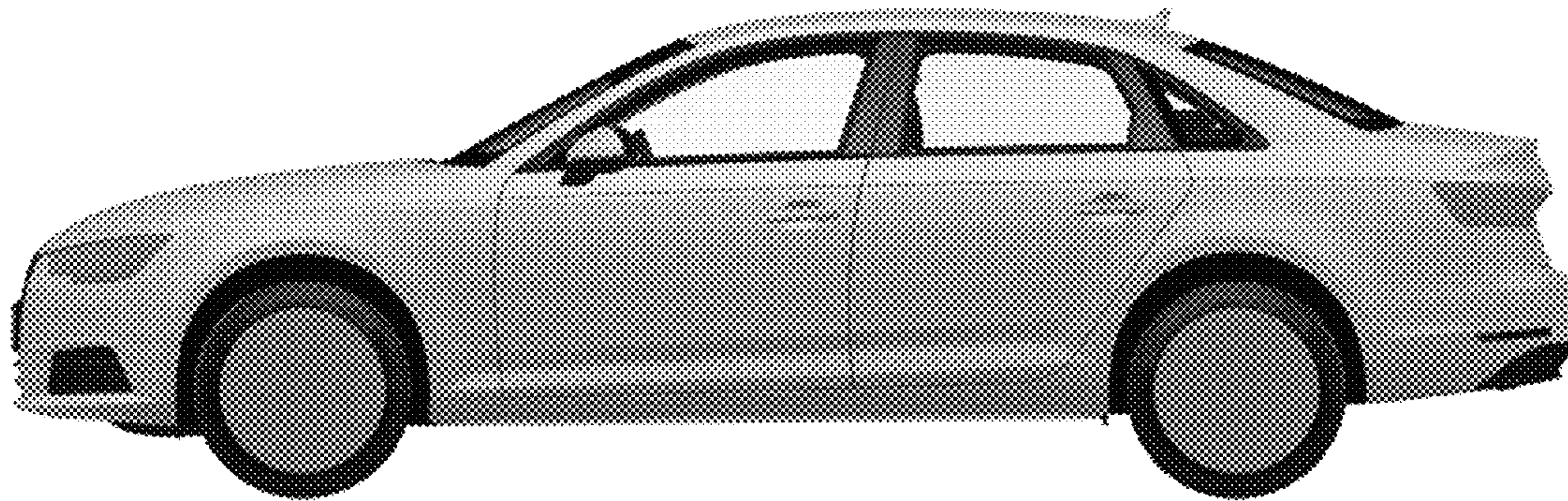

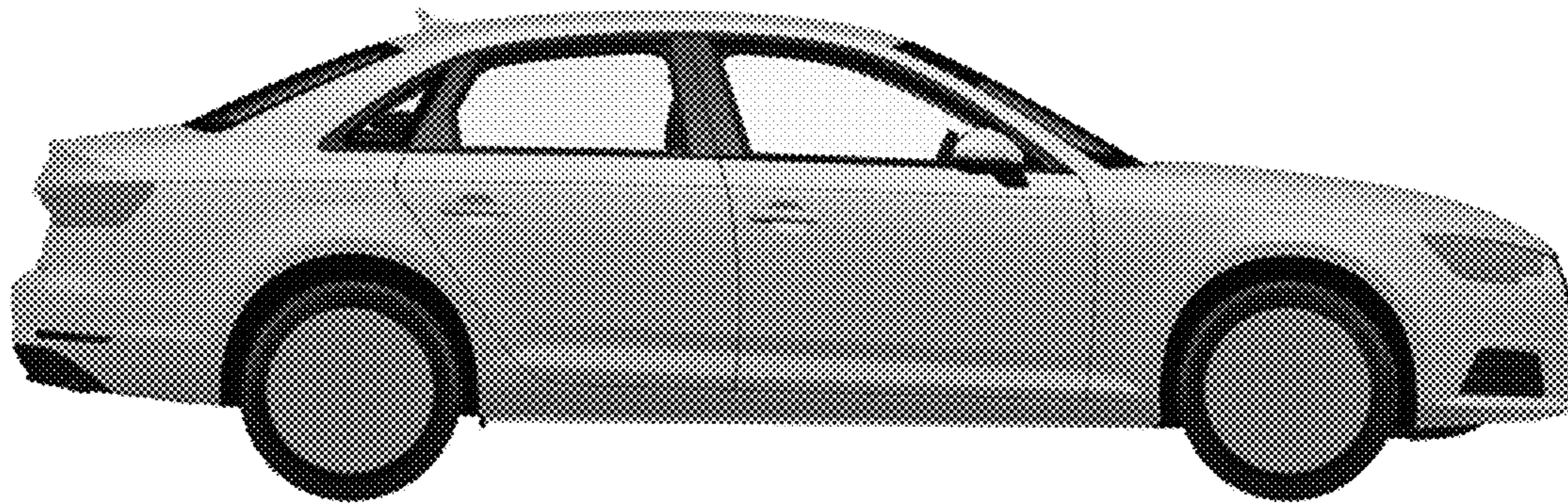

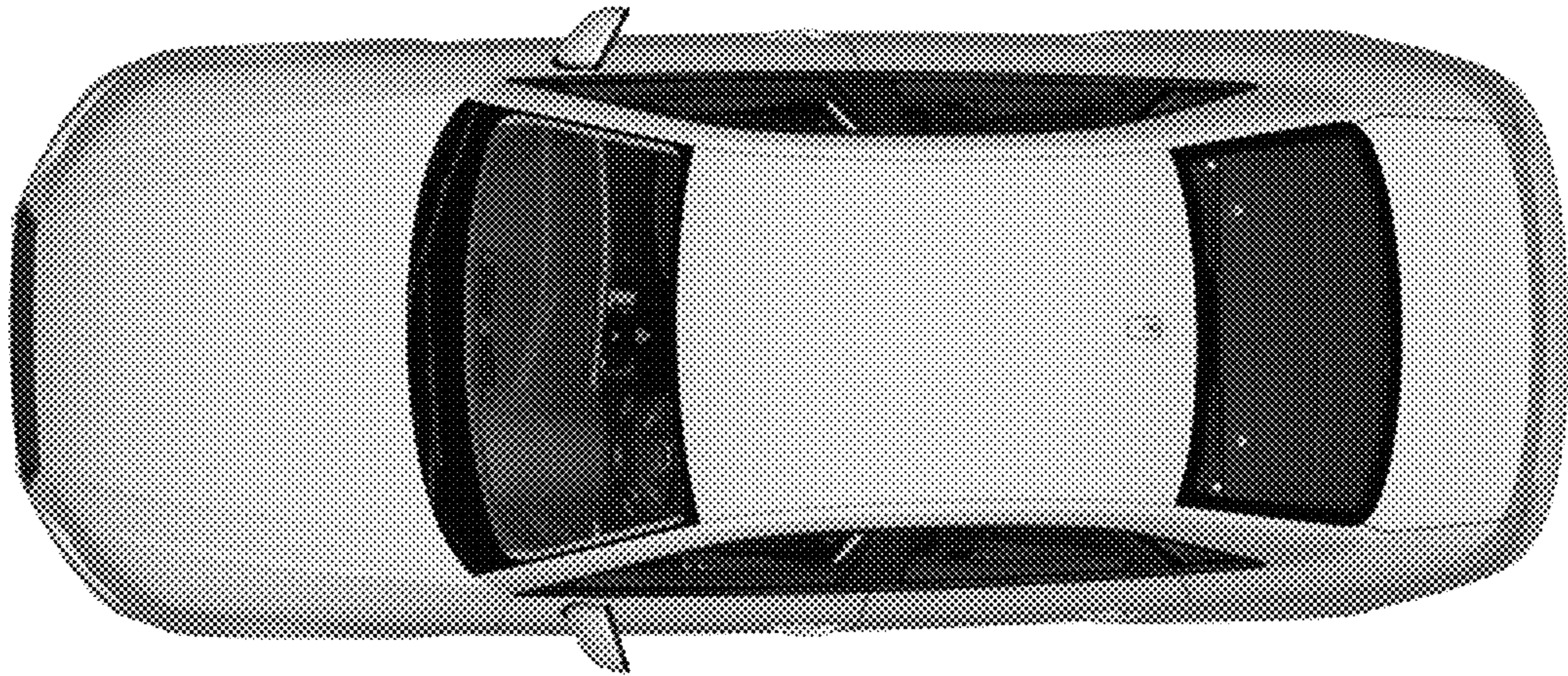
