**DESCRIPTION**

FIG. 1 is a right, front perspective view of a front end of a vehicle showing my new design;  
FIG. 2 is a left side perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof; and,  
FIG. 6 is a top plan view thereof.

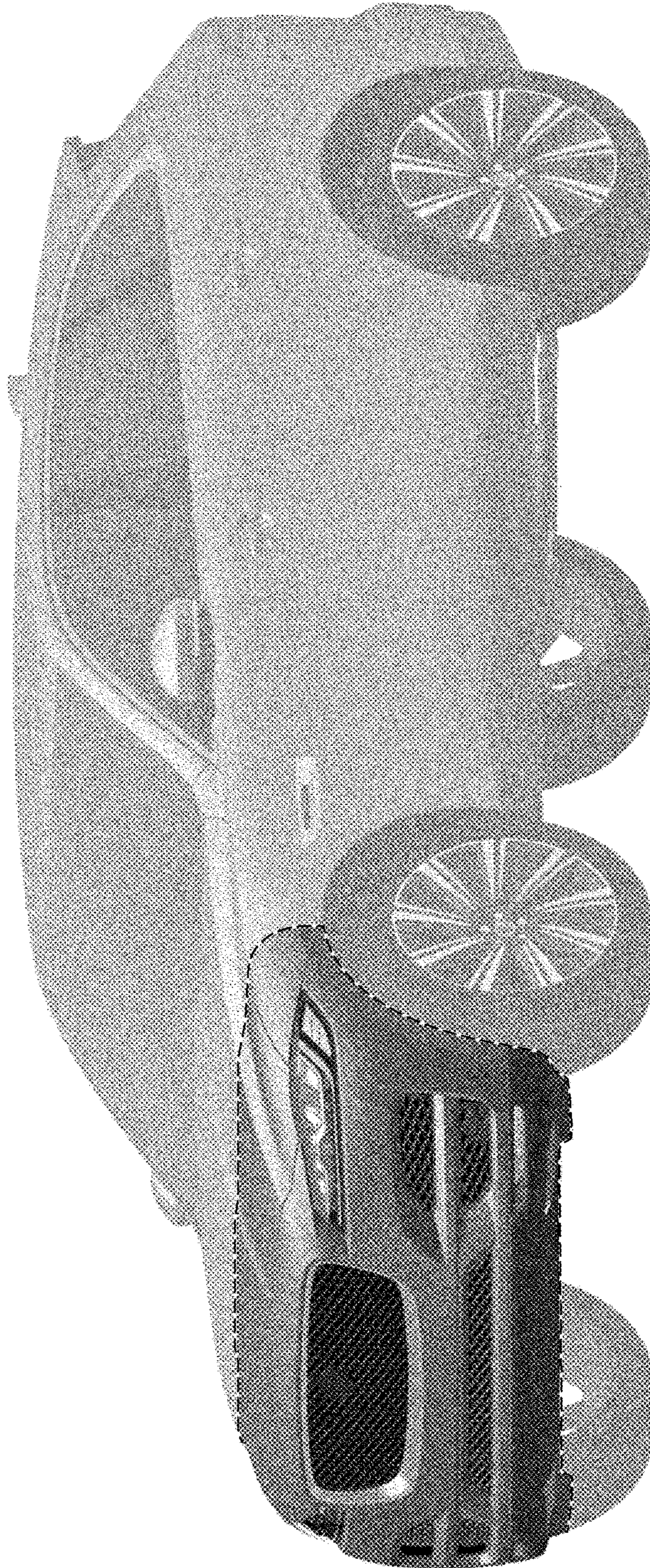

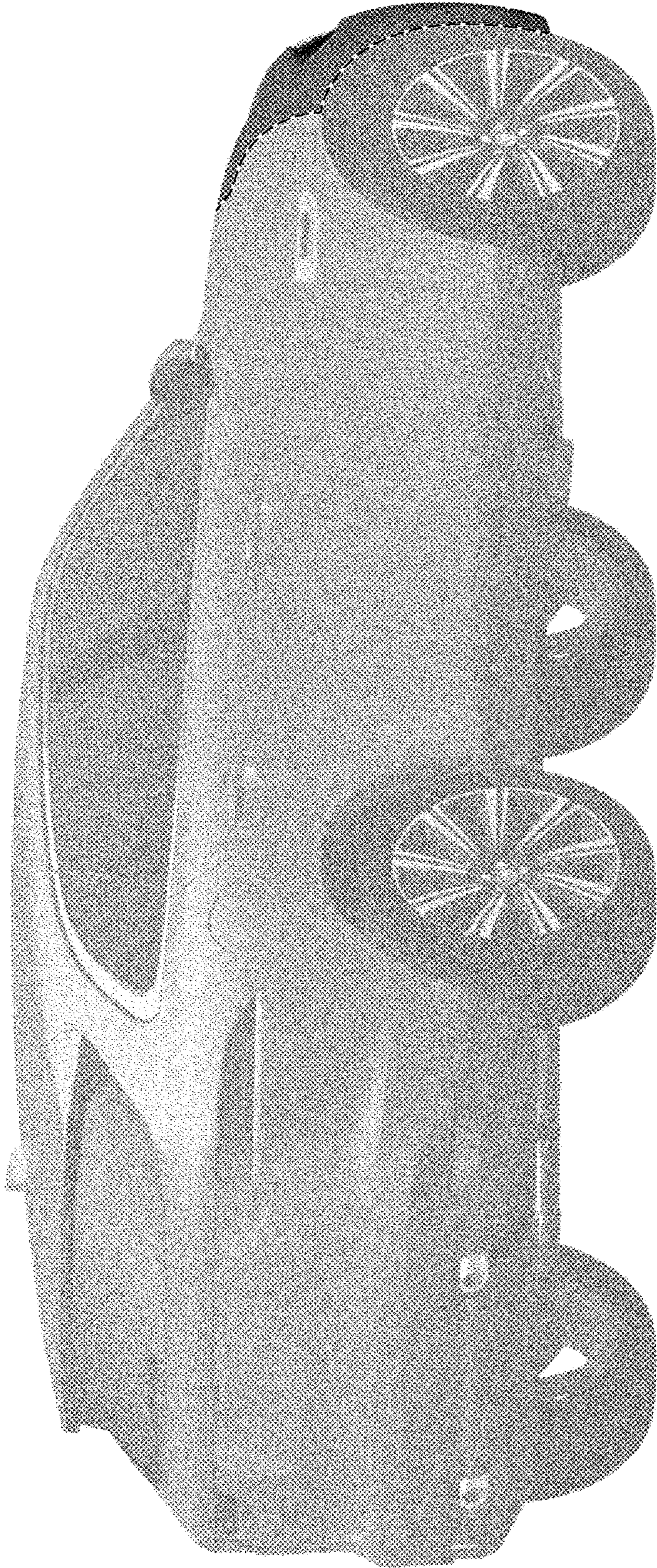

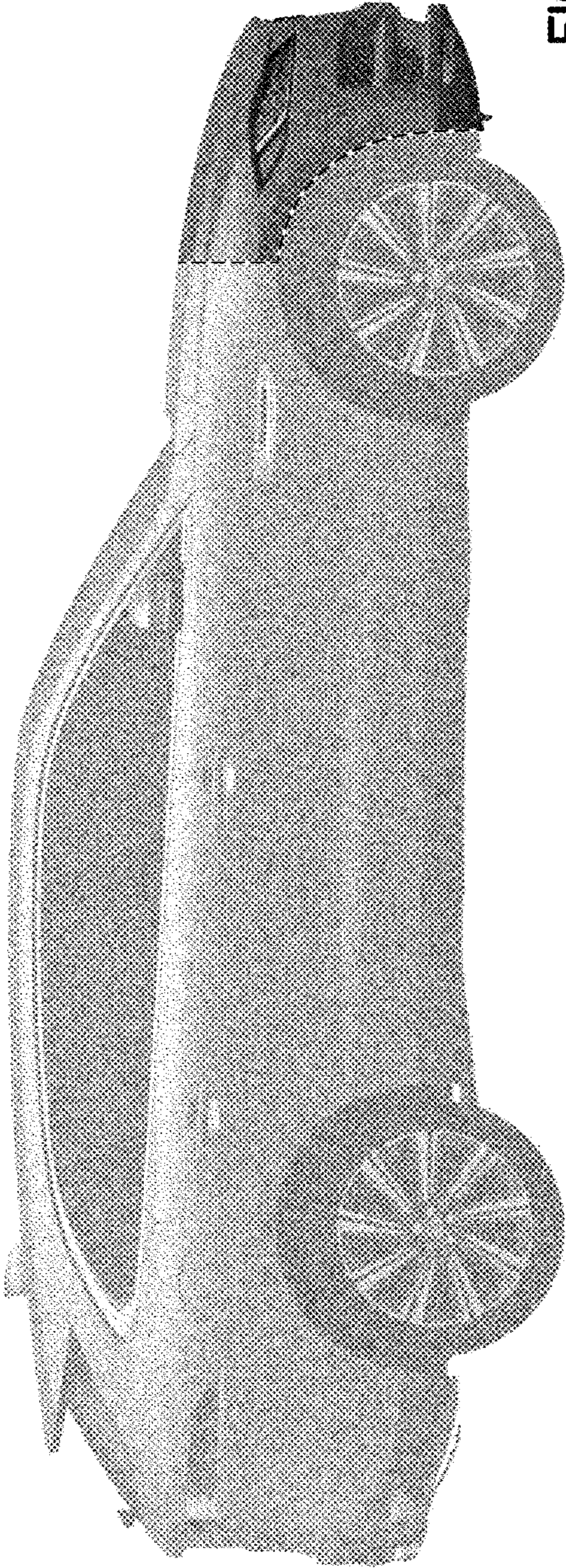

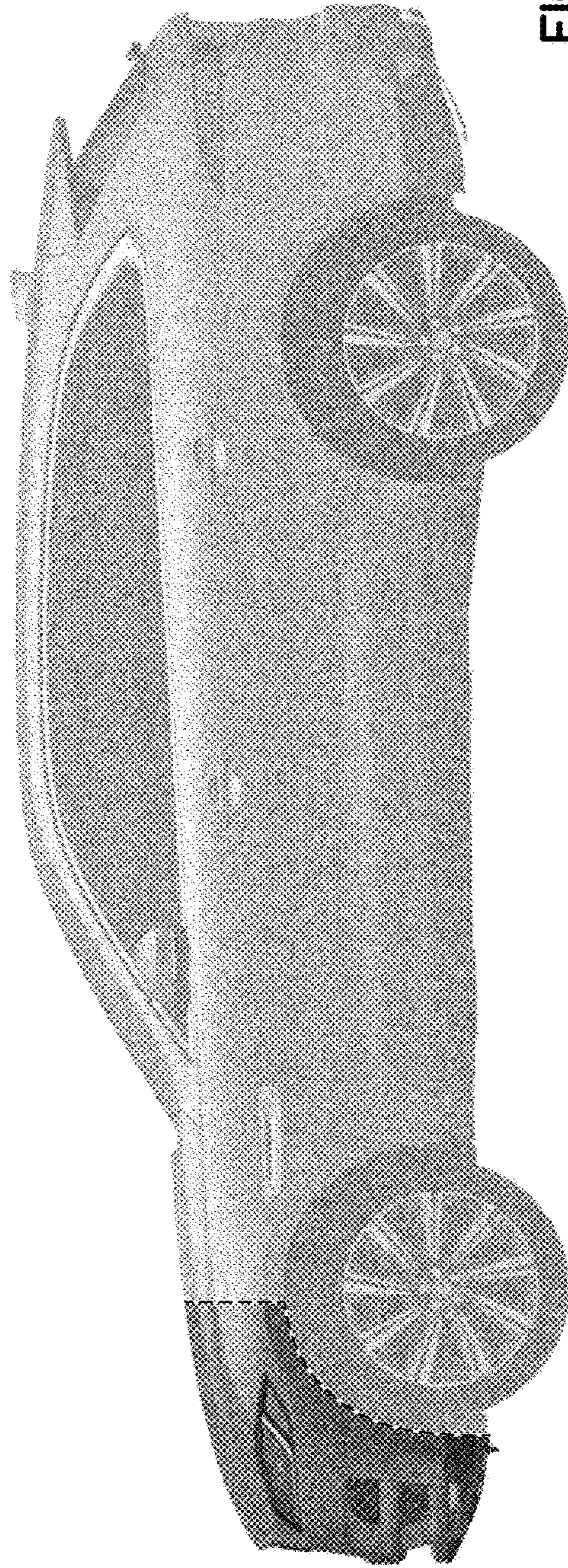

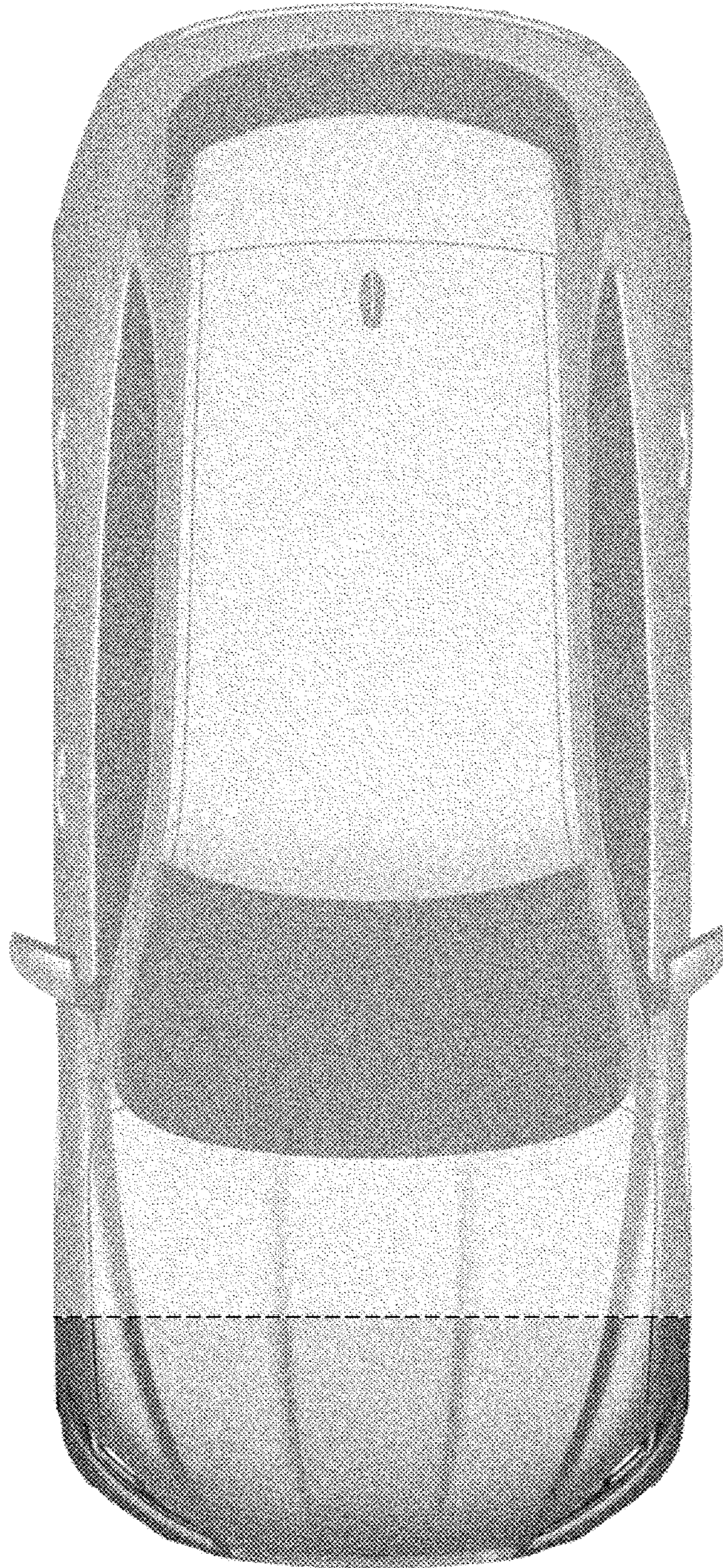
