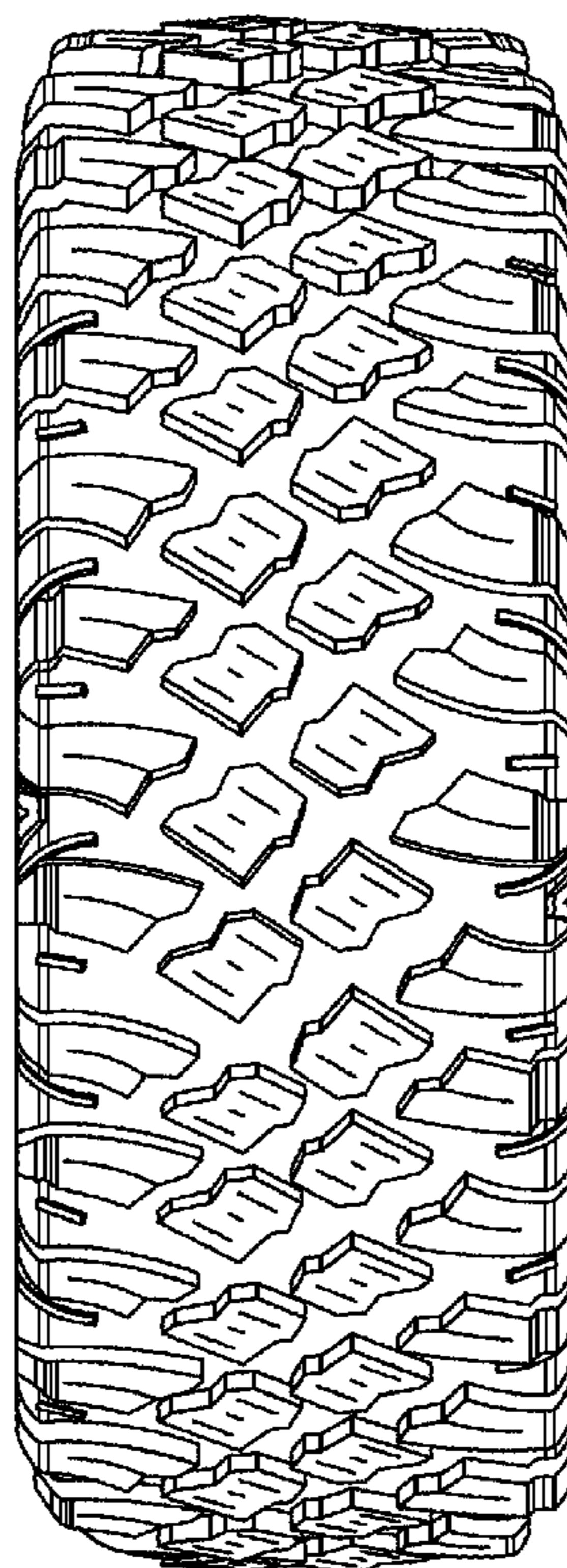
(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tire tread showing my new design, it being understood that the tread pattern is repeated throughout the circumference of the tire tread.
FIG. 2 is a perspective view of the tire tread, thereof; and, FIG. 3 is a side view of the tire tread, thereof.

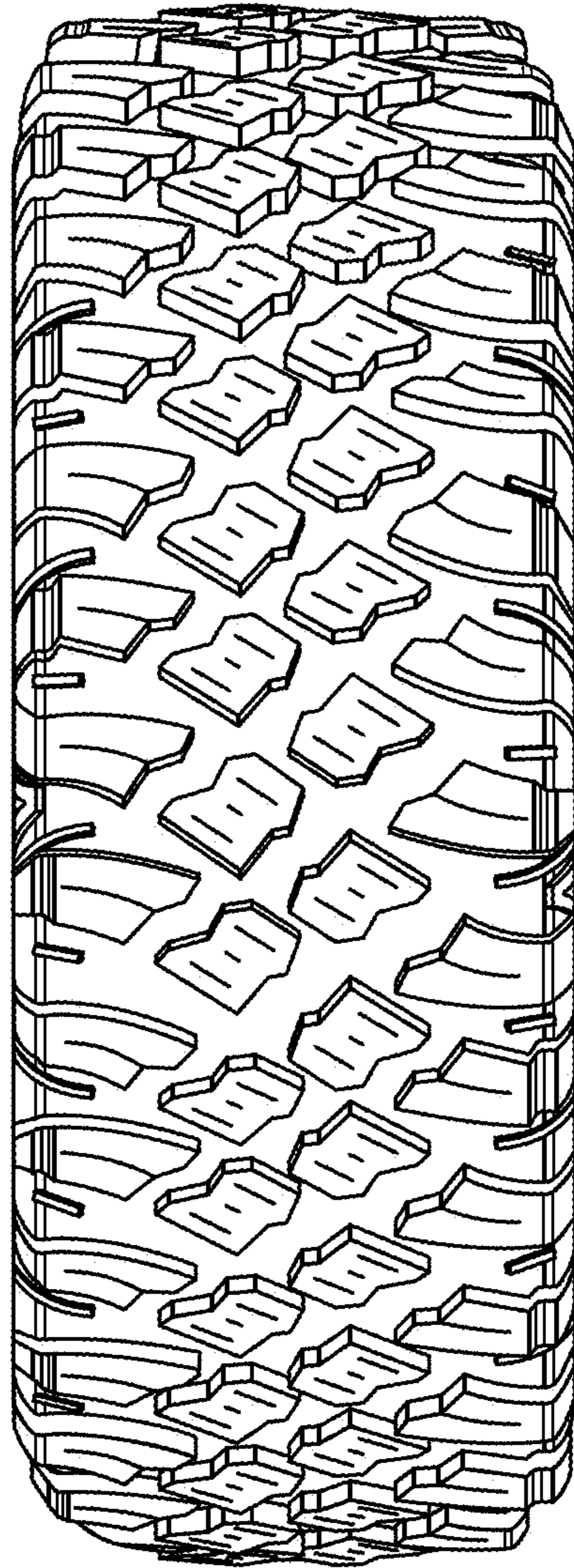

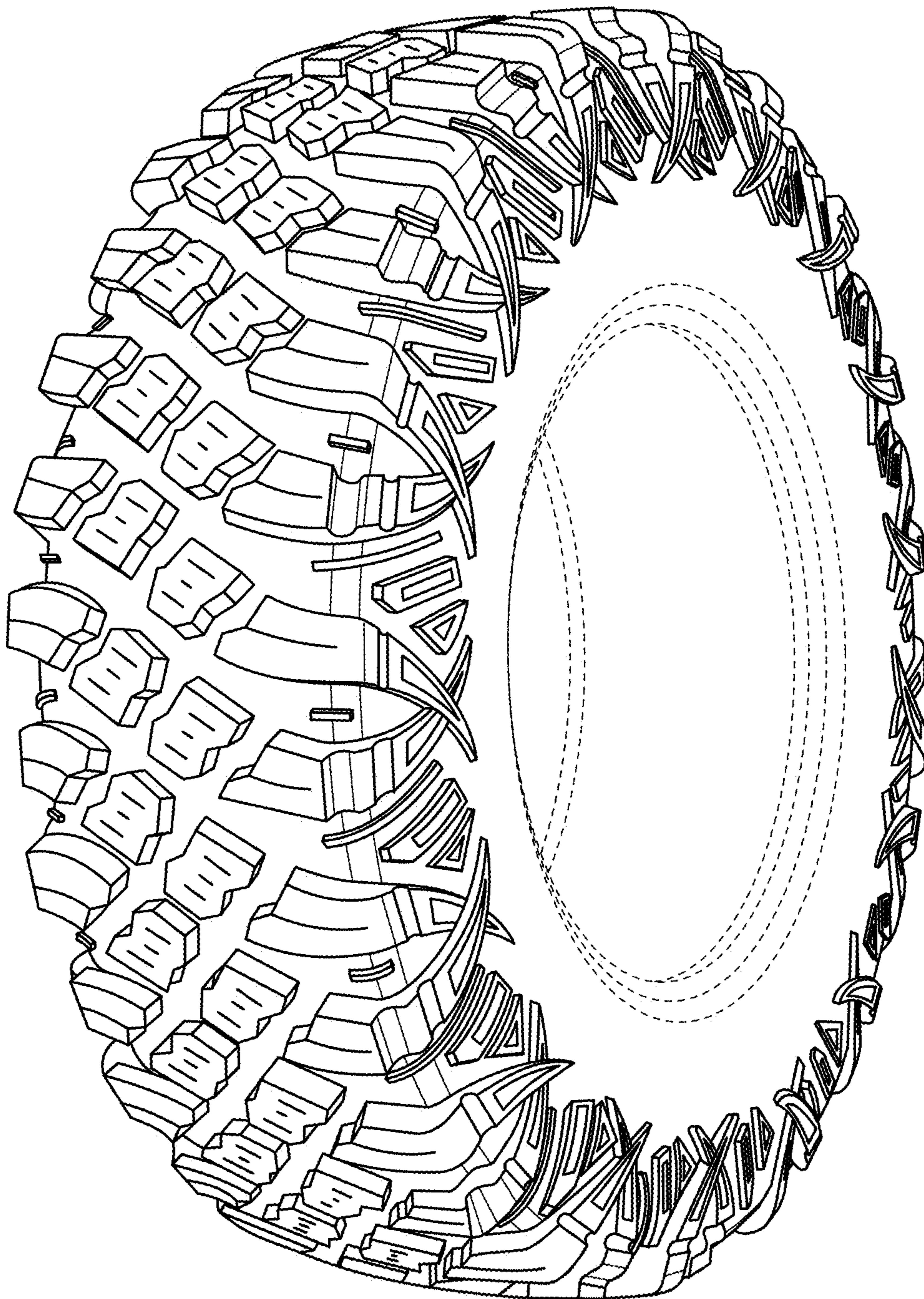

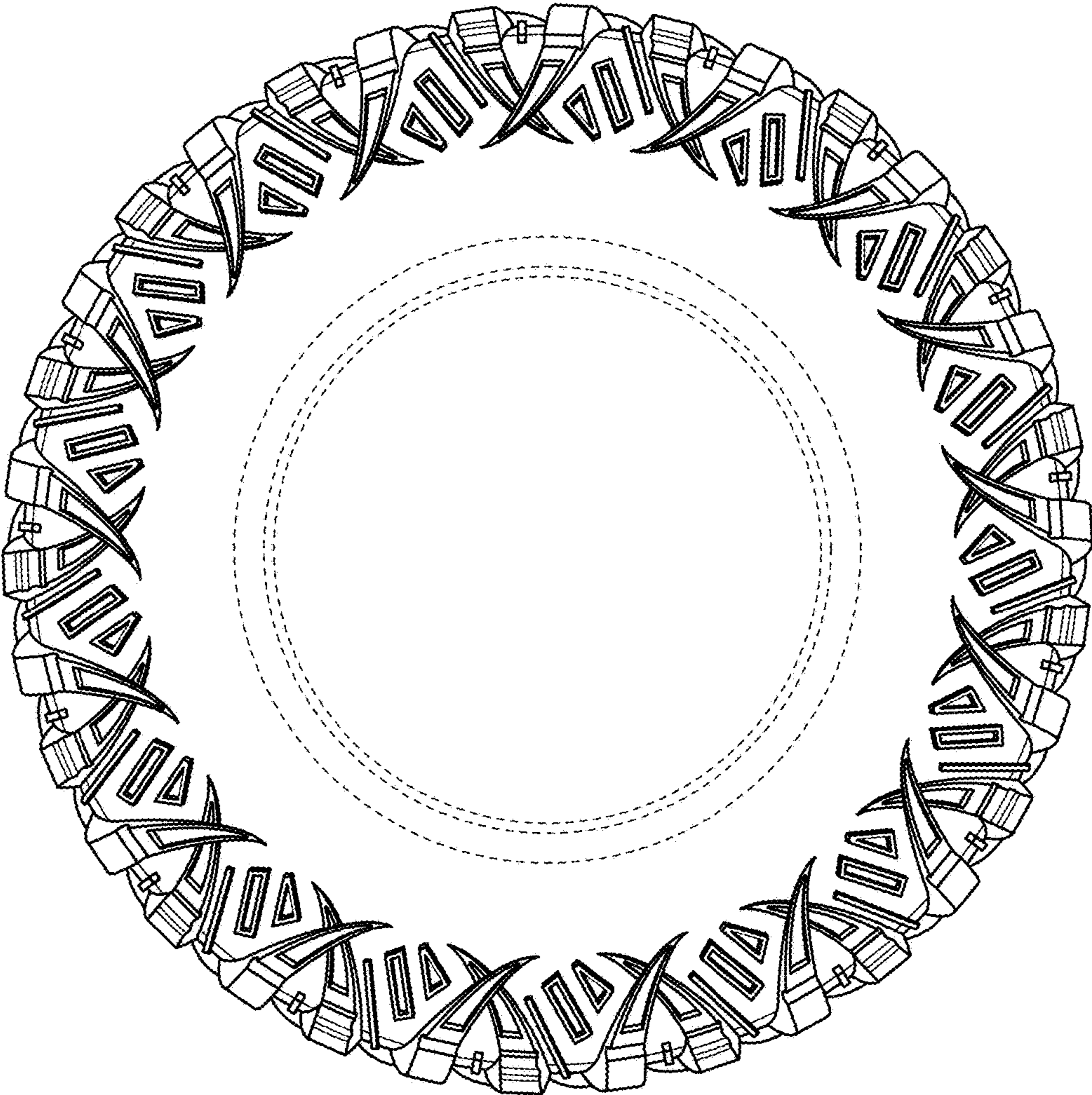
