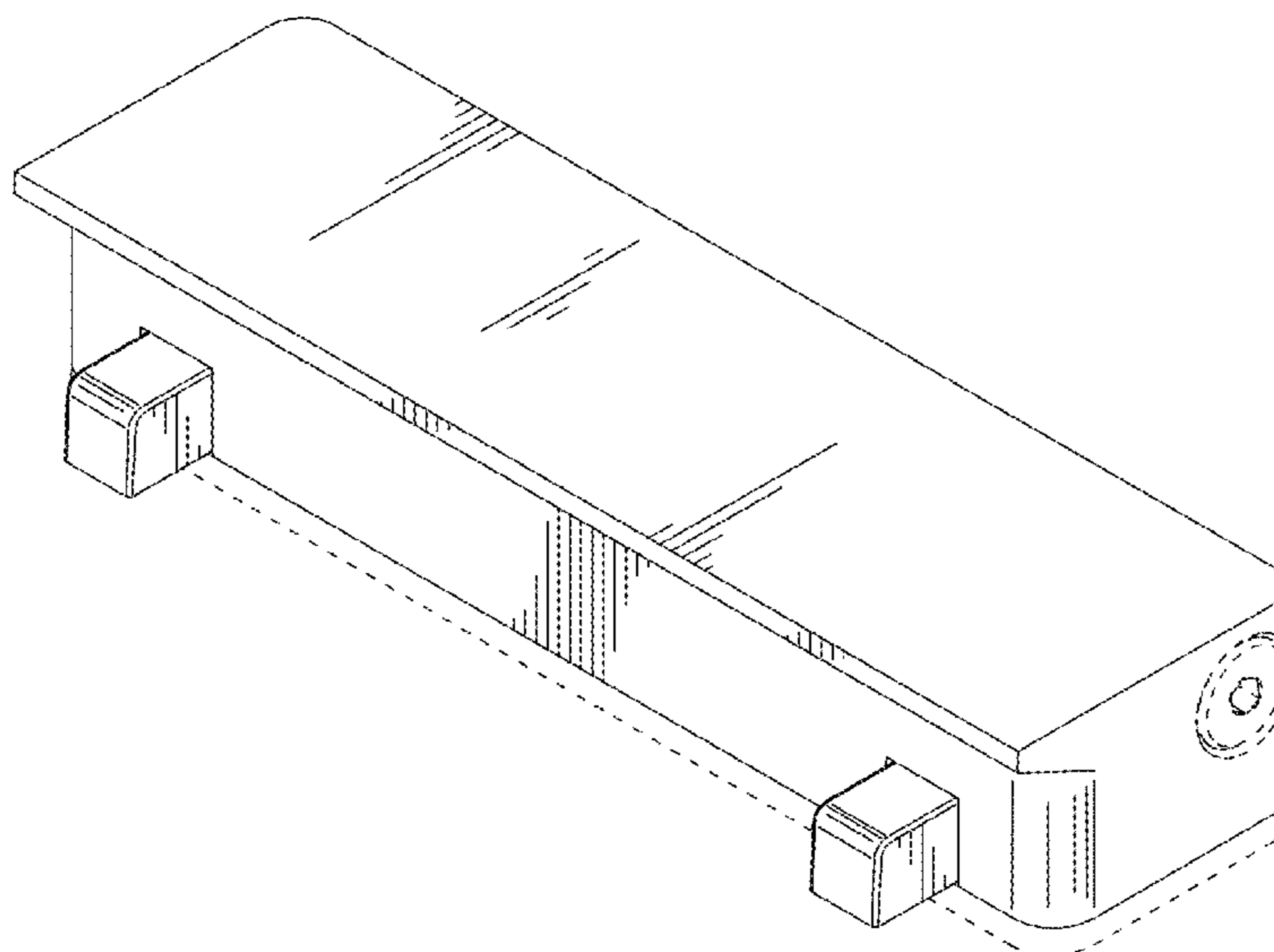
(57) **CLAIM**

The ornamental design for the actuator module for an electric strike assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of an actuator module for an electric strike assembly of our new design; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a back view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a left side view thereof with the right side view being a mirror image thereof. 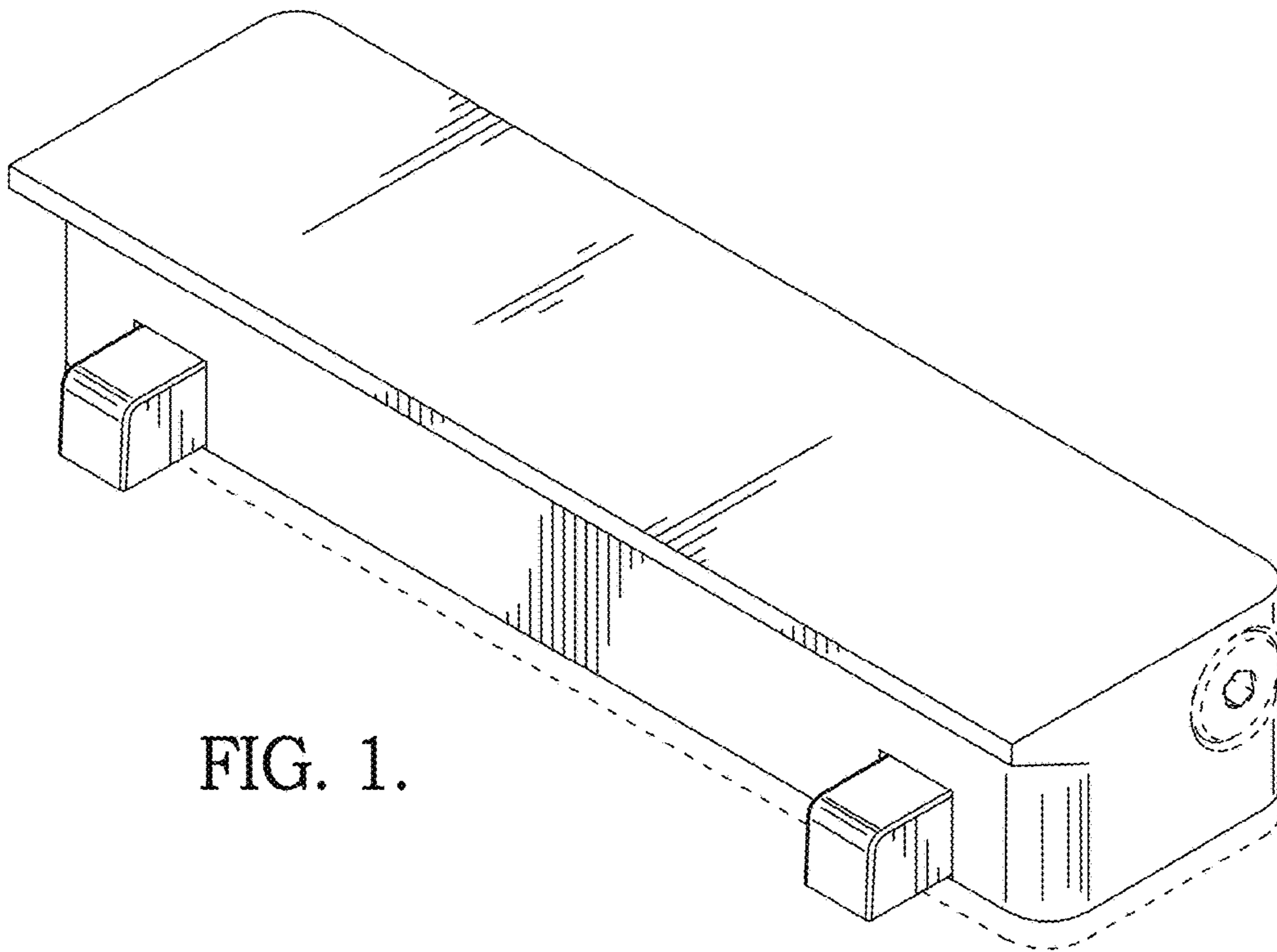

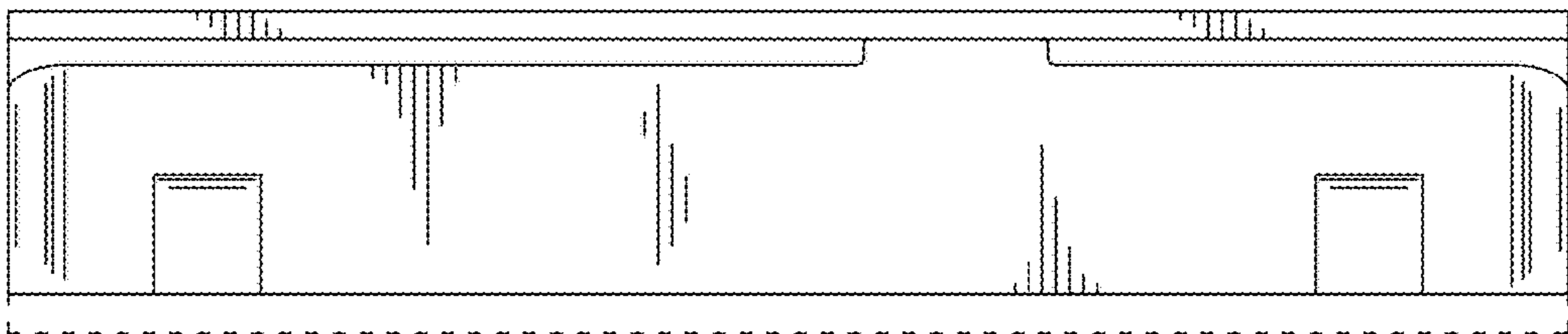

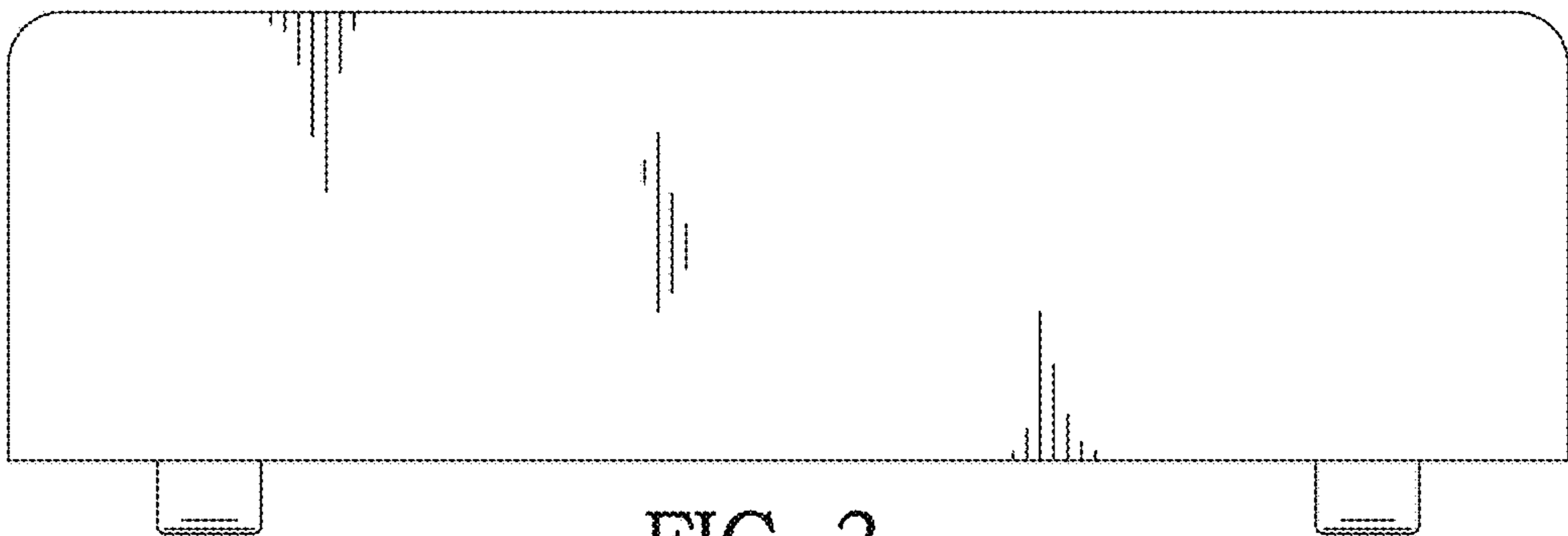

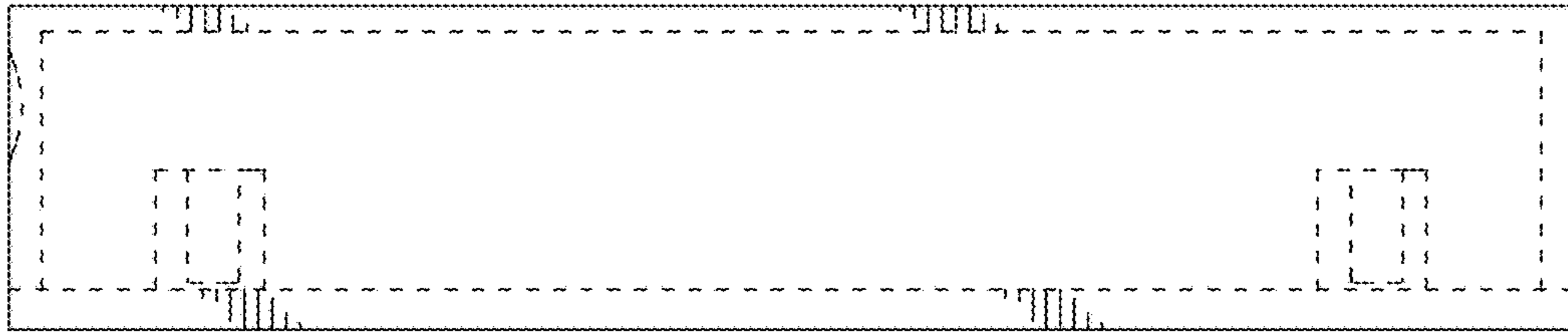

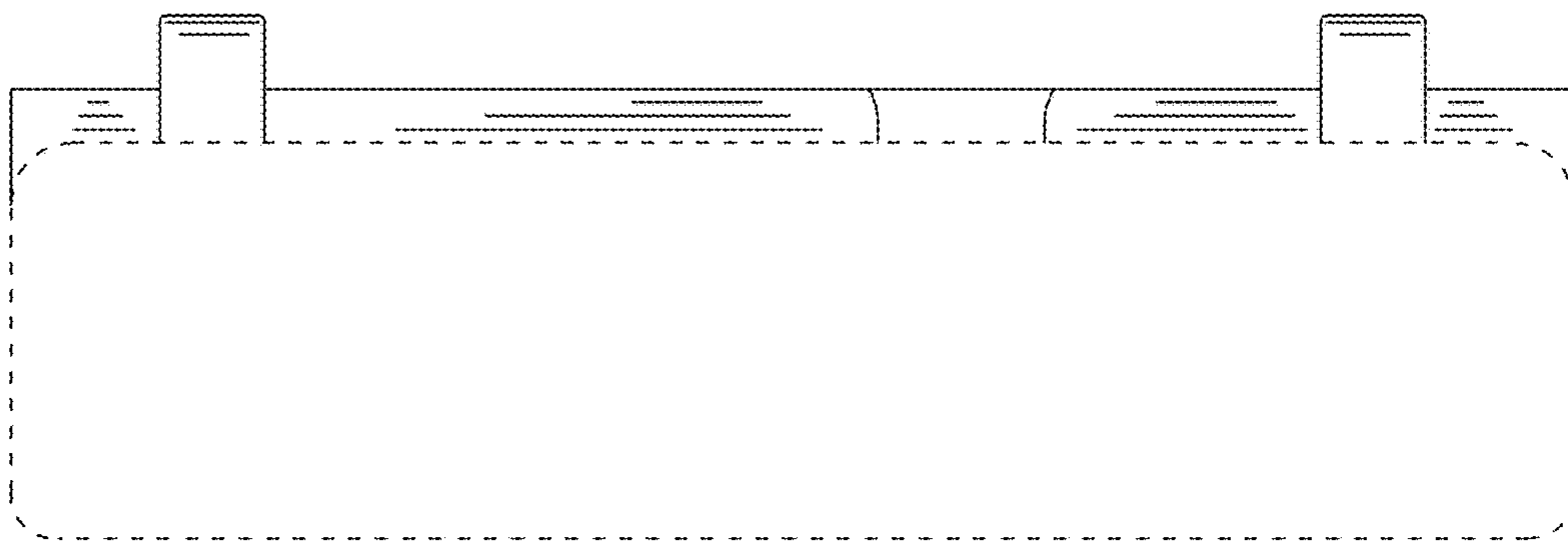

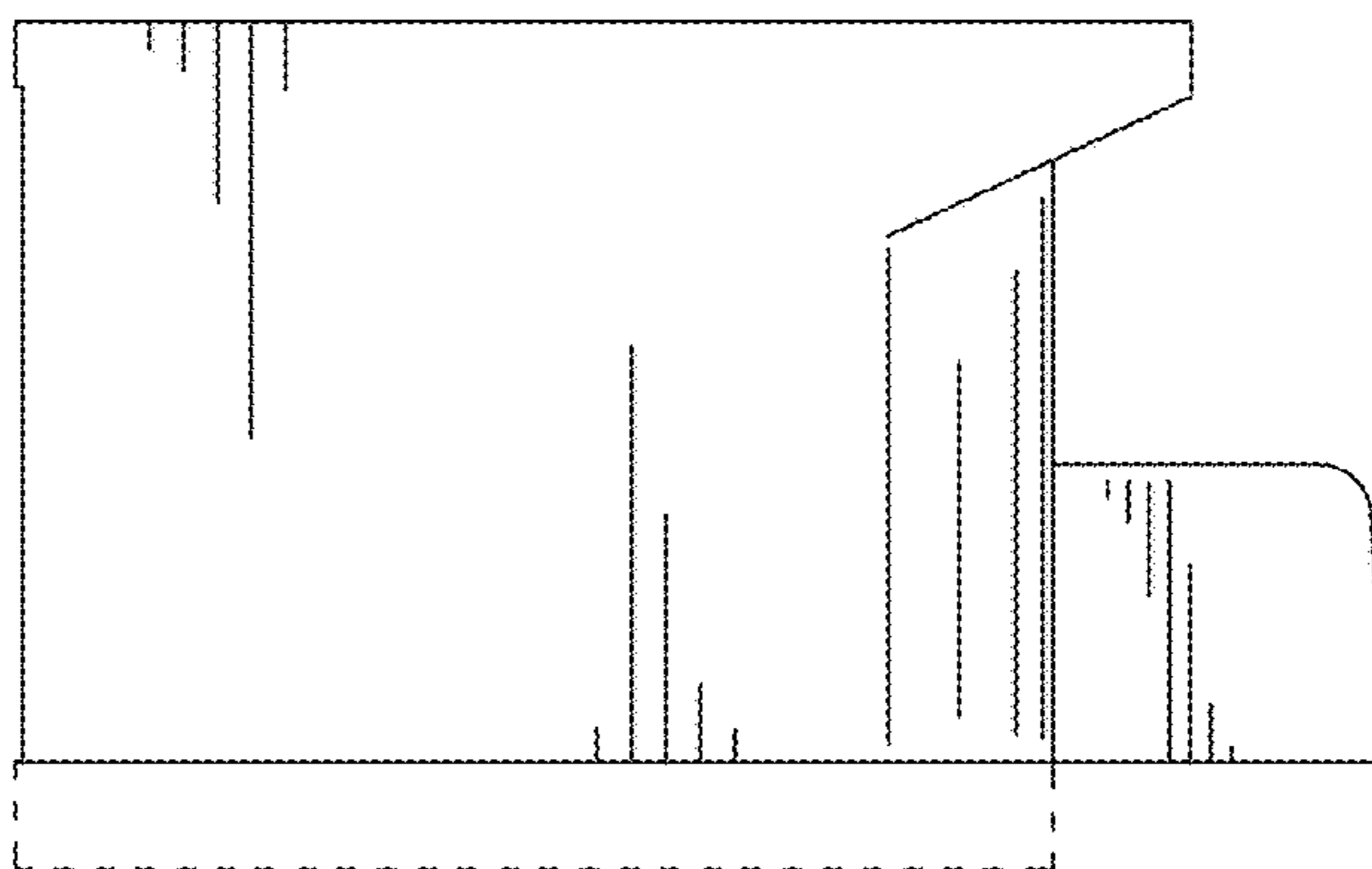
