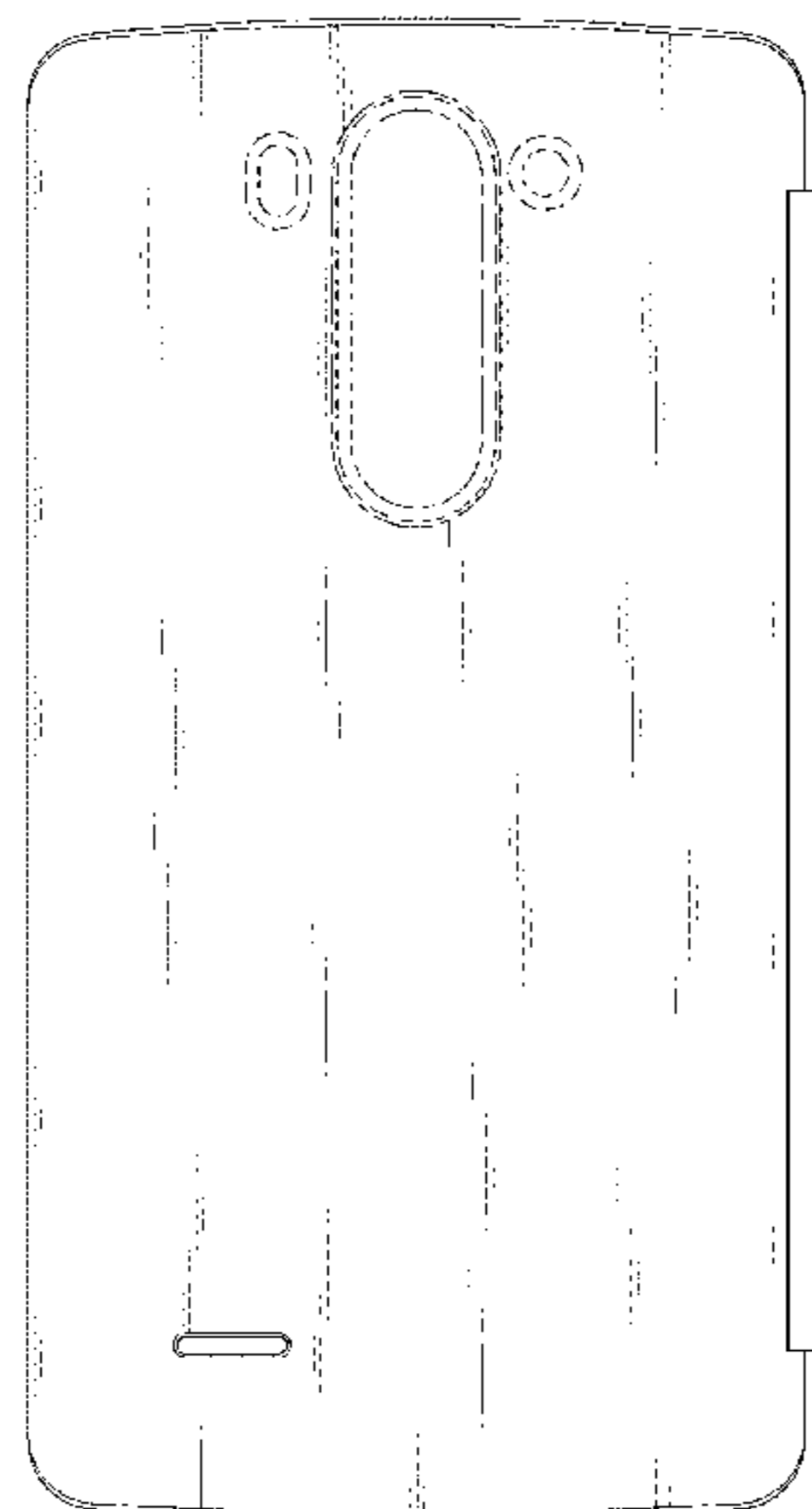
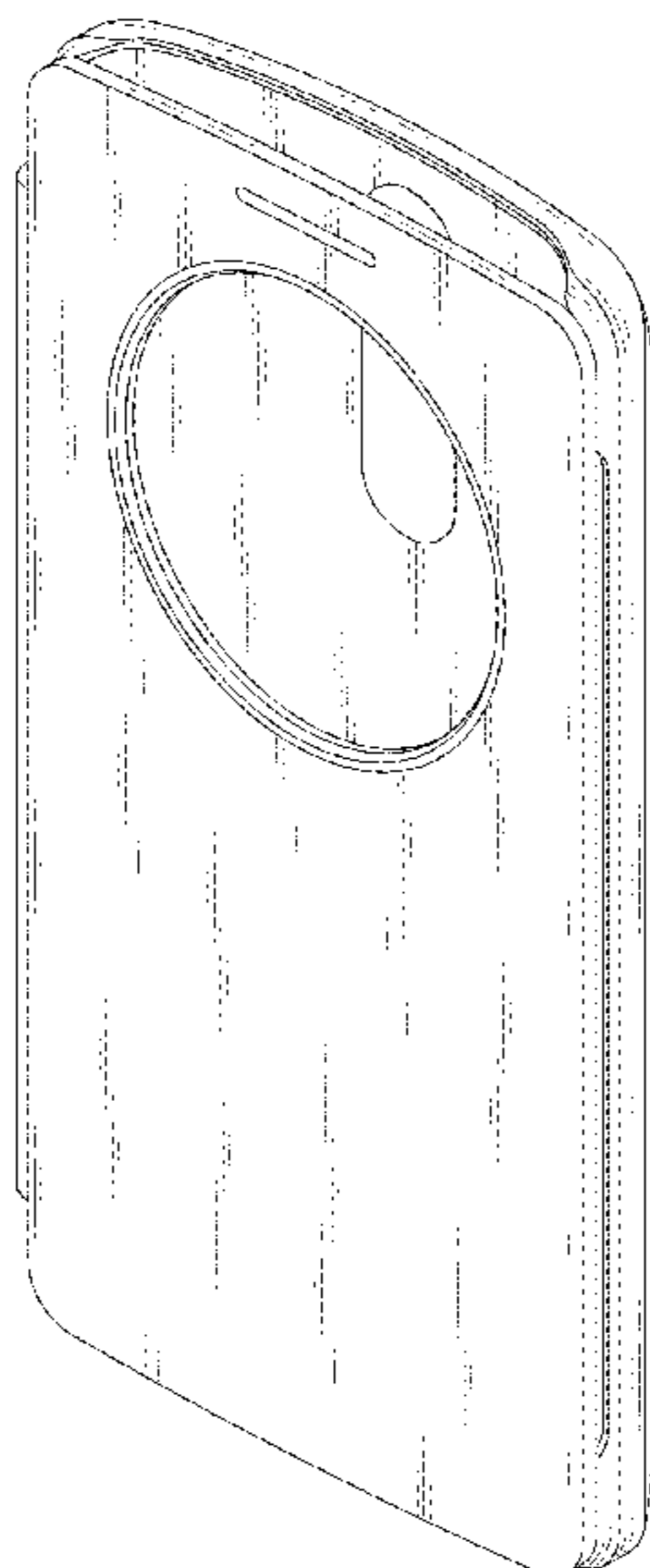
I claim the ornamental design for a case for mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for mobile phone showing my new design;

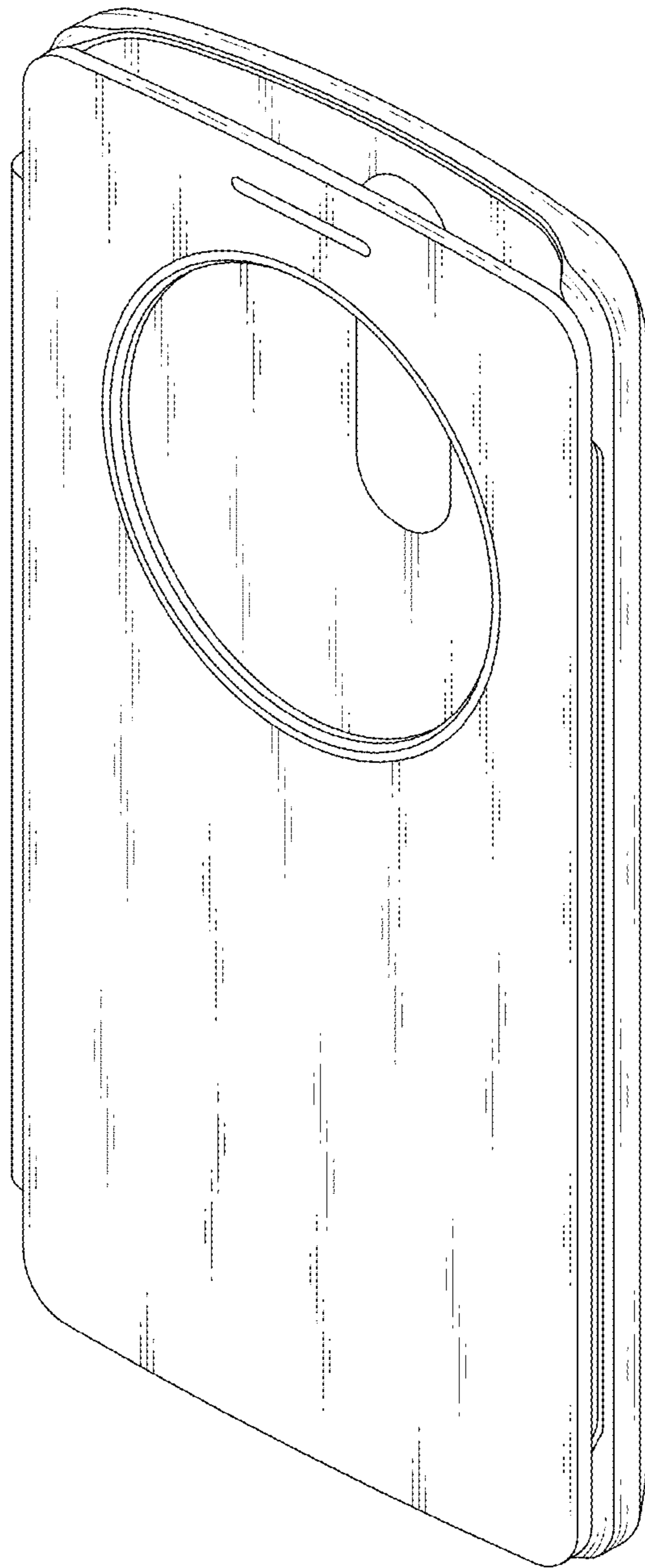

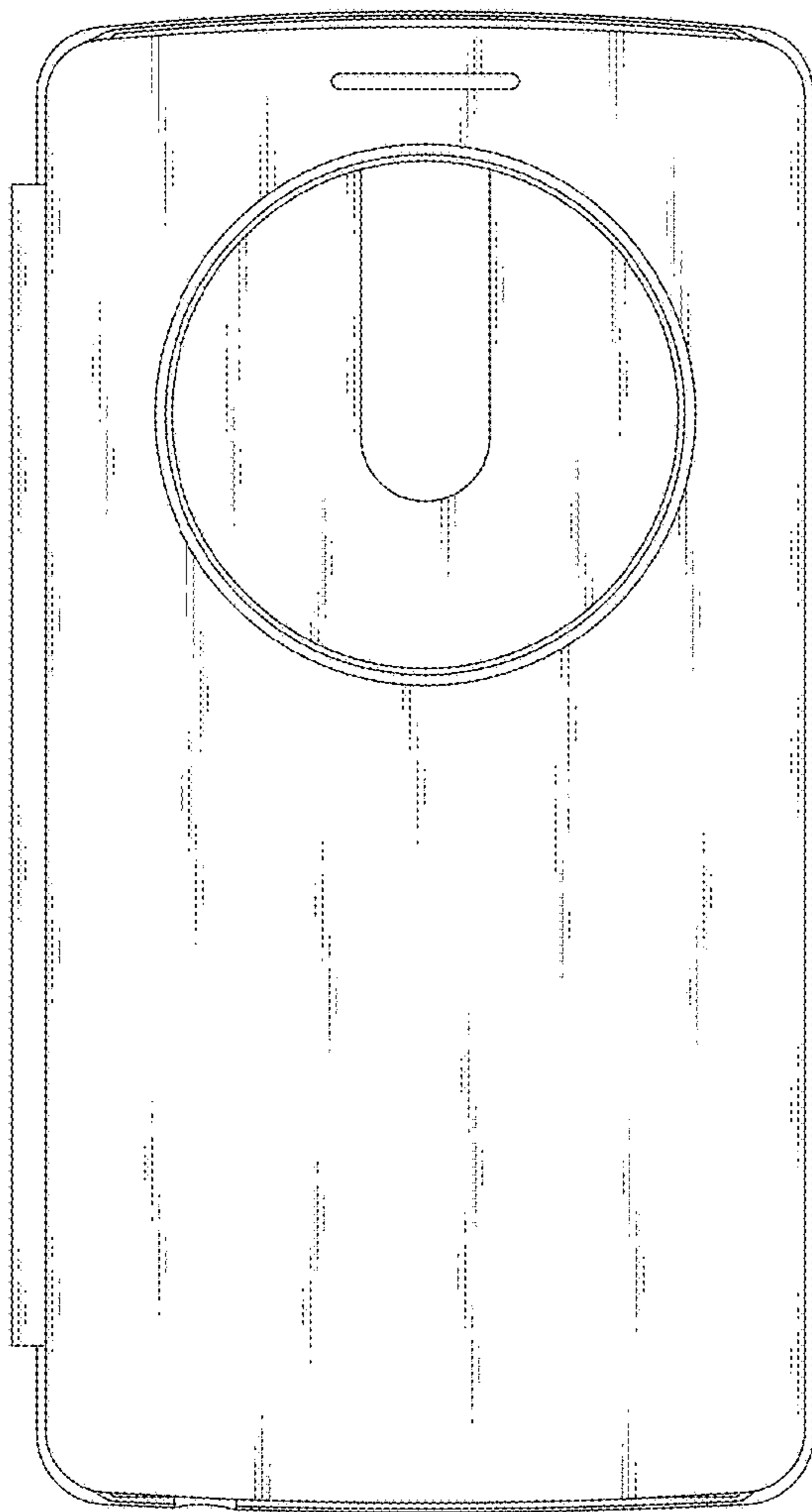

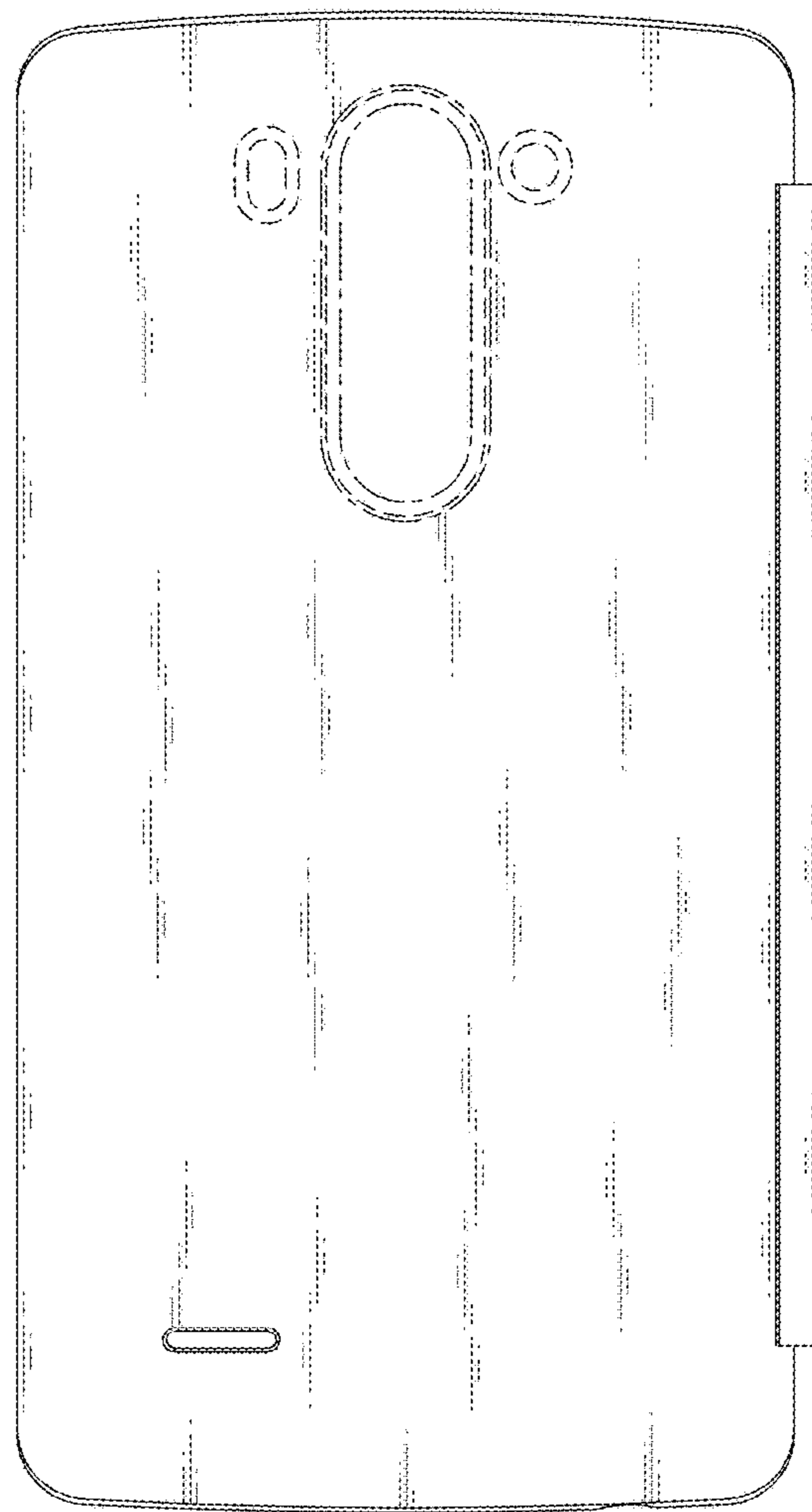

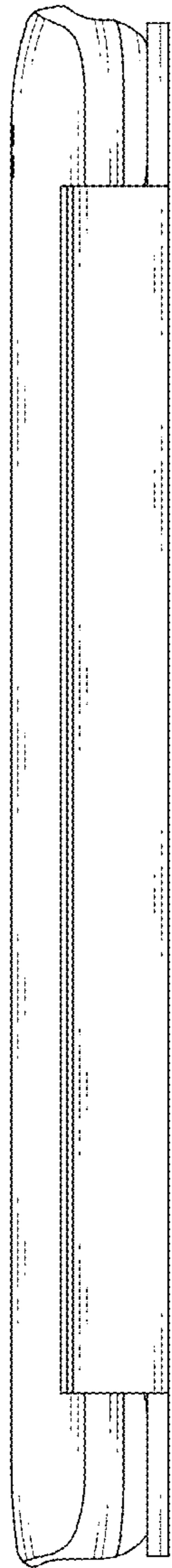

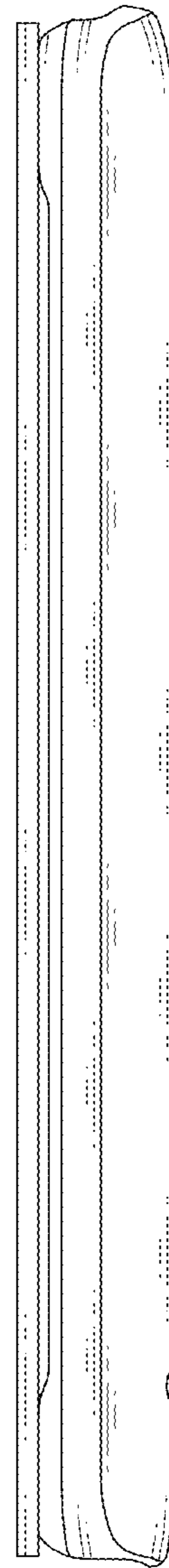

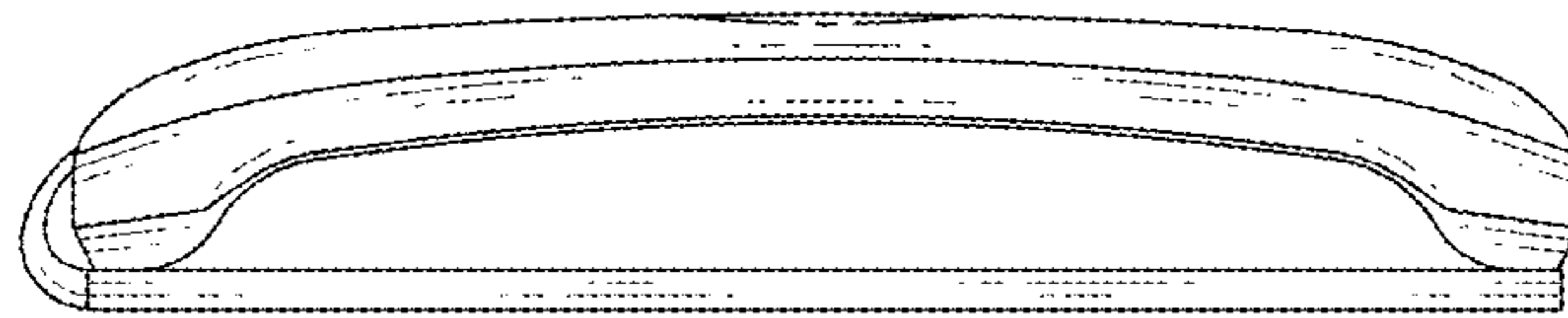
