**DESCRIPTION**

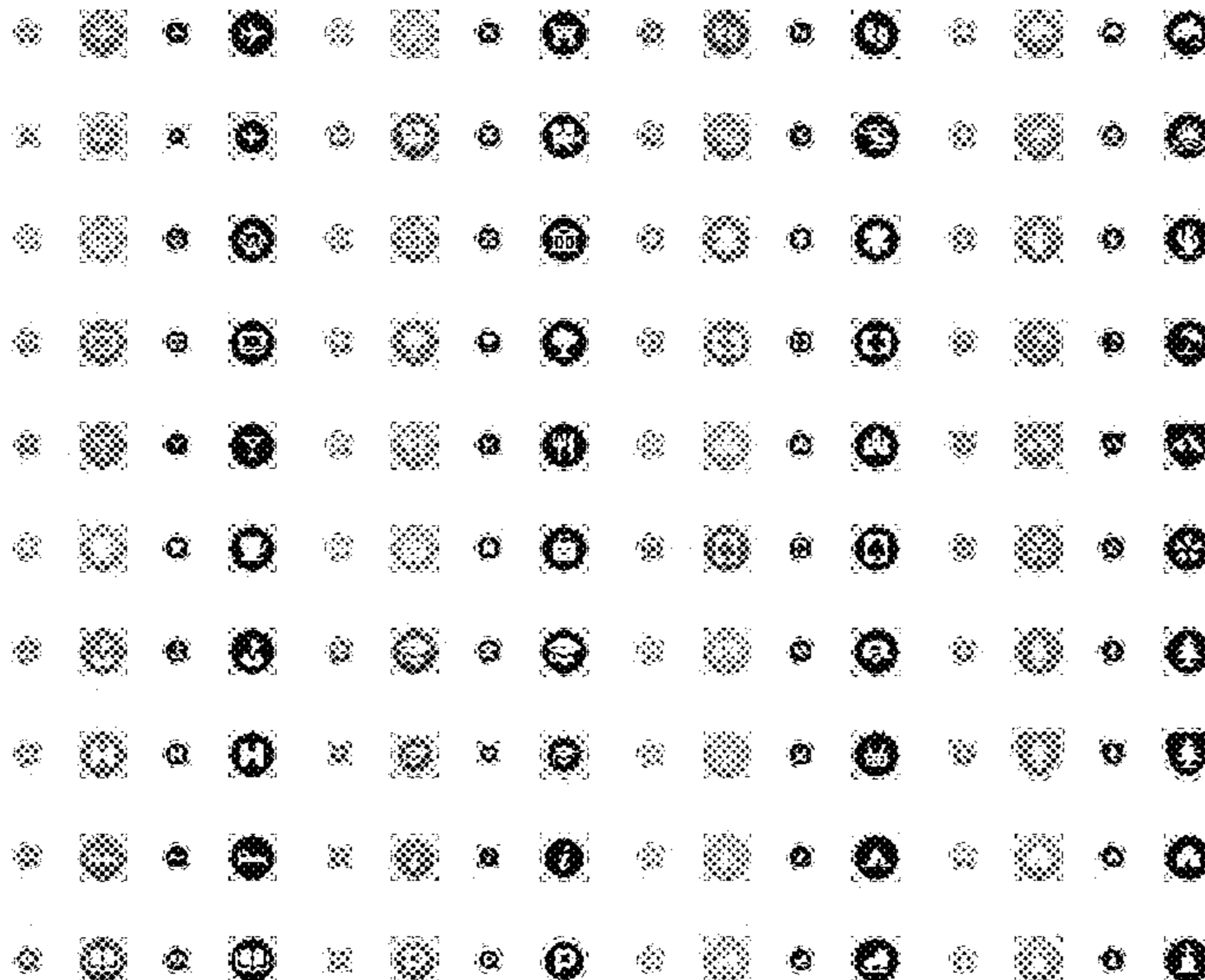
