FIG. 10 a first image in a sequence of a fourth embodiment of a display screen or portion thereof with animated graphical user interface showing our new design;

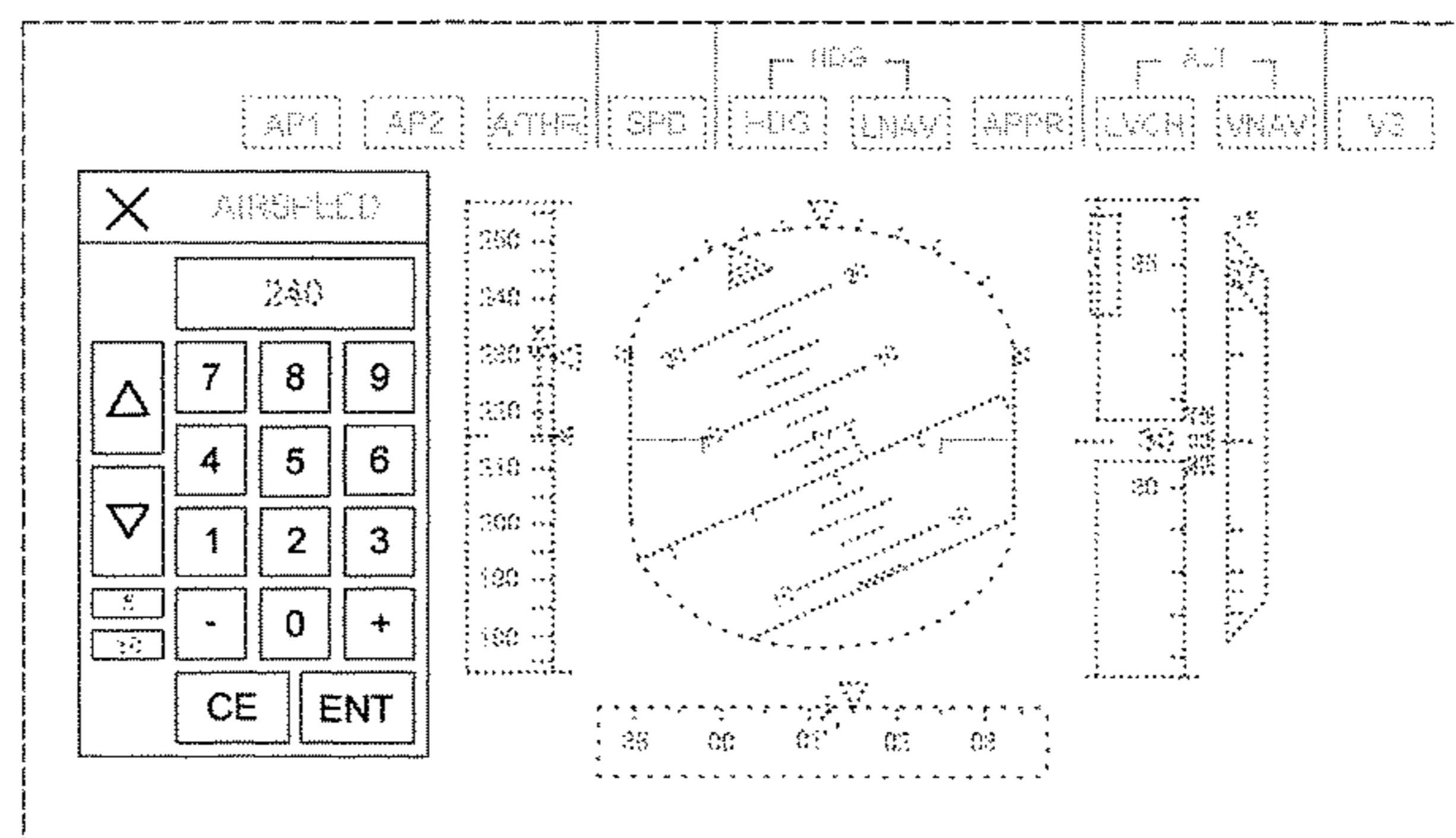
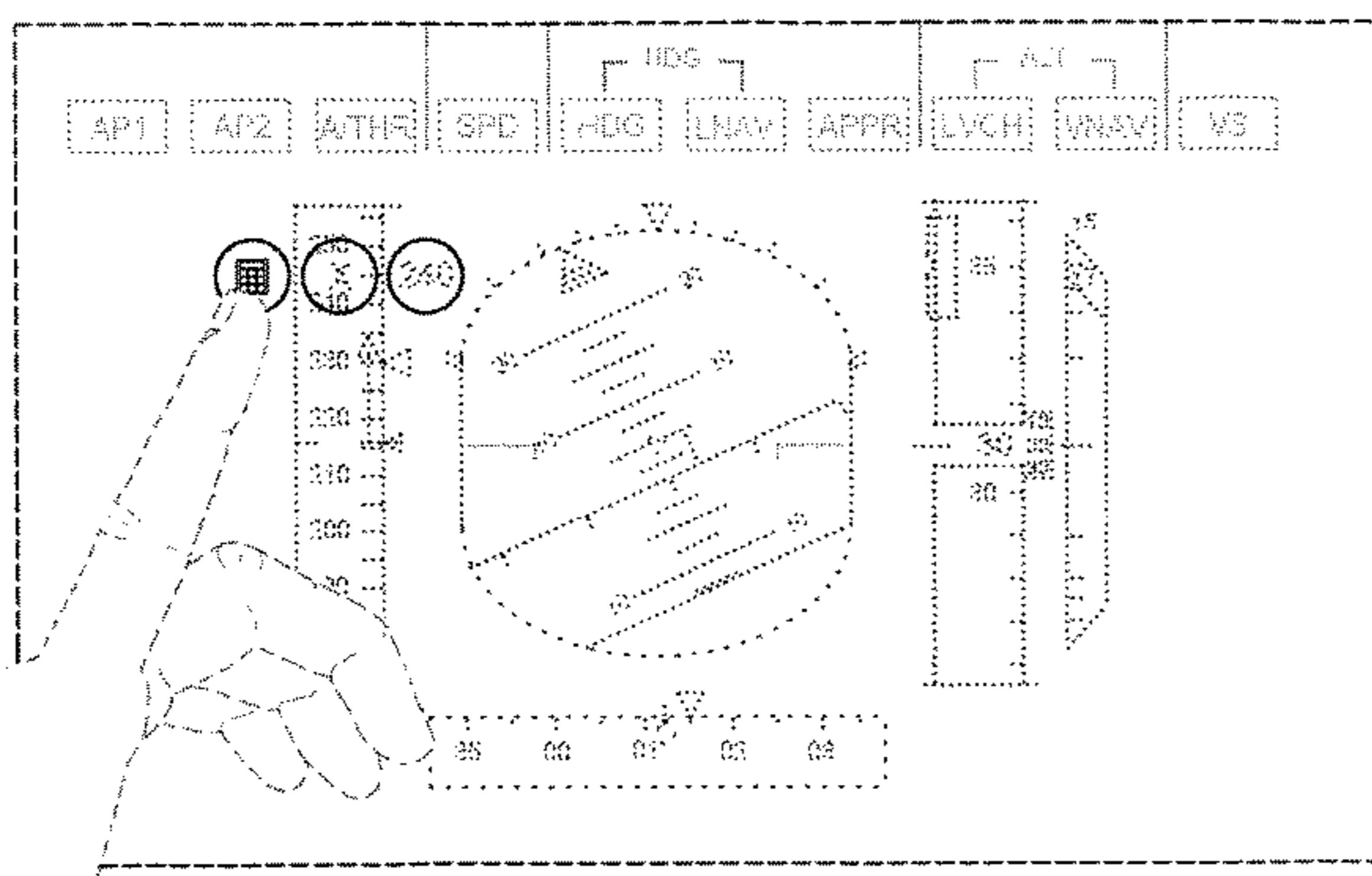
FIG. 11 is a second image thereof; and

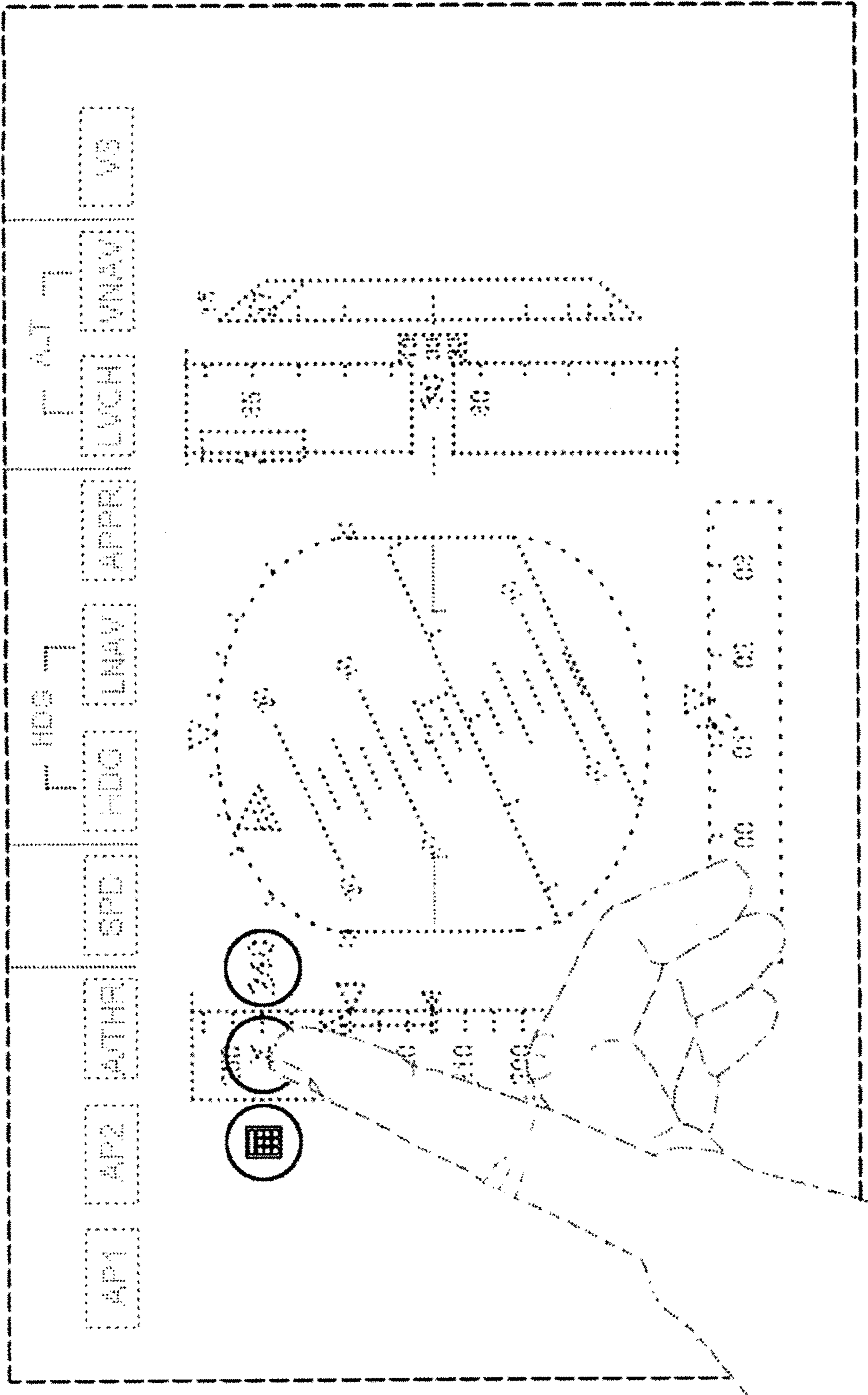

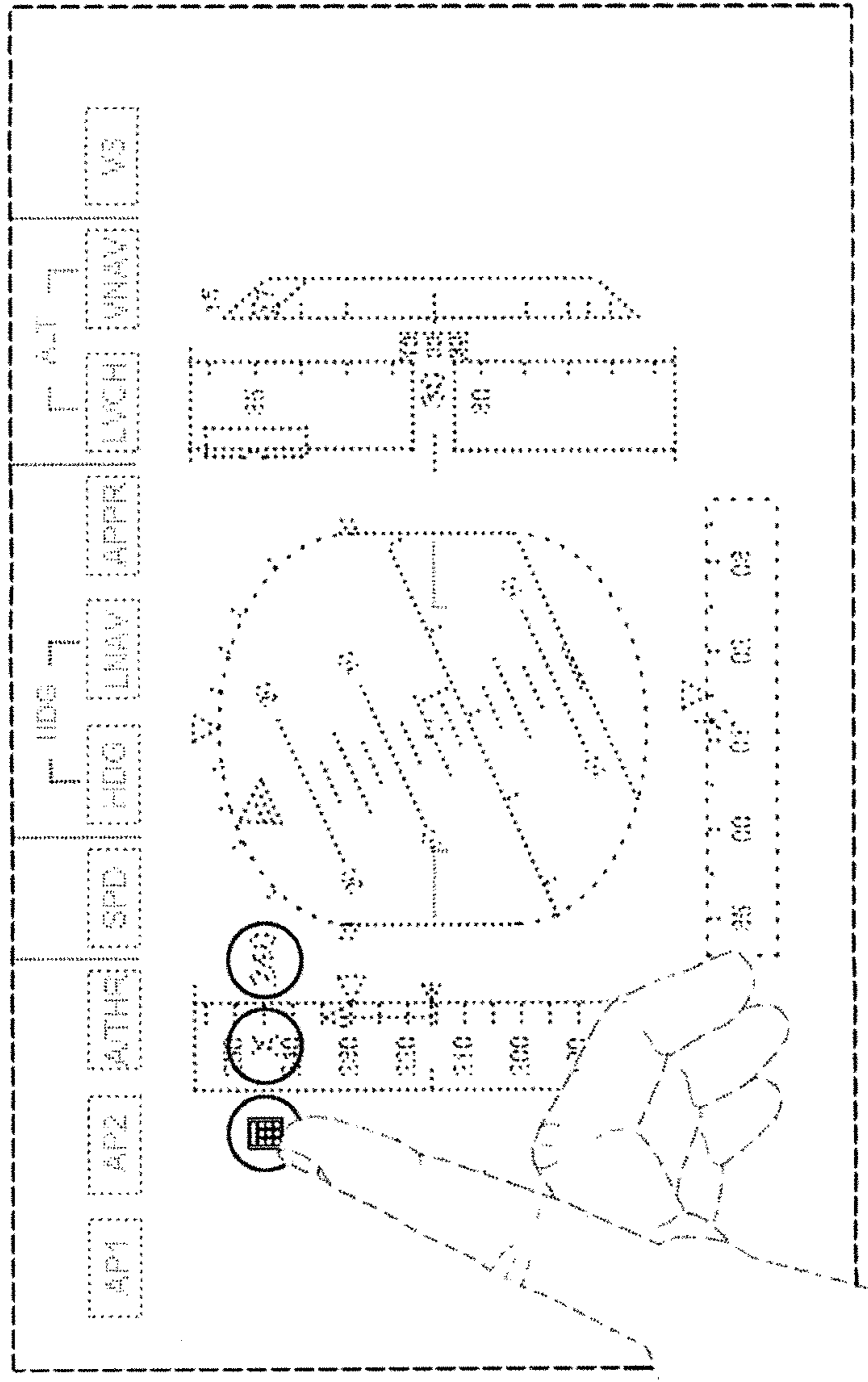

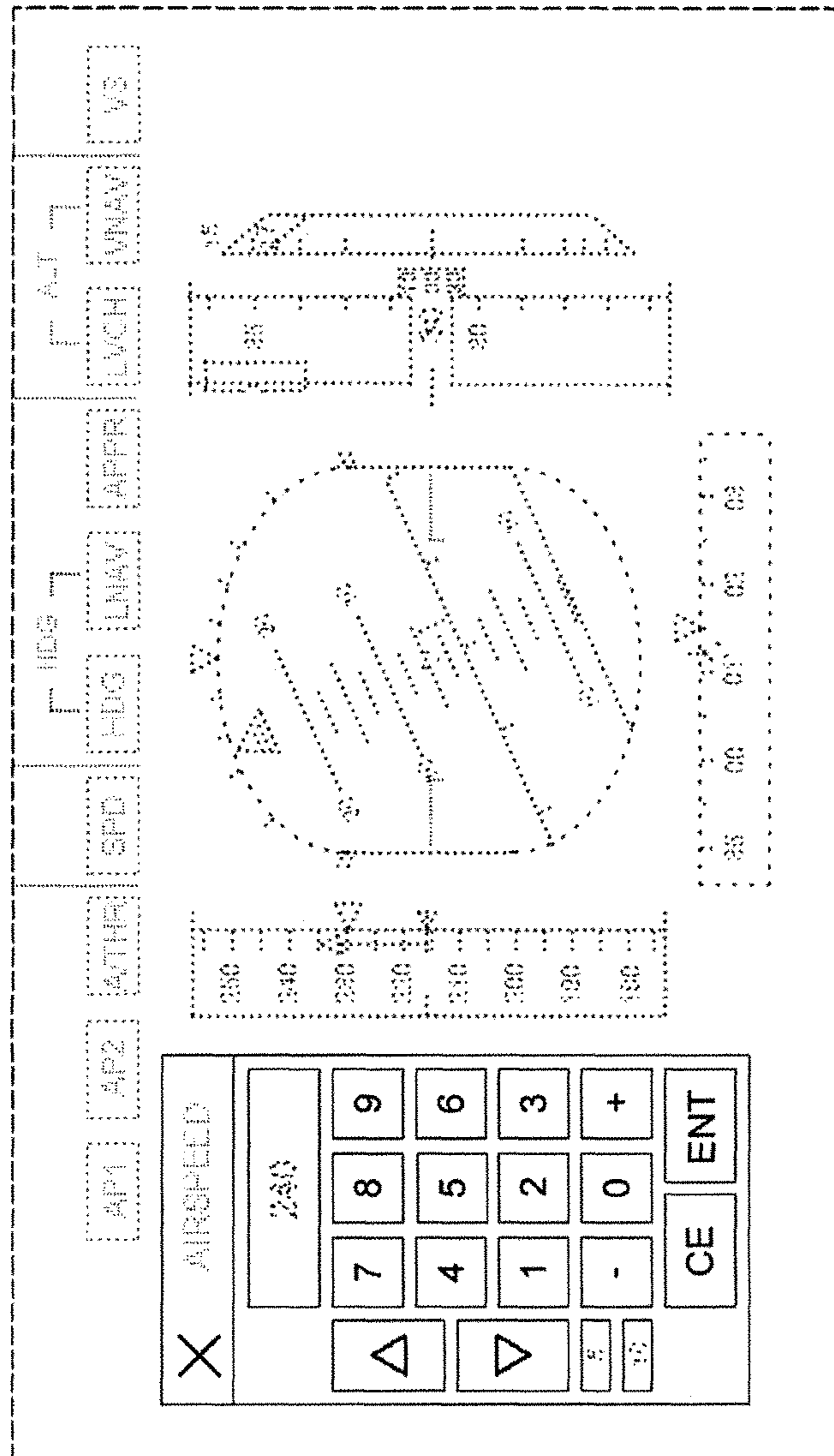

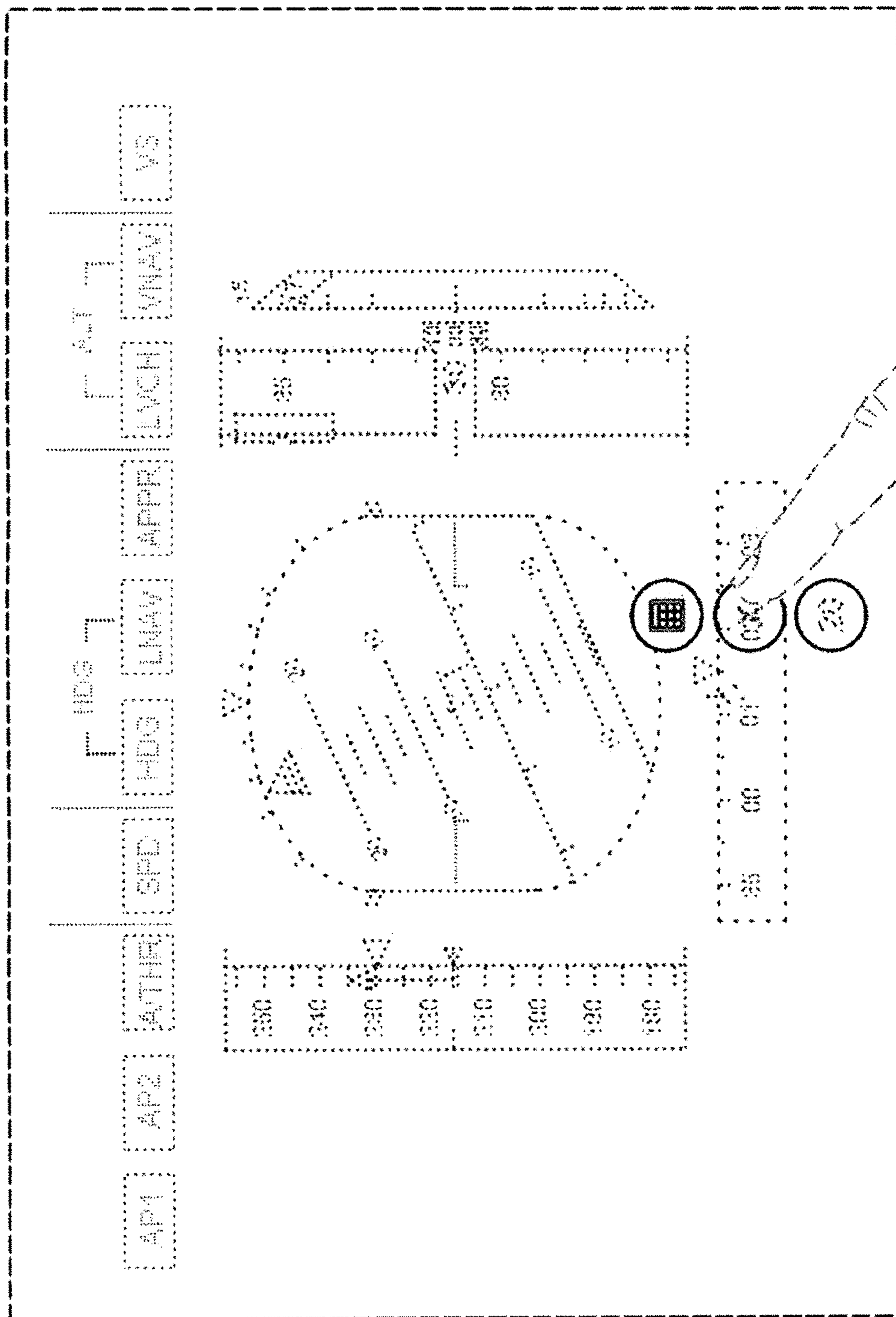

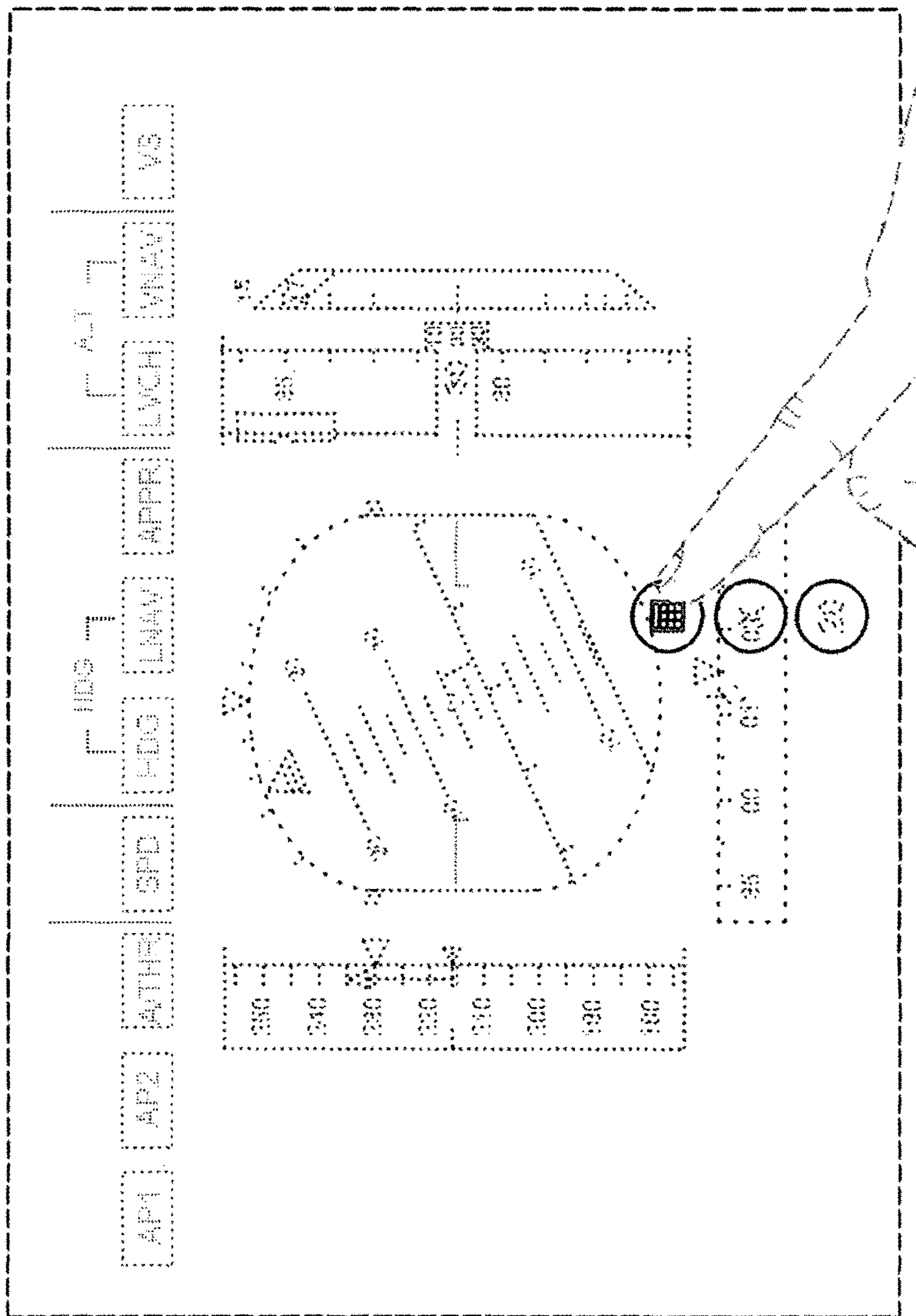

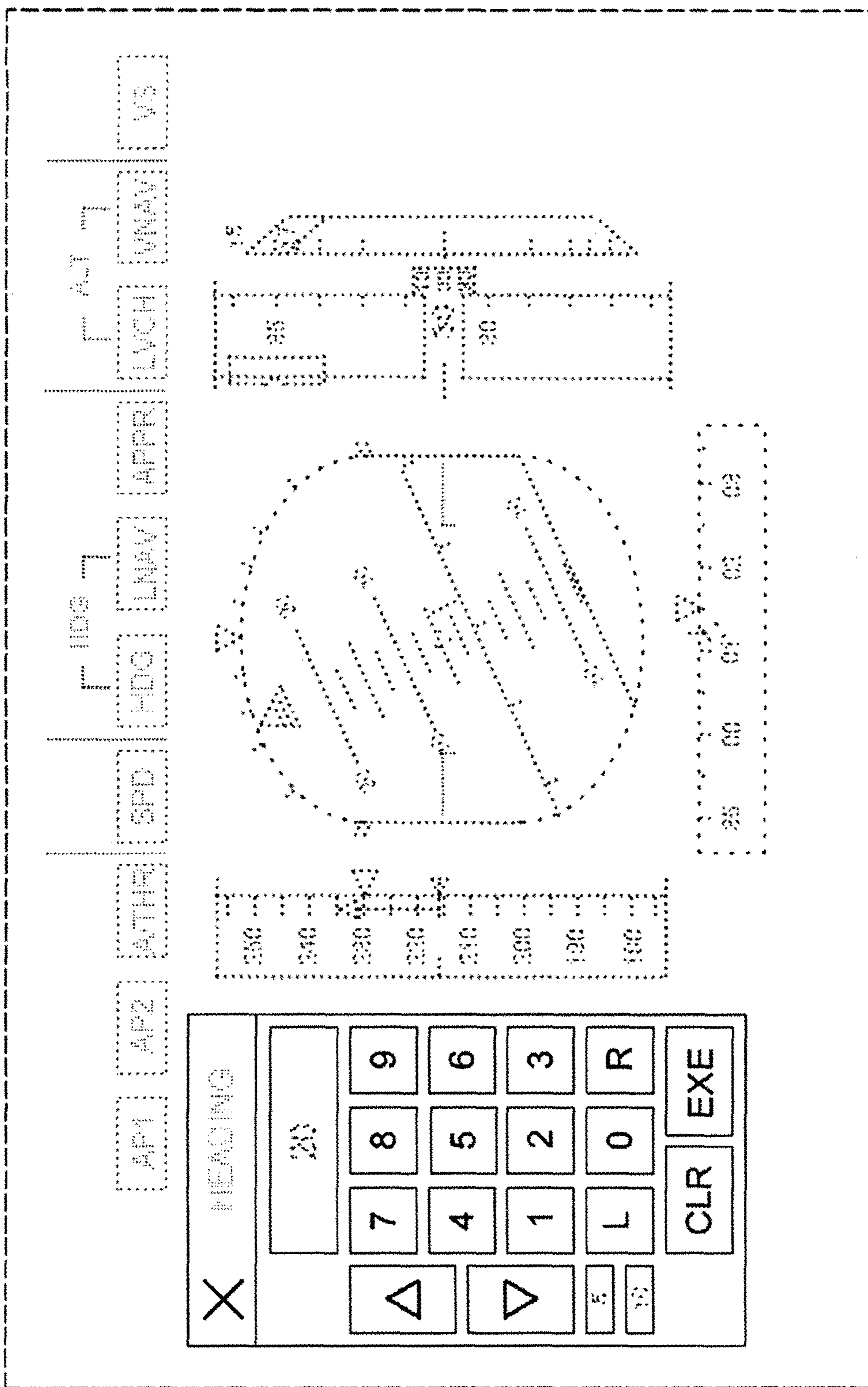

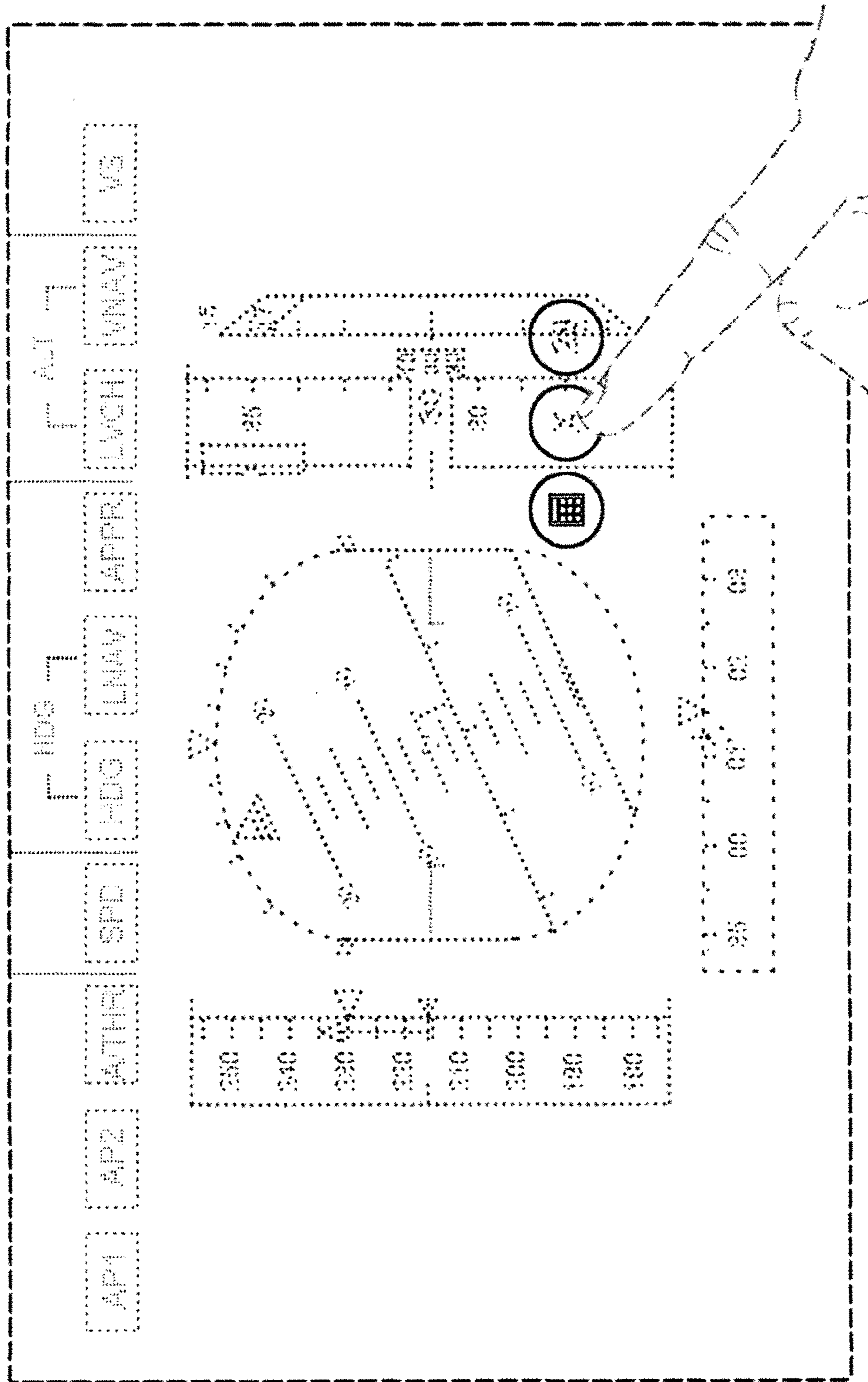

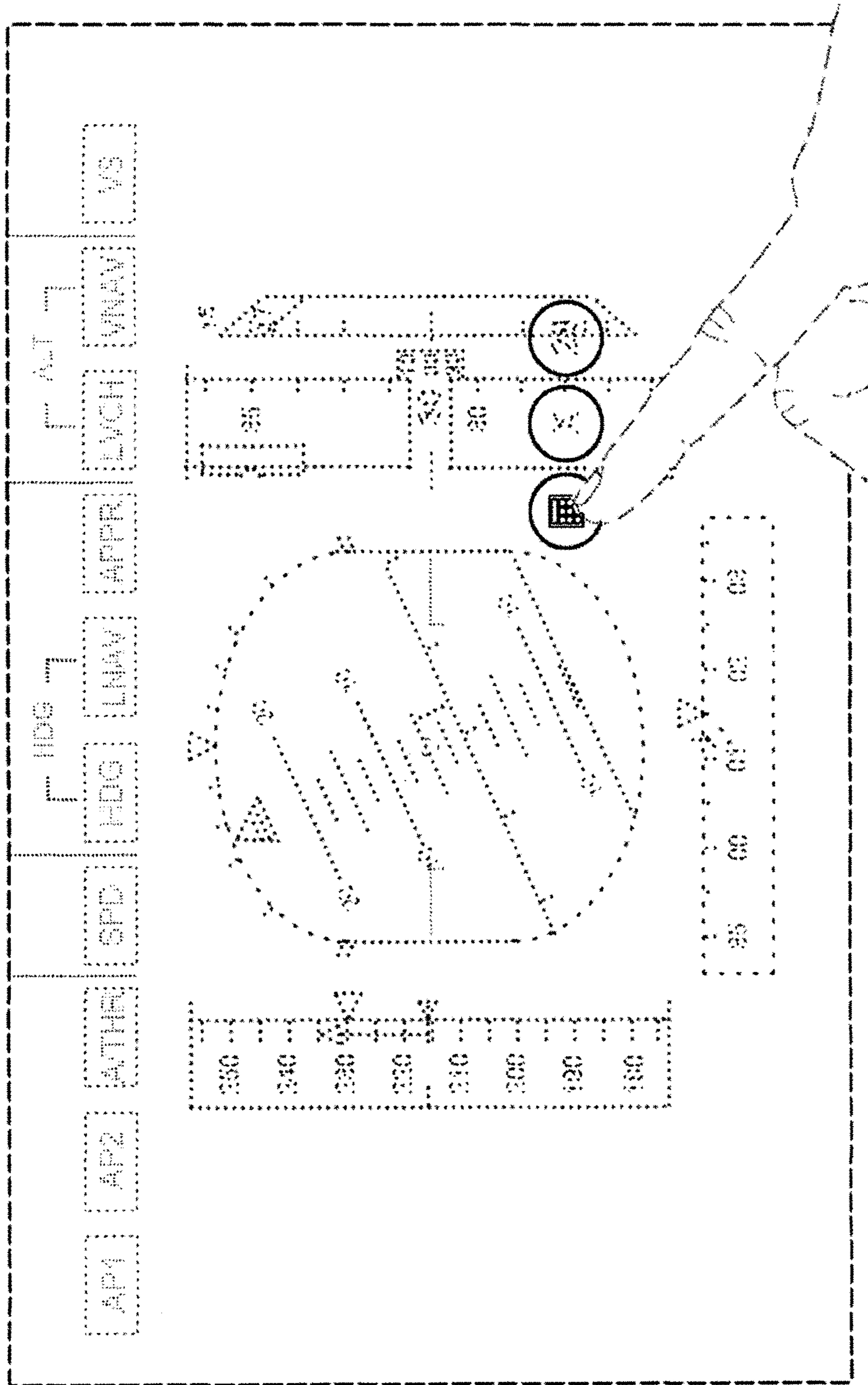

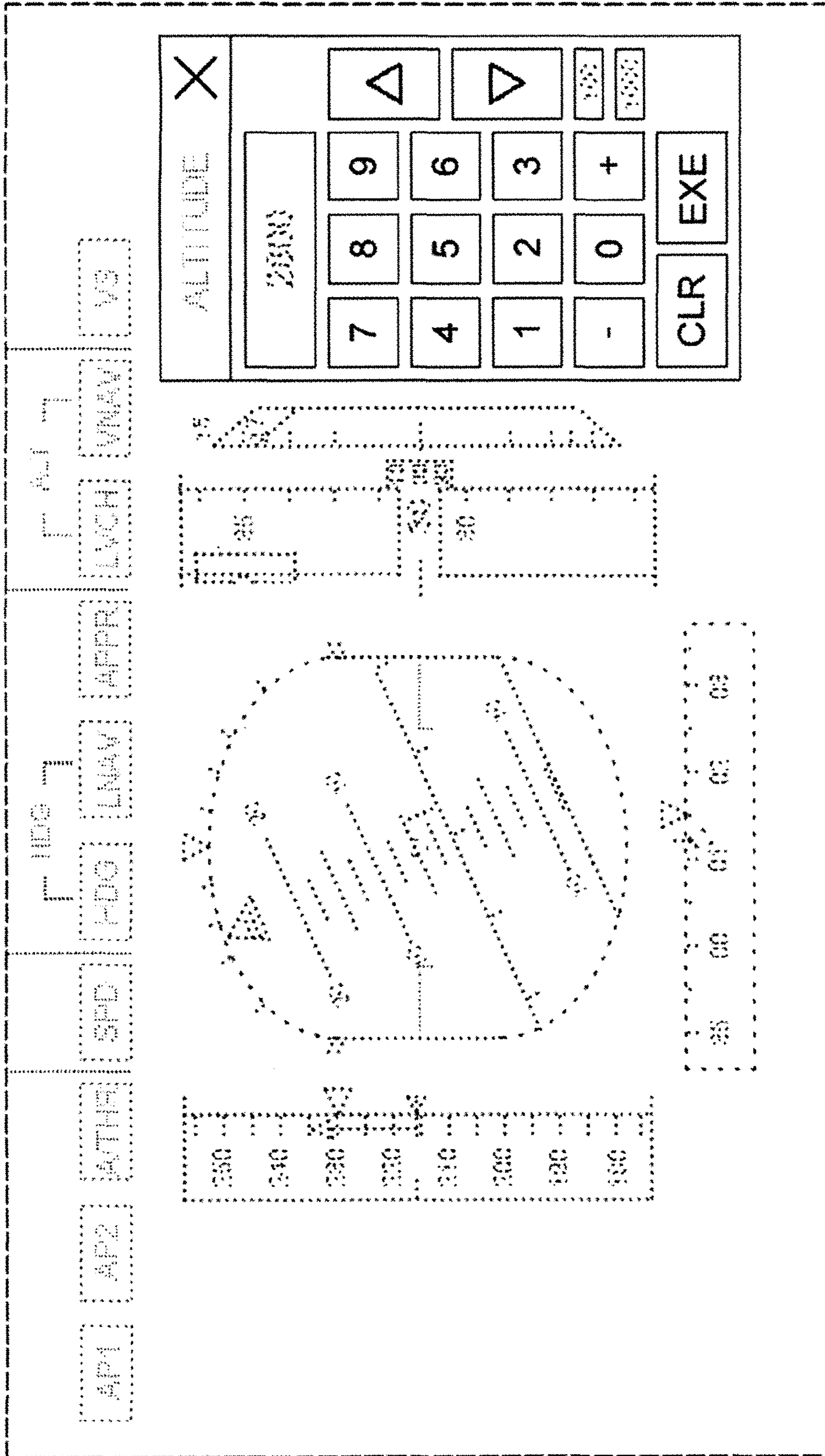

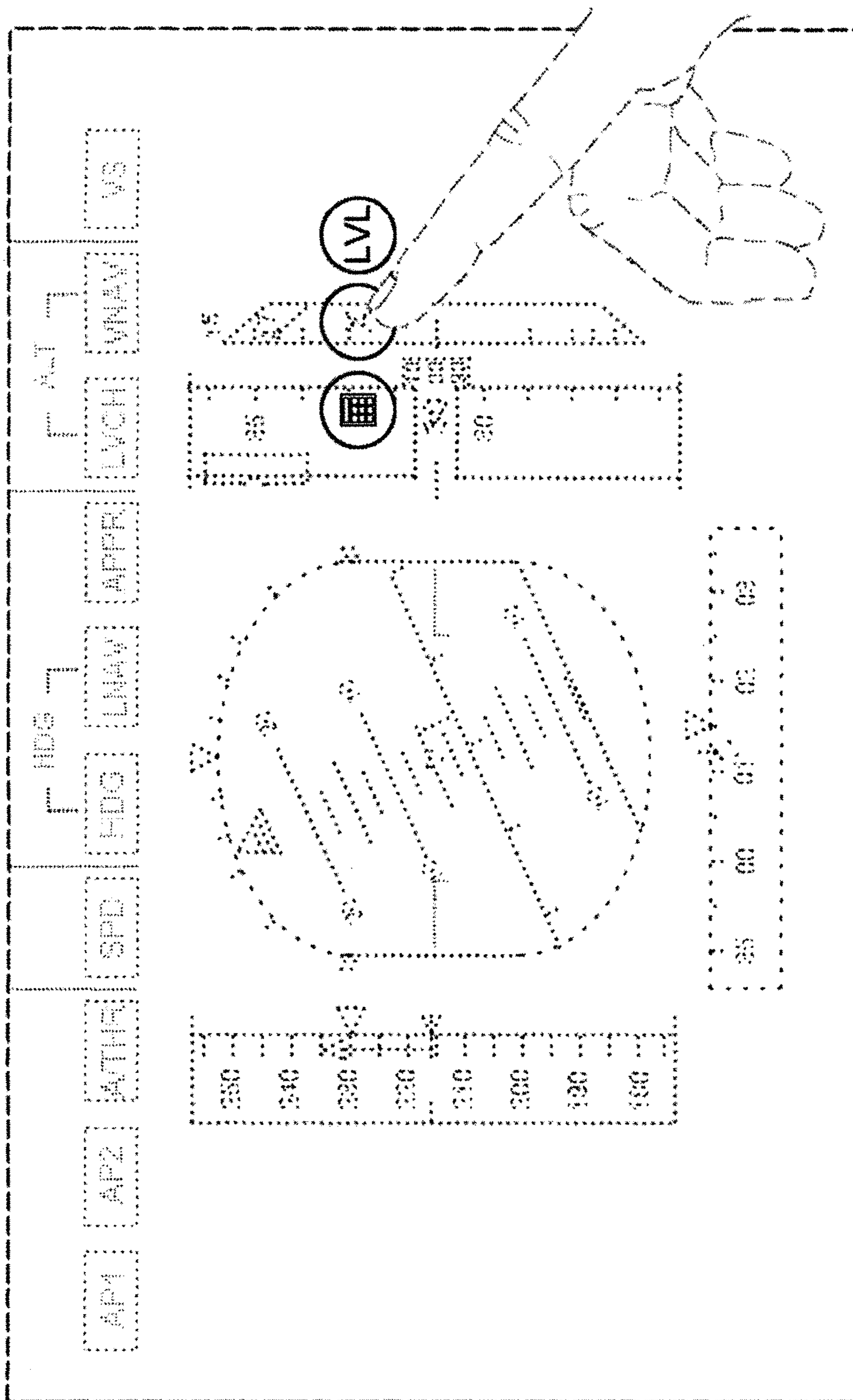

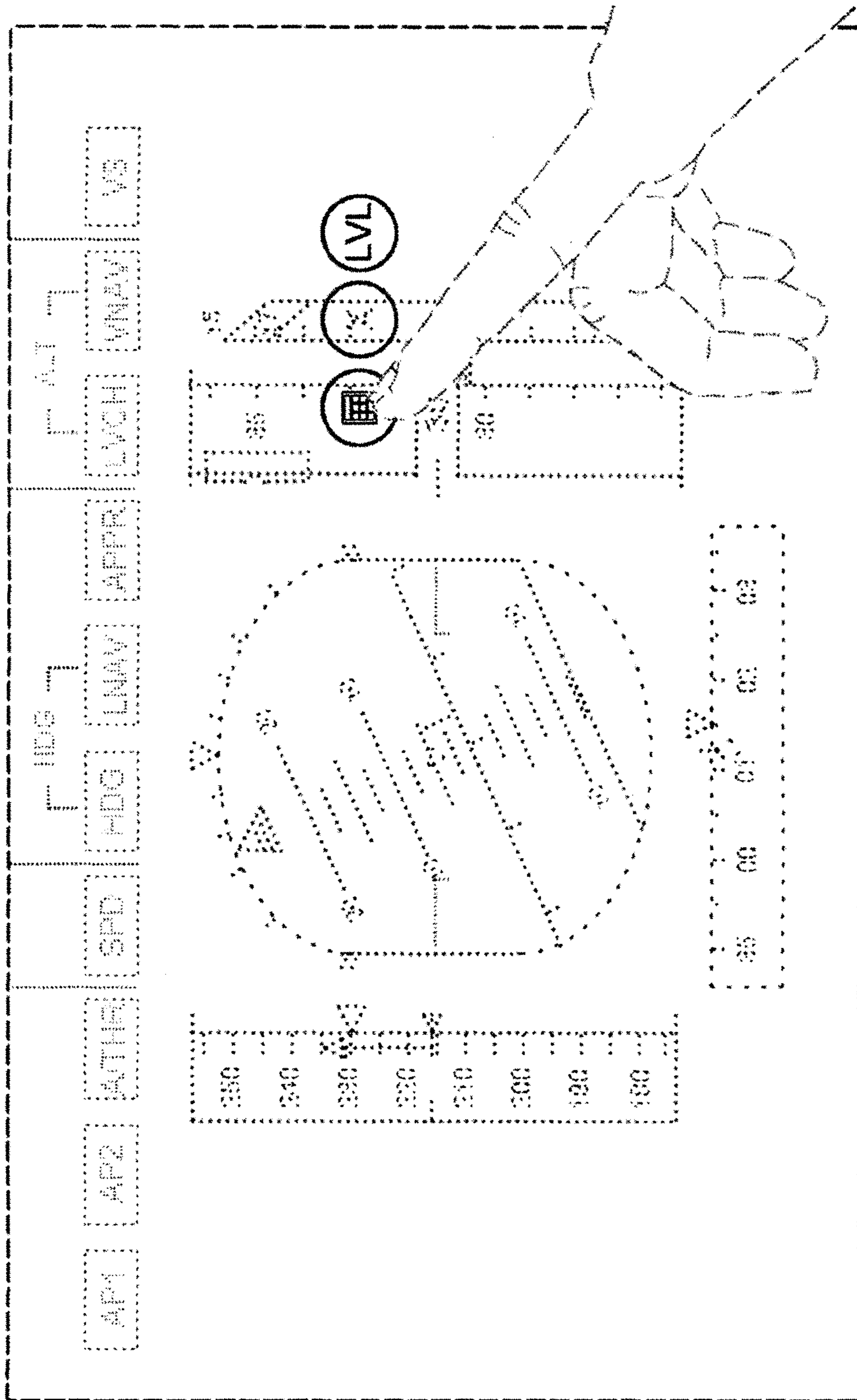

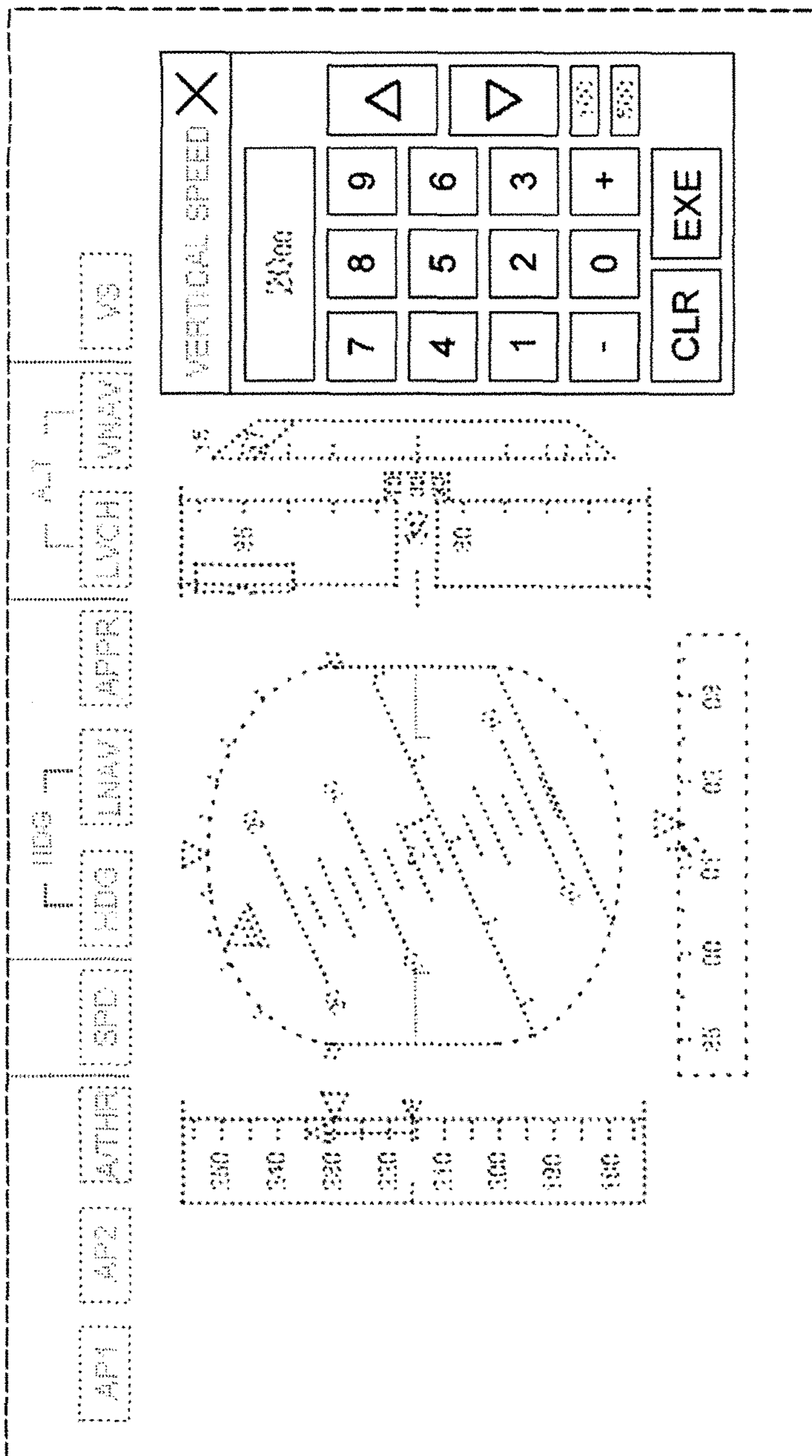
