FIG. 4 is a rear view thereof, with the journal in an open position.

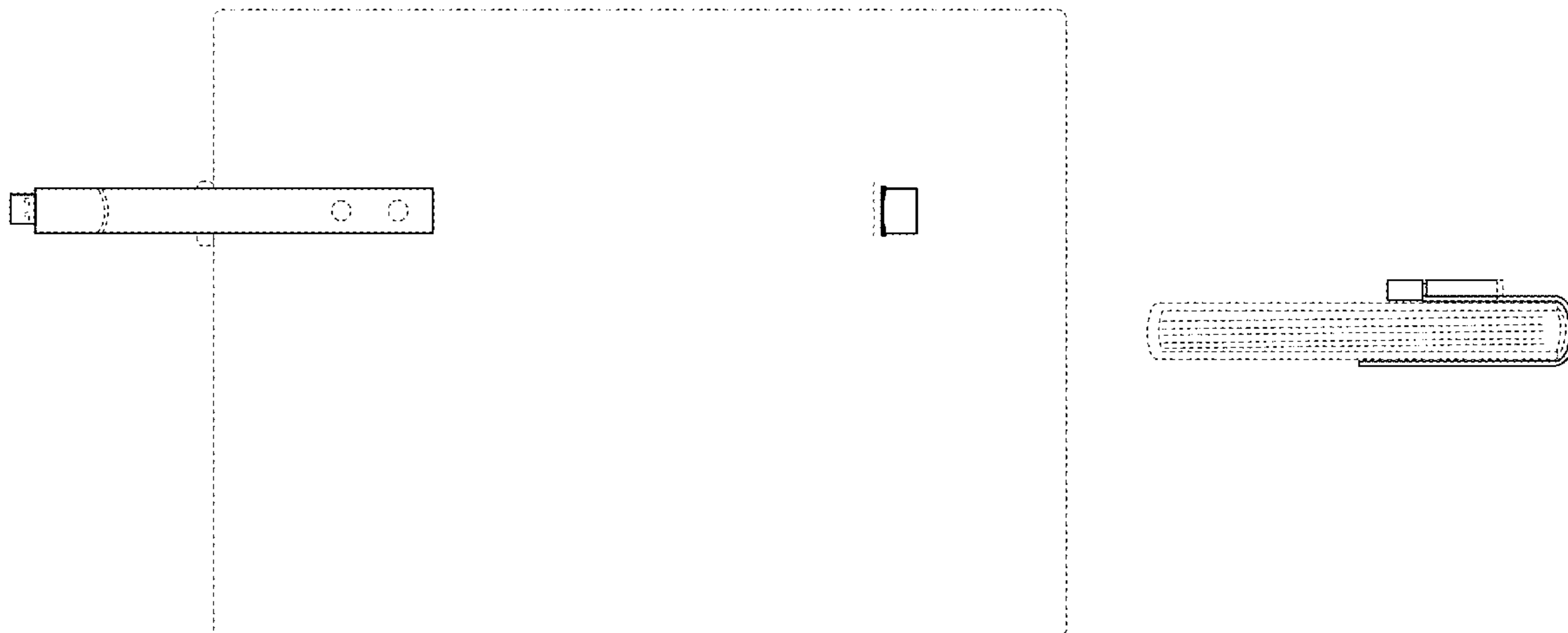
FIG. 5 is a left side view thereof.

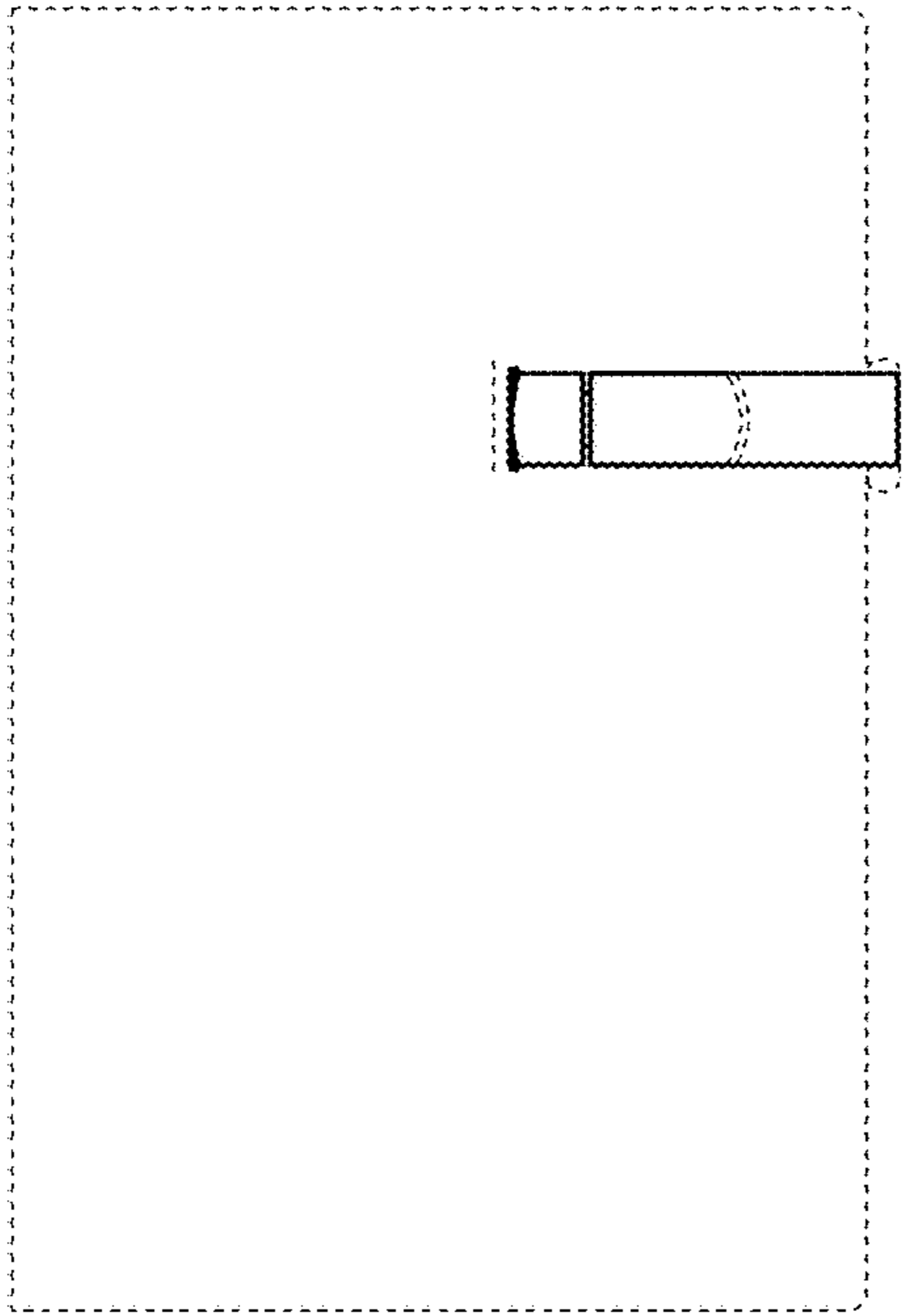

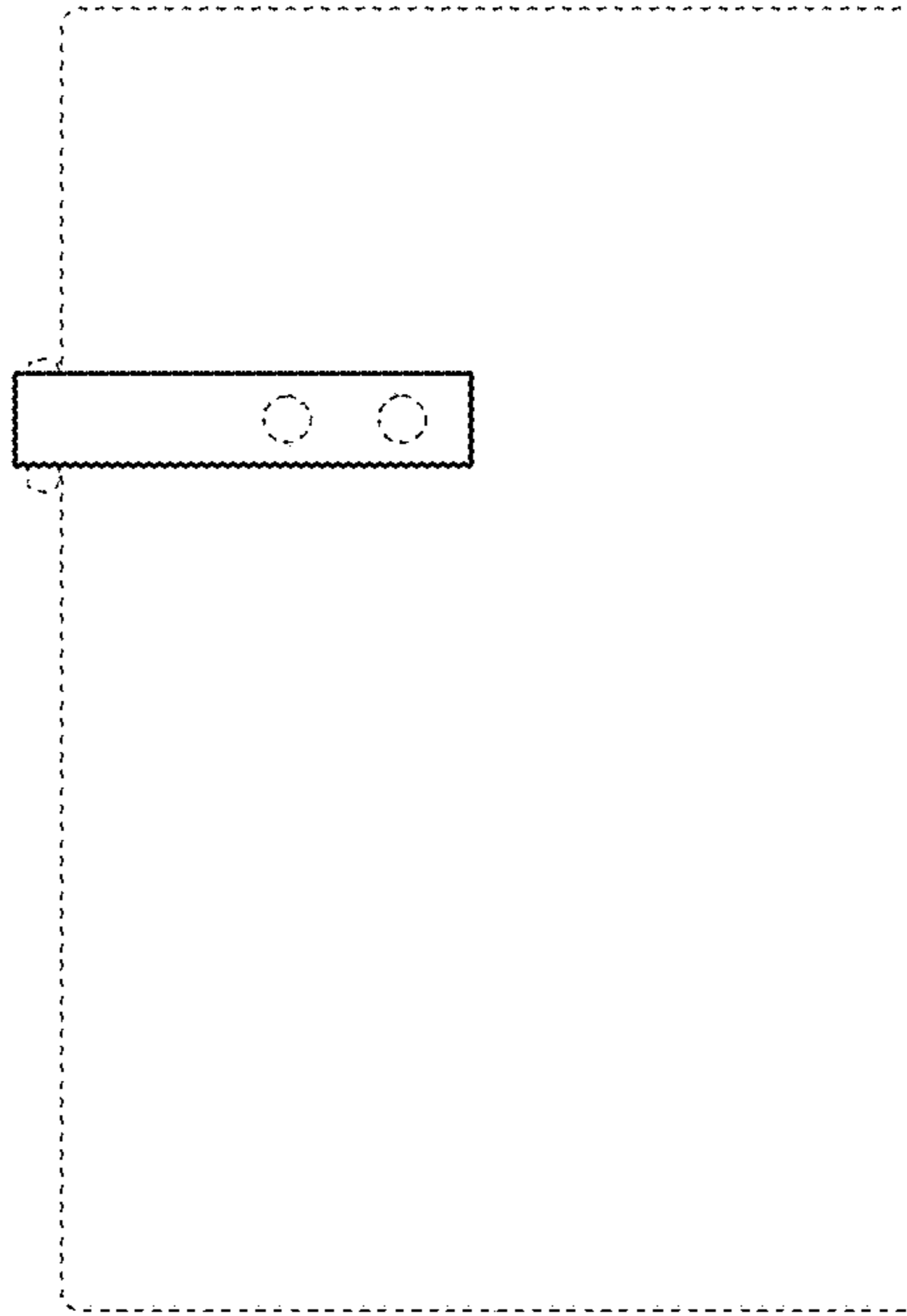

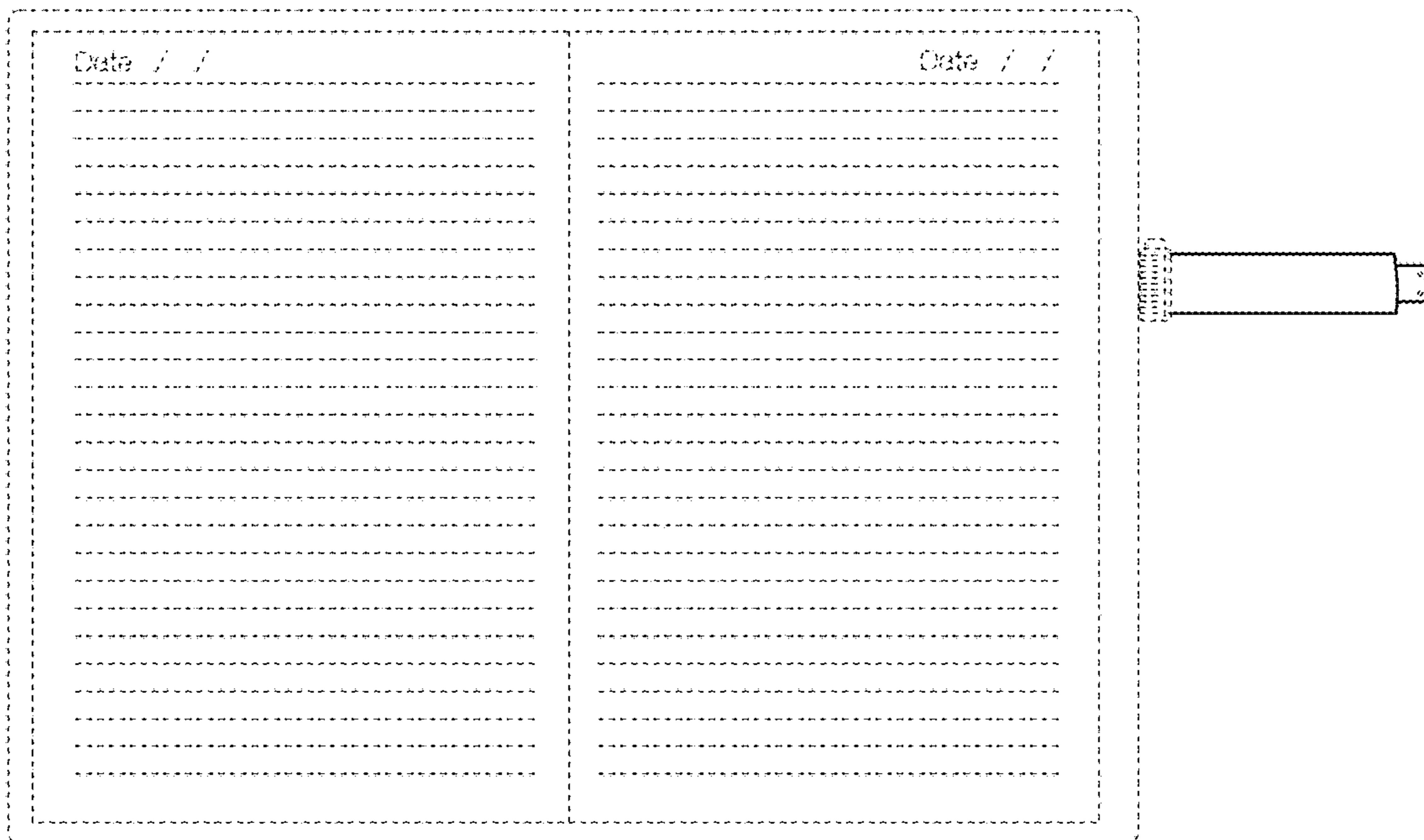

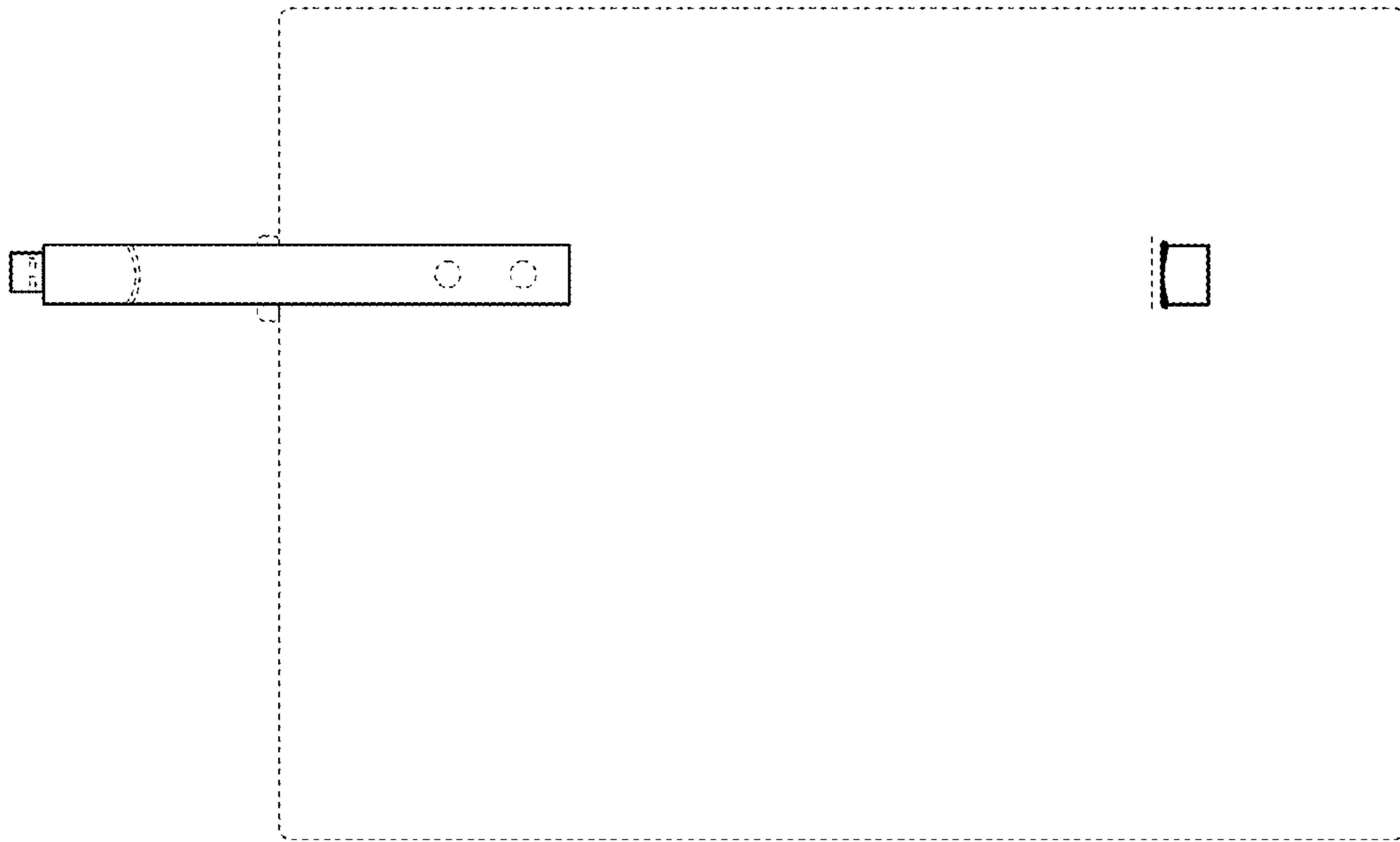

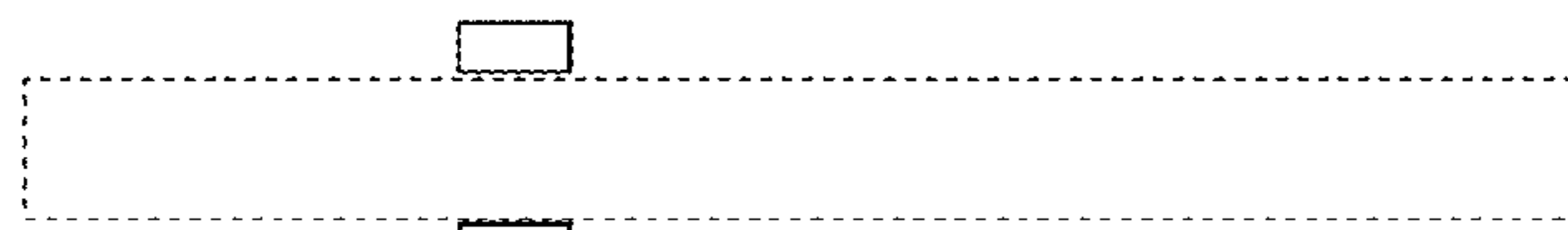

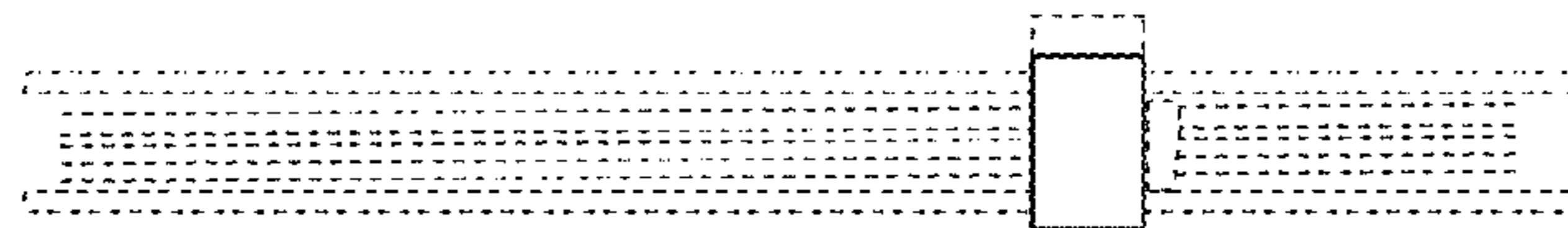

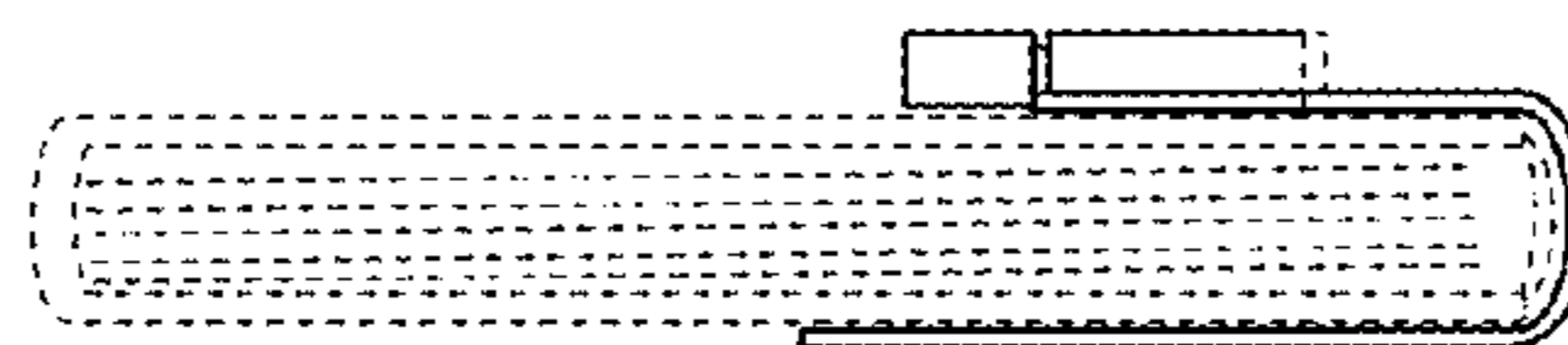
