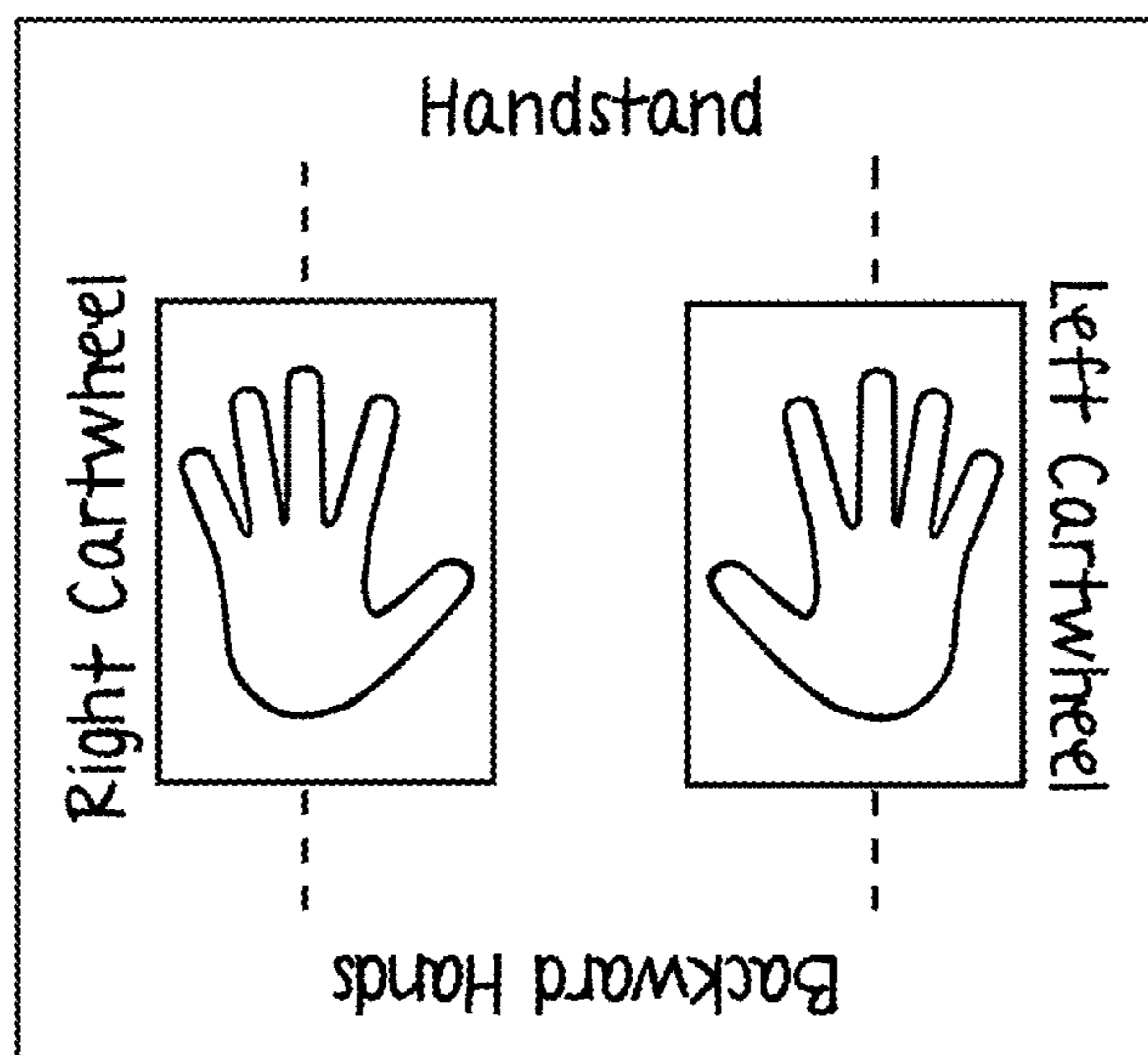
The ornamental design for a gymnastics mat, as shown and described.

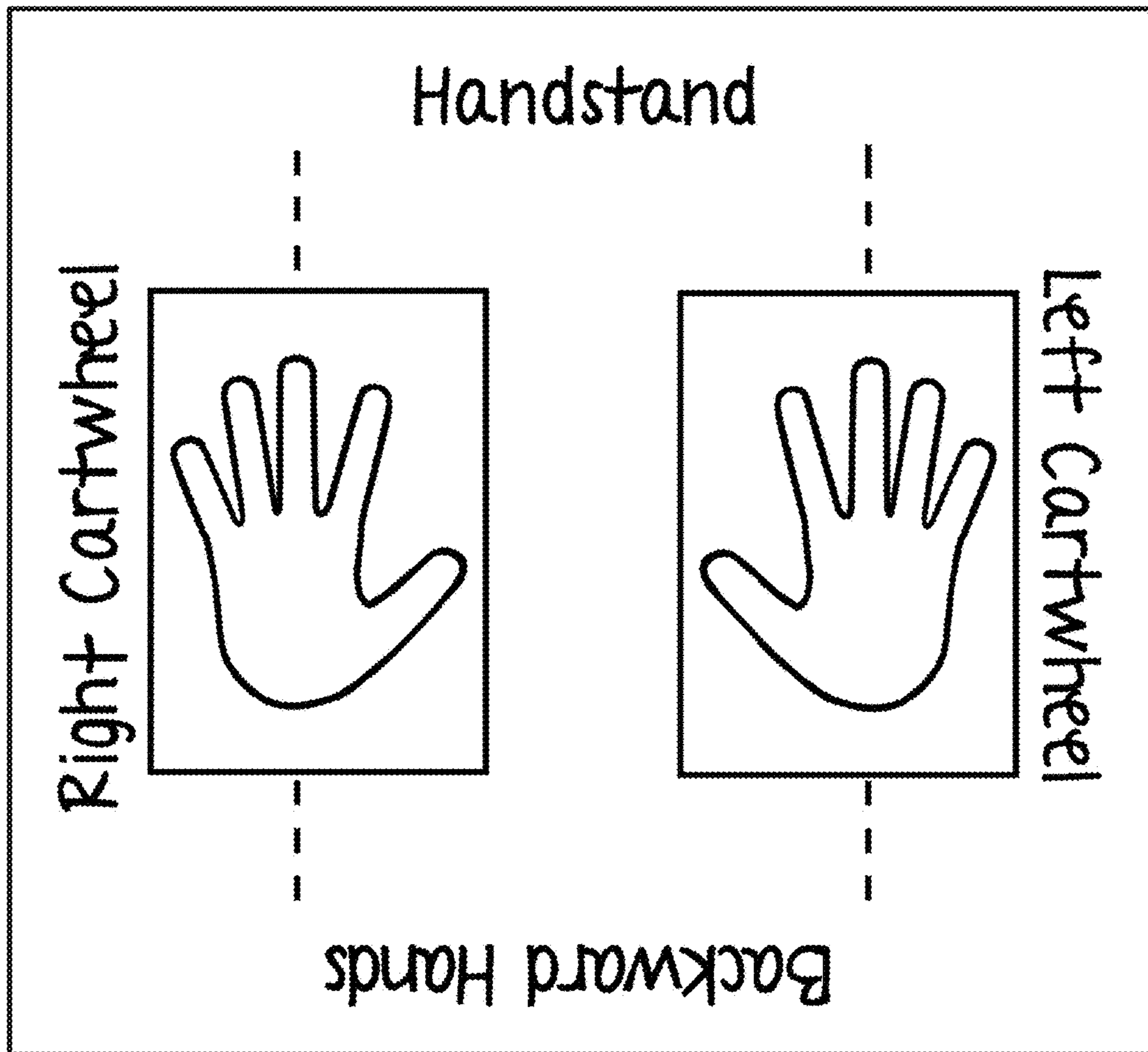

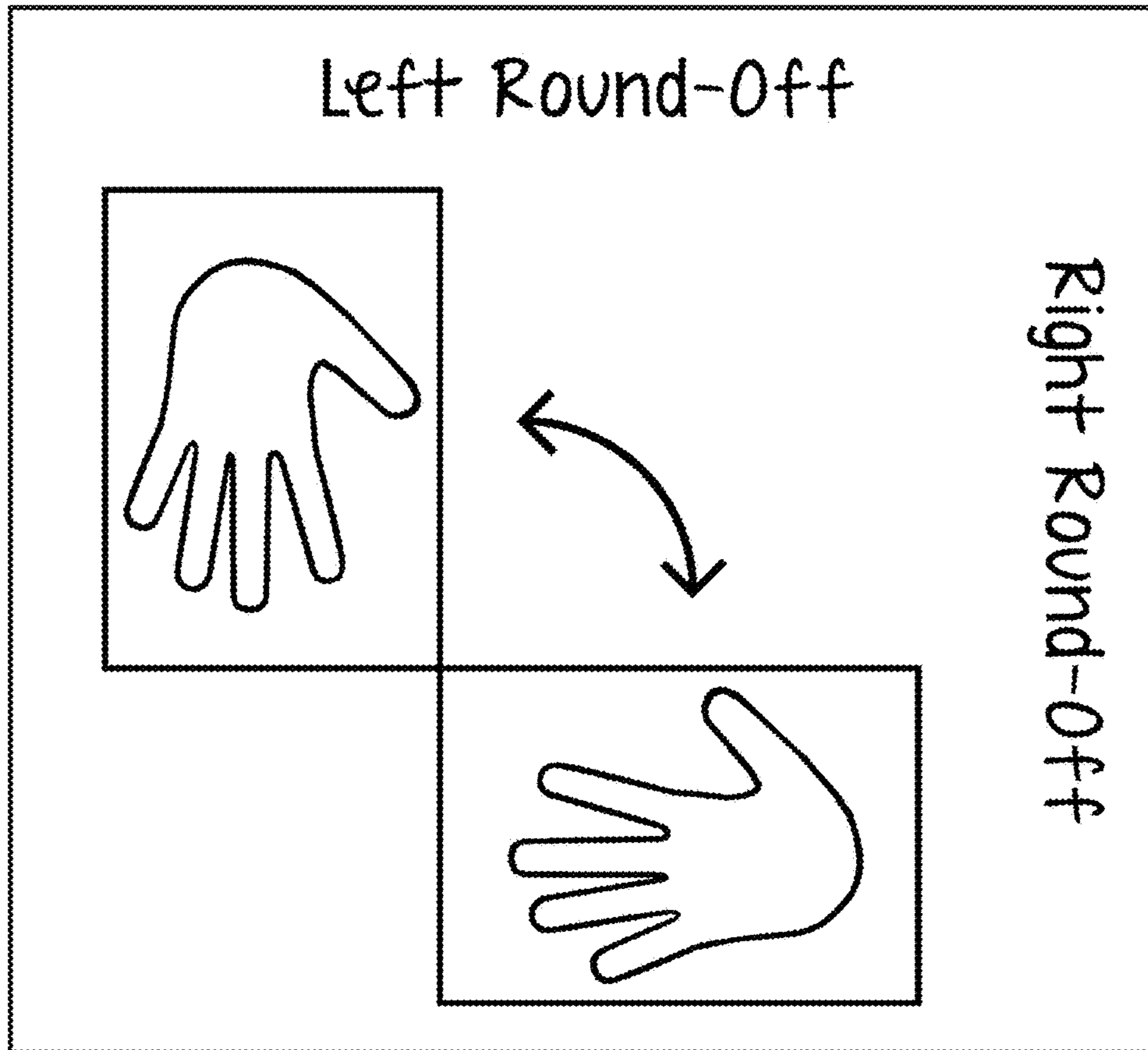
