(57) **CLAIM**

The ornamental design for a drain hose, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective of a drain hose embodying my new design;

FIG. 2 is an enlarged detail of a first portion of the drain hose shown in FIG. 1;

FIG. 3 is an enlarged detail of a second portion of the drain hose shown in FIG. 1;

FIG. 4 is an enlarged detail of a third portion of the drain hose shown in FIG. 1;

FIG. 5 is a right side elevational view of the drain hose shown in FIG. 1;

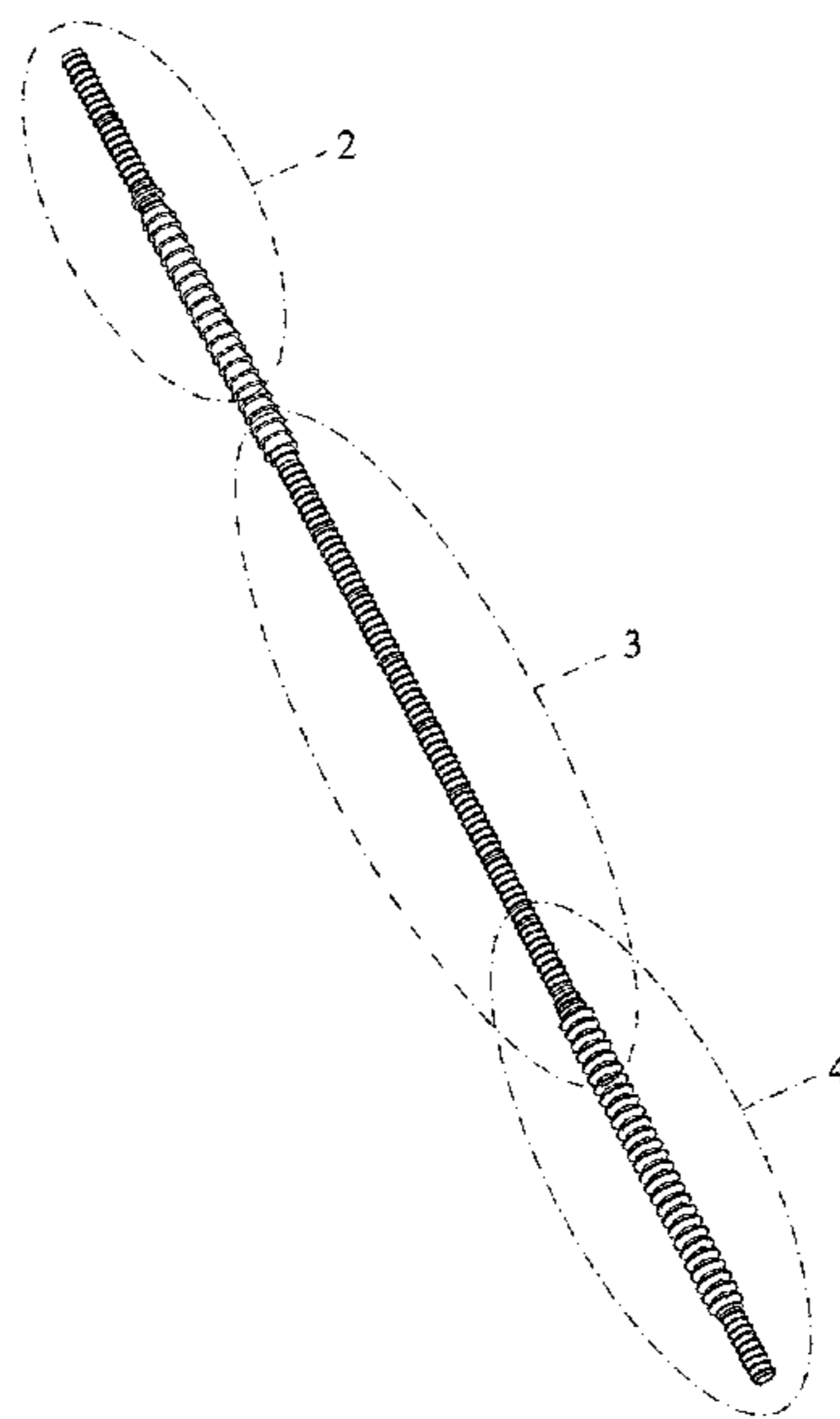
FIG. 6 is a left side elevational view of the drain hose shown in FIG. 1;

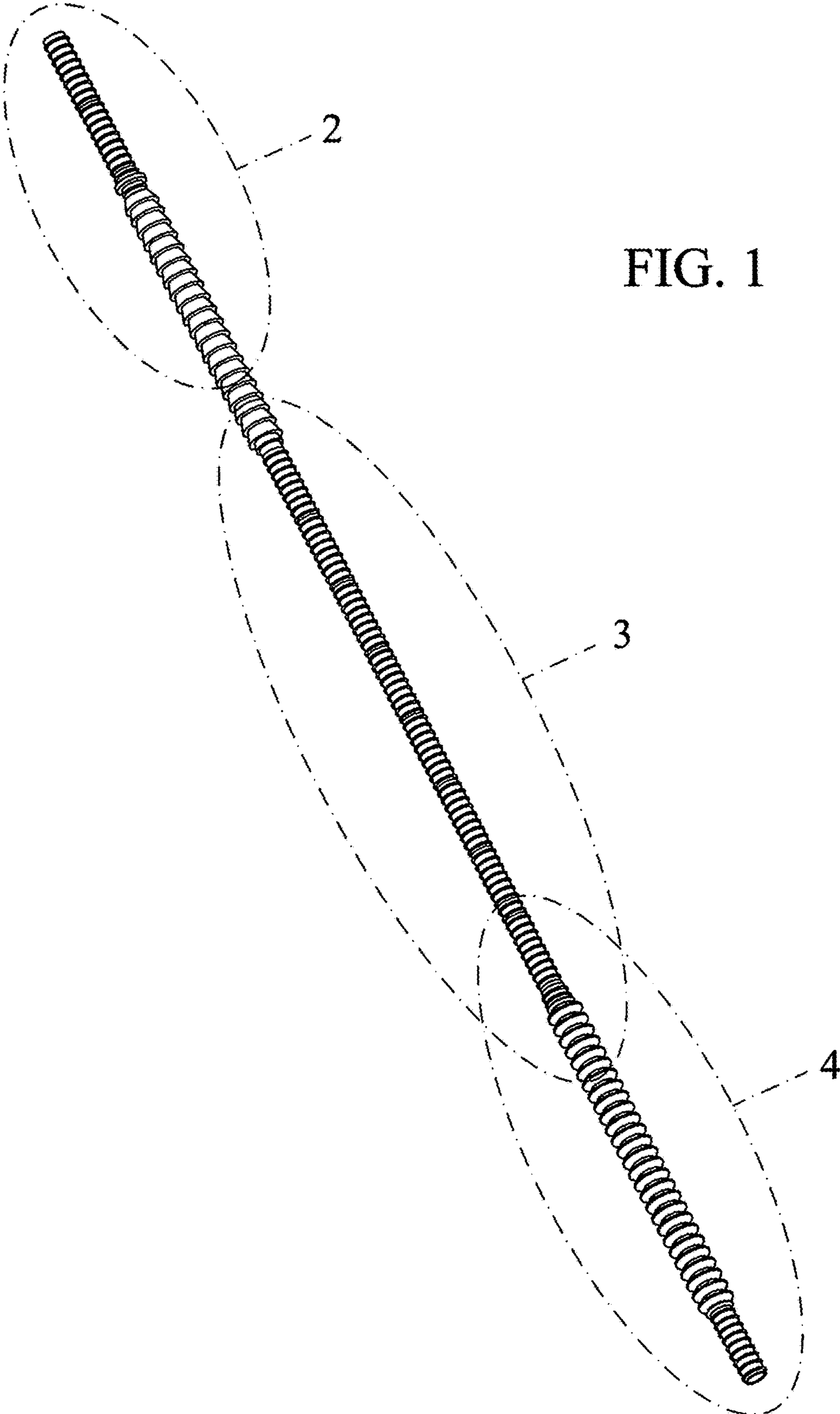

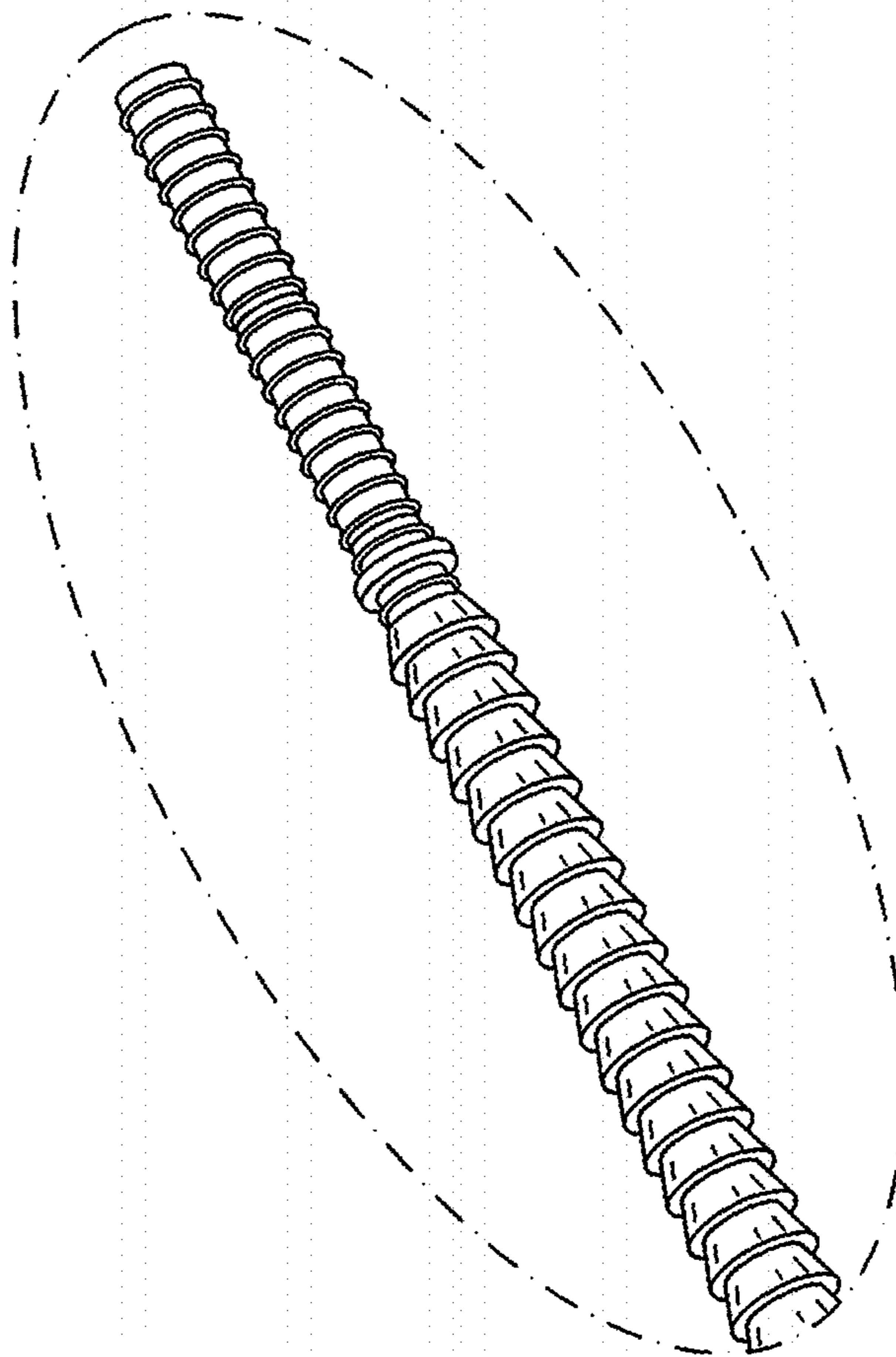

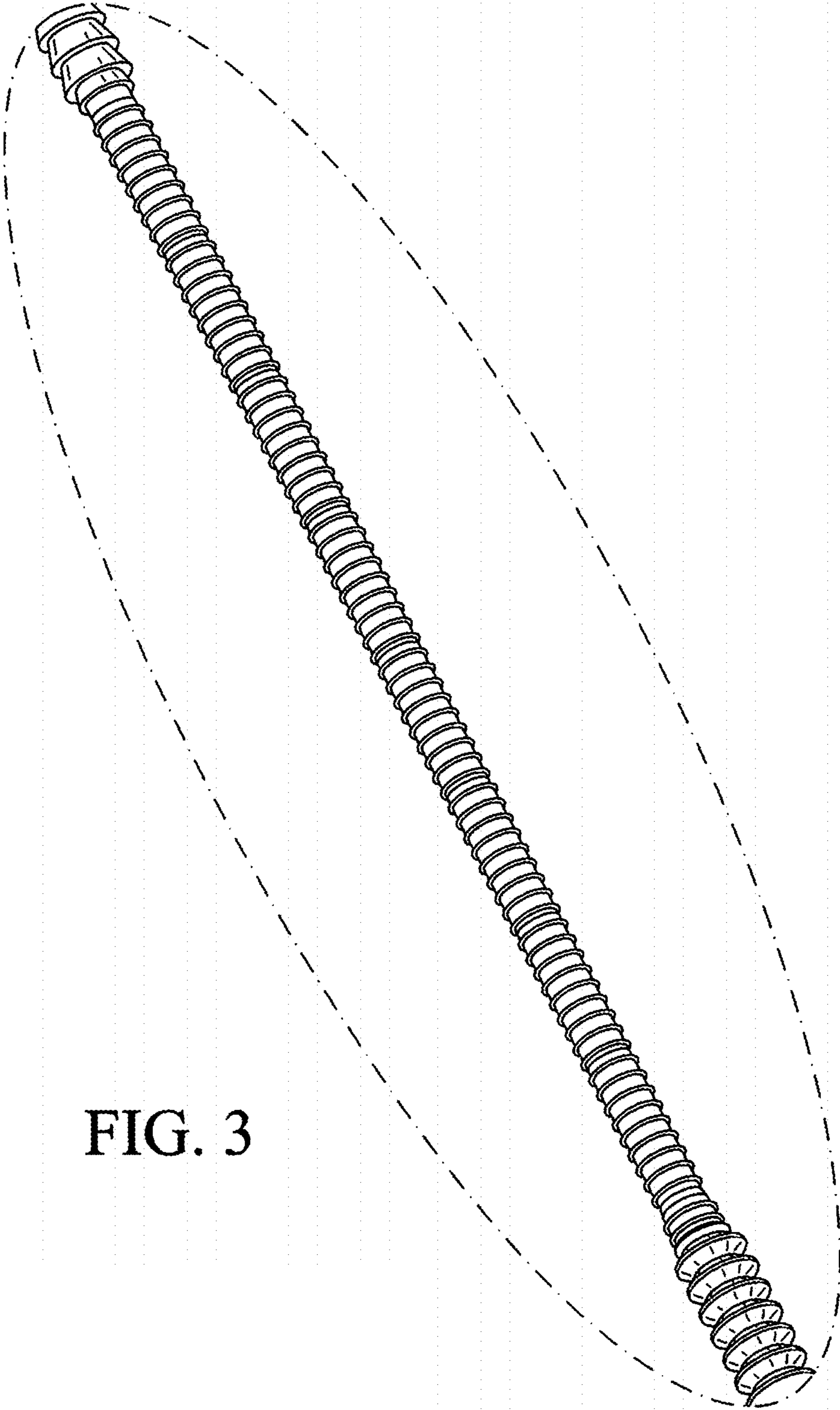

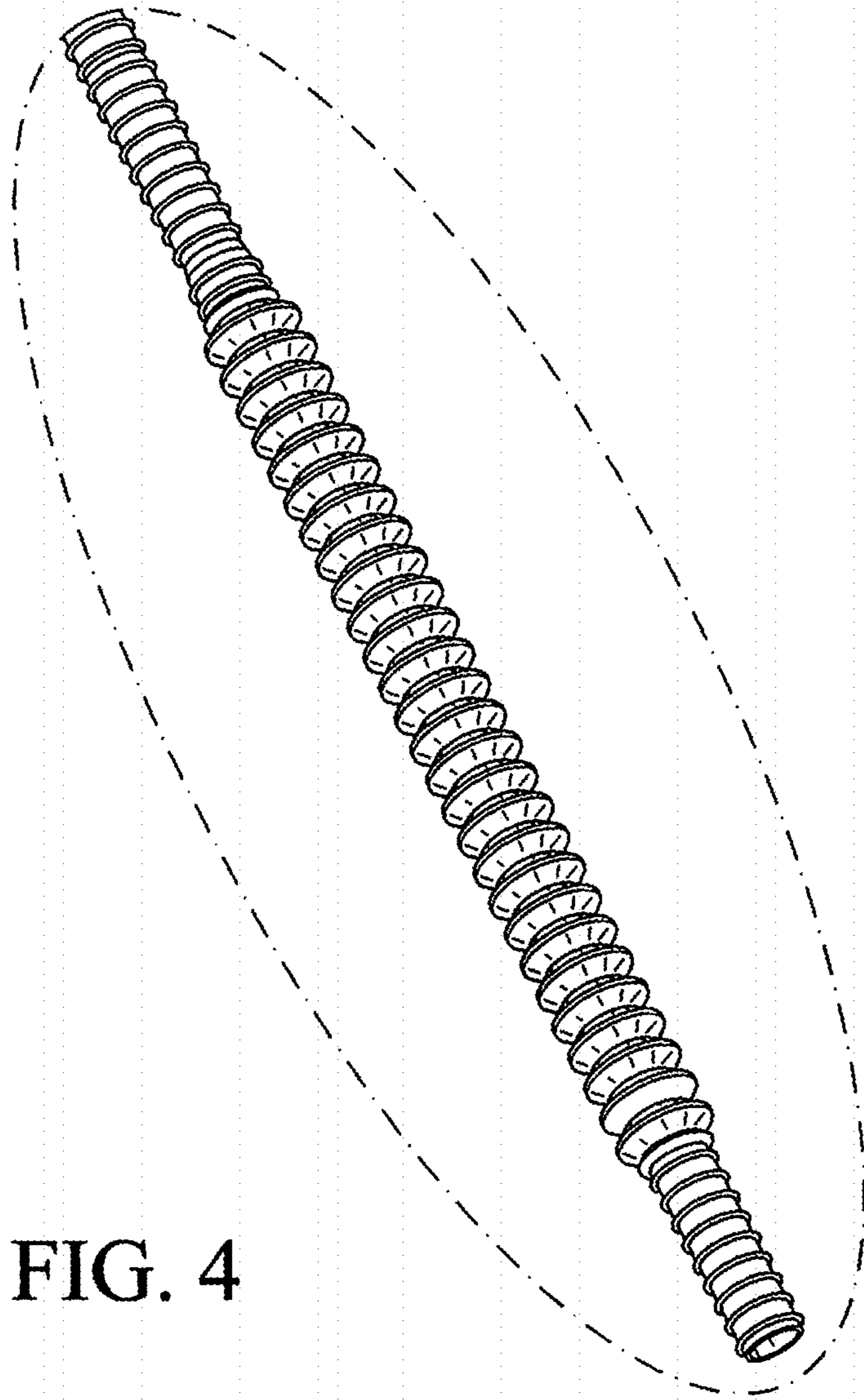

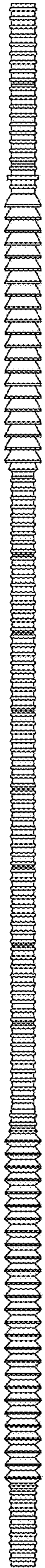

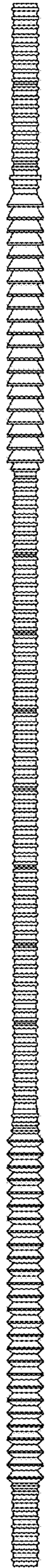

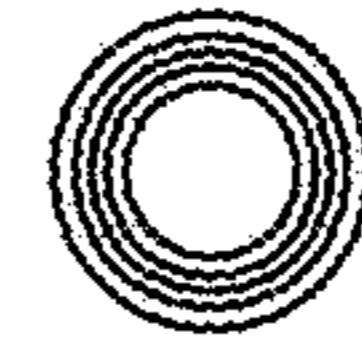

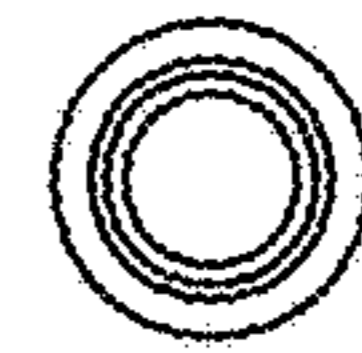
