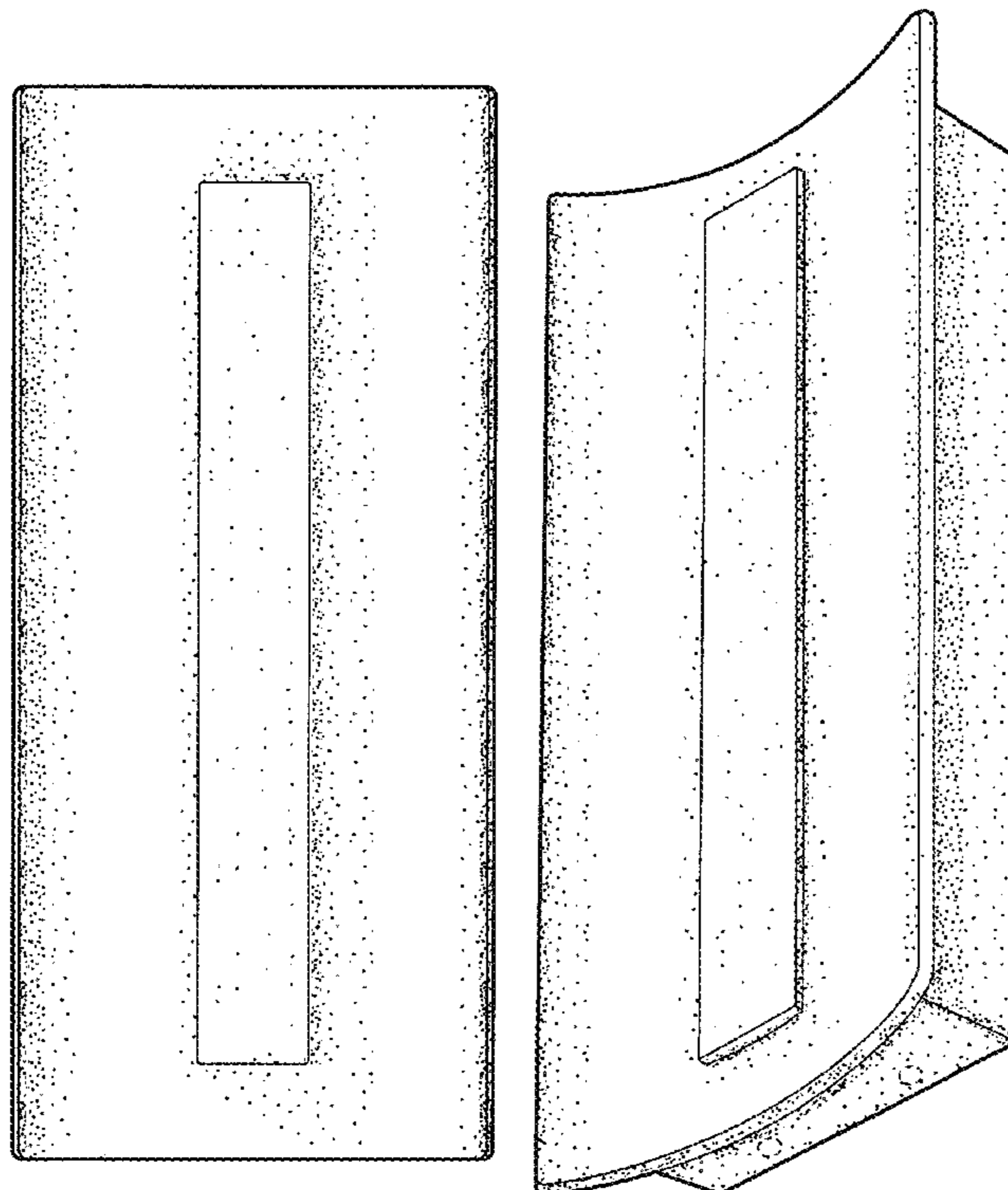
(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a light fixture showing the new design;  
FIG. 2 is a side elevation view thereof, the opposite side being a mirror image of that shown;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a perspective view thereof.  
The broken lines in the drawing depict parts of the light fixture that form no part of the claimed design.

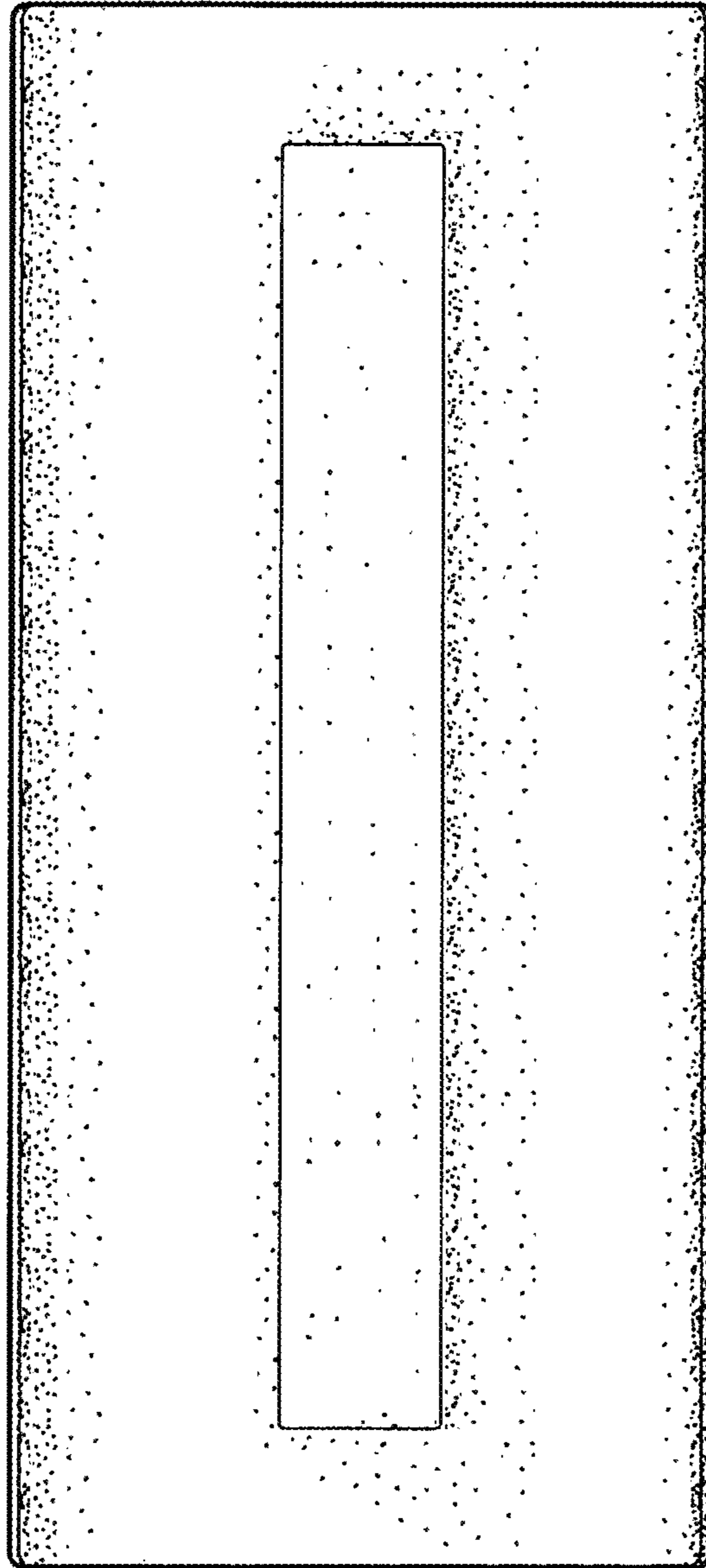

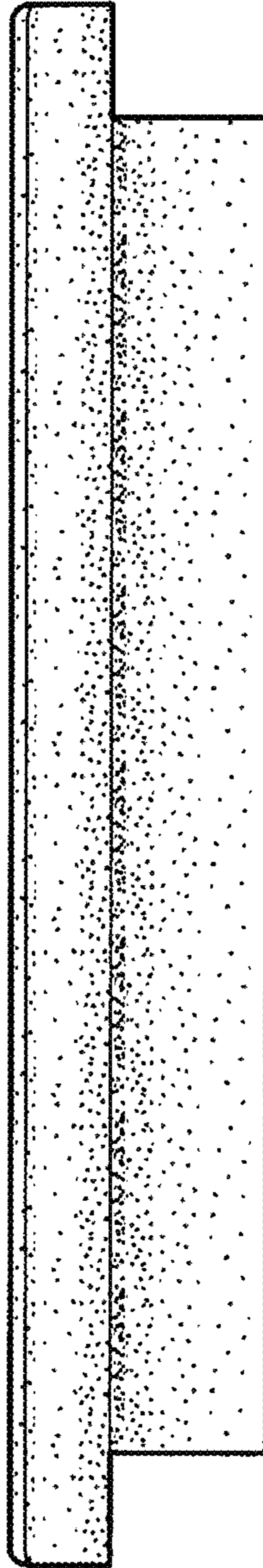

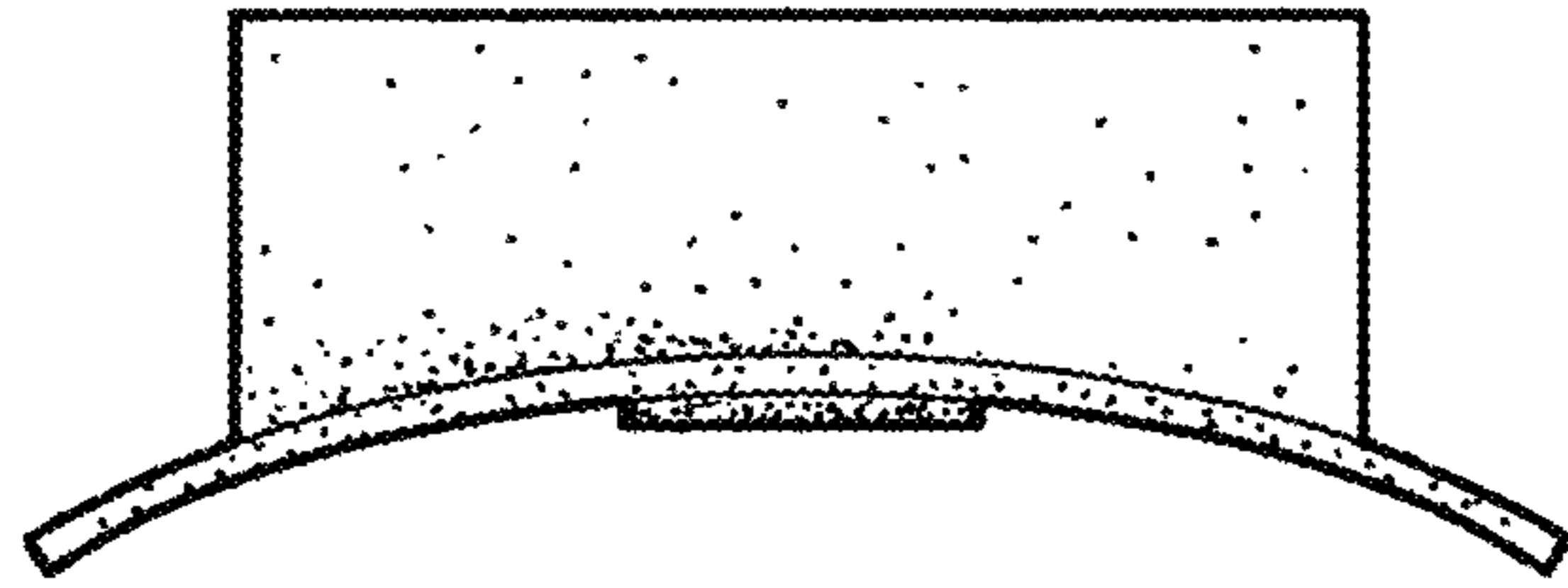

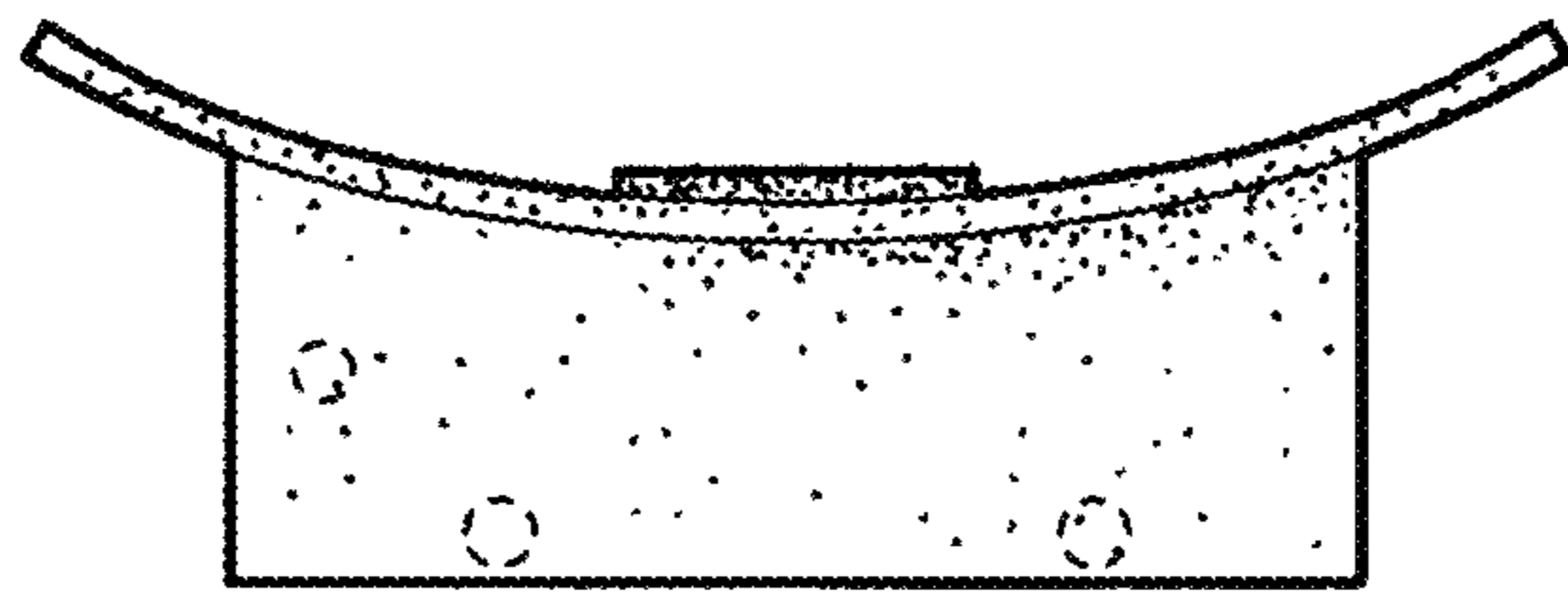

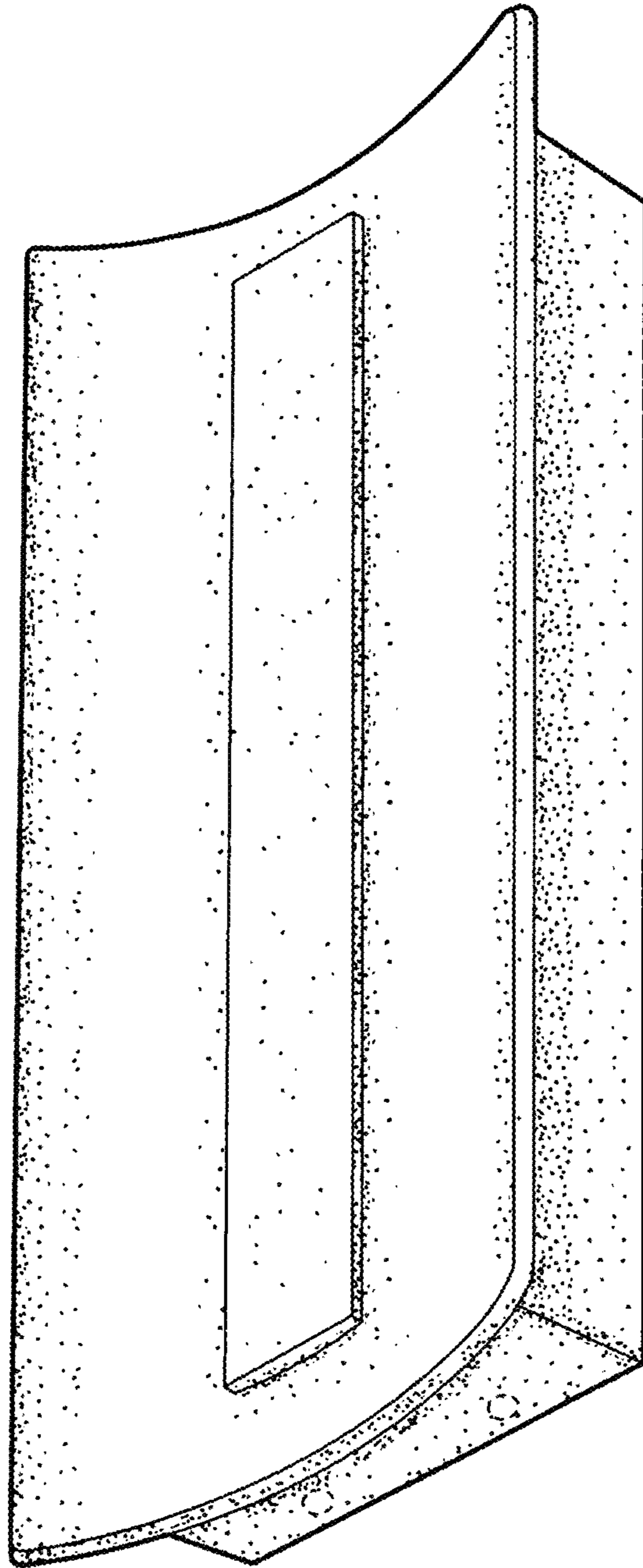
