(57) **CLAIM**

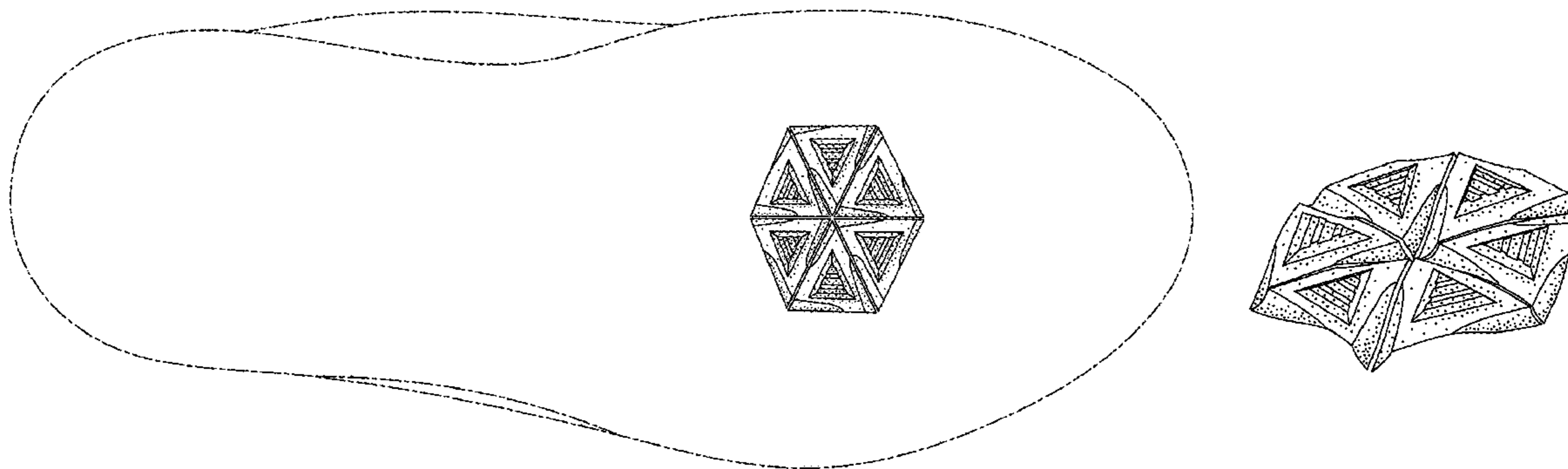
The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;  
 FIG. 2 is a bottom view thereof;  
 FIG. 3 is a rear perspective view thereof;  
 FIG. 4 is an enlarged view of the claimed region in FIG. 1, shown in isolation;  
 FIG. 5 is an enlarged view of the claimed region in FIG. 2, shown in isolation; and,  
 FIG. 6 is an enlarged view of the claimed region in FIG. 3, shown in isolation.

The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

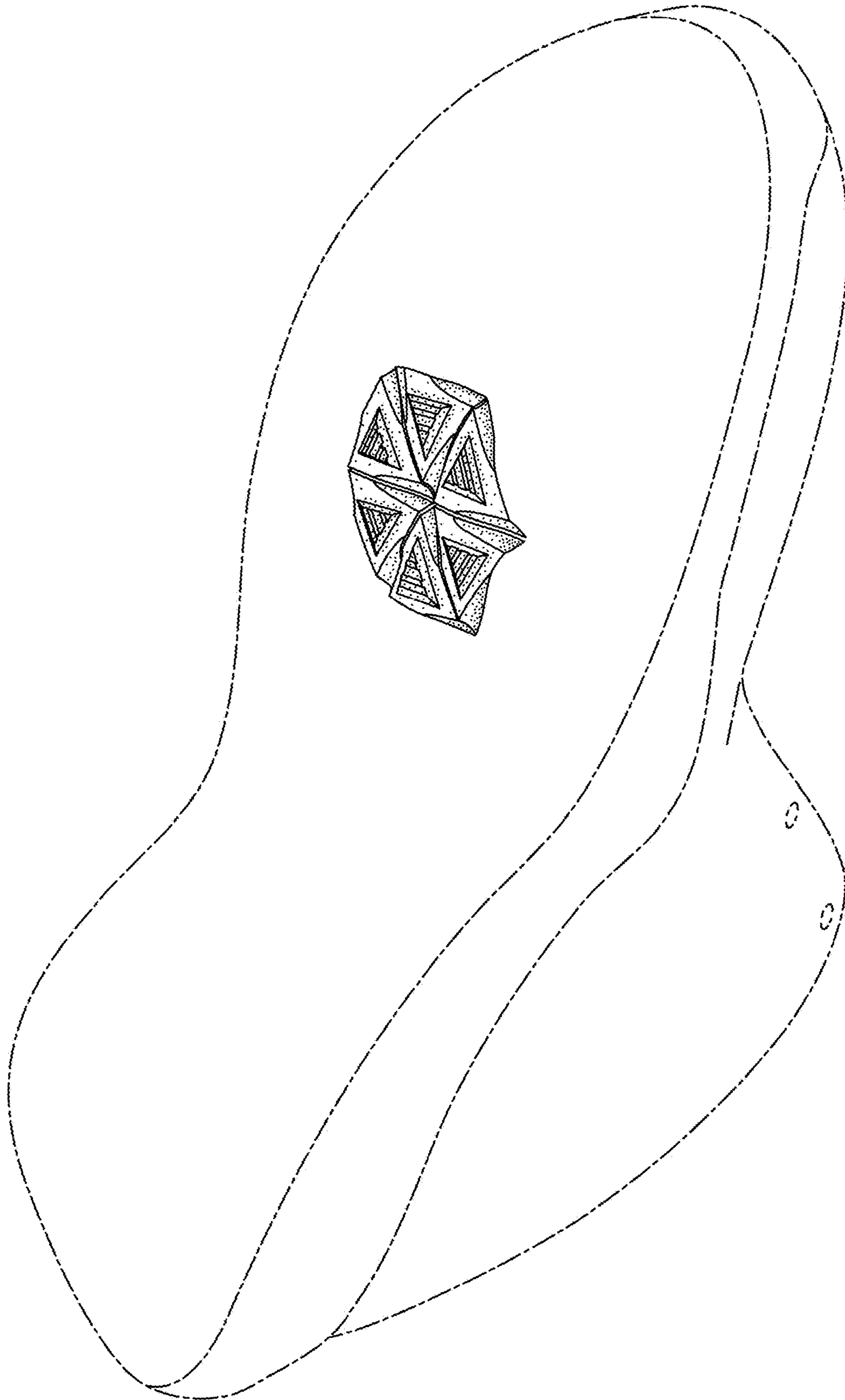

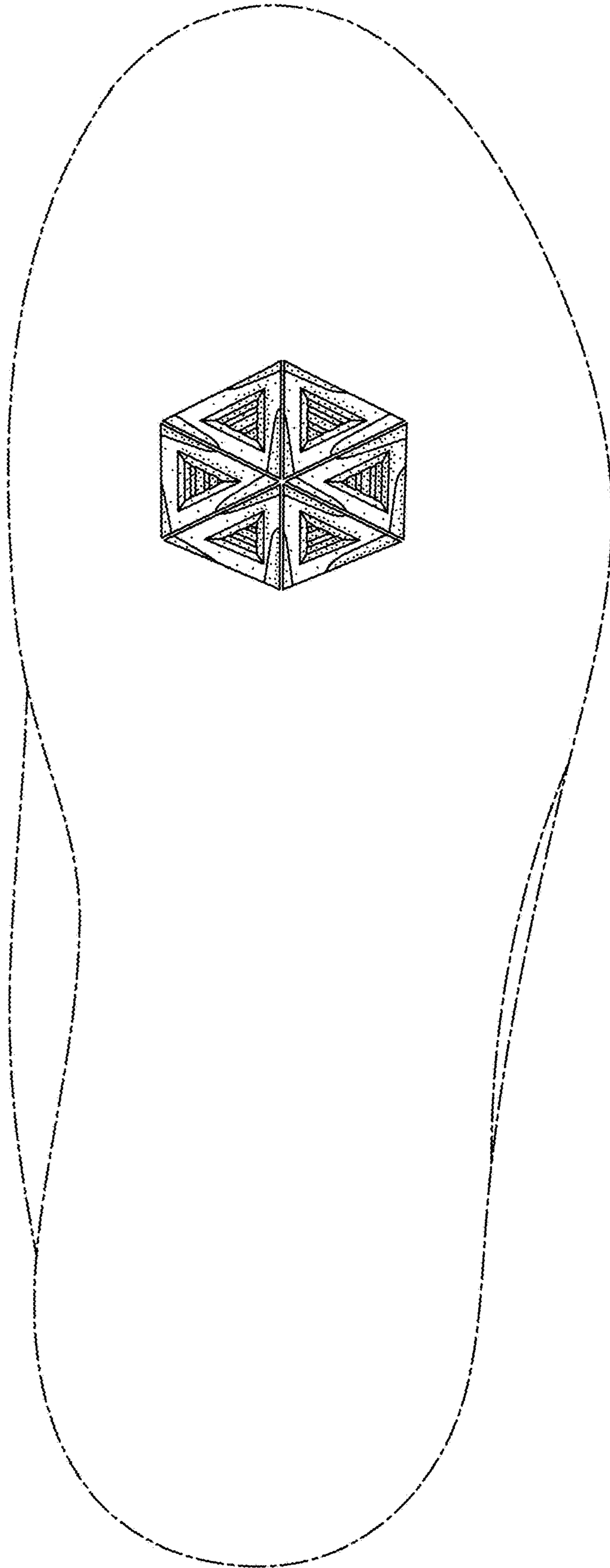

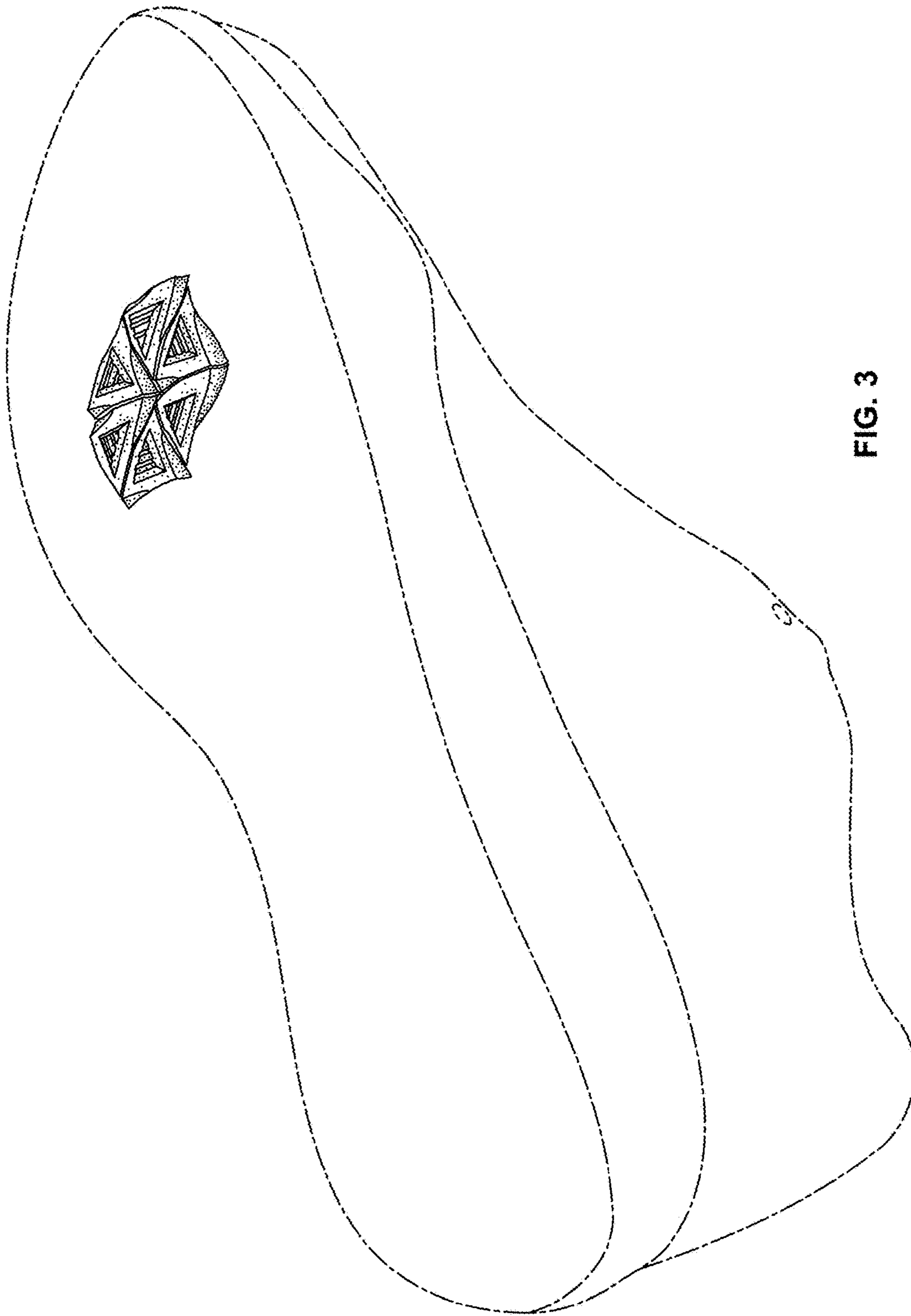

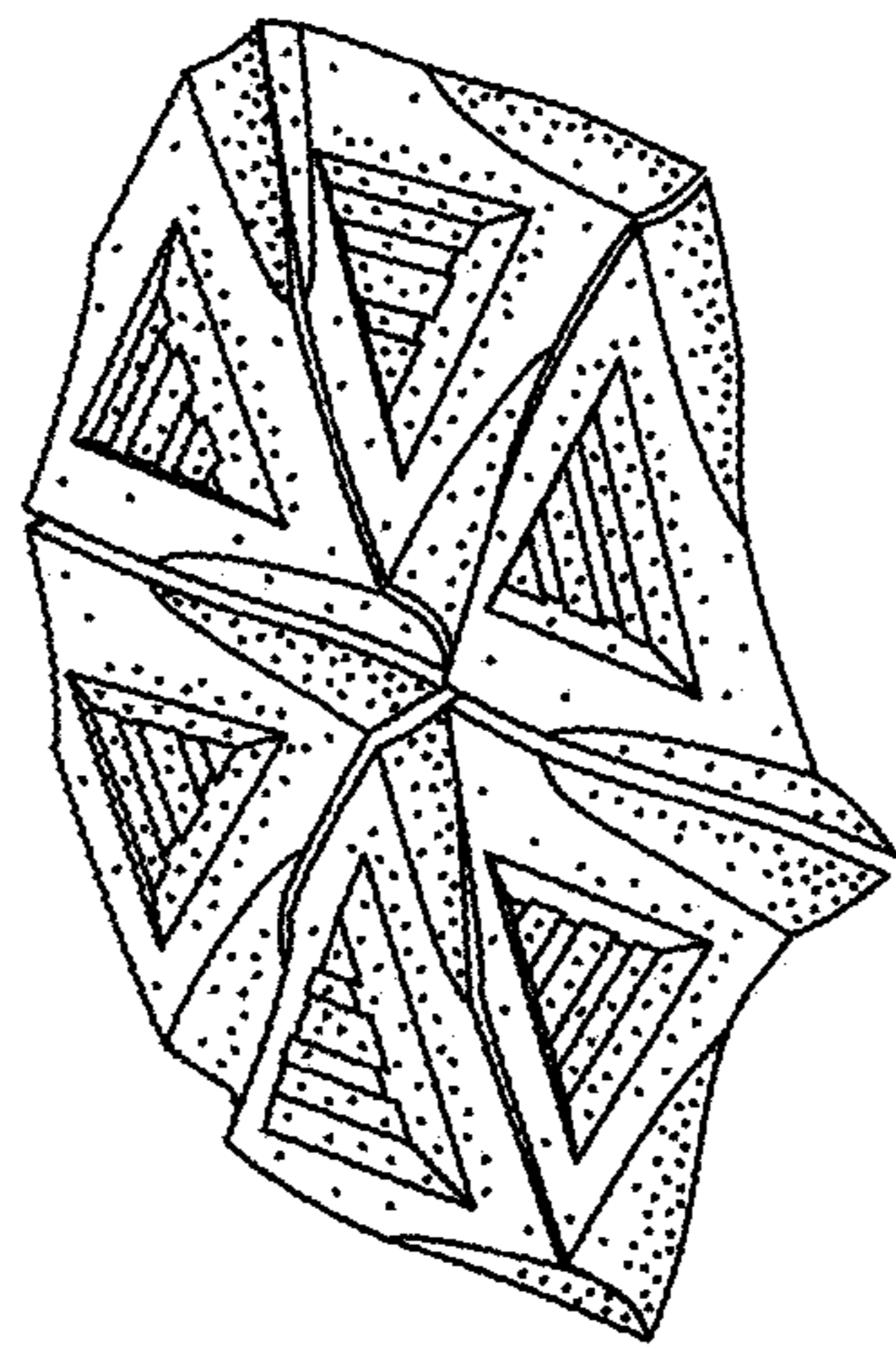

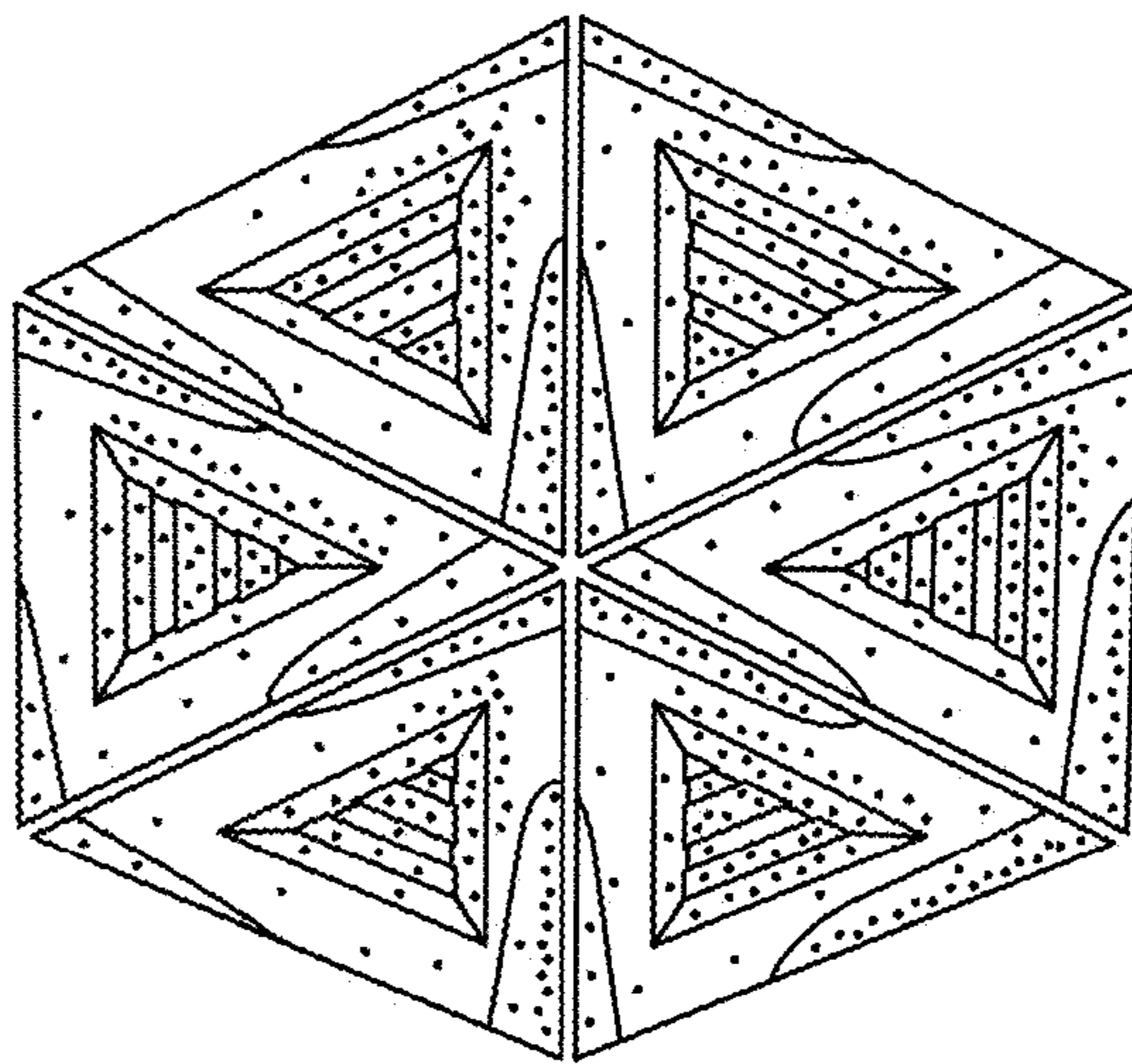

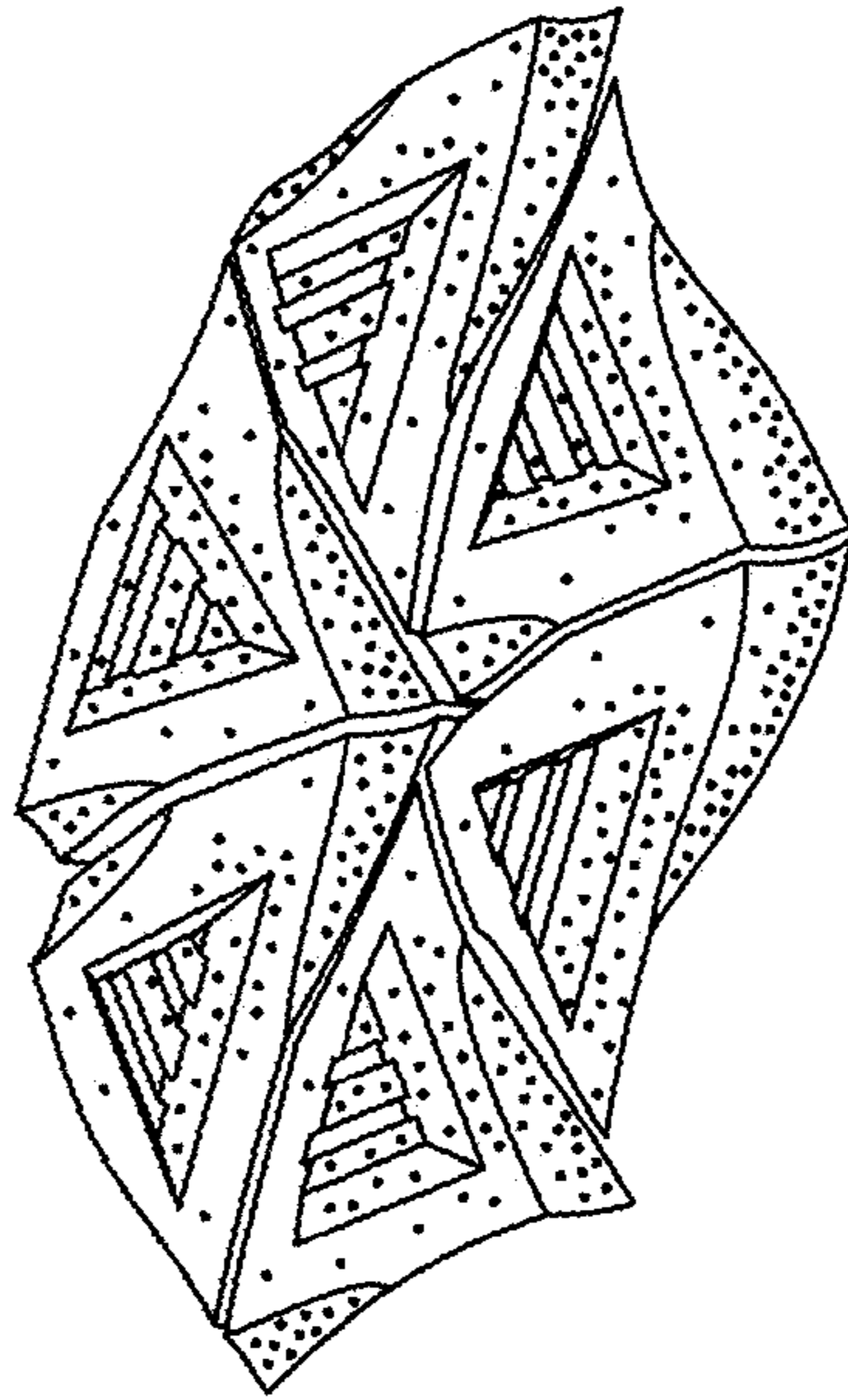
