DESCRIPTION

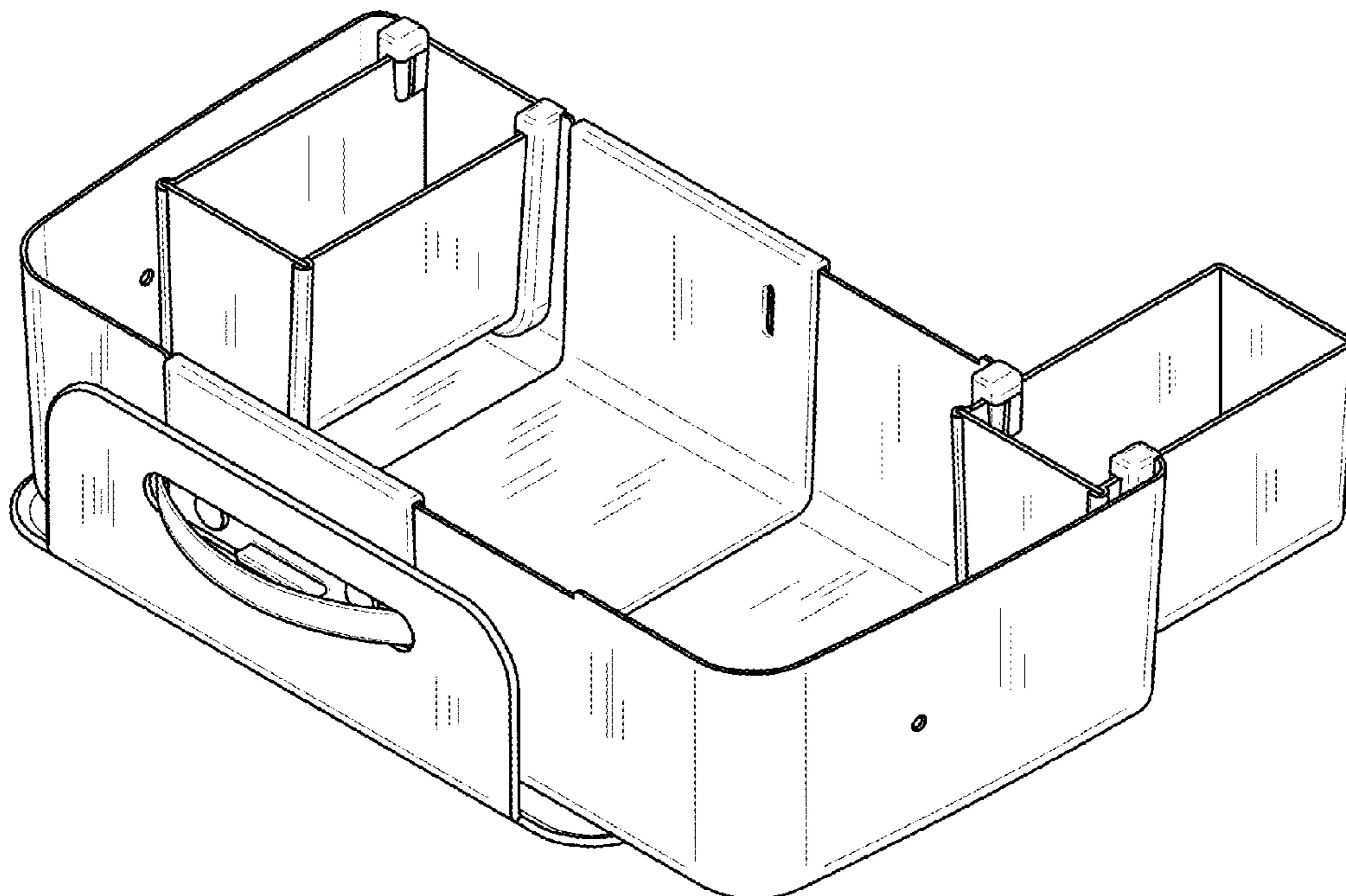
FIG. 1 is a perspective view of article holding tray in full lines.

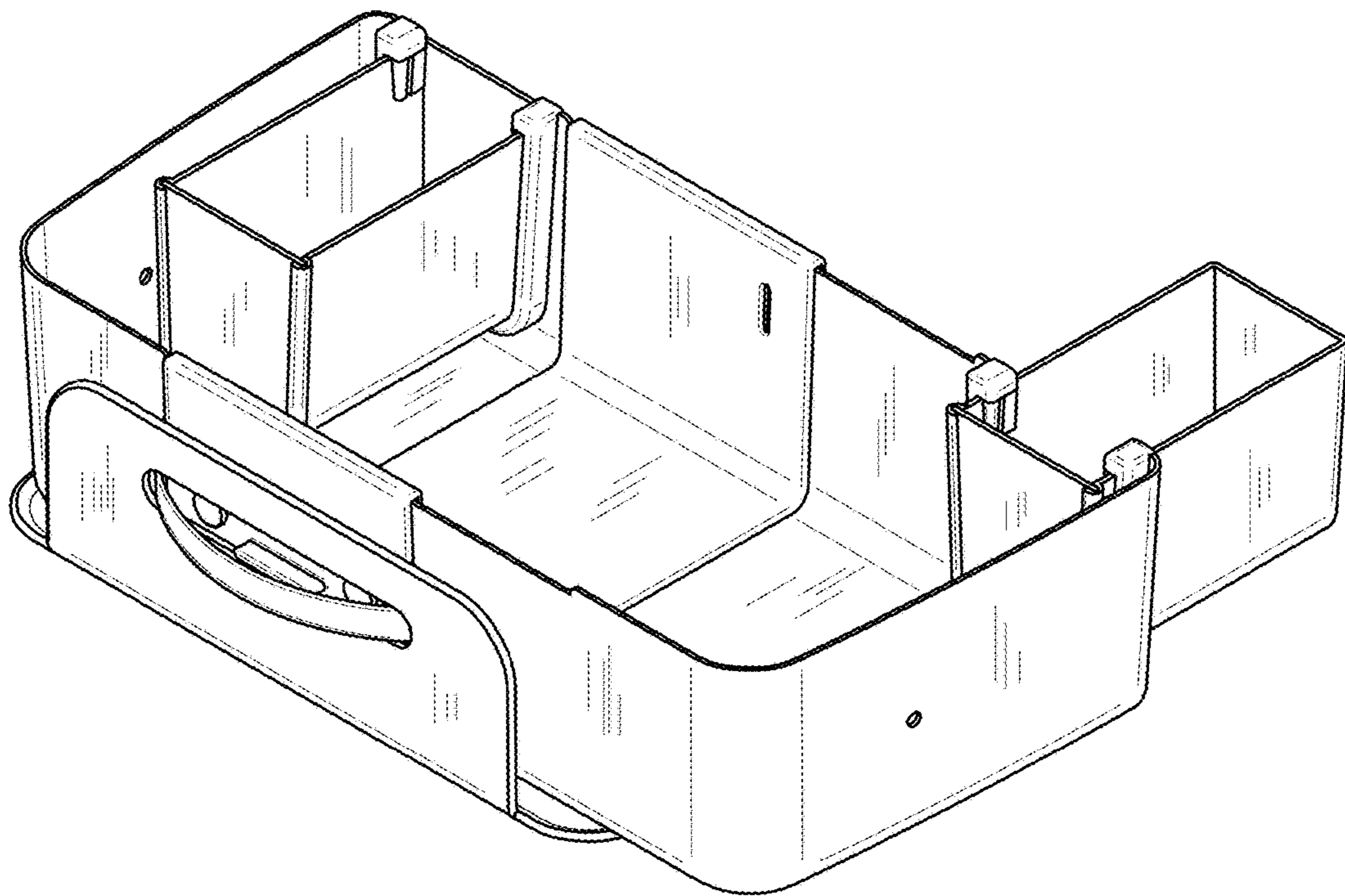

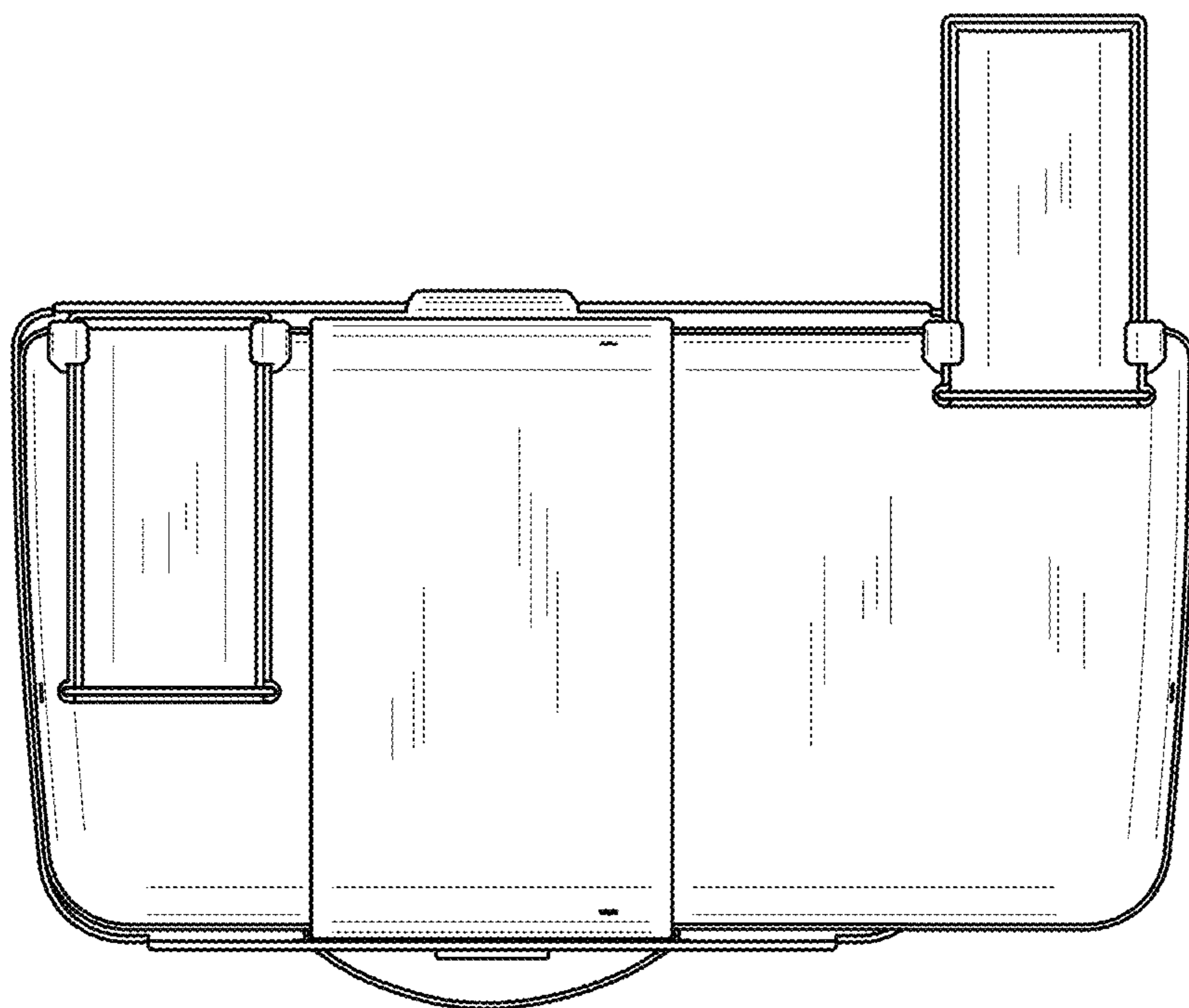

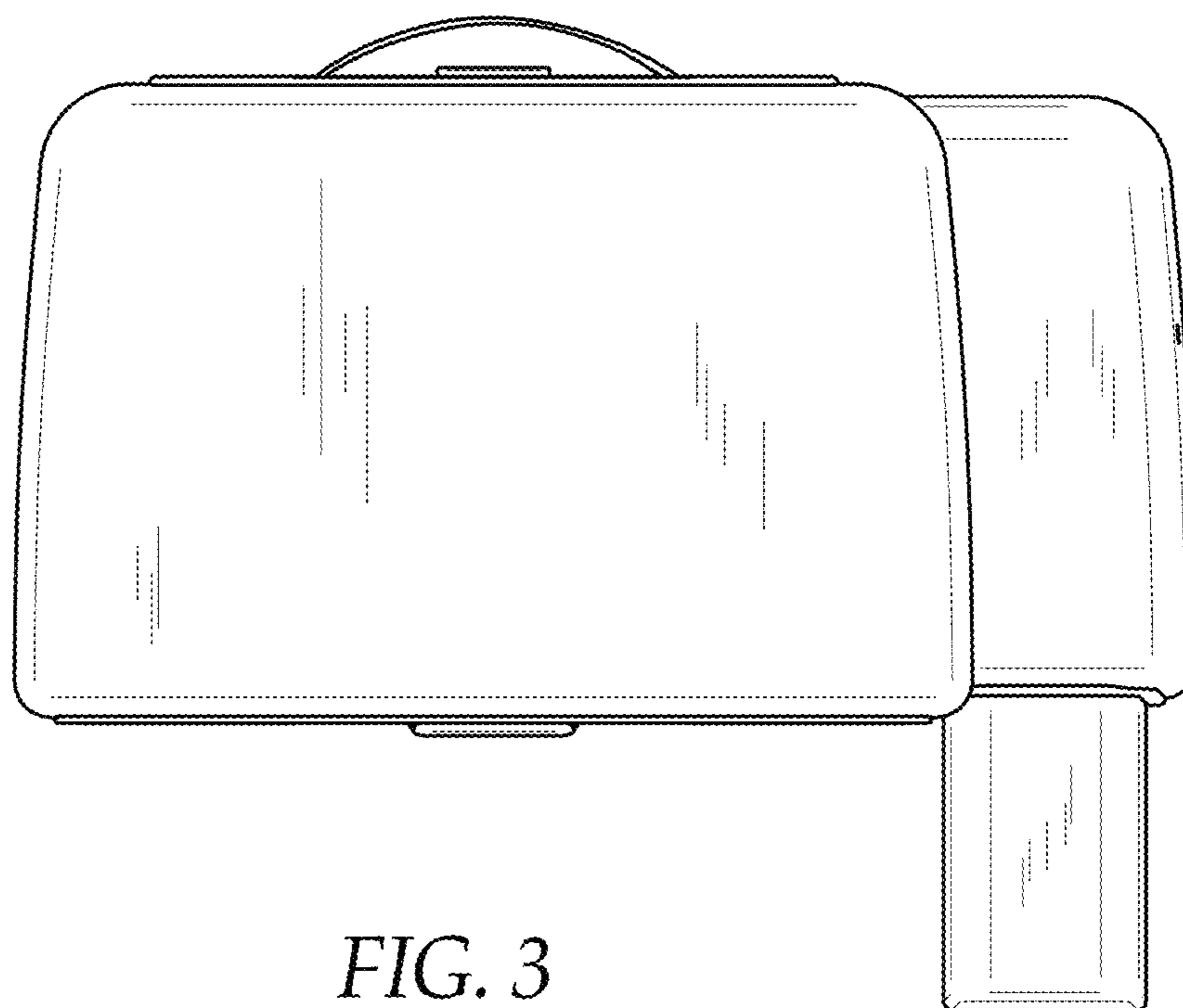

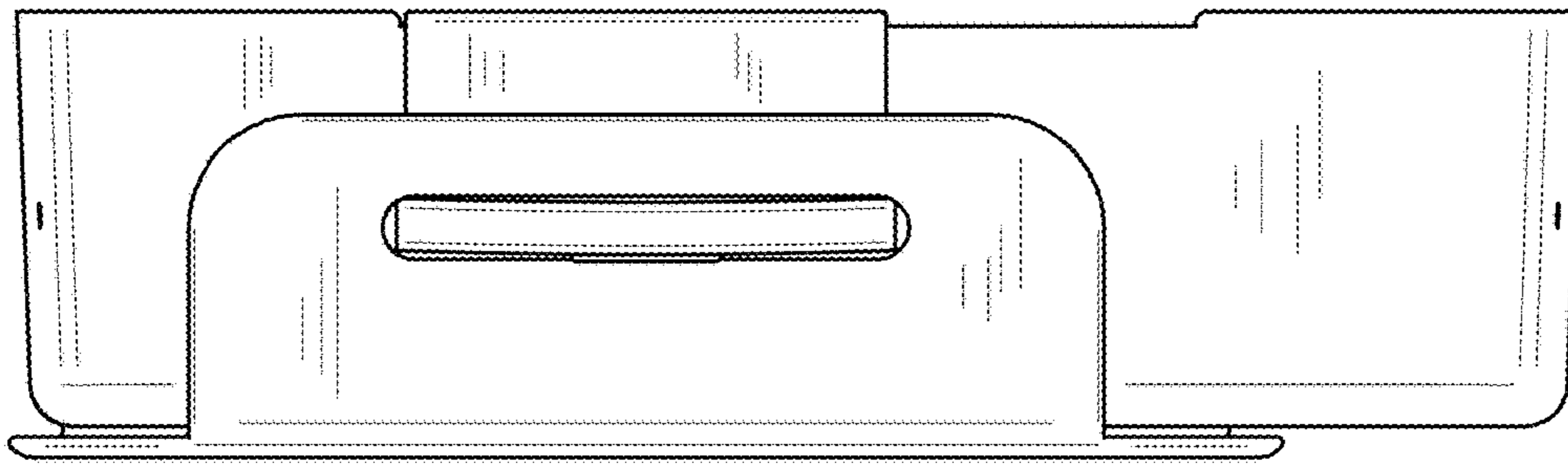

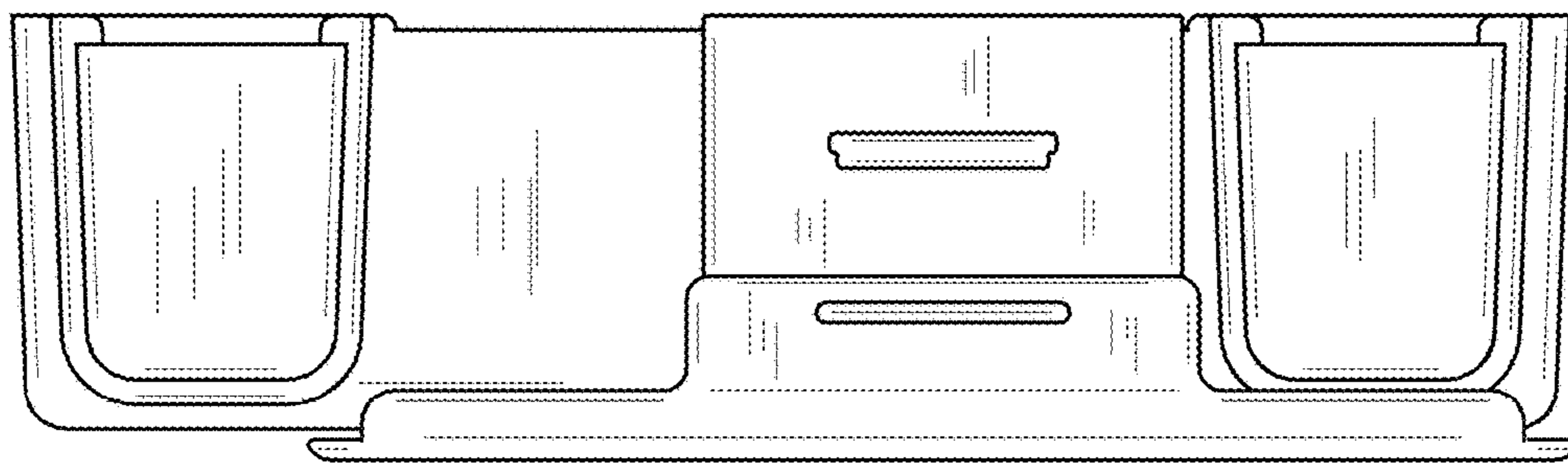

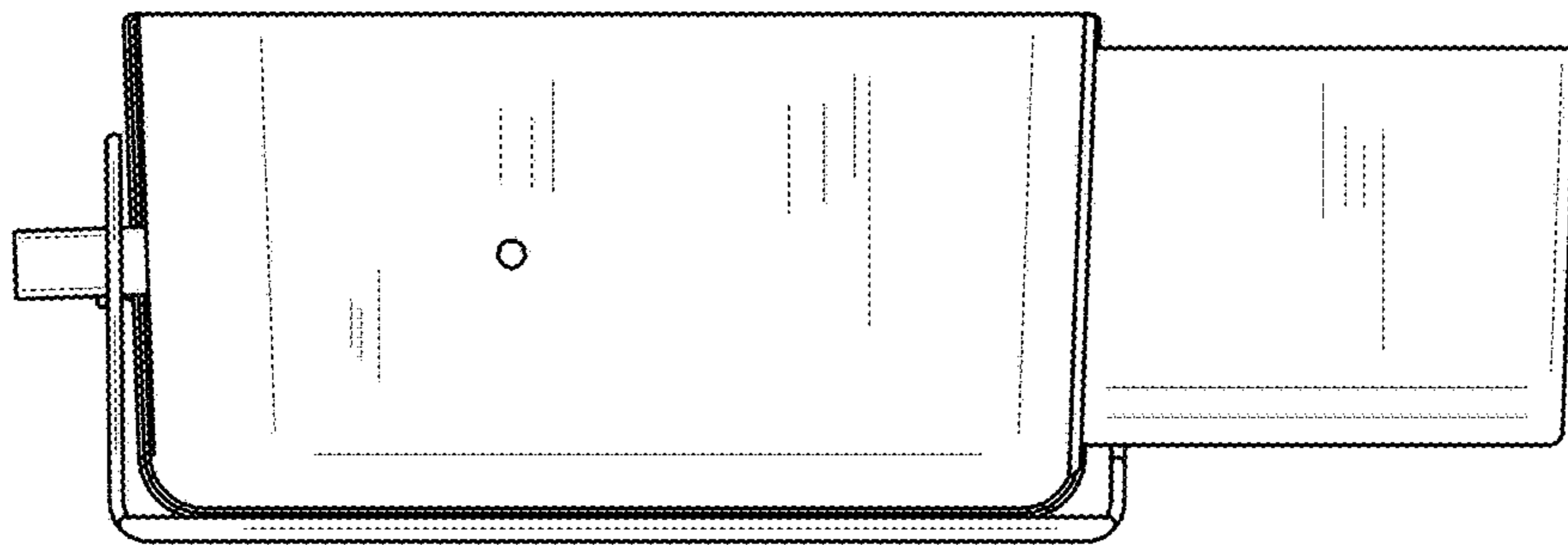

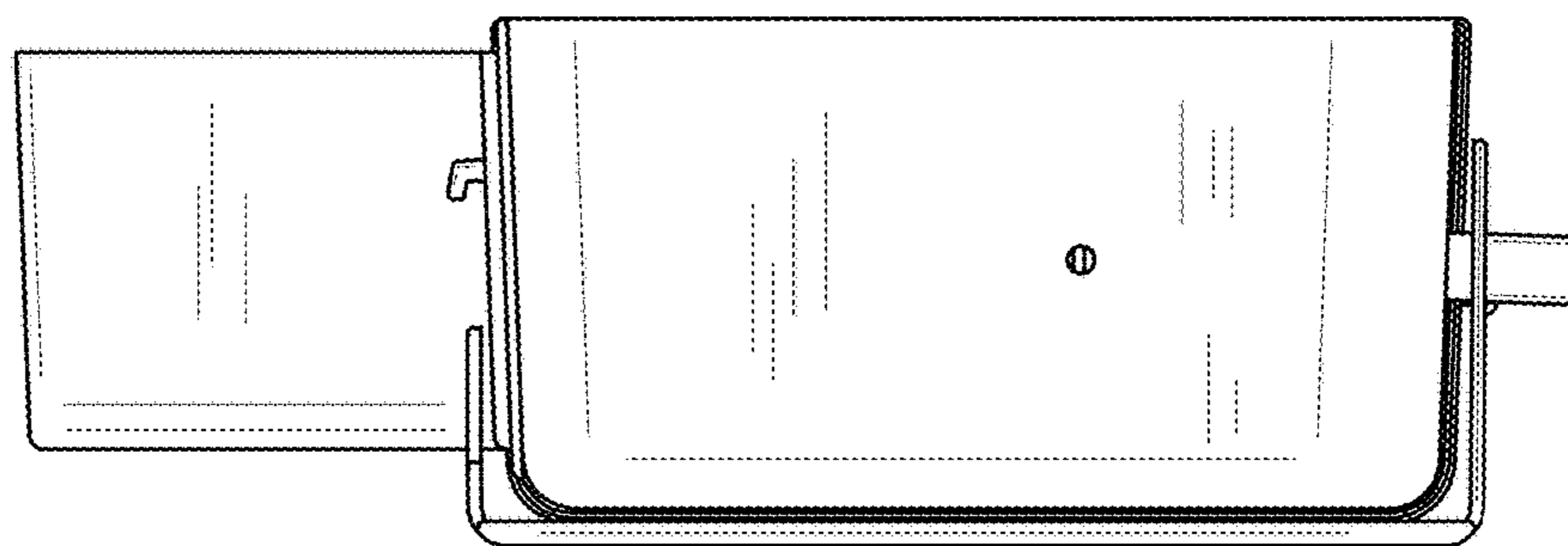
