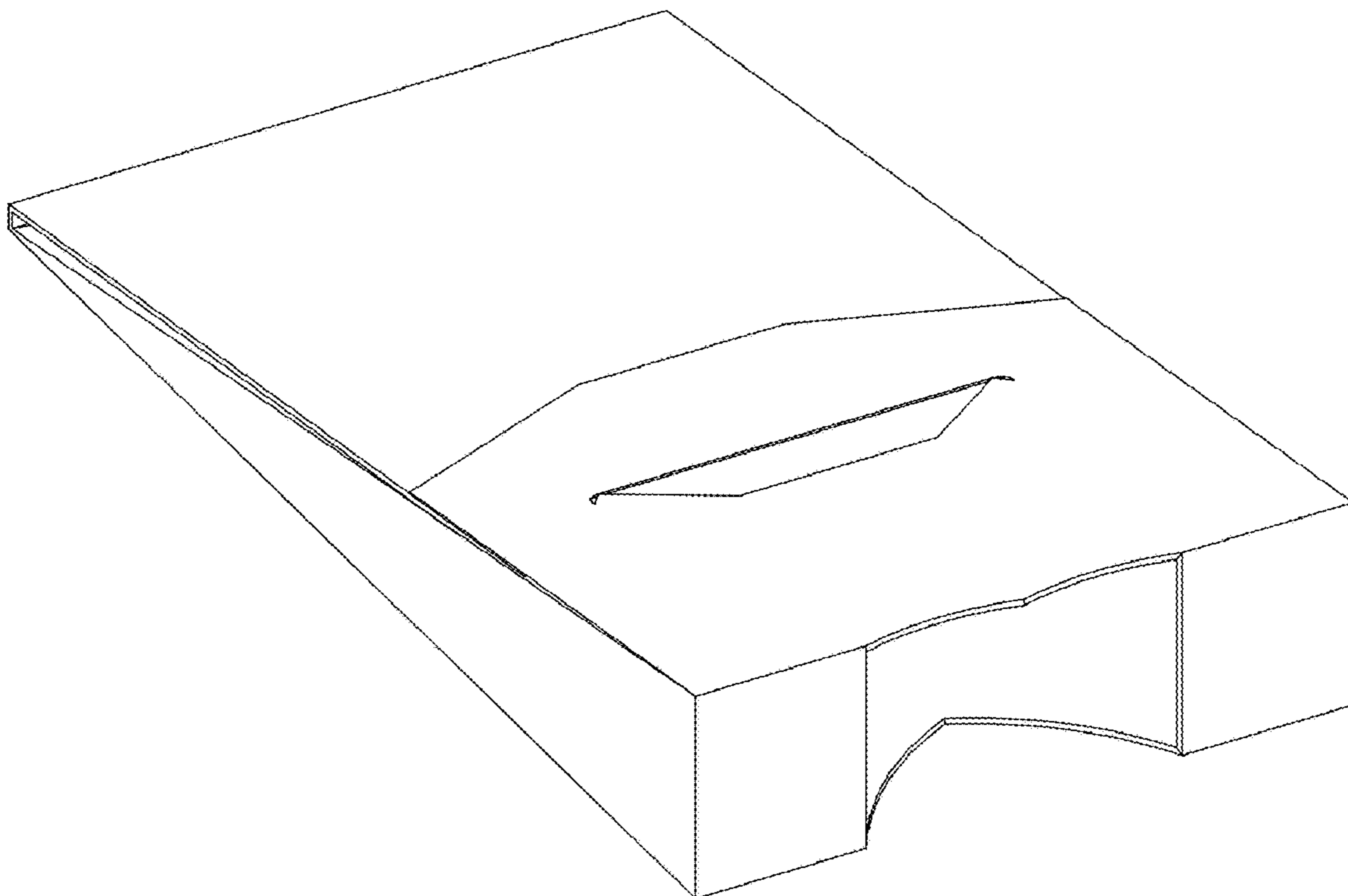
(57) **CLAIM**

I claim the ornamental design for the paintbrush cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the paintbrush cover showing my new design;
FIG. 2 is a left-side view of the paintbrush cover;

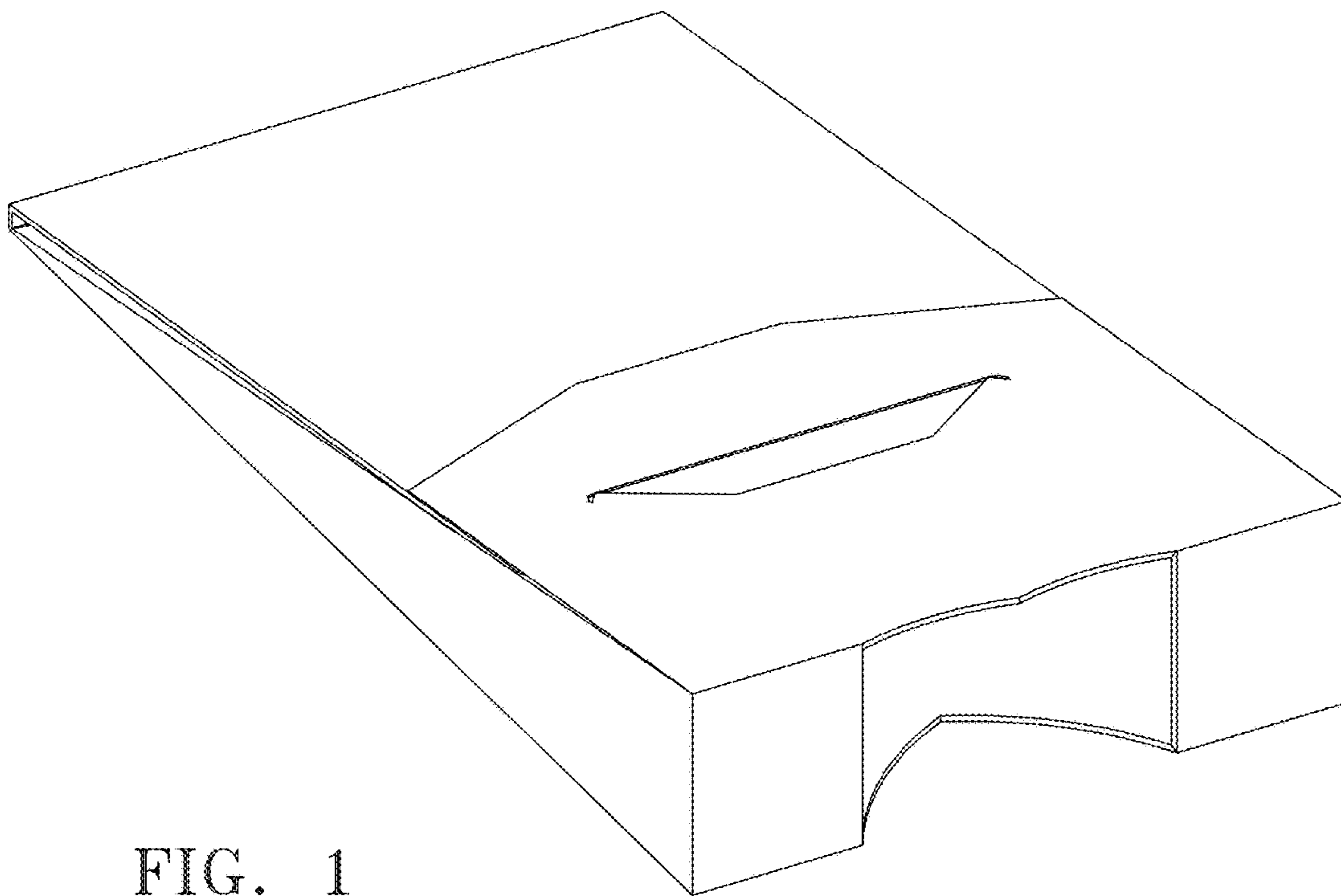

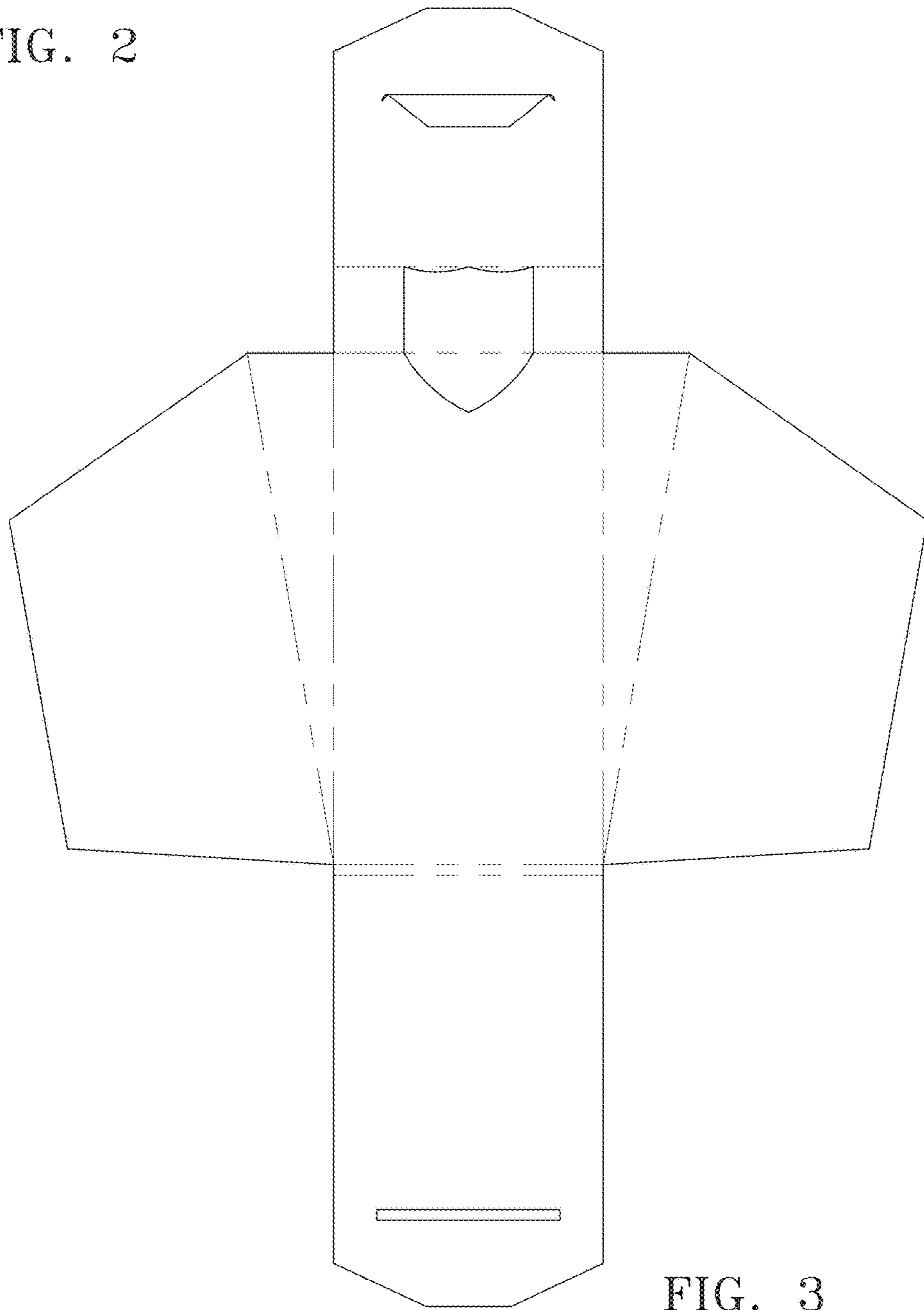

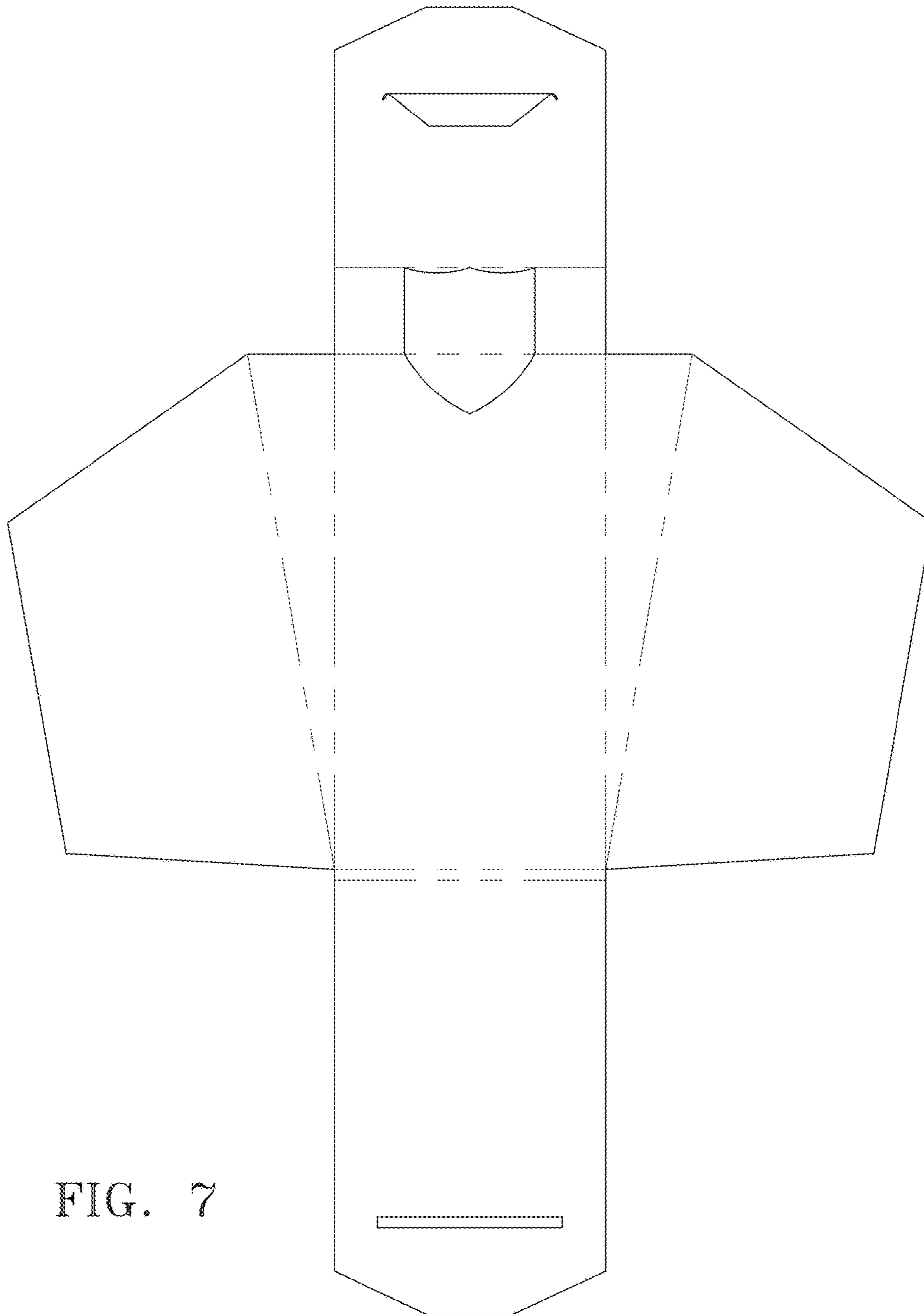
