(57) **CLAIM**

The ornamental design for a display structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display structure with a divider portion thereof shown in a first position according to the design;

FIG. 2 is another front view of the display structure of FIG. 1 with the divider portion thereof shown in a second position;

FIG. 3 is a right side view of the display structure of FIG. 1;

FIG. 4 is a left side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a left side top perspective view thereof, the right side top perspective view being a mirror image of FIG. 6; FIG. 7 is a right side bottom perspective view thereof, the left side bottom perspective view being a mirror image of FIG. 7;

FIG. 8 is an enlarged fragmentary left side top perspective view of the divider portion of FIG. 1 with side panels thereof shown in an opened position;

FIG. 9 is another enlarged fragmentary left side top perspective view of the divider portion of FIG. 1 with the side panels thereof shown in a closed position;

FIG. 10 is a front view of the divider portion of FIG. 8;

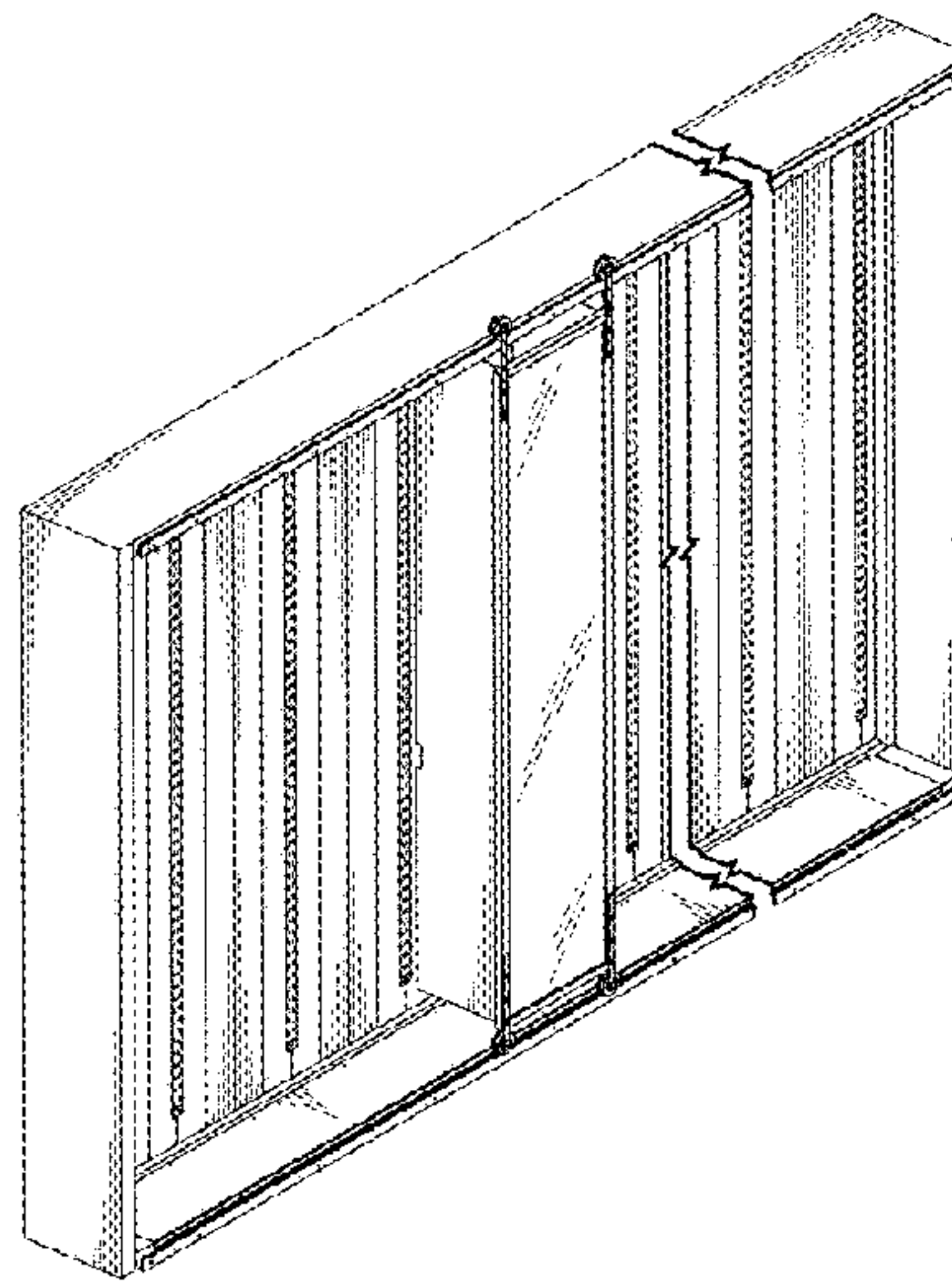
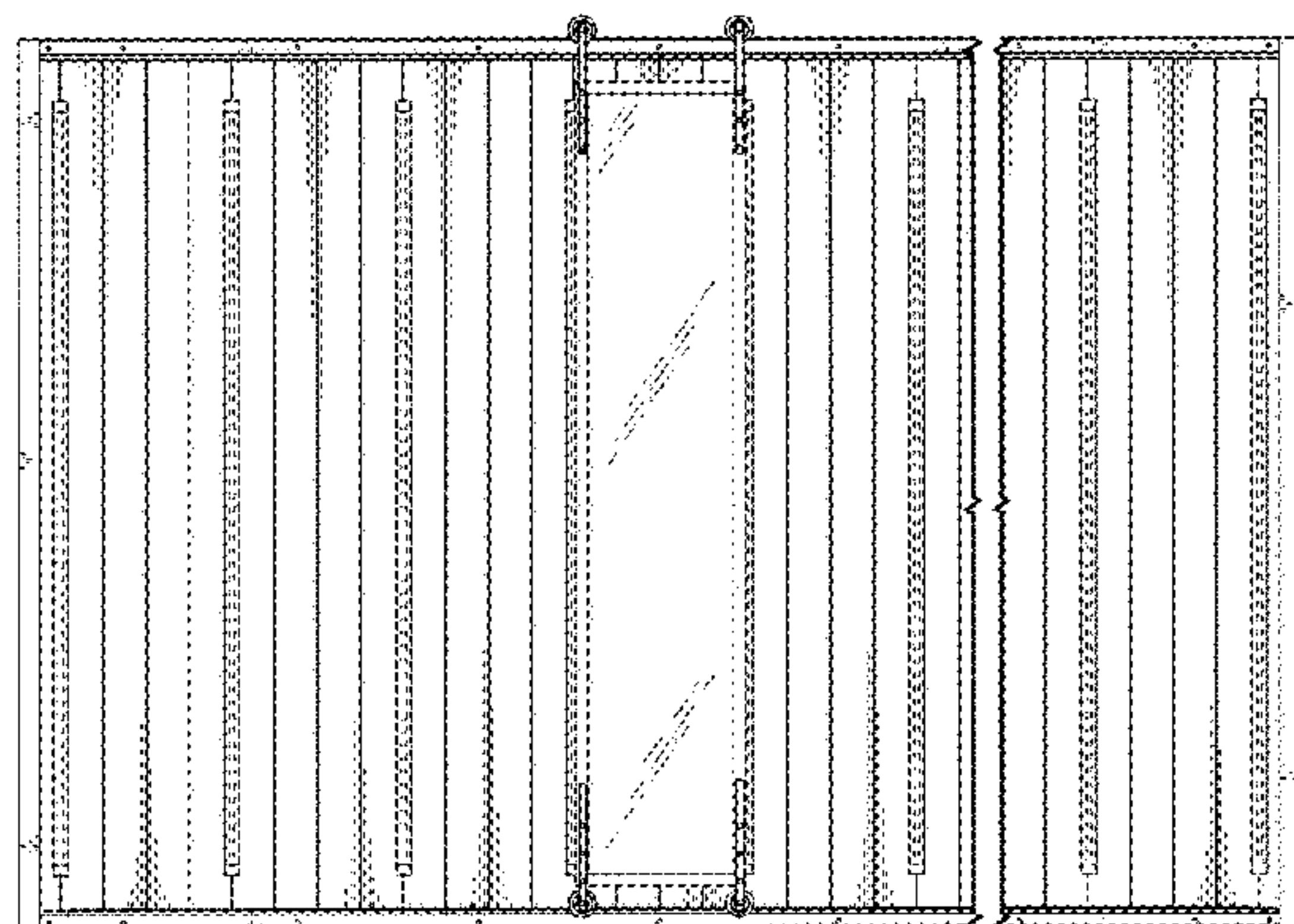
FIG. 11 is a right side view thereof;

FIG. 12 is a left side view thereof; and,

FIG. 13 is a top view thereof.

The claimed design is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design. The thin shade lines shown on the divider portion of the display structure are for indicating a reflective or mirrored surface.

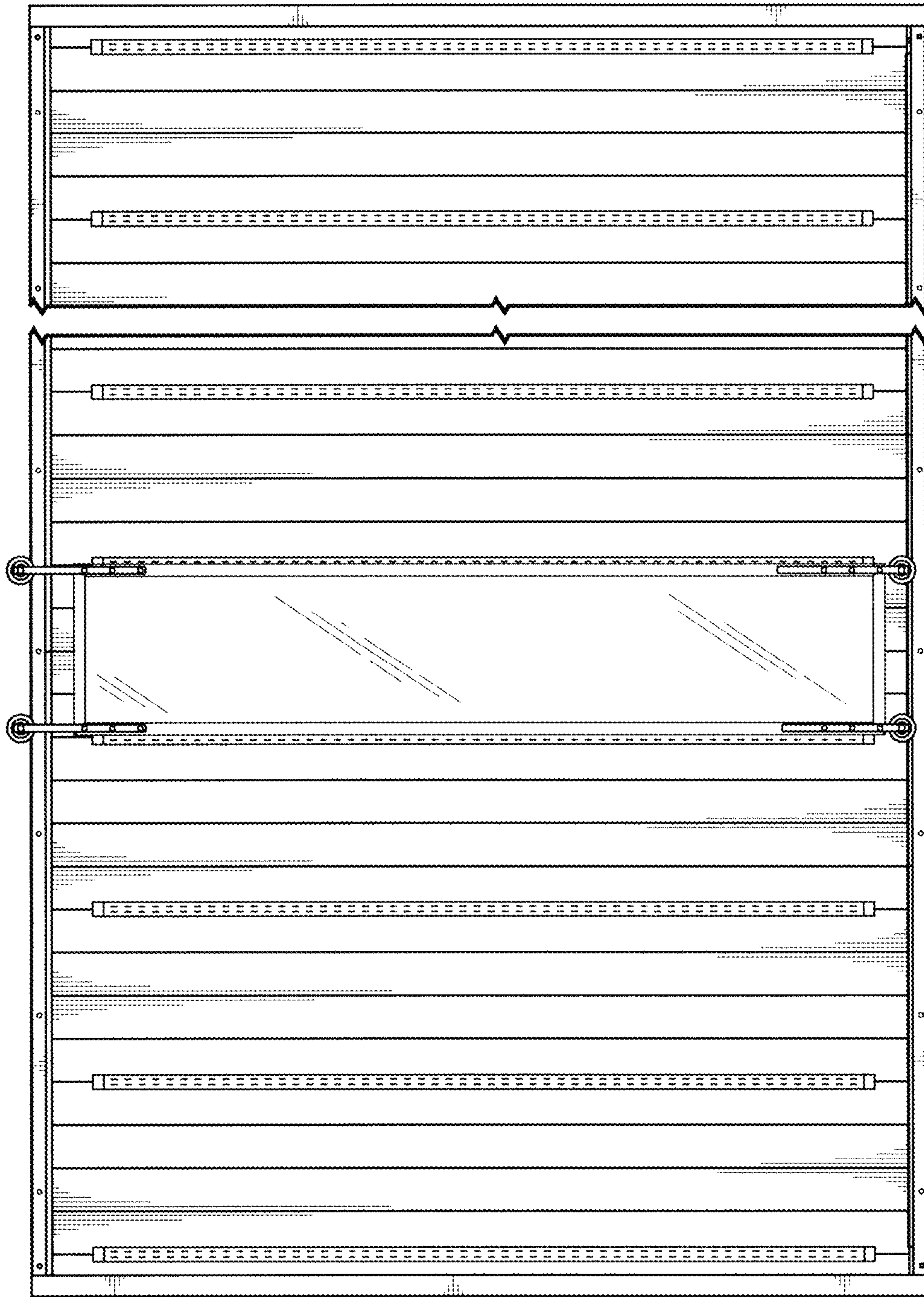

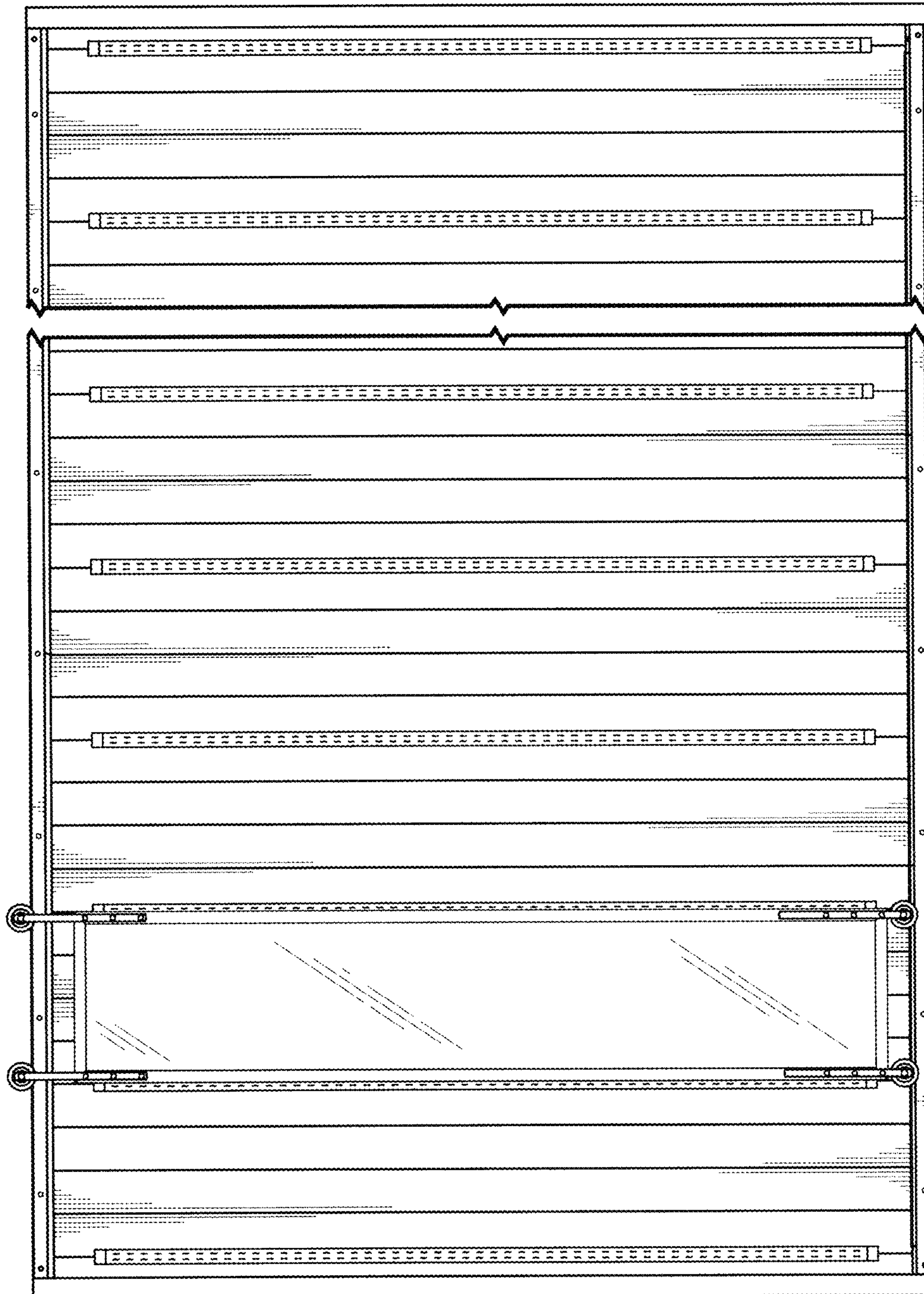

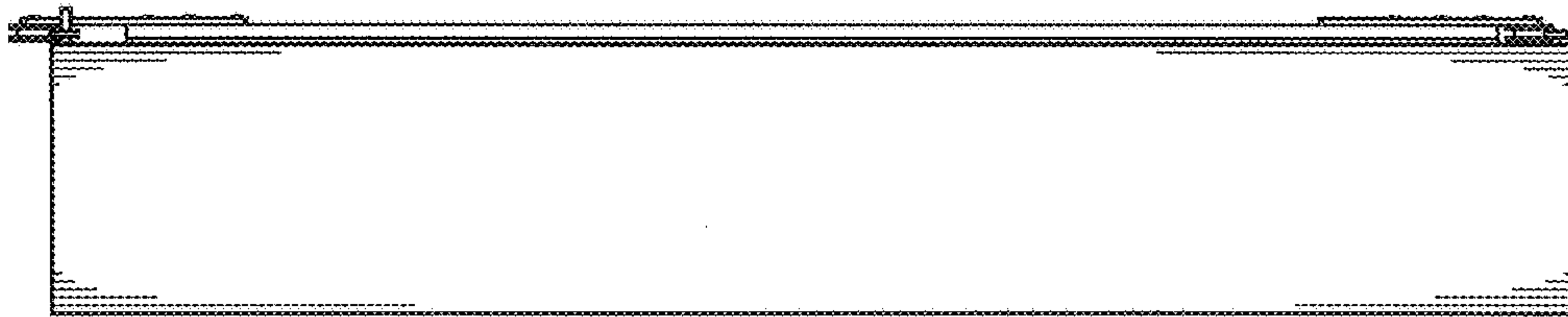

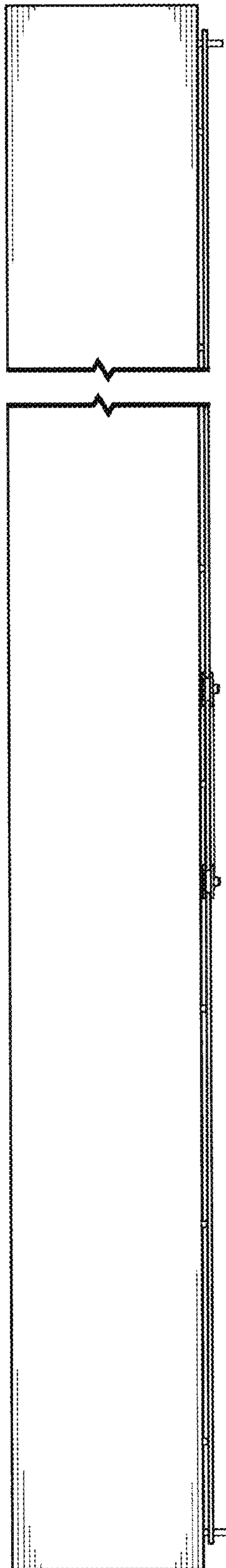

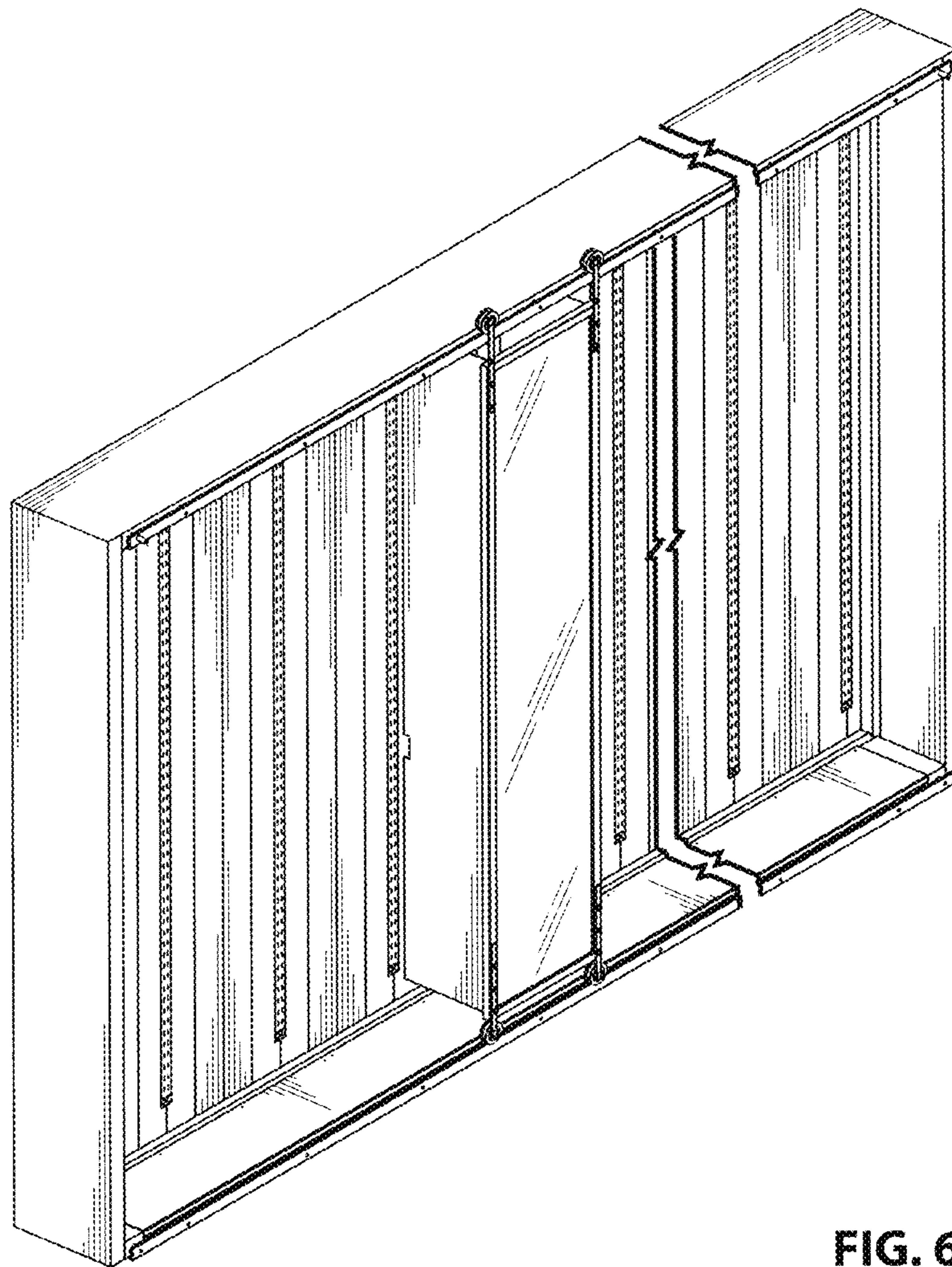

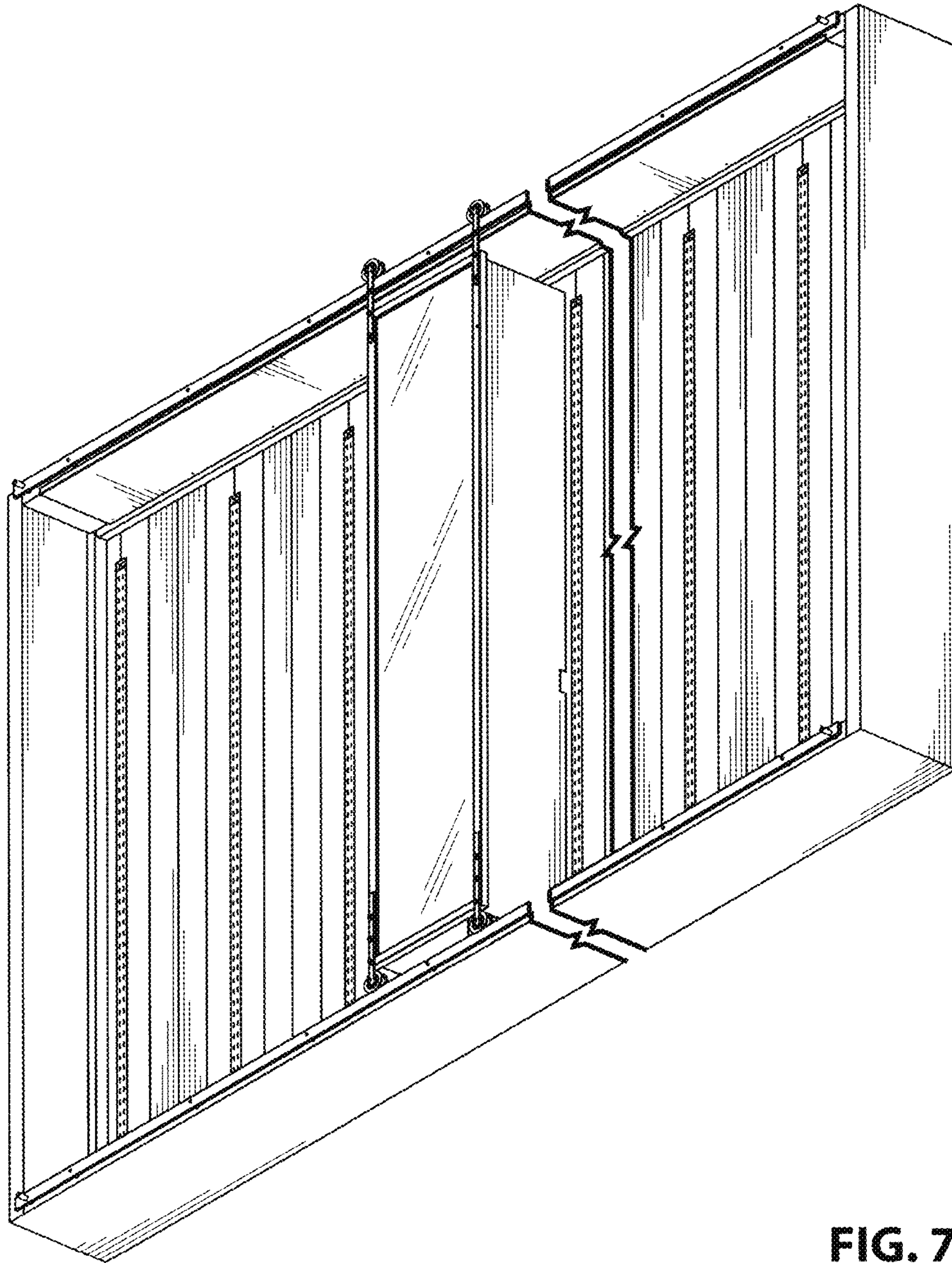

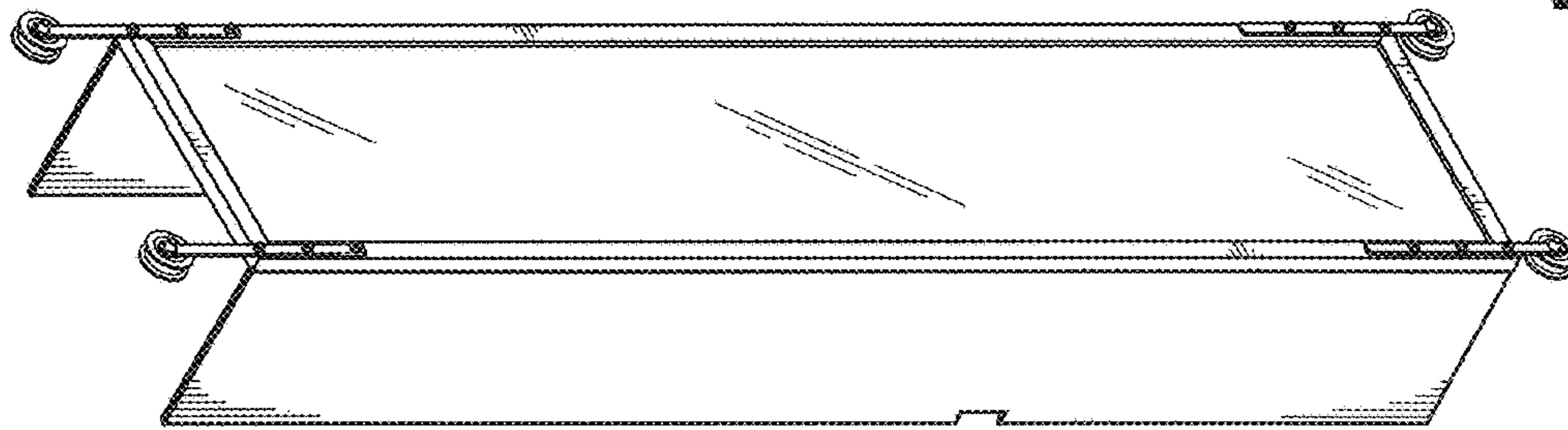

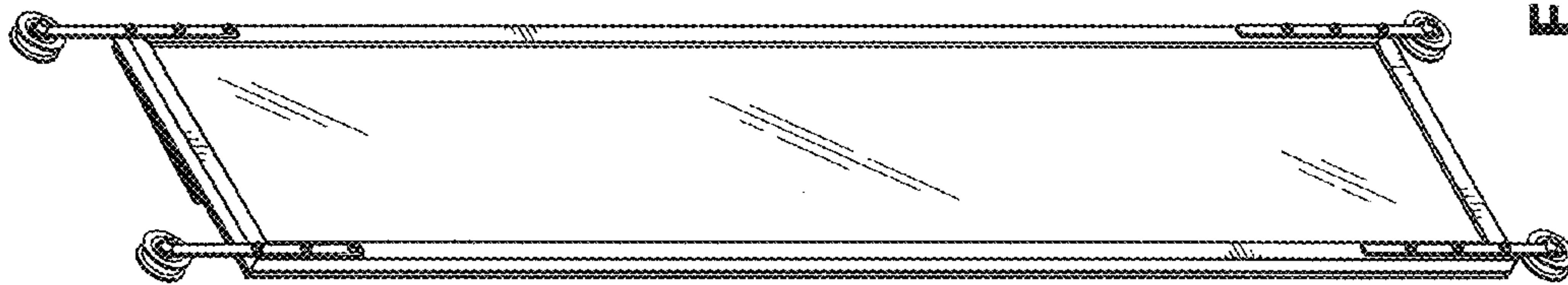

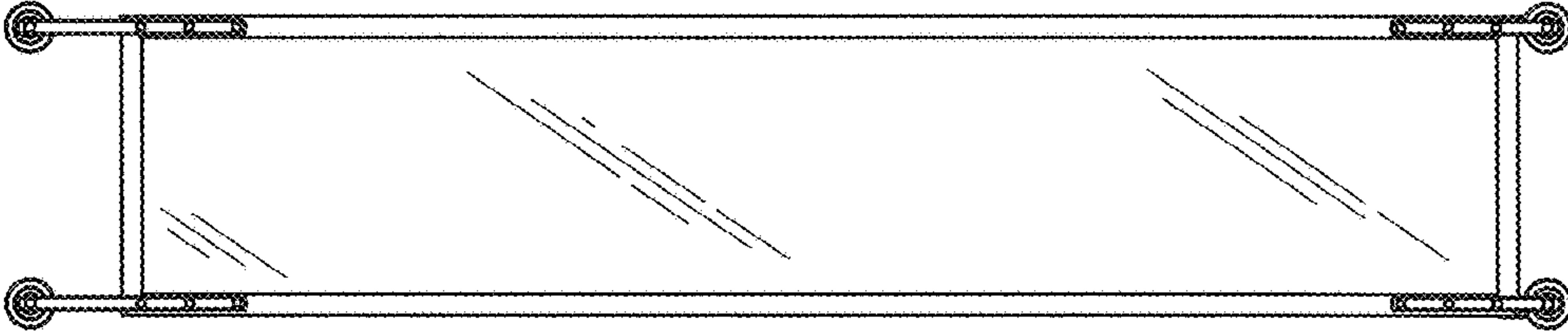

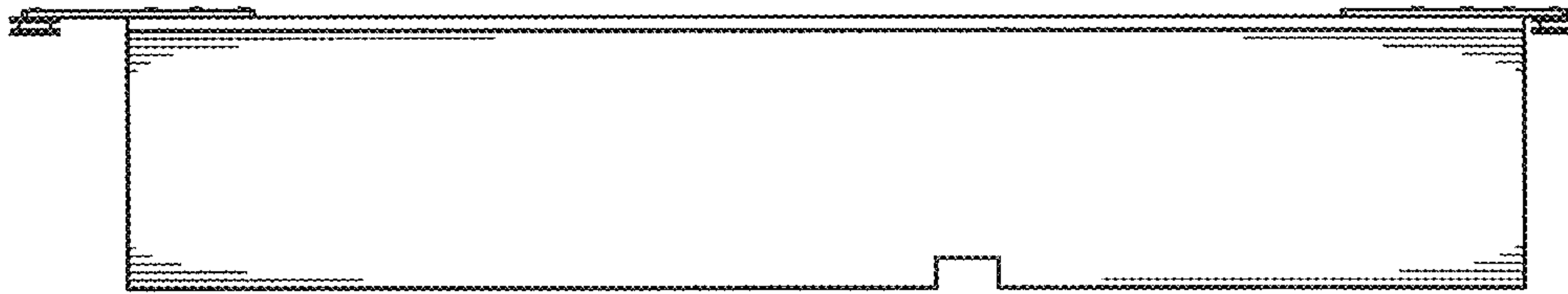

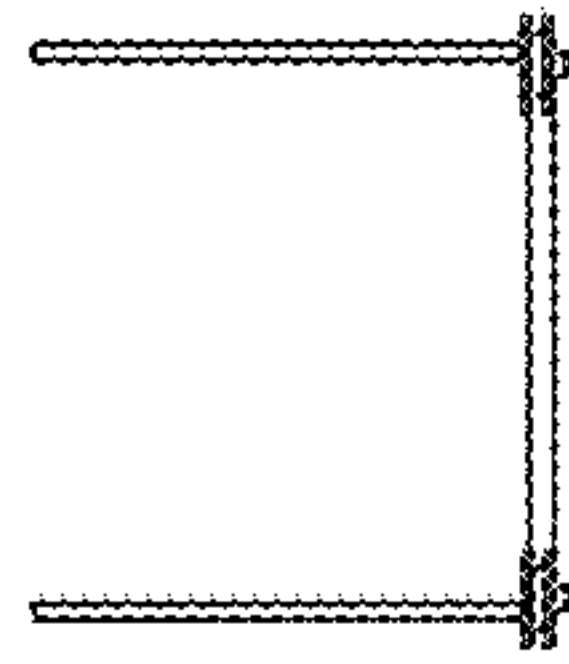
