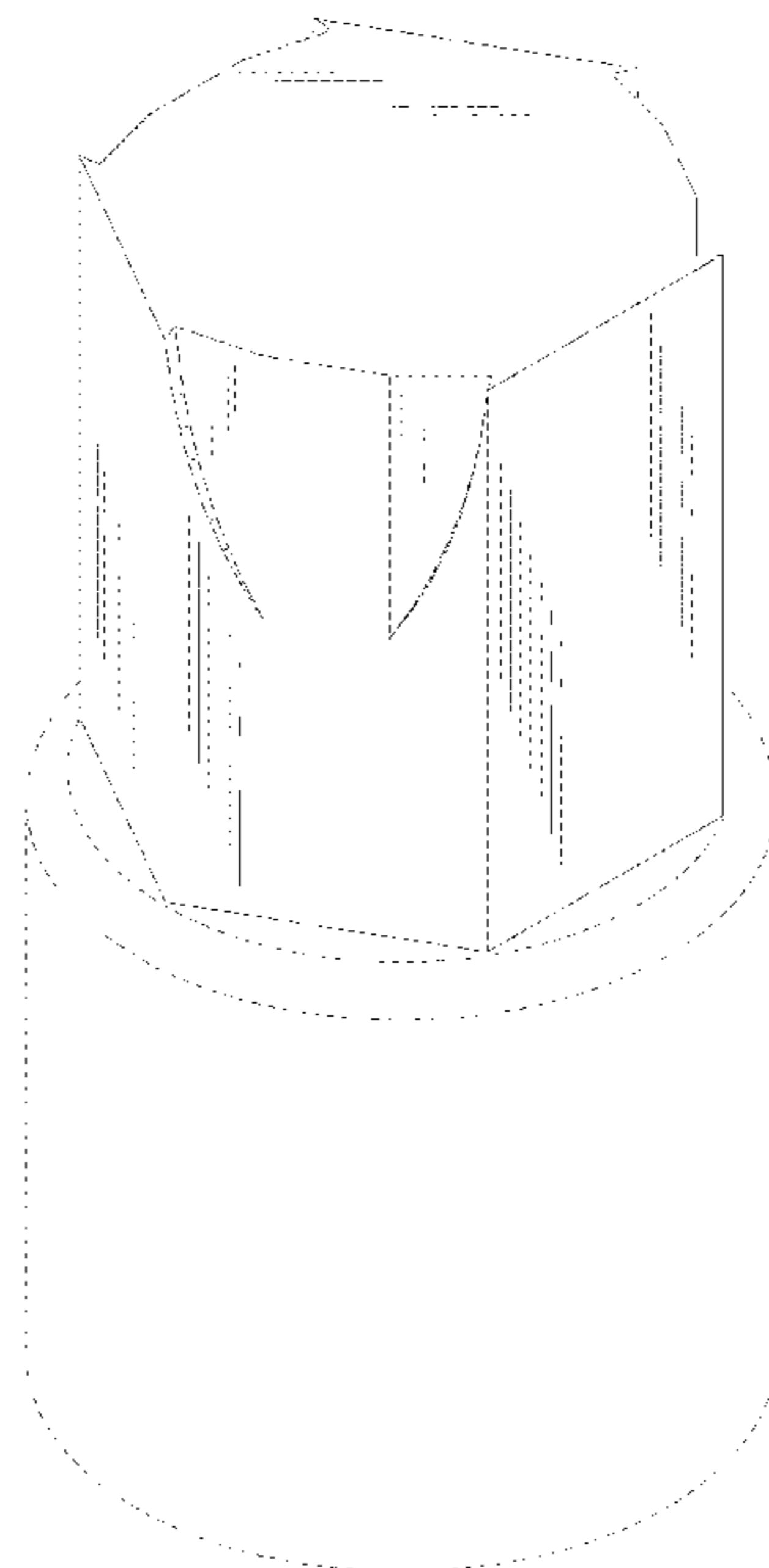
(57) **CLAIM**

The ornamental design for a bidirectional anti-slip fastener remover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bidirectional anti-slip fastener remover;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line showing an engagement interface for a torque tool is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

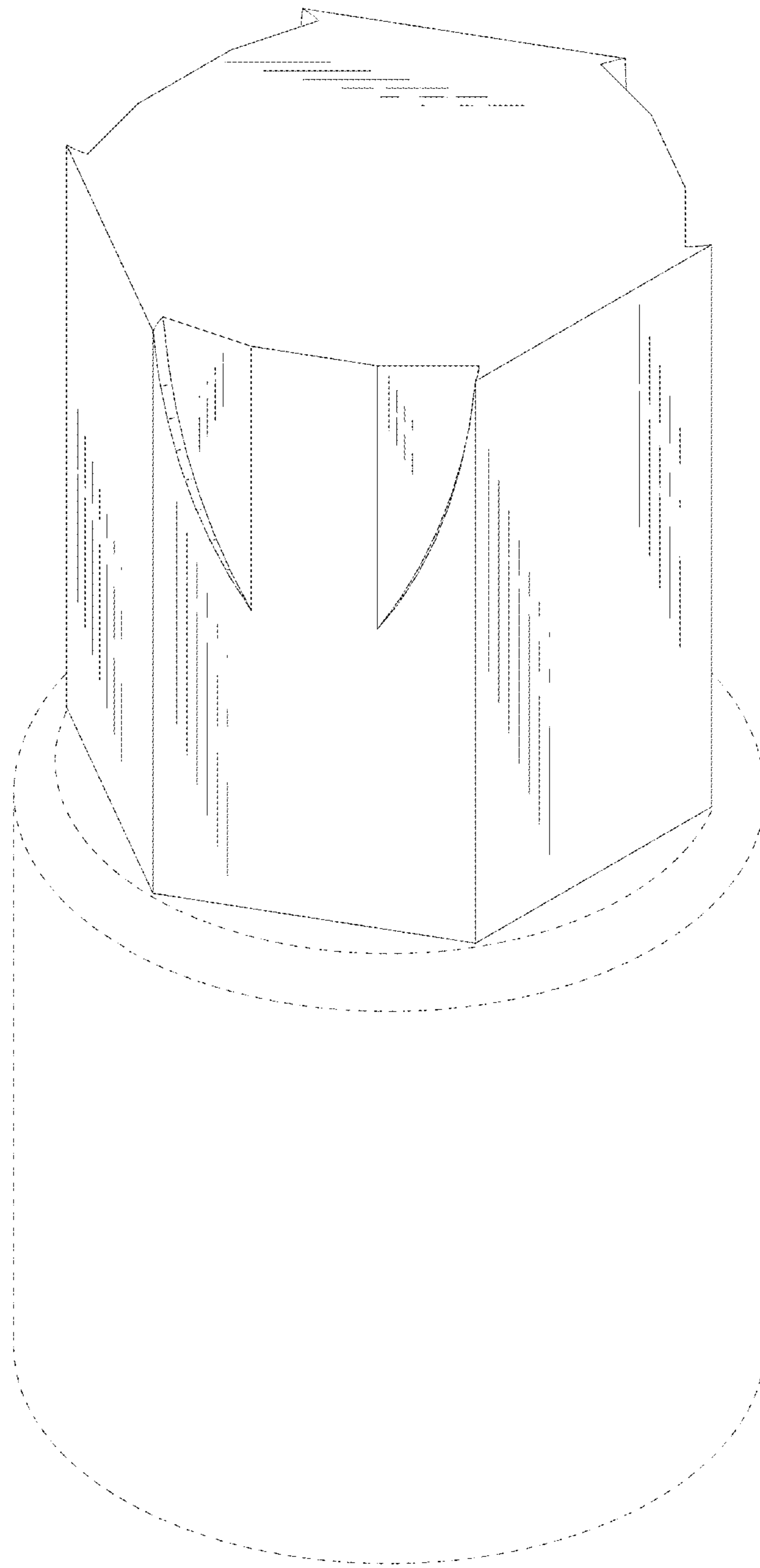

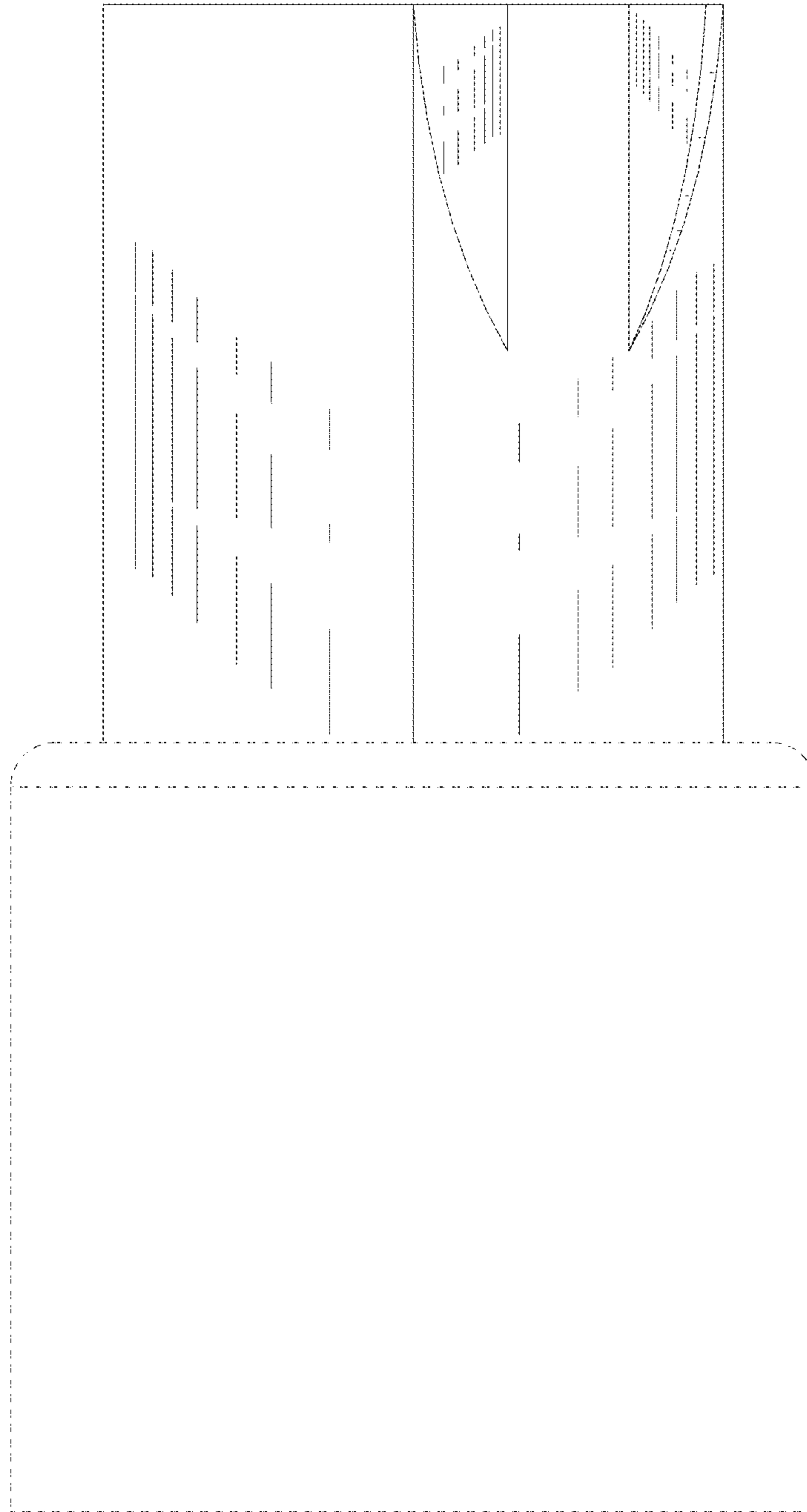

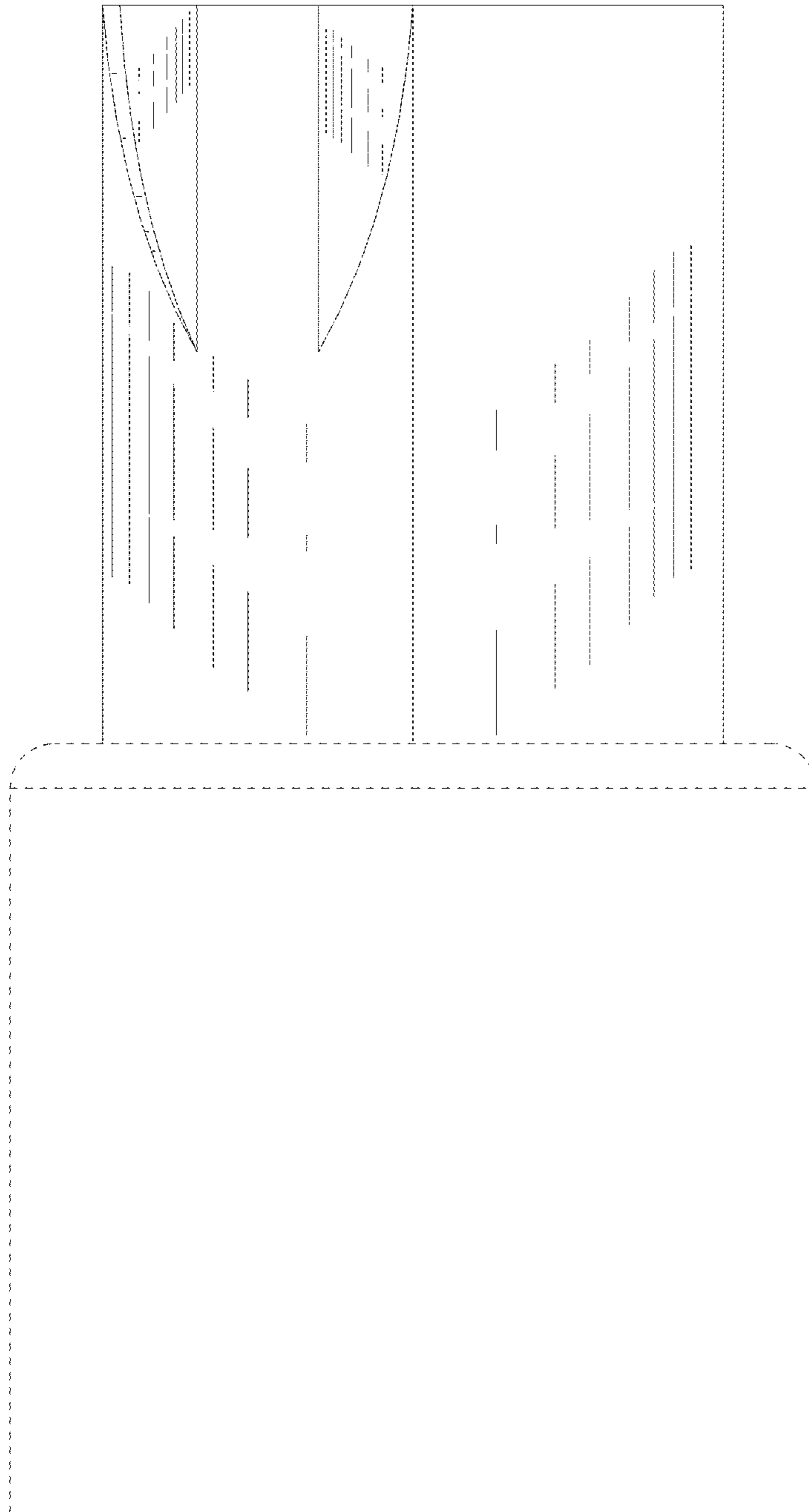

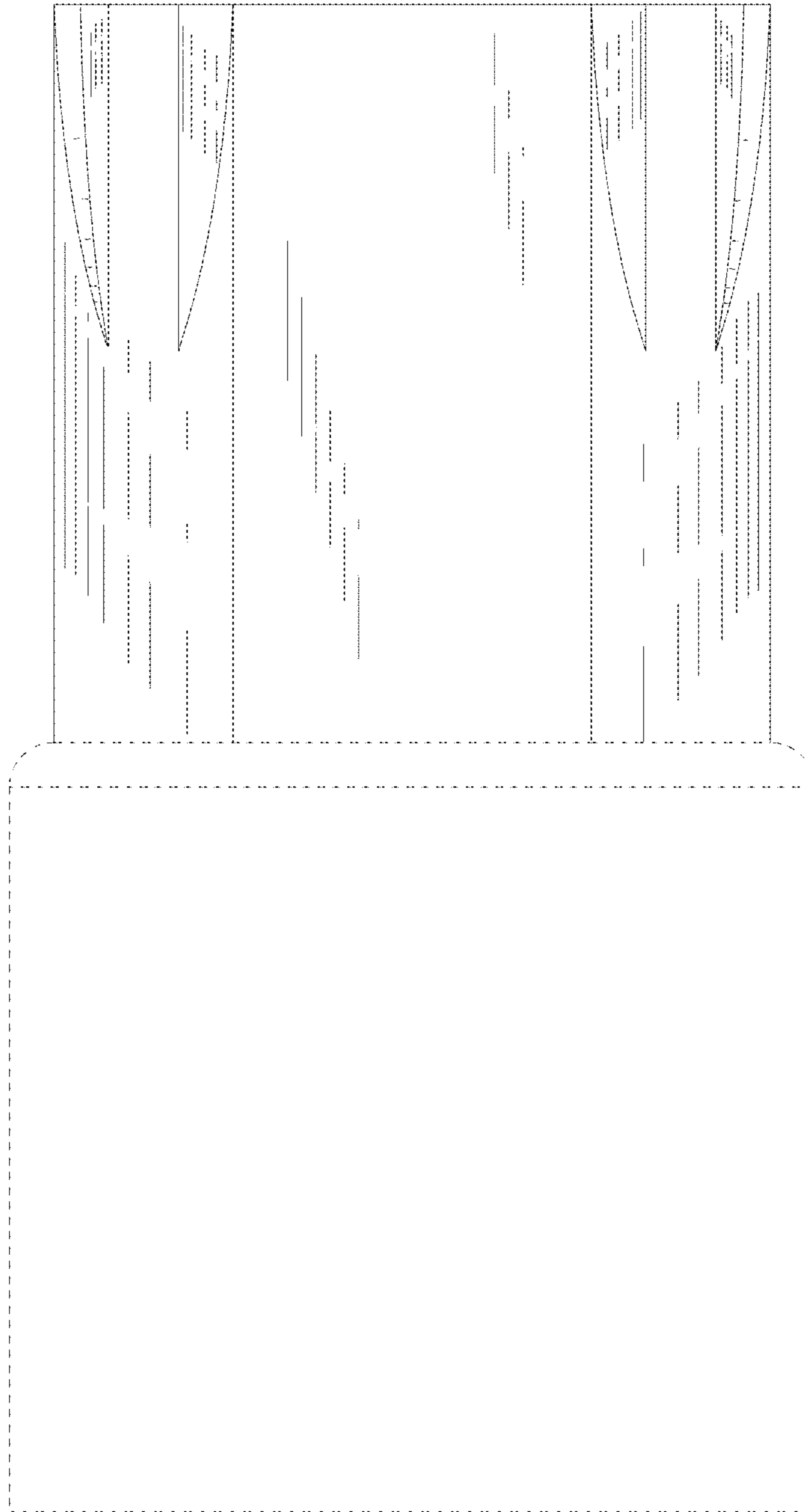

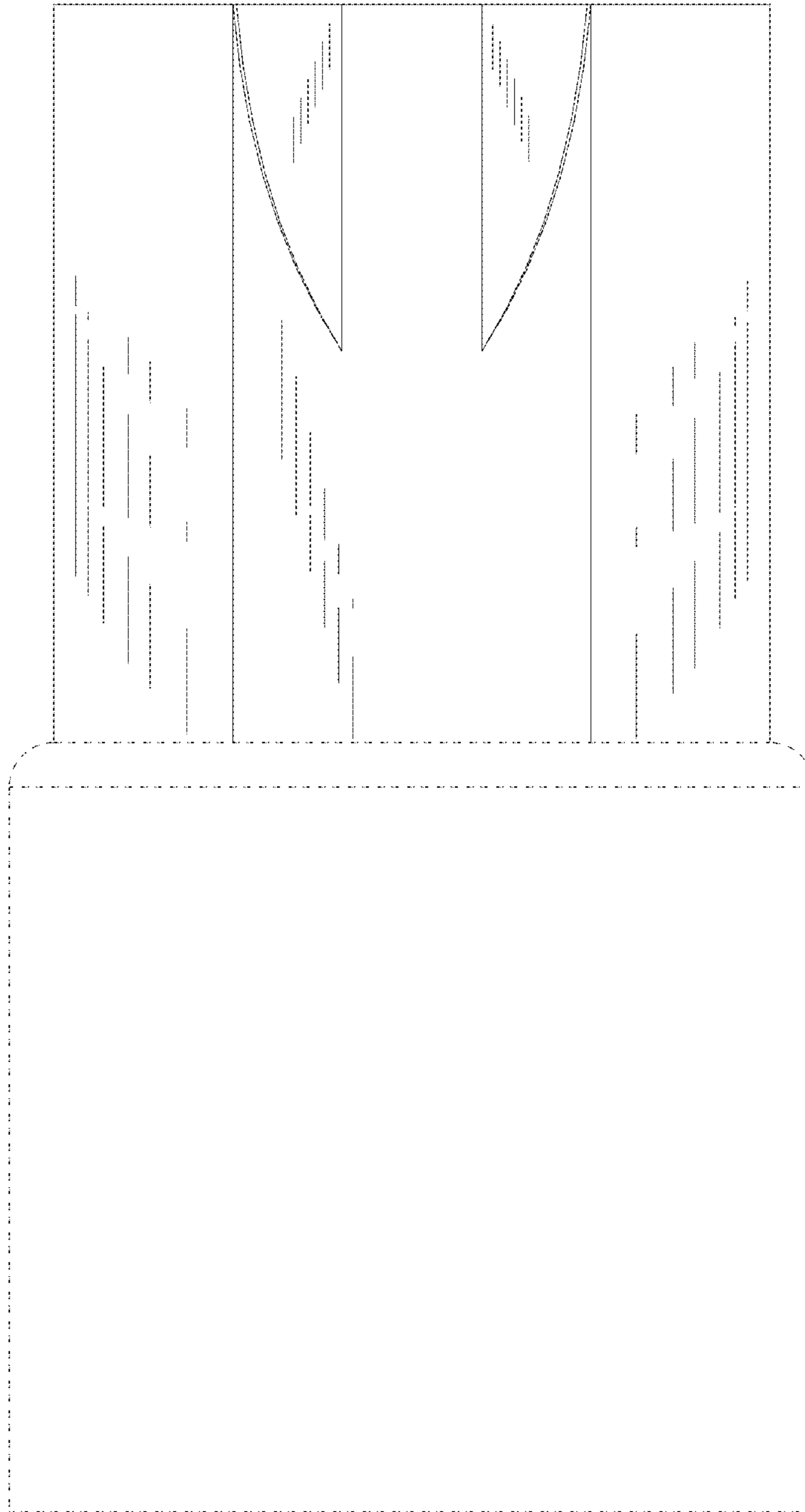

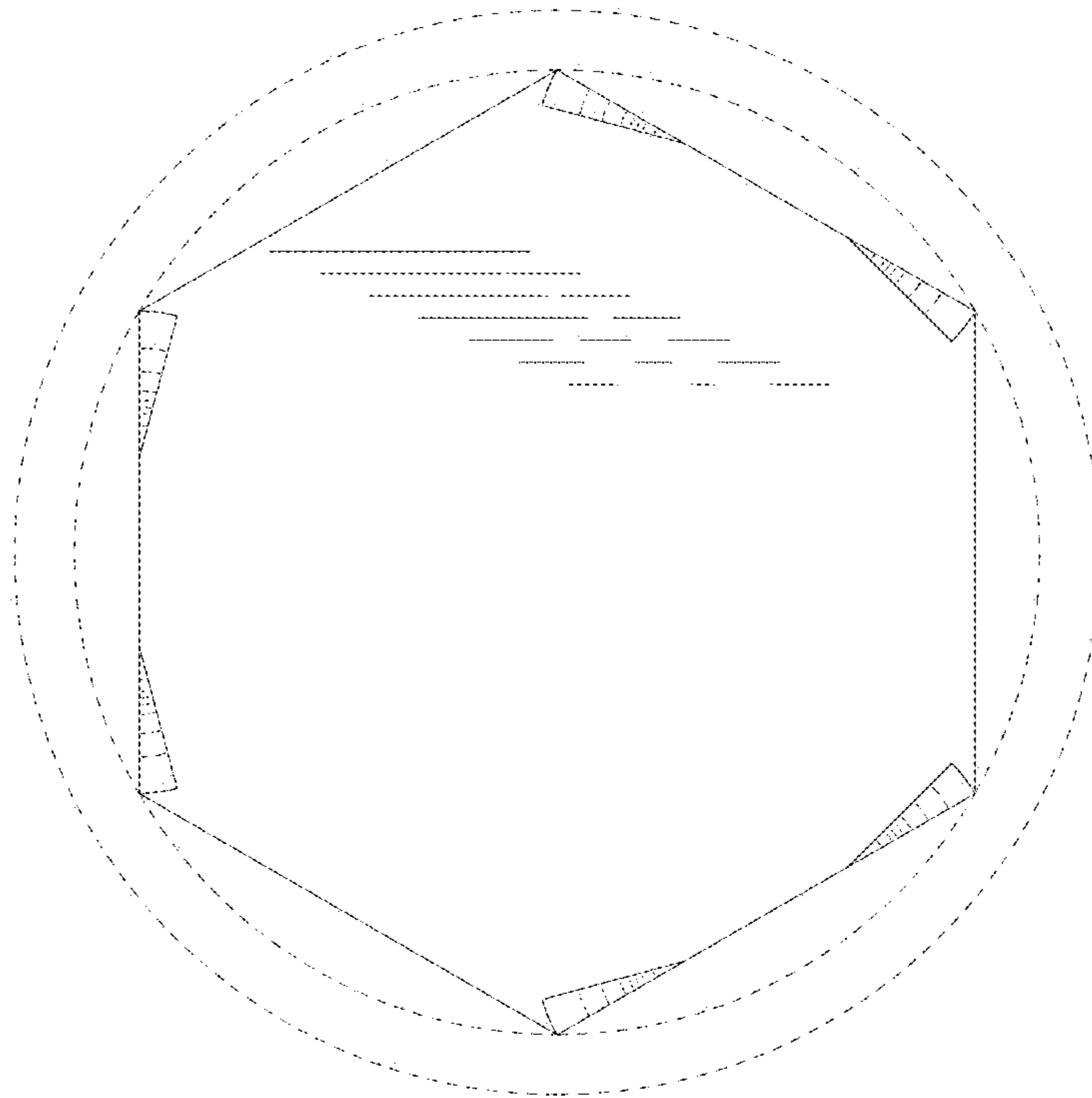

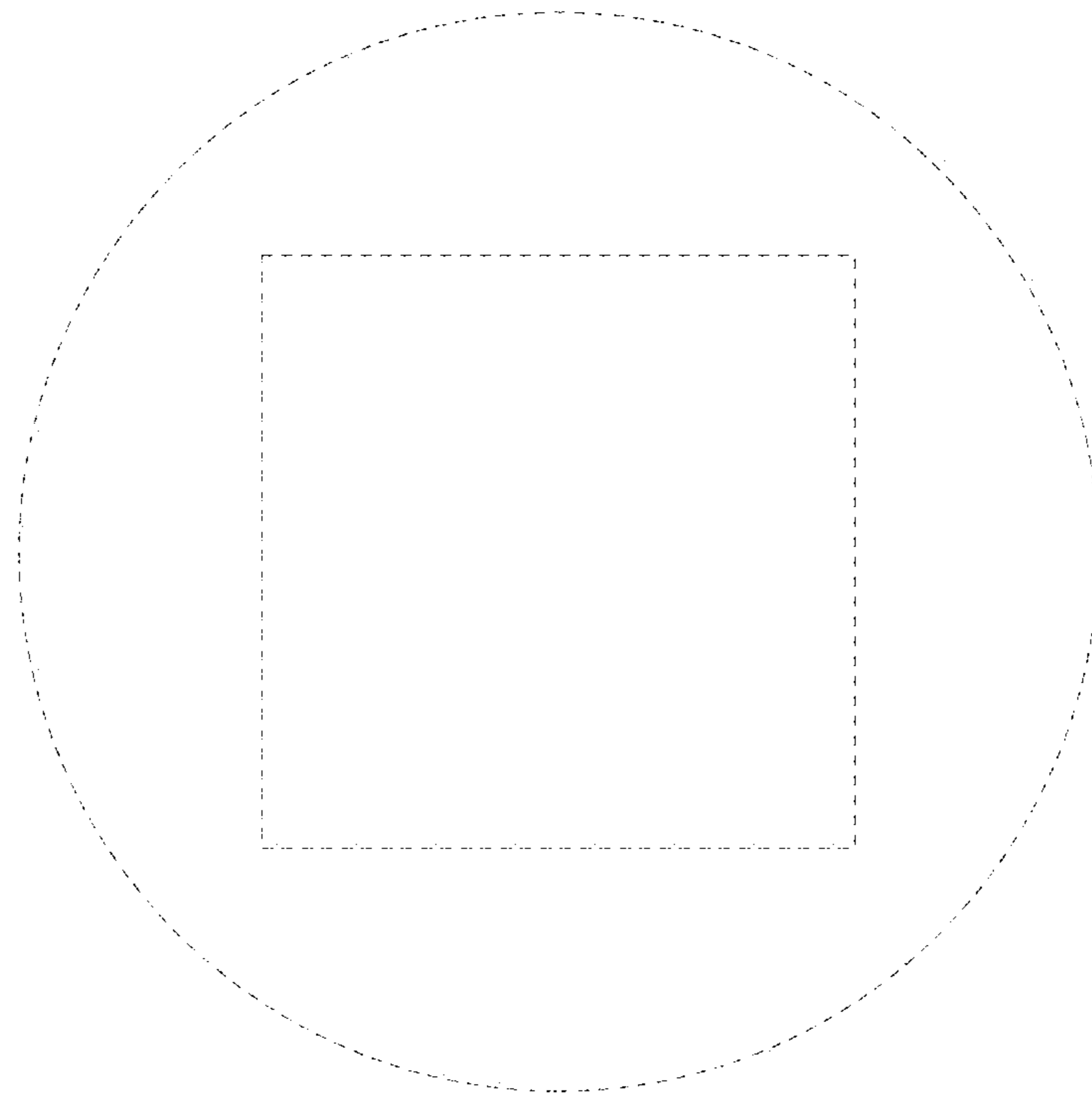
