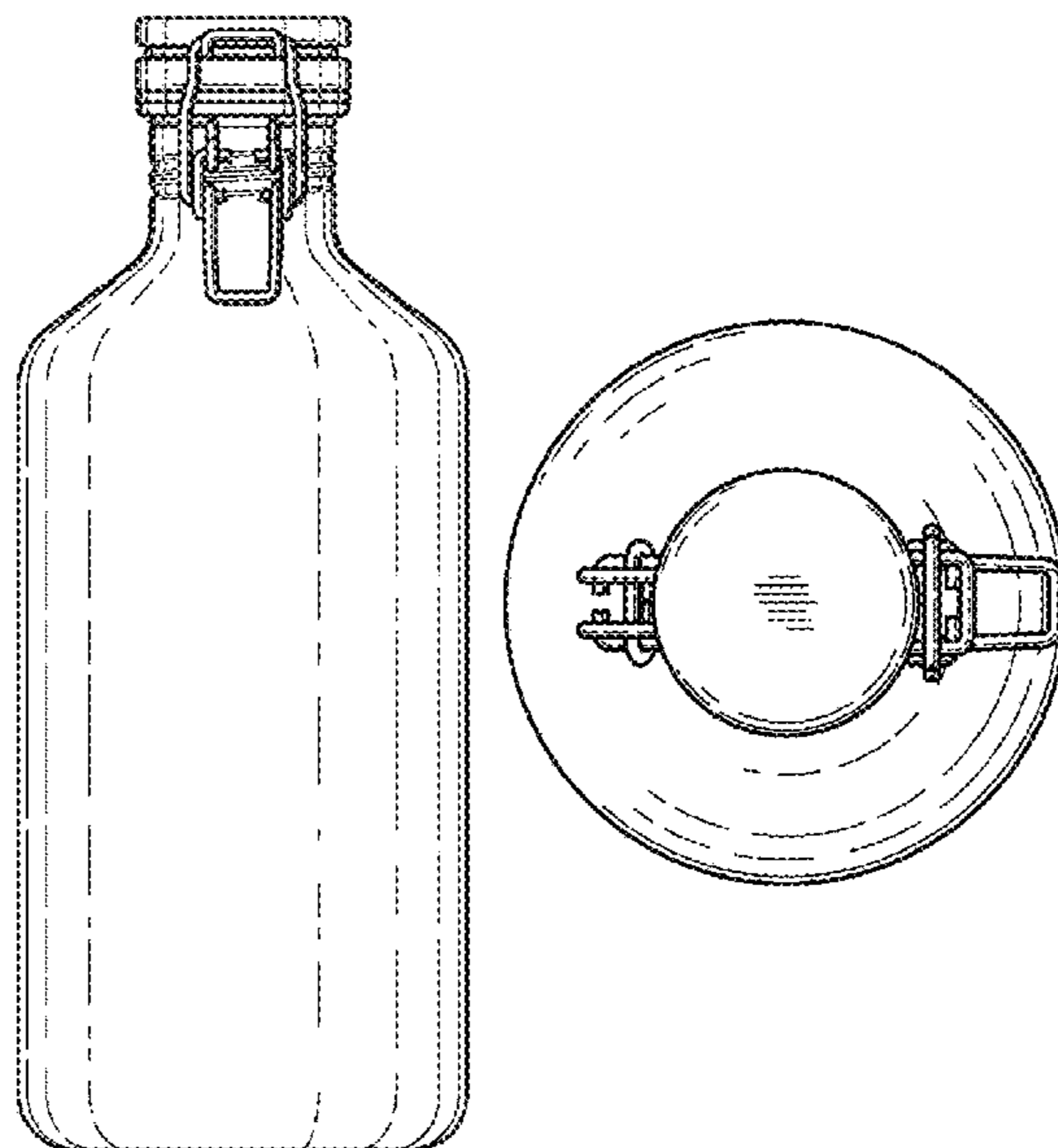
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a bottle with closure.
FIG. 2 is a front view of the bottle with closure of FIG. 1.
FIG. 3 is a back view of the bottle with closure of FIG. 1.
FIG. 4 is a right view of the bottle with closure of FIG. 1.
FIG. 5 is a left view of the bottle with closure of FIG. 1; and,

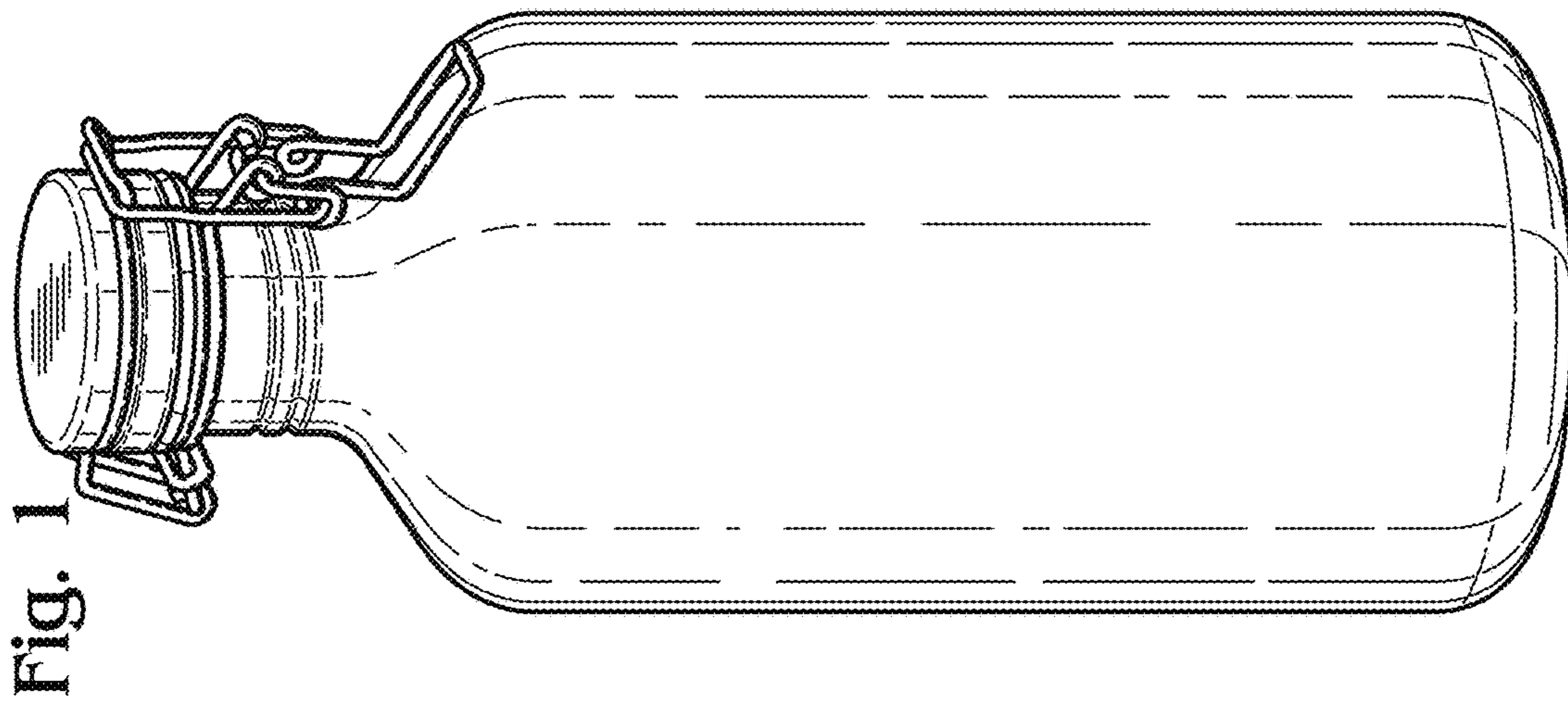

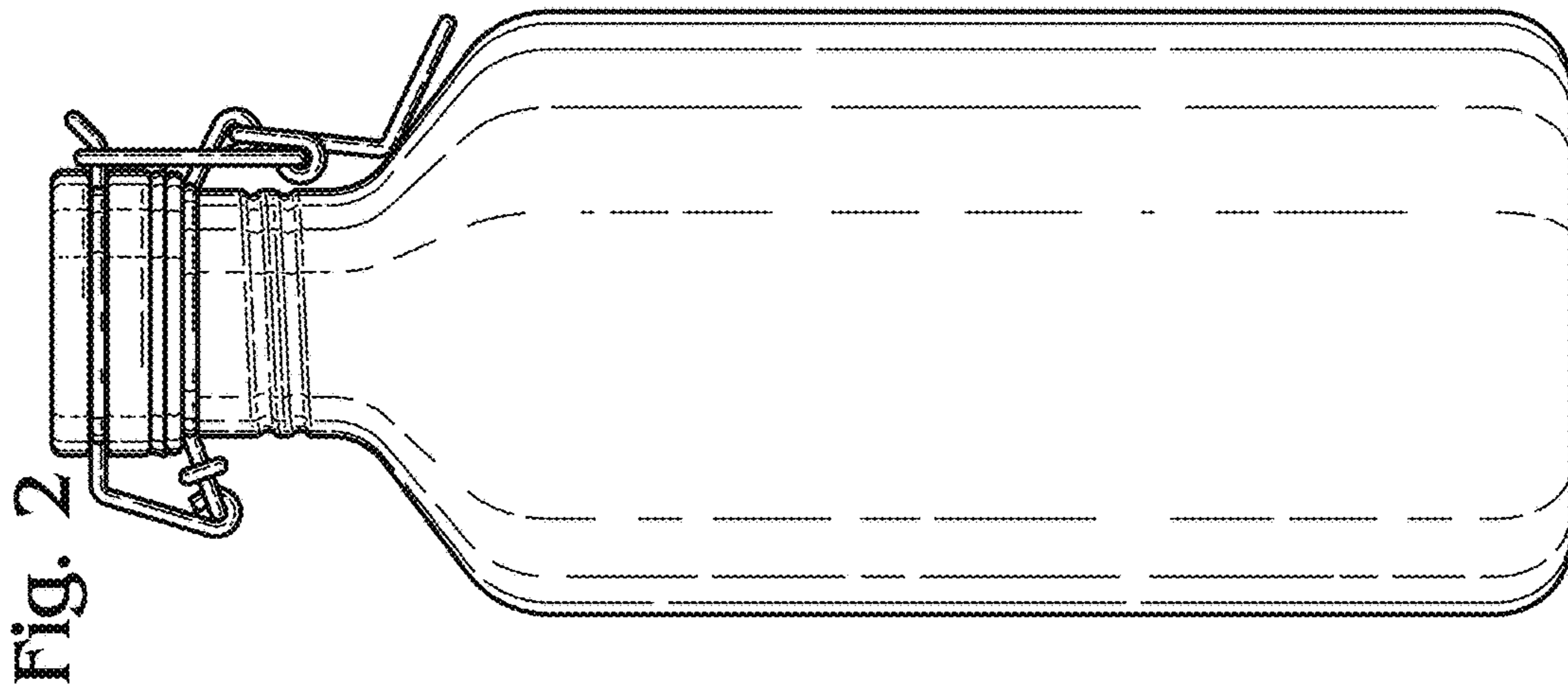

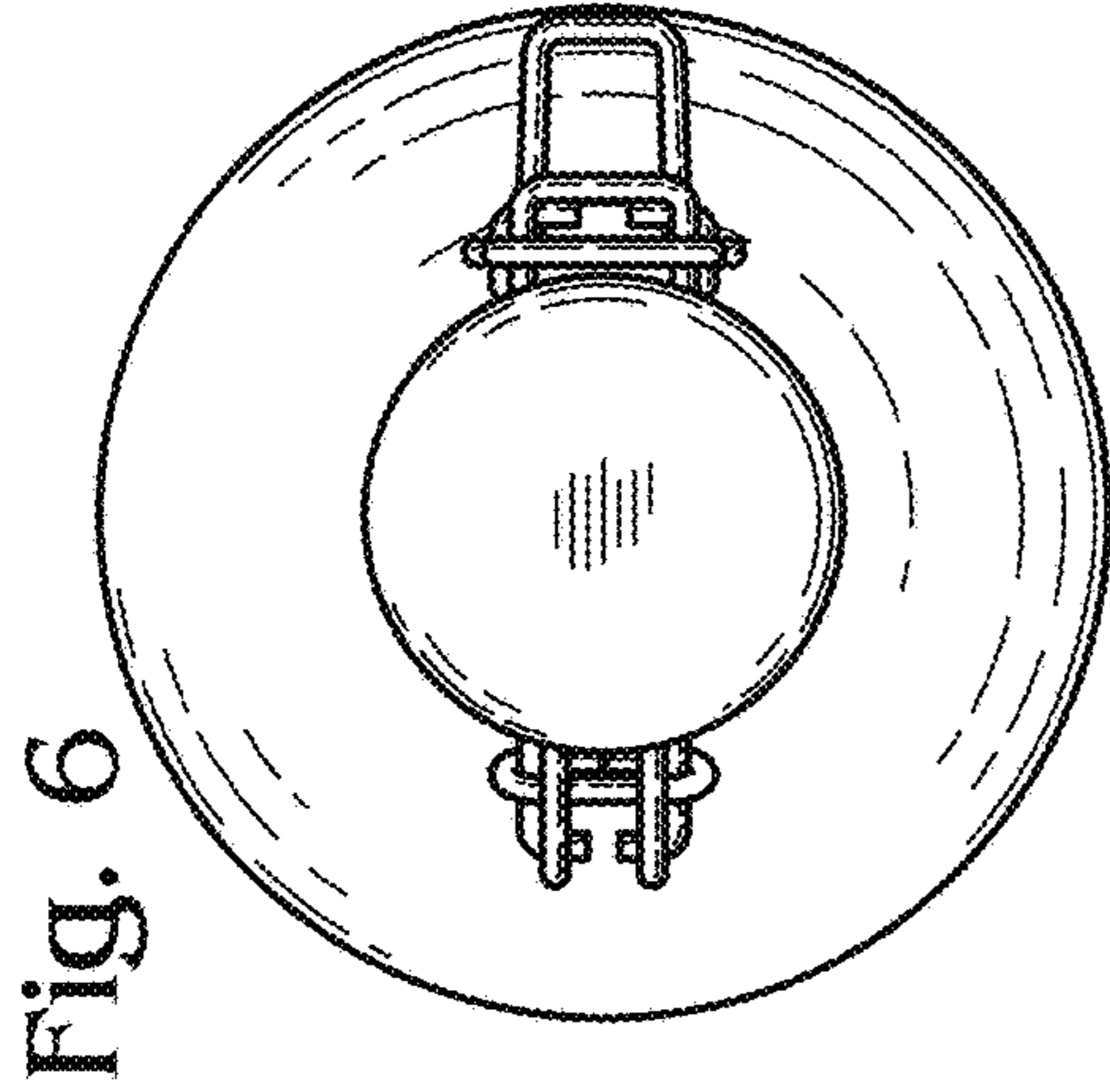
